FIG. 5 is right side elevational view thereof;

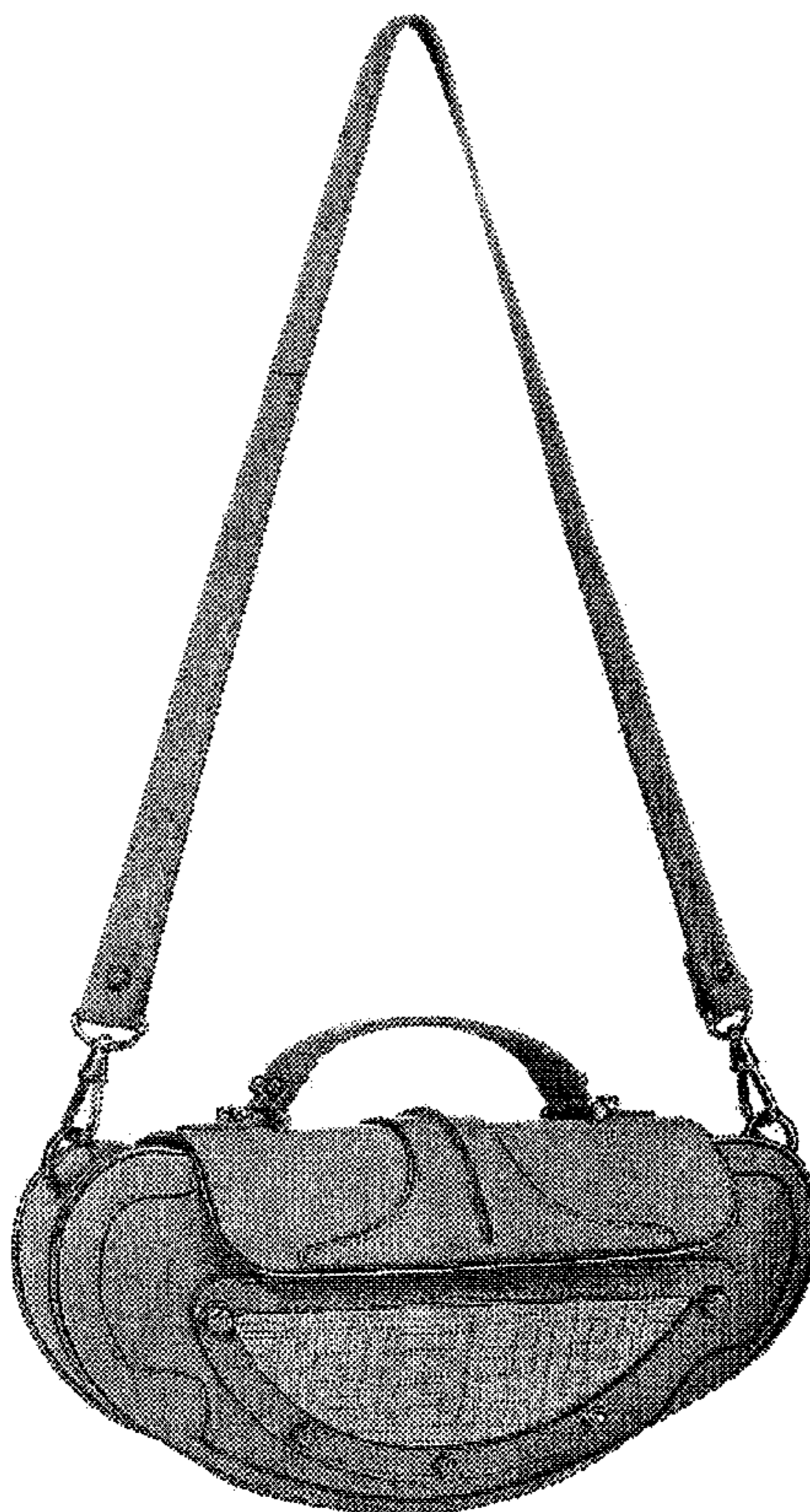
FIG. 6 is a left side elevational view thereof;

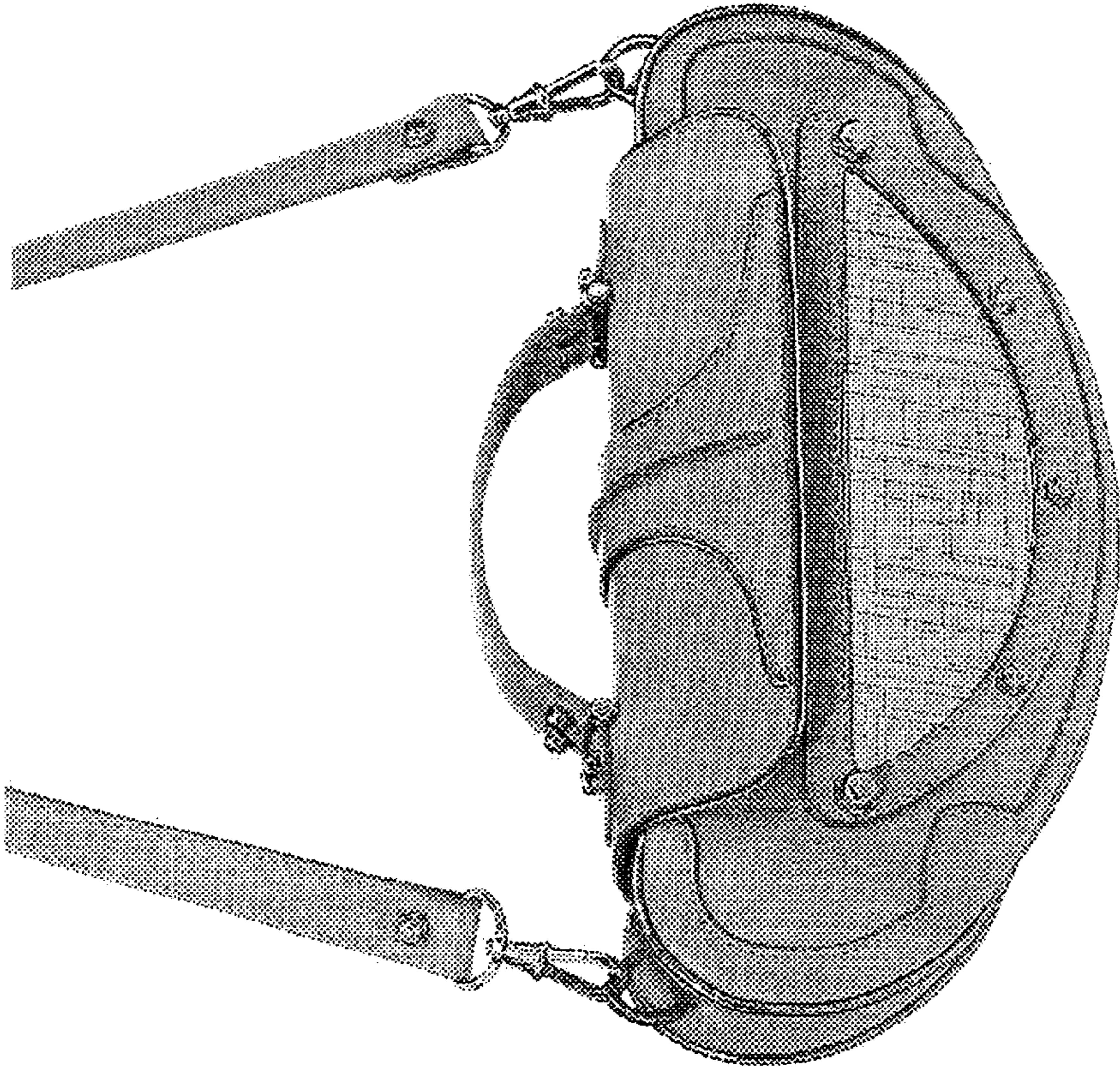

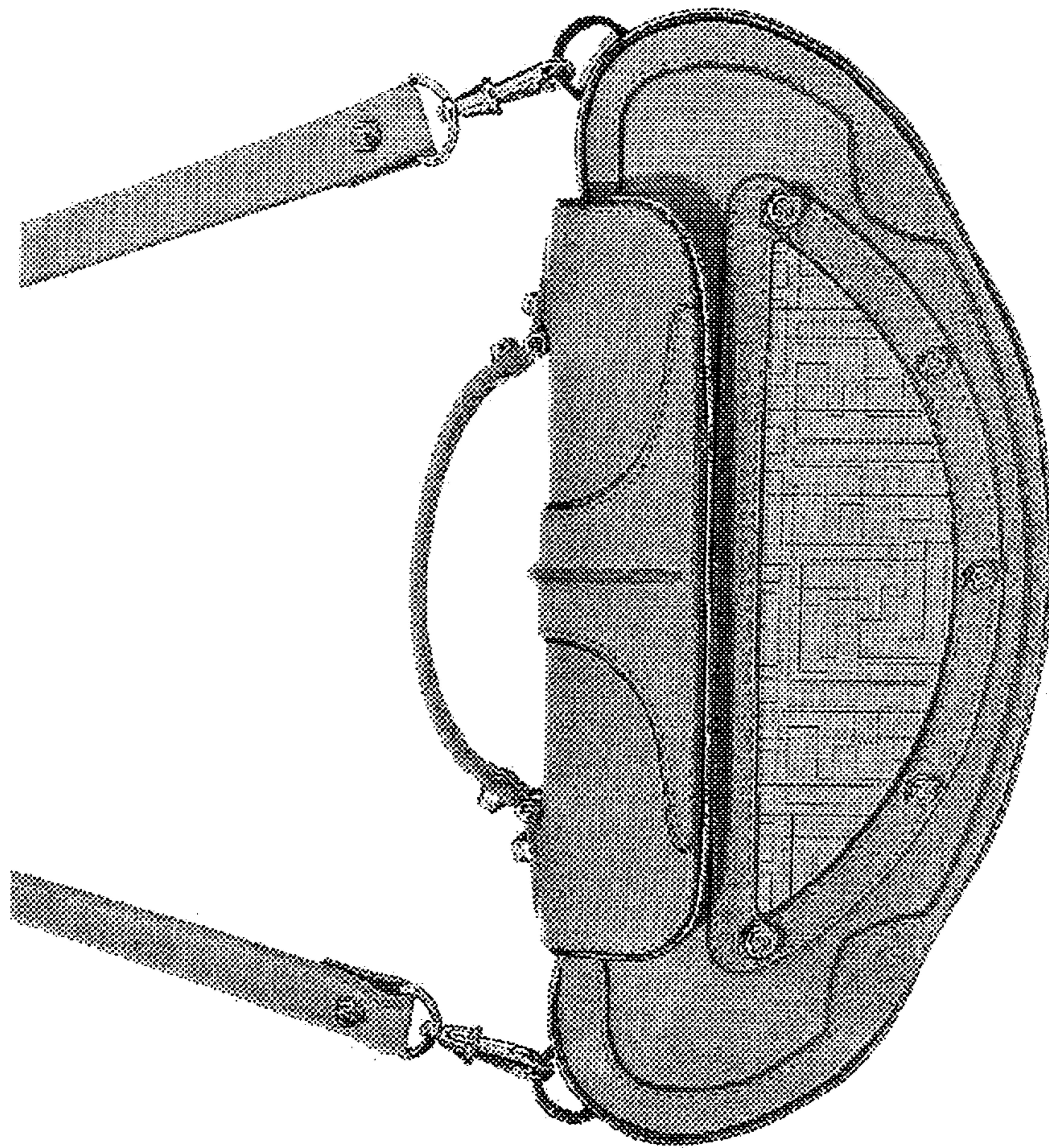
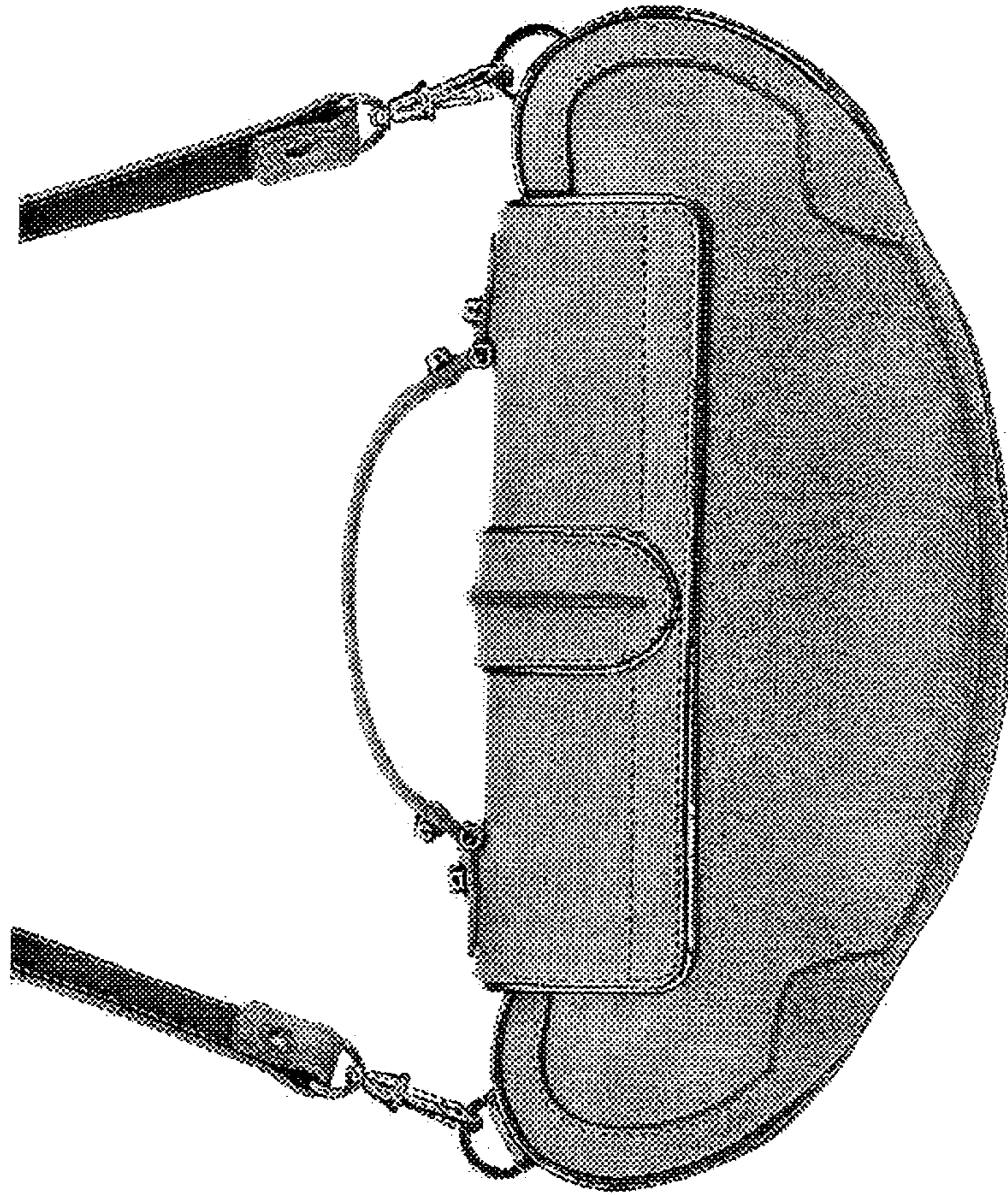
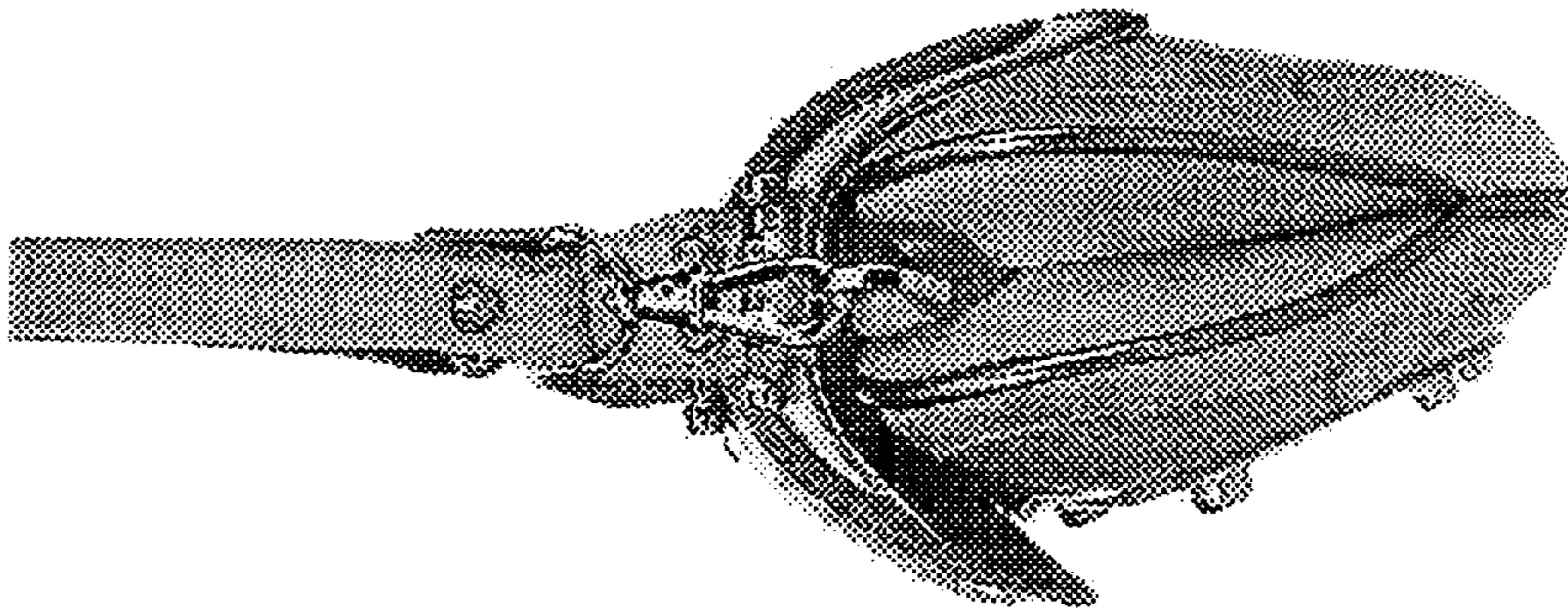


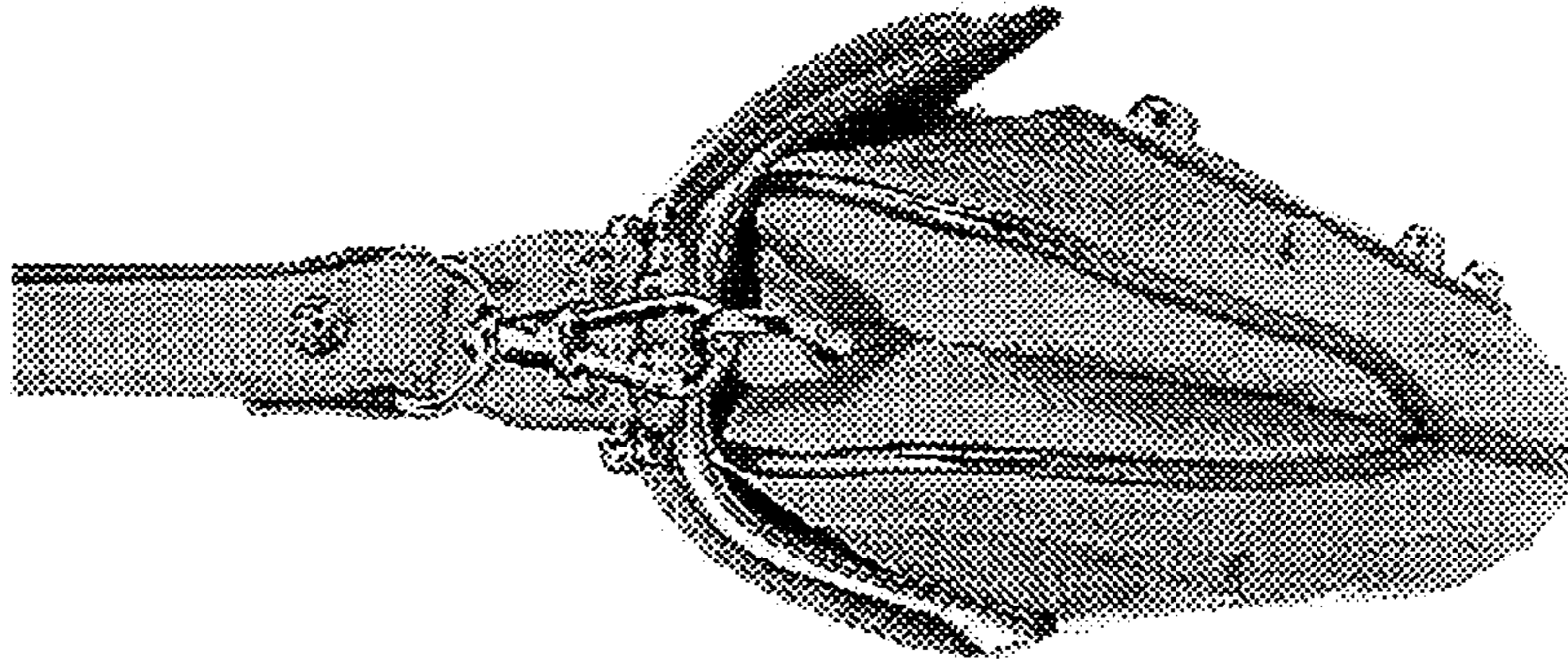

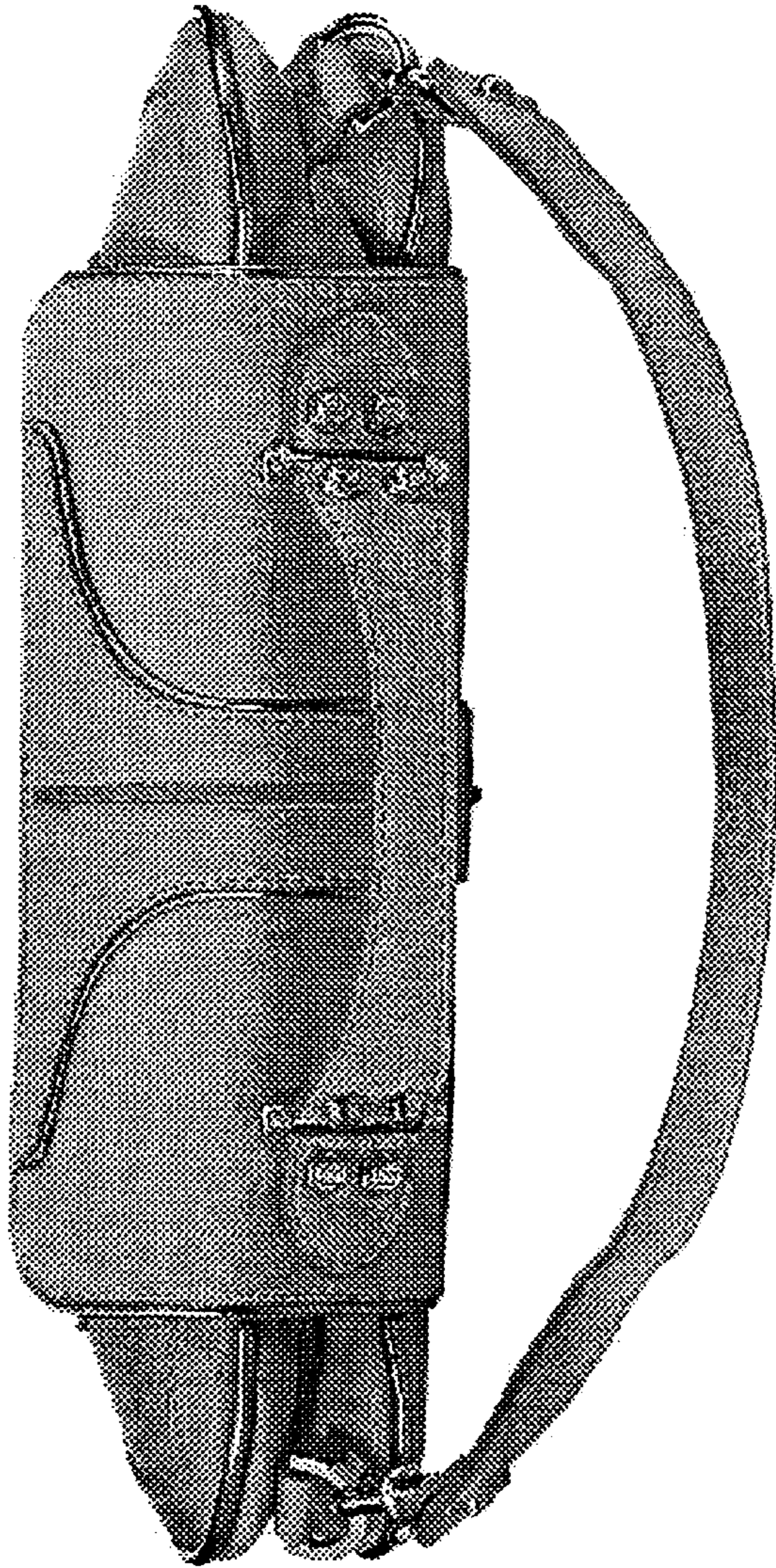

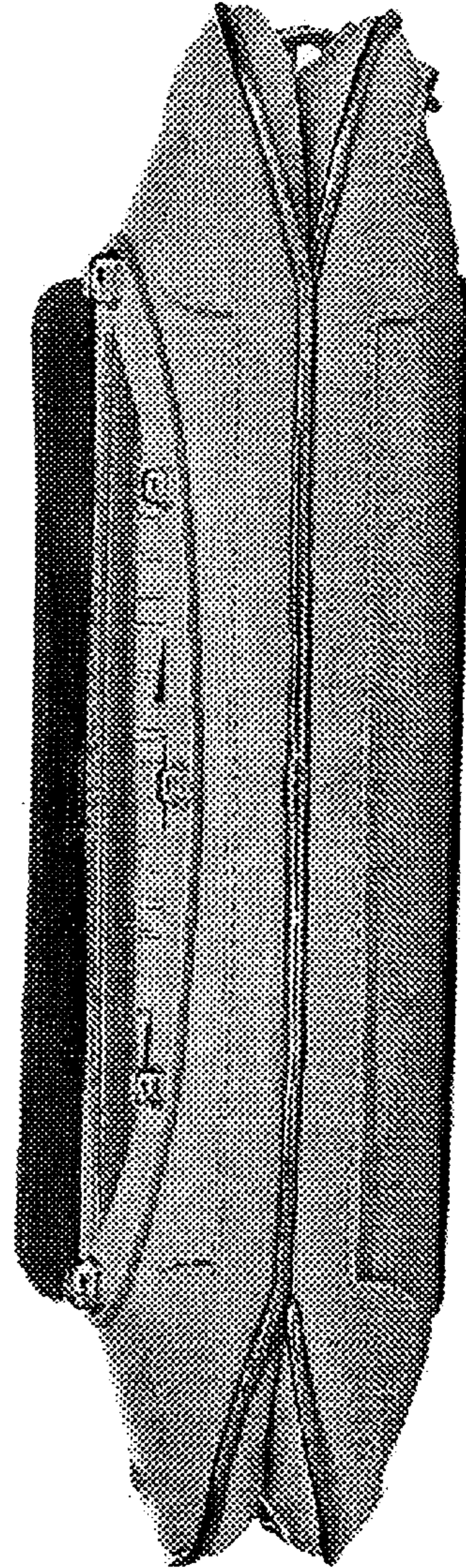
