(57) **CLAIM**

The ornamental design for a grill/baking brush, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of a handle portion of the grill/baking brush;

FIG. 2 is a top plan view of the handle portion of FIG. 1;

FIG. 3 is a bottom plan view of the handle portion of FIG. 1;

FIG. 4 is a side perspective view of a brush head portion of the grill/baking brush;

FIG. 5 is a top plan view of the brush head portion of FIG. 4;

FIG. 6 is a bottom plan view of the brush head portion of FIG. 4;

FIG. 7 is an exploded side perspective view of the grill/baking brush; and,

FIG. 8 is a side perspective view of the grill brush;

FIG. 9 is a cross-sectional view of the exploded view of the grill brush in FIG. 7; and,

FIG. 10 is a cross-sectional view of the grill brush in FIG. 8.

The handle in FIGS. 1-3 and the brush head in FIGS. 4-6 are shown separately for clarity of illustration only.

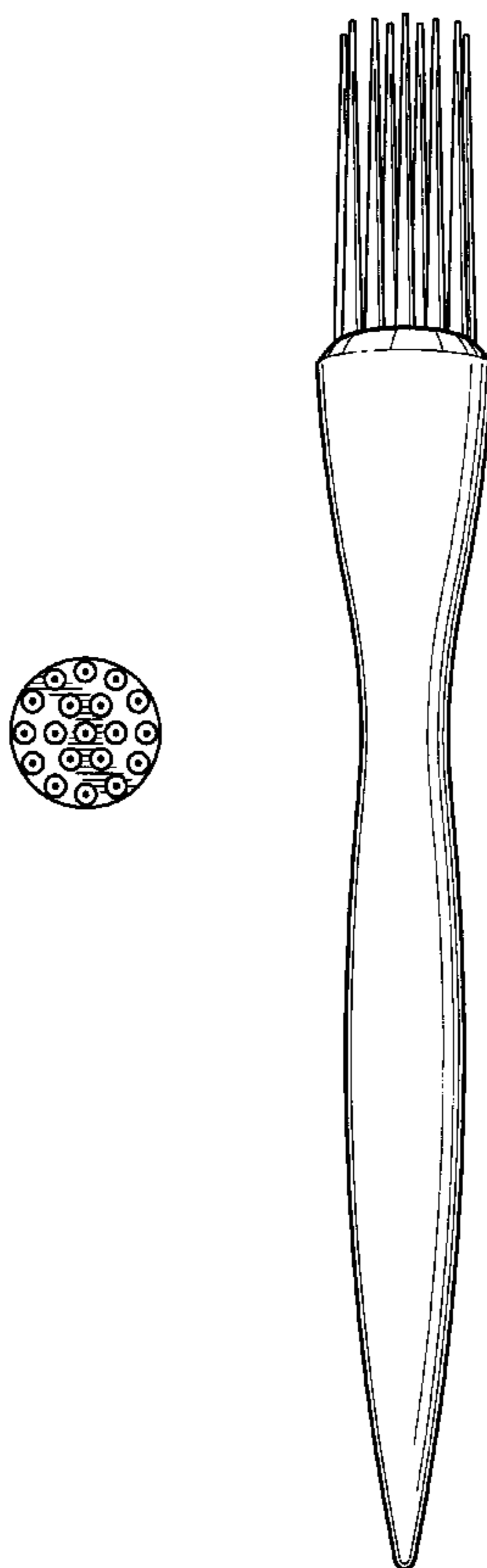

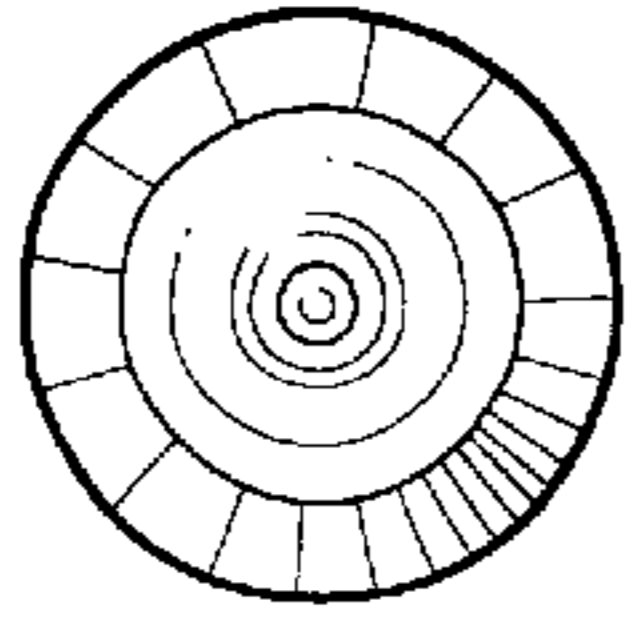

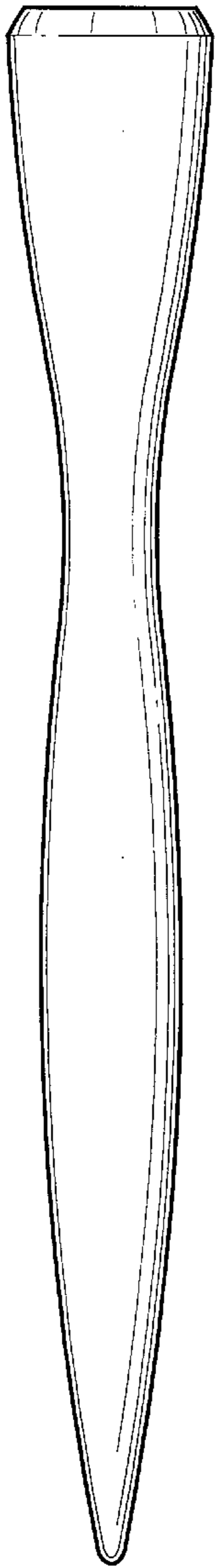

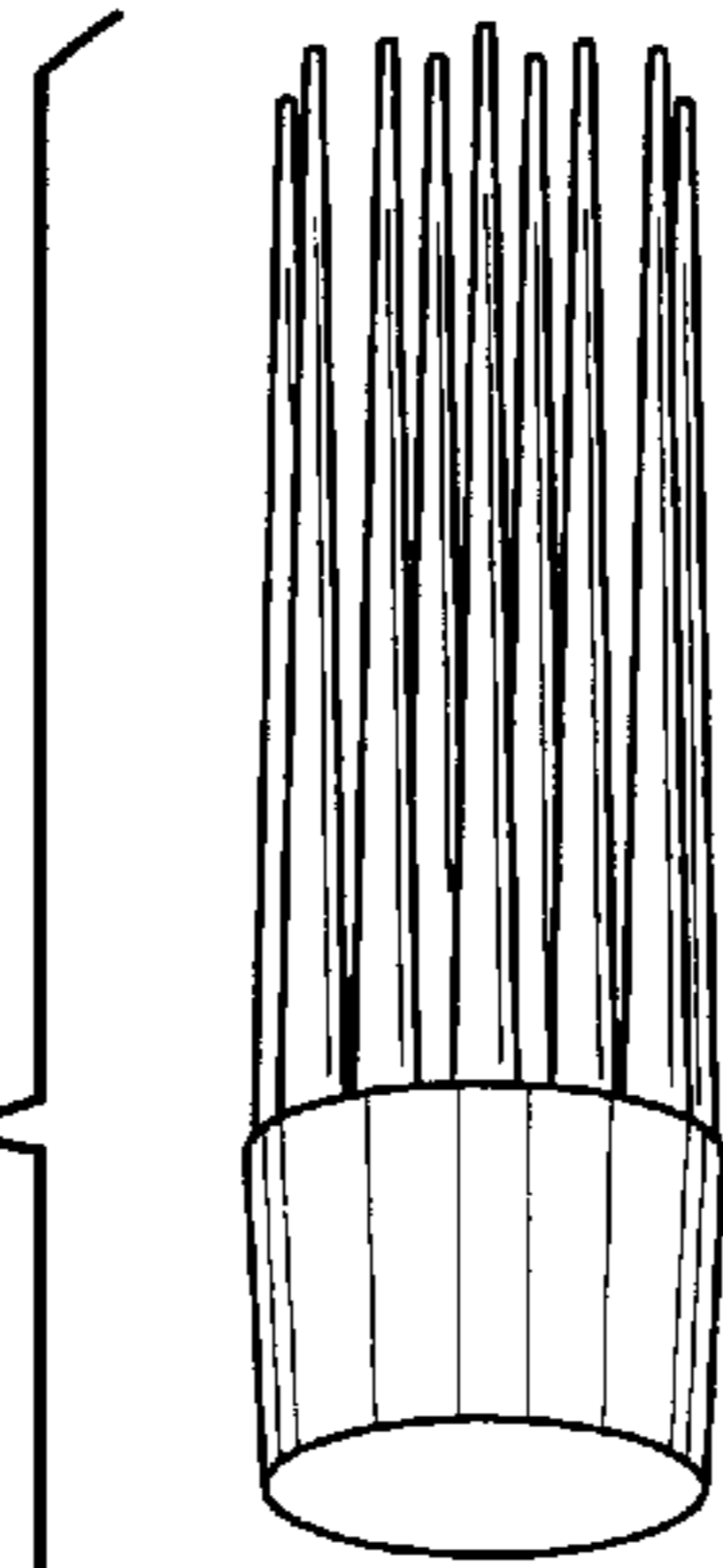

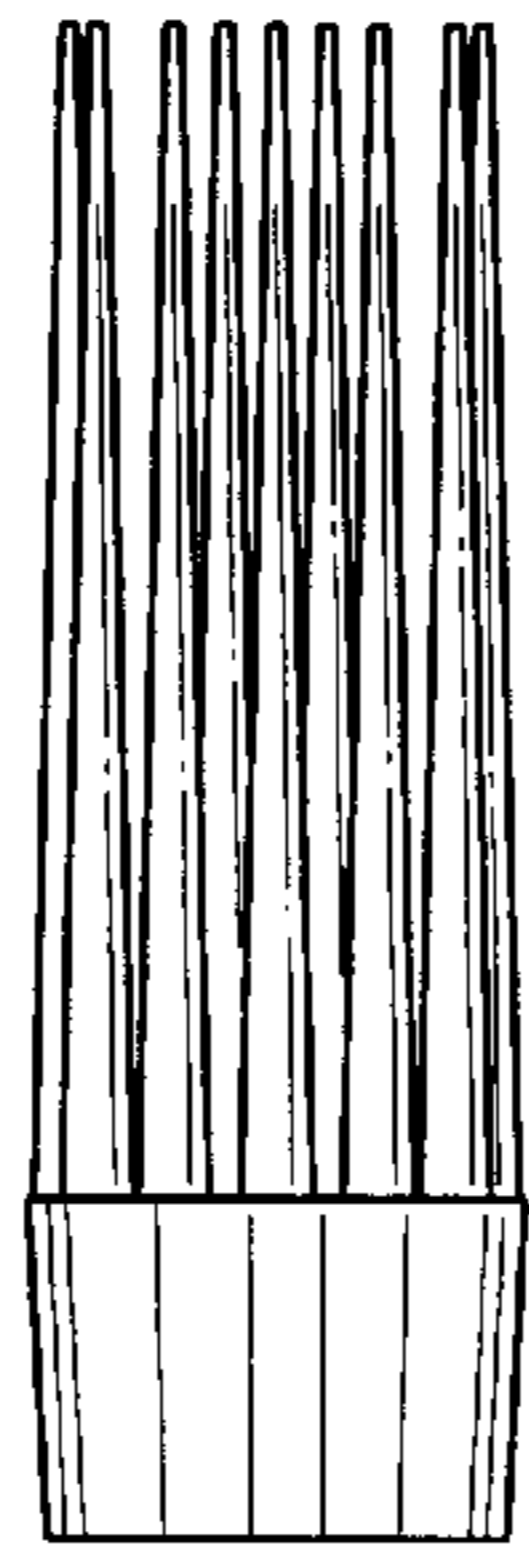

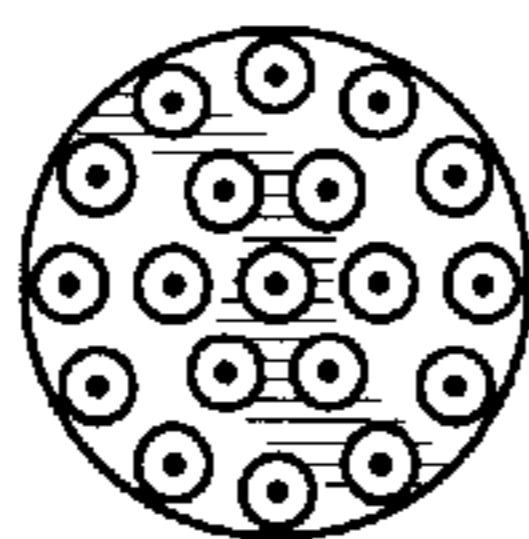

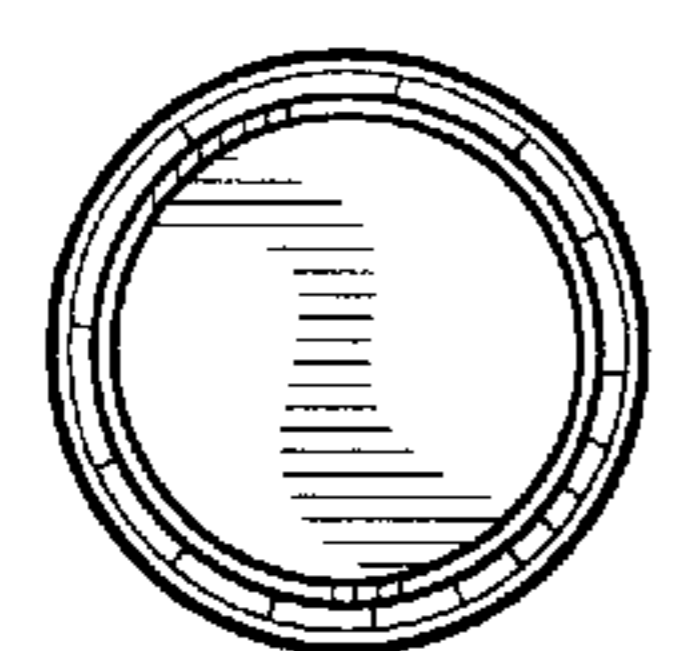

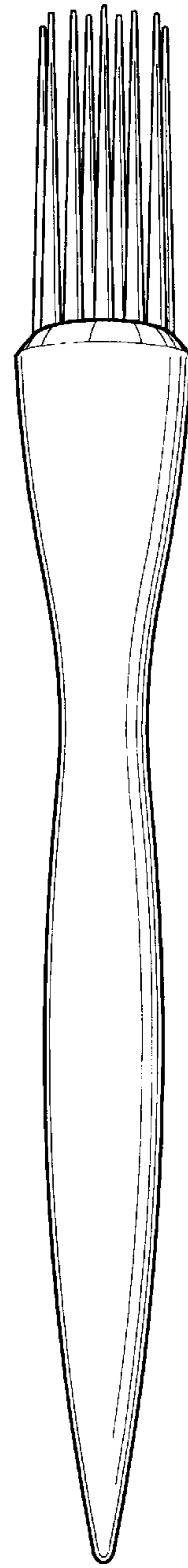
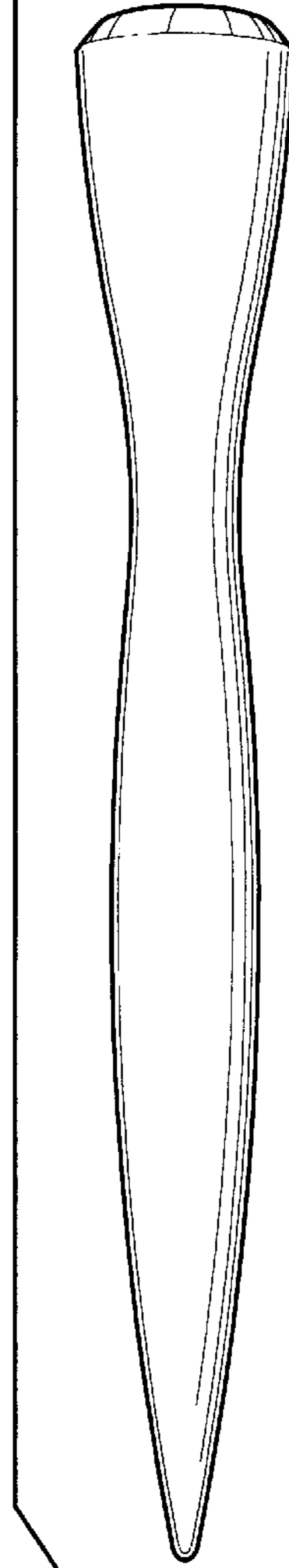

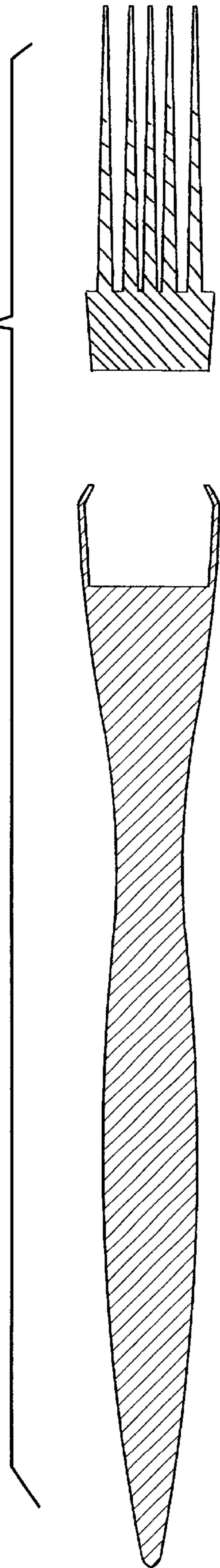
