**DESCRIPTION**

FIG. 1 is a top perspective view of a spatula handle showing my new design;

FIG. 2 is a bottom perspective view thereof;

FIG. 3 is an enlarged bottom plan view thereof, the spatula lower portion not shown for ease of illustration;

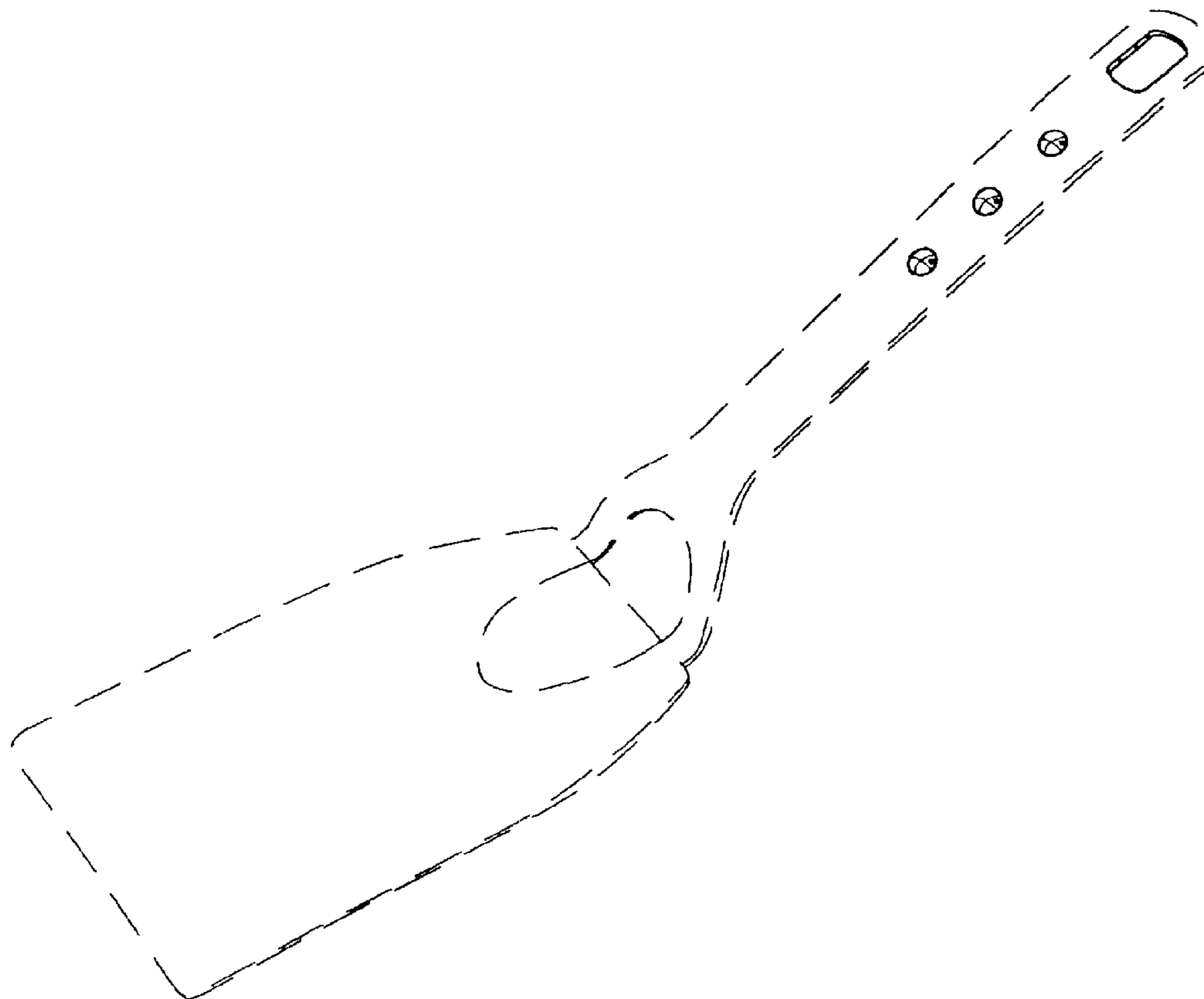
FIG. 4 is an enlarged top plan view thereof, the spatula lower portion not shown for ease of illustration;

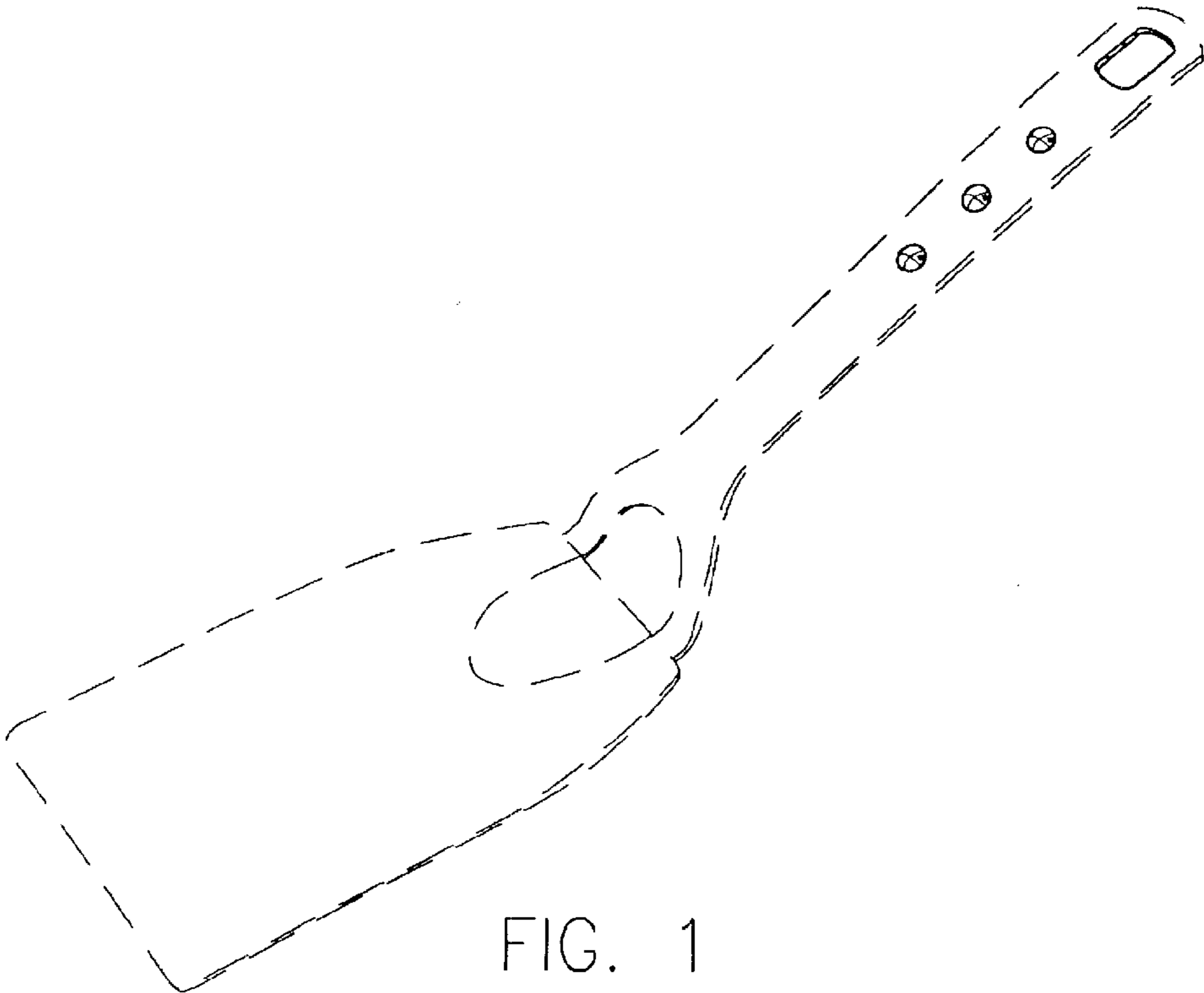

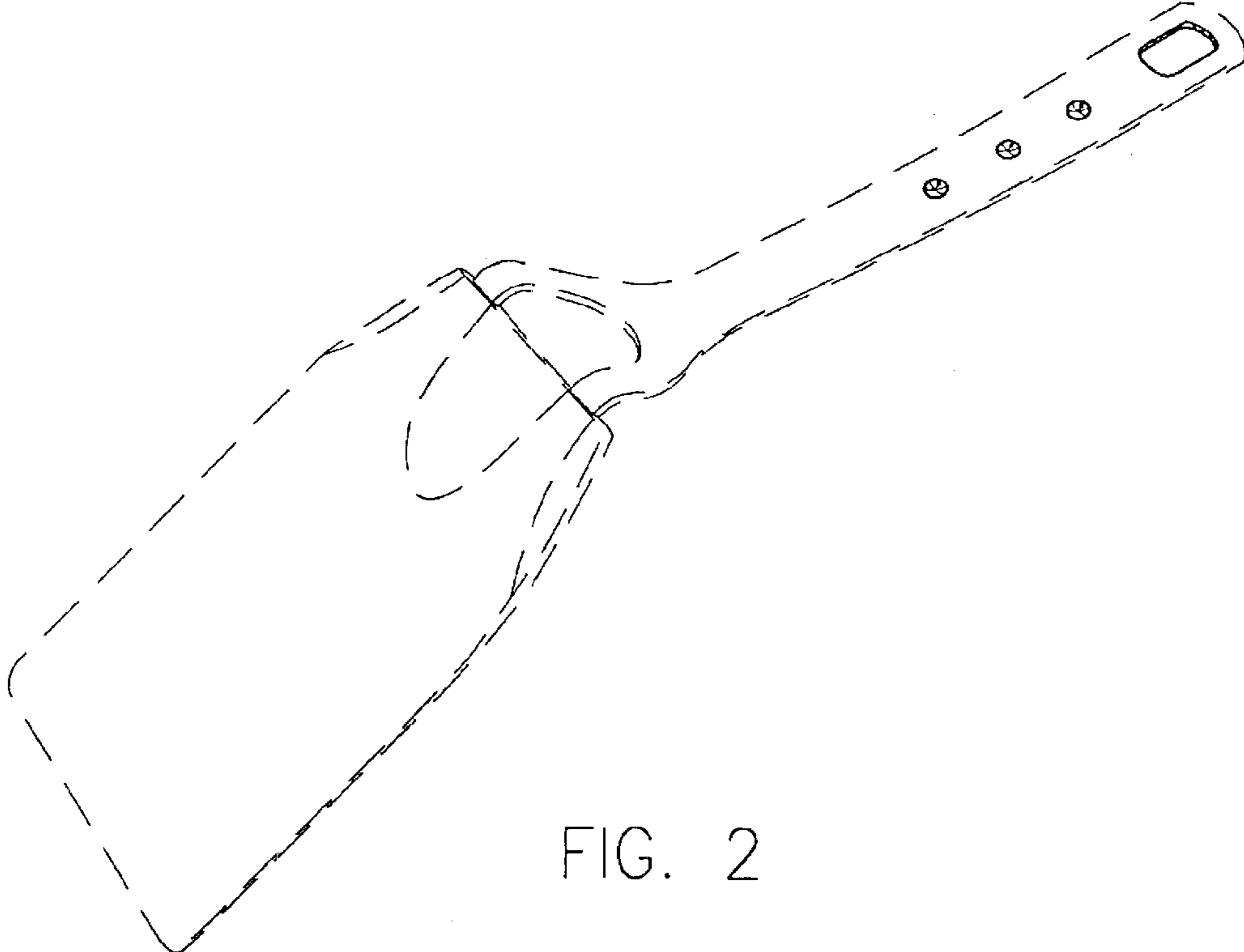

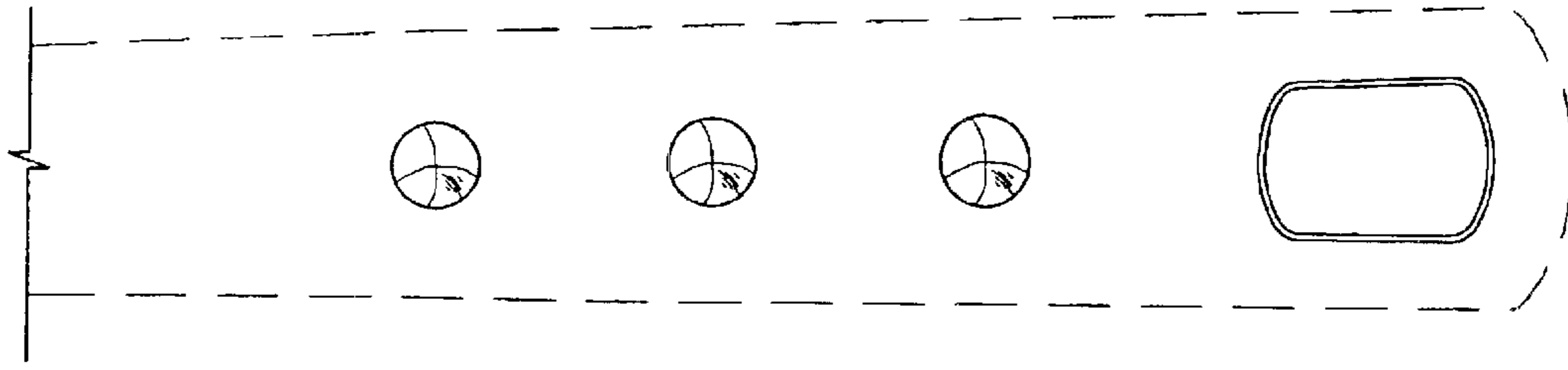

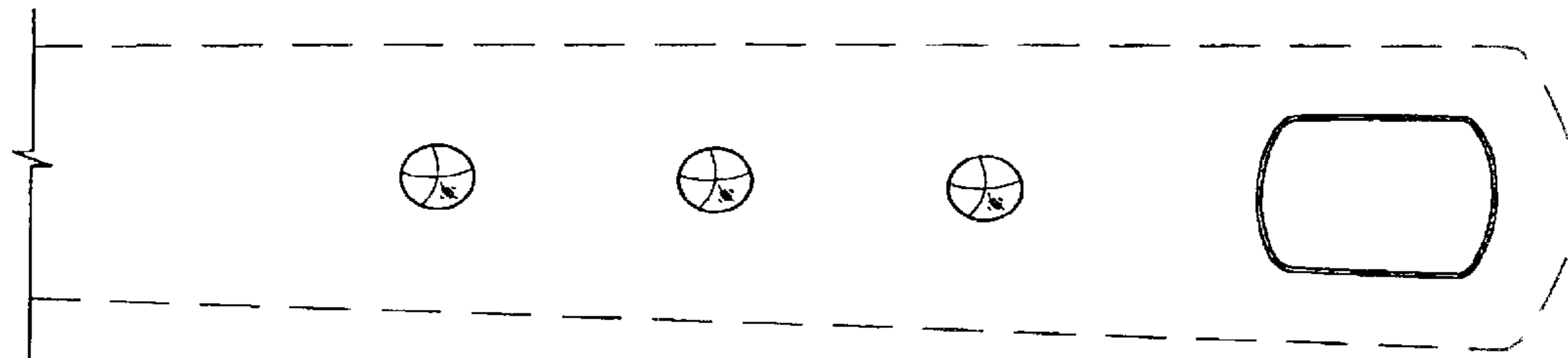

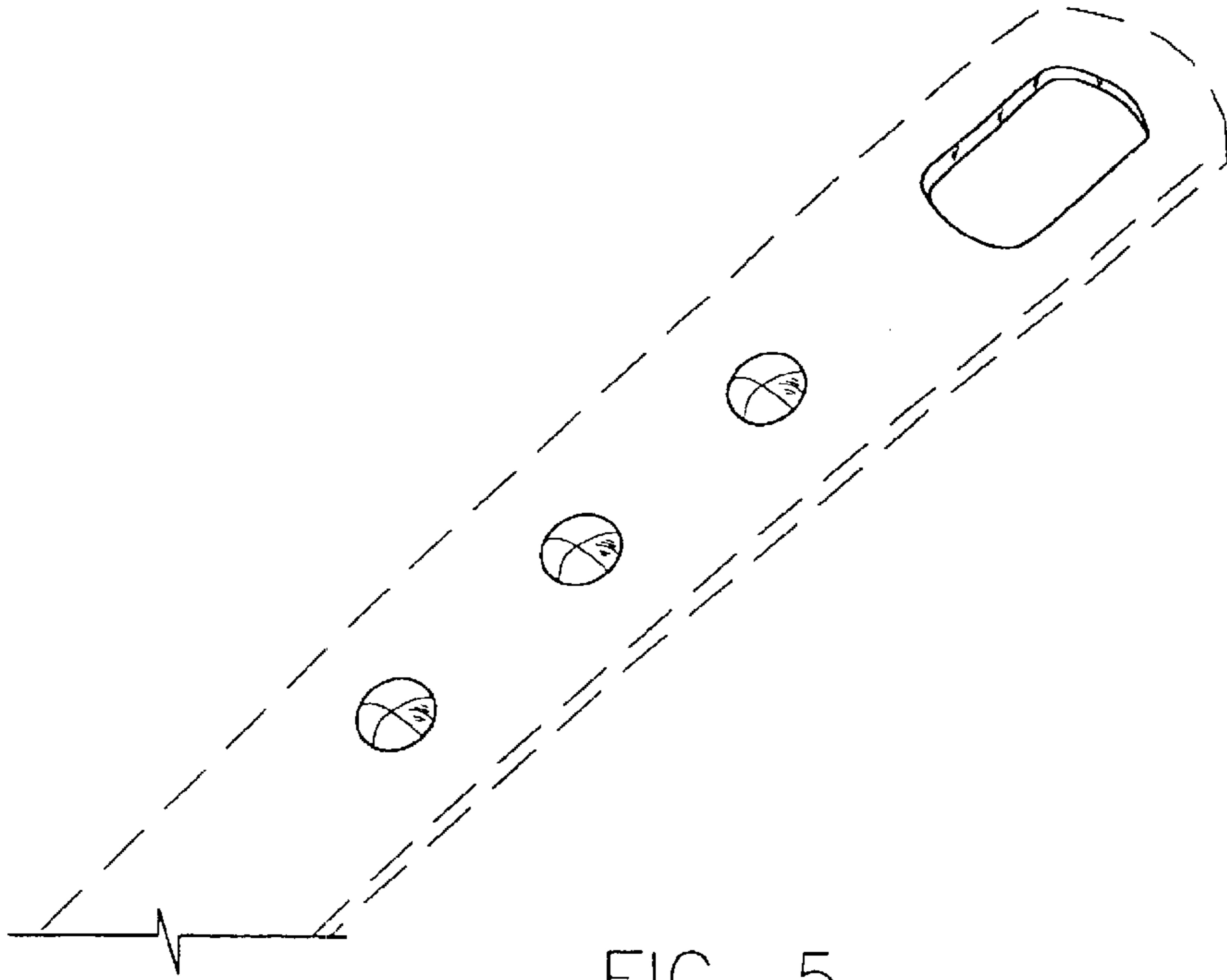

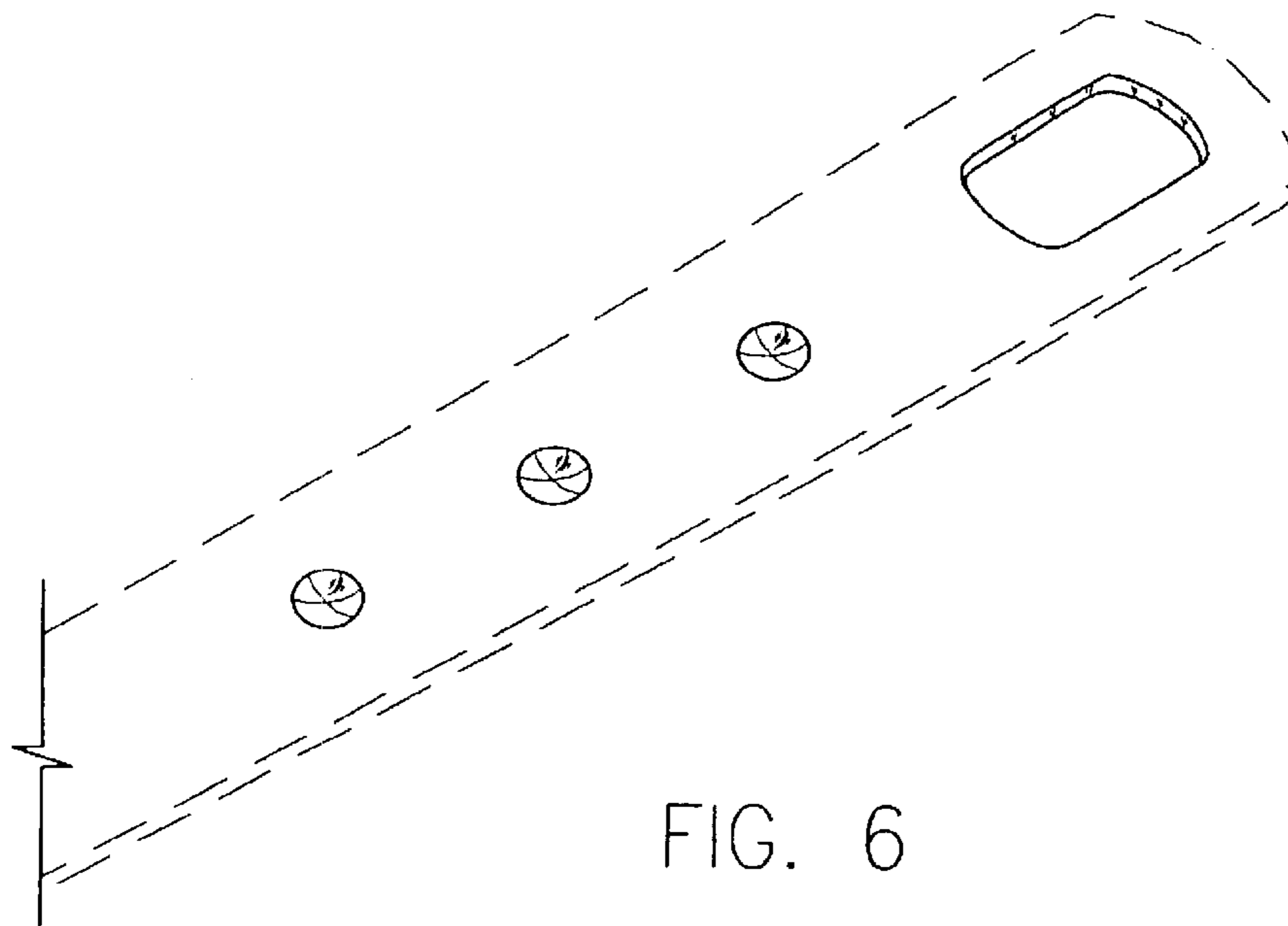
