(57) **CLAIM**

The ornamental design for a desk or table lamp, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side elevational view of a desk or table lamp showing my new design, the left side elevational view being mirror symmetrical thereto;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a top, front, right side perspective view thereof;

FIG. 5 is a front elevational view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a right side elevational view of a modified desk or table lamp showing my new design, the left side elevational view being mirror symmetrical thereto;

FIG. 8 is a bottom plan view thereof;

FIG. 9 is a top plan view thereof;

FIG. 10 is a top, front, right side perspective view thereof;

FIG. 11 is a front elevational view thereof; and,

FIG. 12 is a rear elevational view thereof.

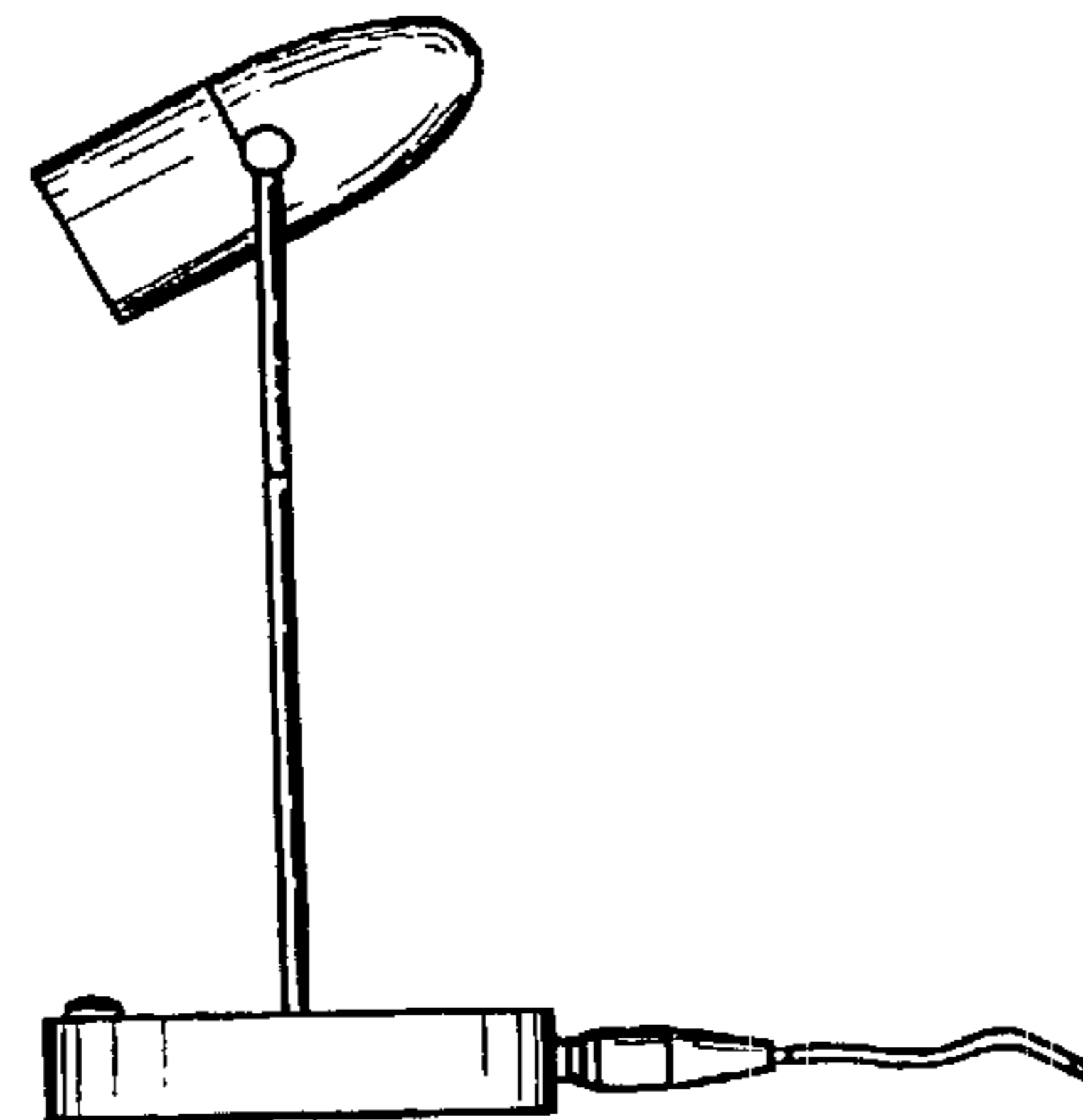
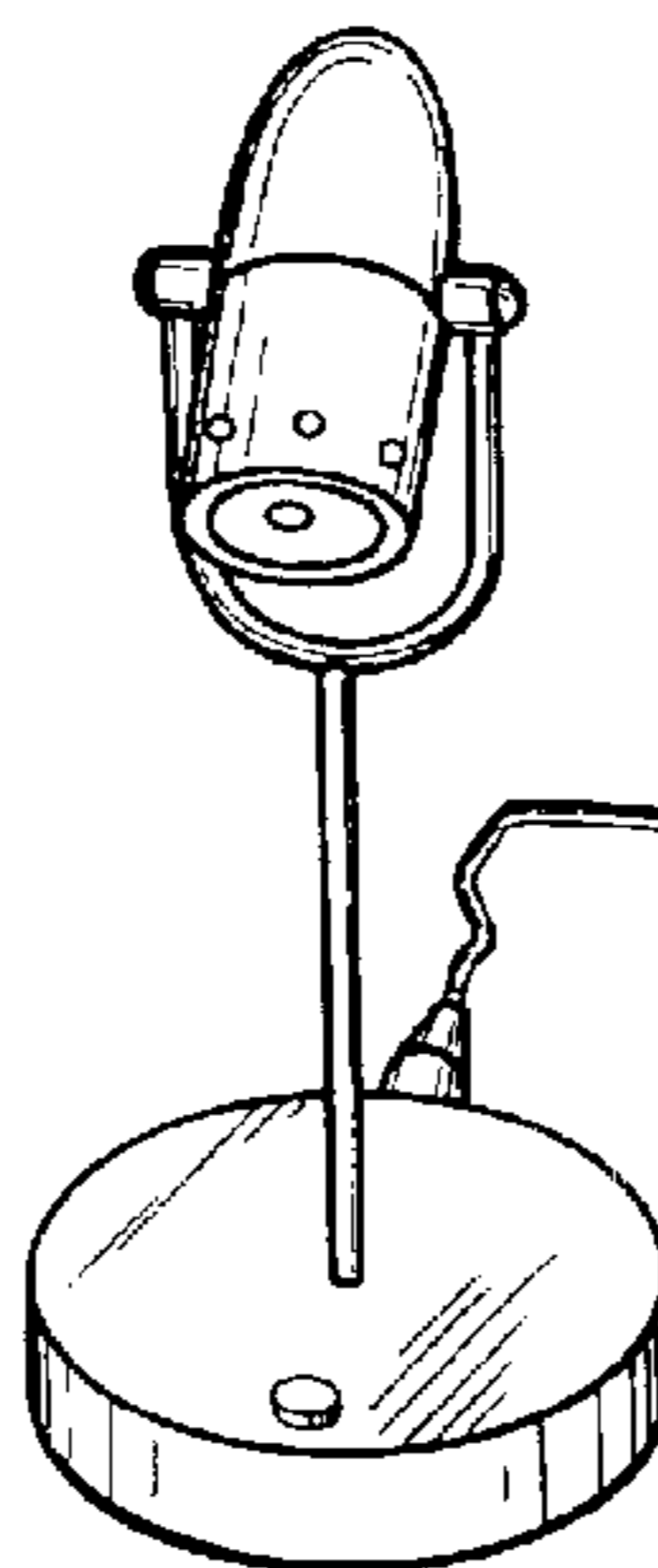
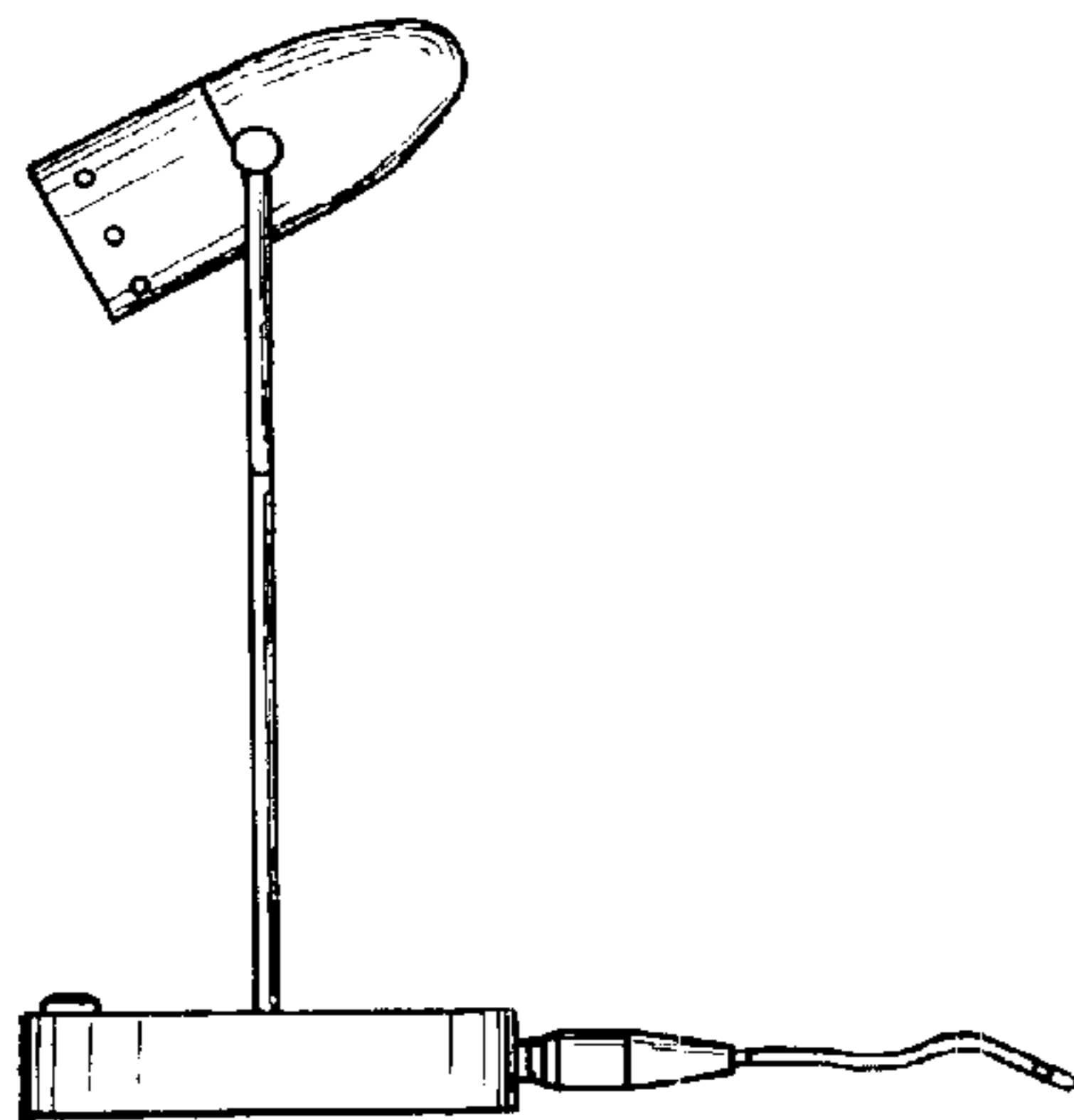

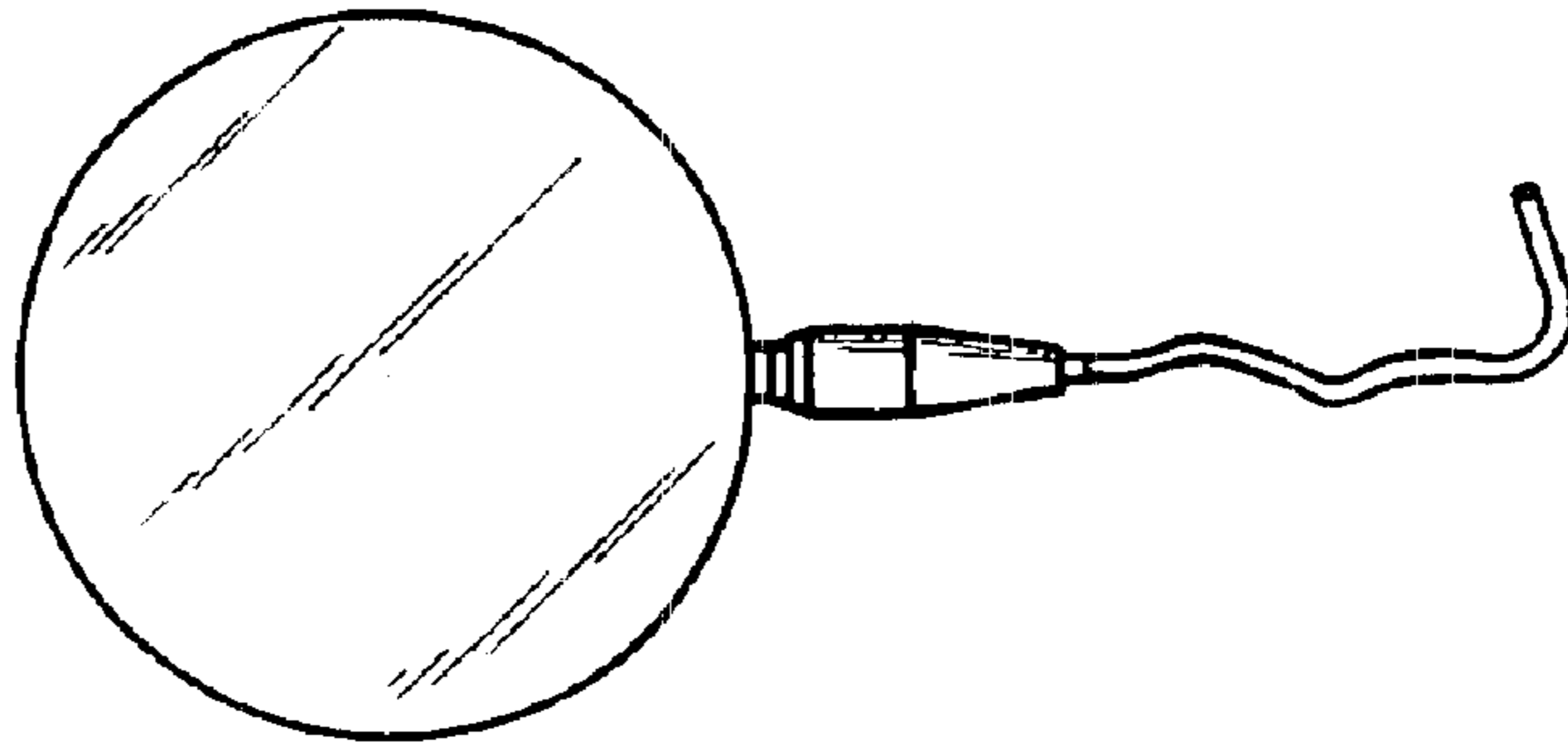

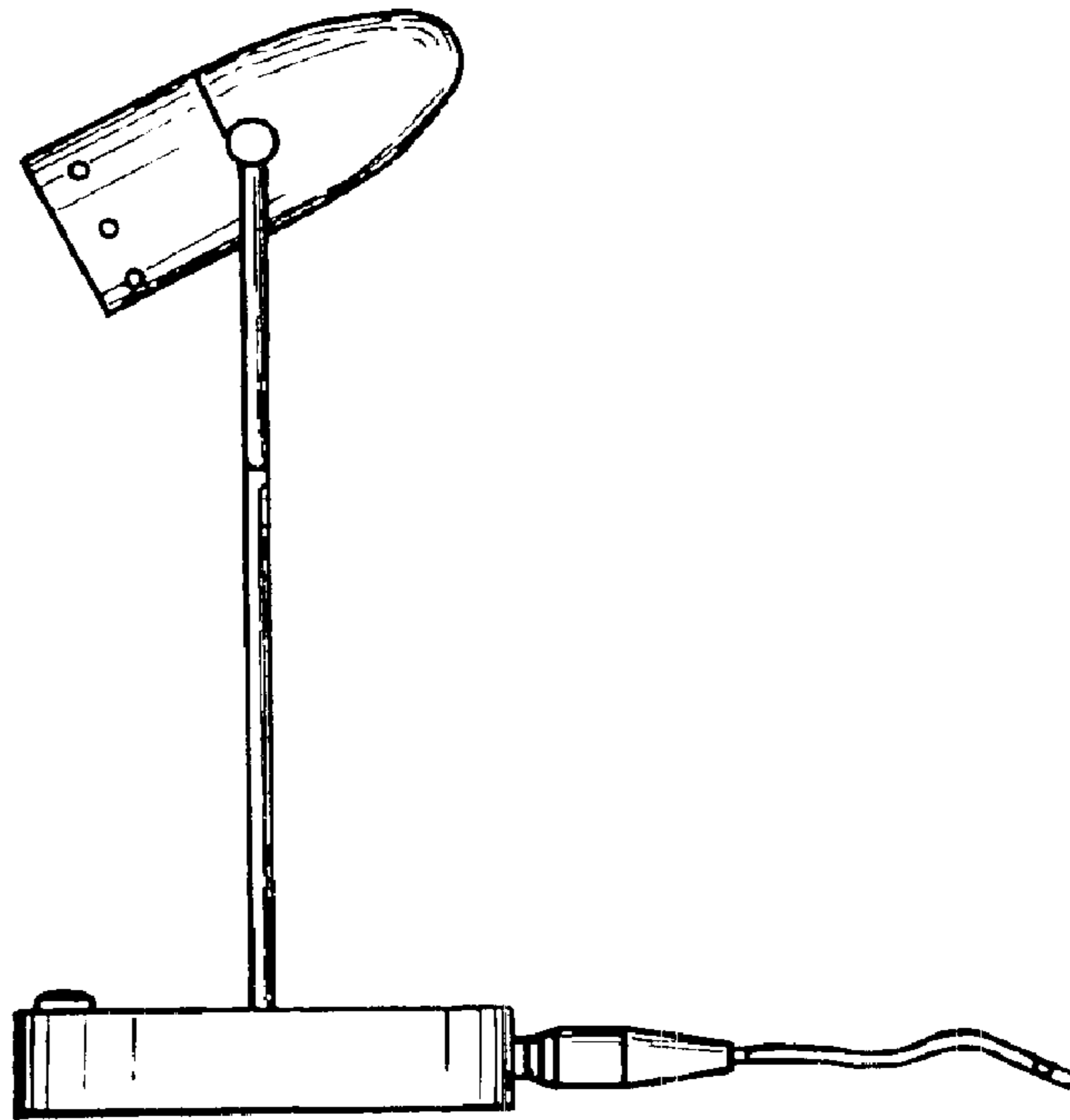
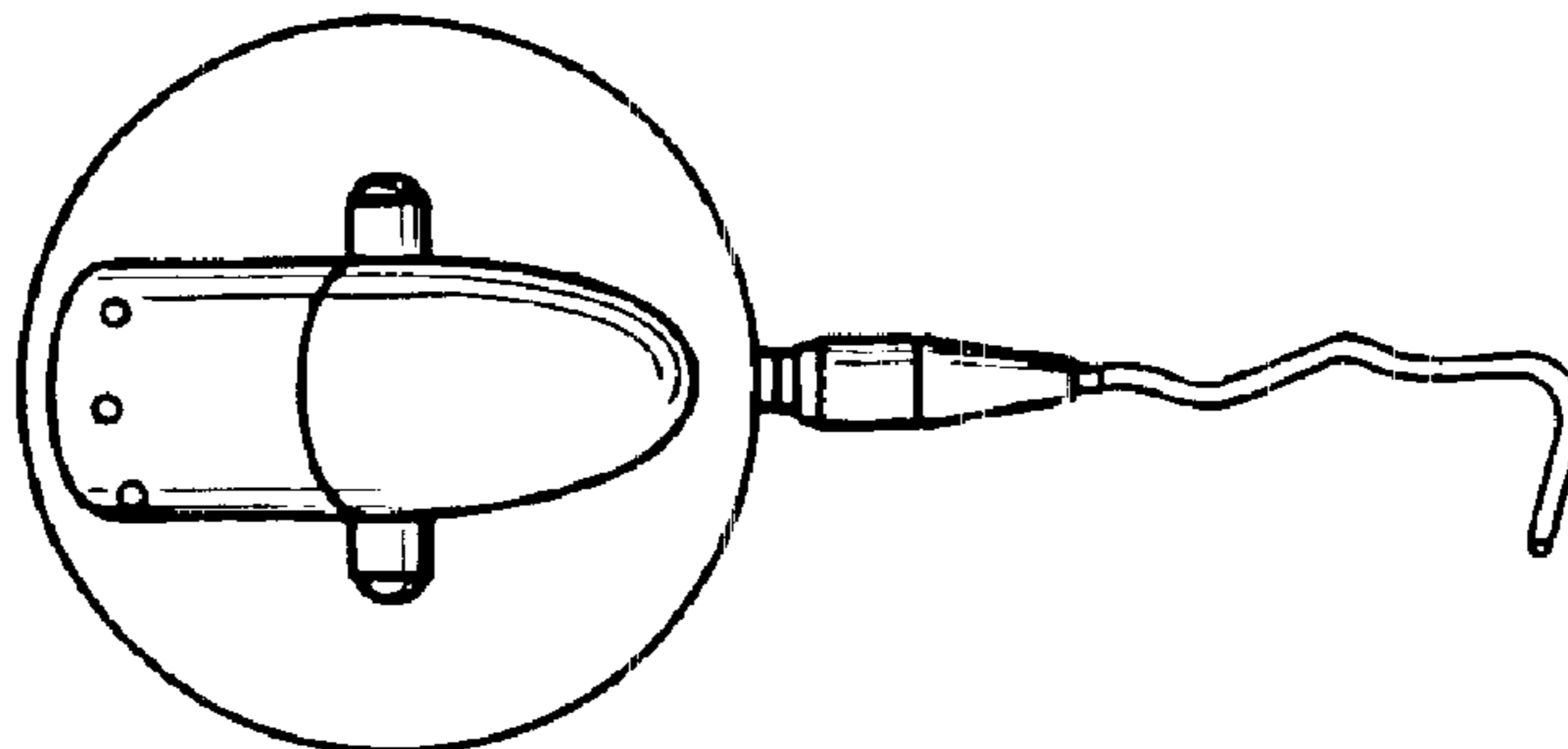

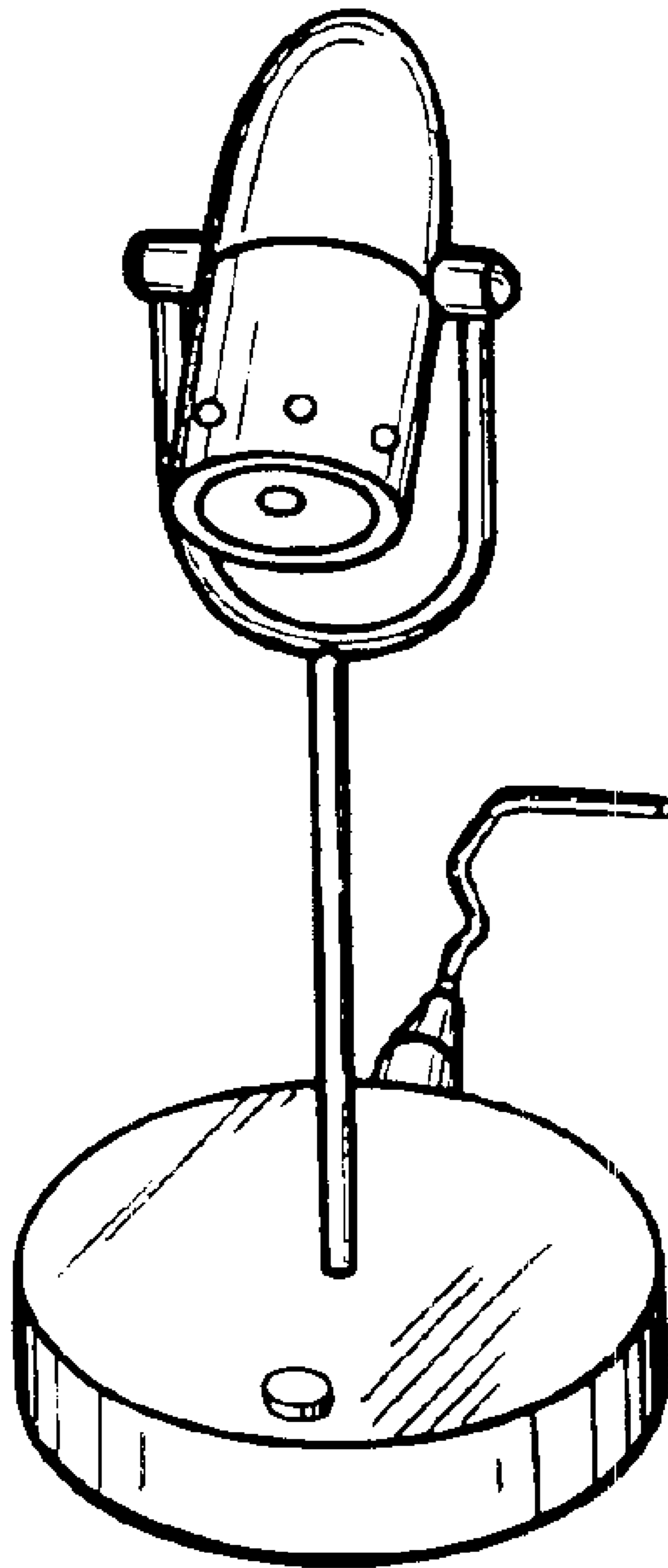

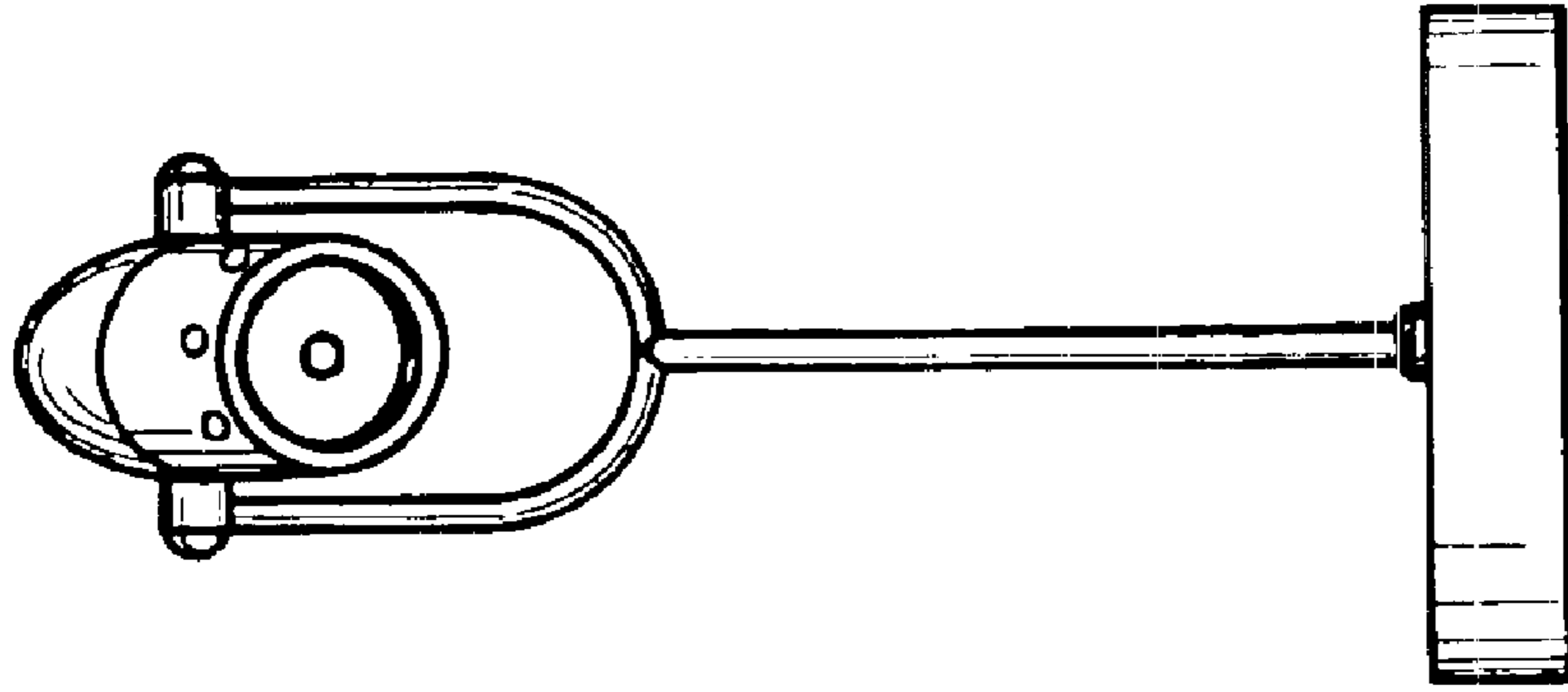

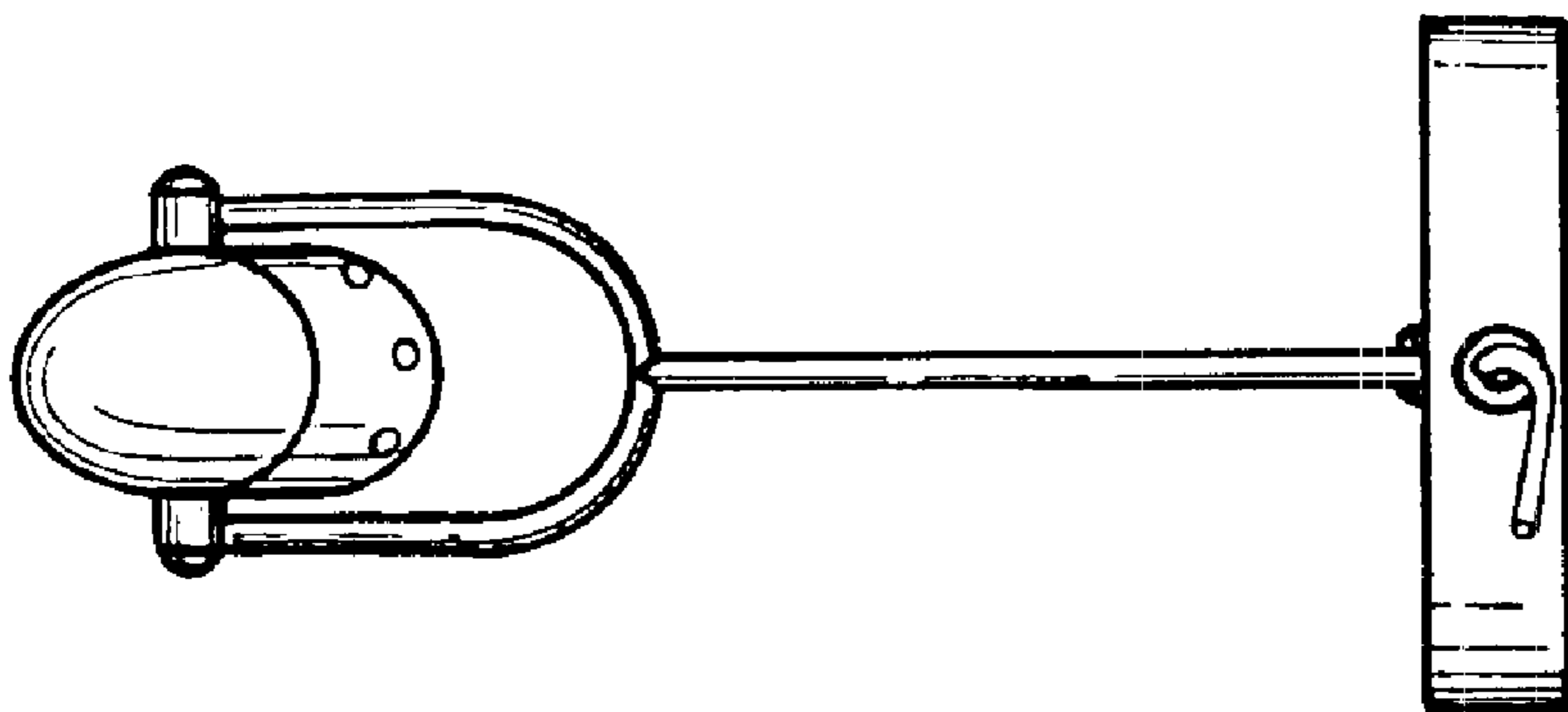

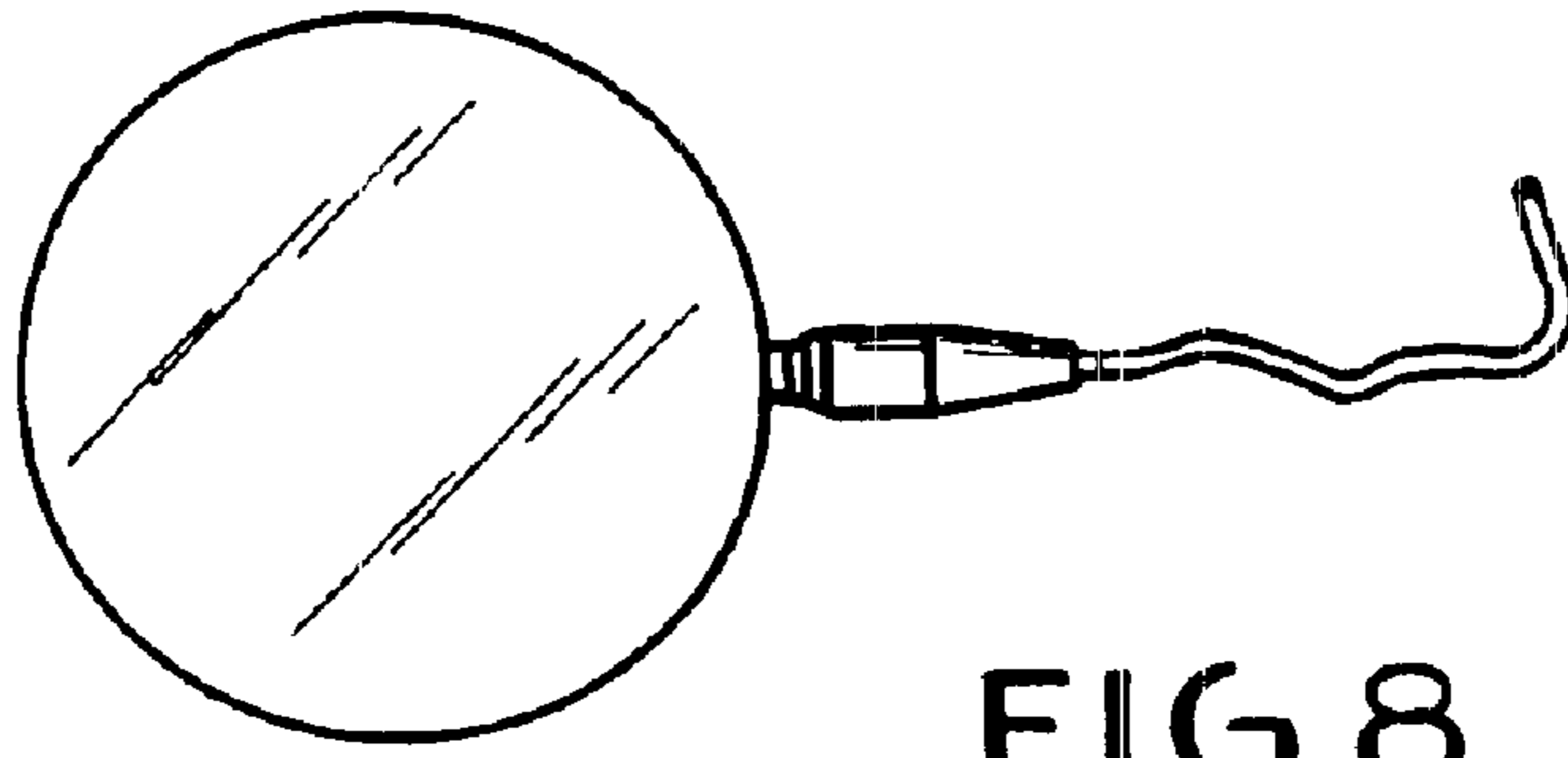

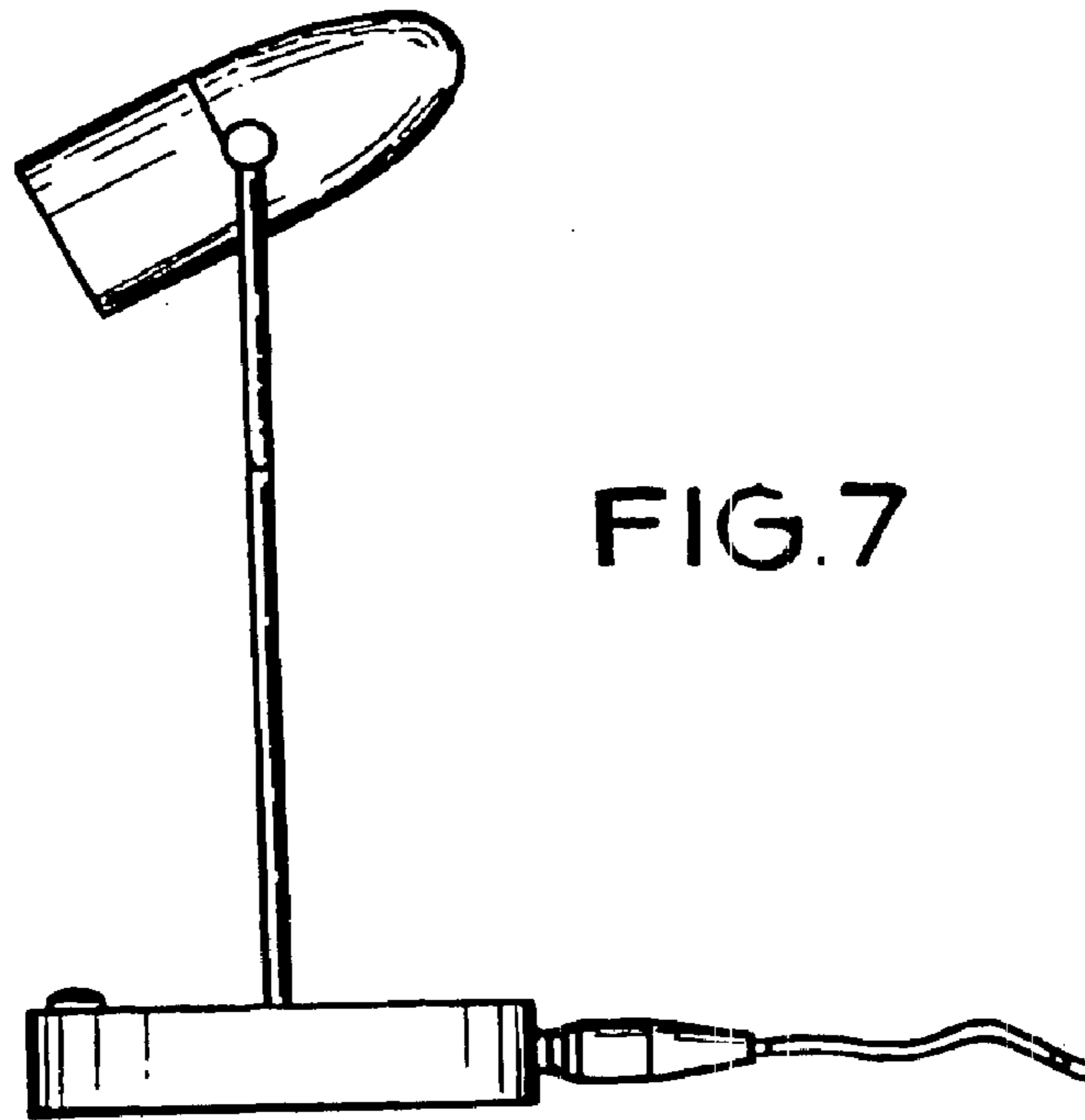

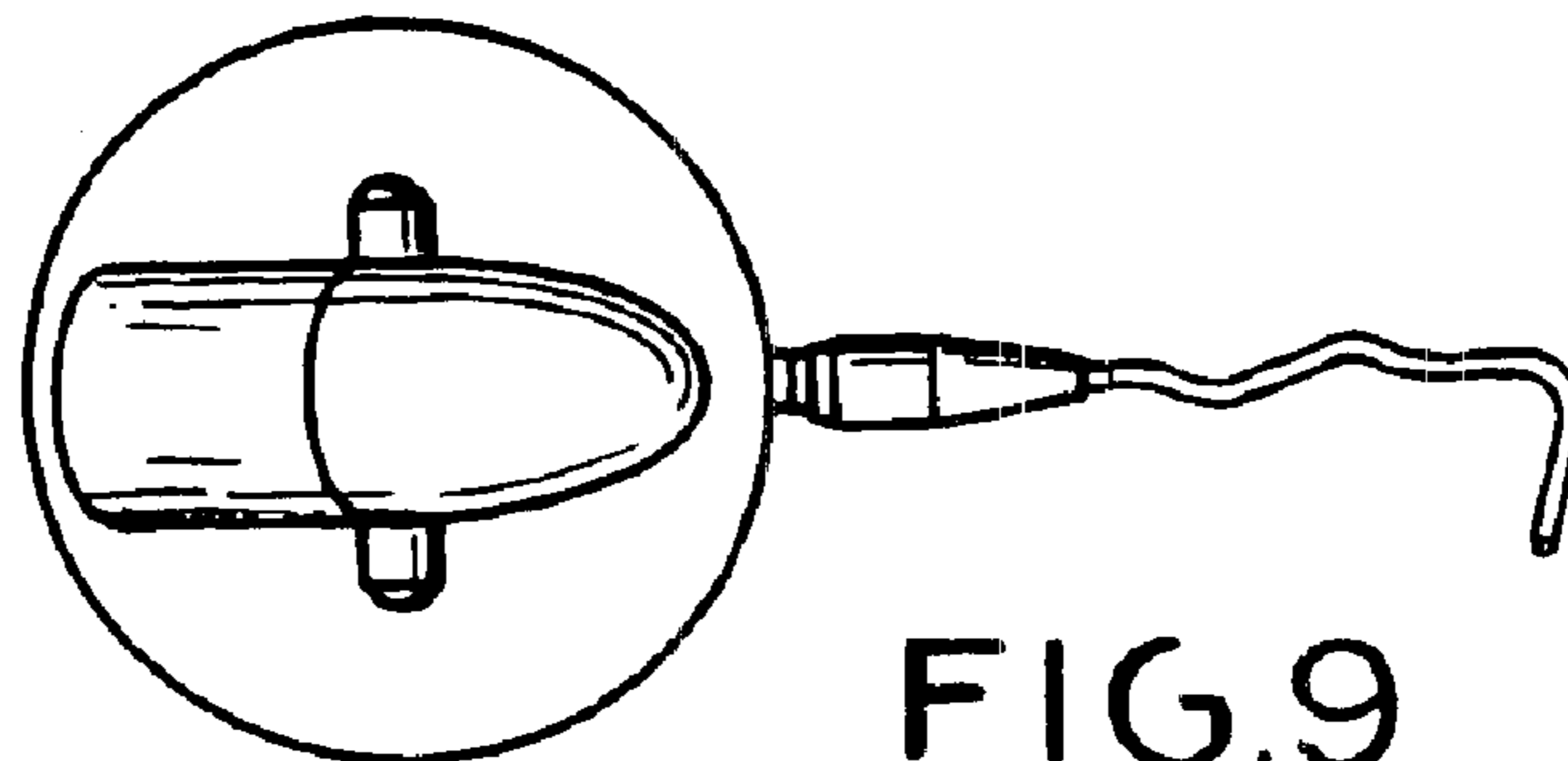

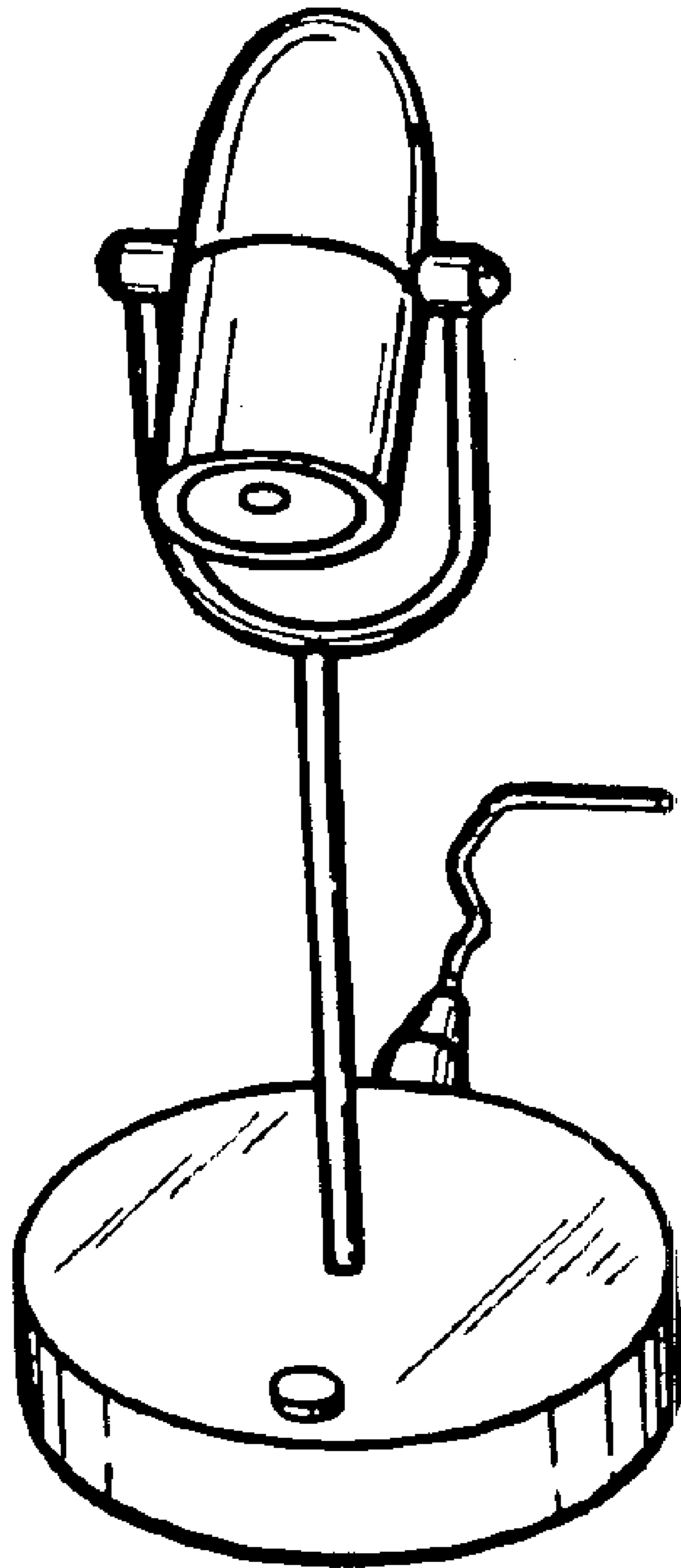

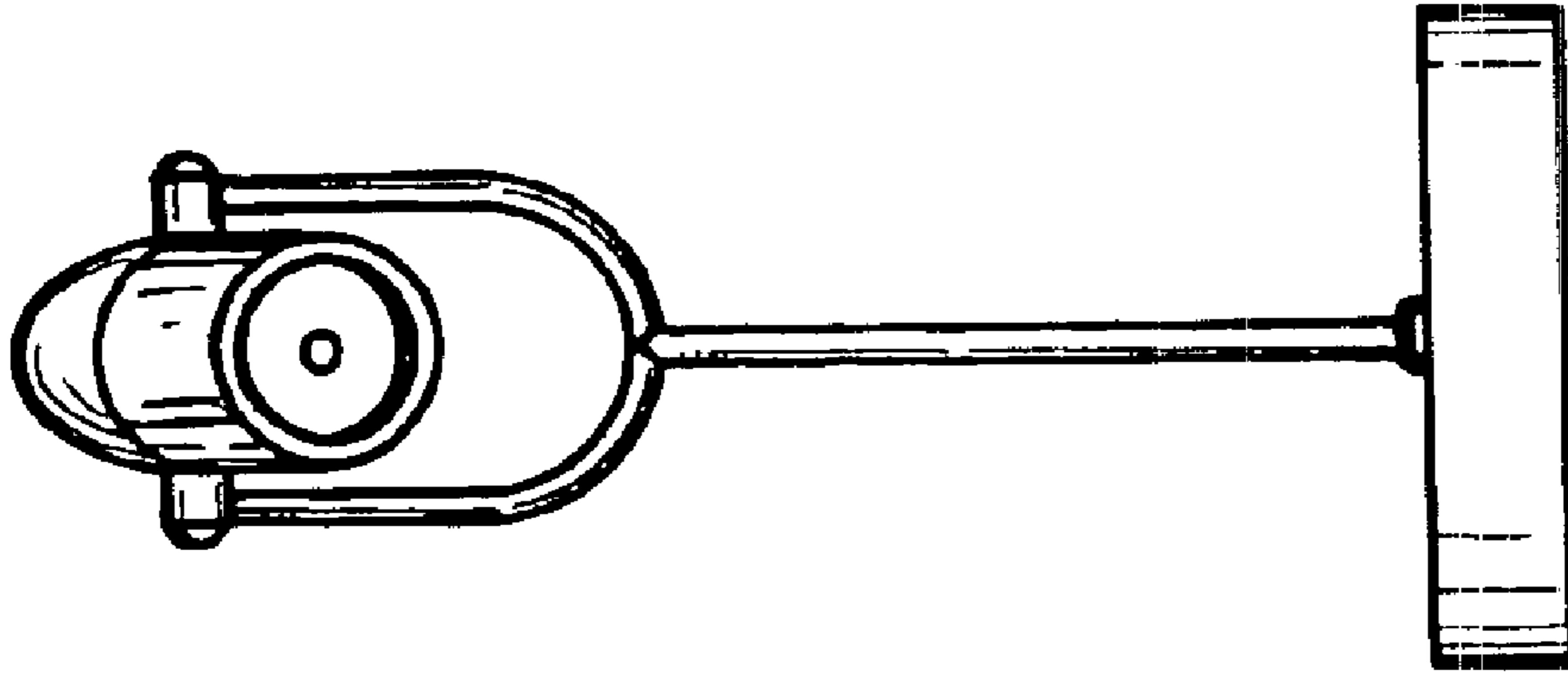

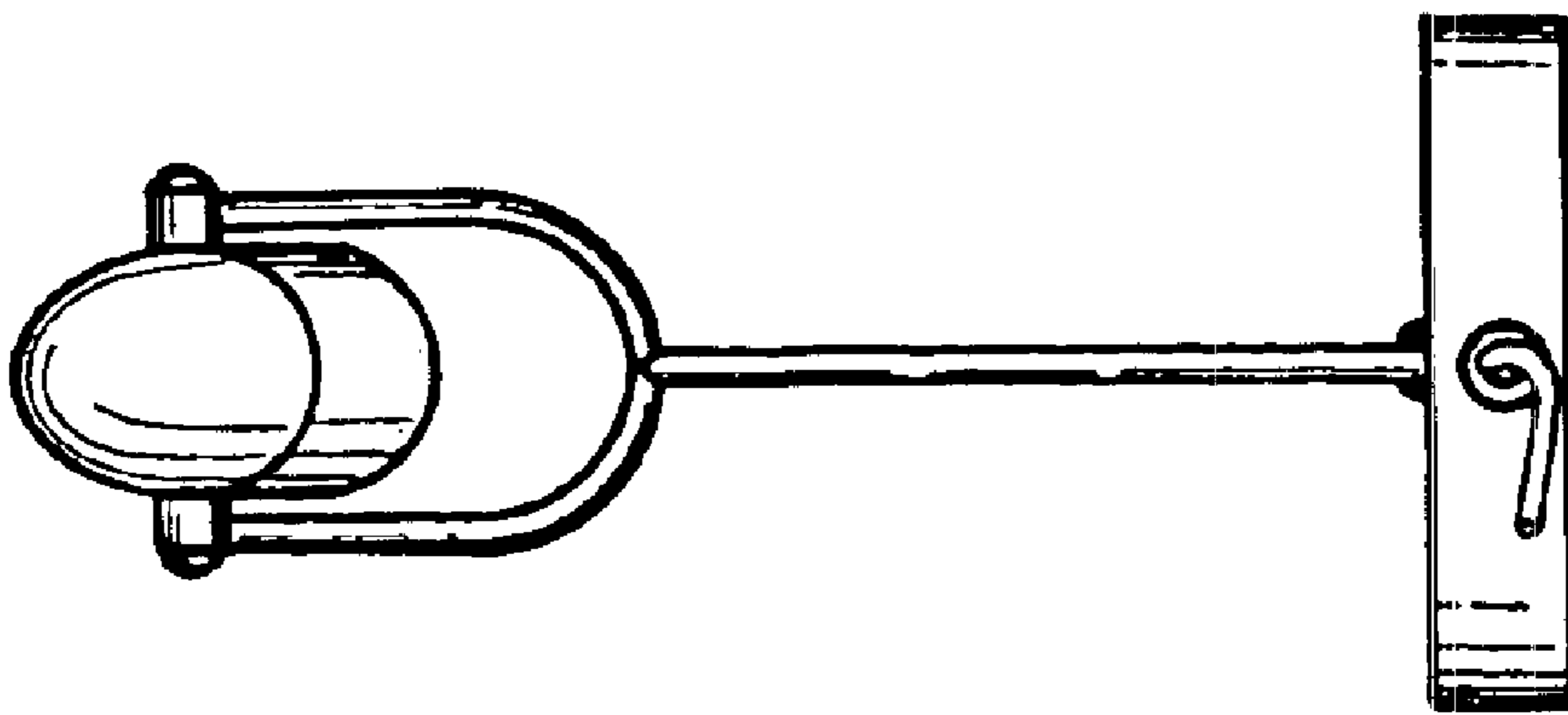
