FIG. 2 is a front elevation view thereof;
FIG. 3 is a side elevation view thereof, taken from the right as viewed in FIG. 2;
FIG. 4 is a top plan view thereof;
FIG. 5 is a side elevation view thereof, taken from the left as viewed in FIG. 2;
FIG. 6 is a rear elevational view thereof; and,
FIG. 7 is a bottom plan view thereof.

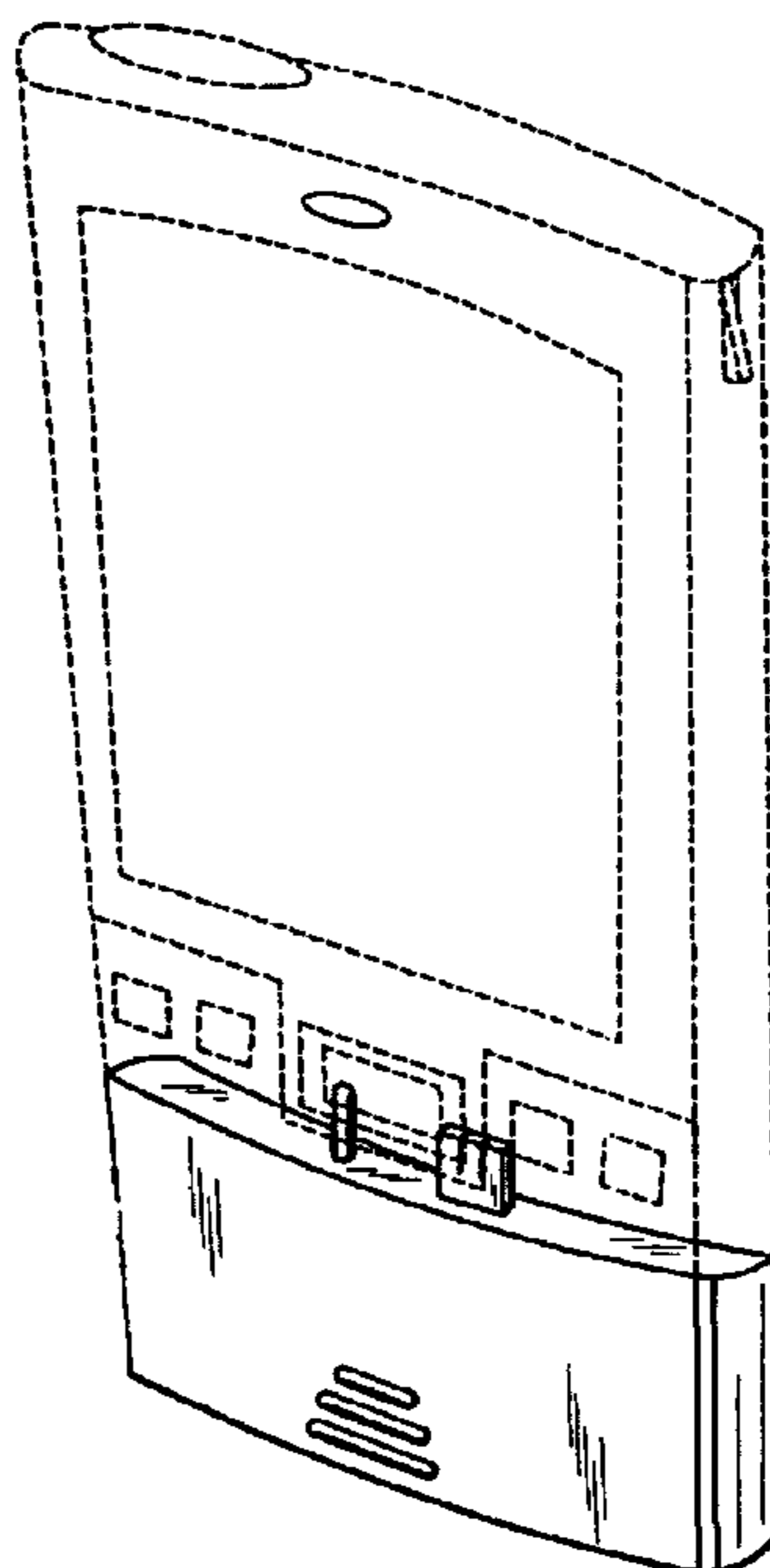

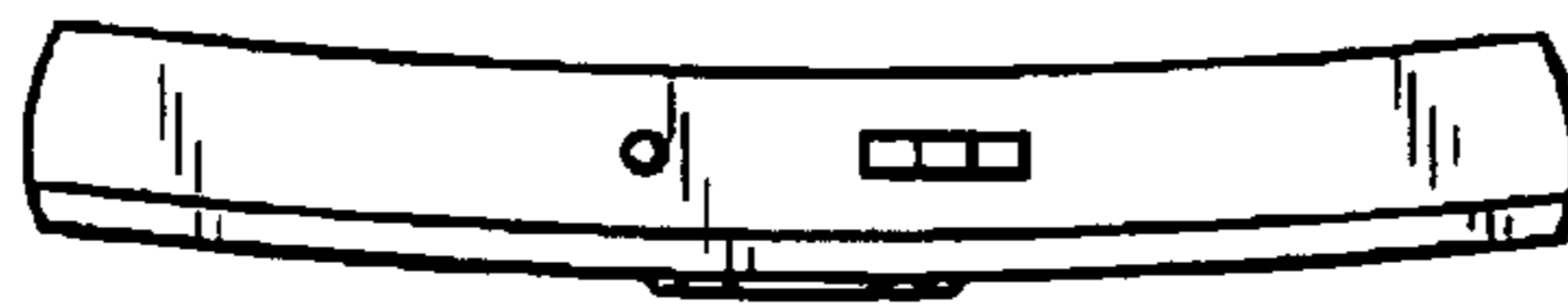
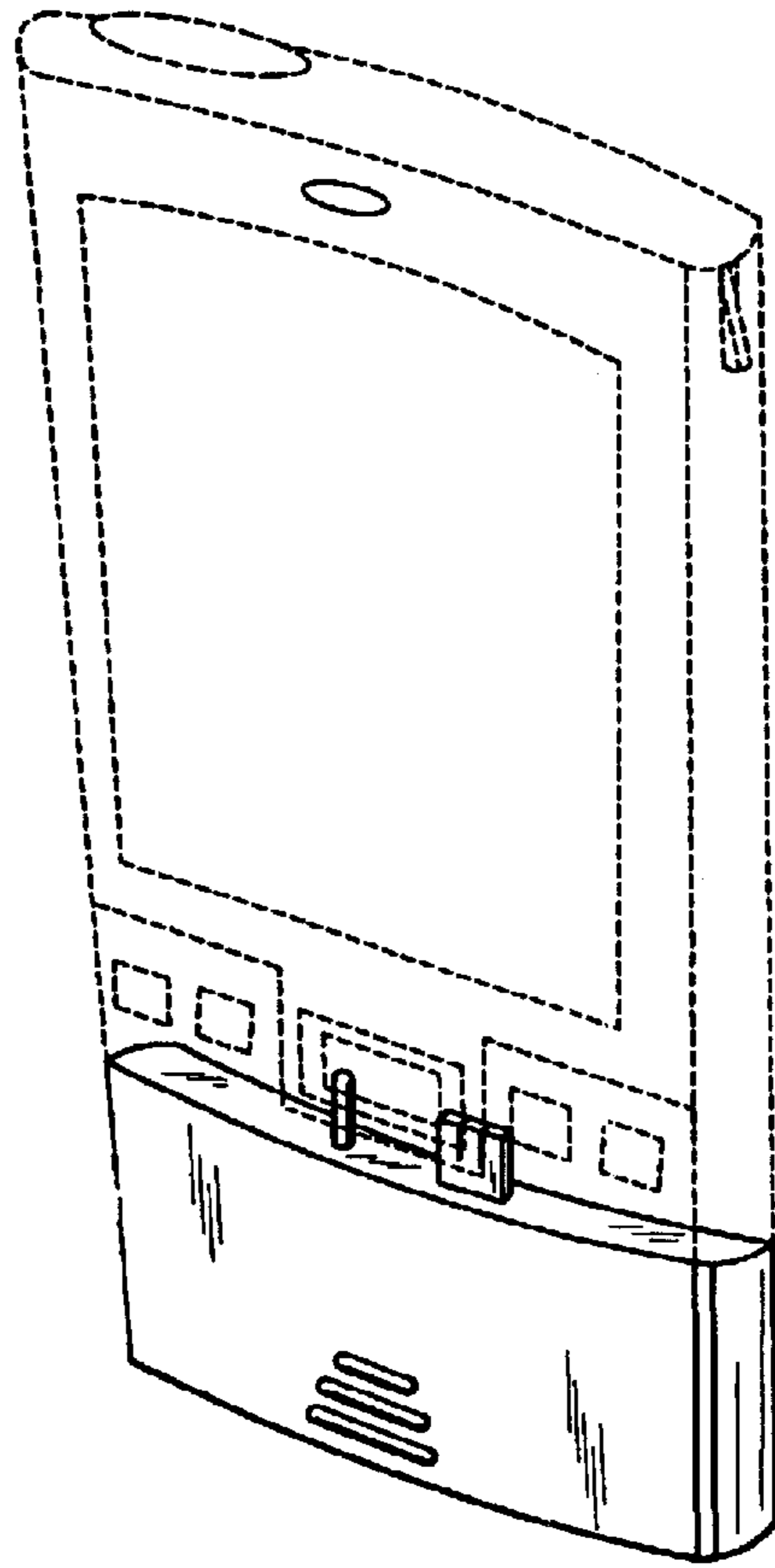

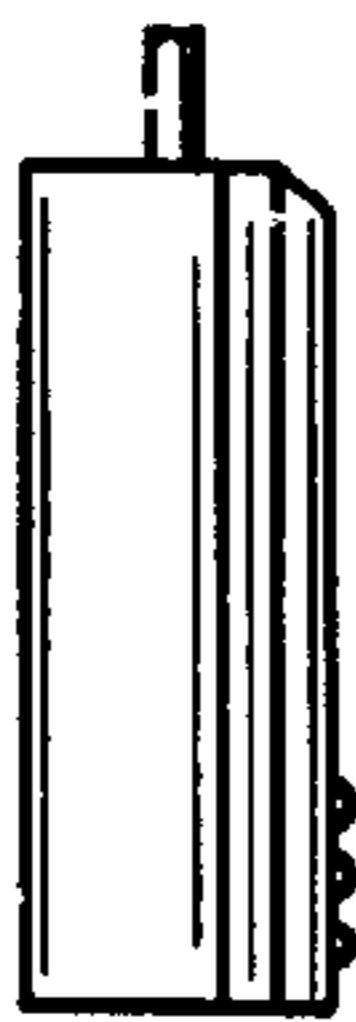

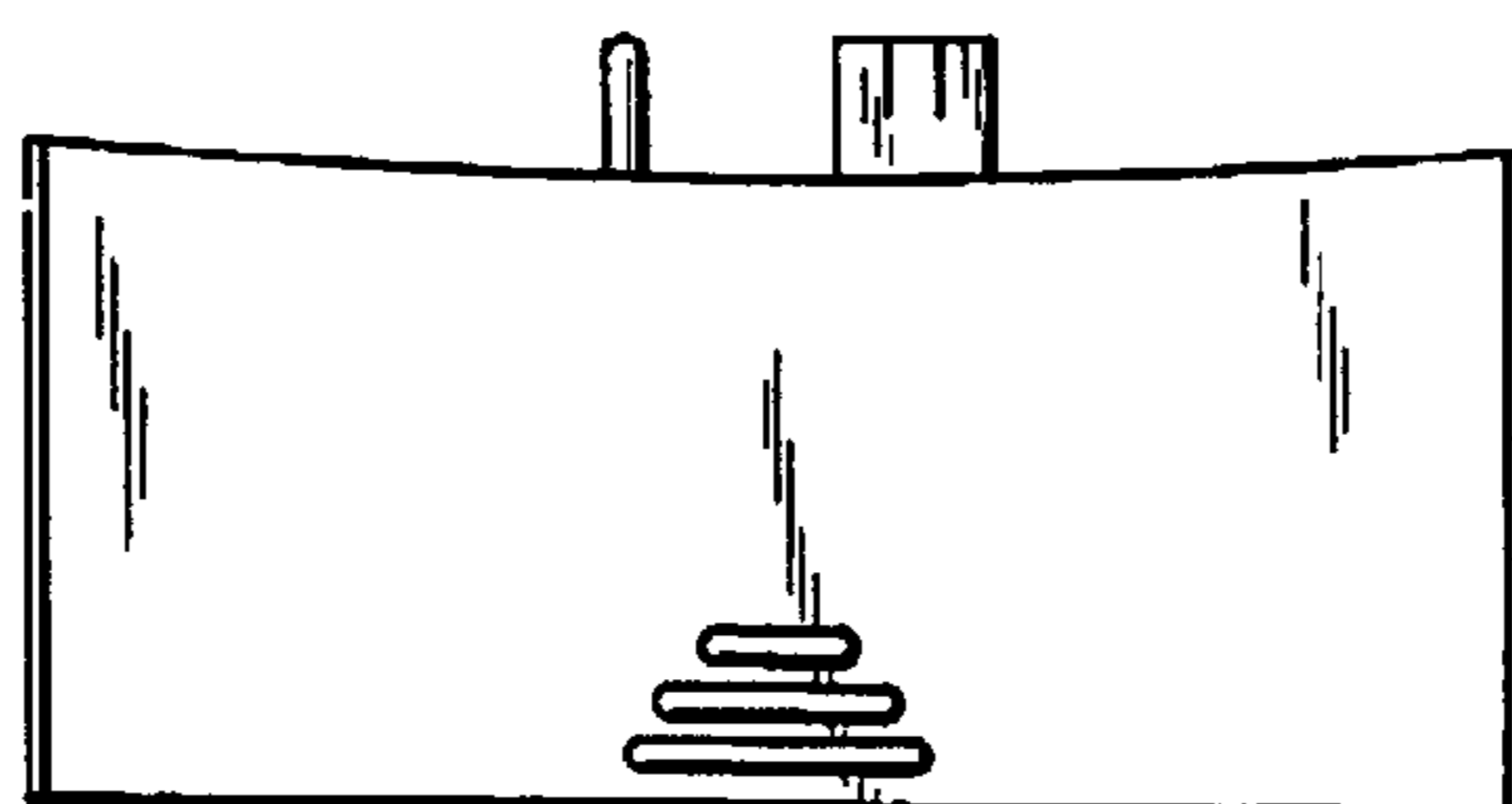

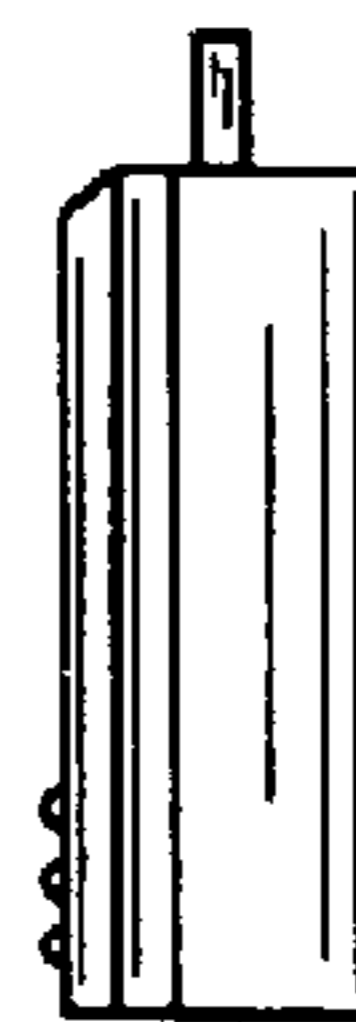

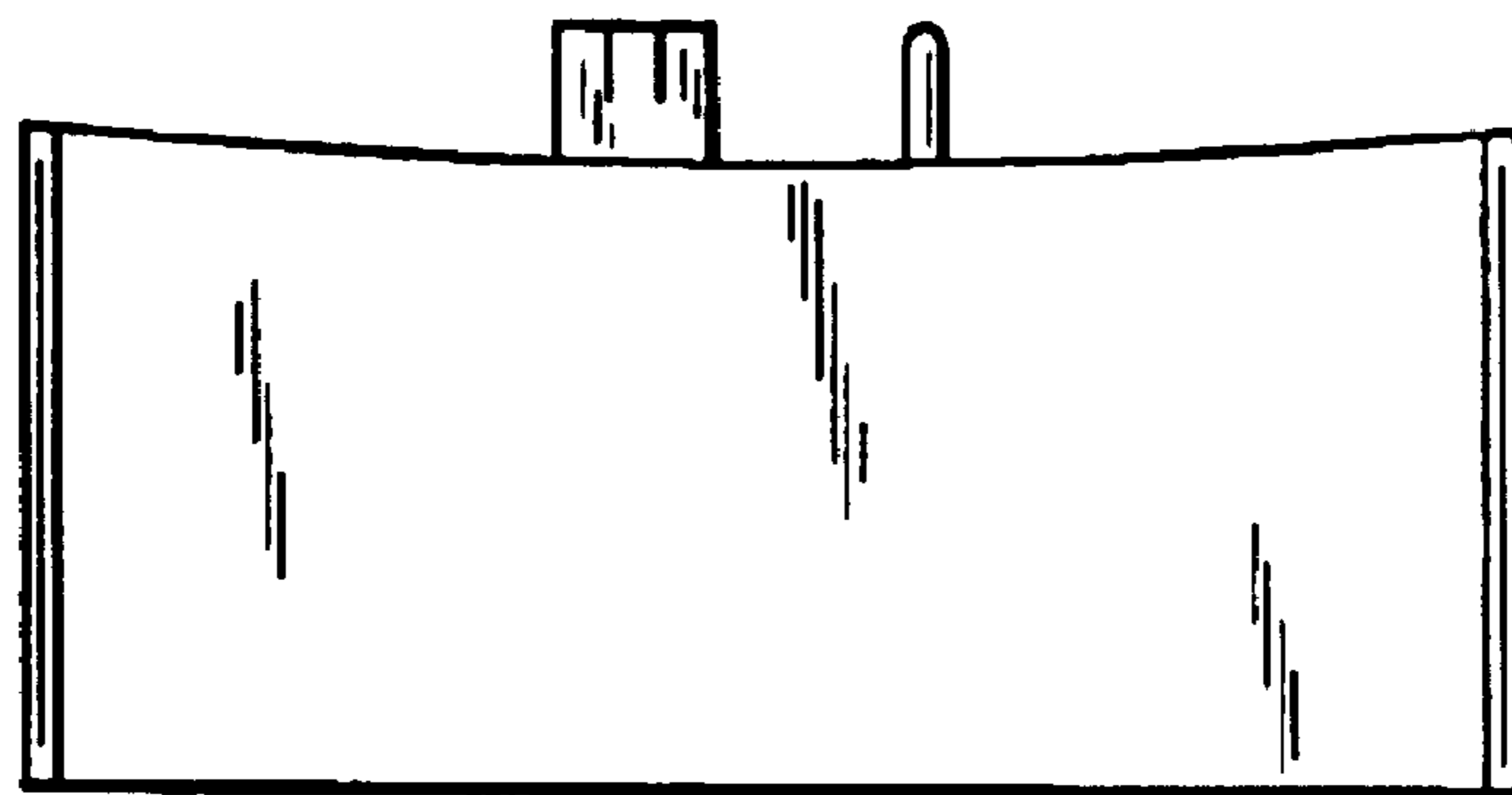

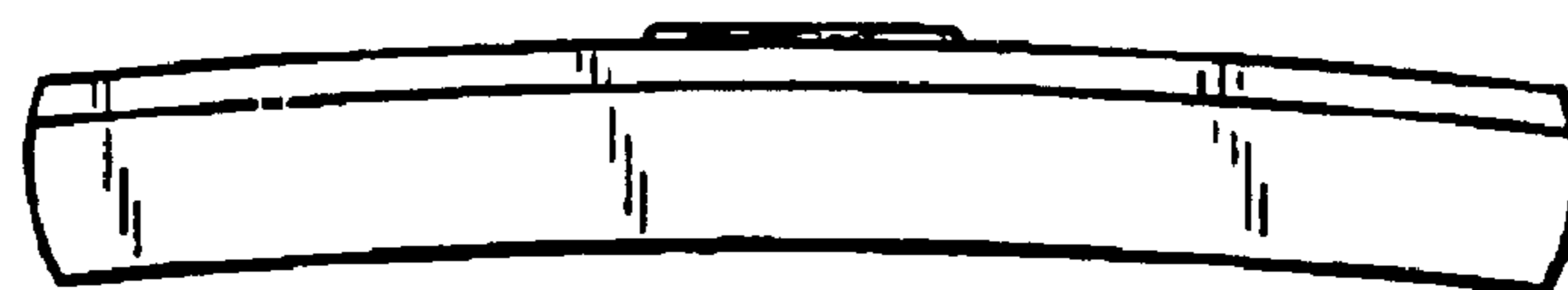
