showing my new design;

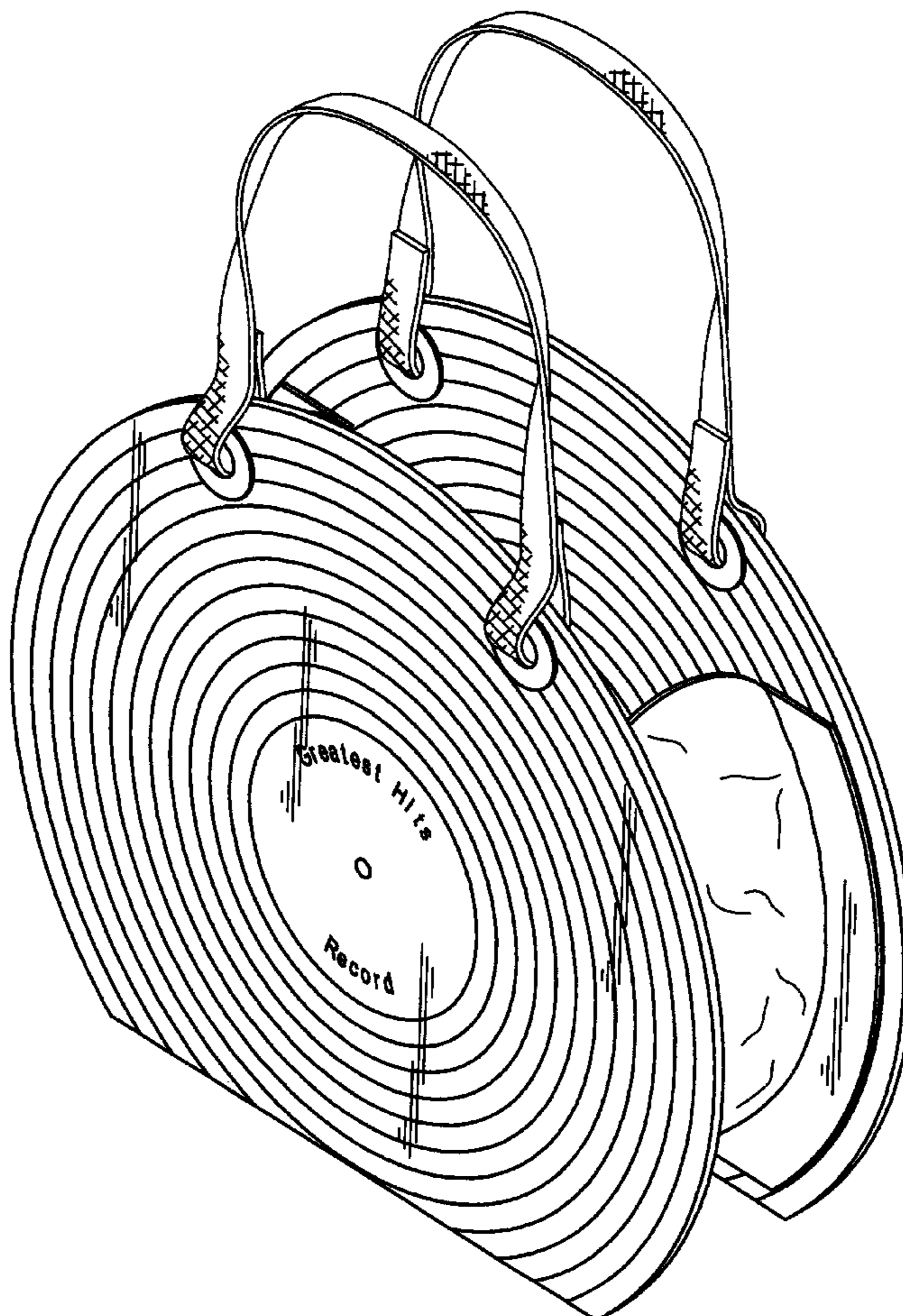
FIG. 2 is a front elevational view, the rear elevational view

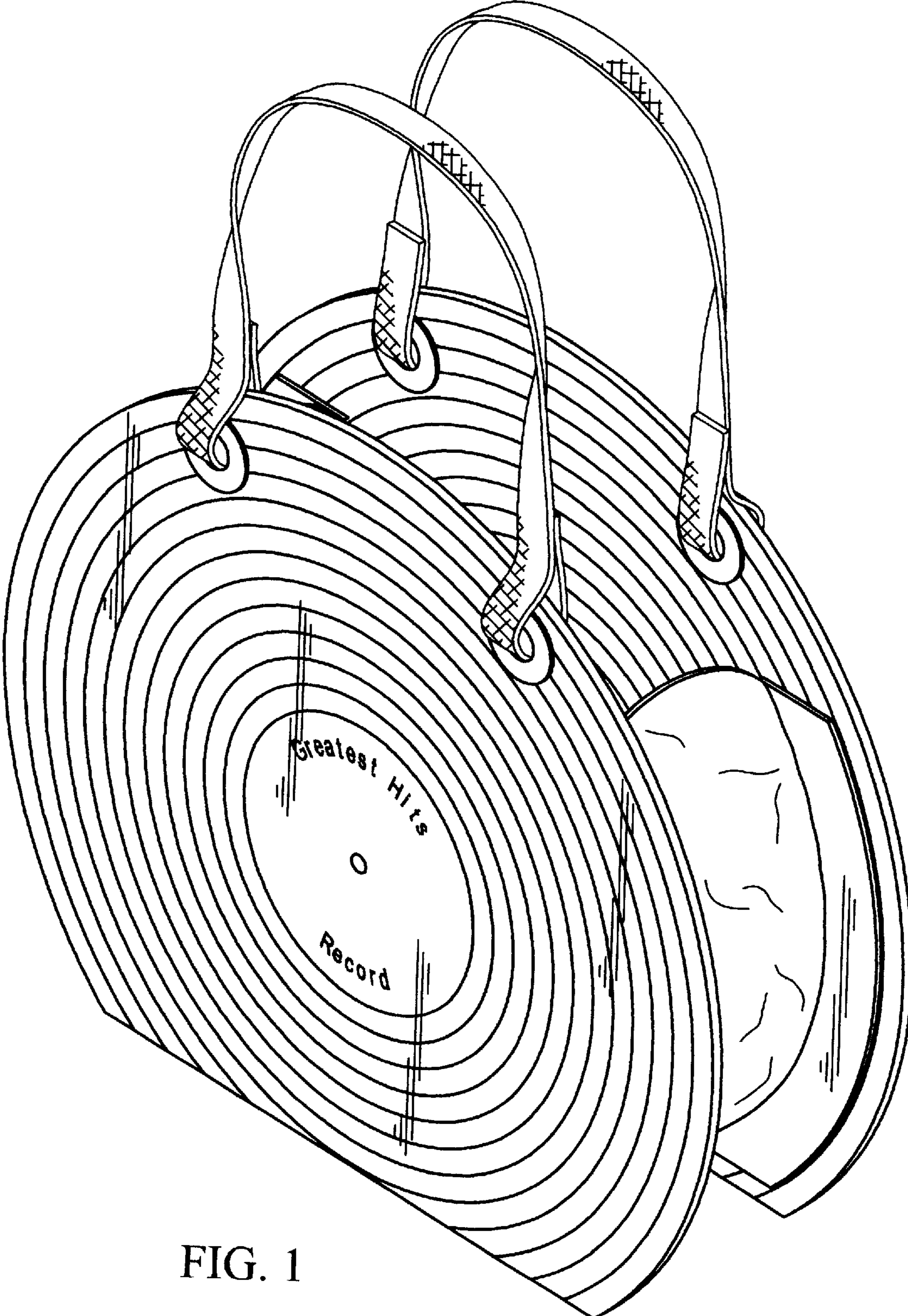

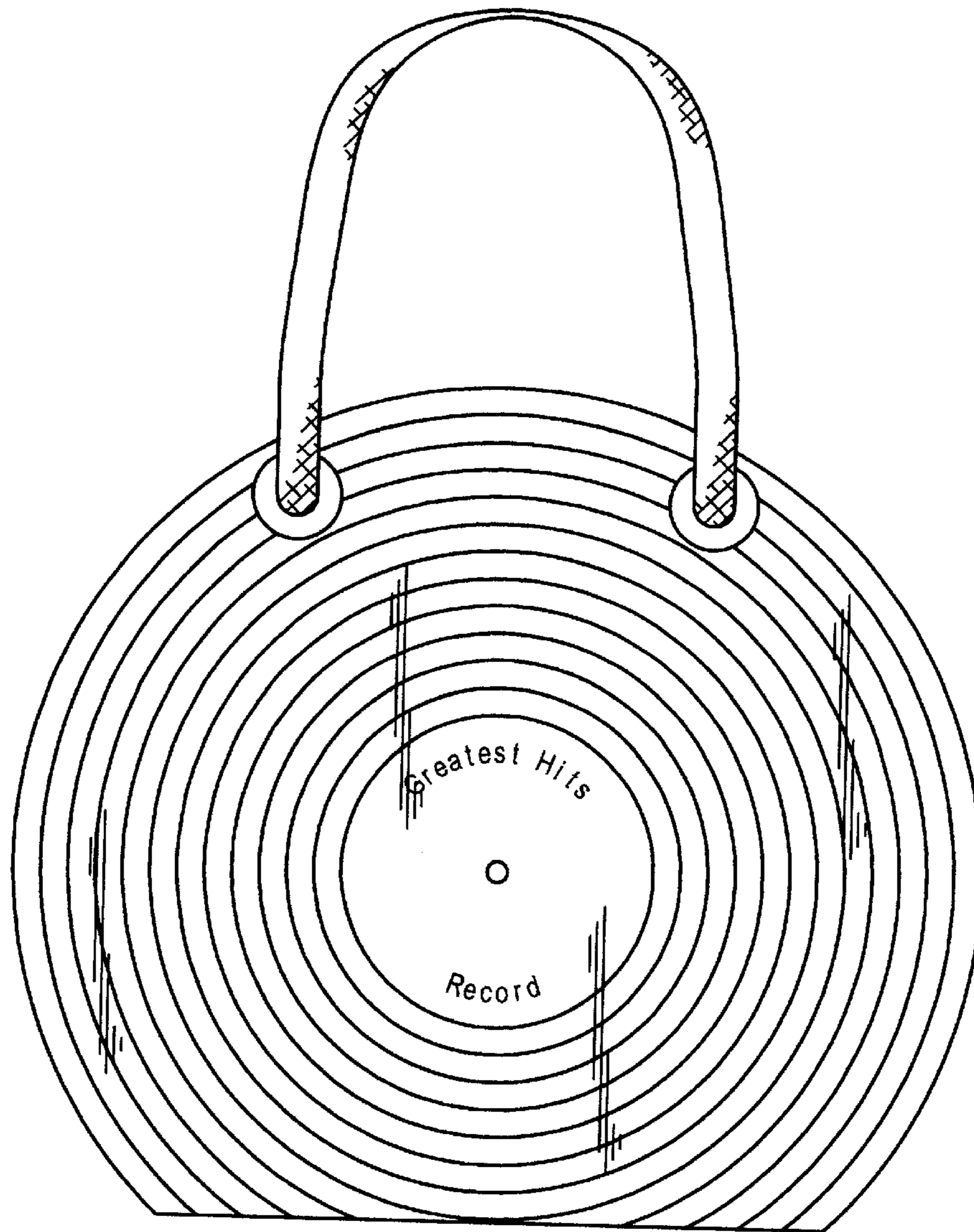

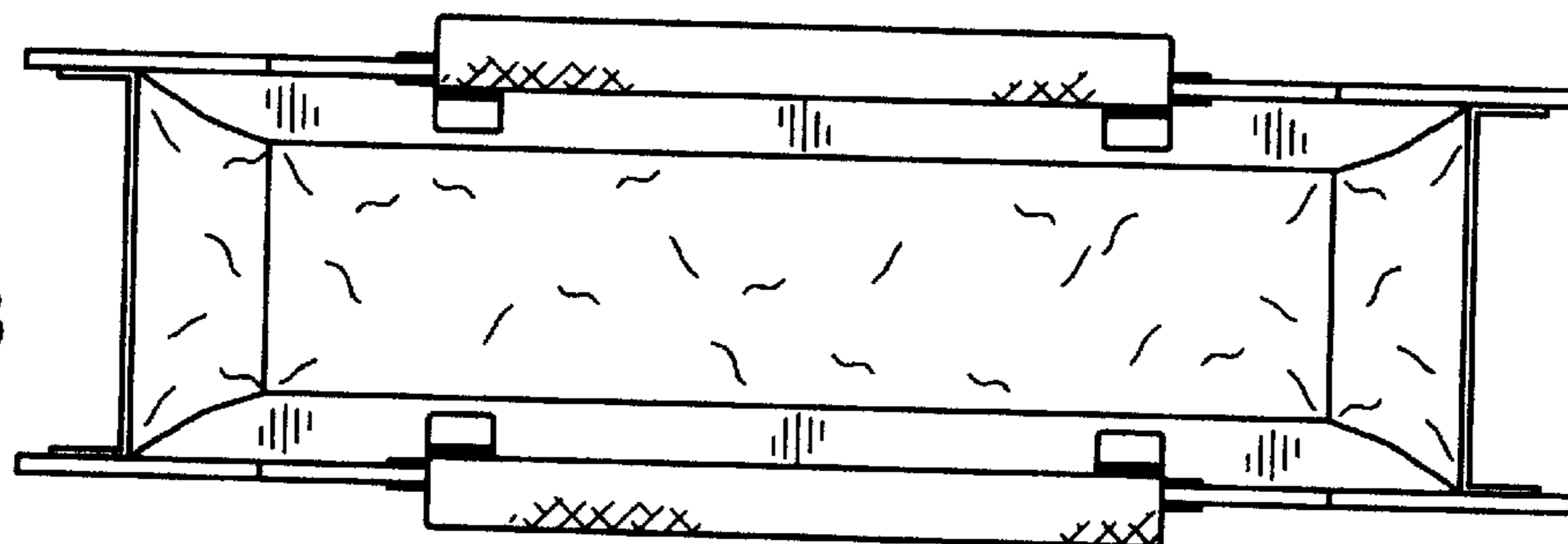

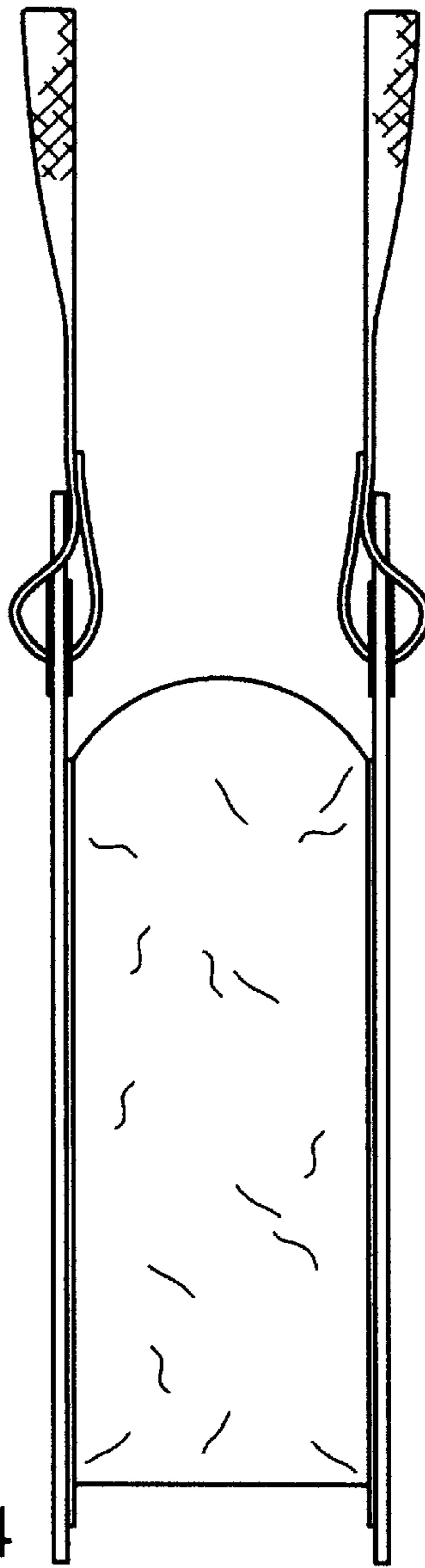

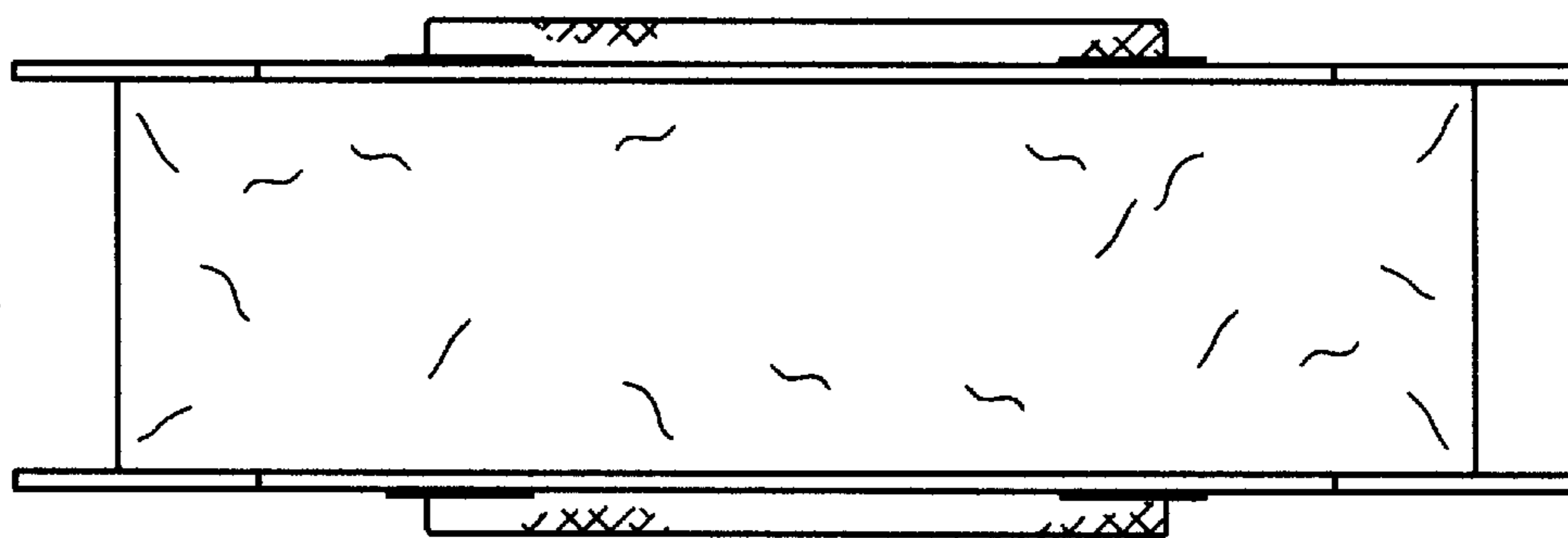
