The ornamental design for a vehicle seat, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a vehicle seat of the present invention;

FIG. 2 is a right elevation view of the vehicle seat shown in FIG. 1, with a left elevation view of the vehicle seat shown in FIG. 1 being a mirror image of FIG. 2;

FIG. 3 is a front elevation view of the vehicle seat shown in FIG. 1;

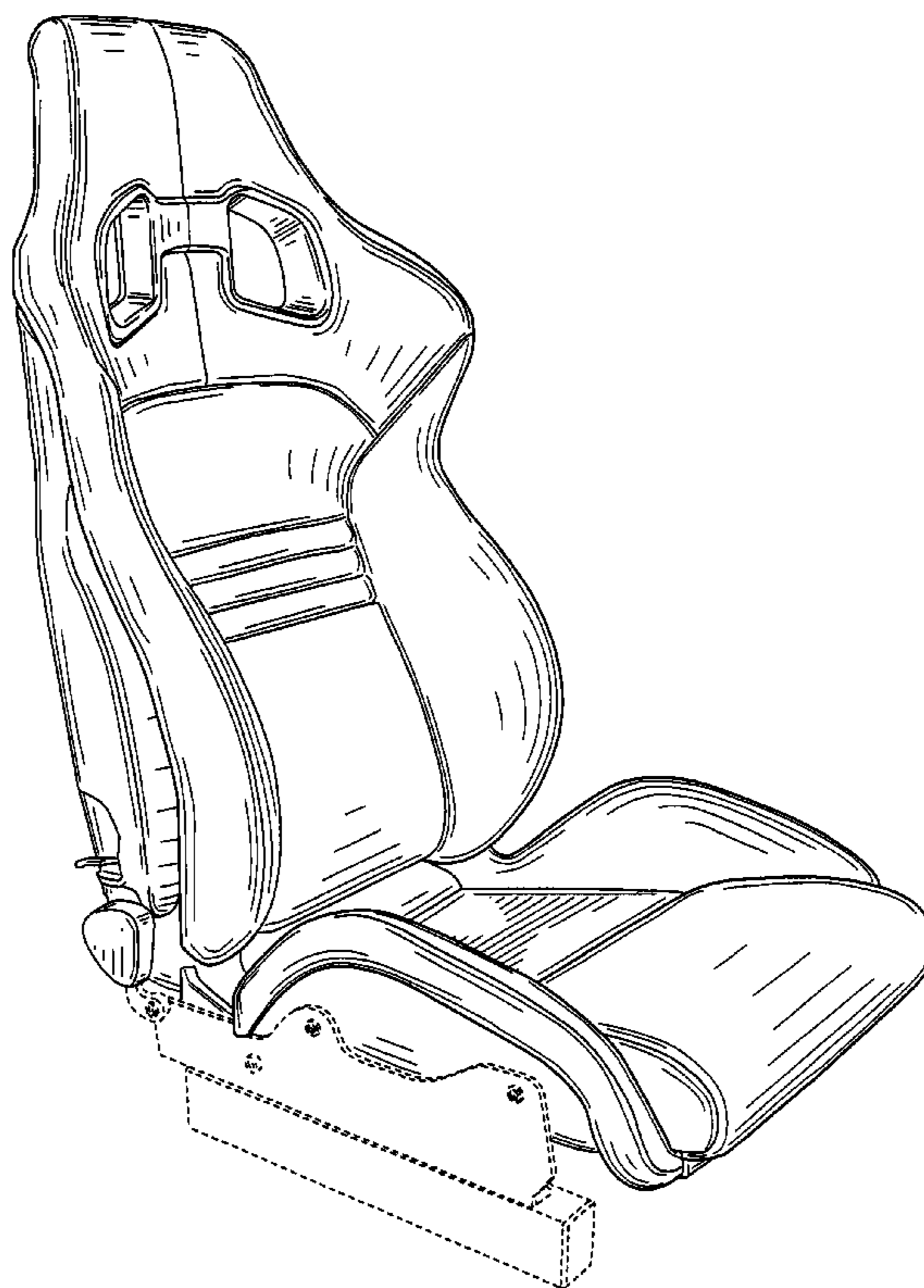
FIG. 4 is a rear elevation view of the vehicle seat shown in FIG. 1;

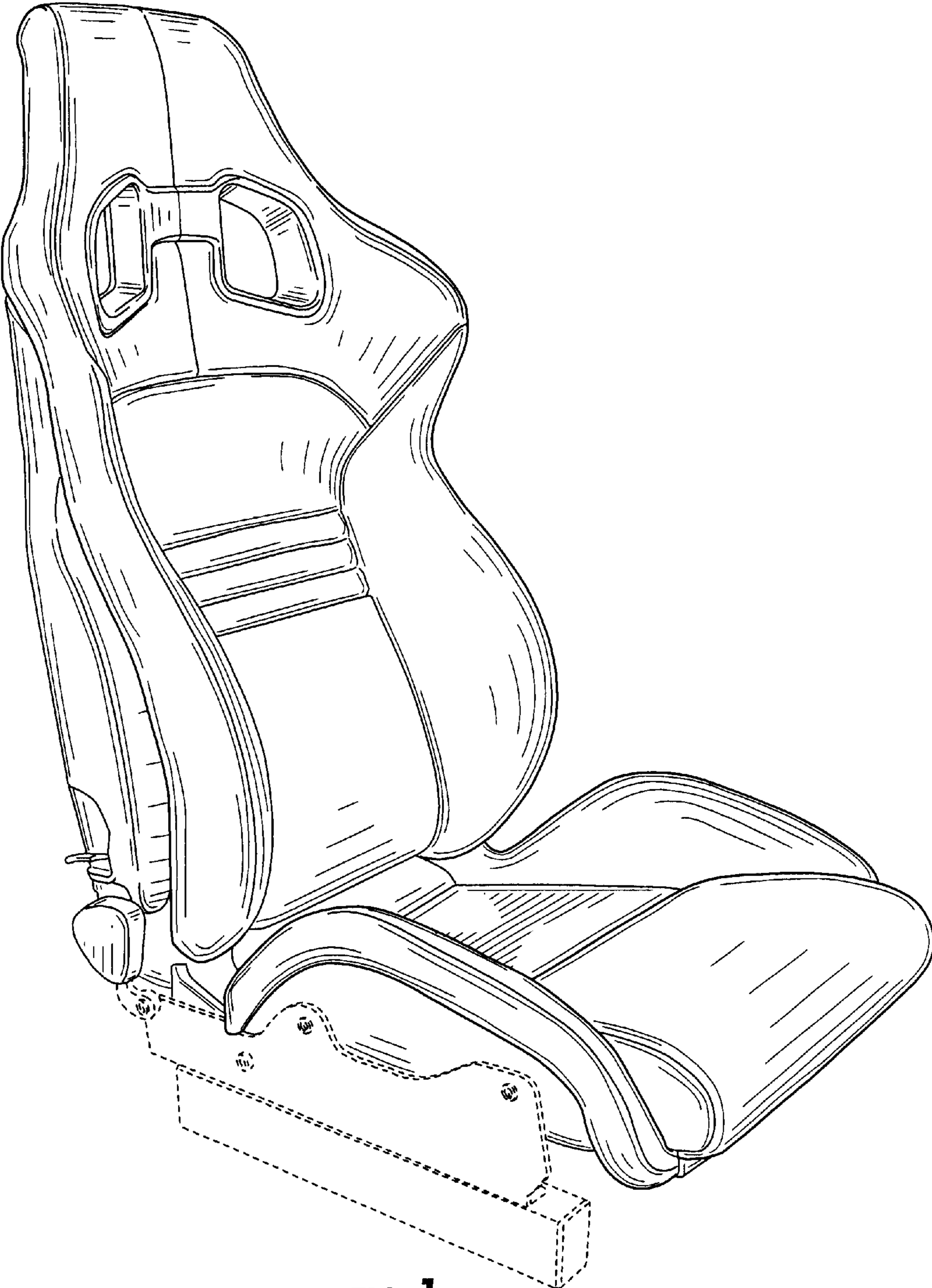

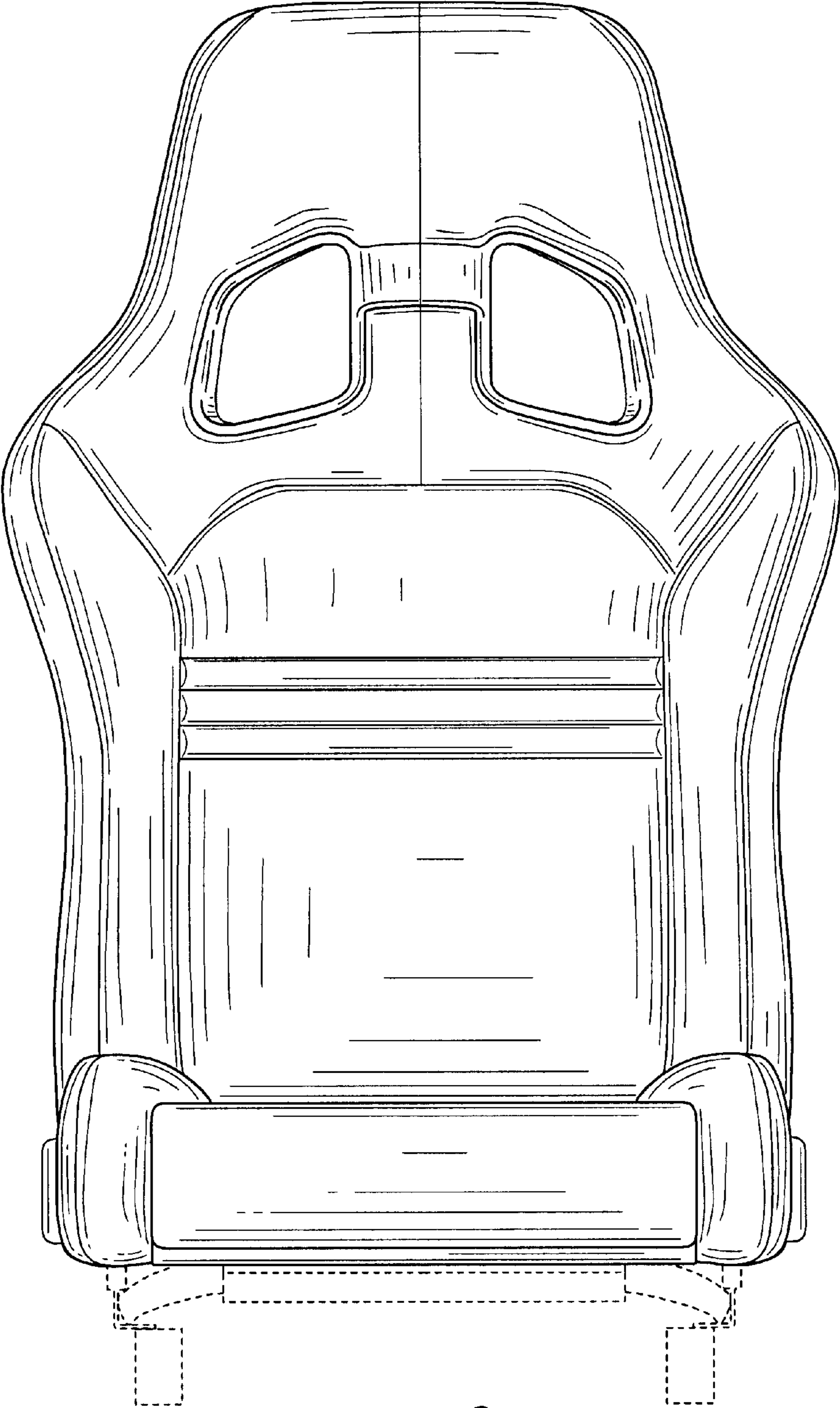

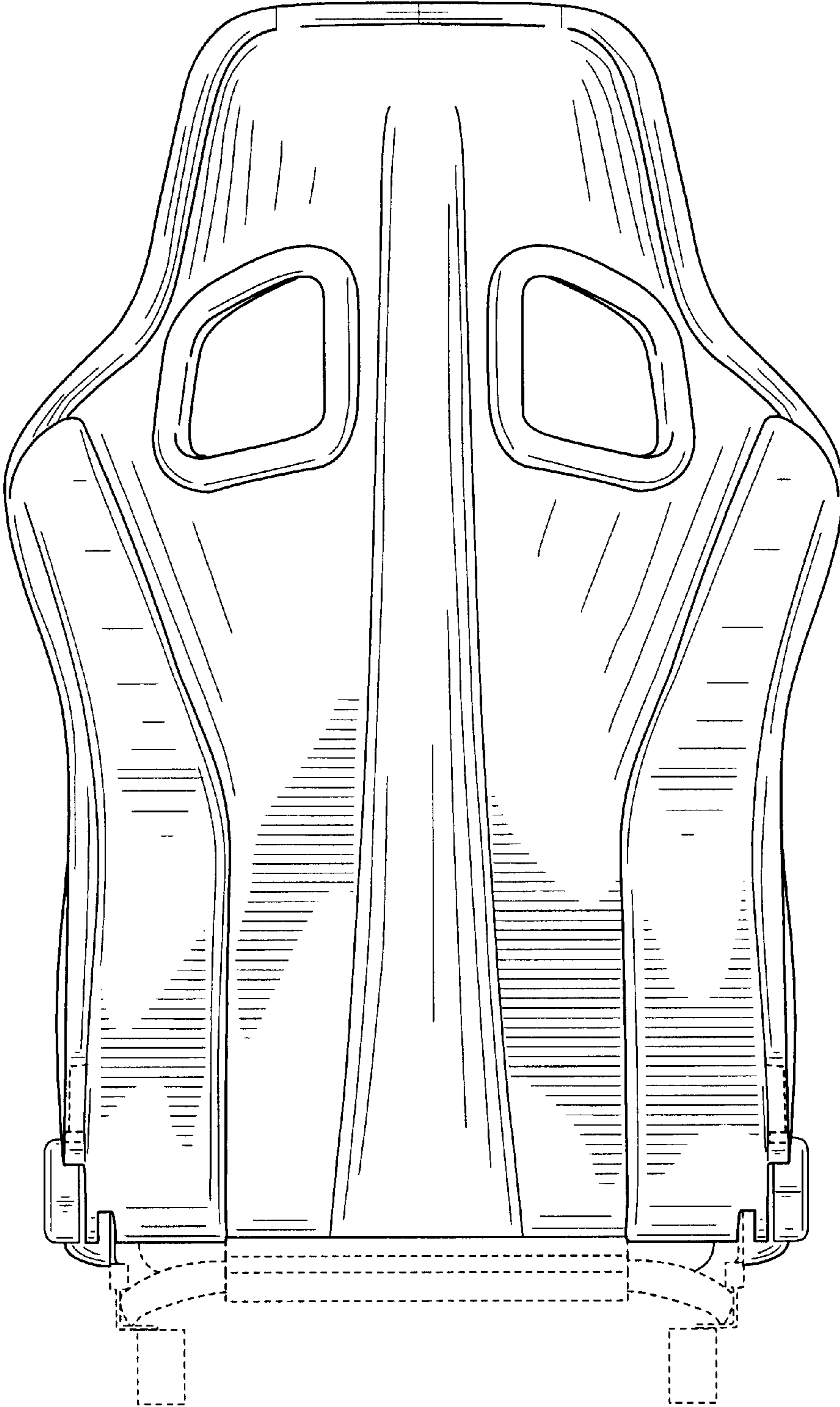

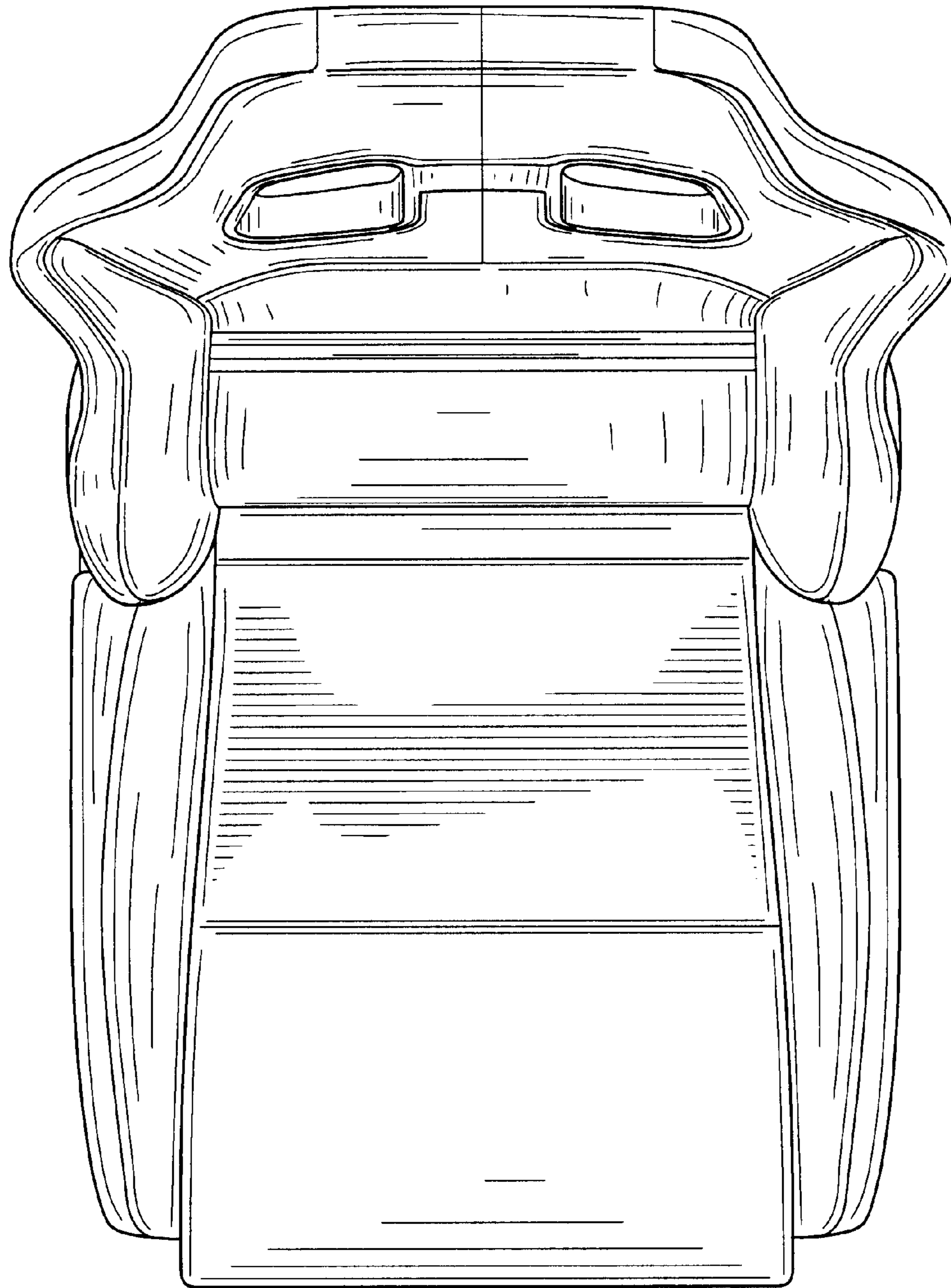

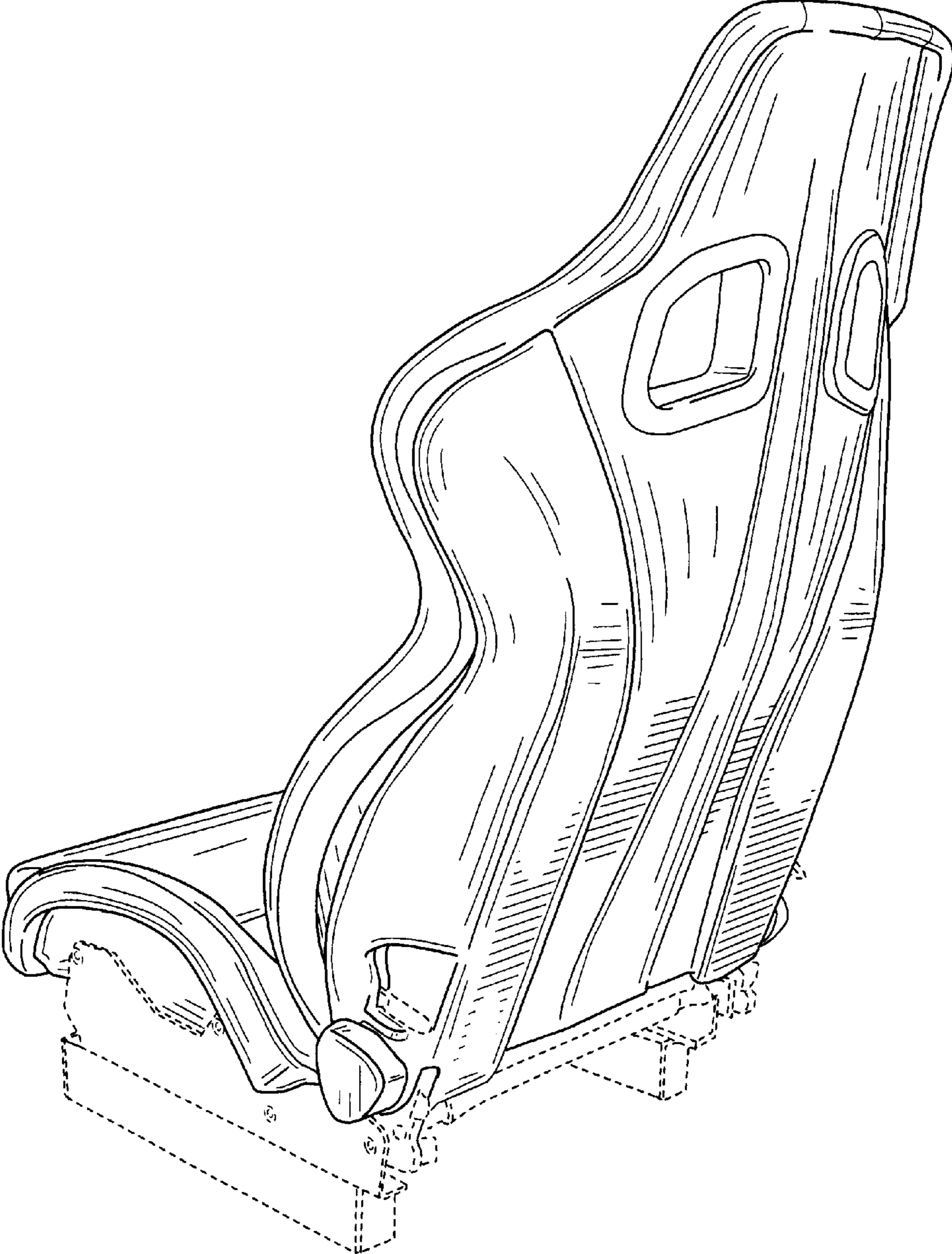
