The ornamental design for a knife, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the knife according to the present invention;

FIG. 2 is a top plan view of the knife;

FIG. 3 is an elevational view of one side of the knife according to the present invention;

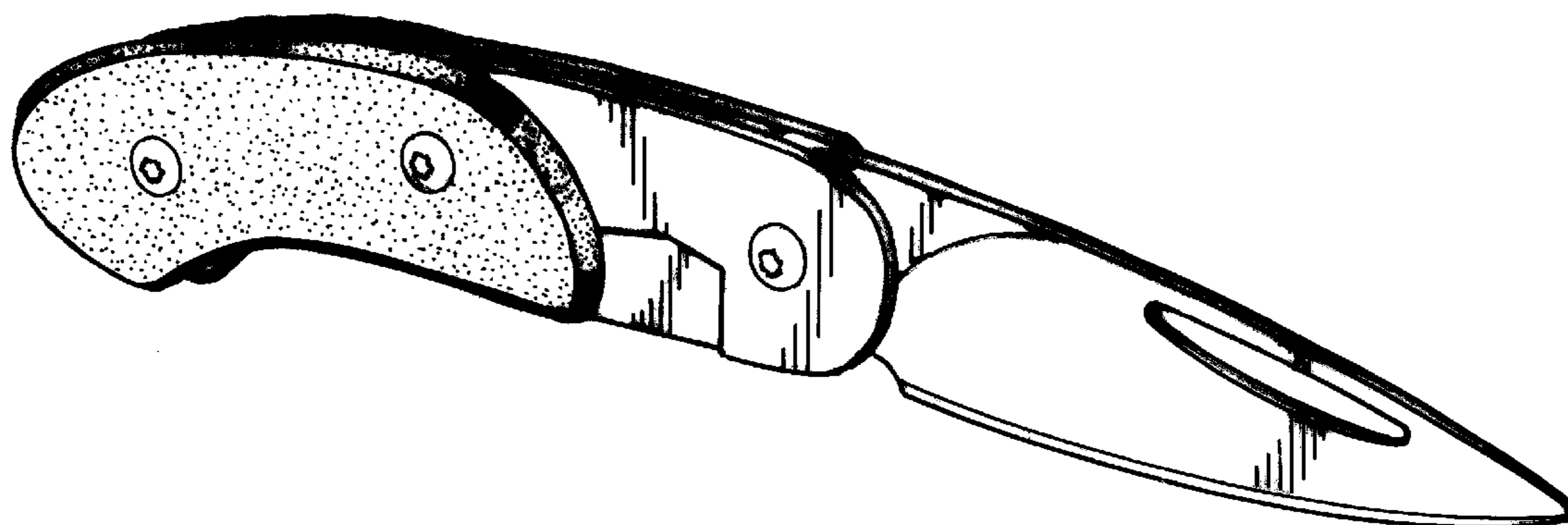
FIG. 4 is a bottom plan view thereof;

FIG. 5 is an elevational view of the knife which is opposite the side shown in FIG. 3;

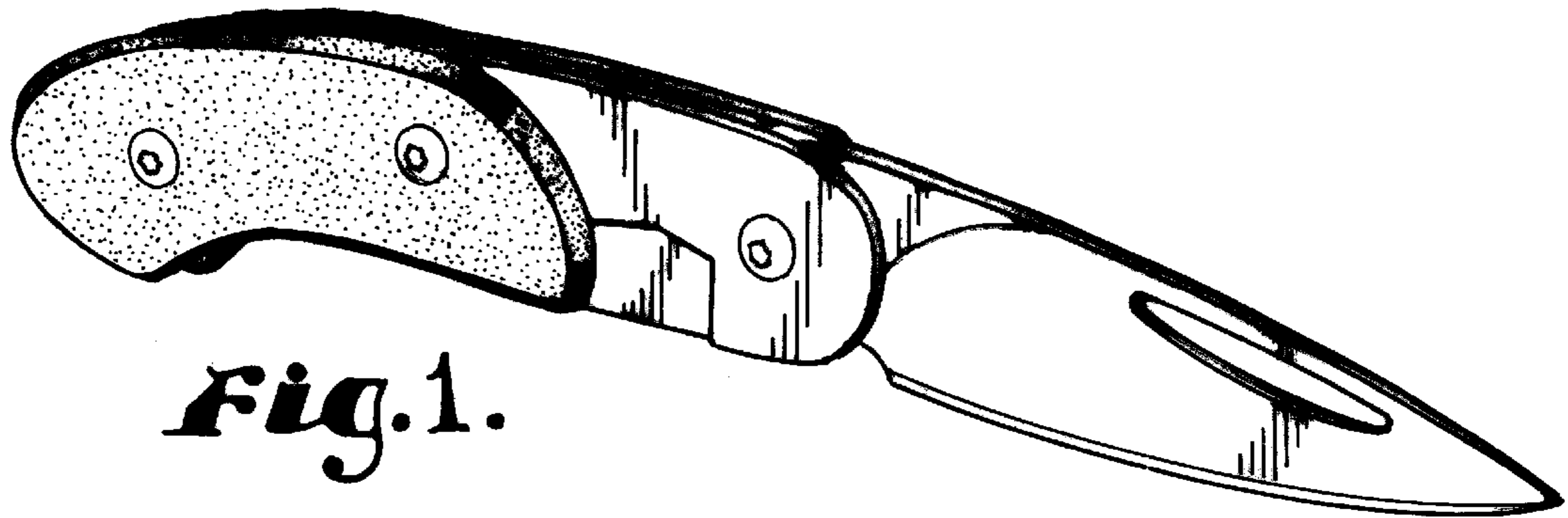

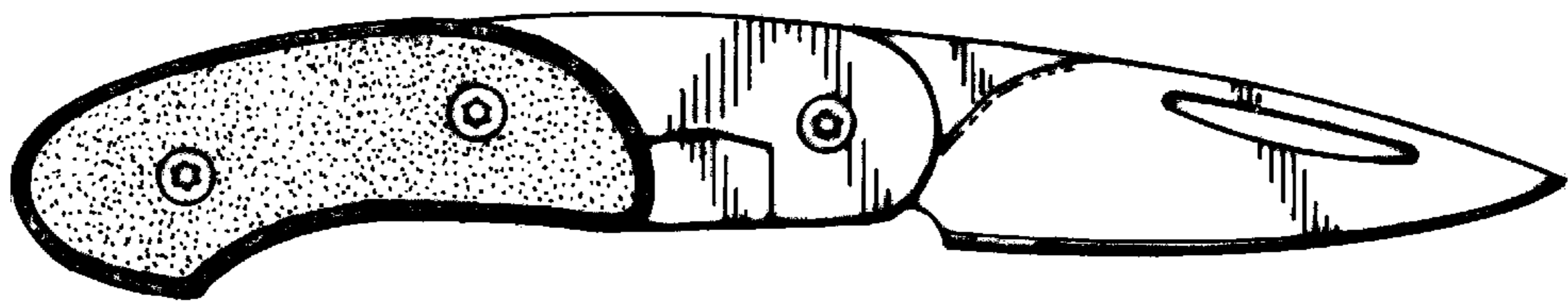

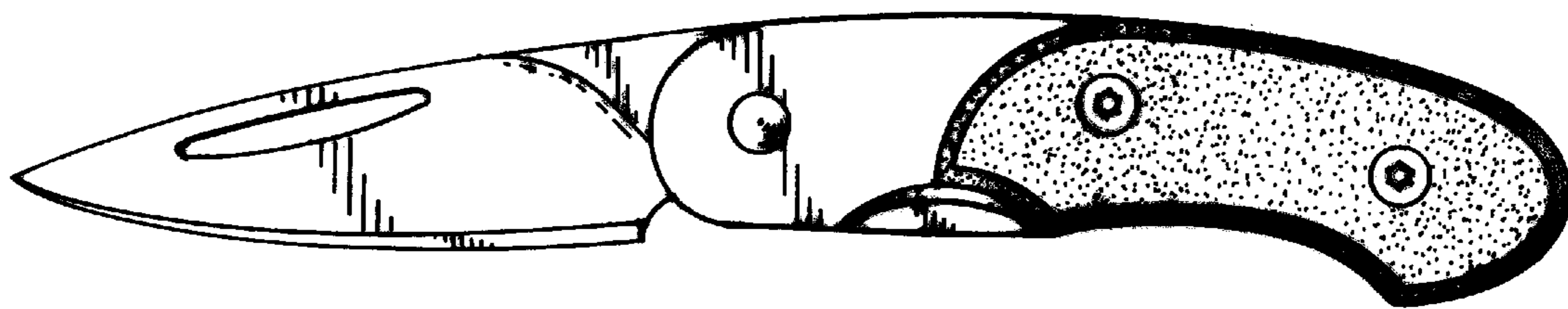
