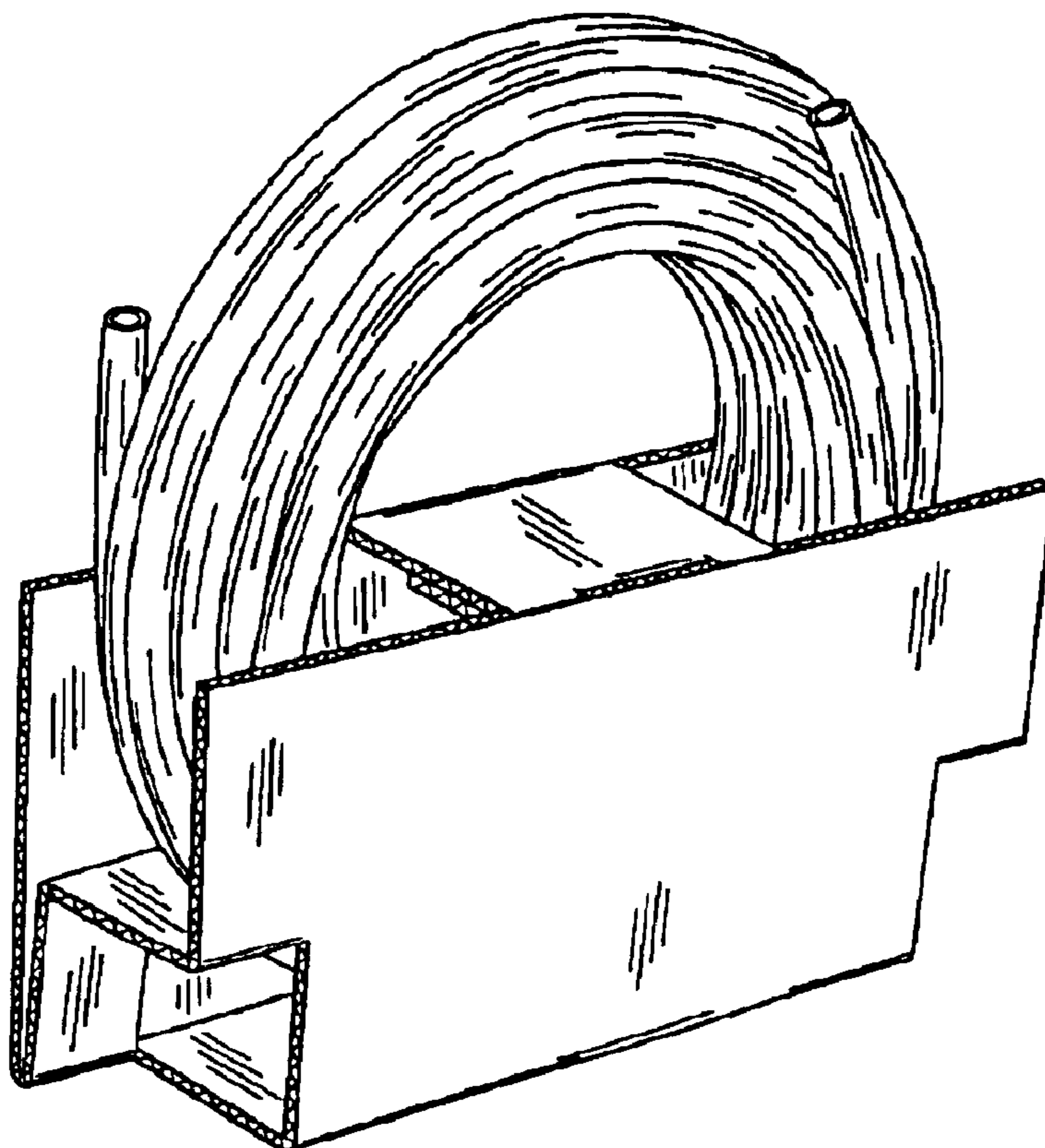
(57) **CLAIM**

The ornamental design for a package and flexible tubing, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a package and flexible tubing showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a side elevation view thereof;
FIG. 4 is a front elevation view thereof, opposite that which is shown in FIG. 3;
FIG. 5 is a rear elevation view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

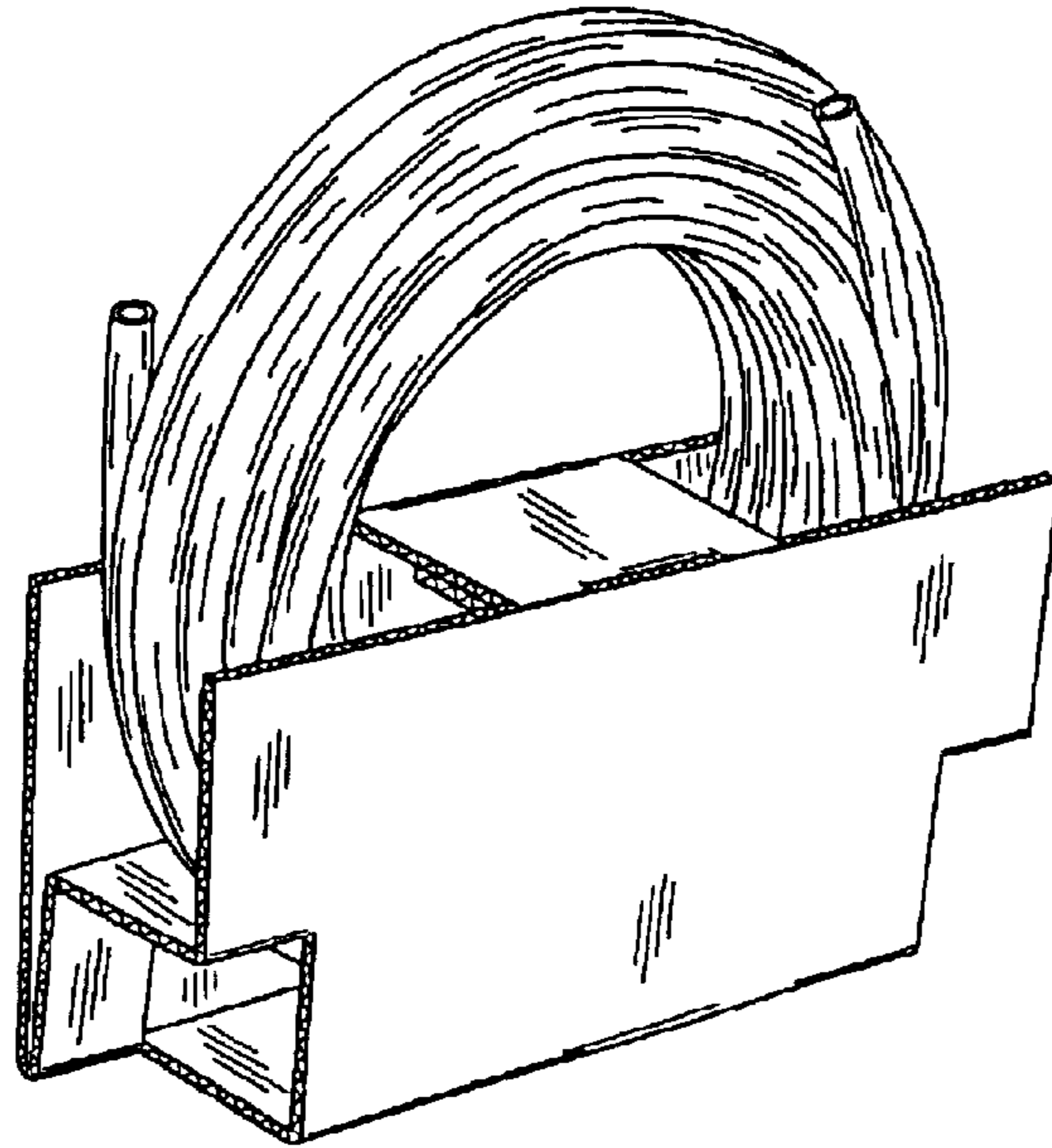

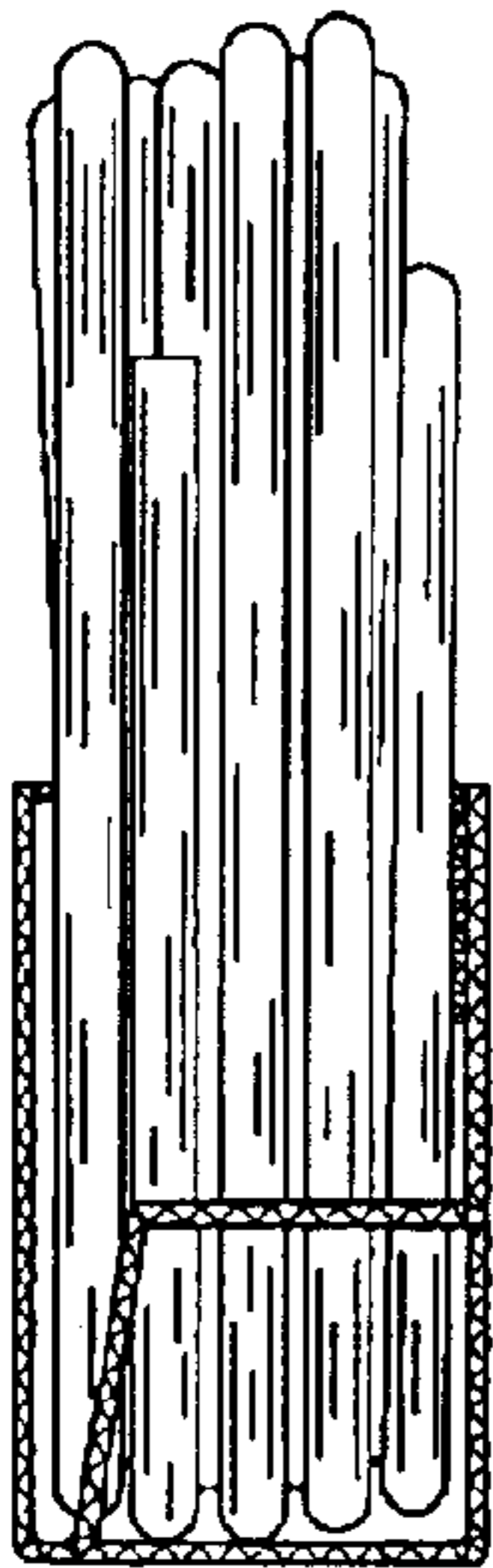

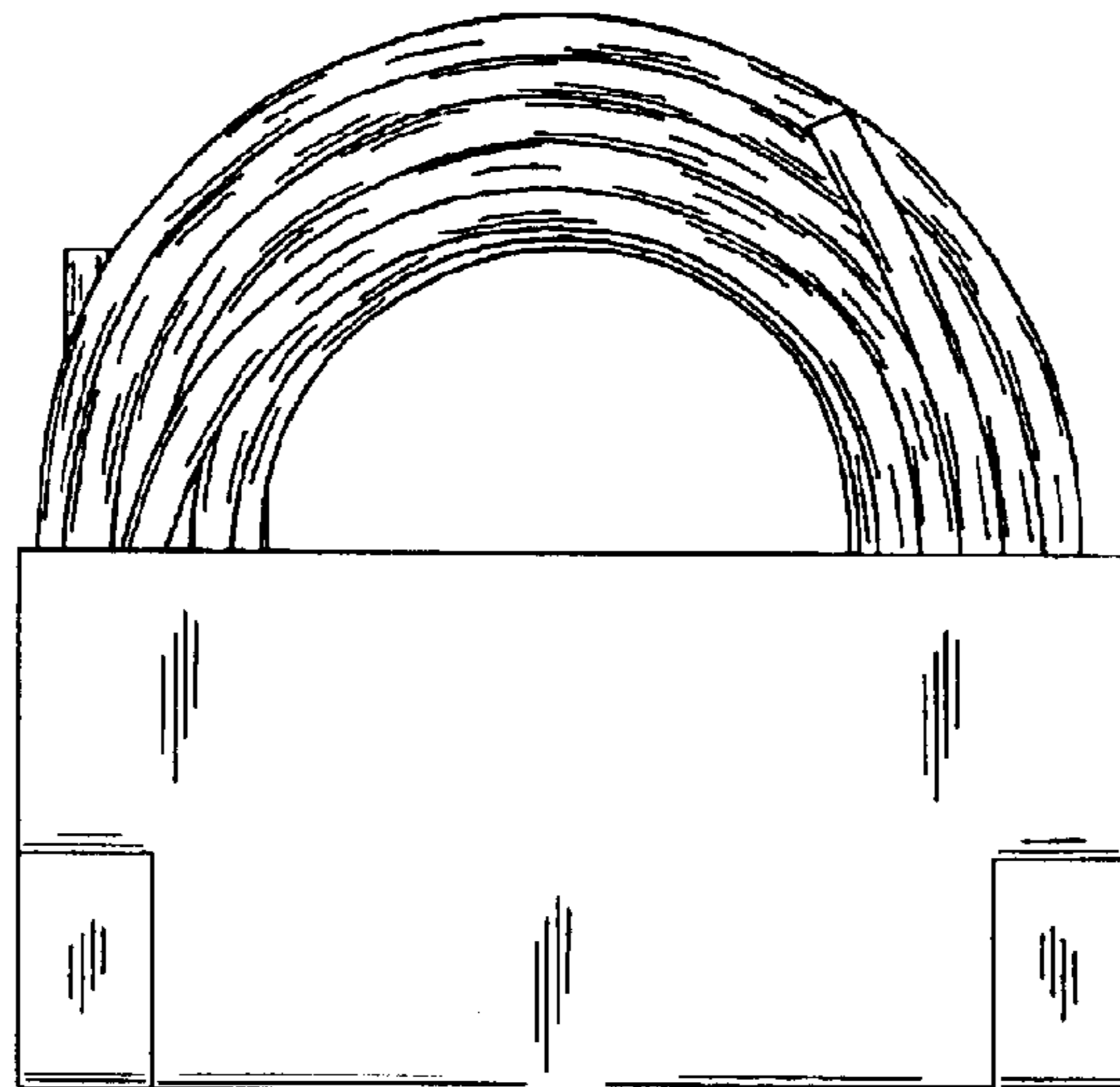

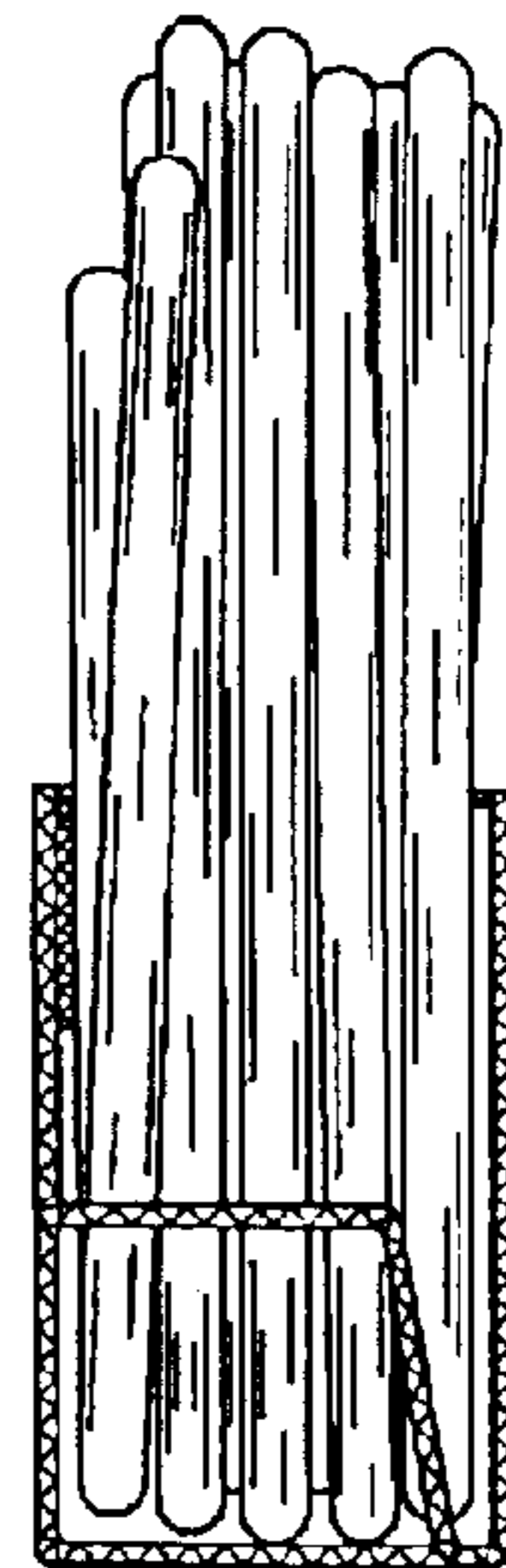

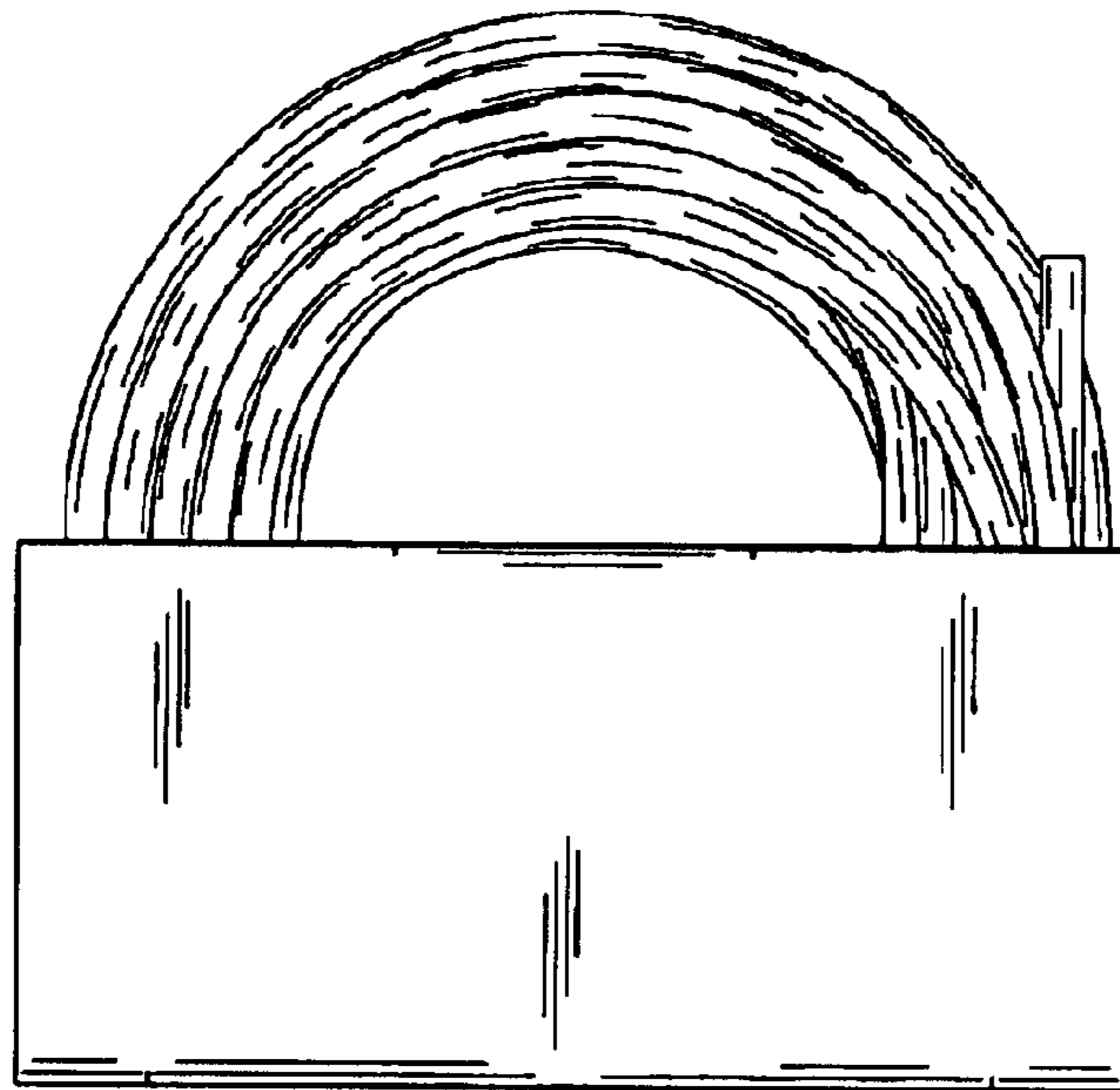

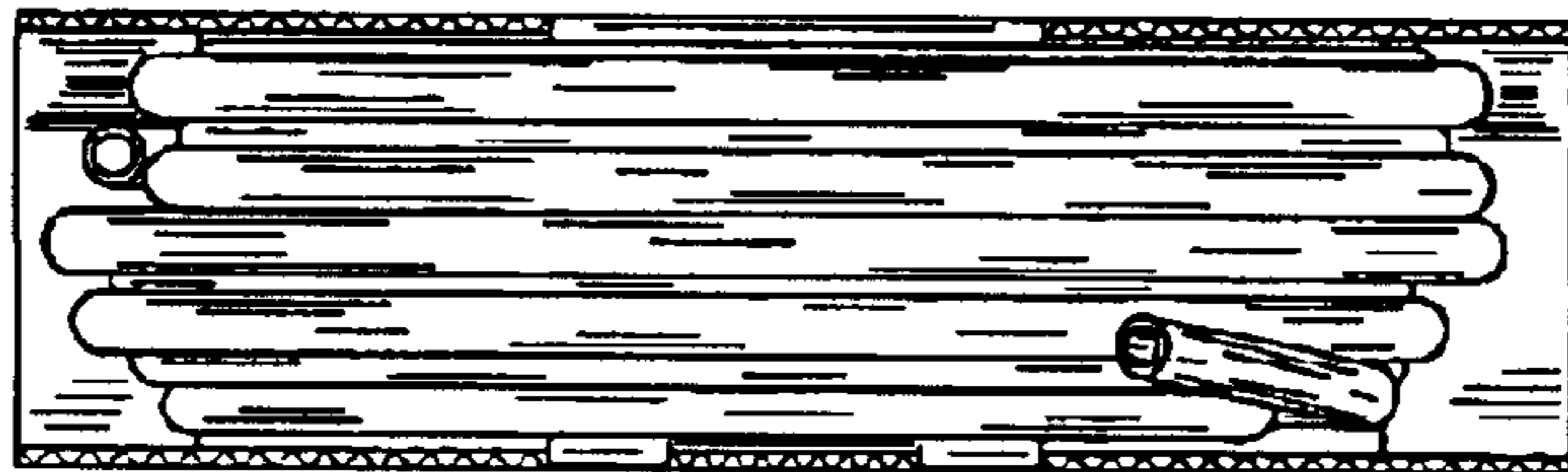

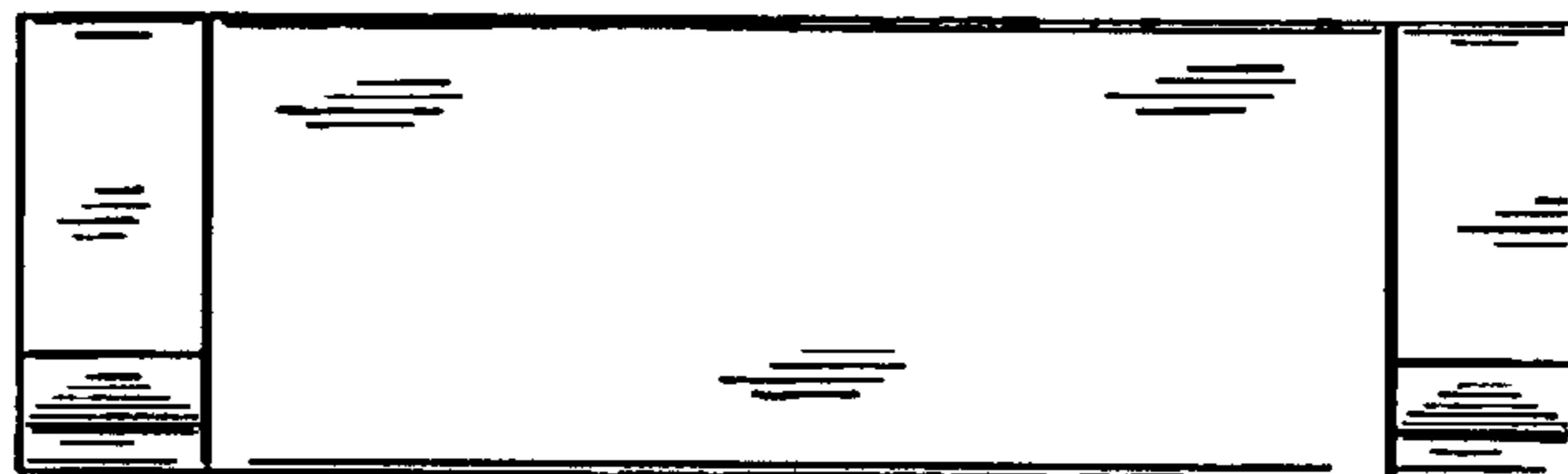
