FIG. 4 is a left side view.

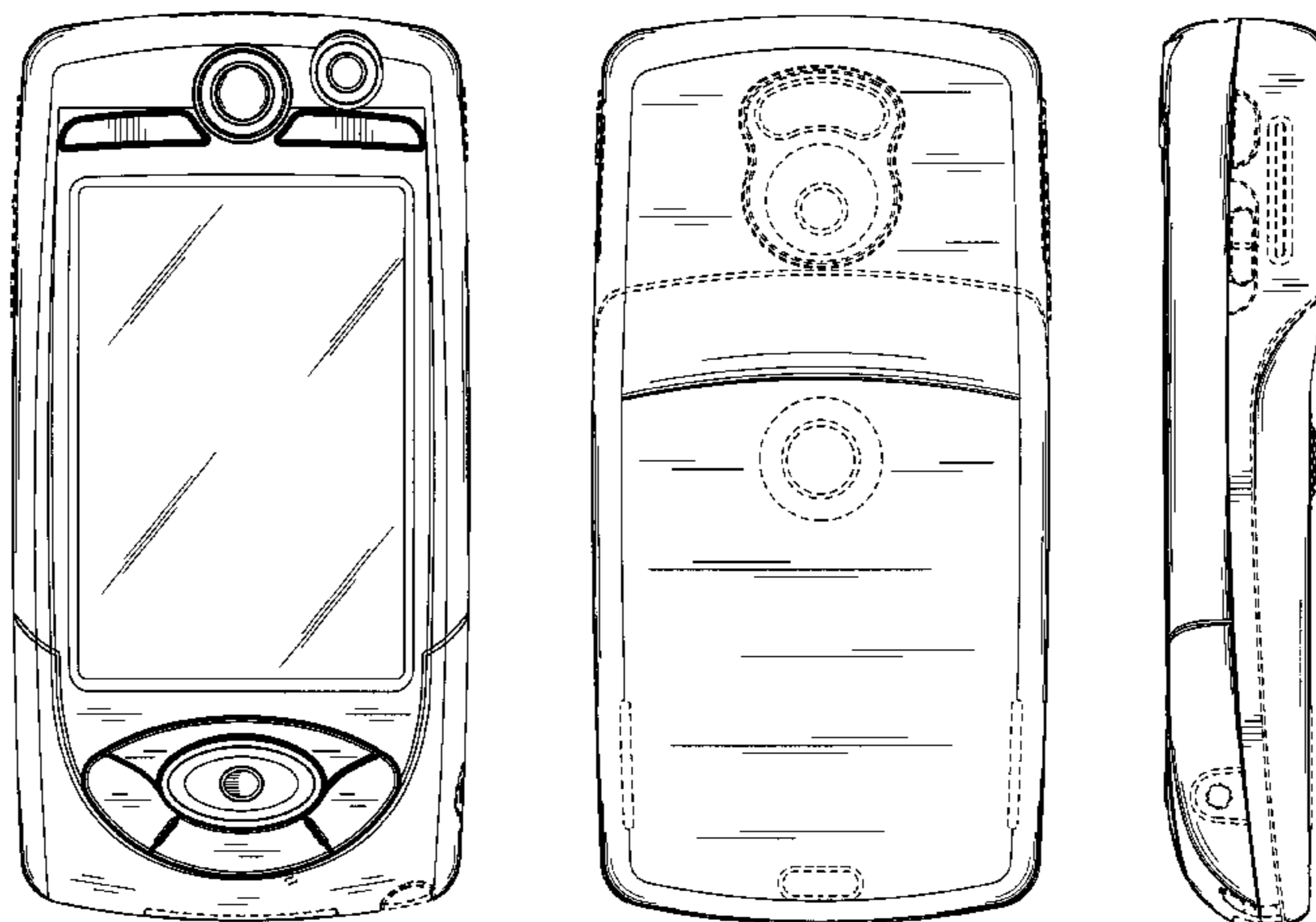
FIG. 5 is a right side view.

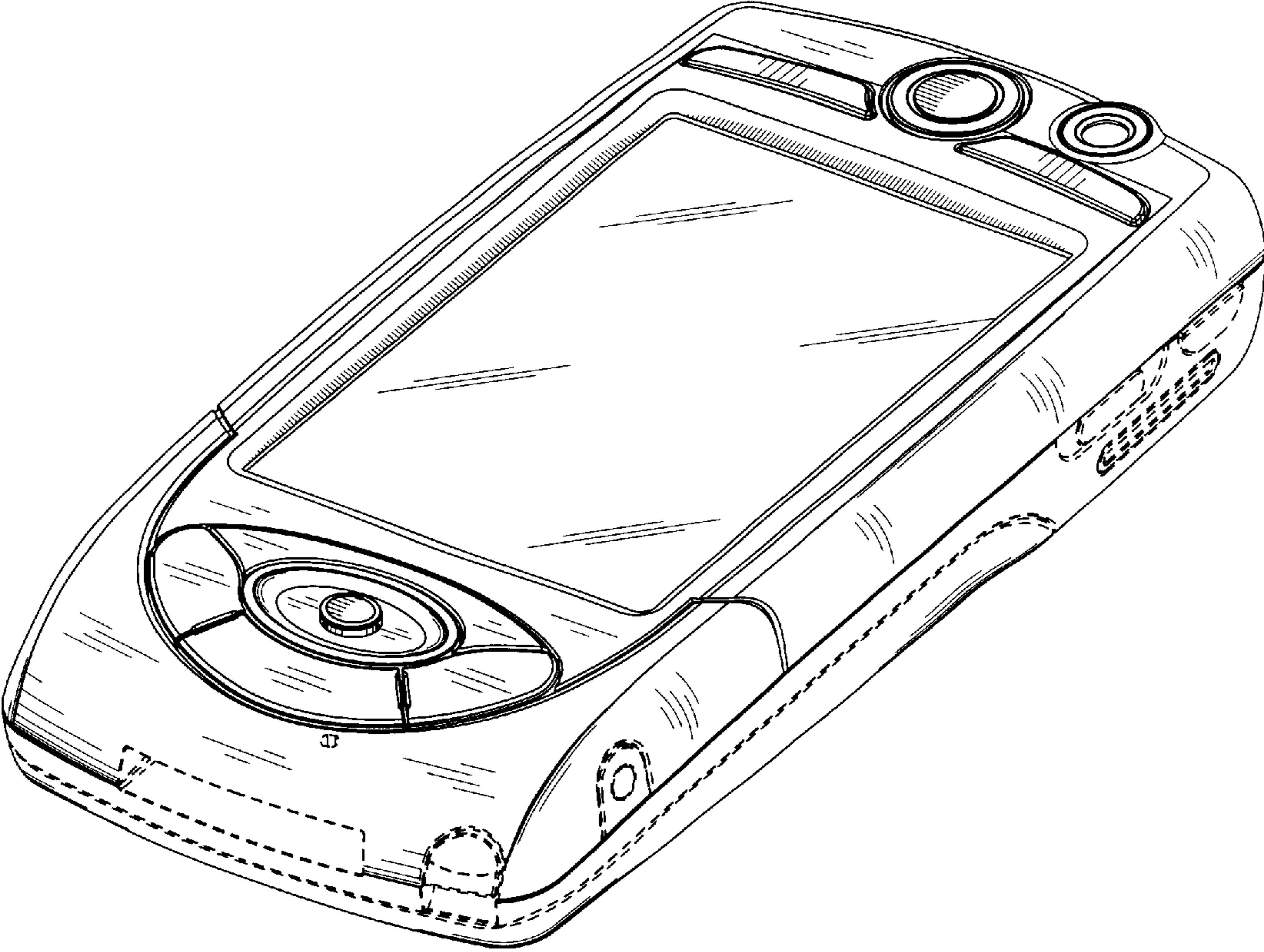
FIG. 6 is a top view; and,

FIG. 7 is a bottom view.

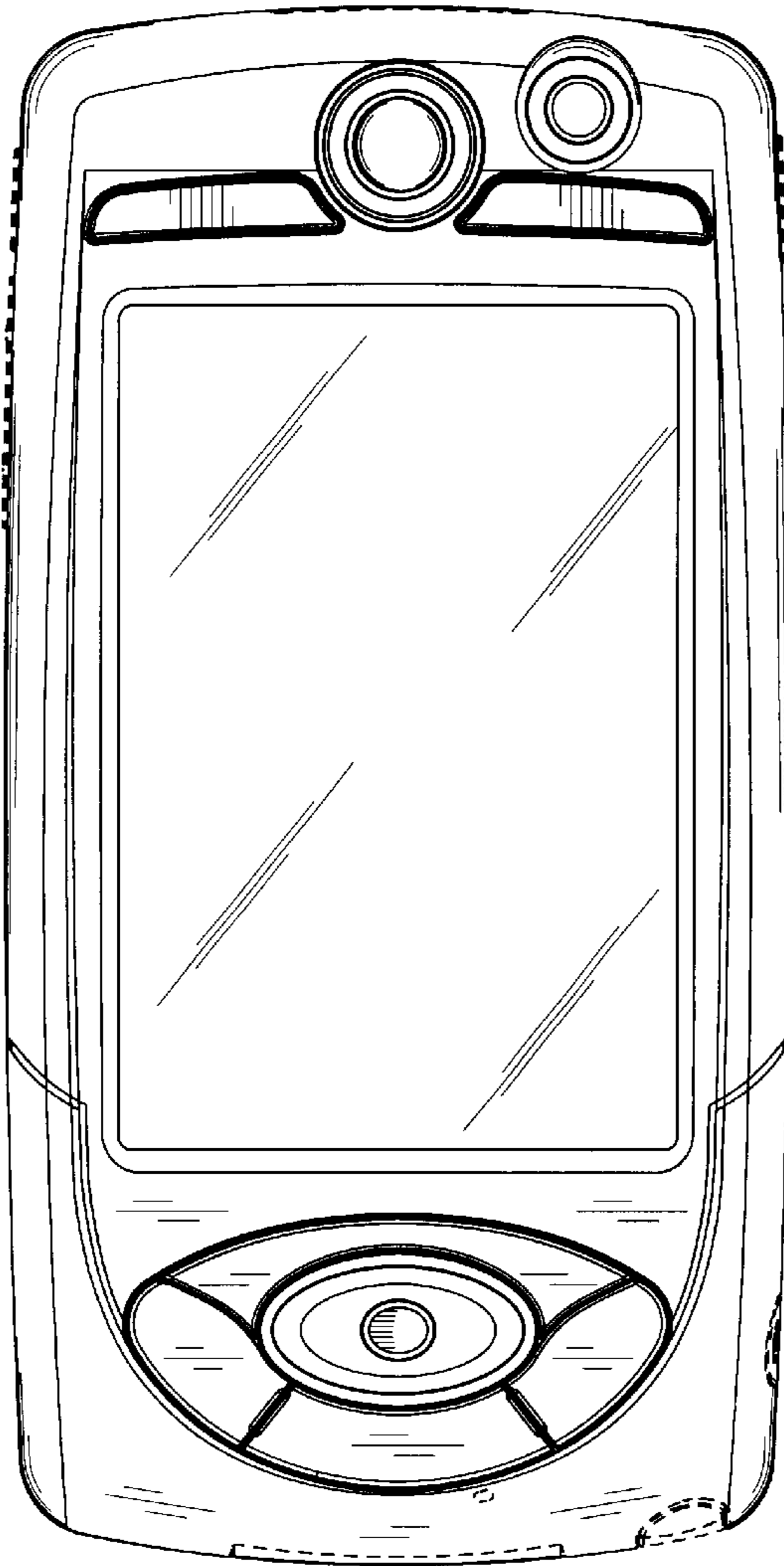

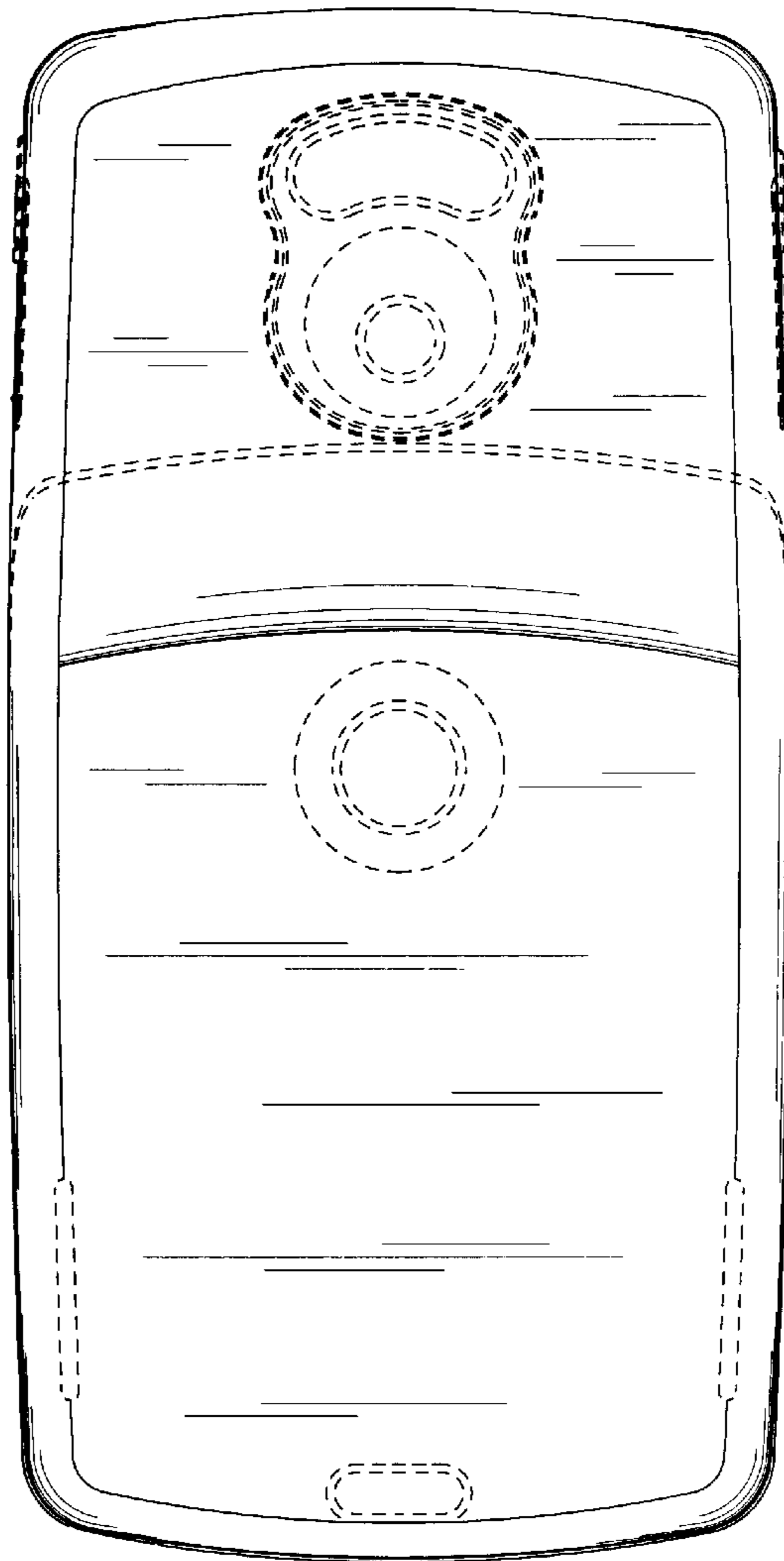




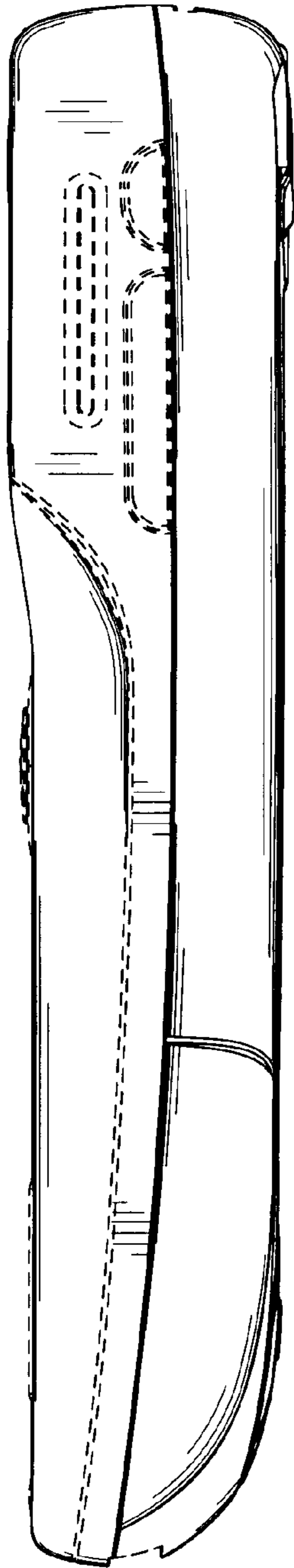

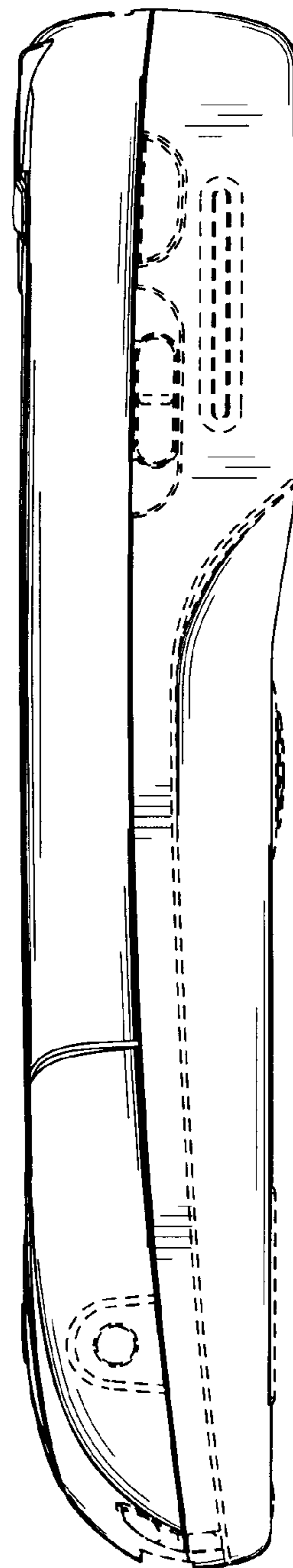

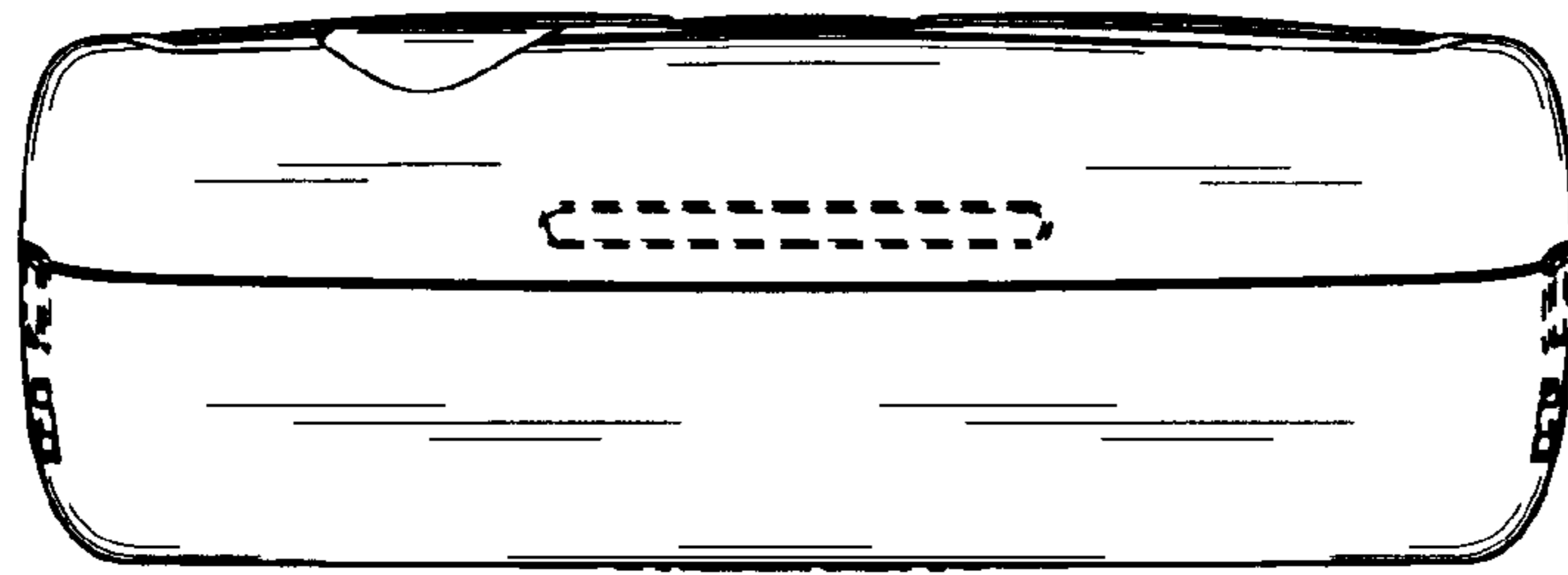

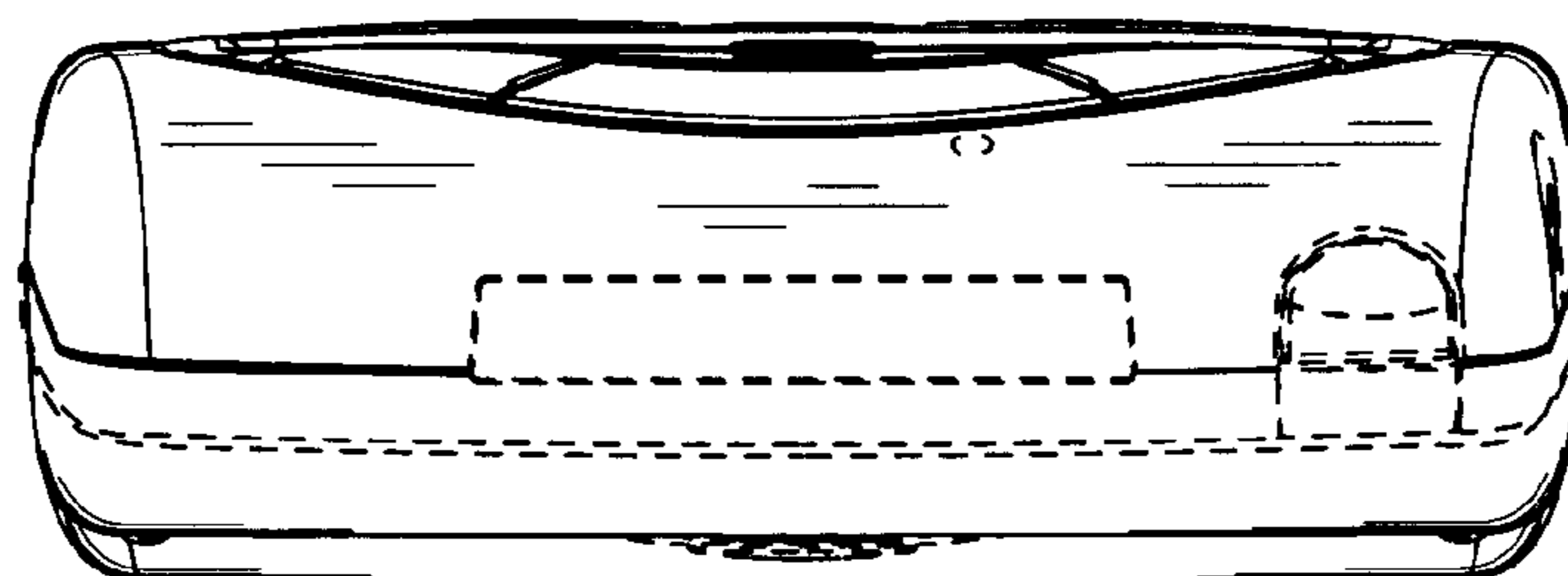
