(57) **CLAIM**

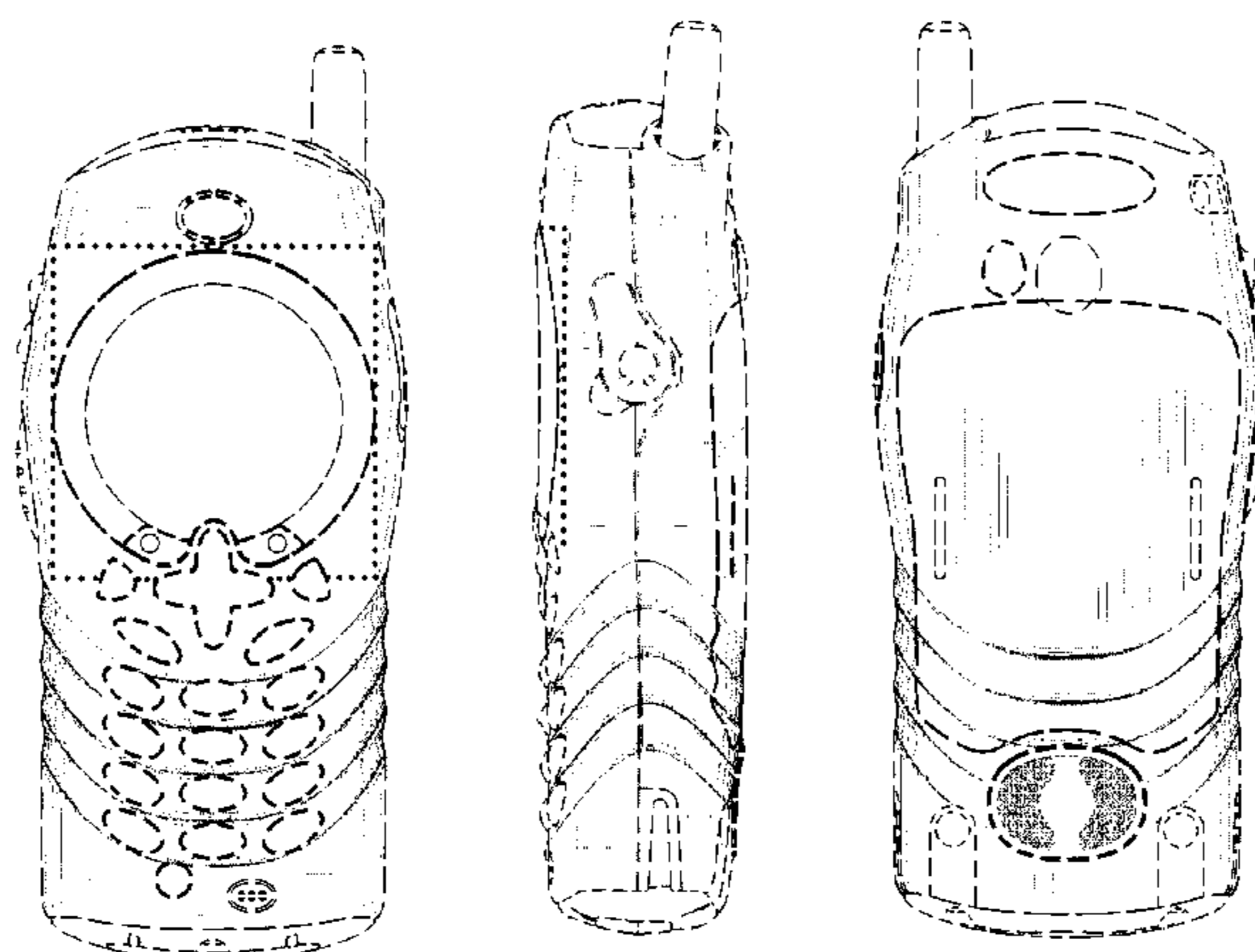
The ornamental design for a housing for a communication device, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a housing for a communication device showing our new design;
FIG. 2 is a right side orthographic view thereof;
FIG. 3 is a front orthographic view thereof;
FIG. 4 is a left side orthographic view thereof;
FIG. 5 is a rear orthographic view thereof;
FIG. 6 is a top orthographic view thereof; and,
FIG. 7 is a bottom orthographic view thereof.

The broken lines shown in FIGS. 1-7 represent environmental elements and form no part of the claimed design. The dotted lines shown in FIGS. 1-4 and FIGS. 6-7 represent an unclaimed border between claimed and unclaimed subject matter and form no part of the claimed design.

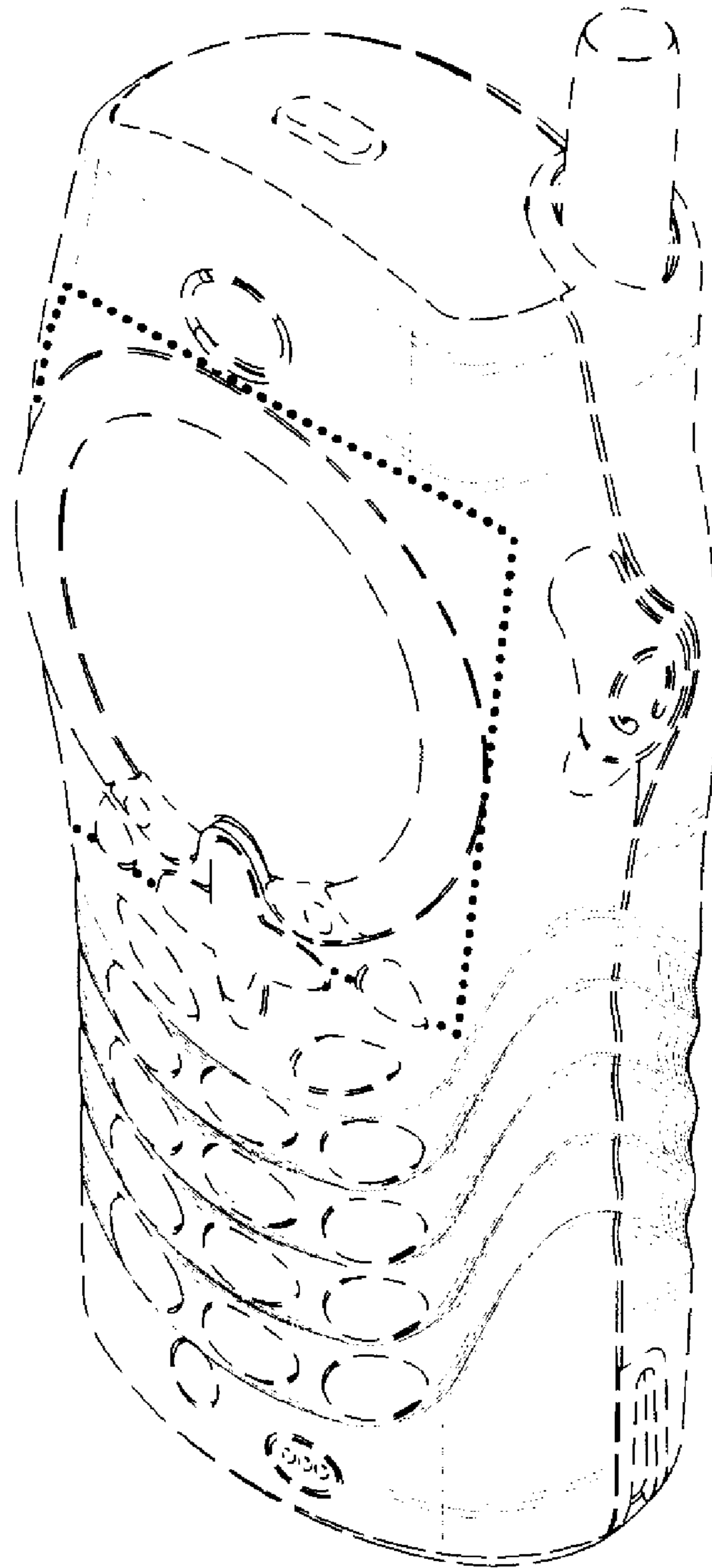

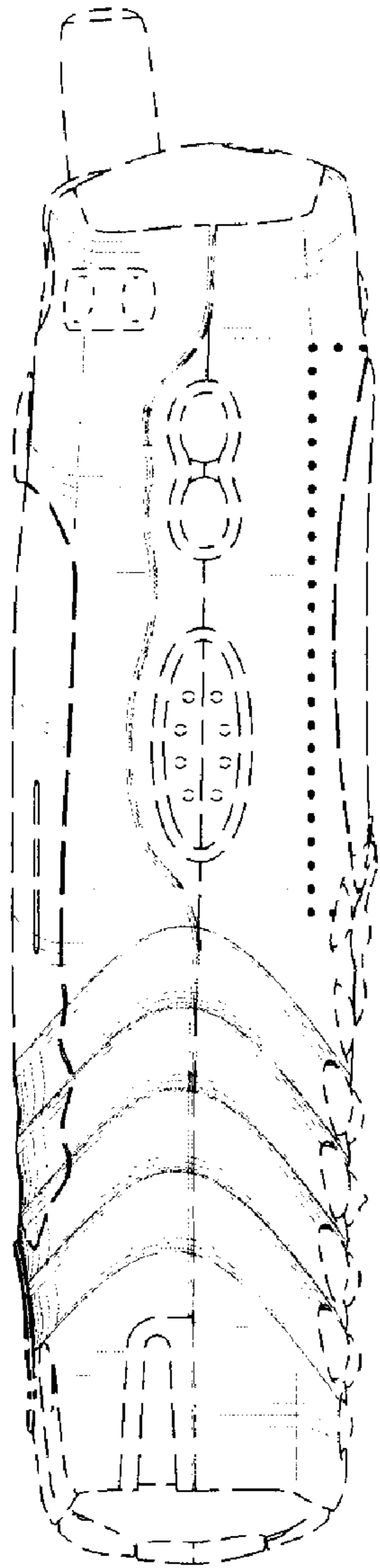

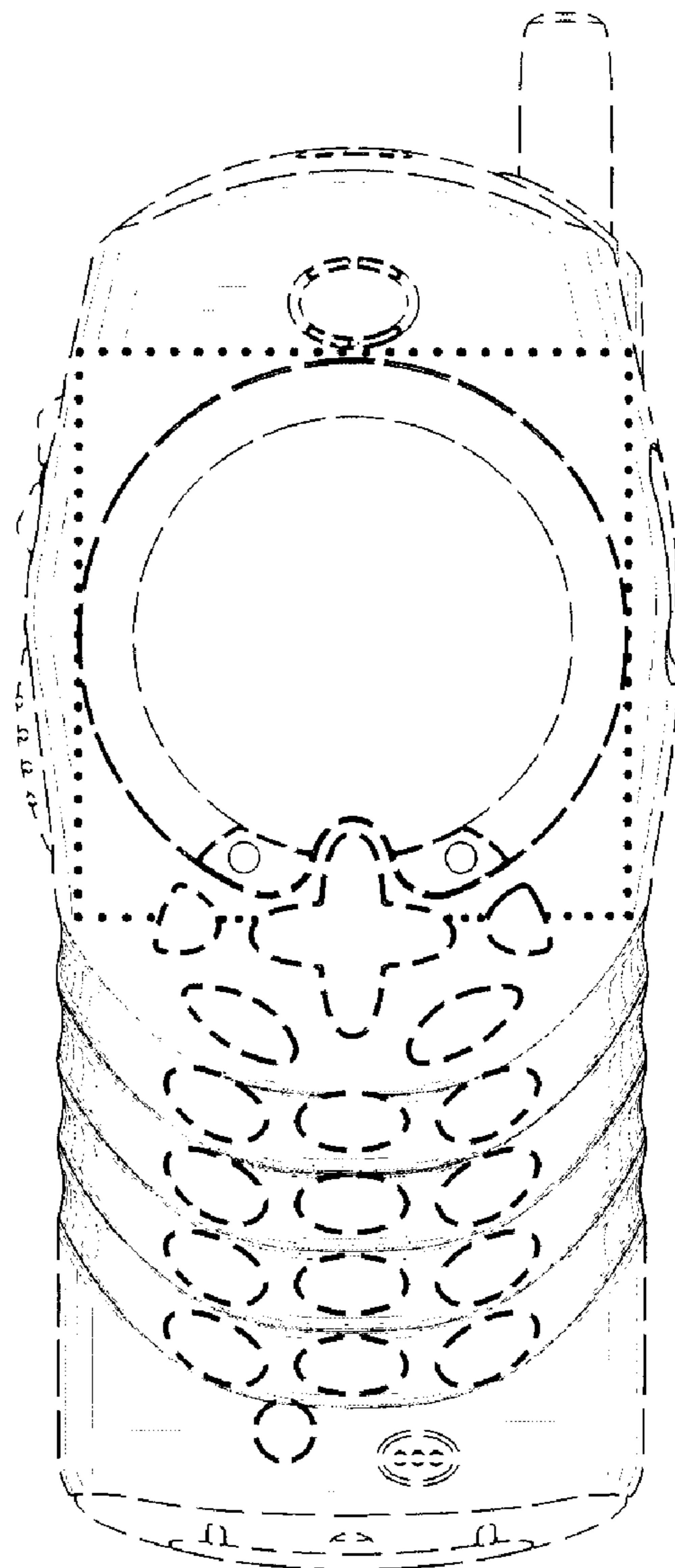

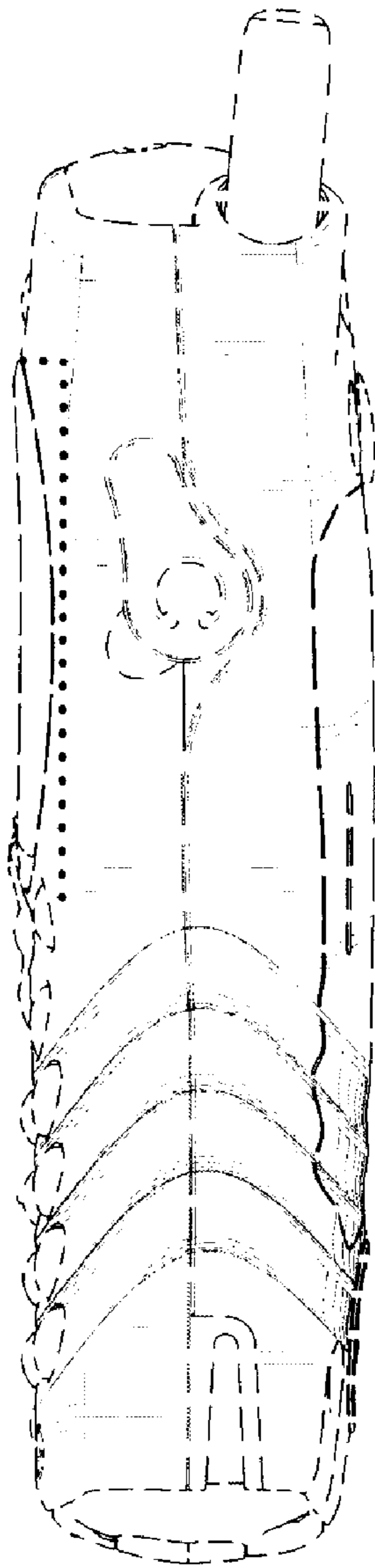

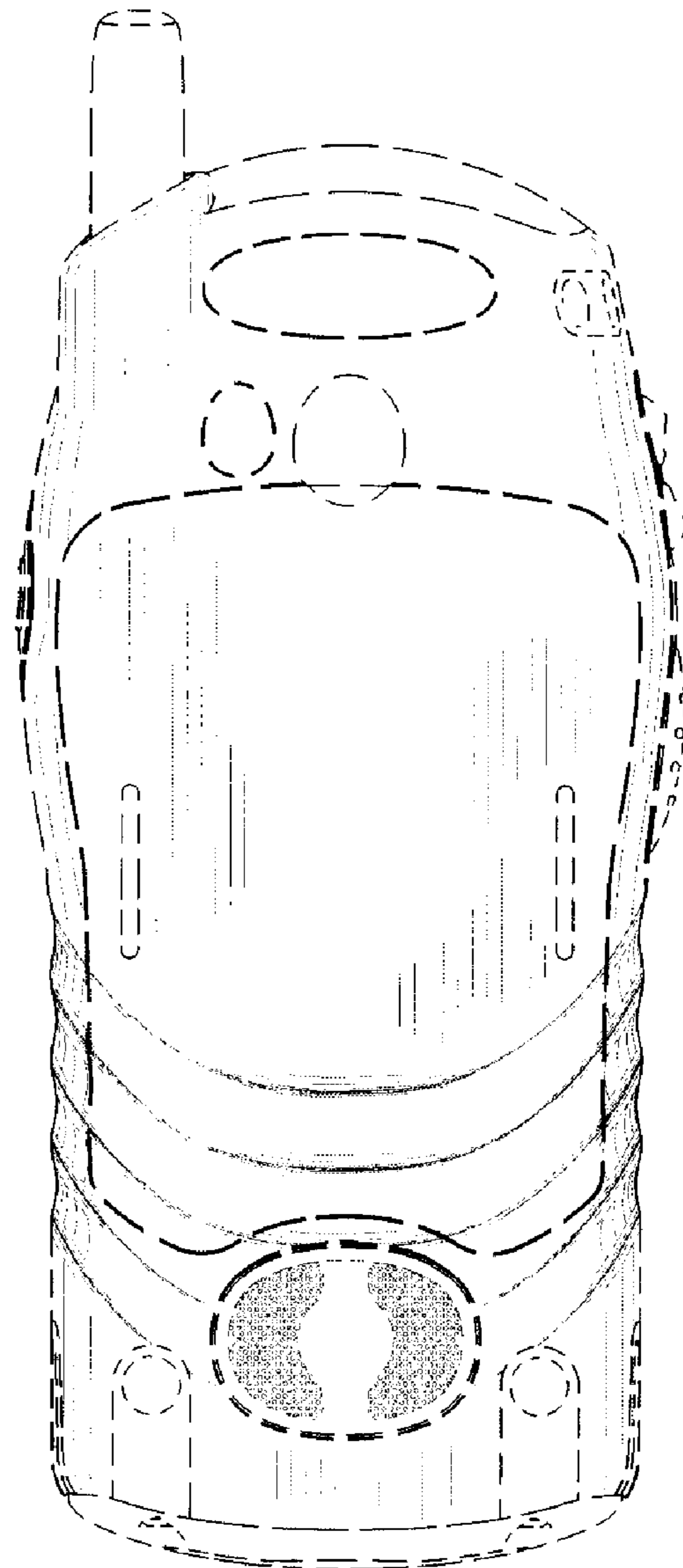

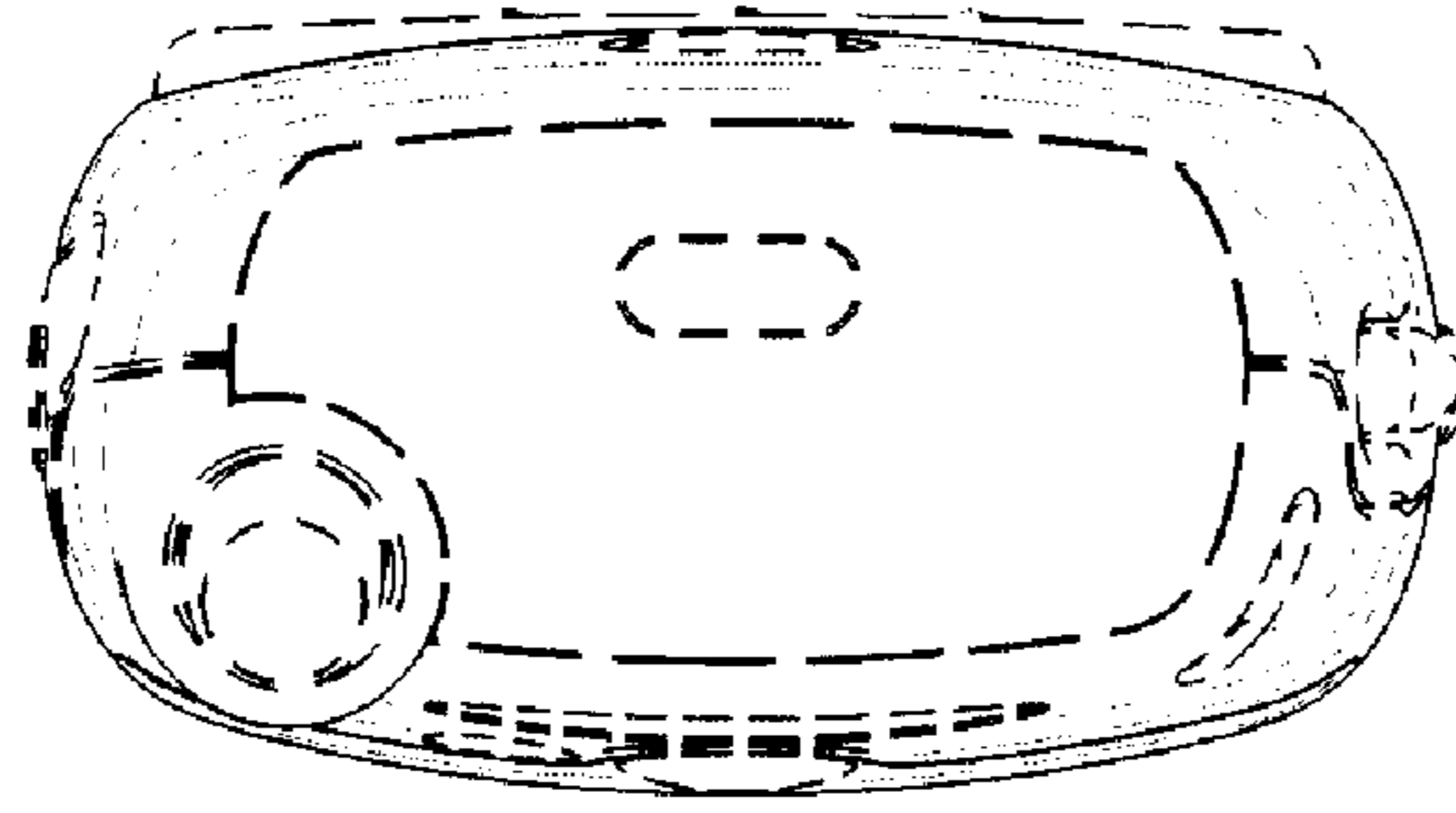

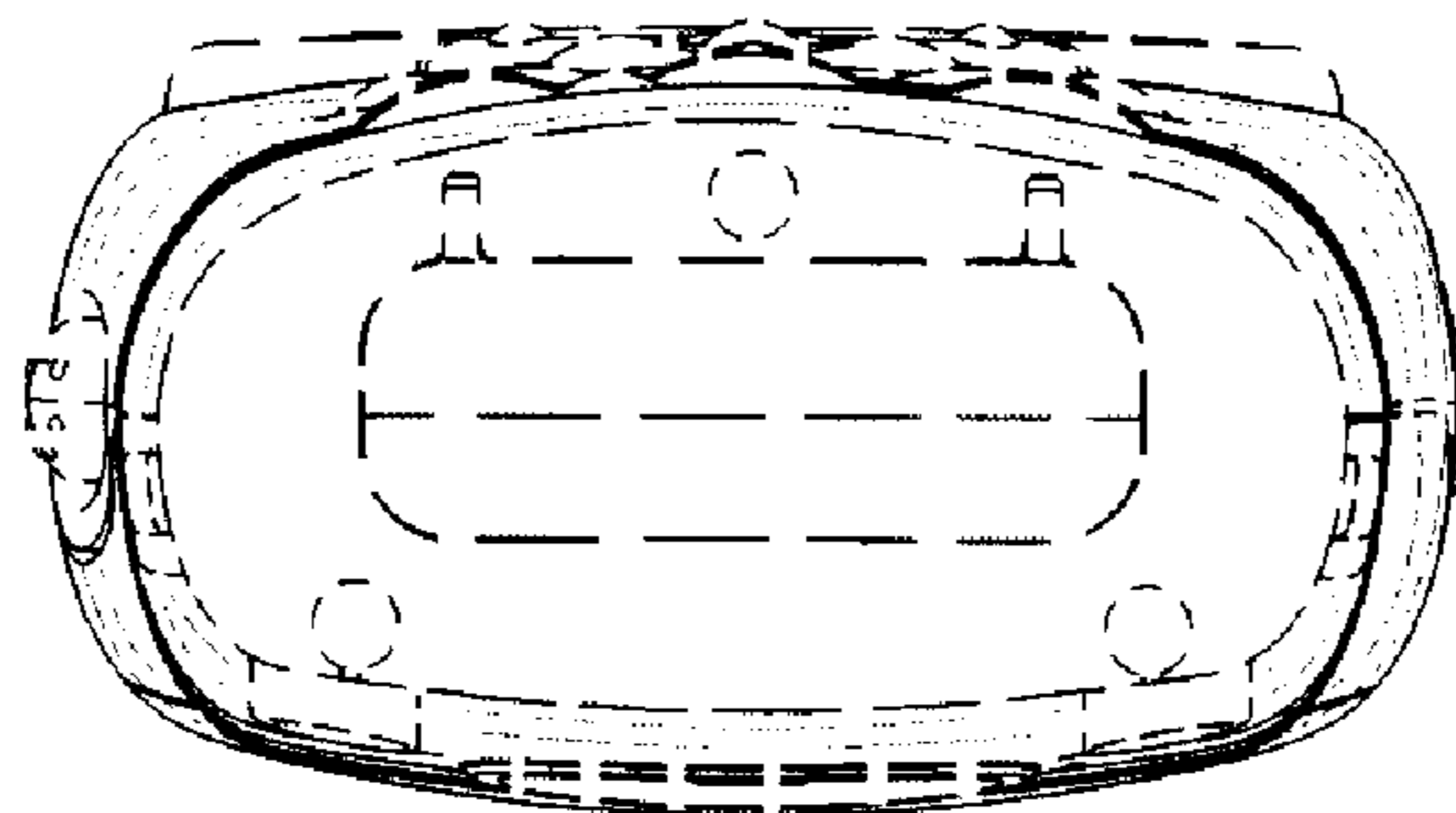
