FIG. 7 is a front view in elevation of the reel slot machine with rotator of FIG. 1.

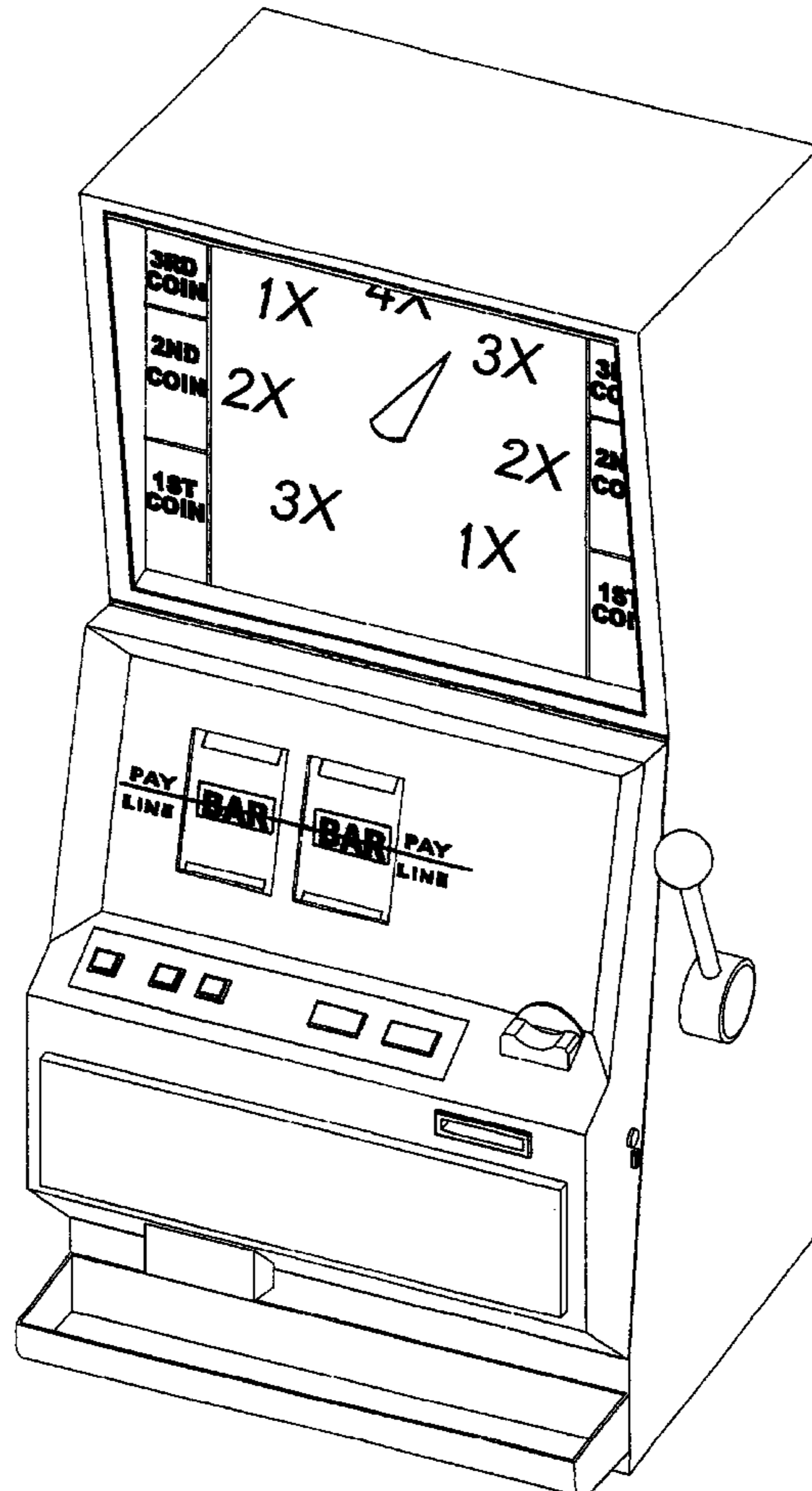

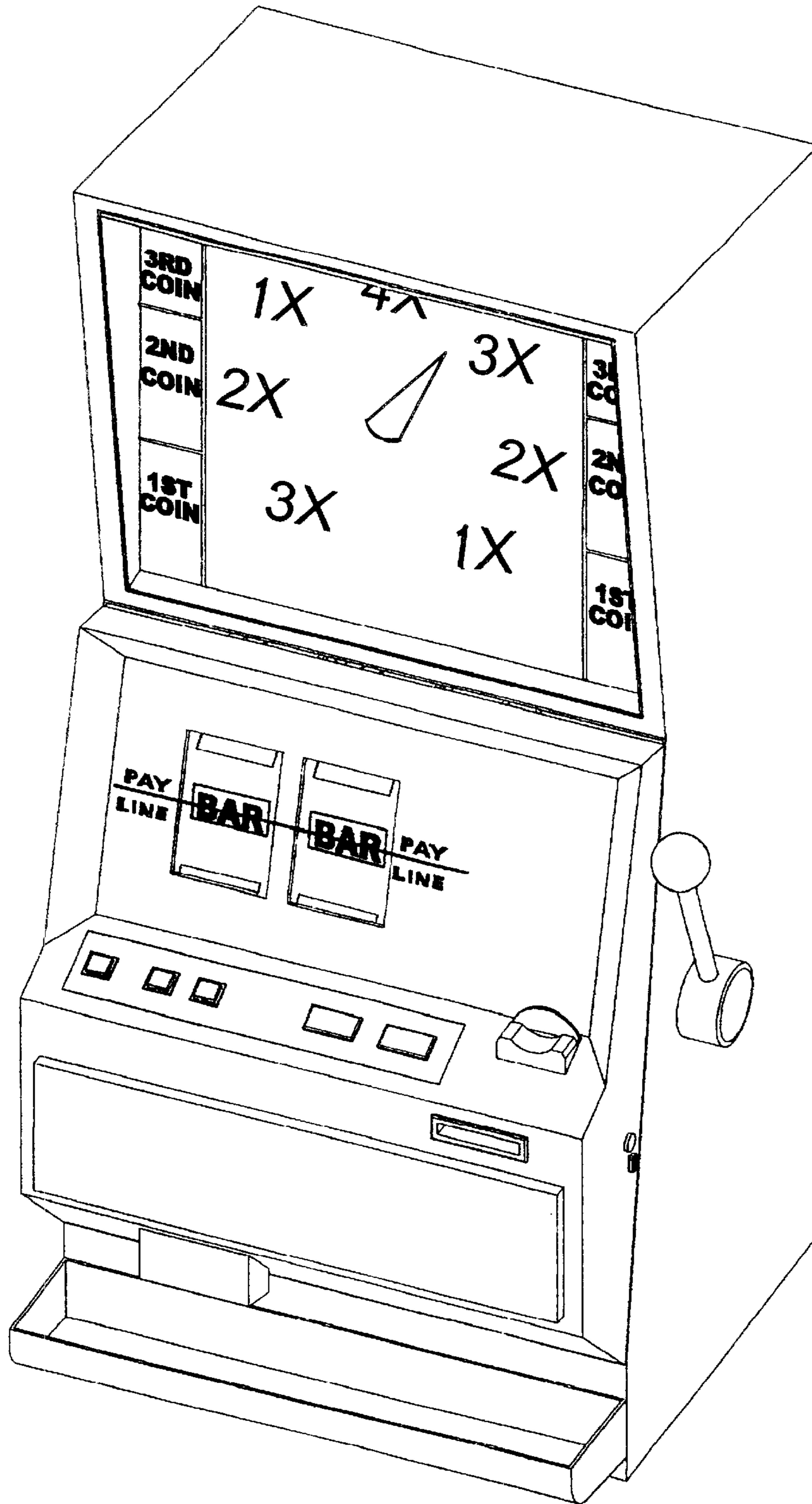

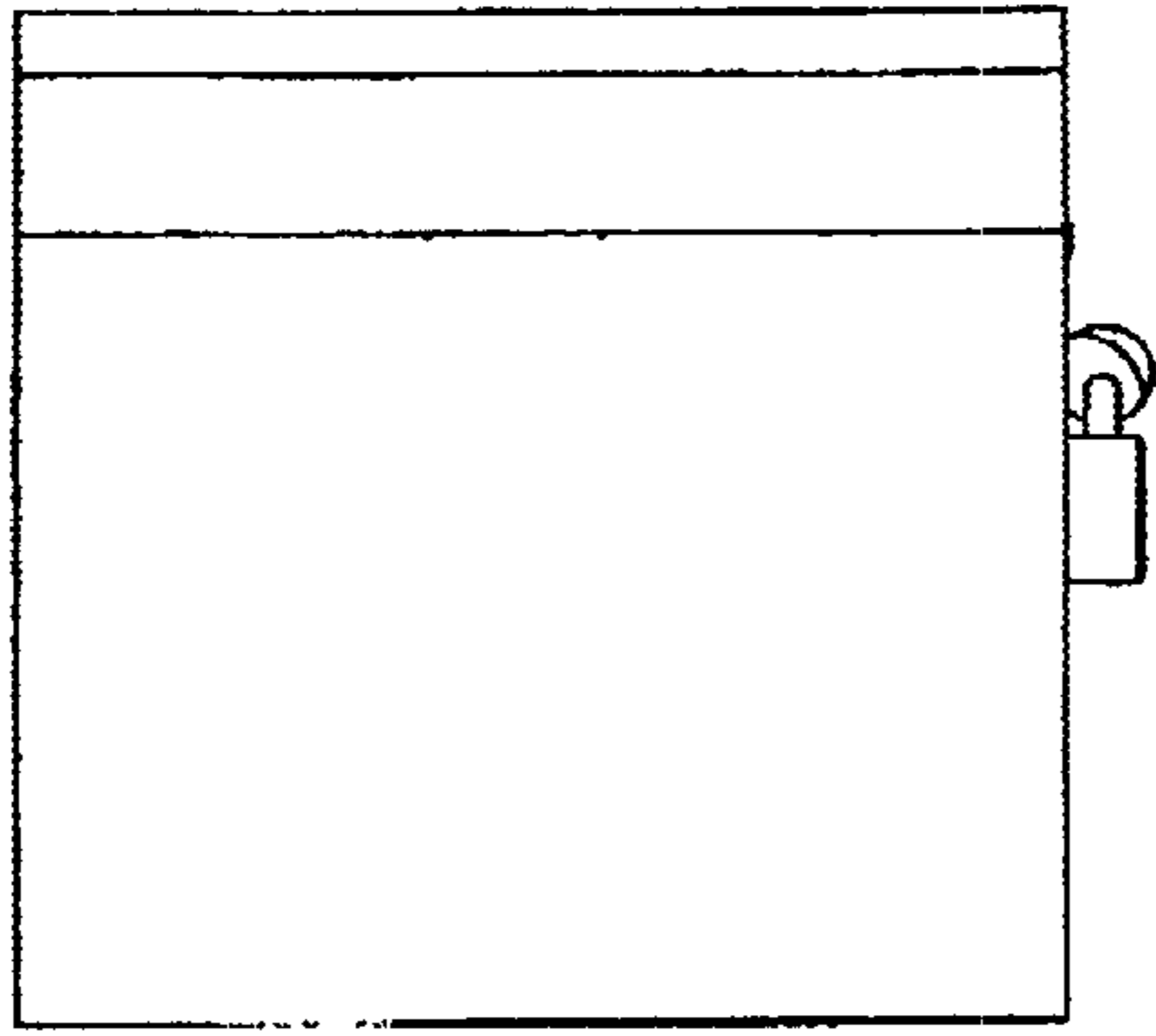

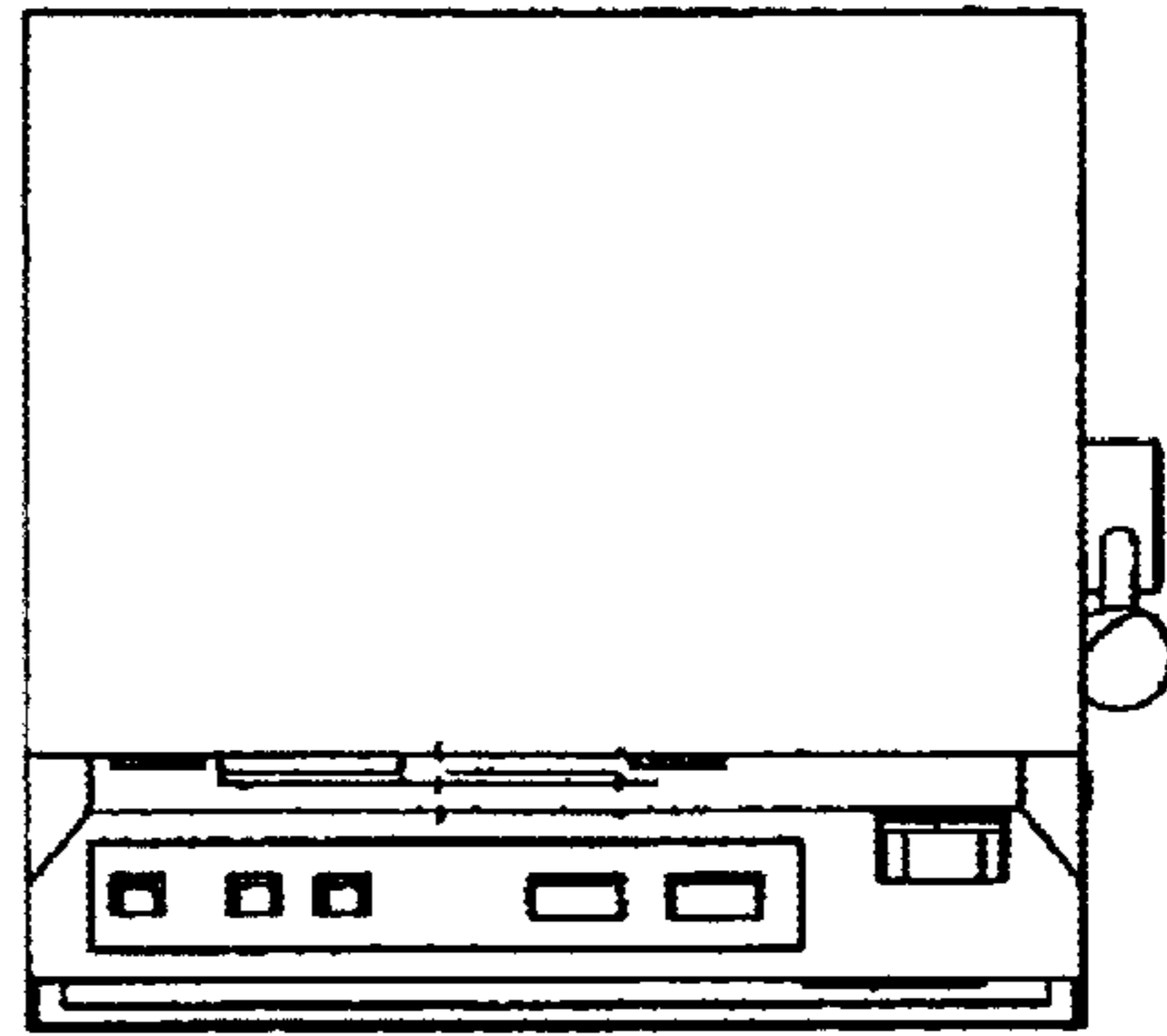

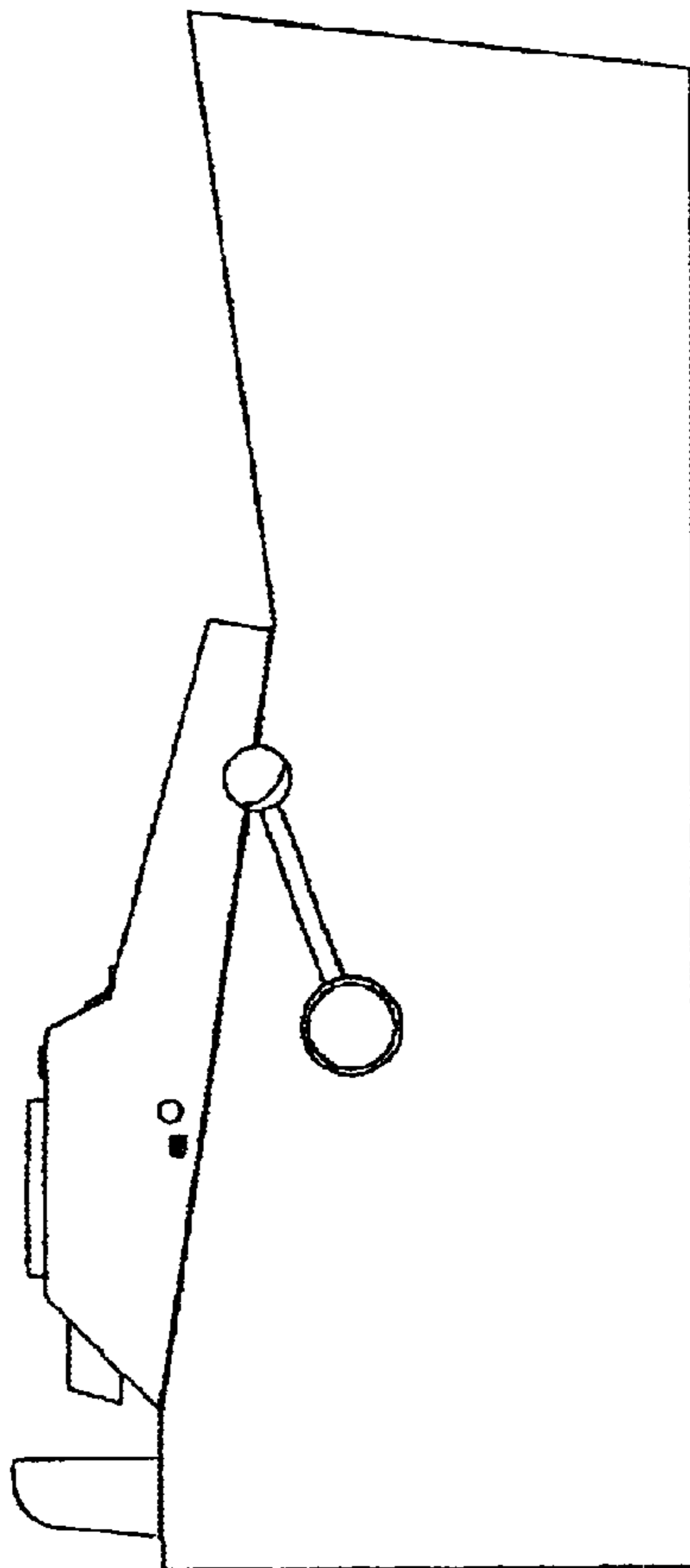

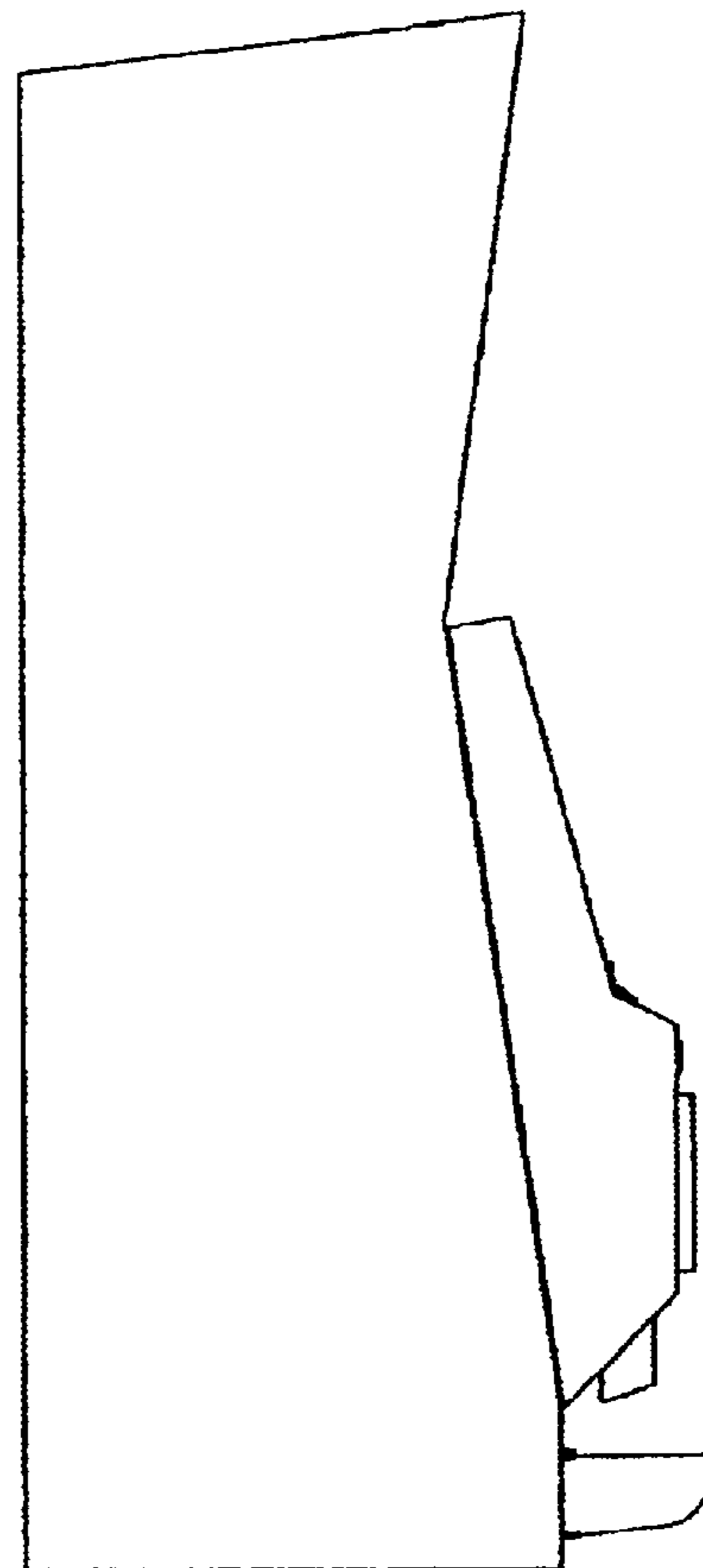

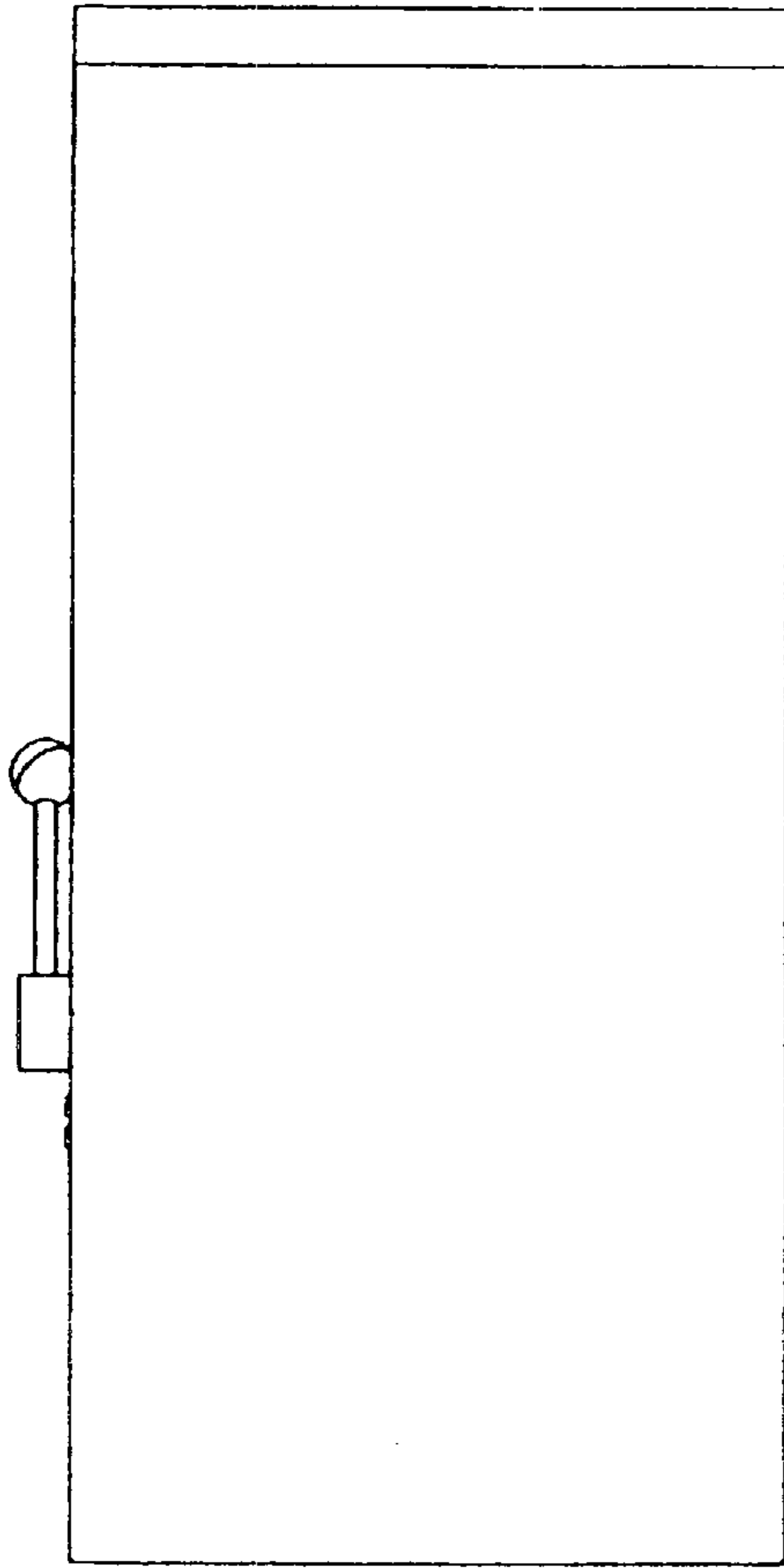

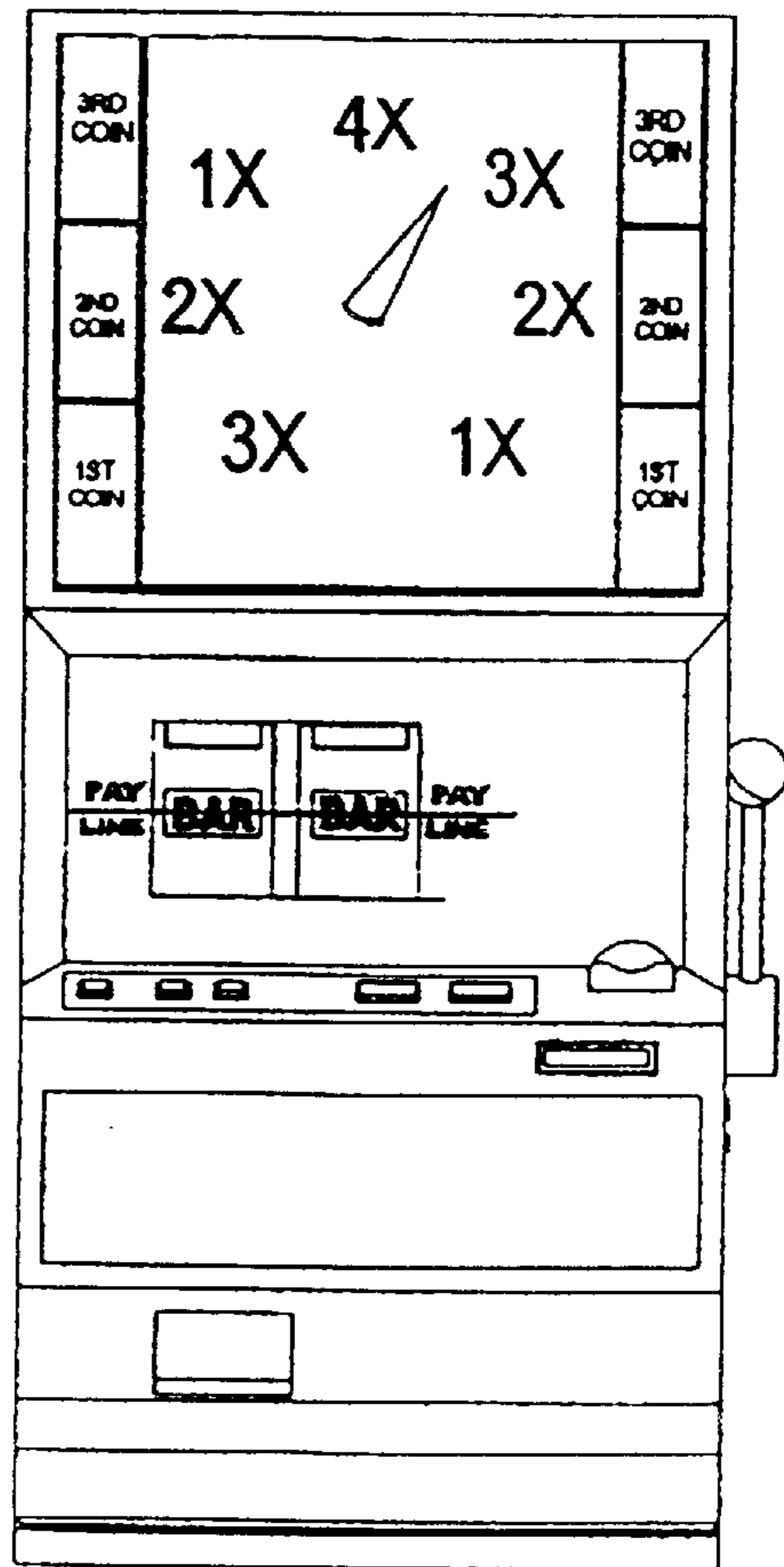
