DESCRIPTION

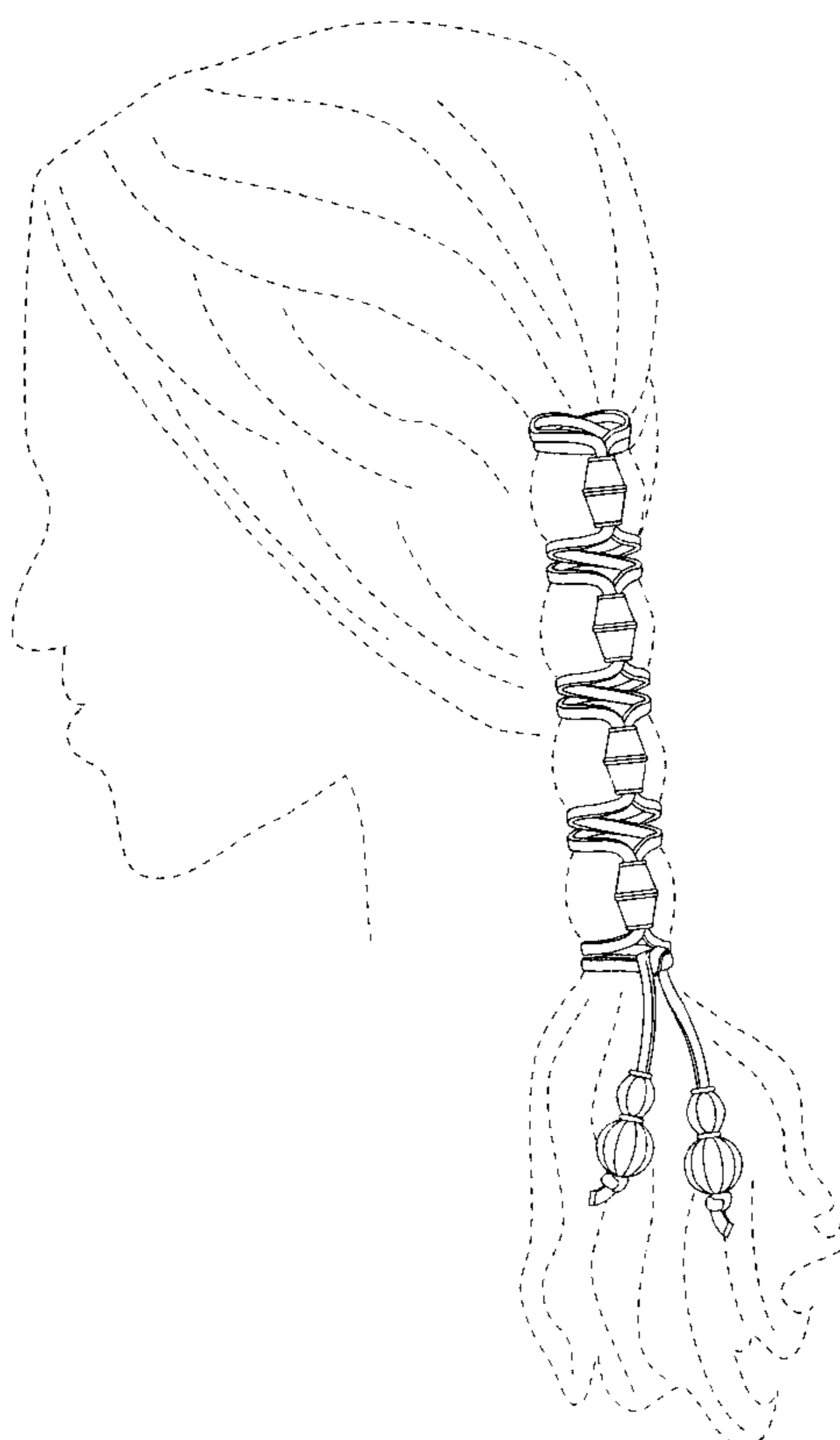
FIG. 1 is a front view of a hair fastener showing our new

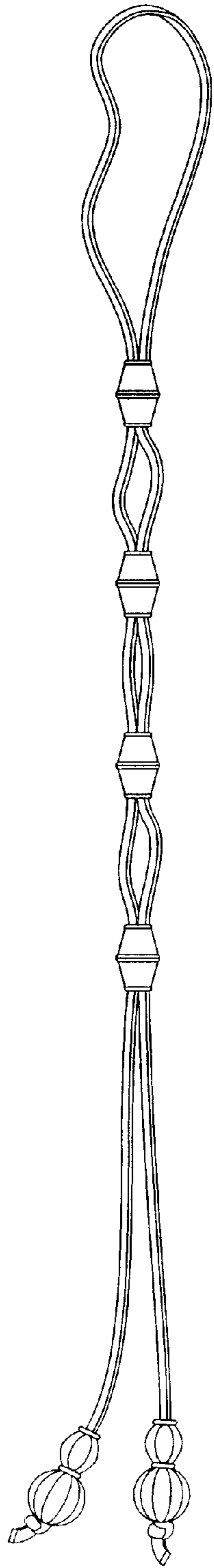

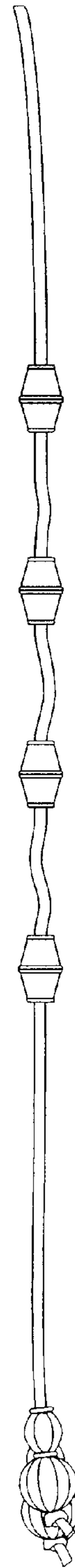

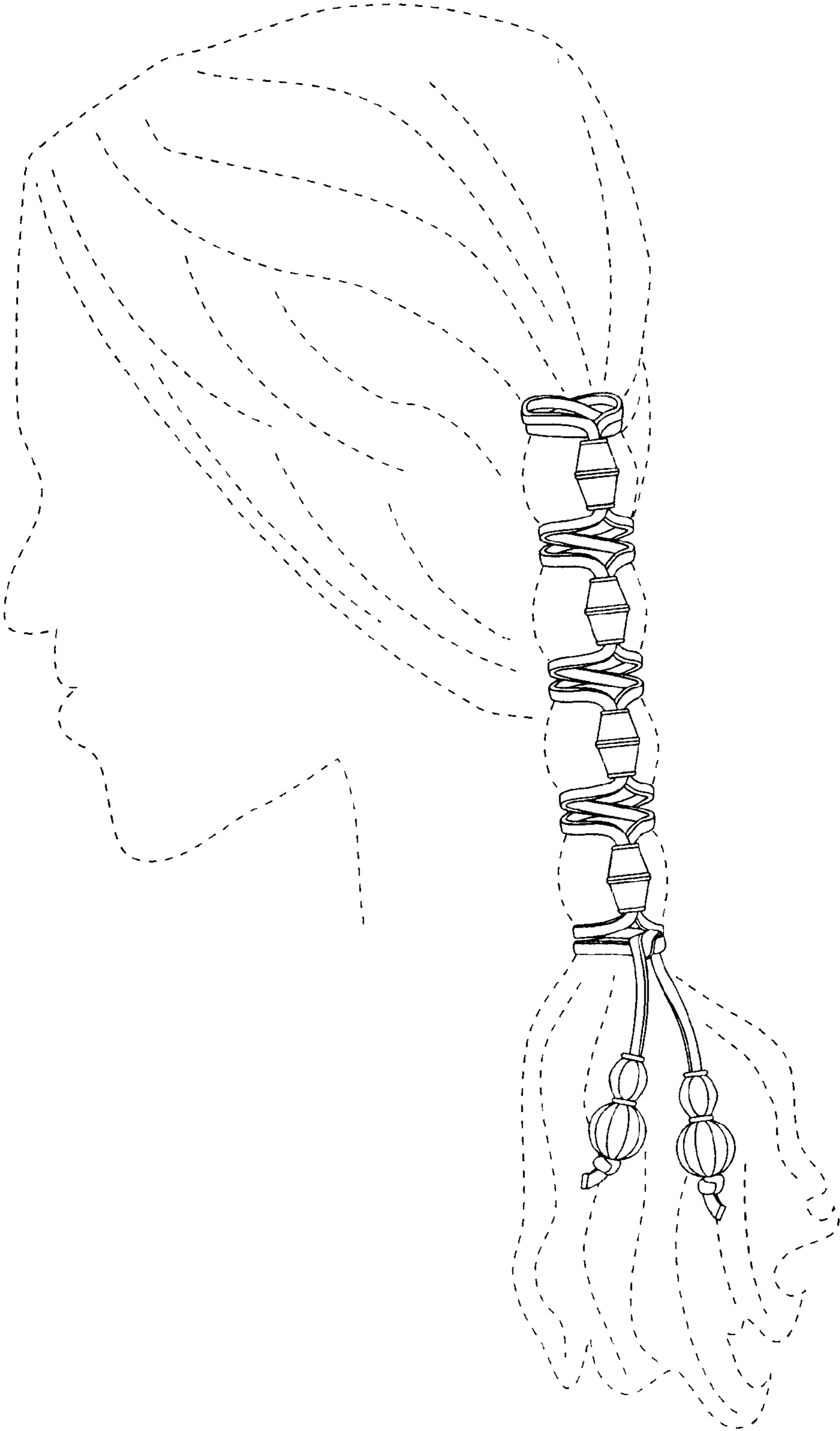
