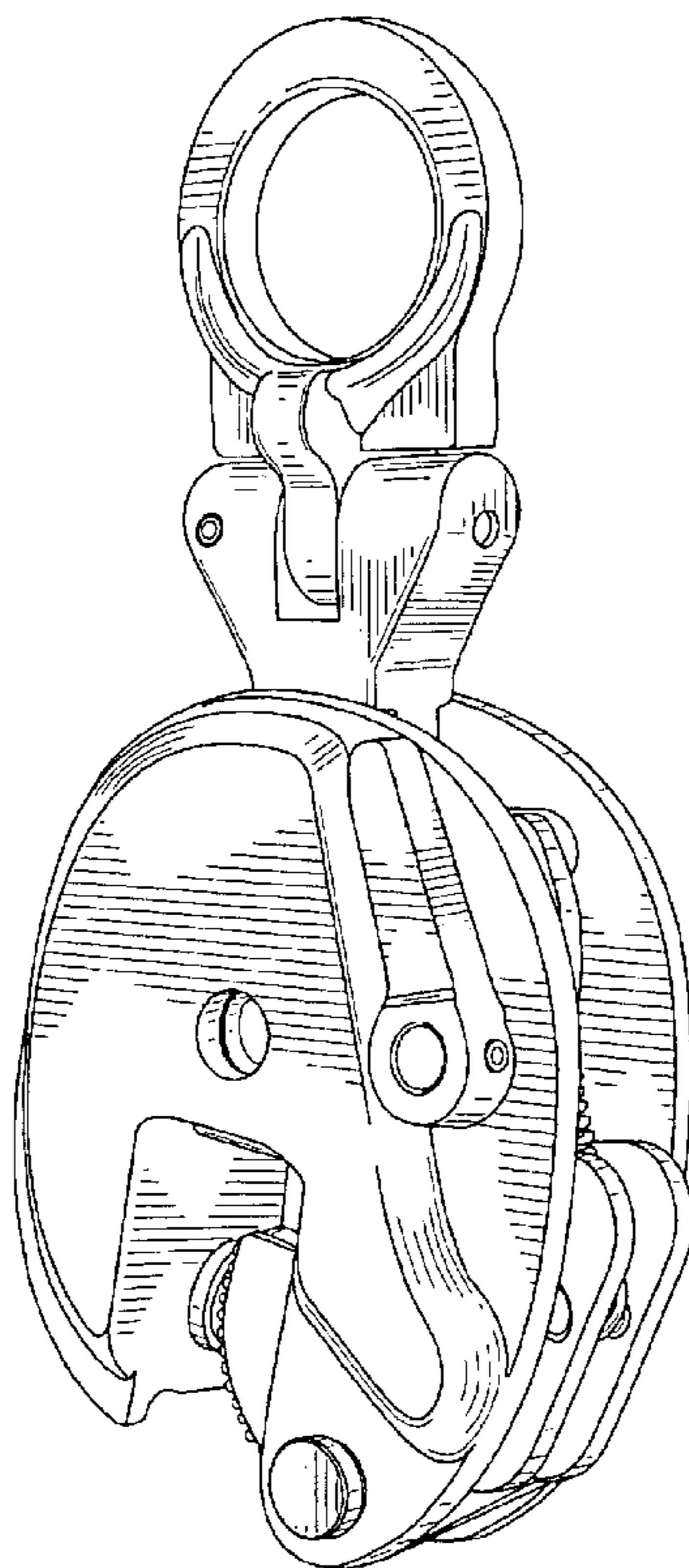
(57) **CLAIM**

The ornamental design of a lifting apparatus, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a lifting apparatus embodying the design of the present invention;  
 FIG. 2 is a front elevational view of the lifting apparatus illustrated in FIG. 1;  
 FIG. 3 is a back elevational view of the lifting apparatus illustrated in FIG. 1;

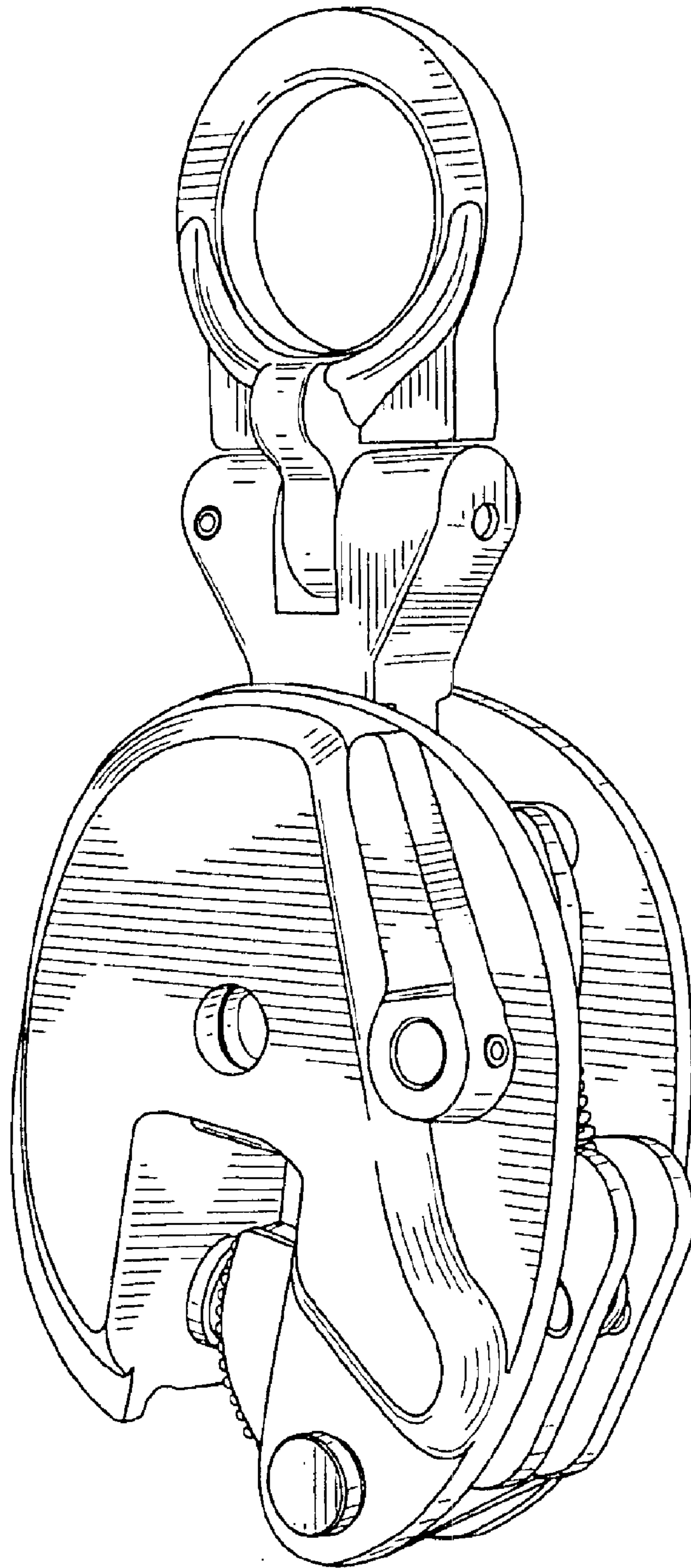

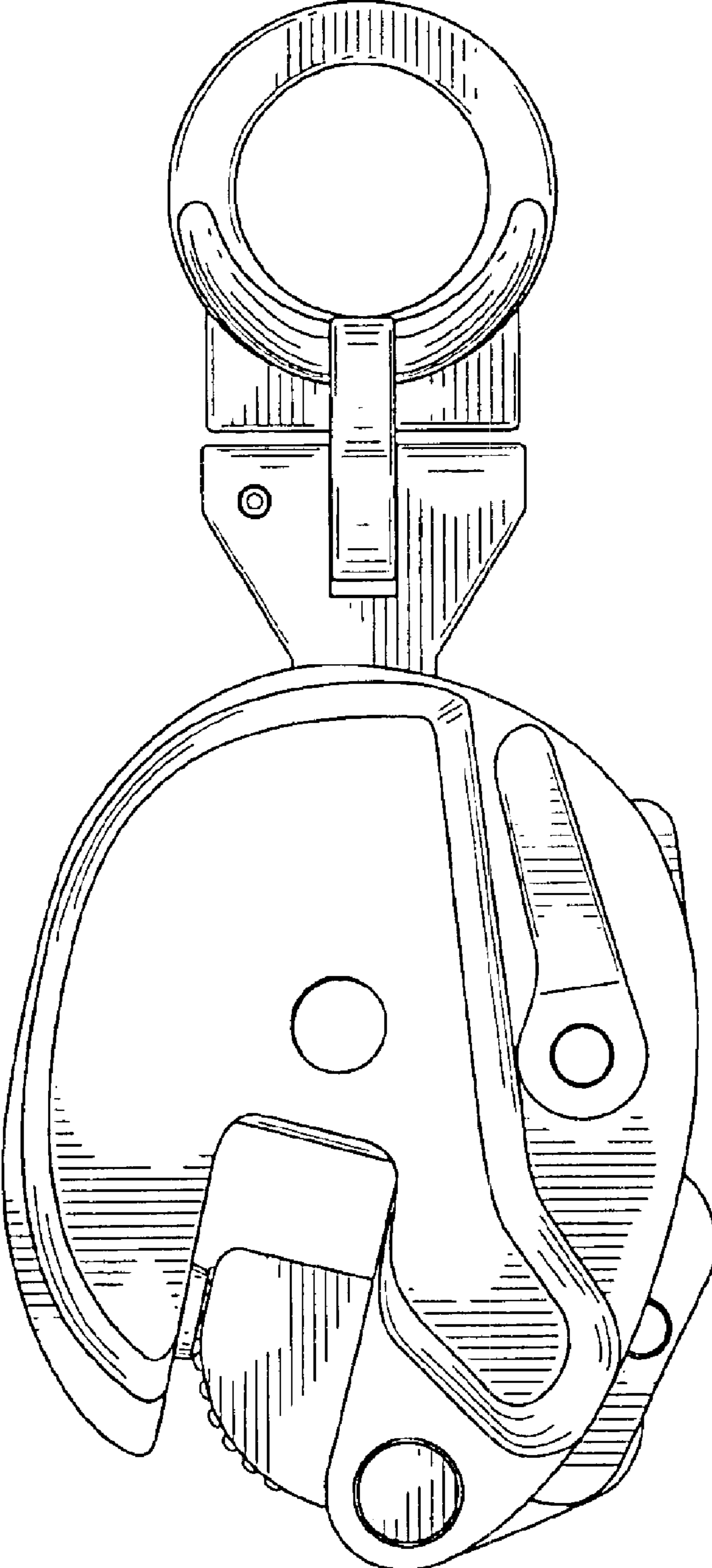

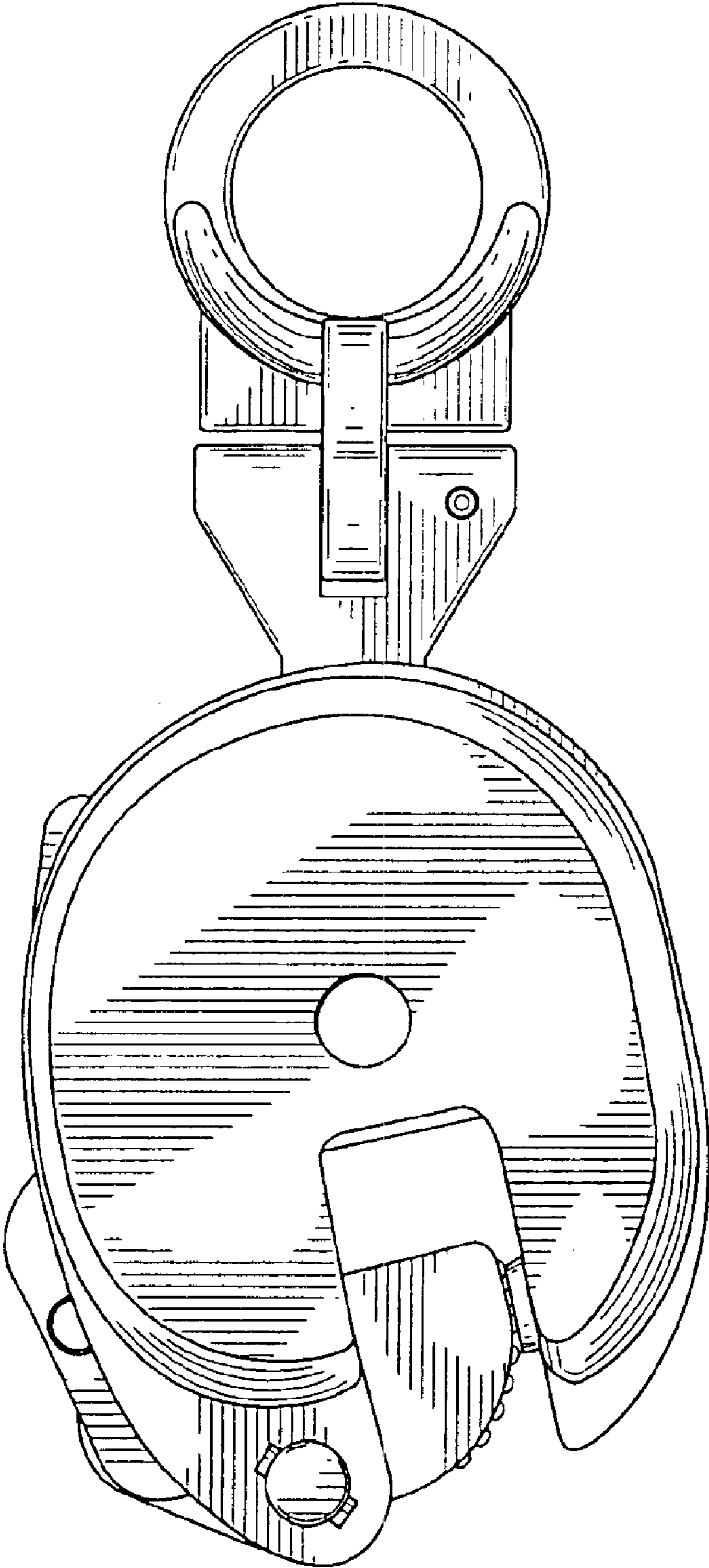

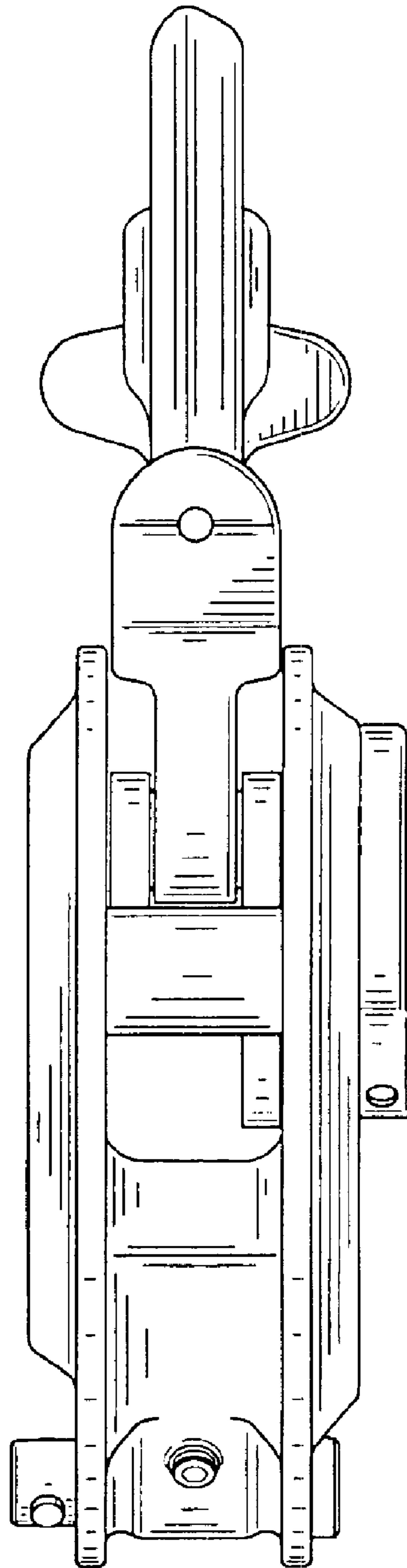

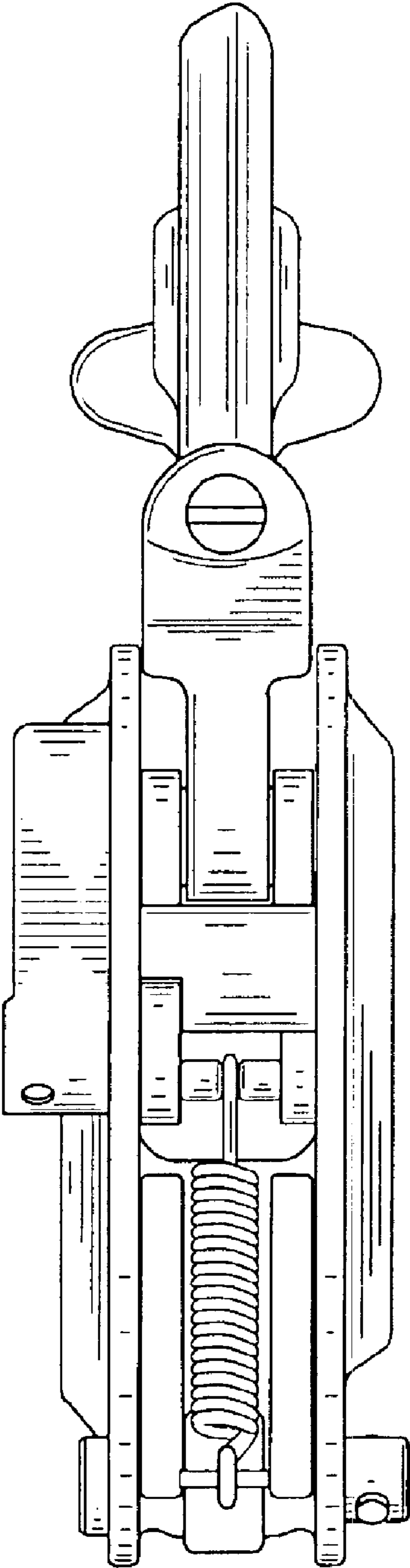
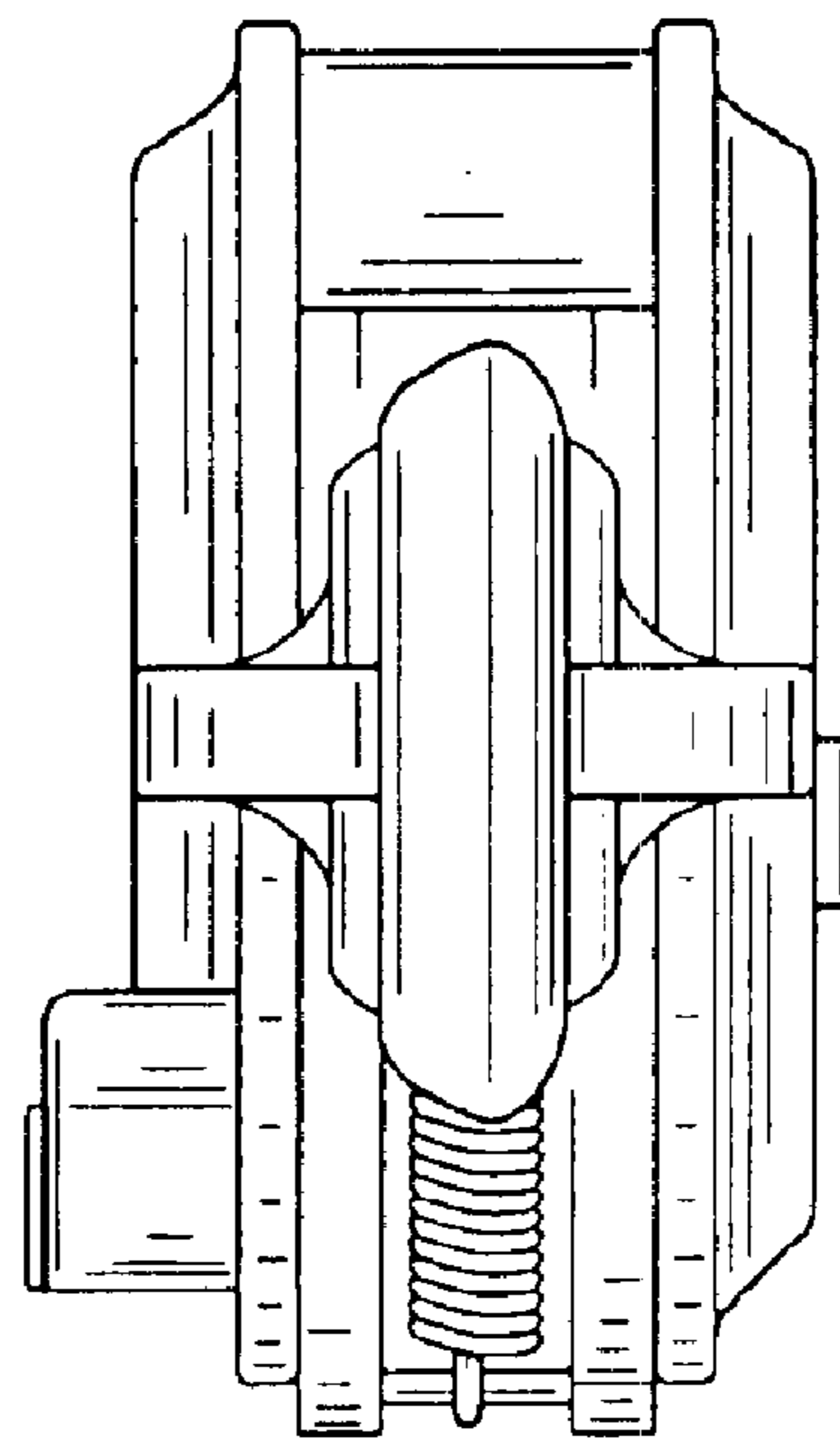
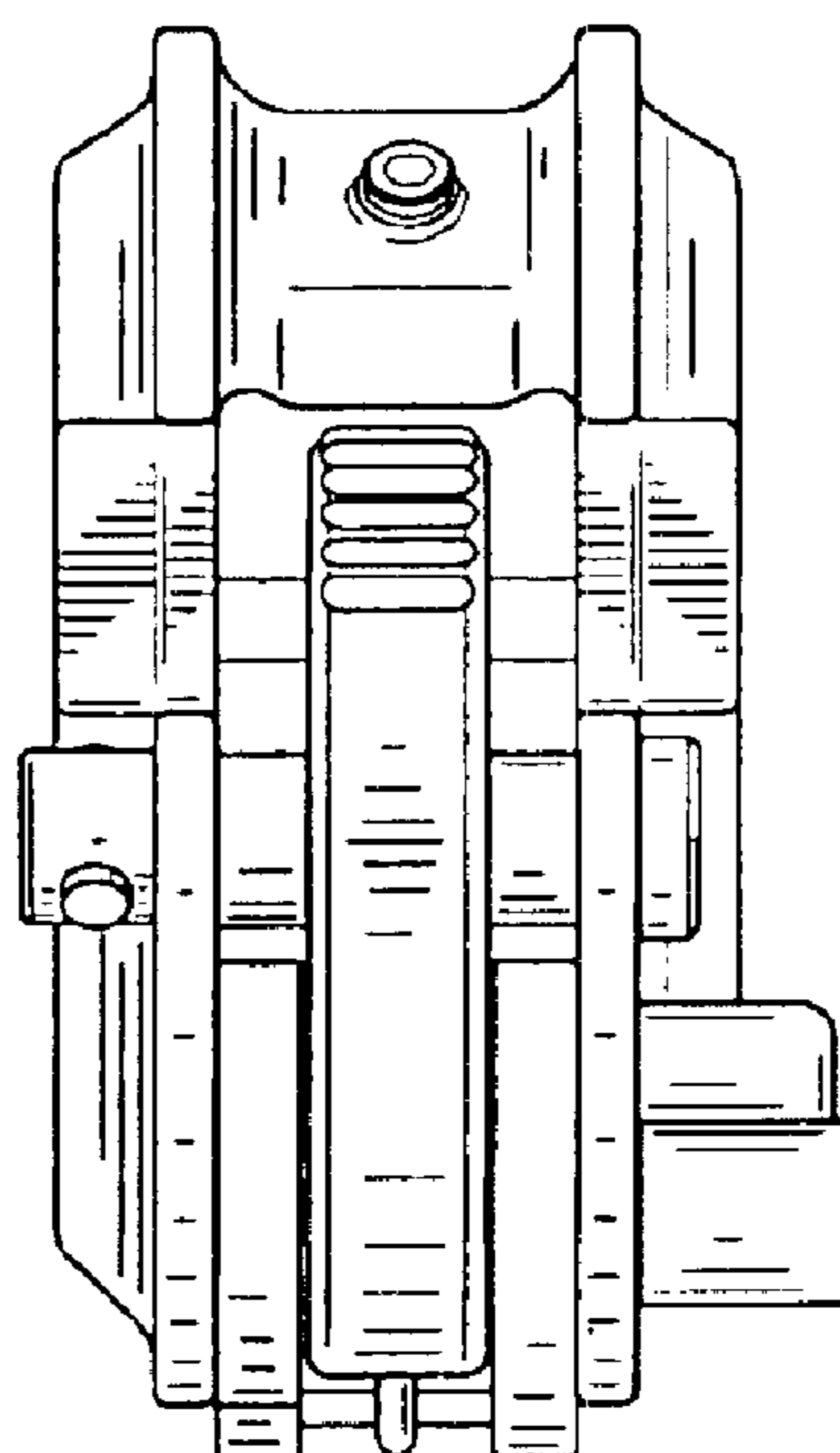
