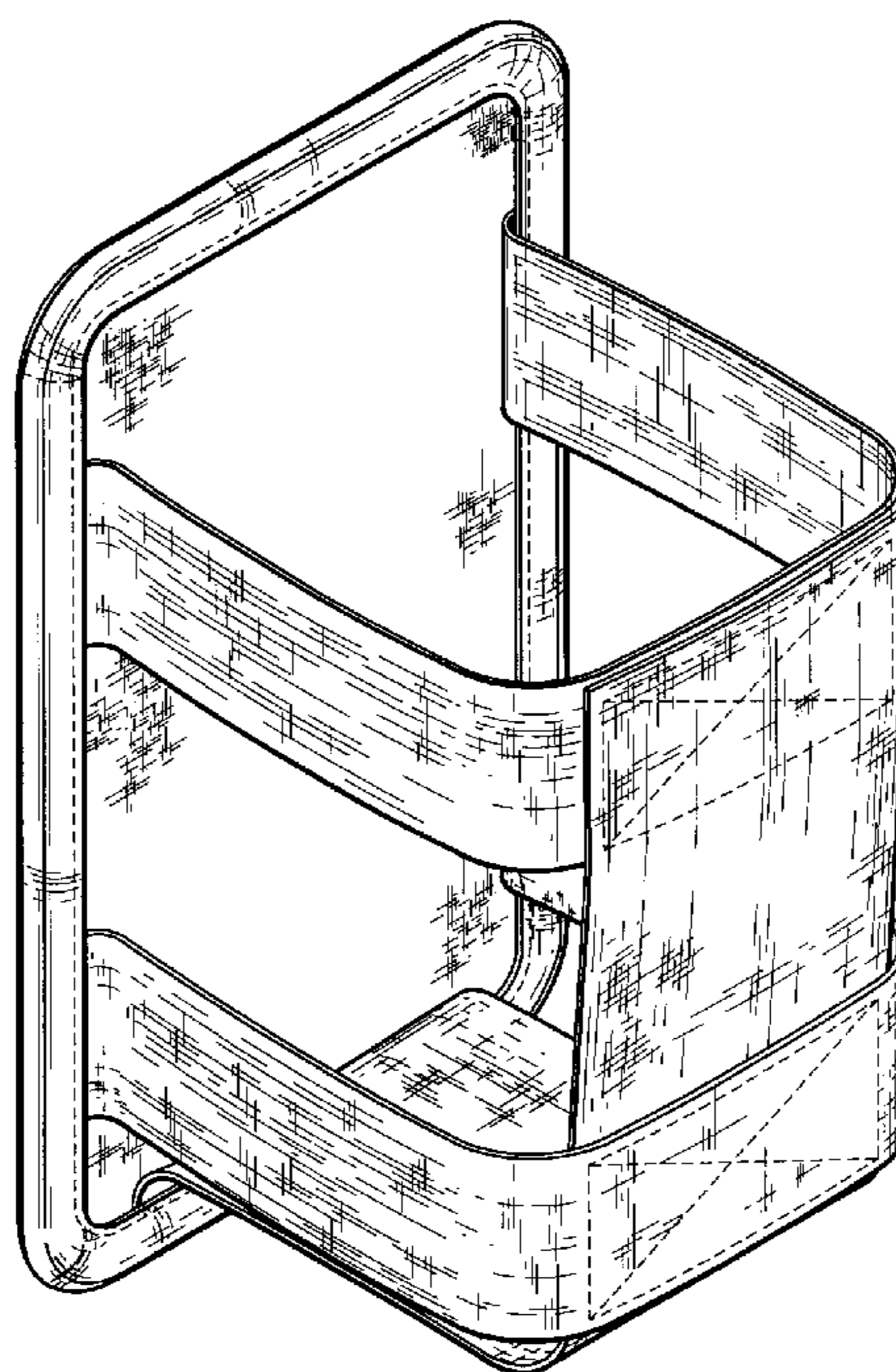

 FIG. 9 is a right side elevation, the left side elevation being a mirror image thereof;
 FIG. 10 is a top plan view thereof;
 FIG. 11 is a bottom plan view thereof;
 FIG. 12 is a rear elevation thereof; and,
 FIG. 13 is a perspective view of the bottle holder shown in FIGS. 1–6 with dotted lines illustrating the intended use and environment of the design.
 The broken line showing of a rear clip is for illustrative purposes only and forms no part of the claimed design.

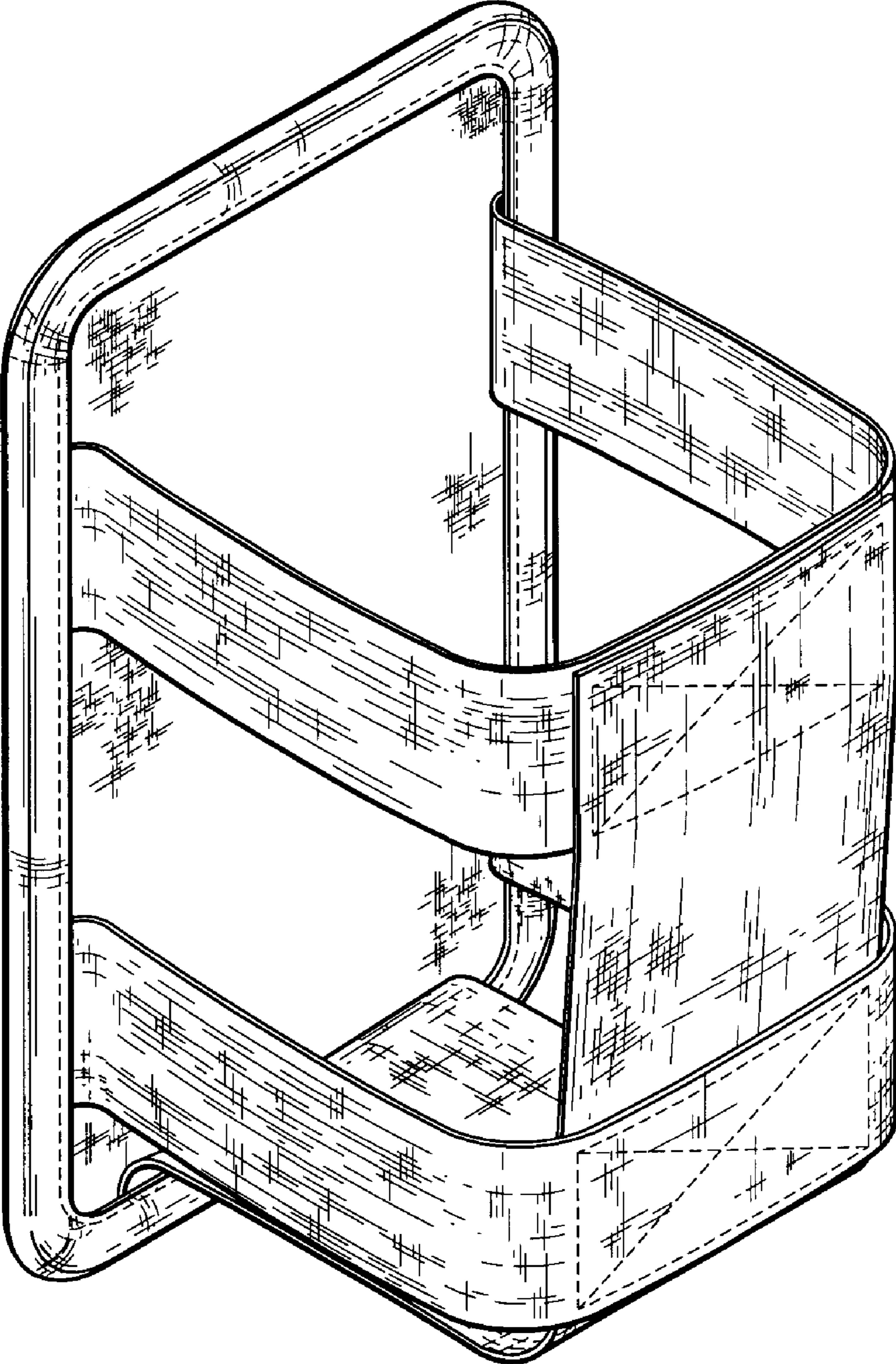

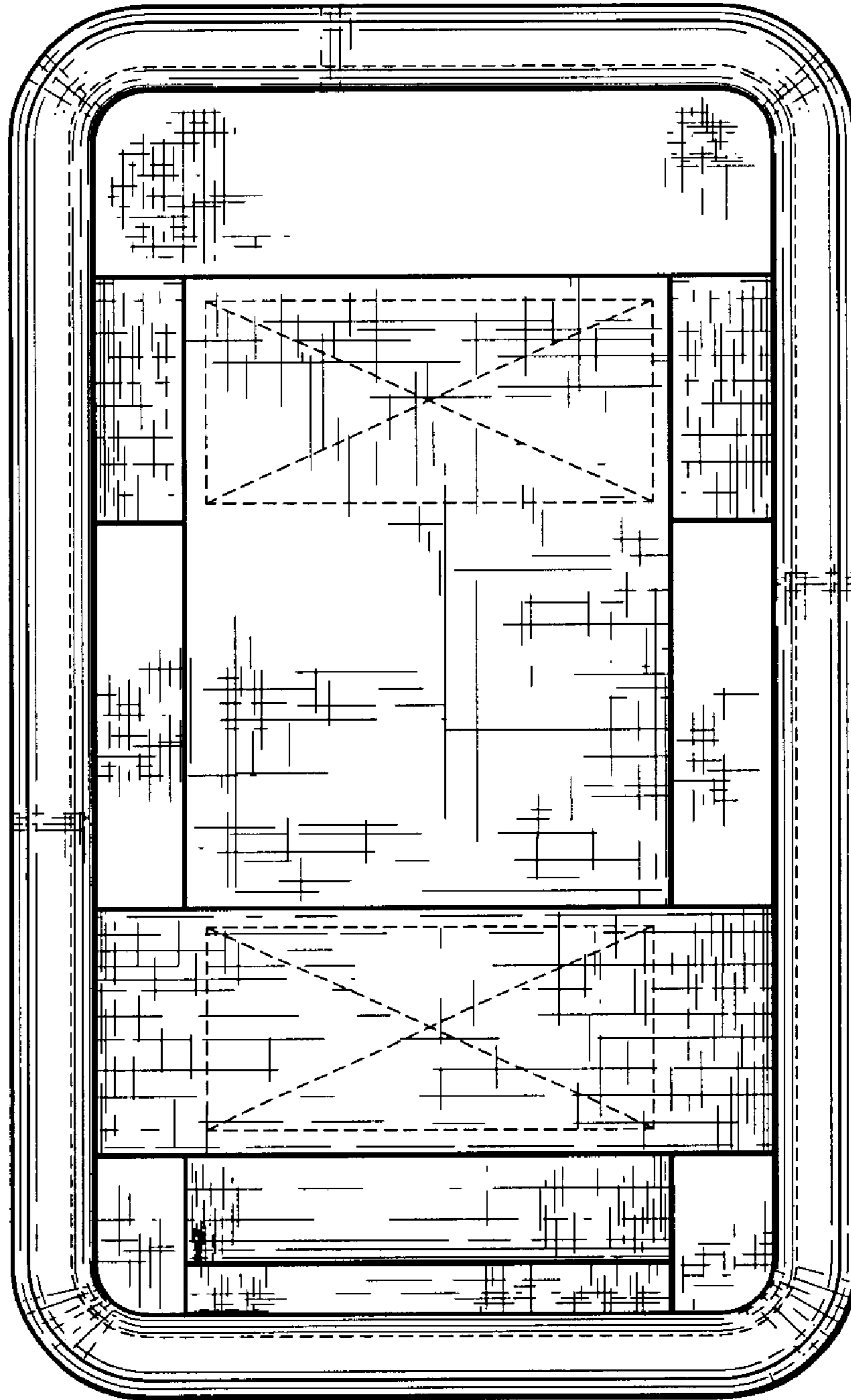

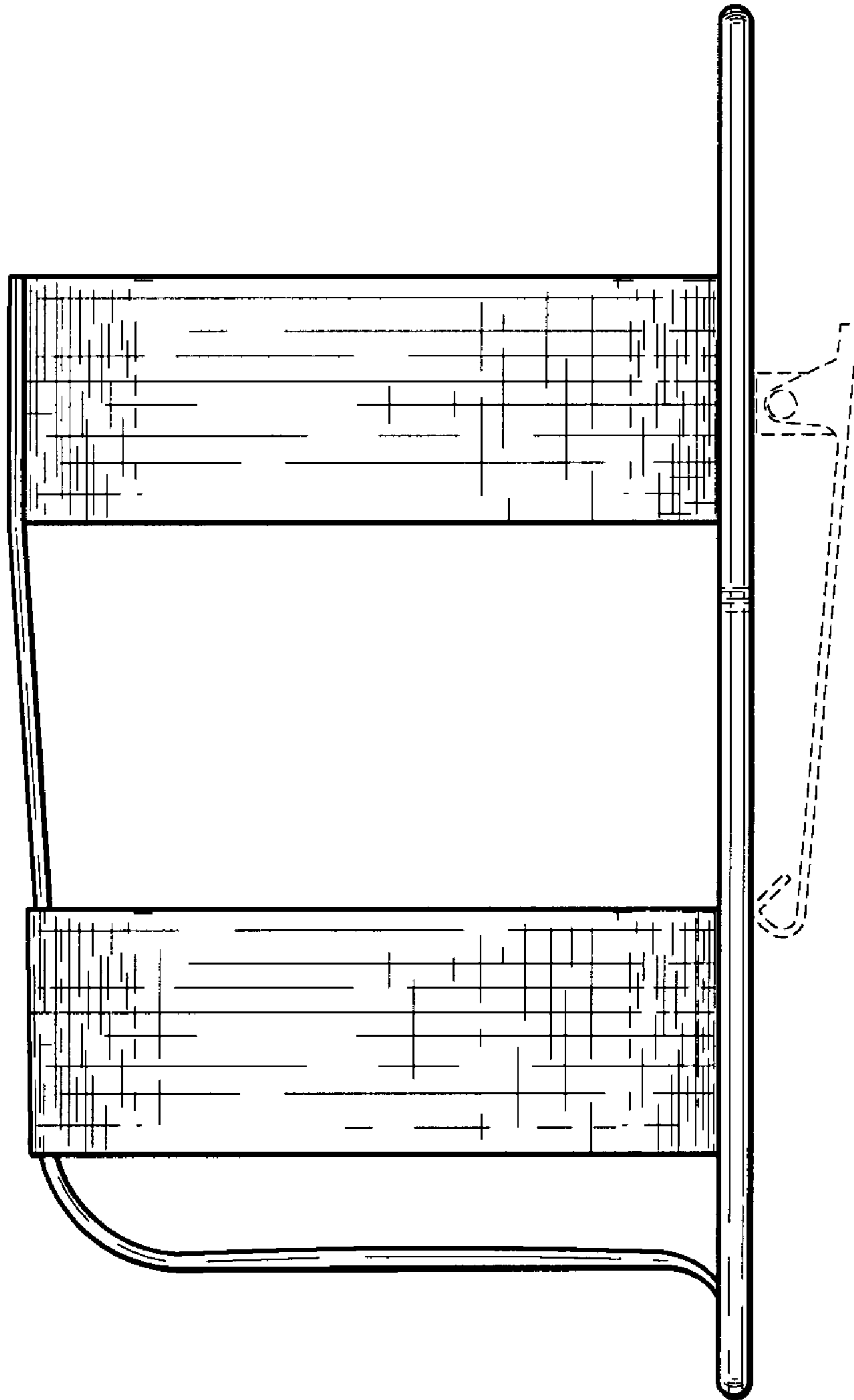

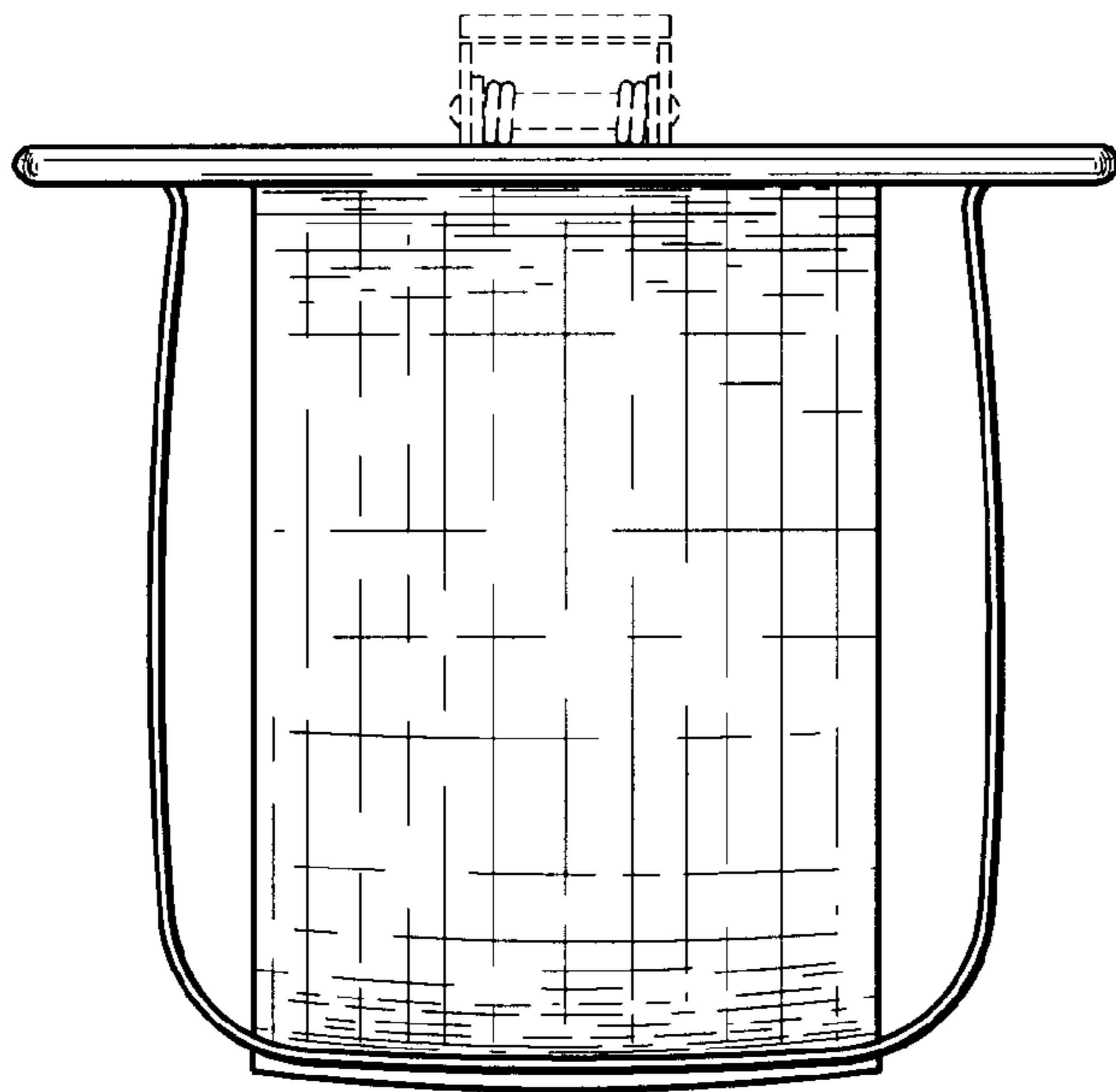

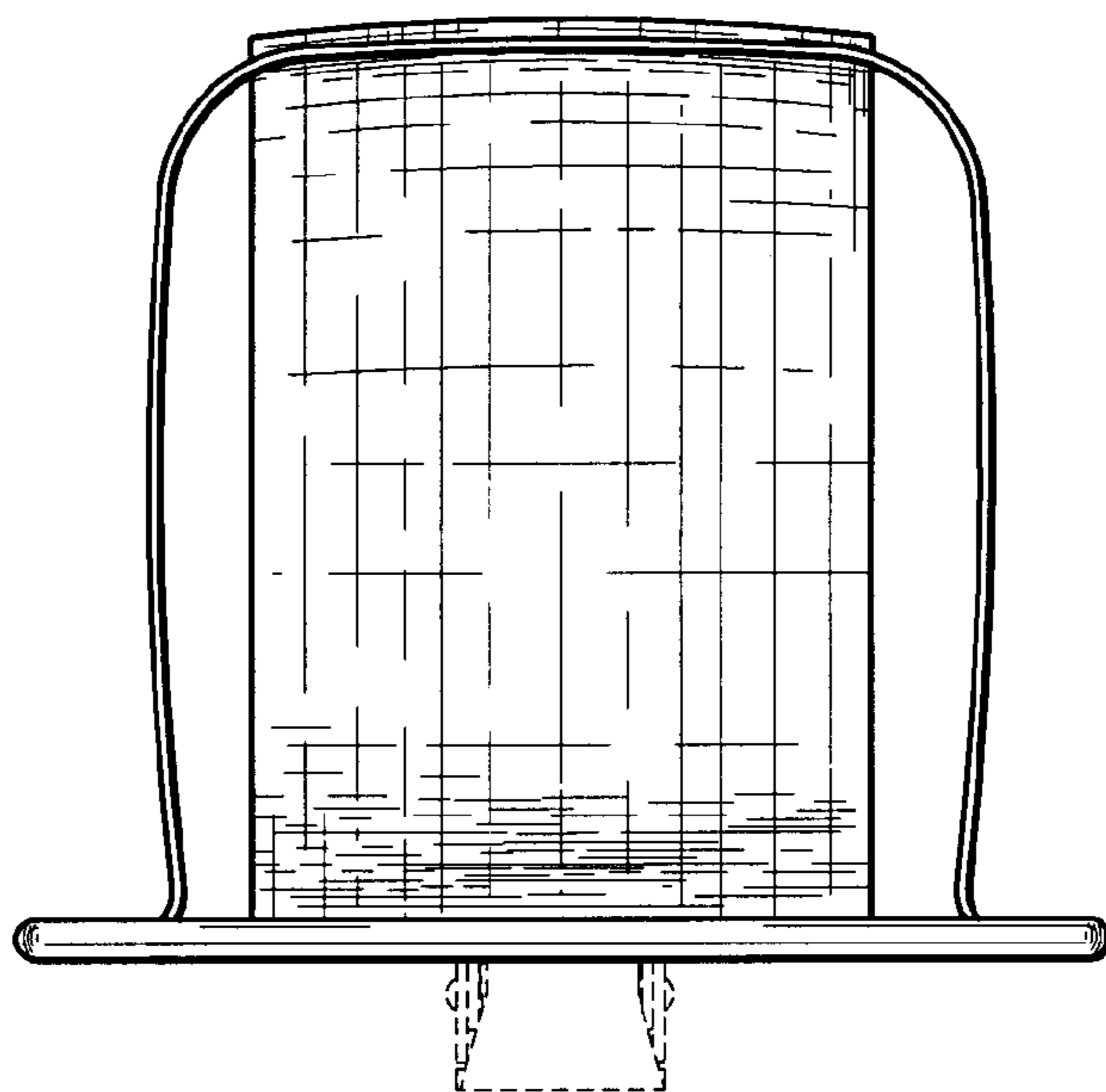

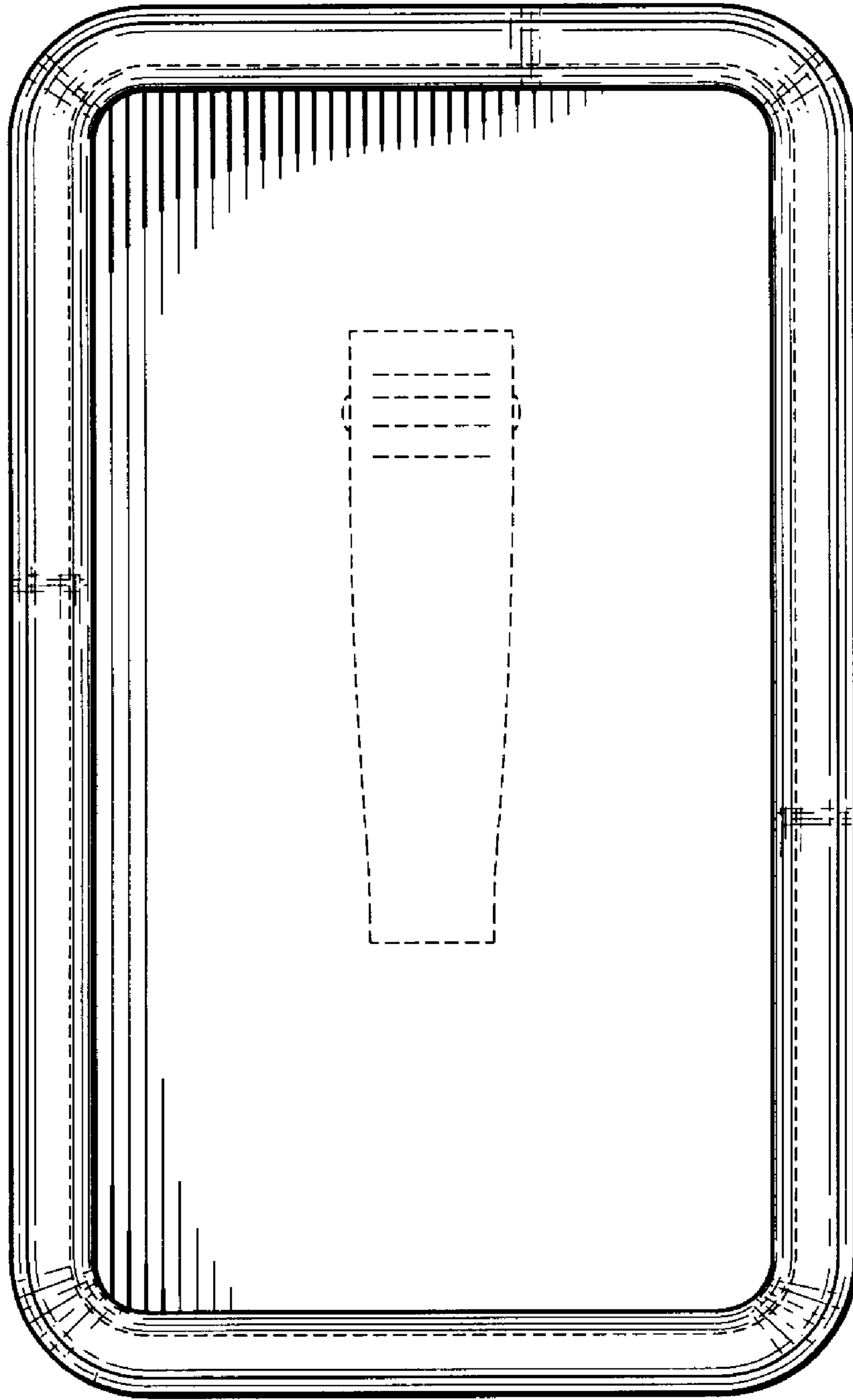

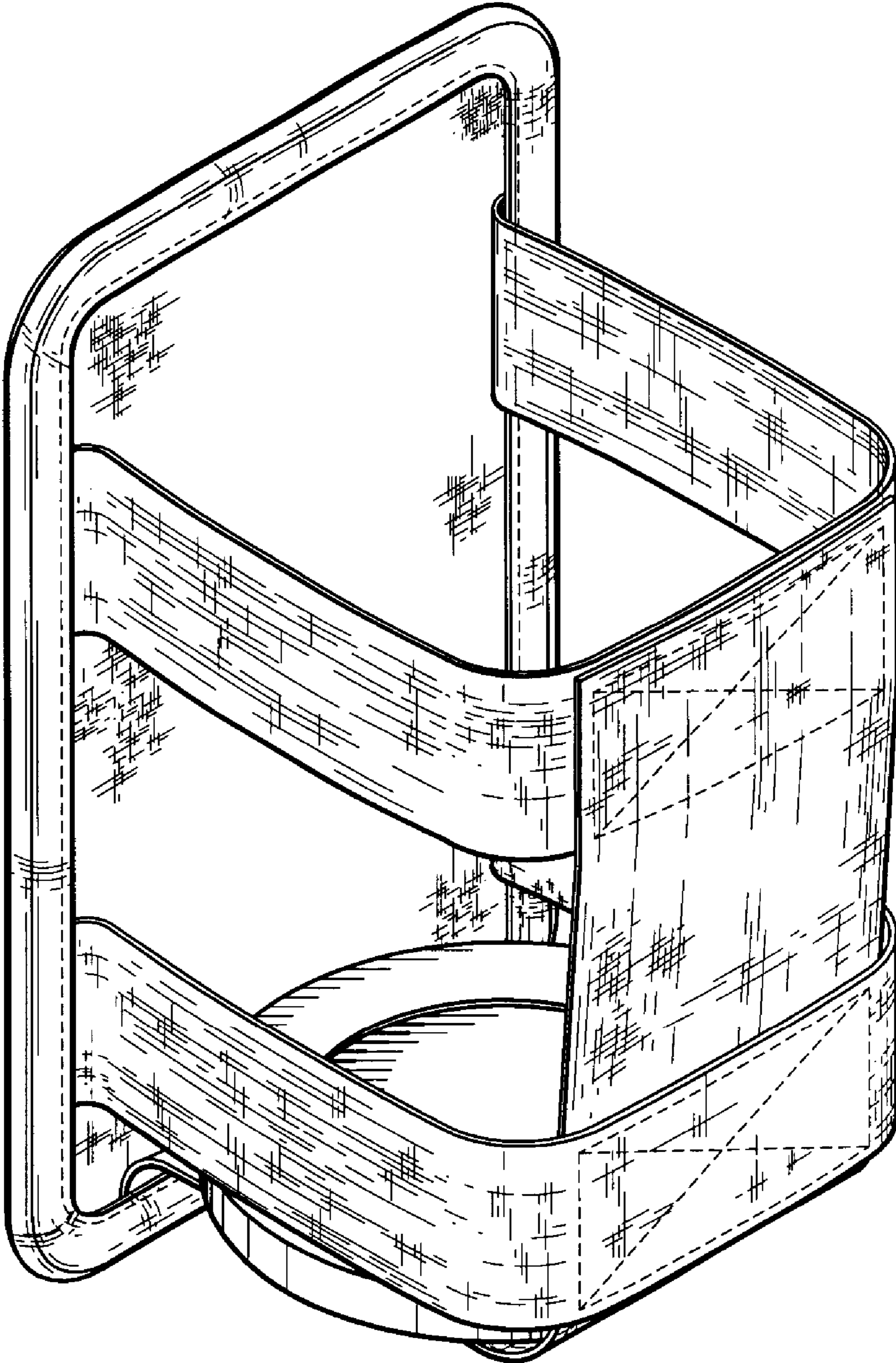

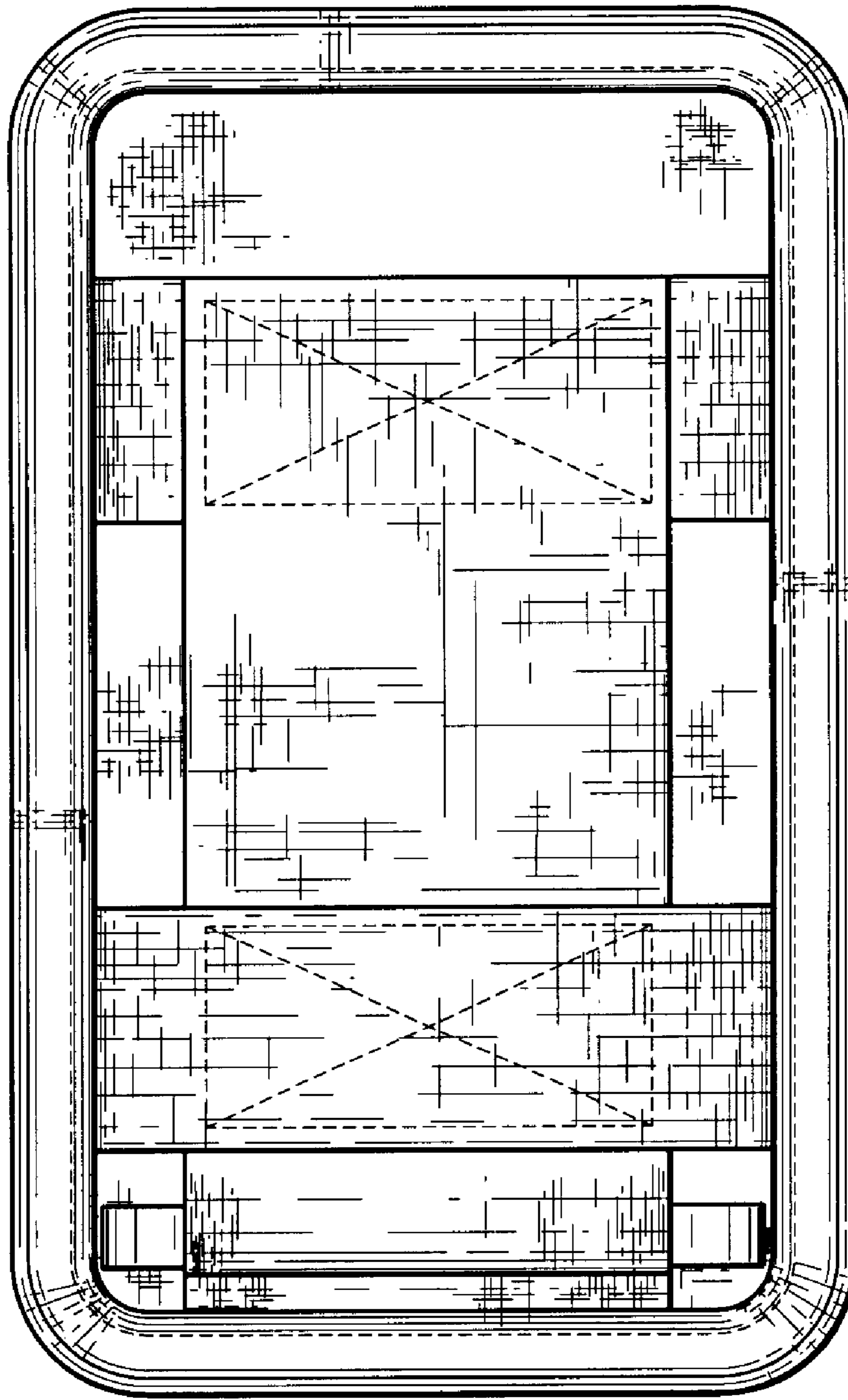

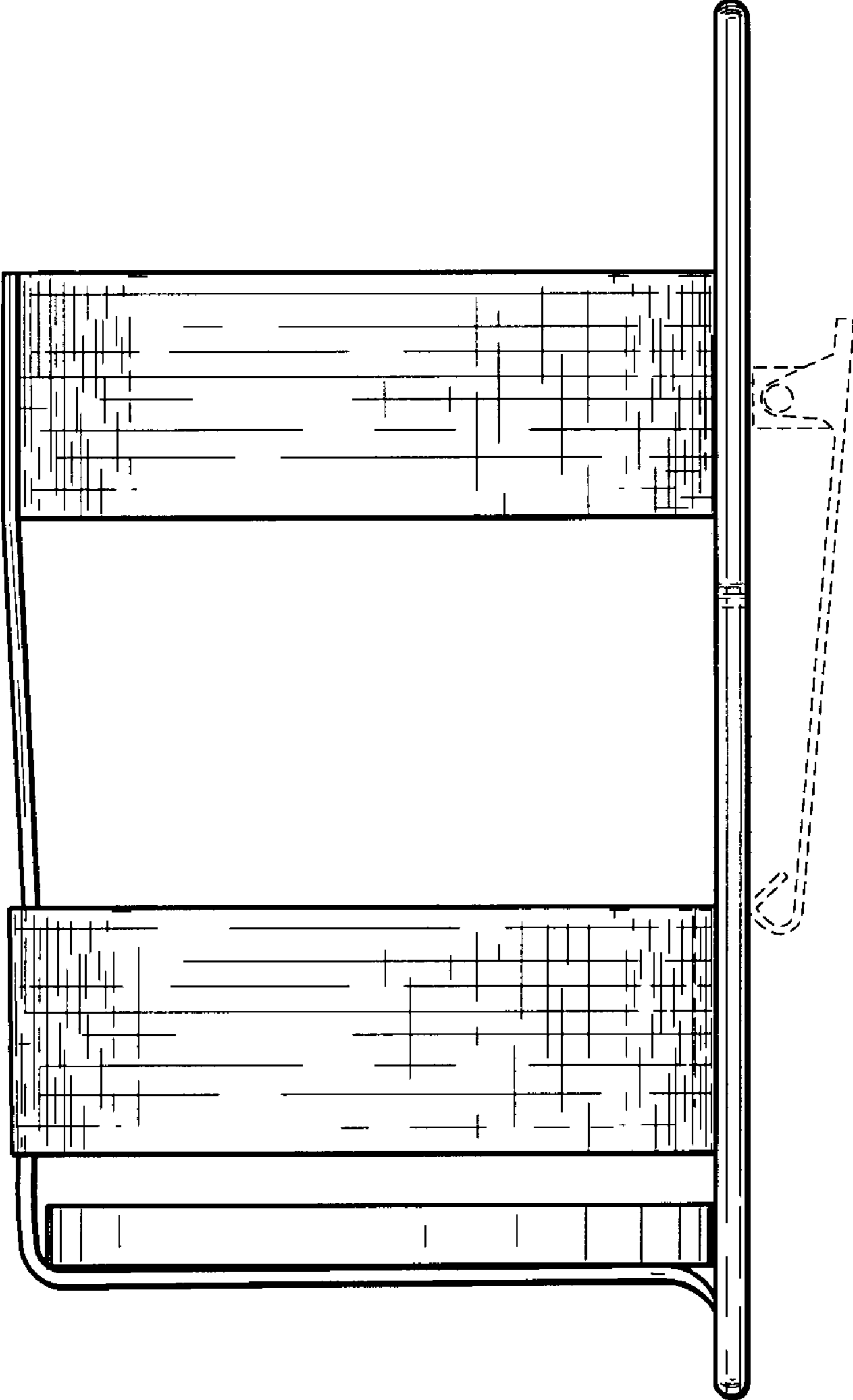

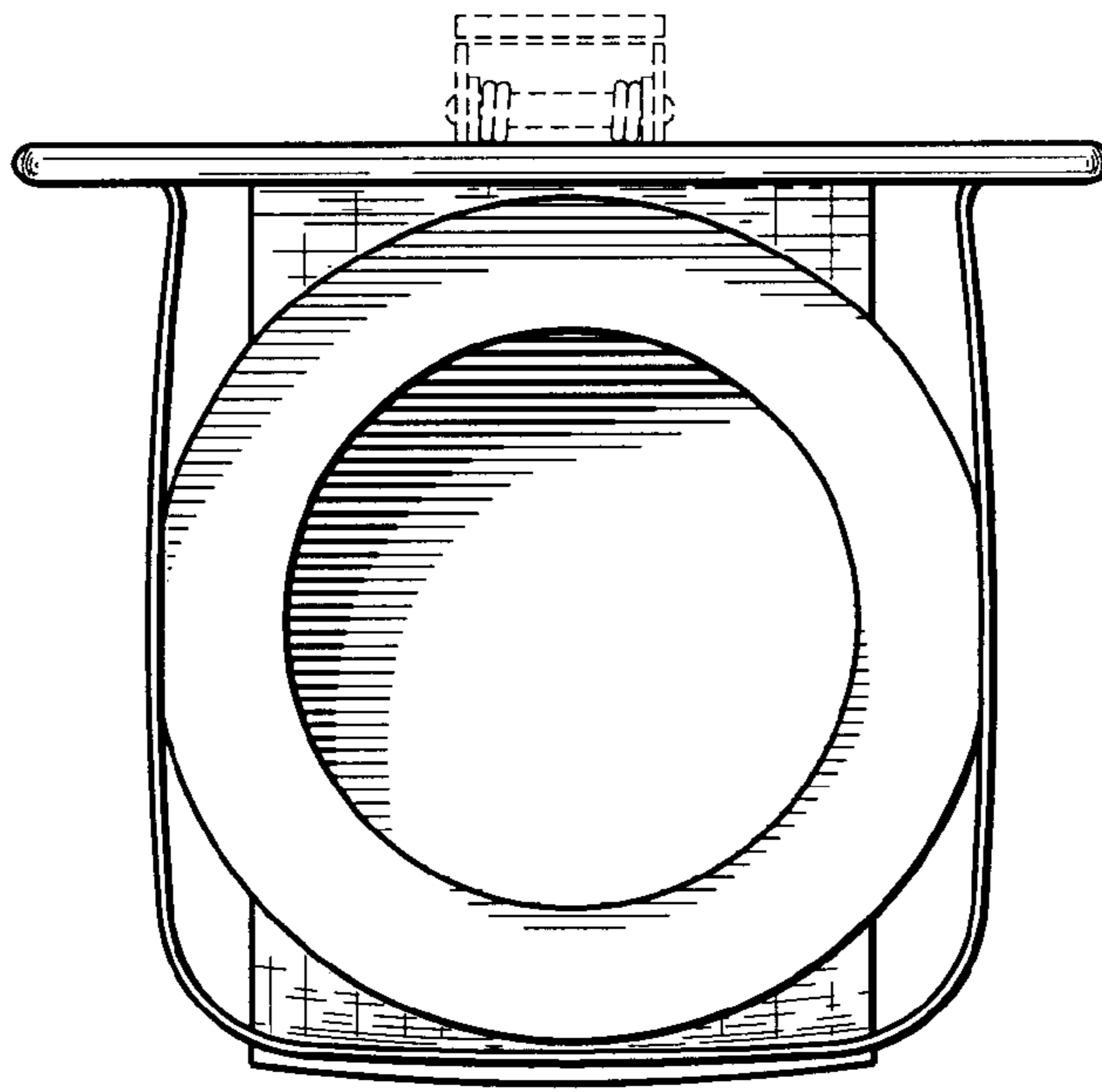

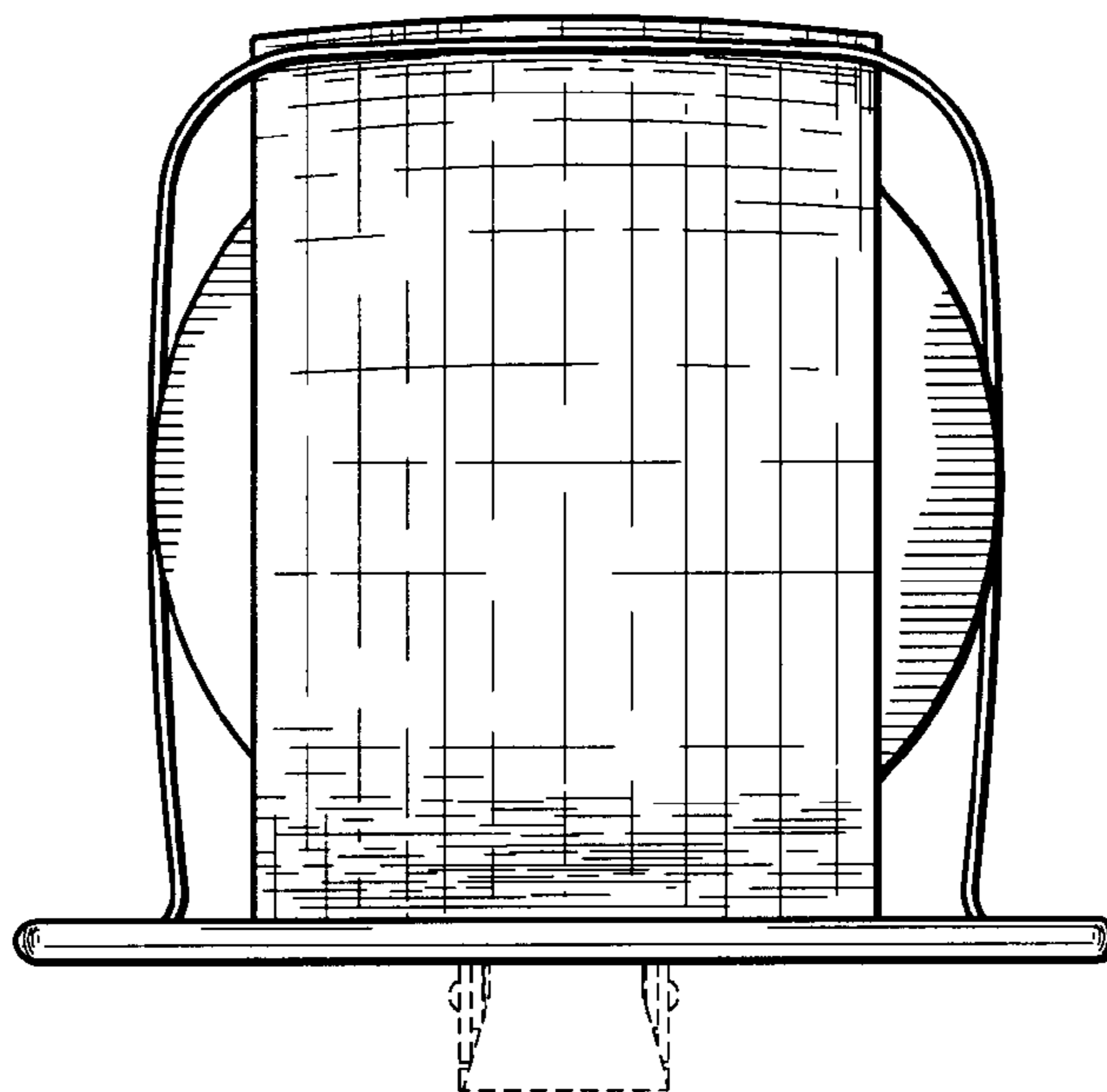

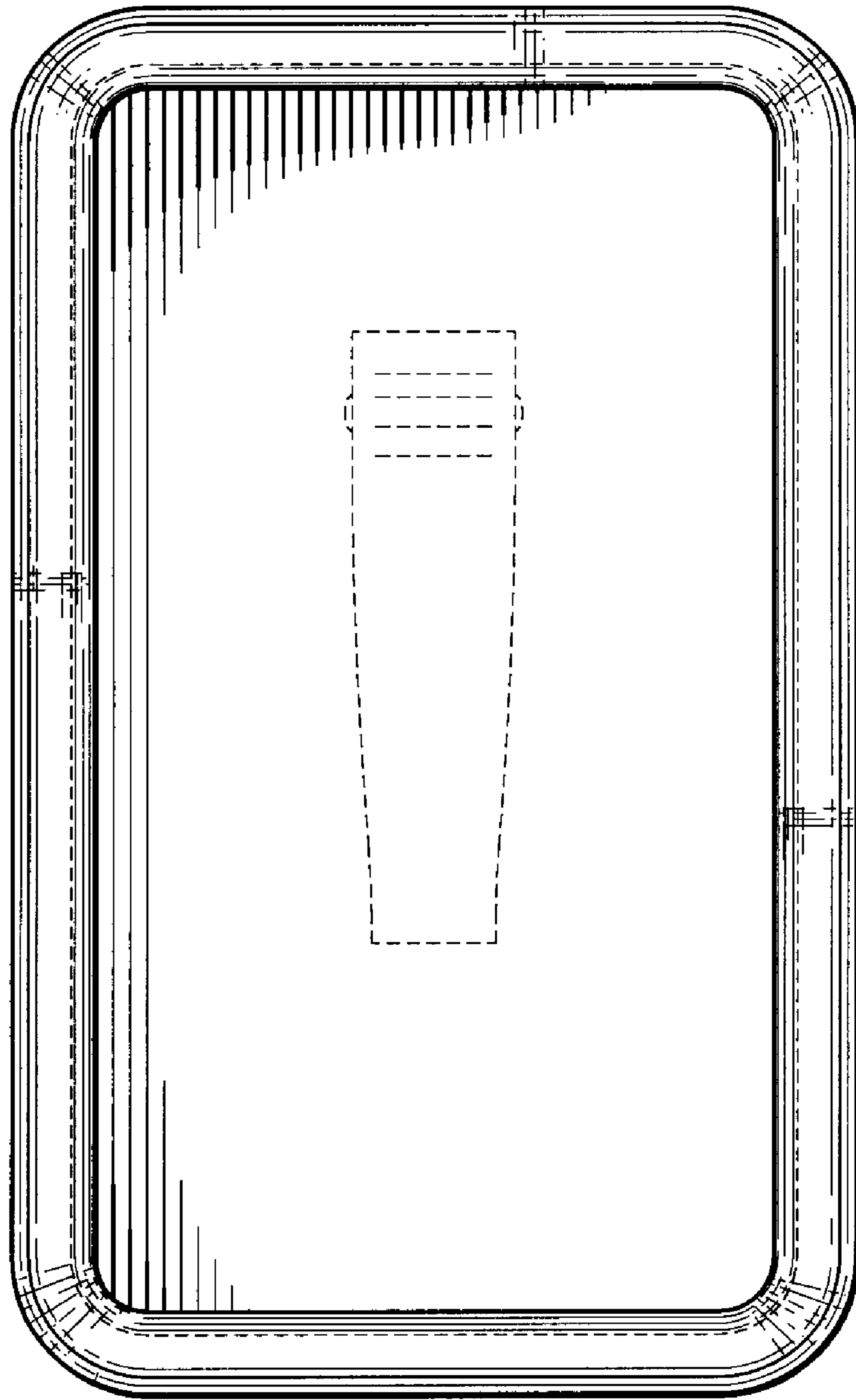

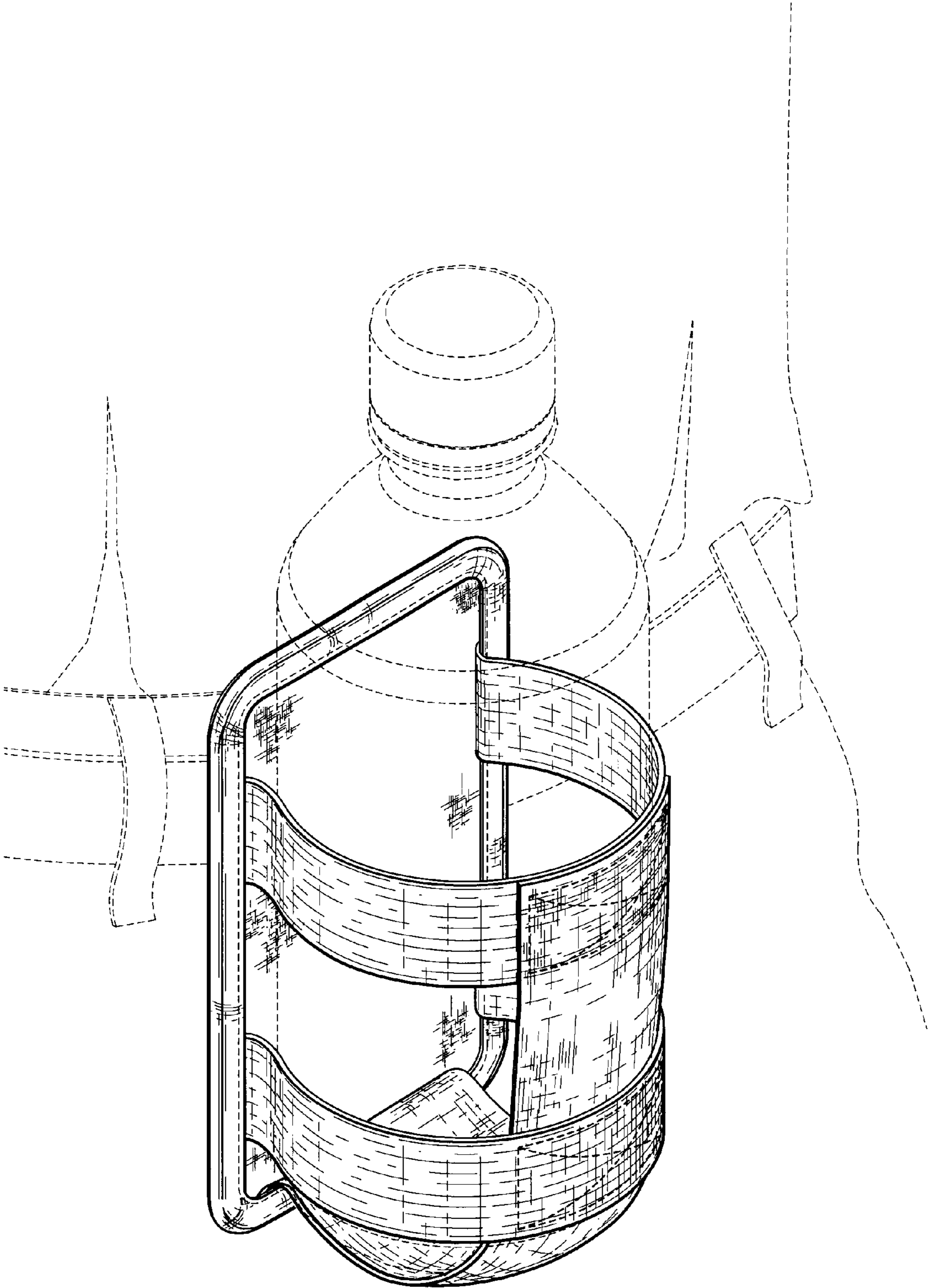
