FIG. 1 is a front view of a hair brush showing our new design;

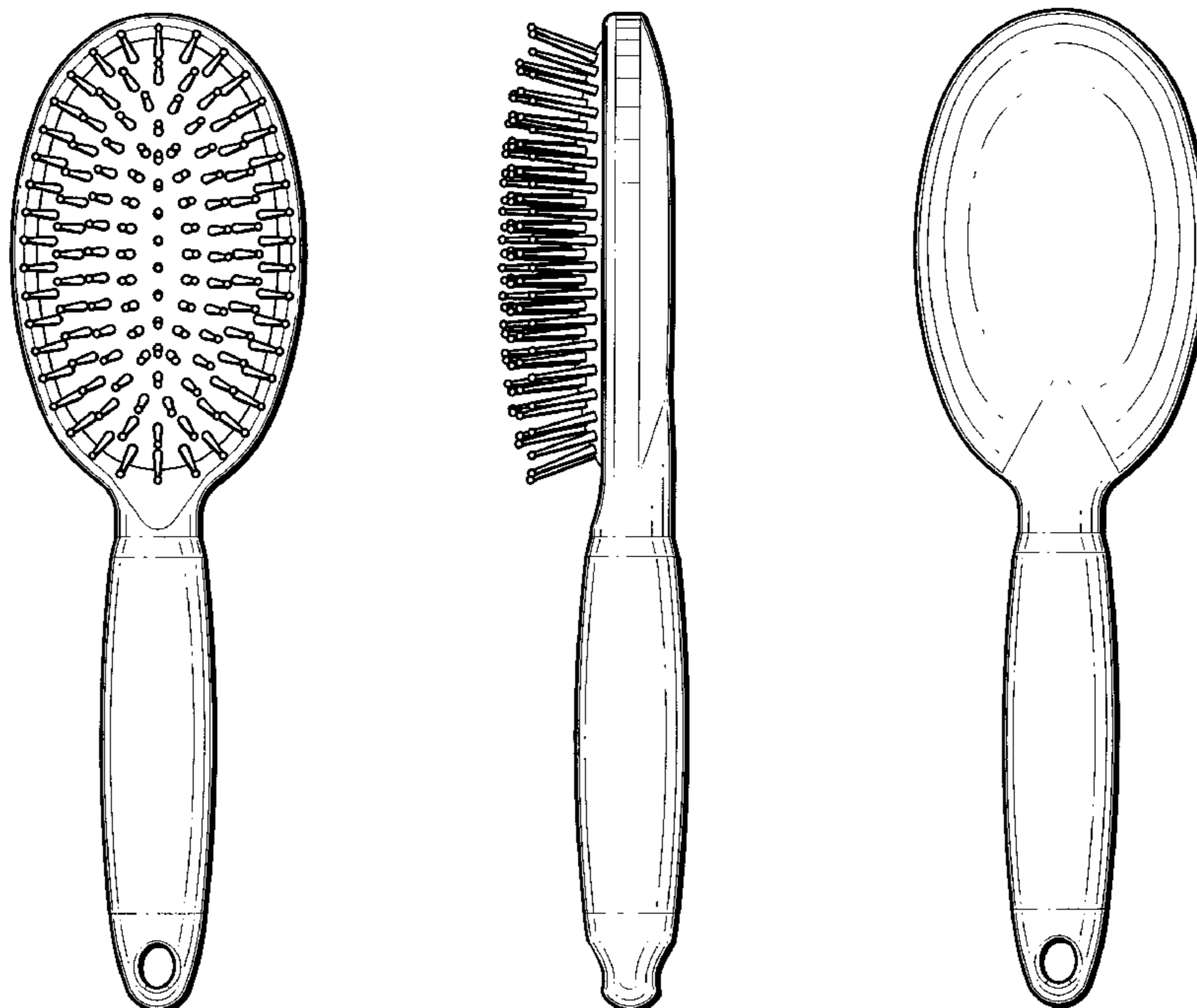
FIG. 2 is a right side view thereof;

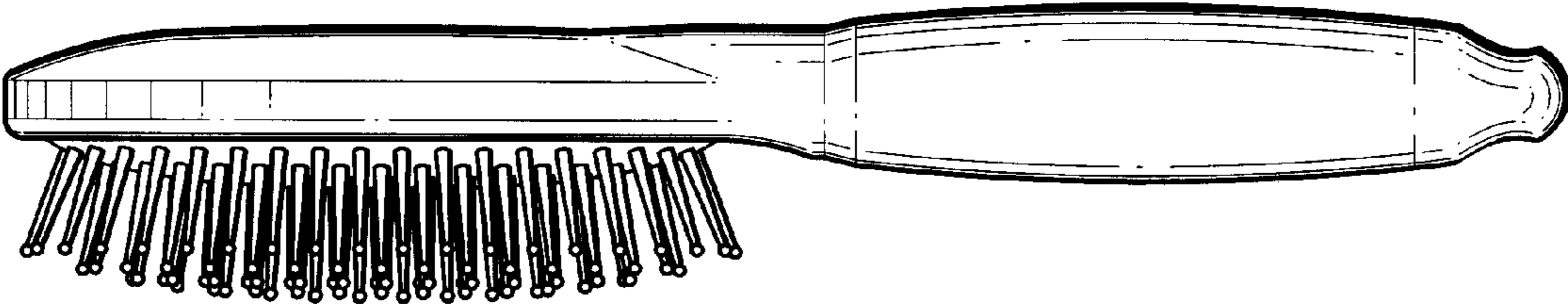

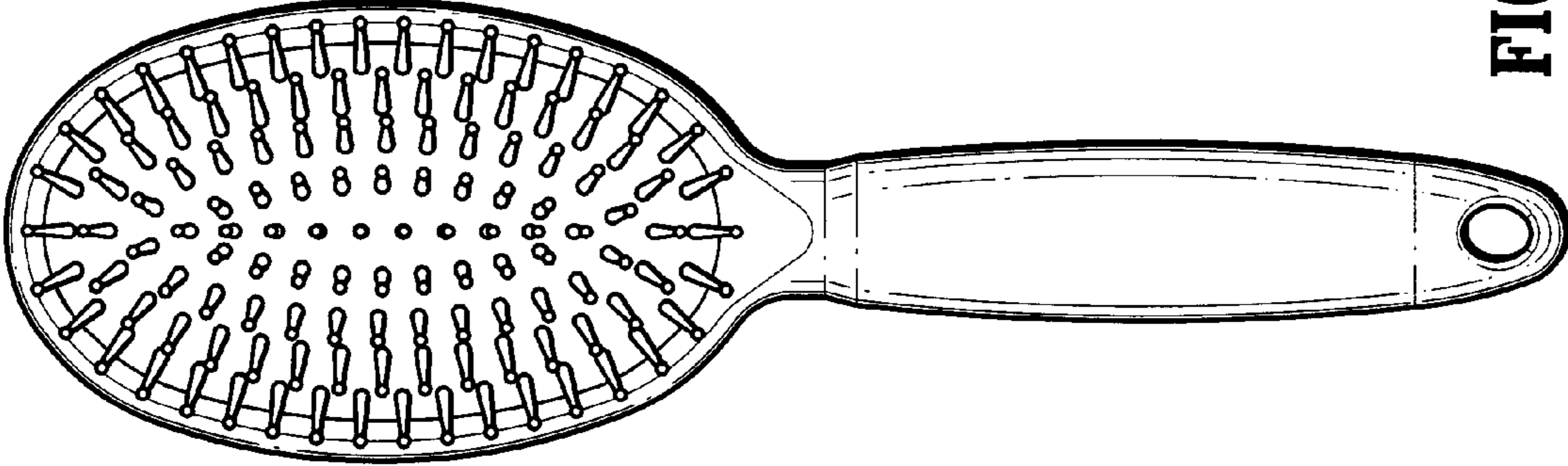

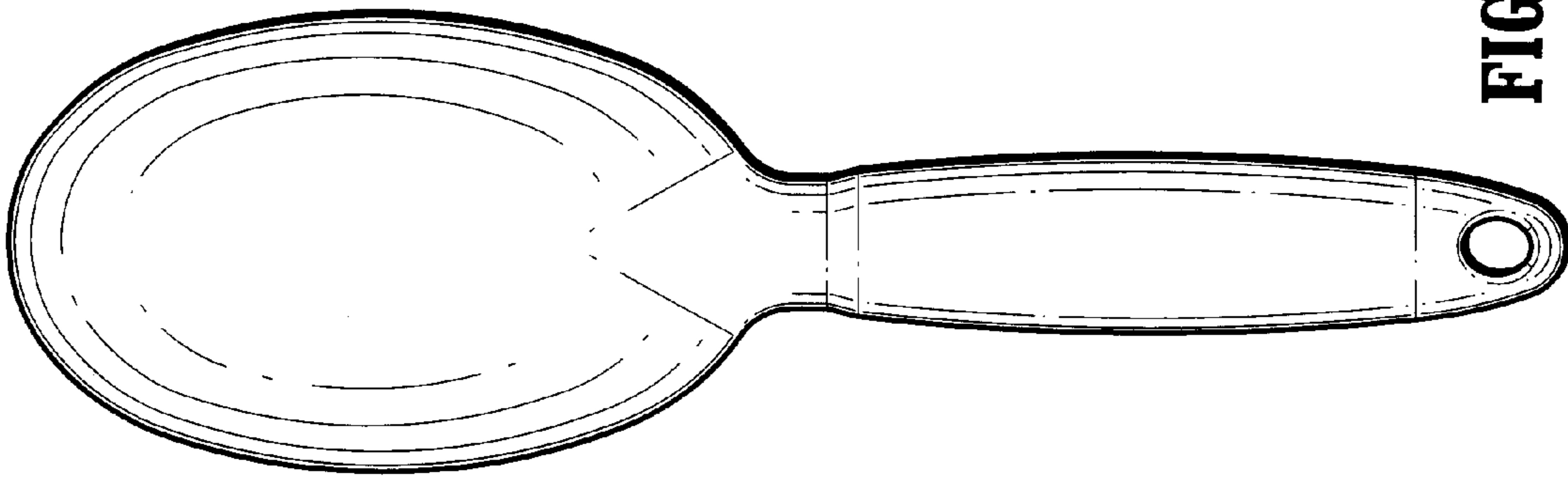

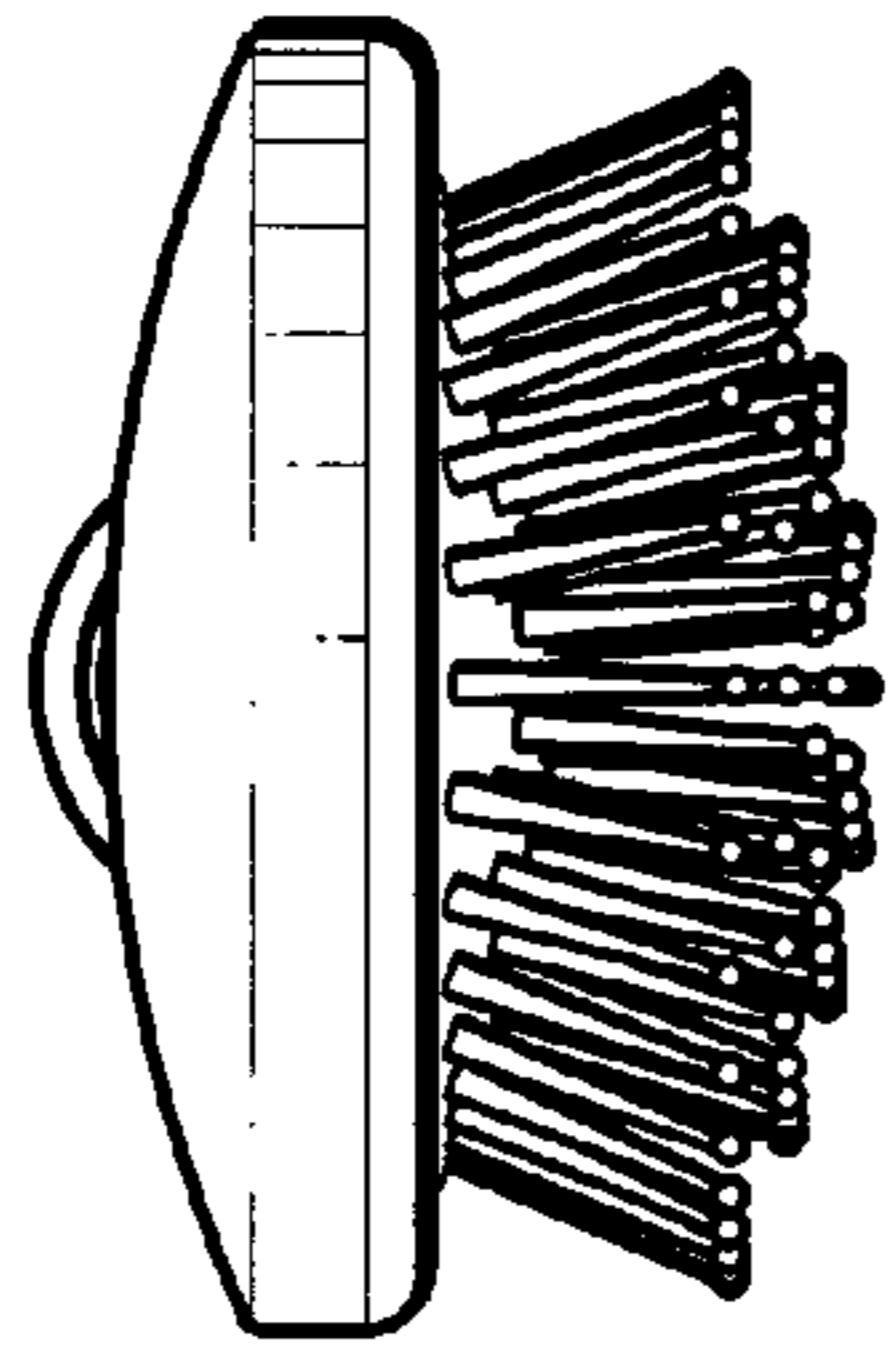

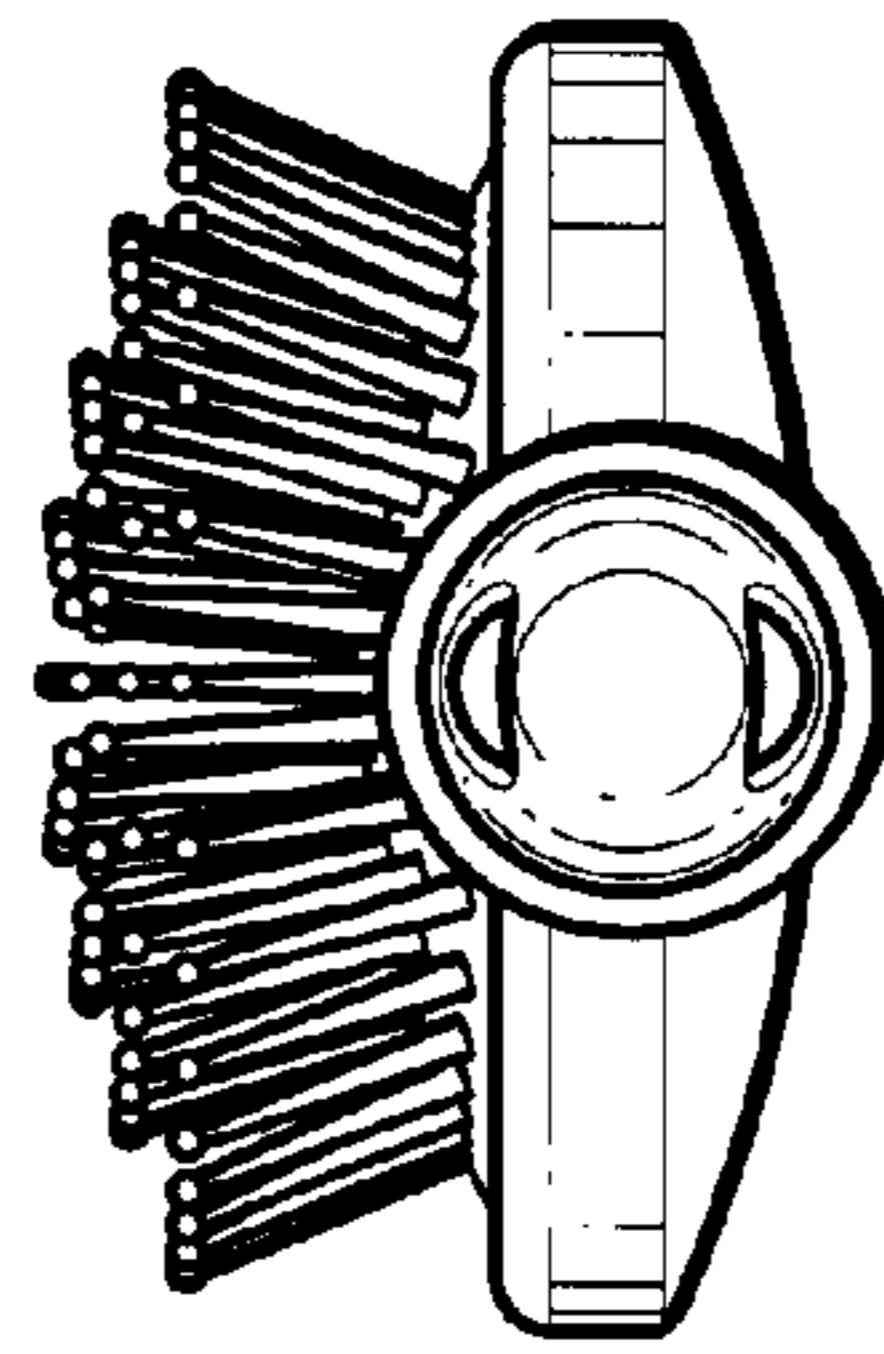
