The ornamental design for the table, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a table accordance with the new design;

FIG. 2 is a top view thereof;

FIG. 3 is a front view thereof, where the rear view is a mirror image thereof;

FIG. 4 is a right view thereof, where the left side view is a mirror image thereof;

FIG. 5 is a right side view of an alternative embodiment of said new design having an indeterminable width;

FIG. 6 is a right side view of an alternative embodiment of said new design showing legs broken away for indeterminable length;

FIG. 7 is a right side view of an alternative embodiment of said new design having an indeterminable width and showing legs broken away for indeterminable length;

FIG. 8 is a right side view of an alternative embodiment of said new design;

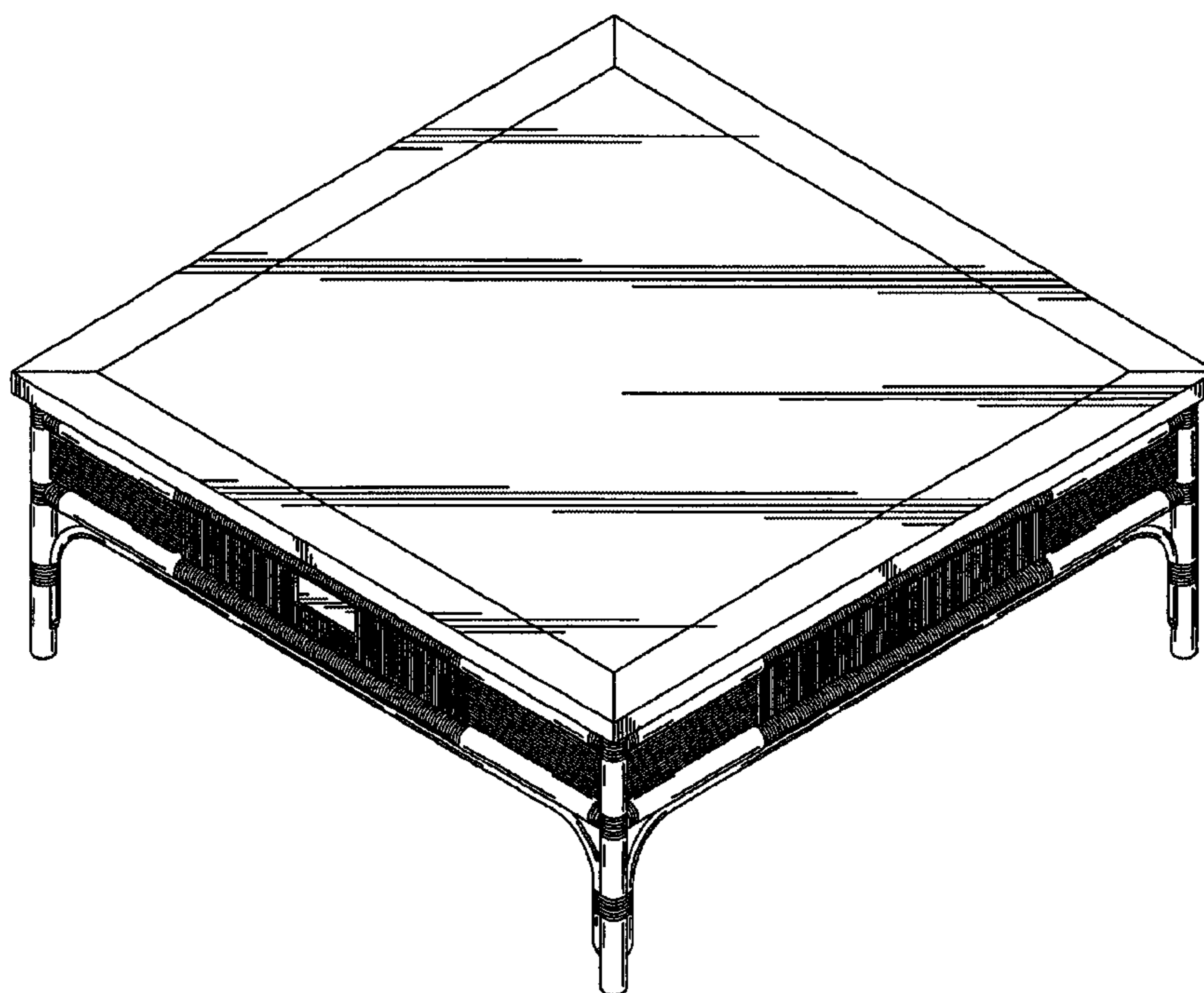
FIG. 9 is a front view of an alternative embodiment of said new design having an indeterminable width;

FIG. 10 is a front view of an alternative embodiment of said new design having an indeterminable width and showing legs broken away for indeterminable length; and,

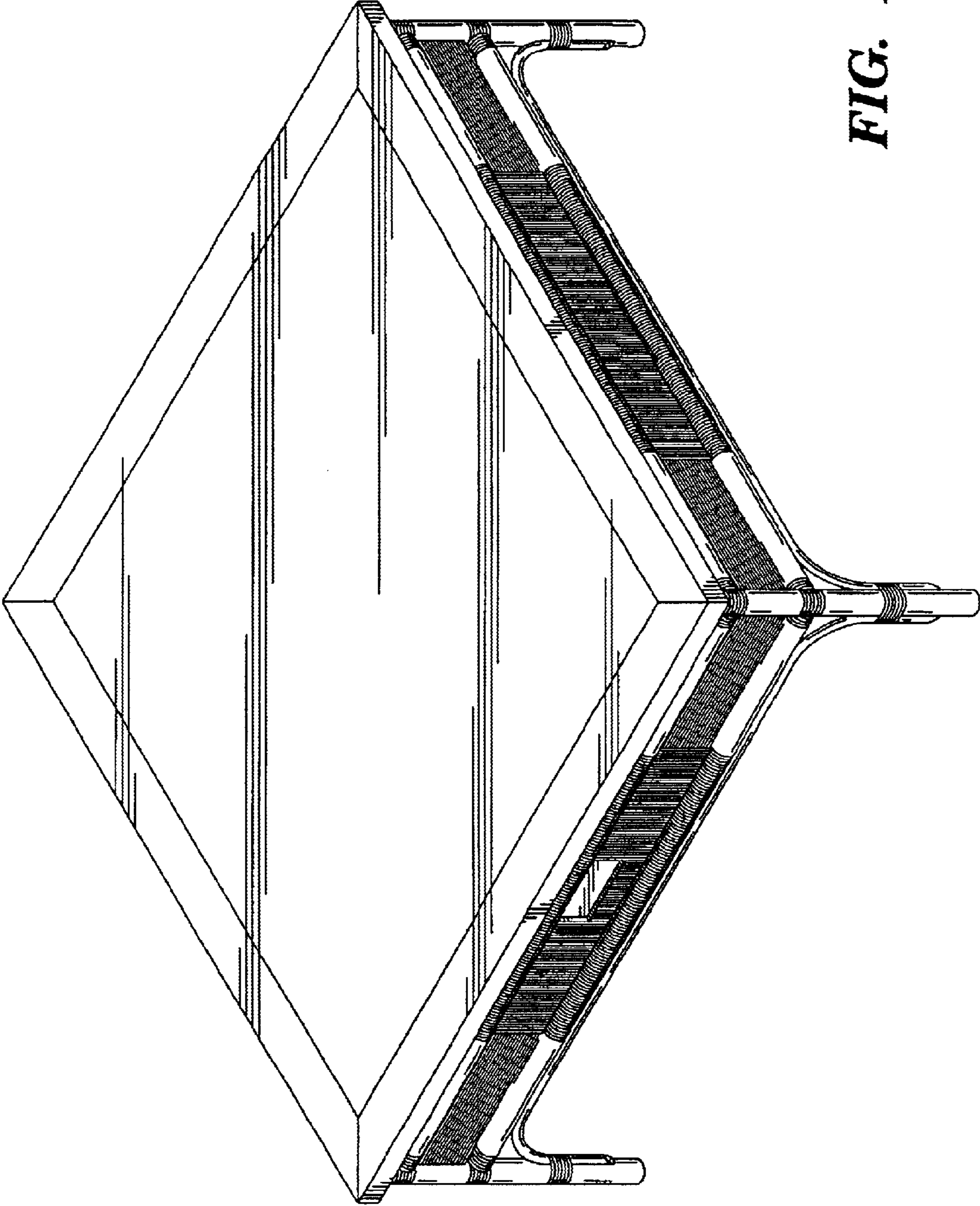

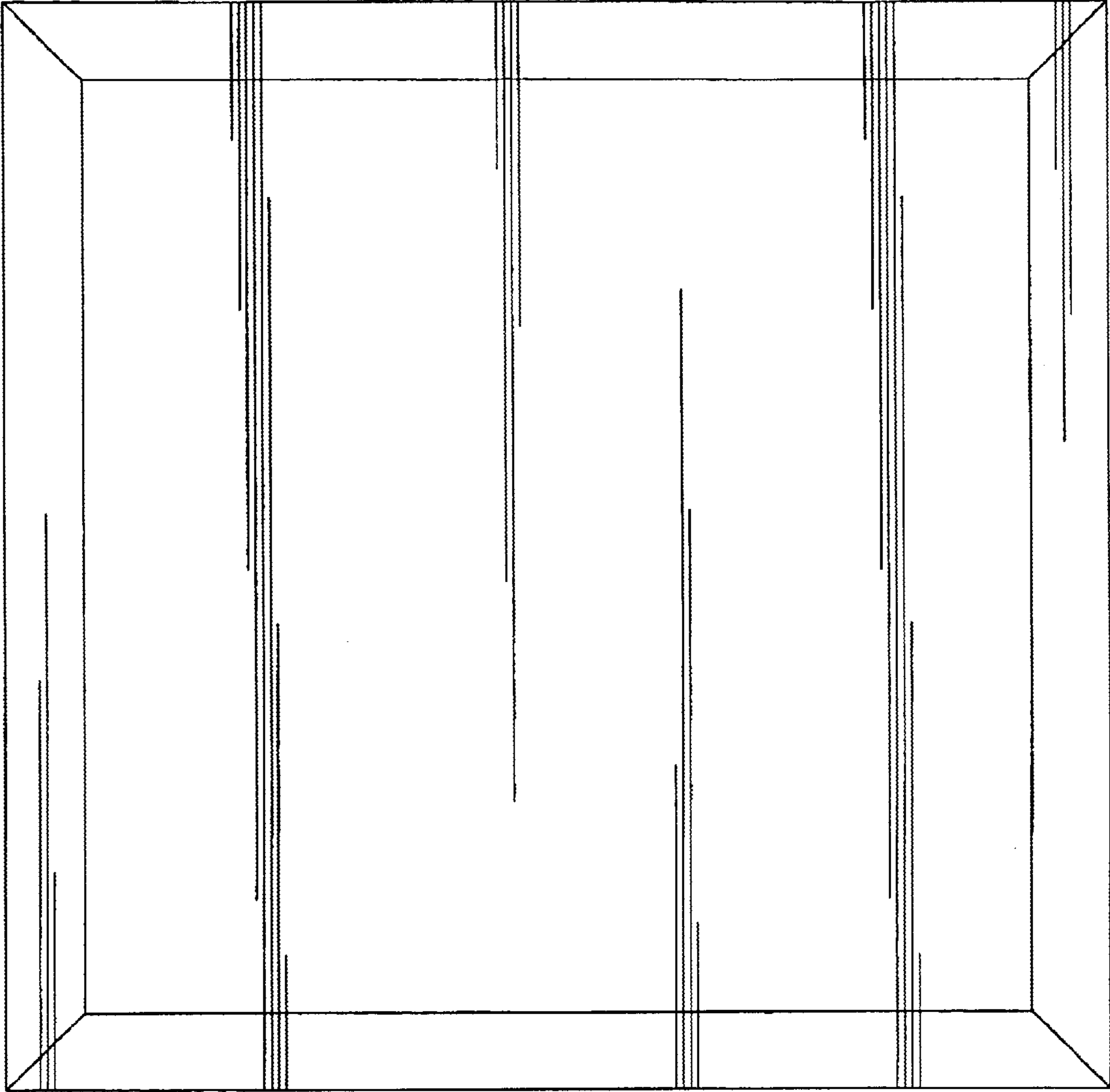

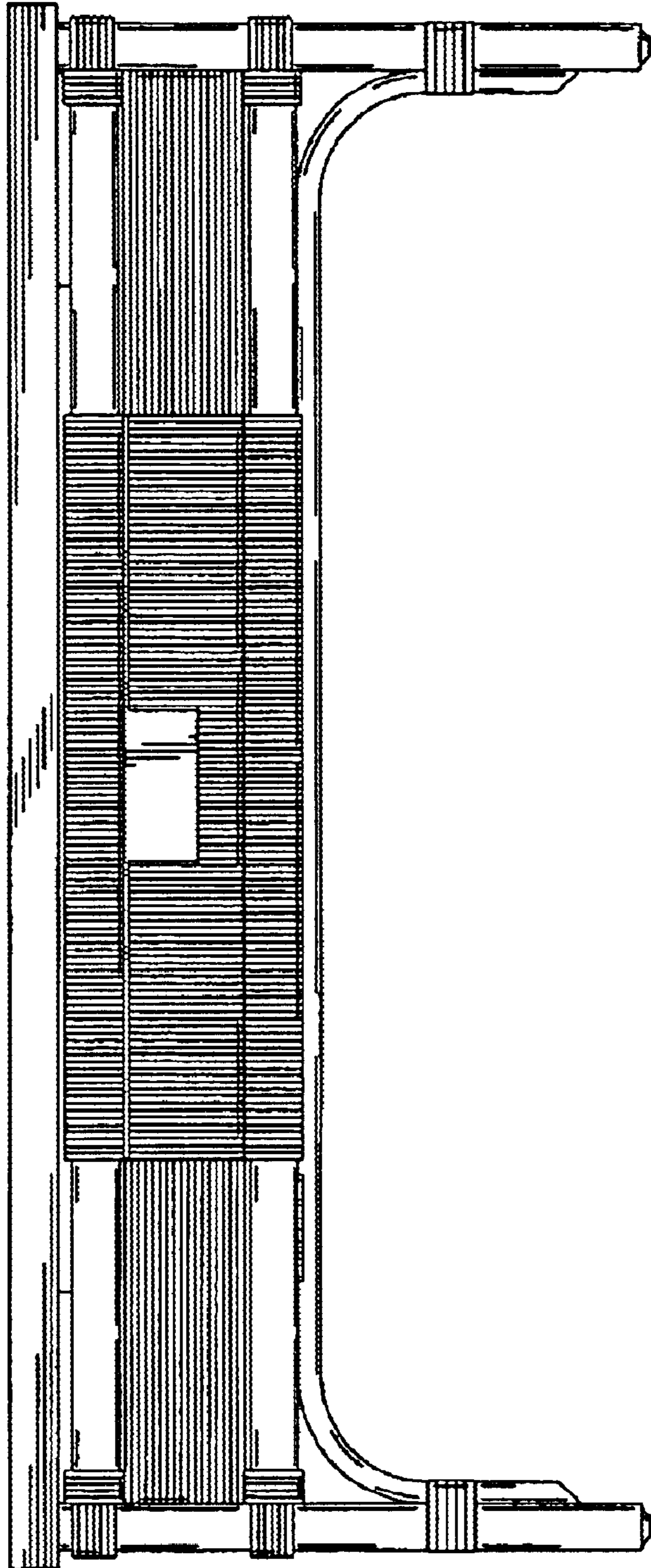

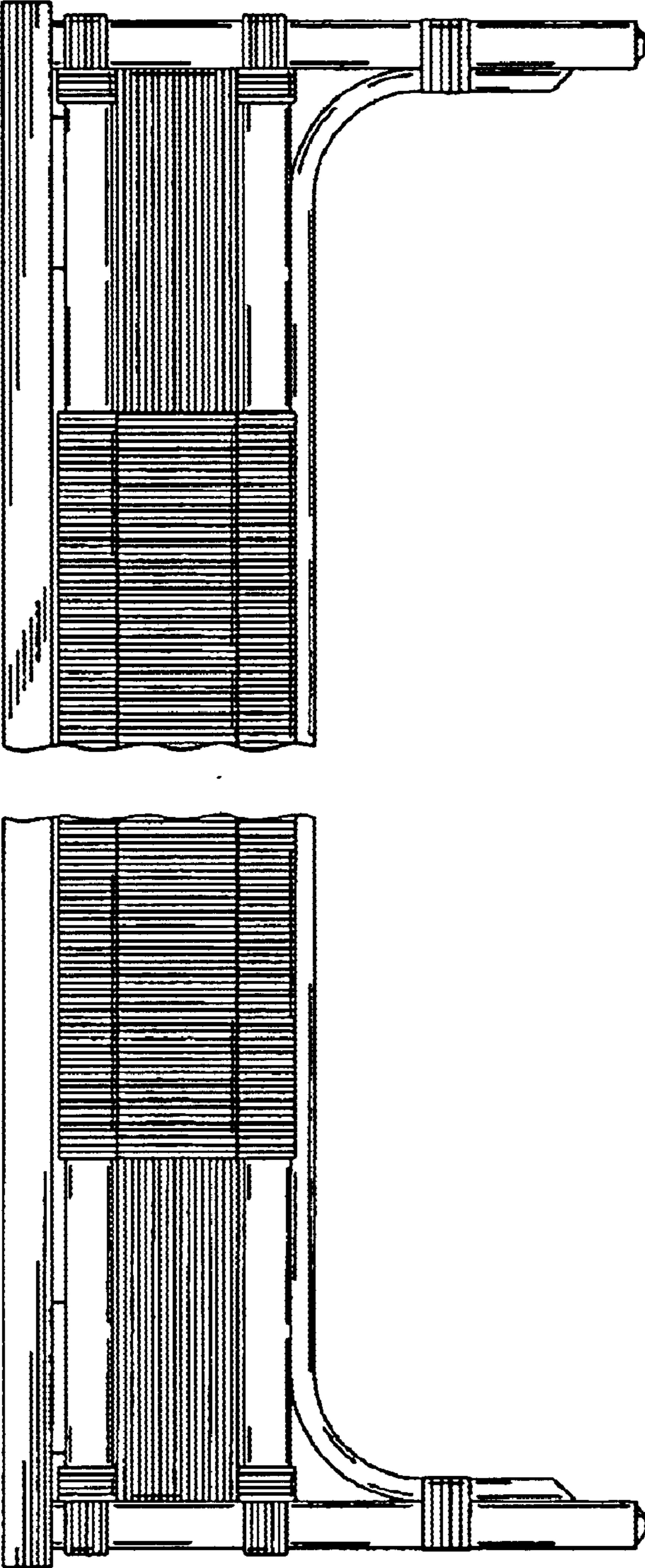

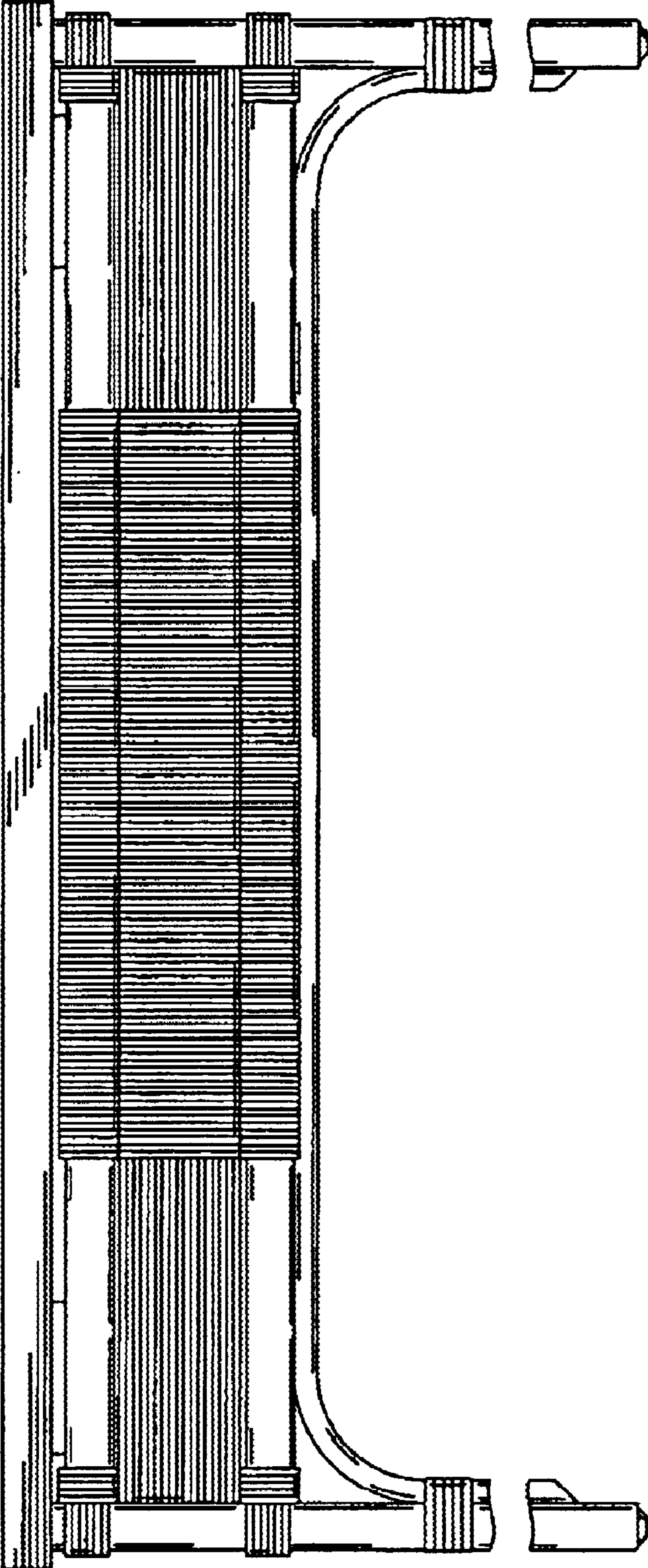

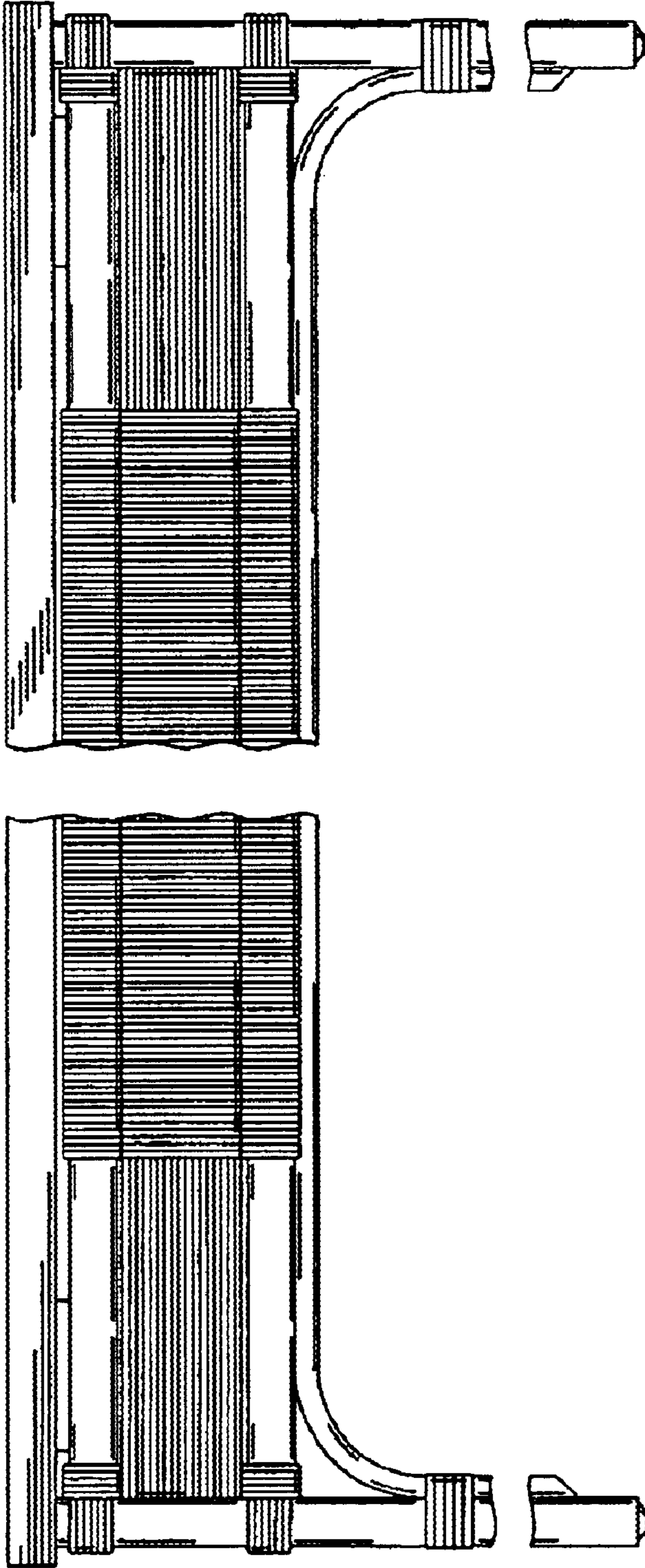

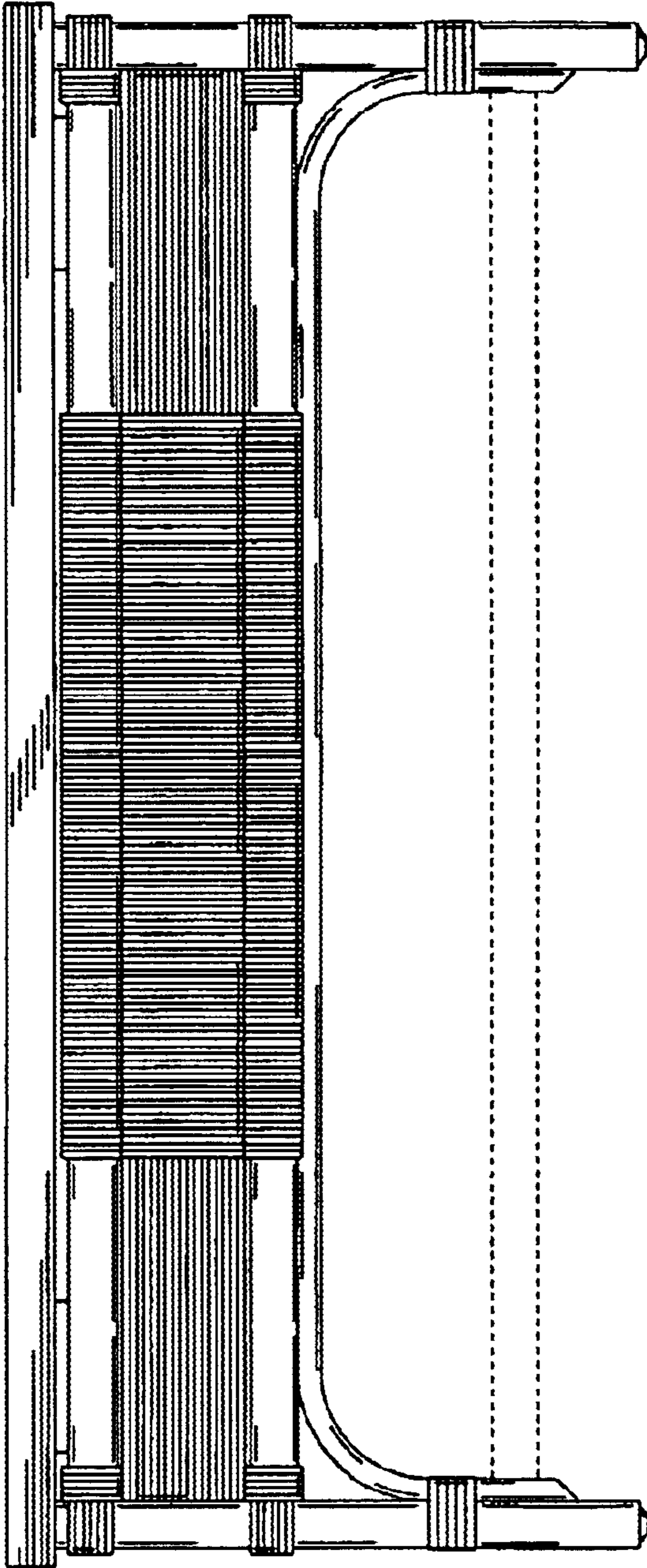

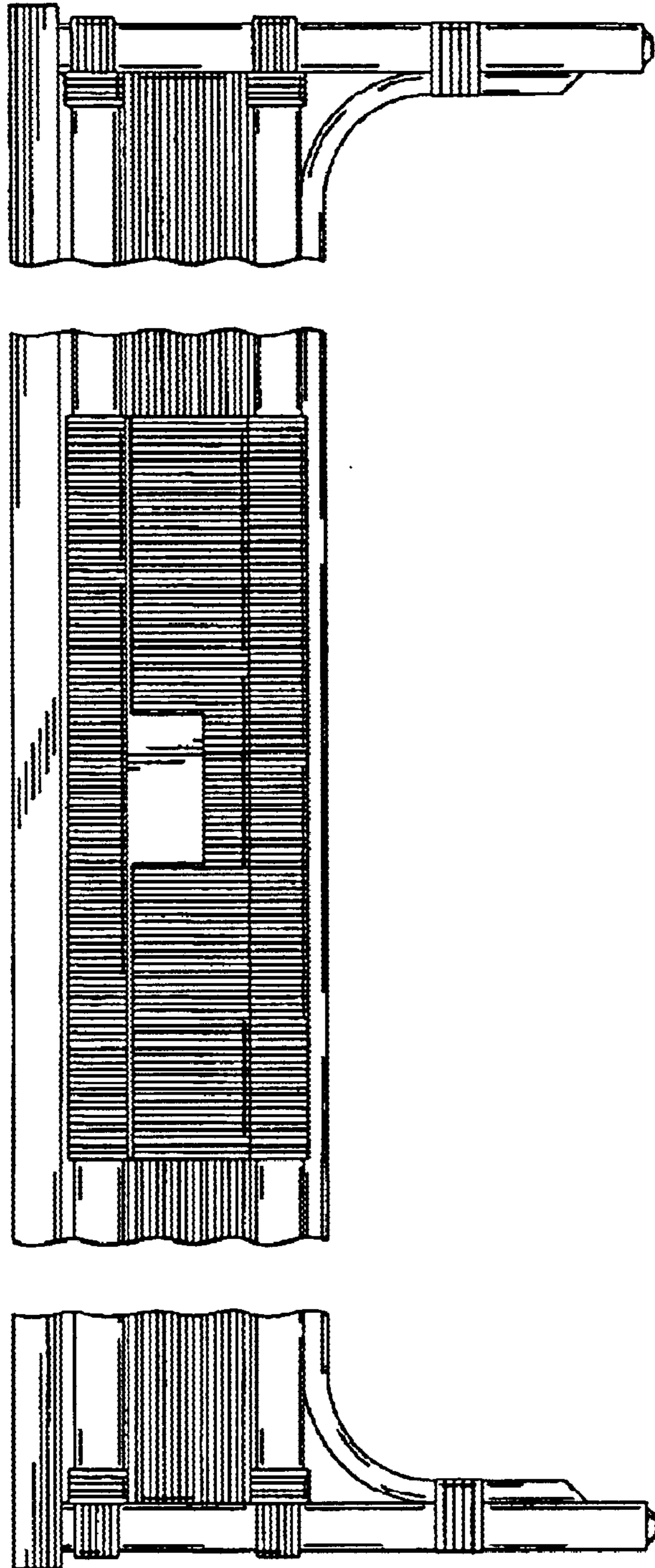

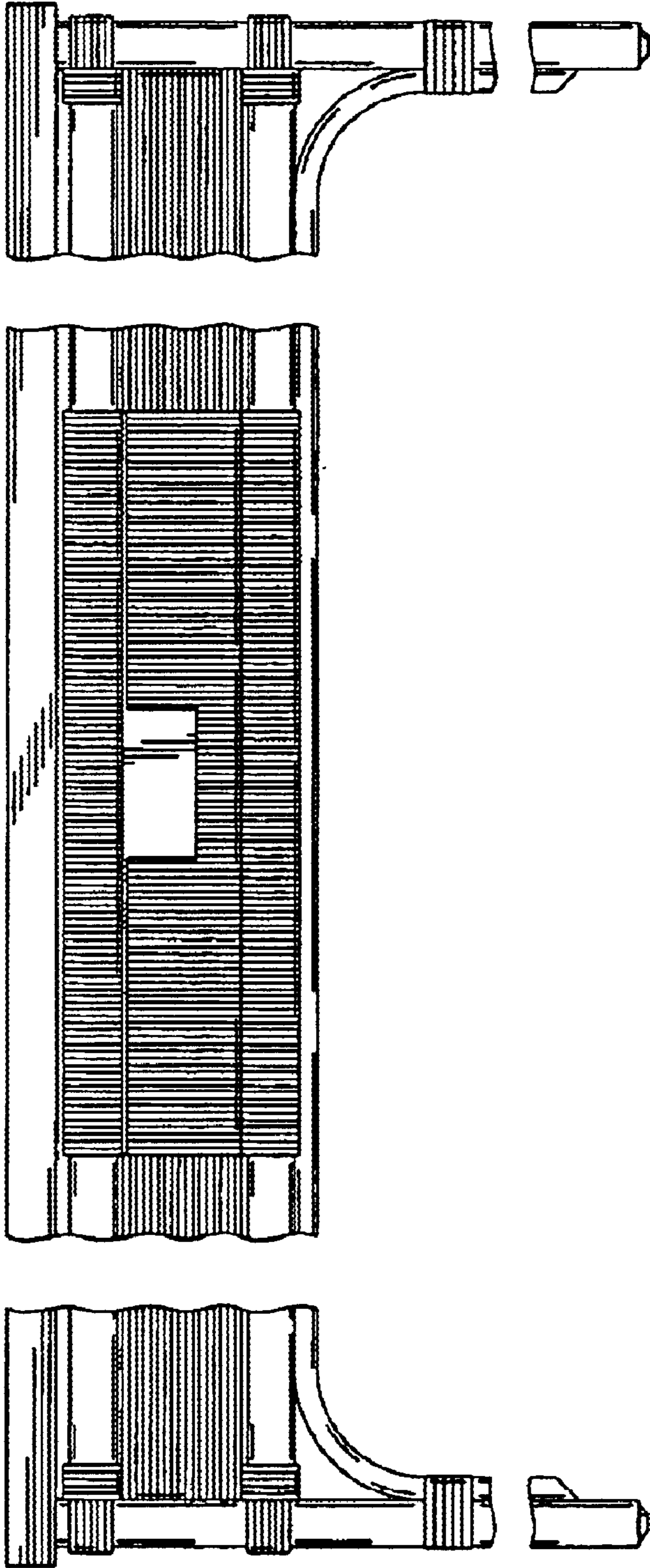

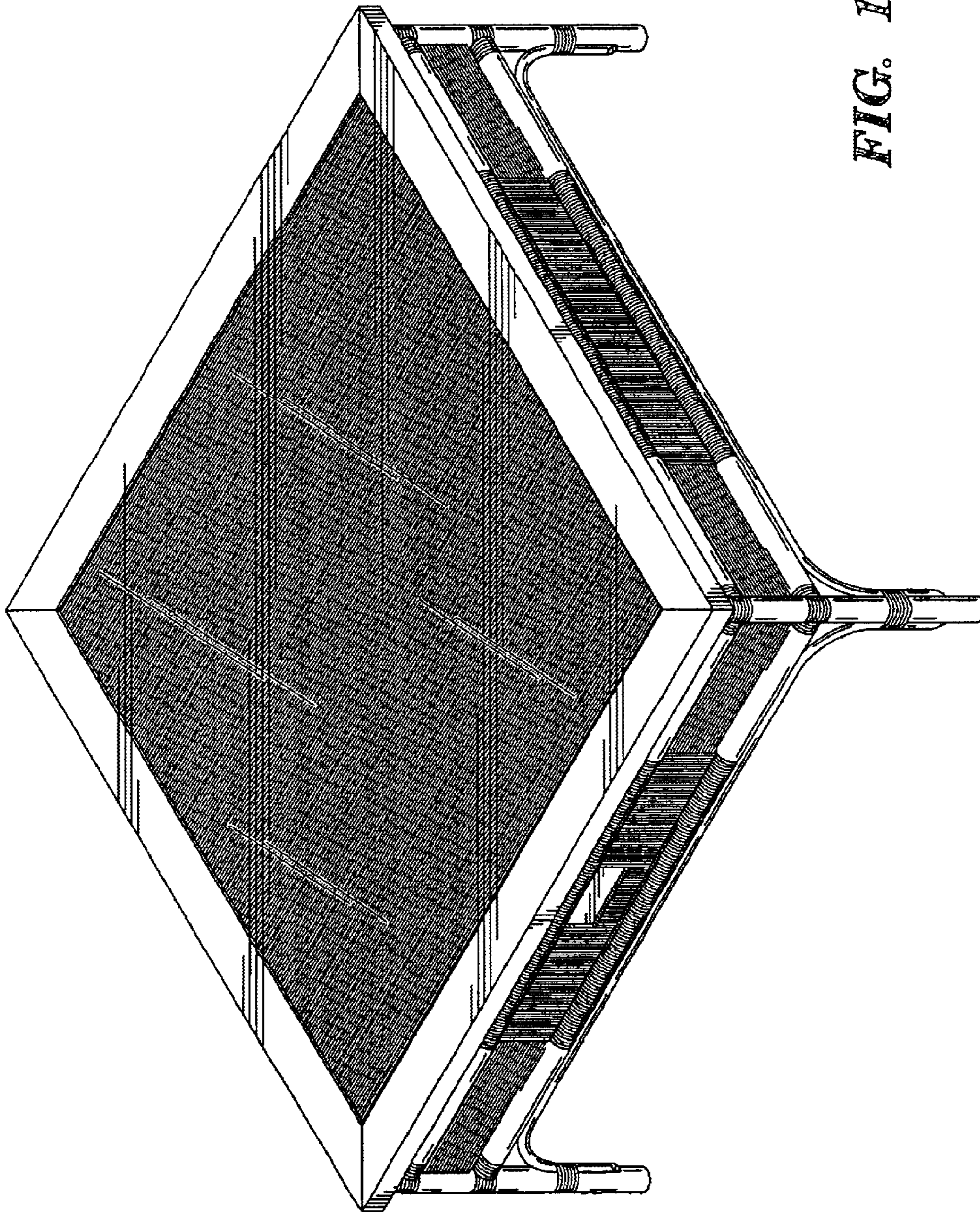
