(57) **CLAIM**

The ornamental design for a cooking plank with football image, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the ornamental design for a first embodiment cooking plank with football image according to the invention;

FIG. 2 is a bottom plan view of the plank of FIG. 1;

FIG. 3 is a front side view of the plank of FIG. 1; the rear side view being a mirror image thereof;

FIG. 4 is a left side view of the plank of FIG. 1; the right side view being a mirror image thereof;

FIG. 5 is a top plan view of the ornamental design for a second embodiment cooking plank with football image according to the invention;

FIG. 6 is a bottom plan view of the plank of FIG. 5;

FIG. 7 is a front side view of the plank of FIG. 5, the rear side view being a mirror image thereof;

FIG. 8 is a left side view of the plank of FIG. 5, the right side view being a mirror image thereof;

FIG. 9 is a top plan view of the ornamental design for a third embodiment f cooking plank with football image according to the invention;

FIG. 10 is a bottom plan view of the plank of FIG. 9;

FIG. 11 is a front side view of the plank of FIG. 9, the rear side view being a mirror image thereof;

FIG. 12 is a left side view of the plank of FIG. 9, the right side view being a mirror image thereof;

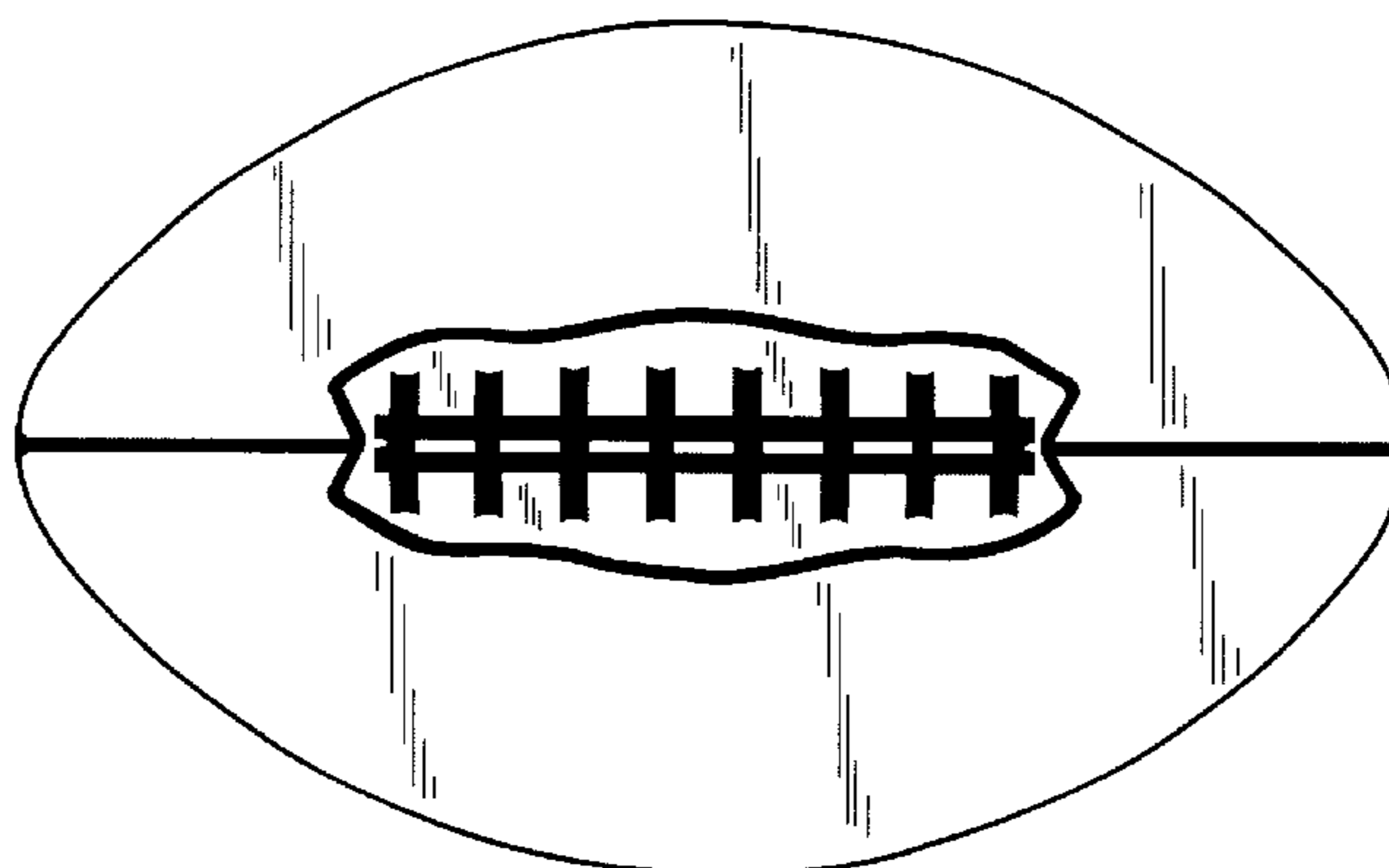
FIG. 13 is a top plan view of the ornamental design for a fourth embodiment cooking plank with football image according to the invention;

FIG. 14 is a bottom plan view of the plank of FIG. 13;

FIG. 16 is a left side view of the plank of FIG. 13, the right side view being a mirror image thereof.

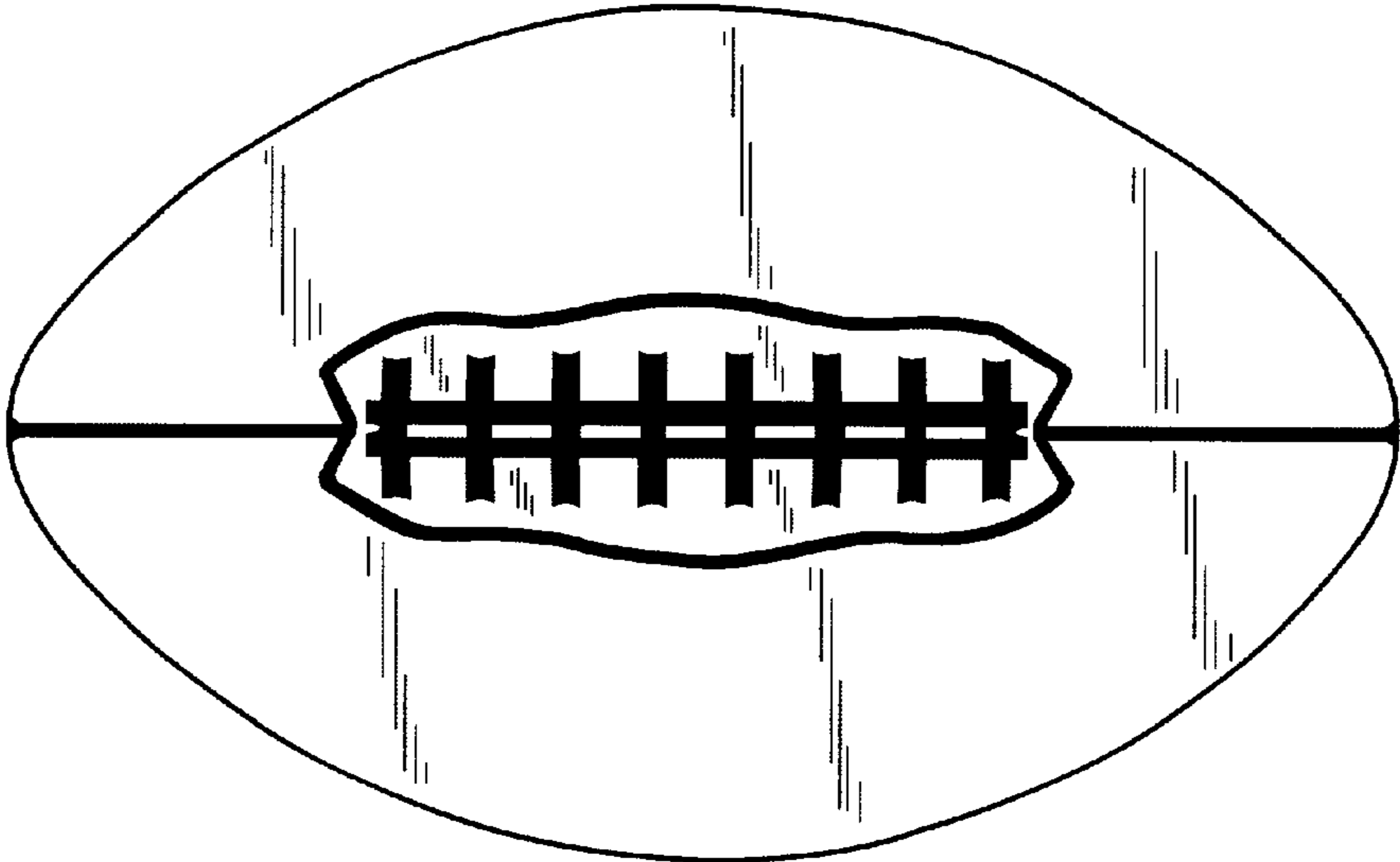

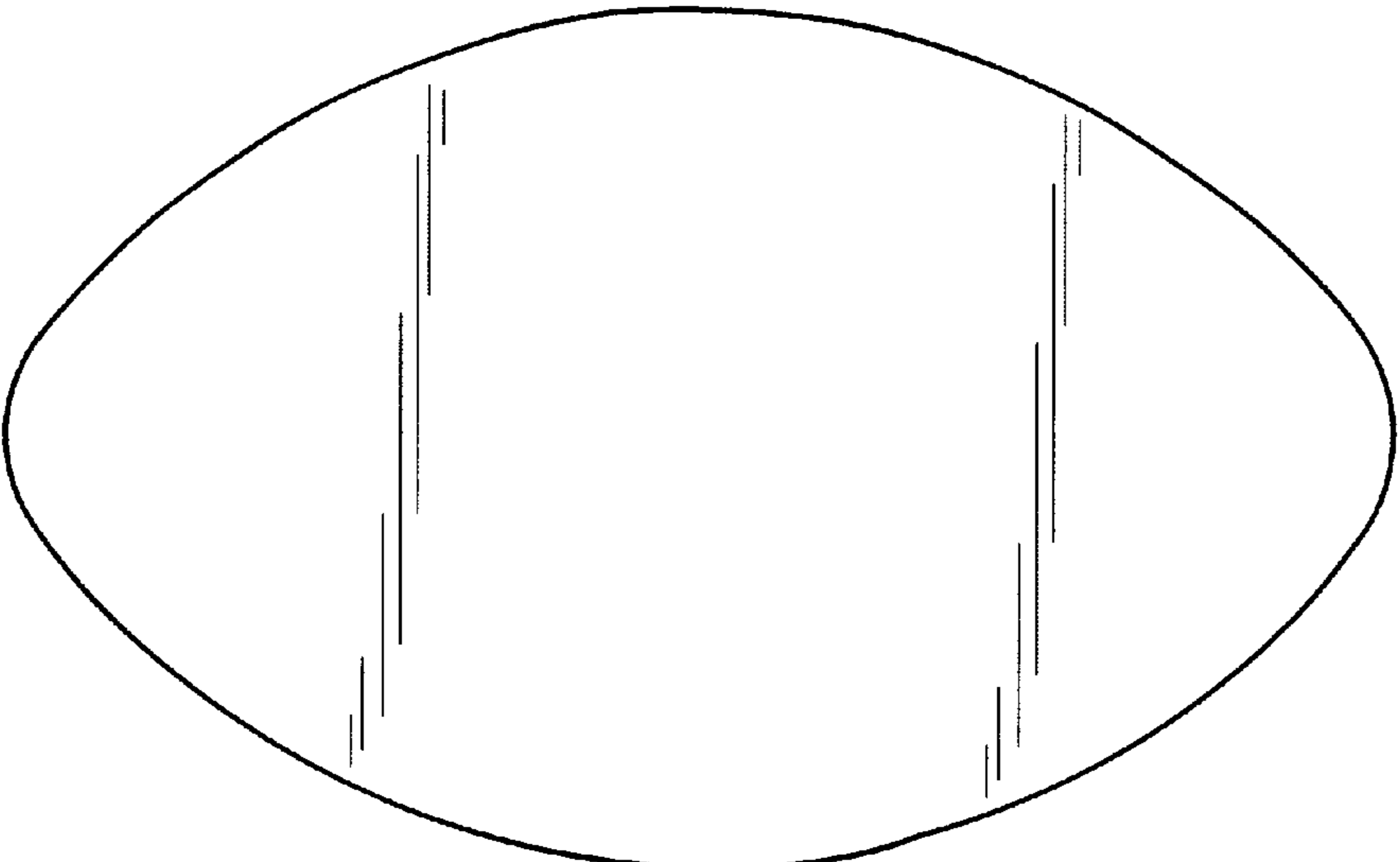

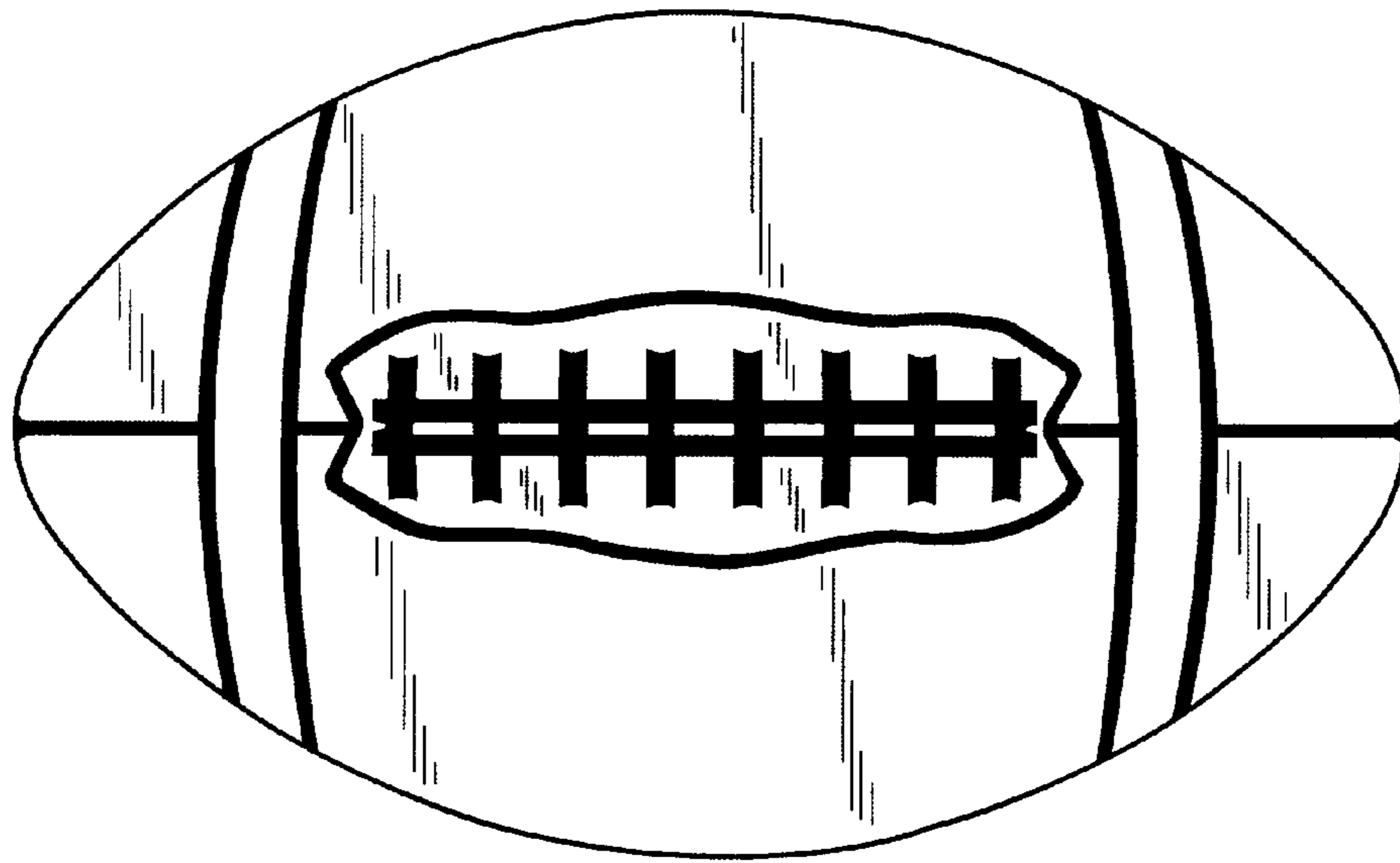

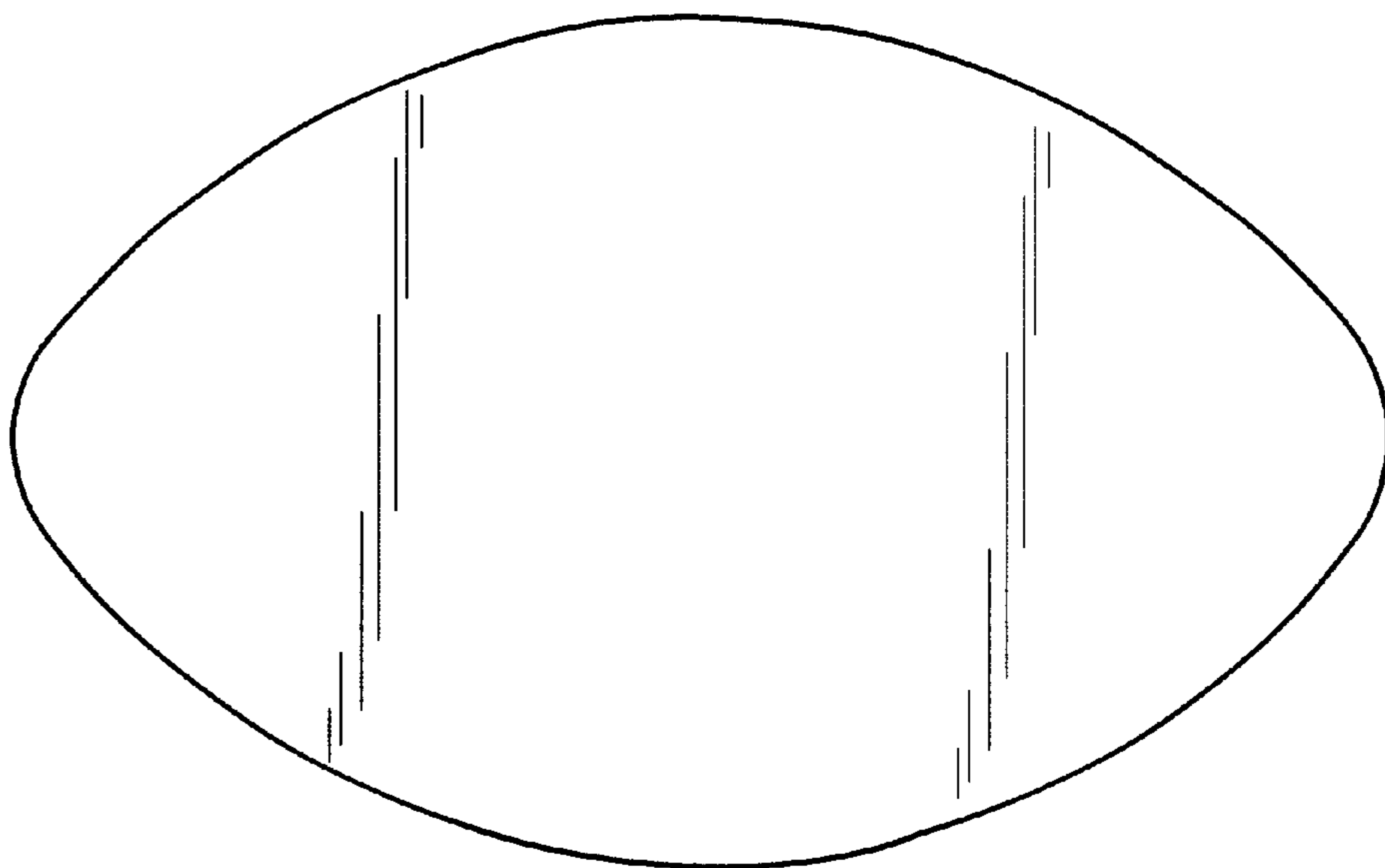

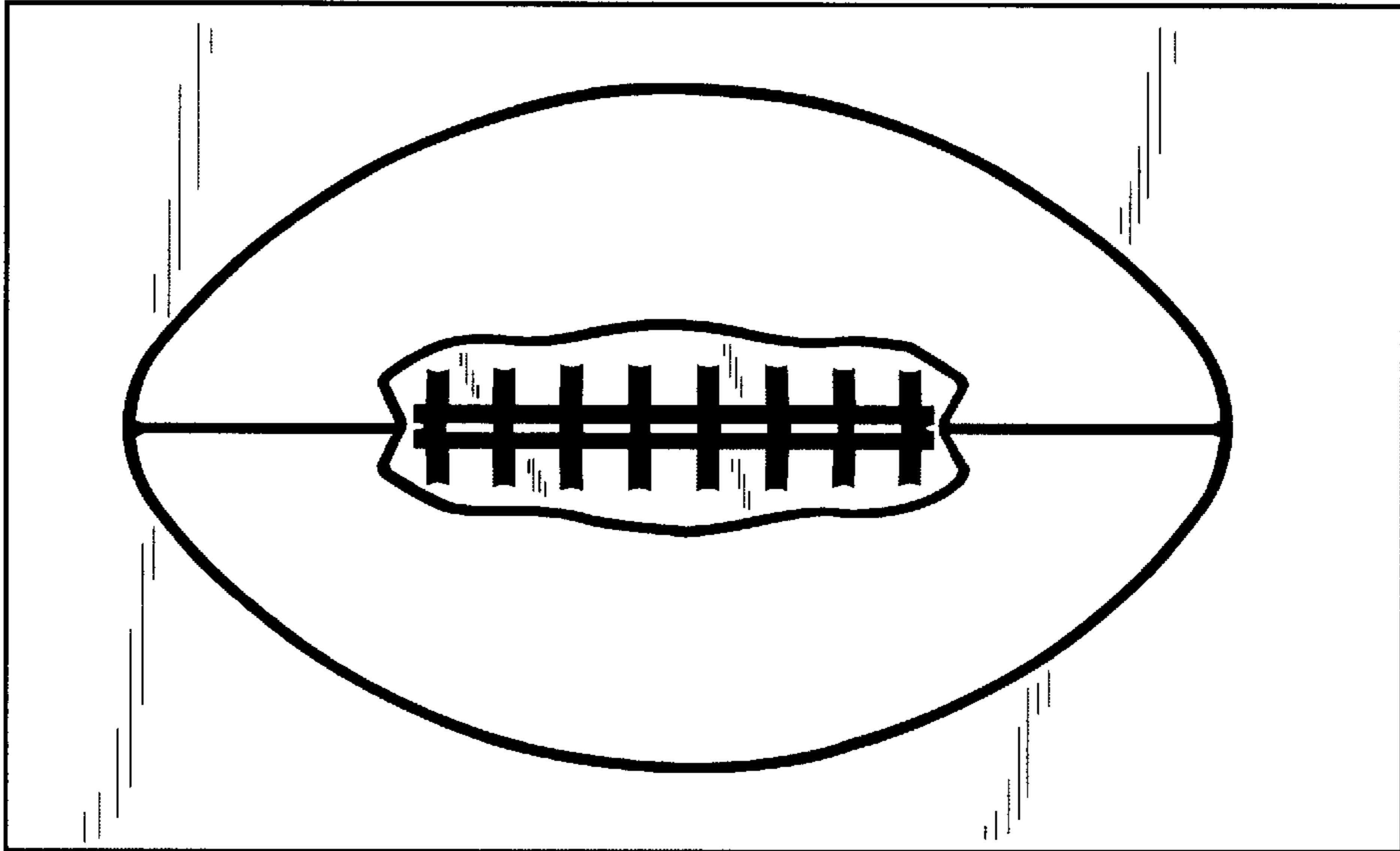

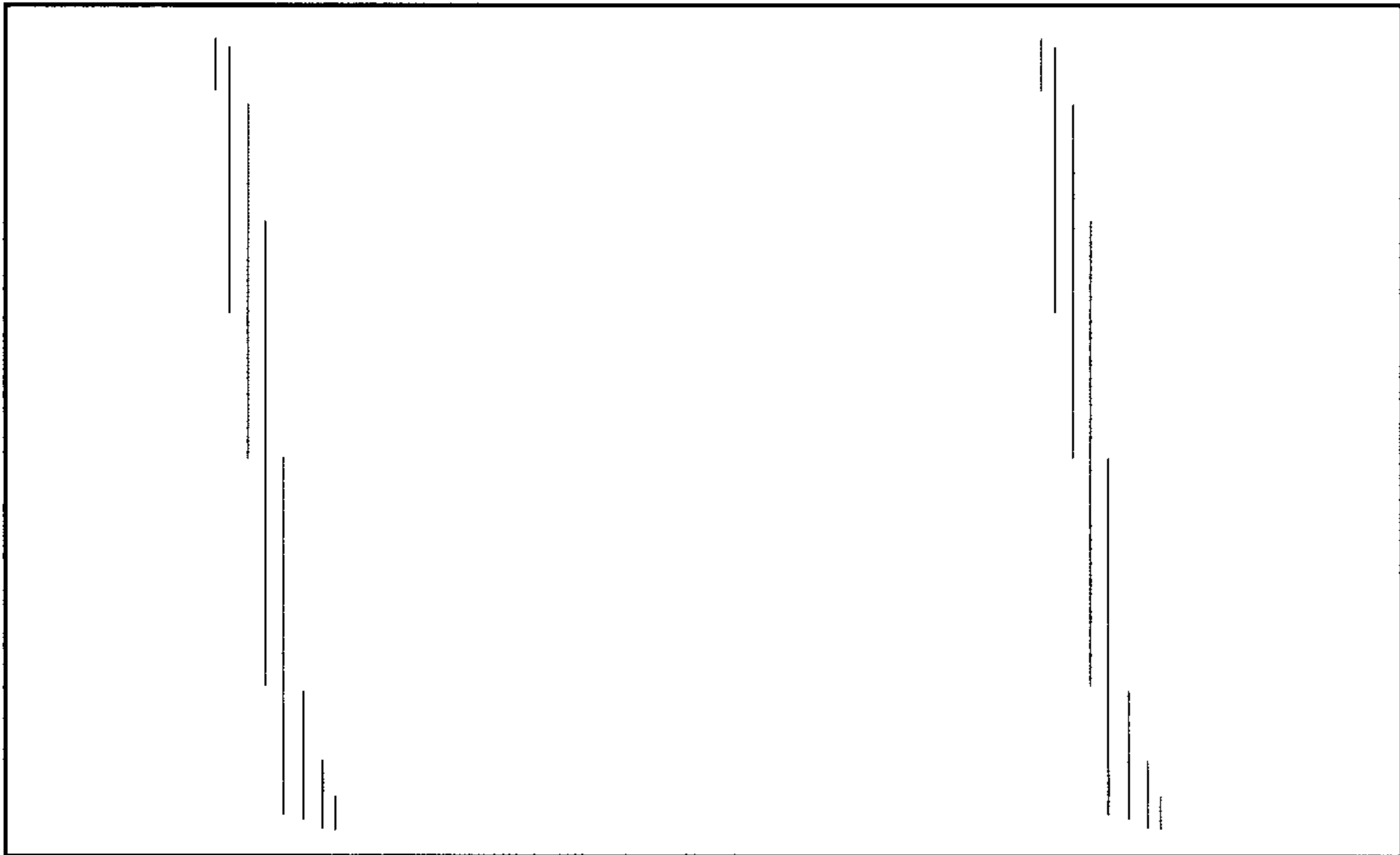

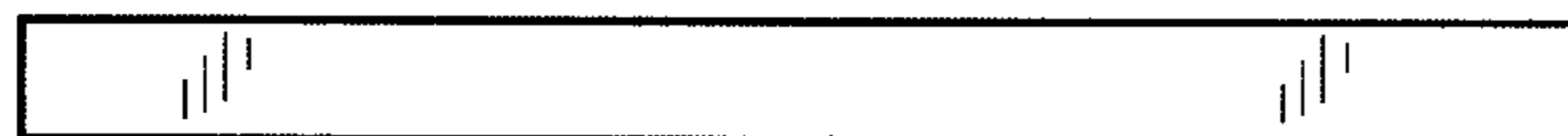

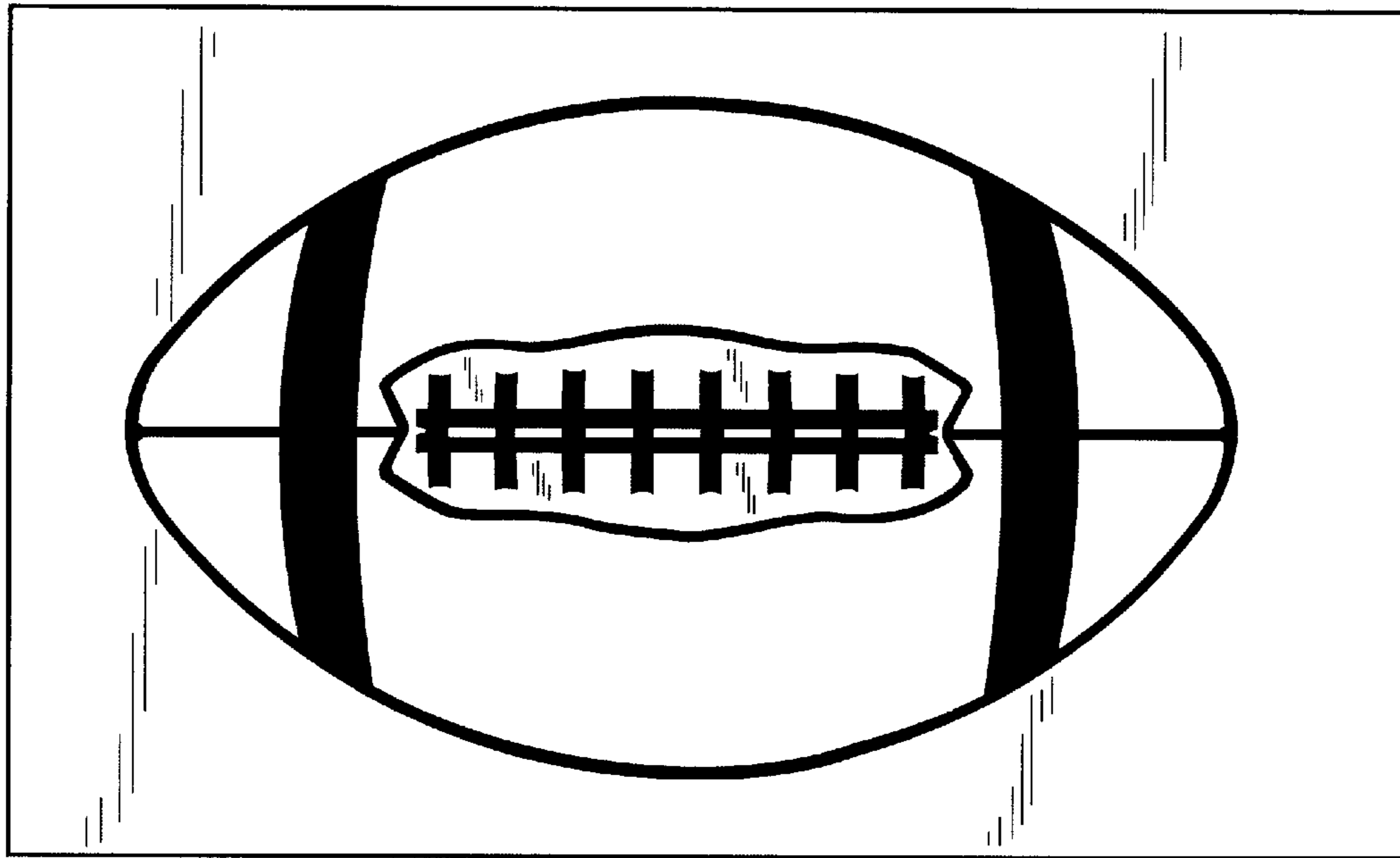

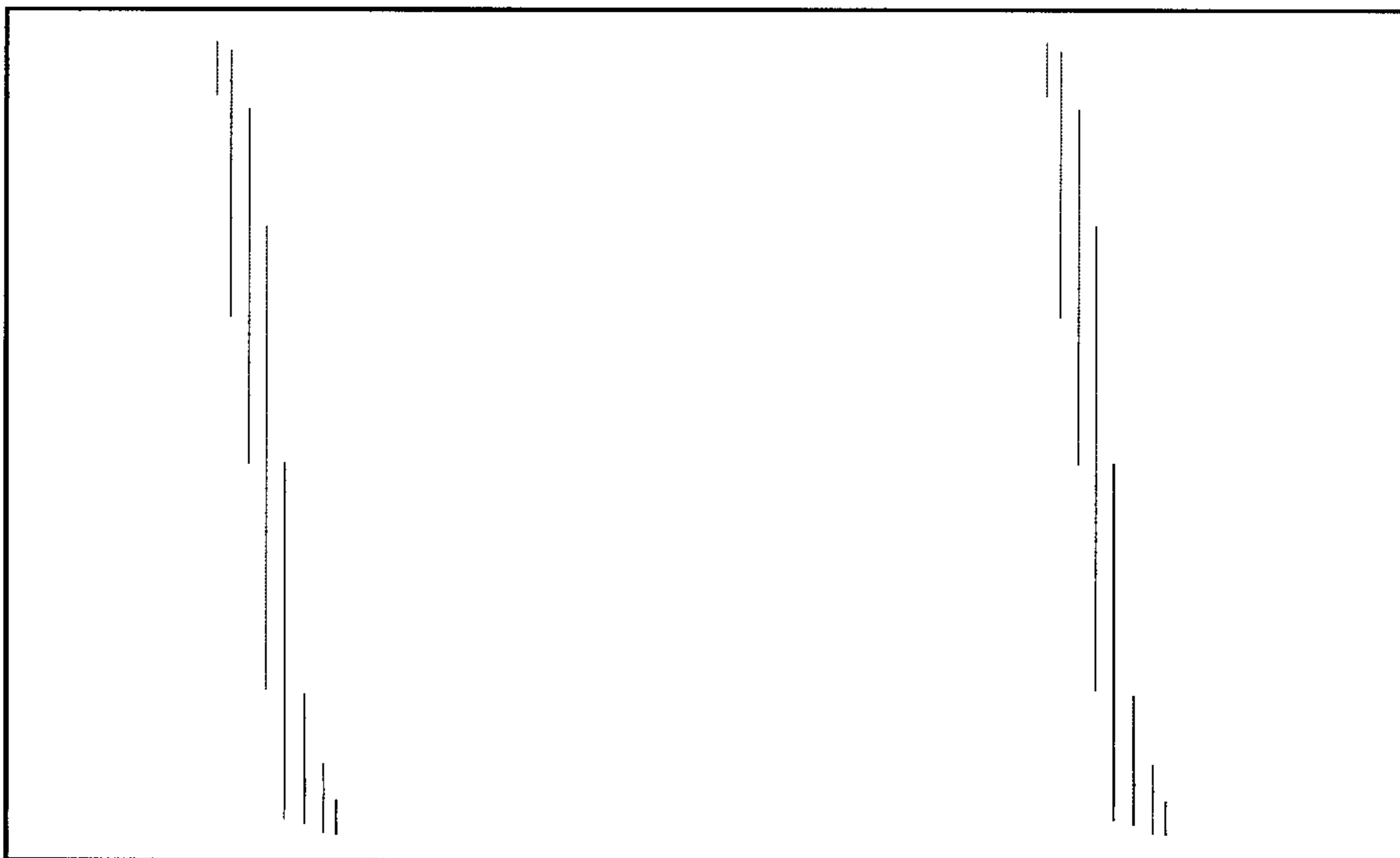
