(57) **CLAIM**

The ornamental design for a container with cover, as shown and described.

DESCRIPTION

FIG. 1 is a top, side and front perspective view of a first embodiment of a container with cover showing the new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a left side elevation view thereof, the right side elevation view being a mirror image thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof.

FIG. 7 is a top, side and front perspective view of a second embodiment of a container with cover showing the new design;

FIG. 8 is a front elevation view thereof;

FIG. 9 is a rear elevation view thereof;

FIG. 12 is a bottom plan view thereof;

FIG. 20 is a front elevation view thereof;

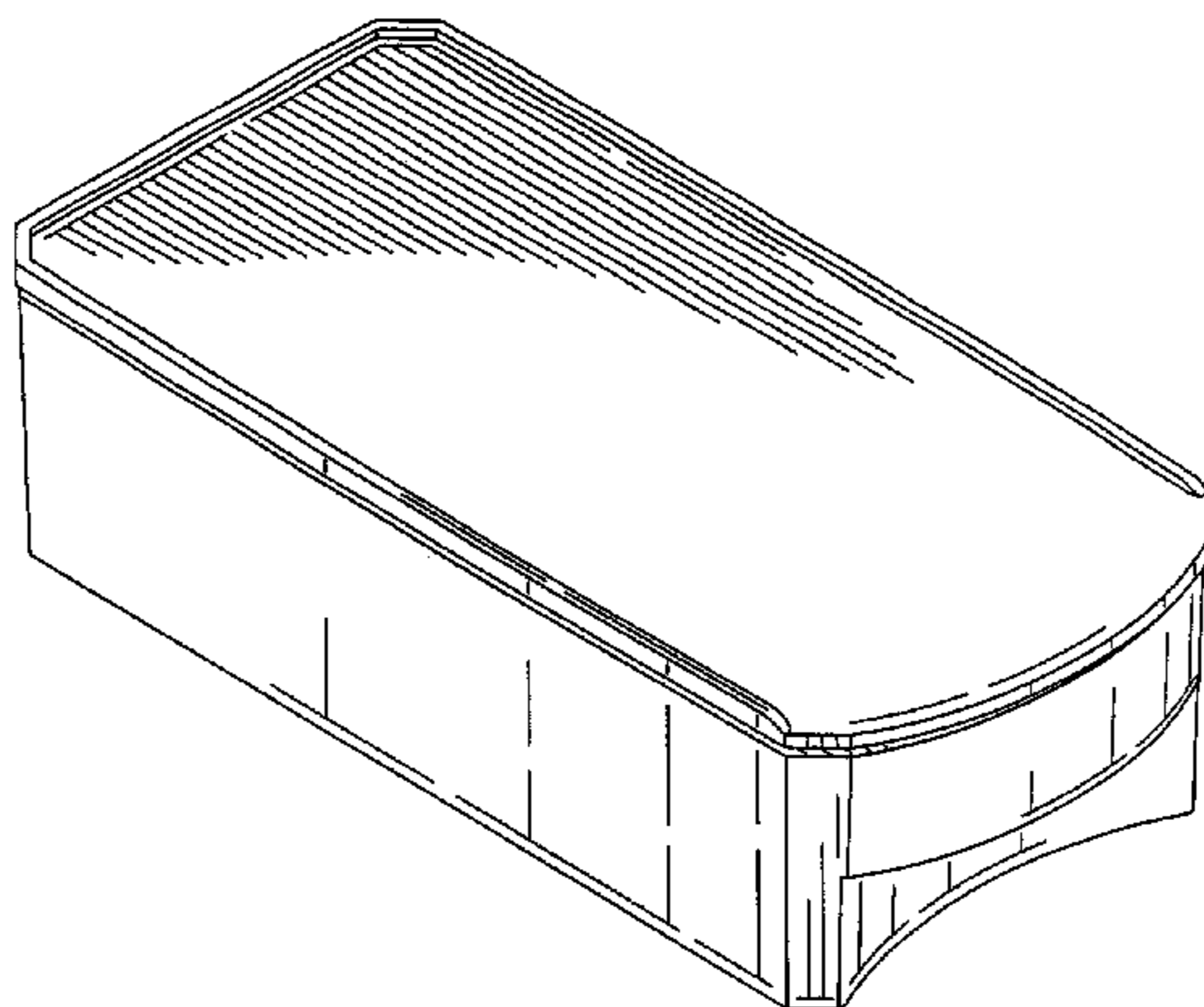
FIG. 21 is a rear elevation view thereof;

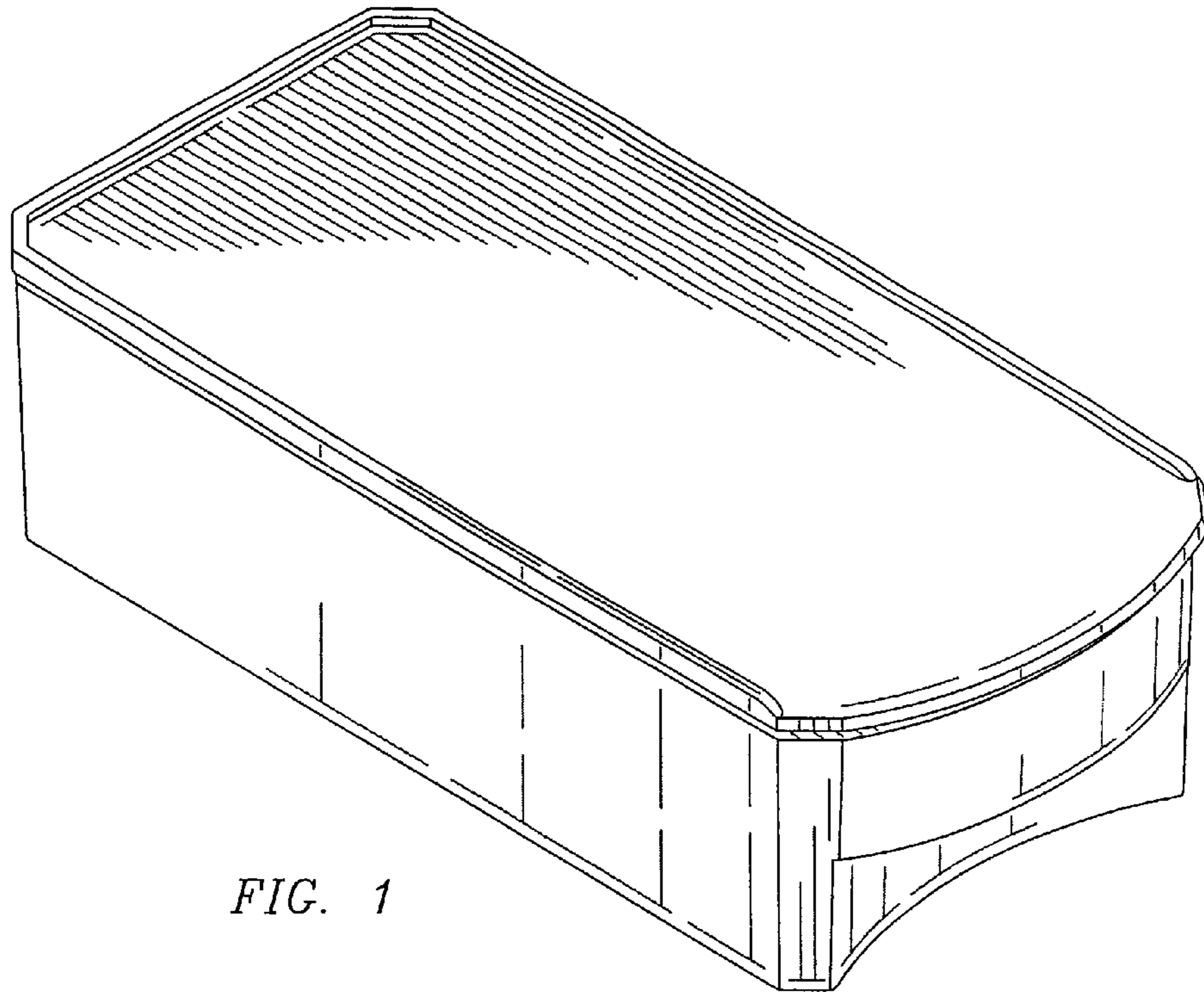

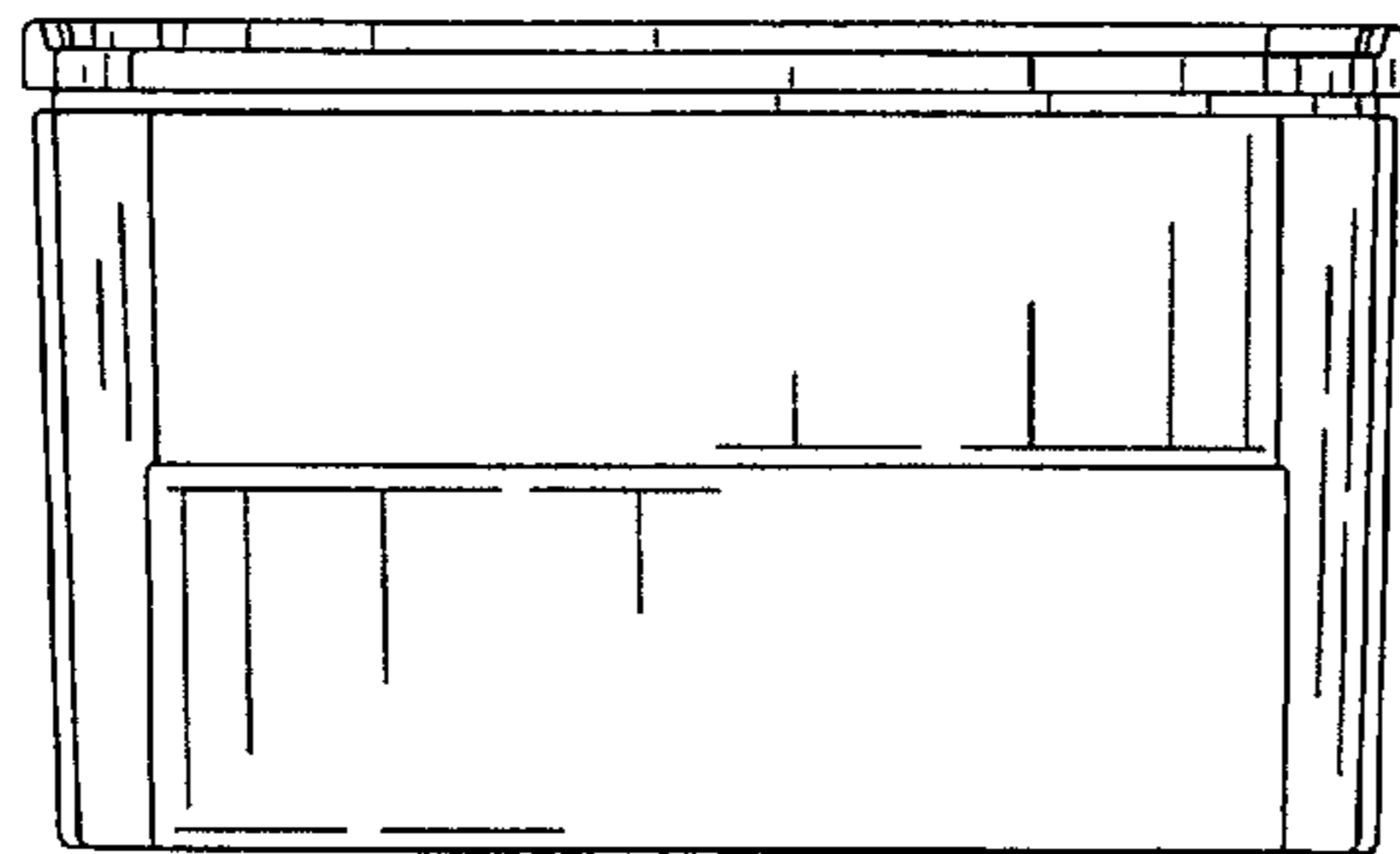

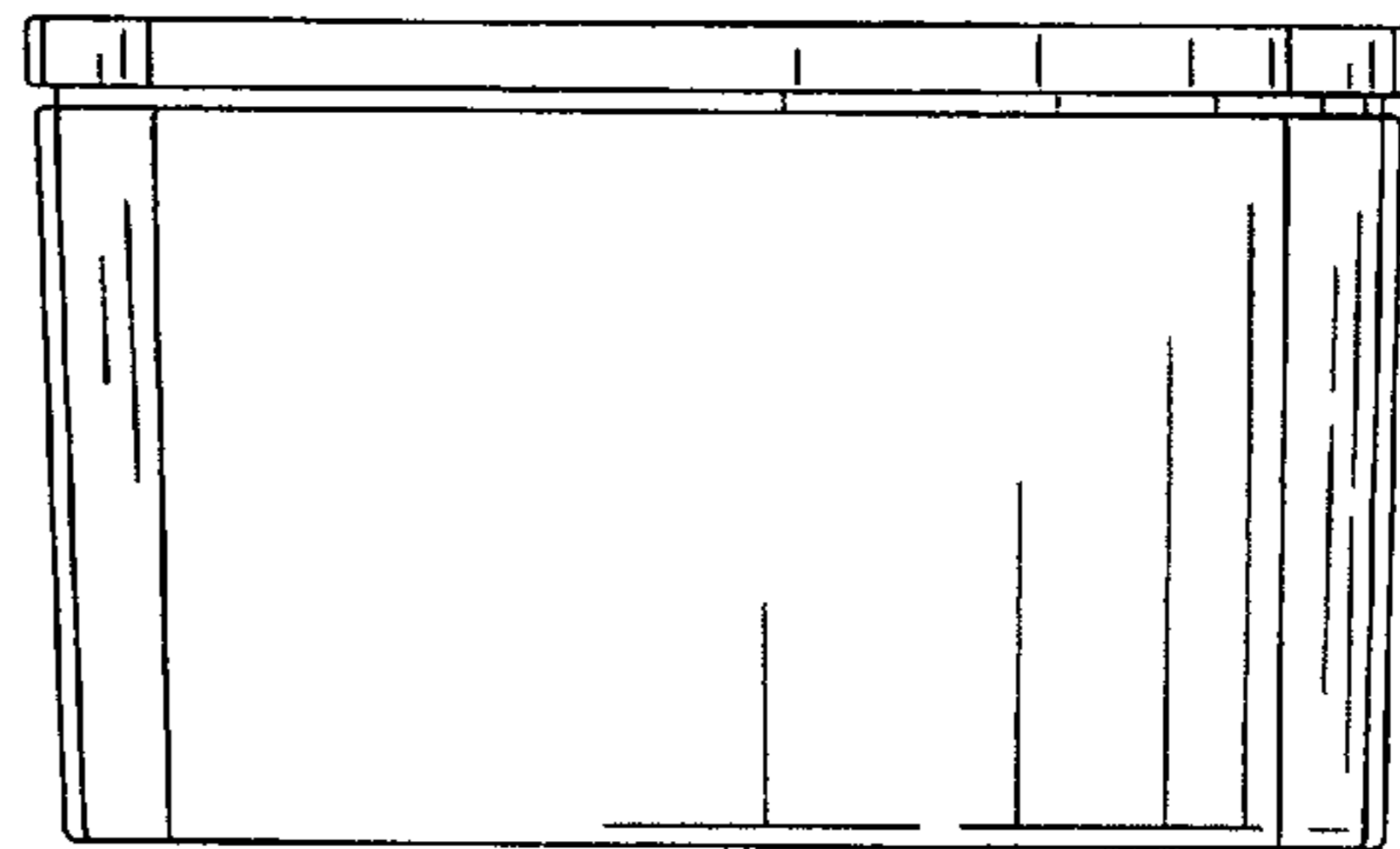

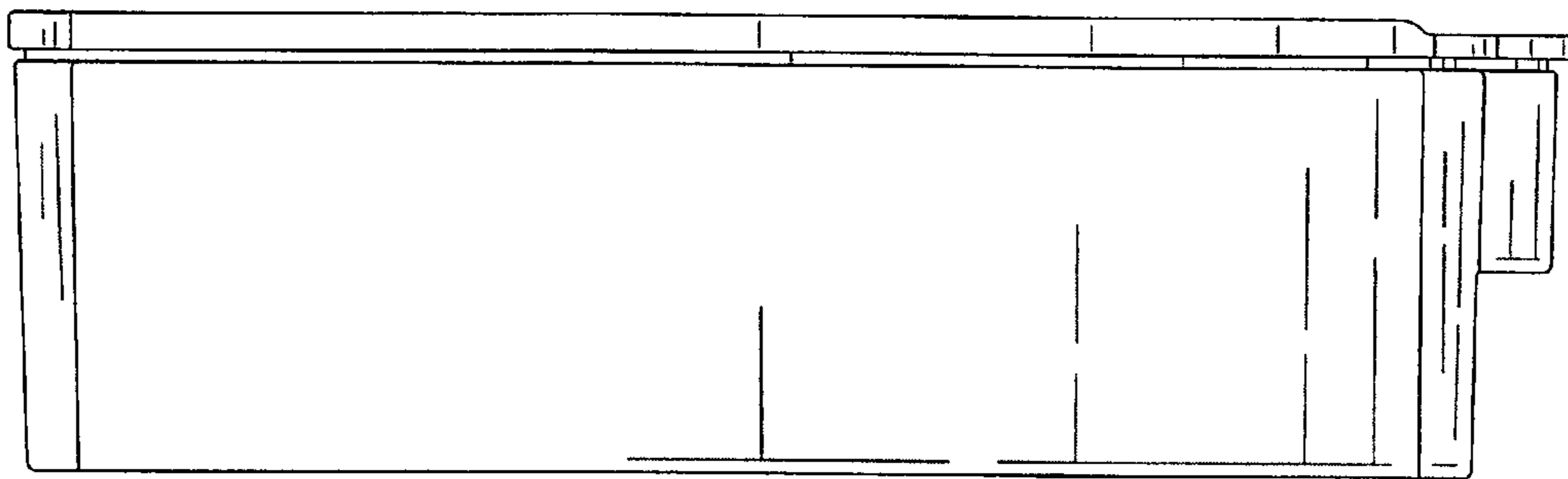

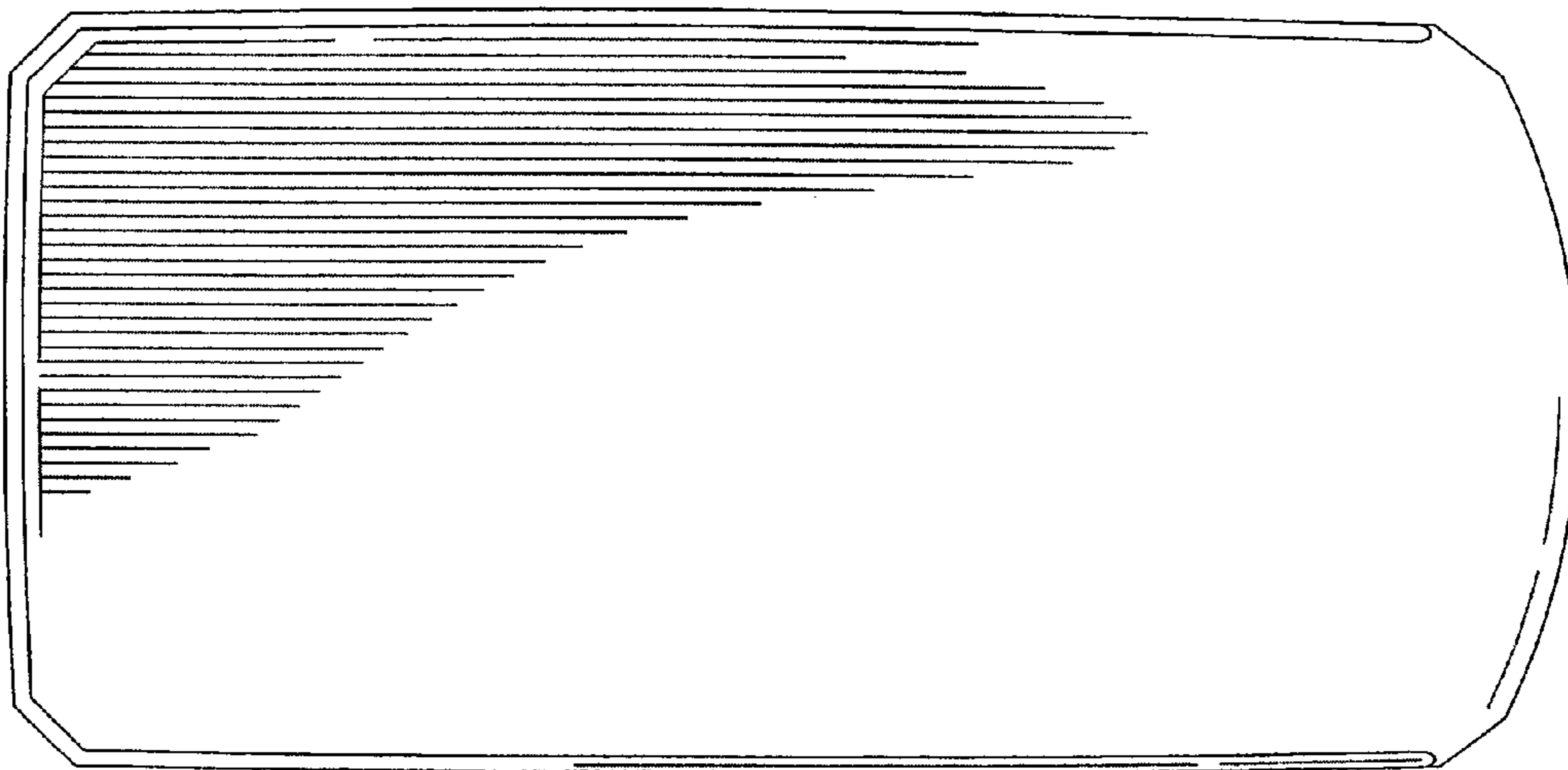

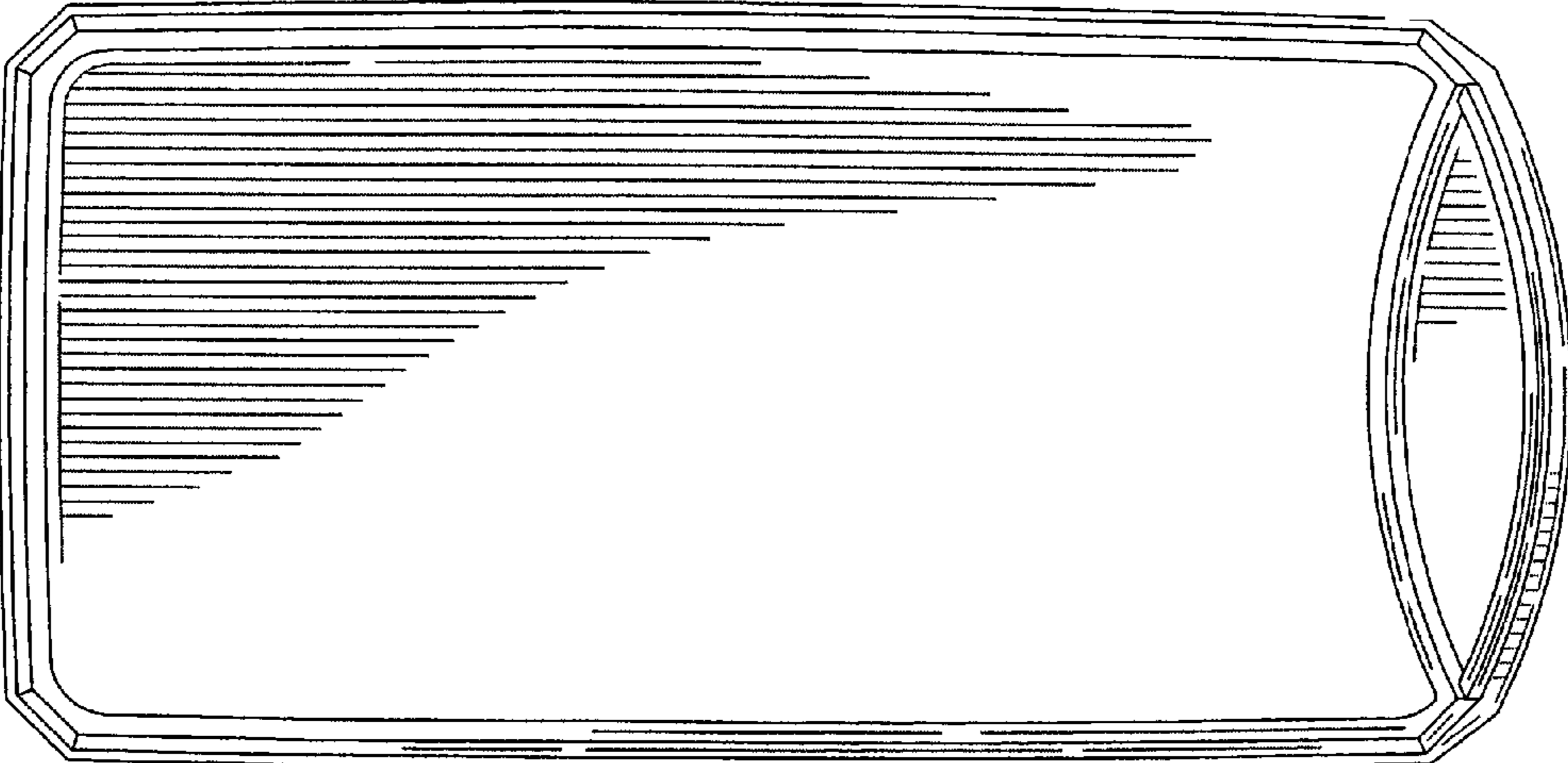

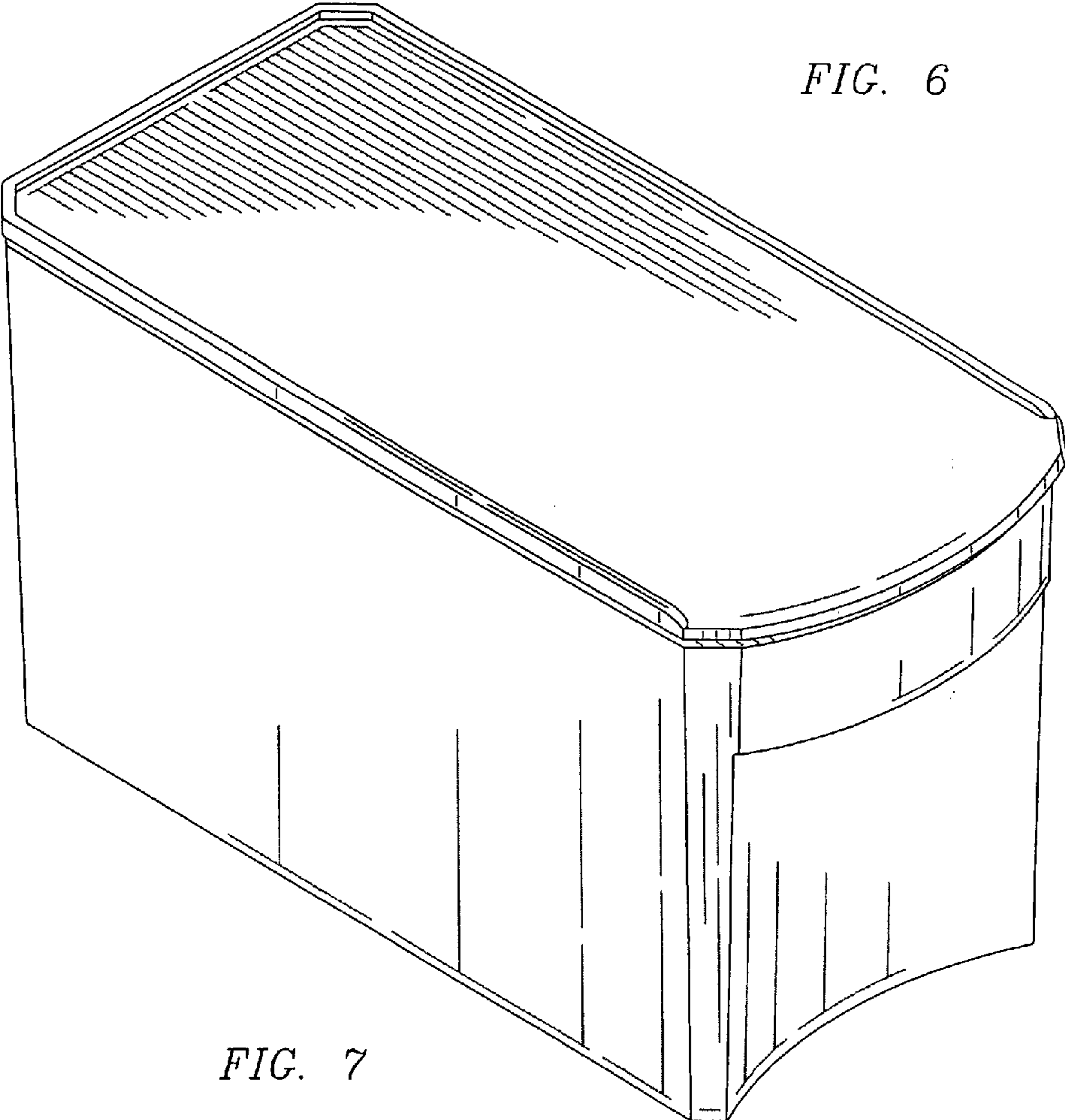

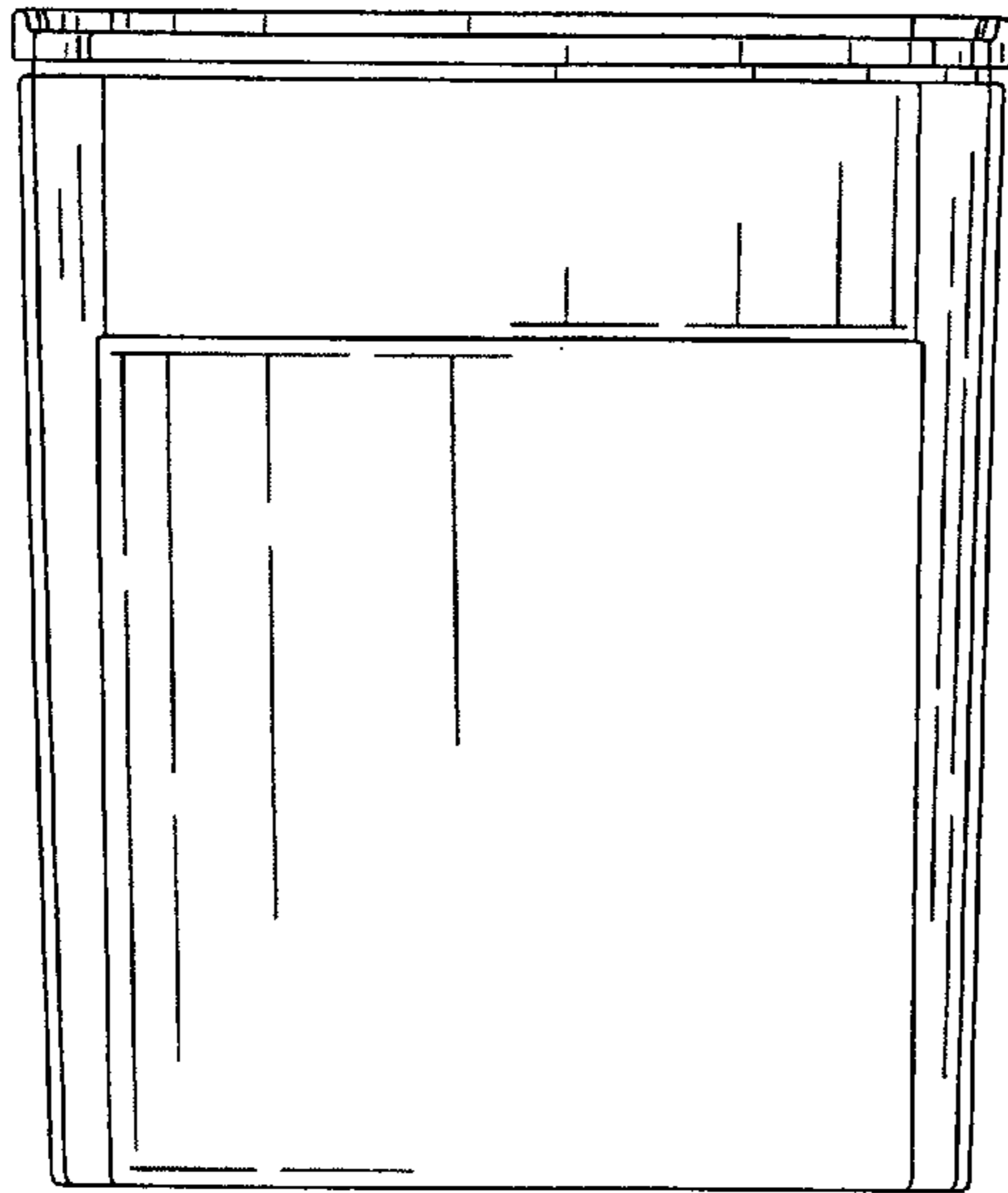

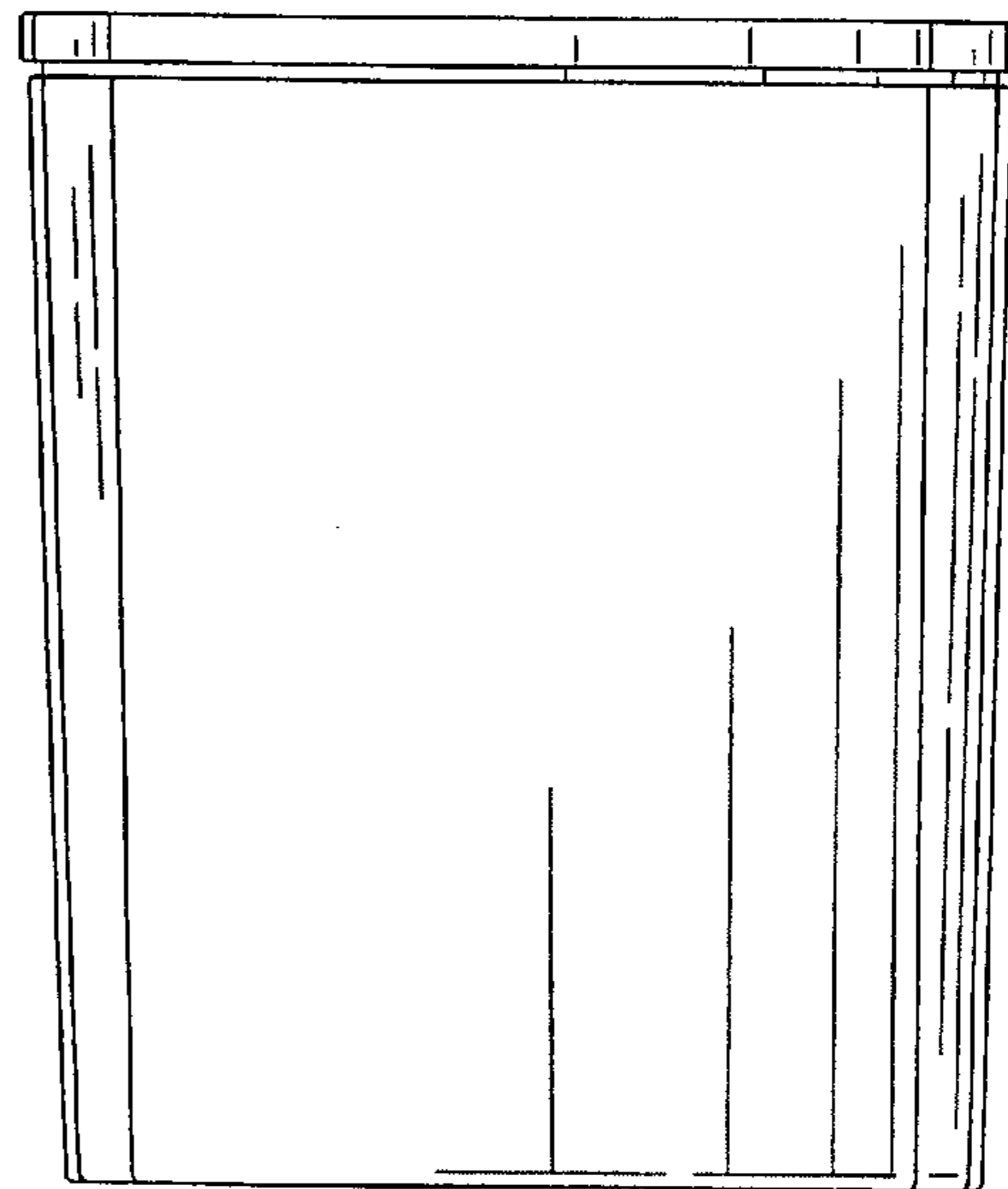

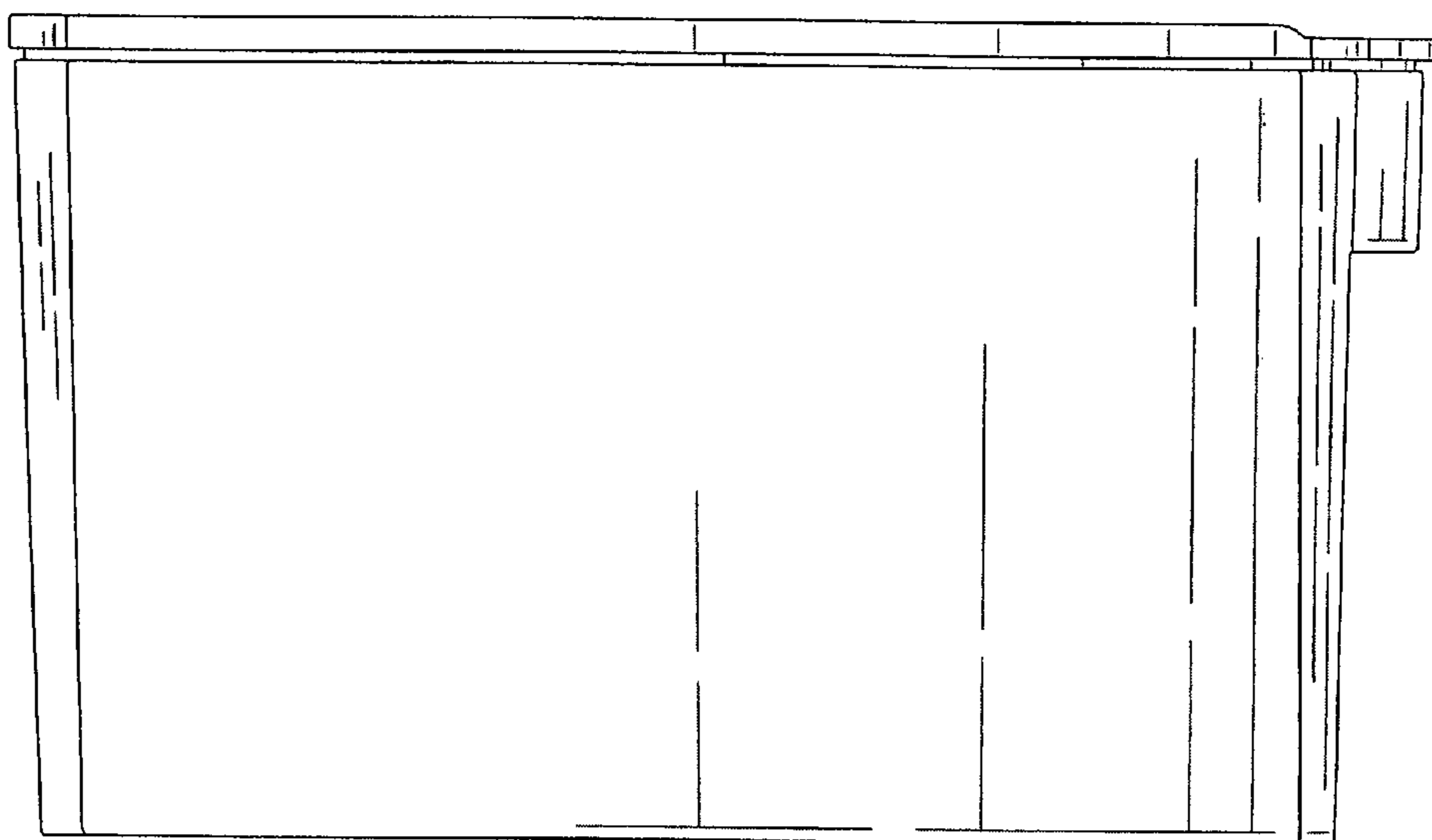

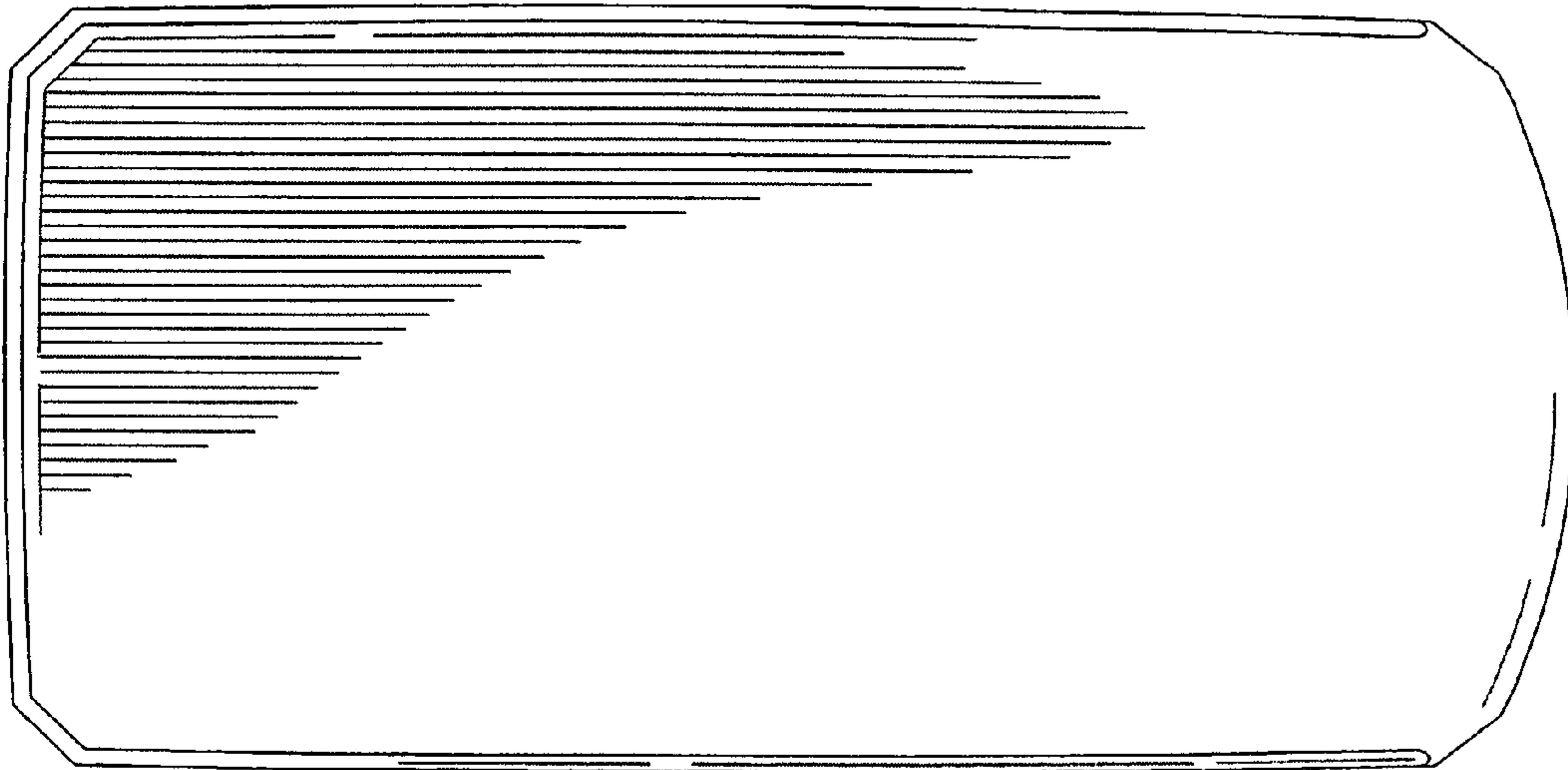

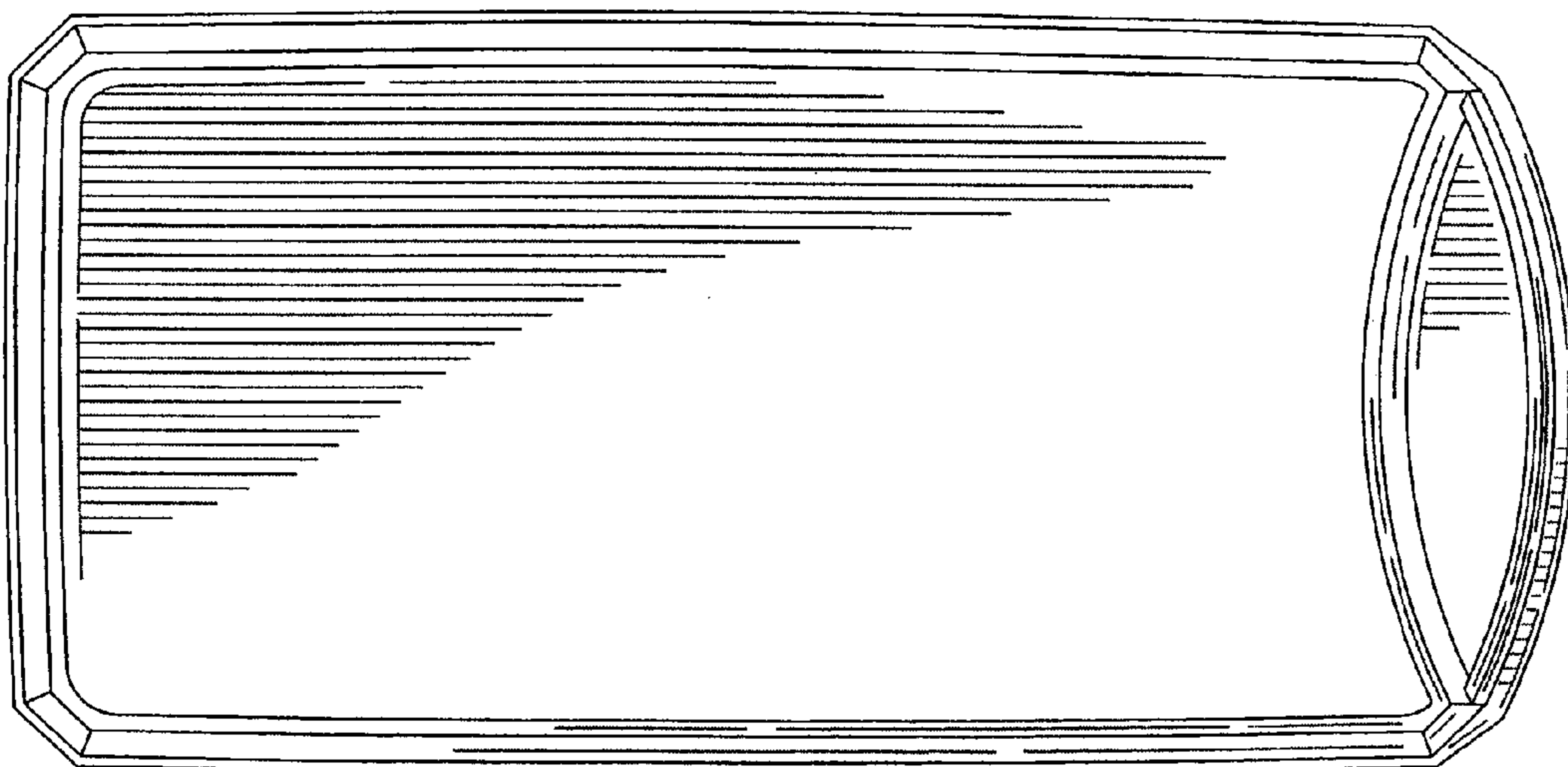

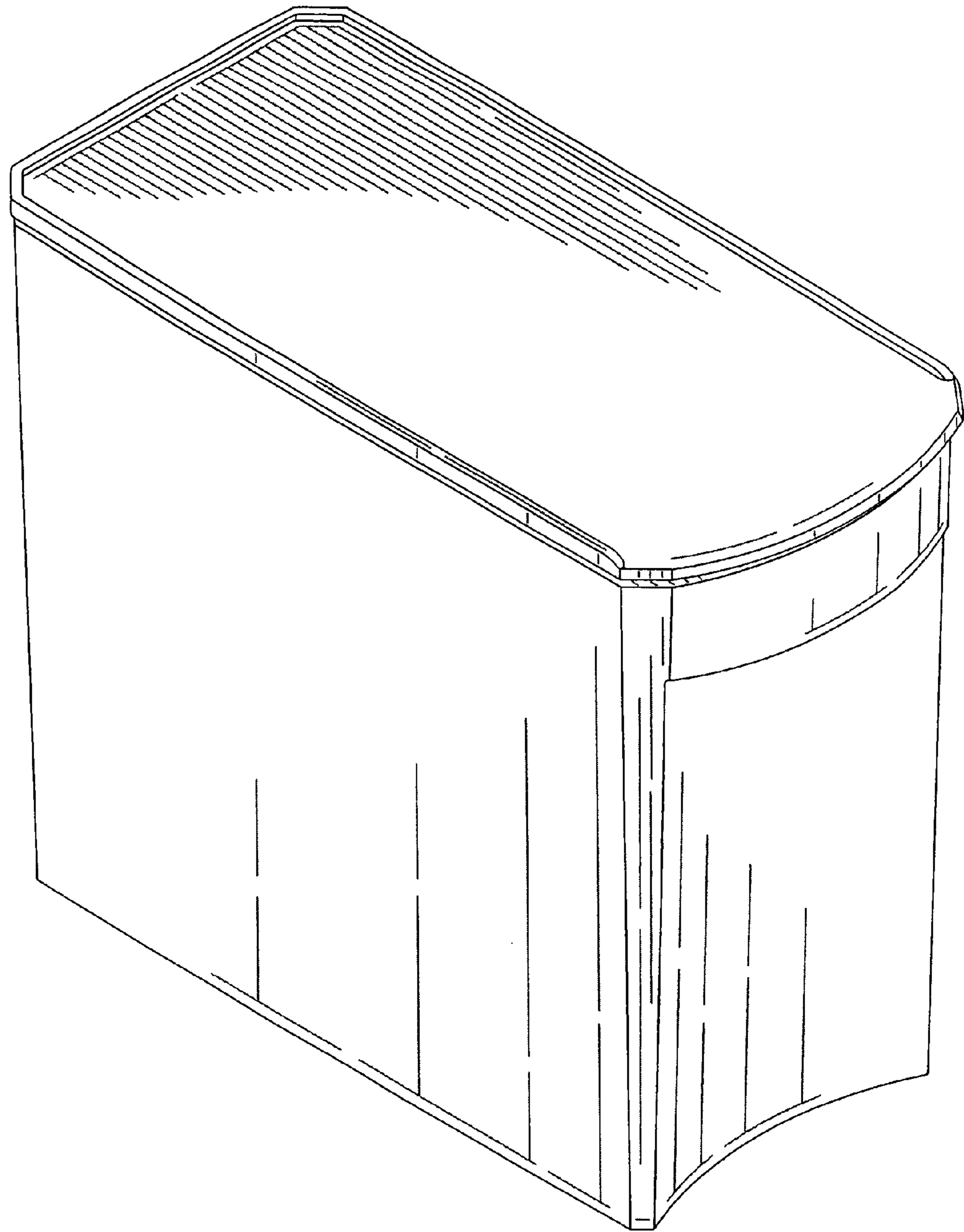

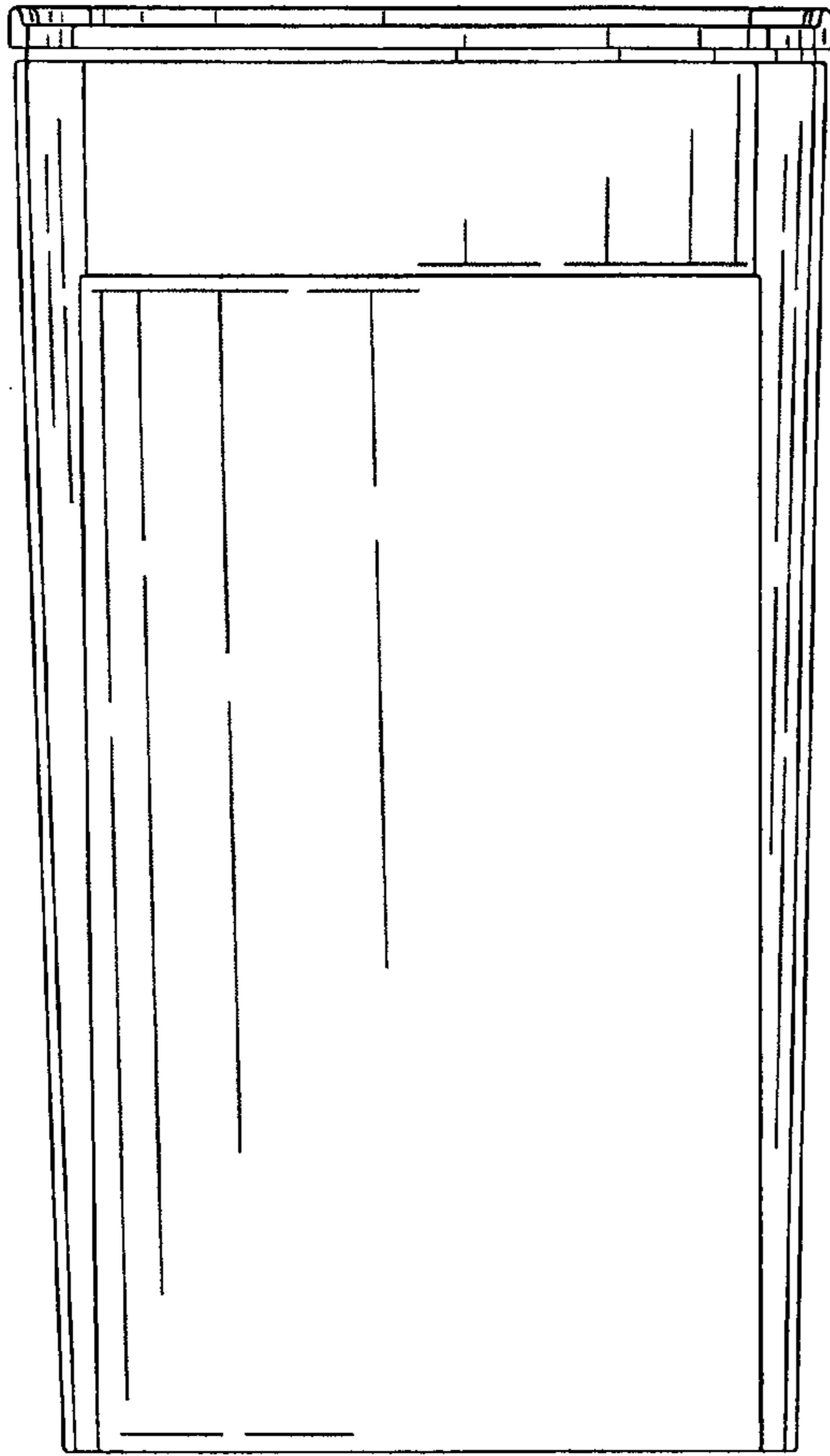

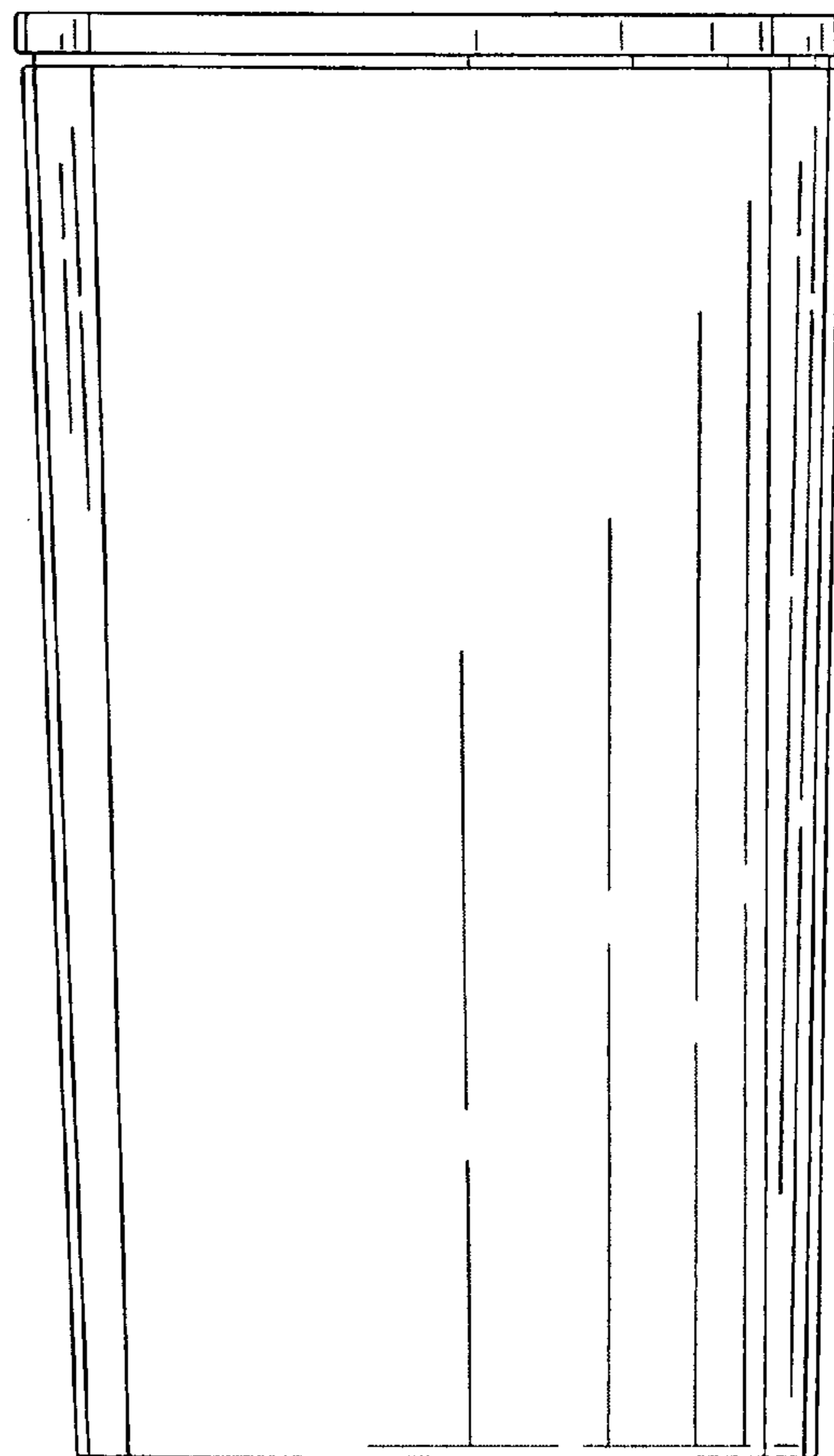

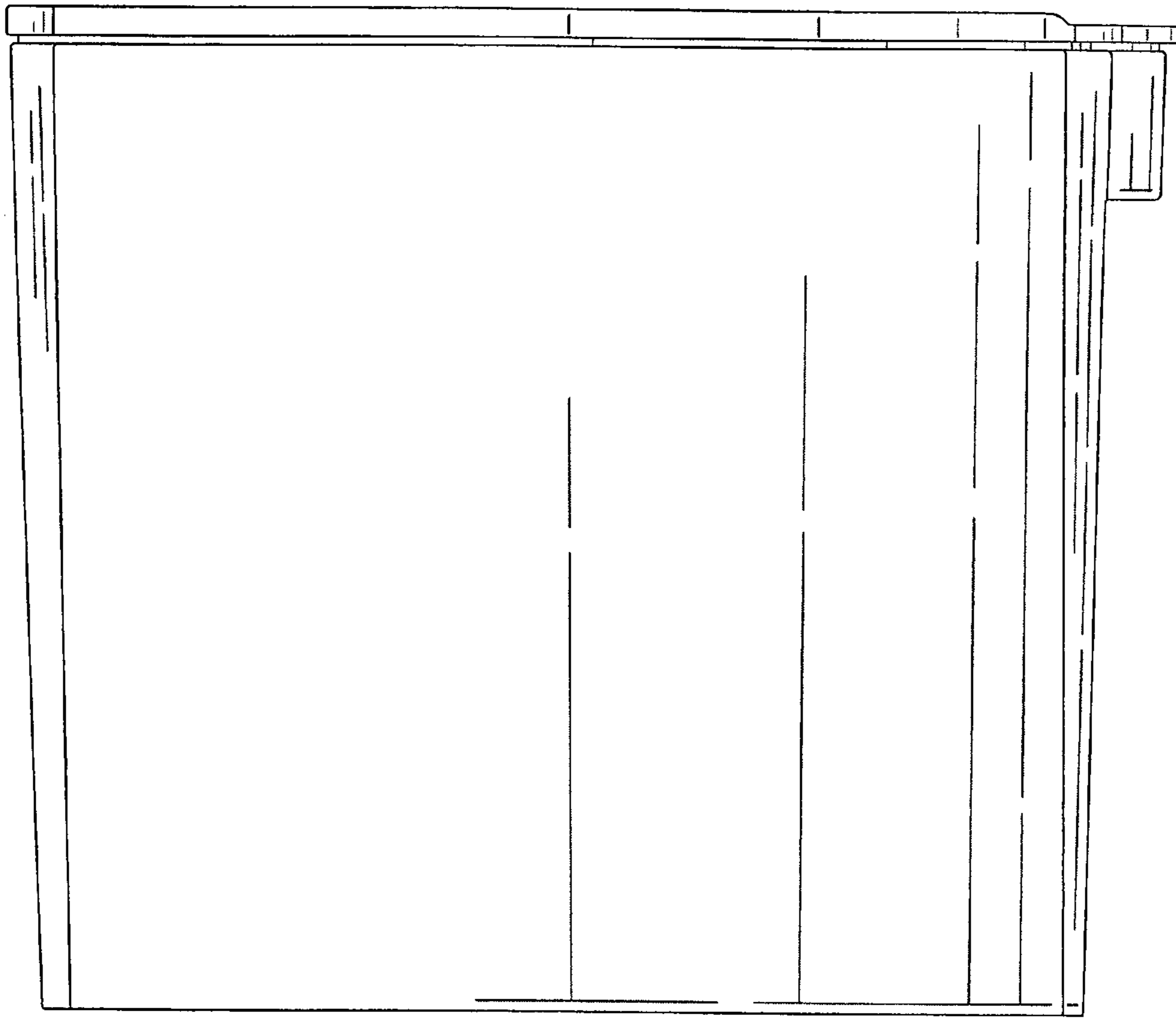

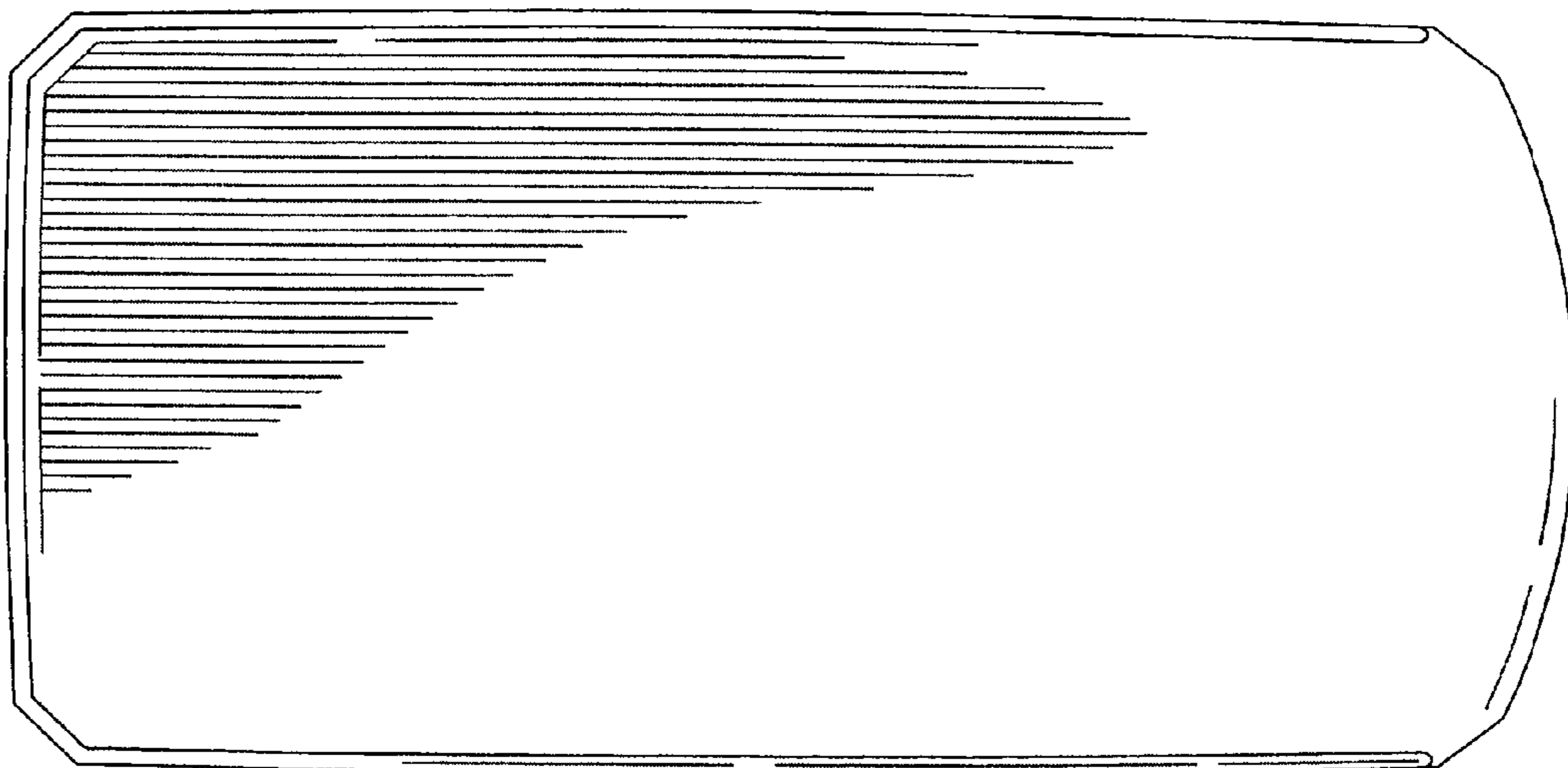

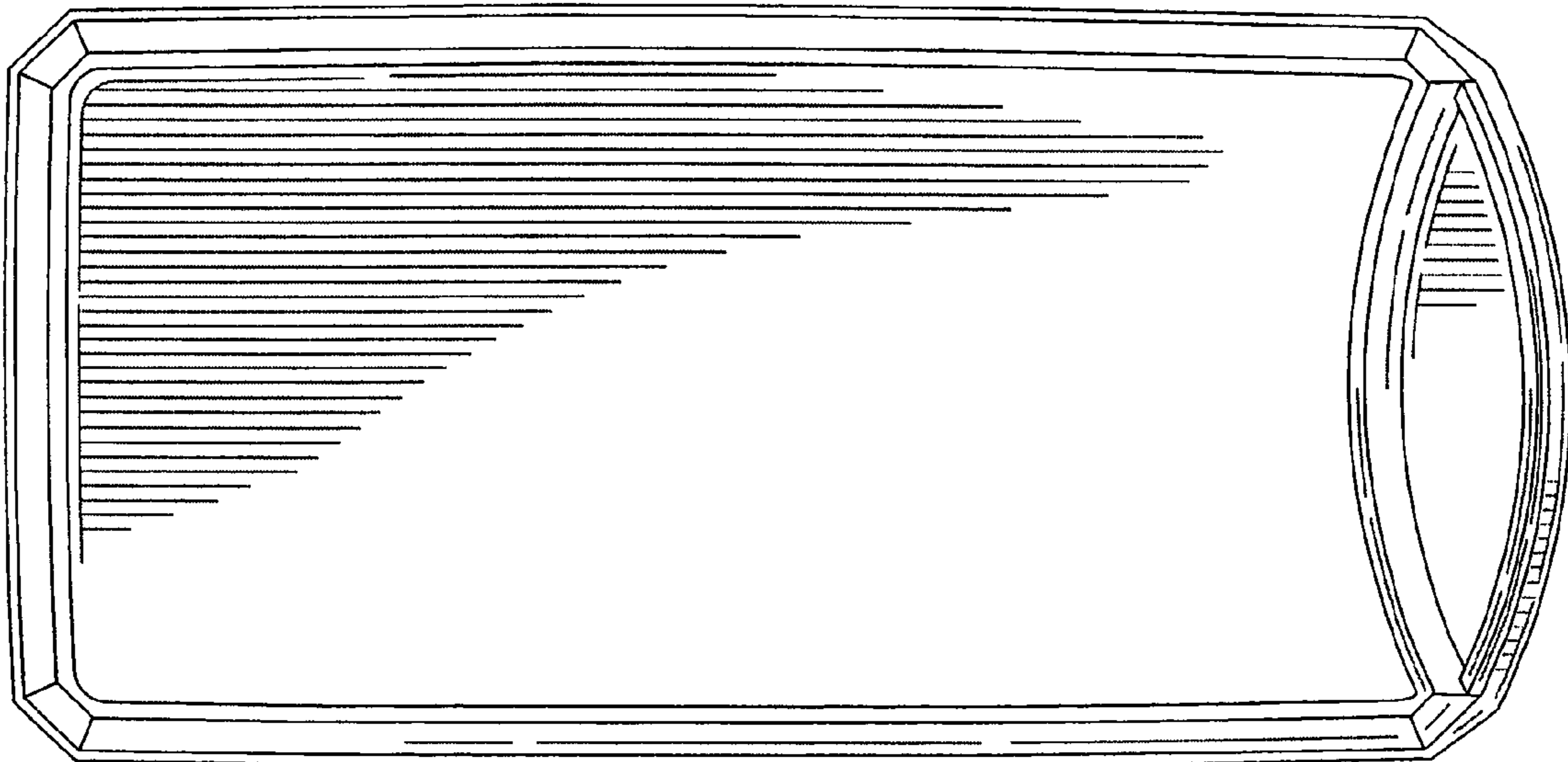

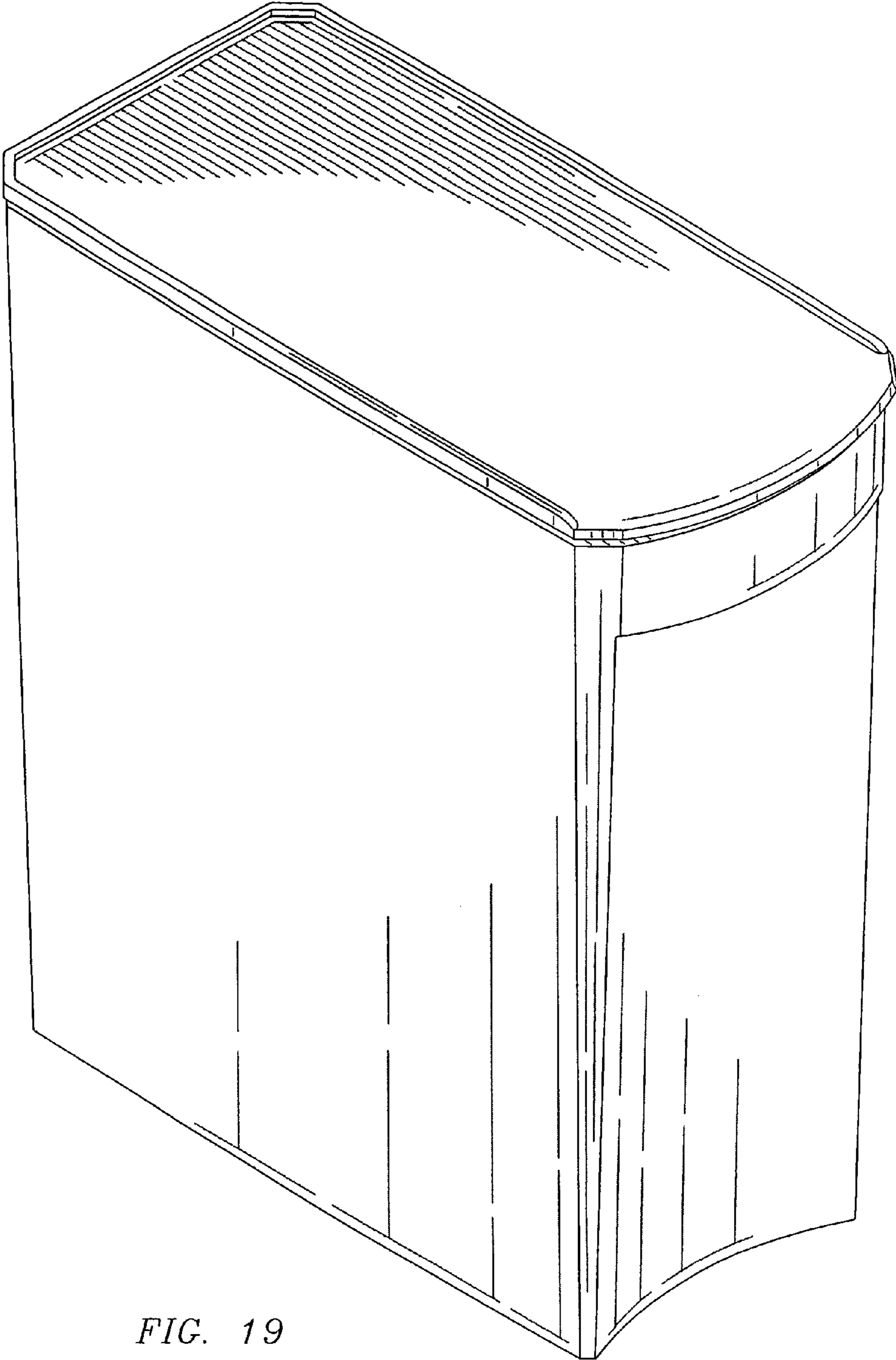

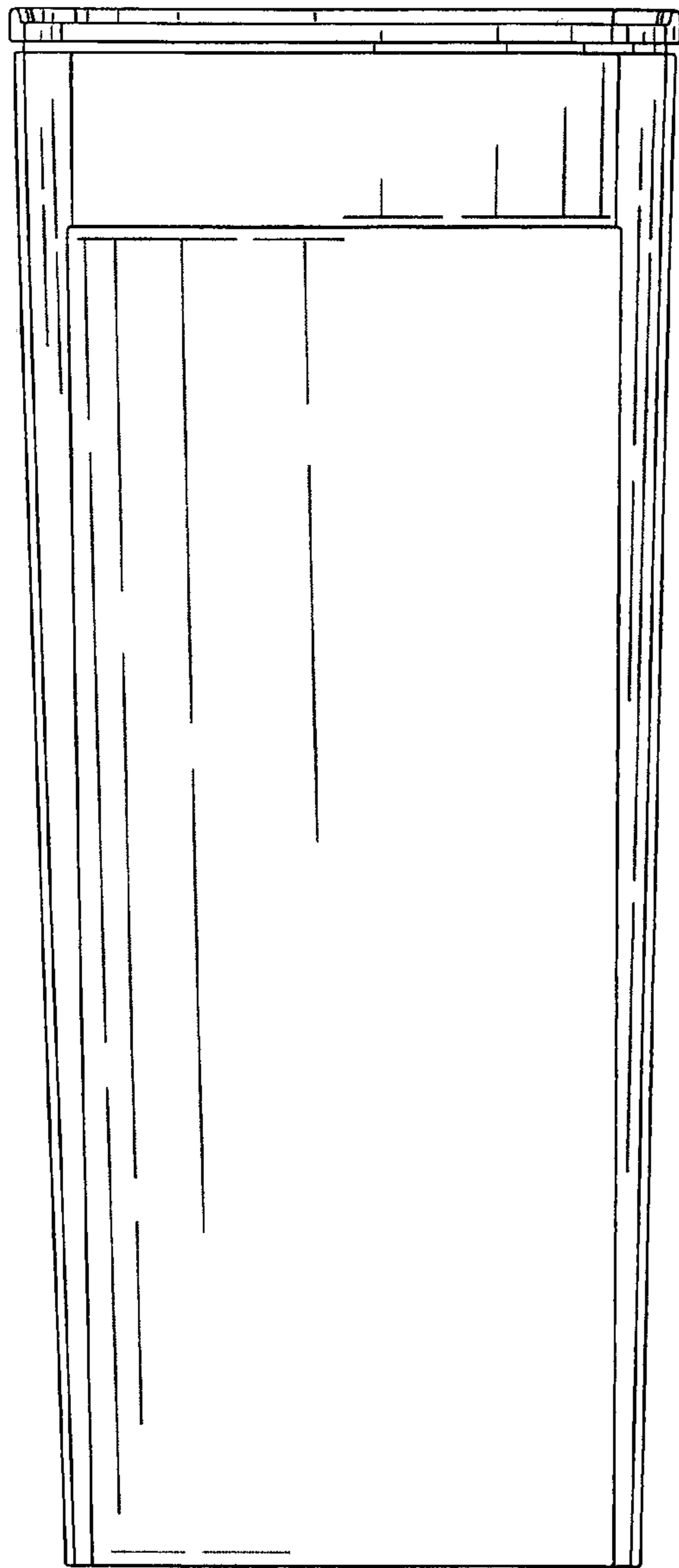

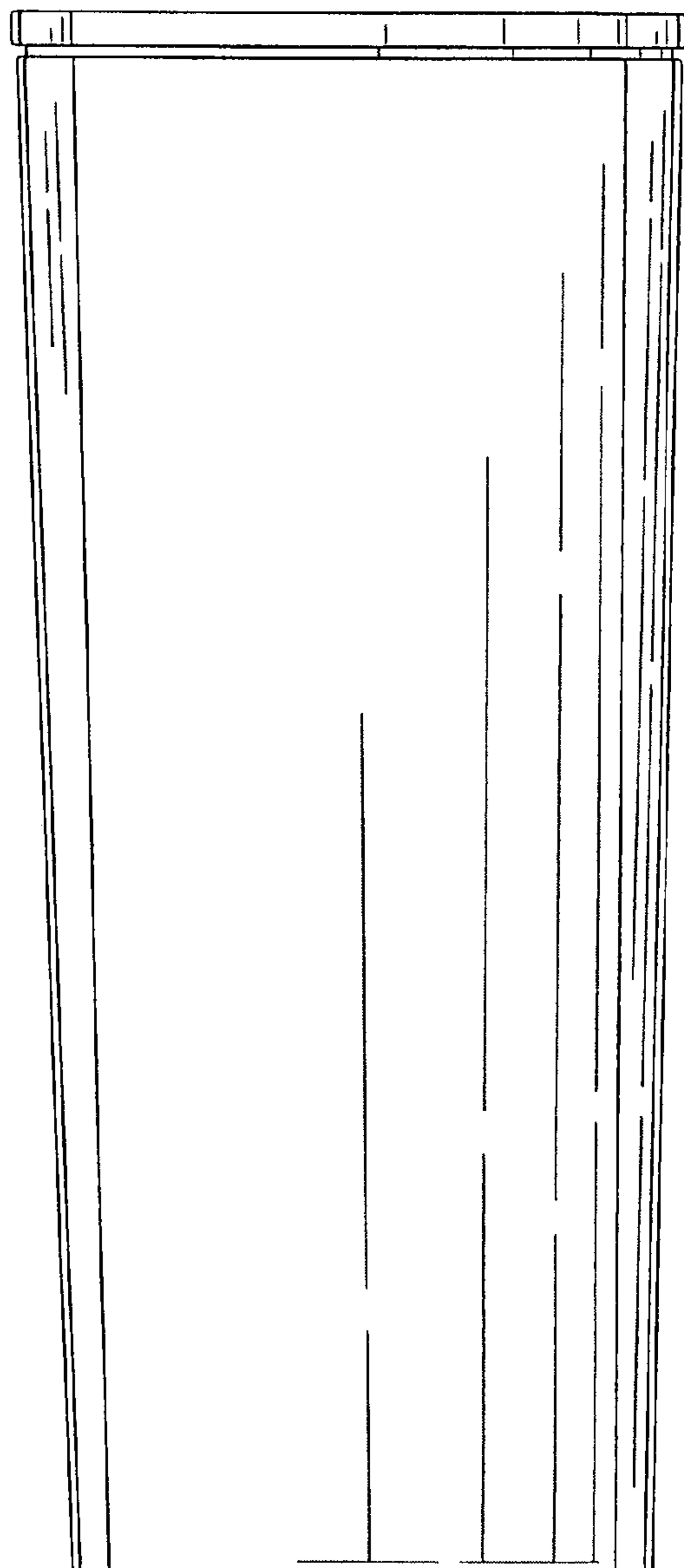

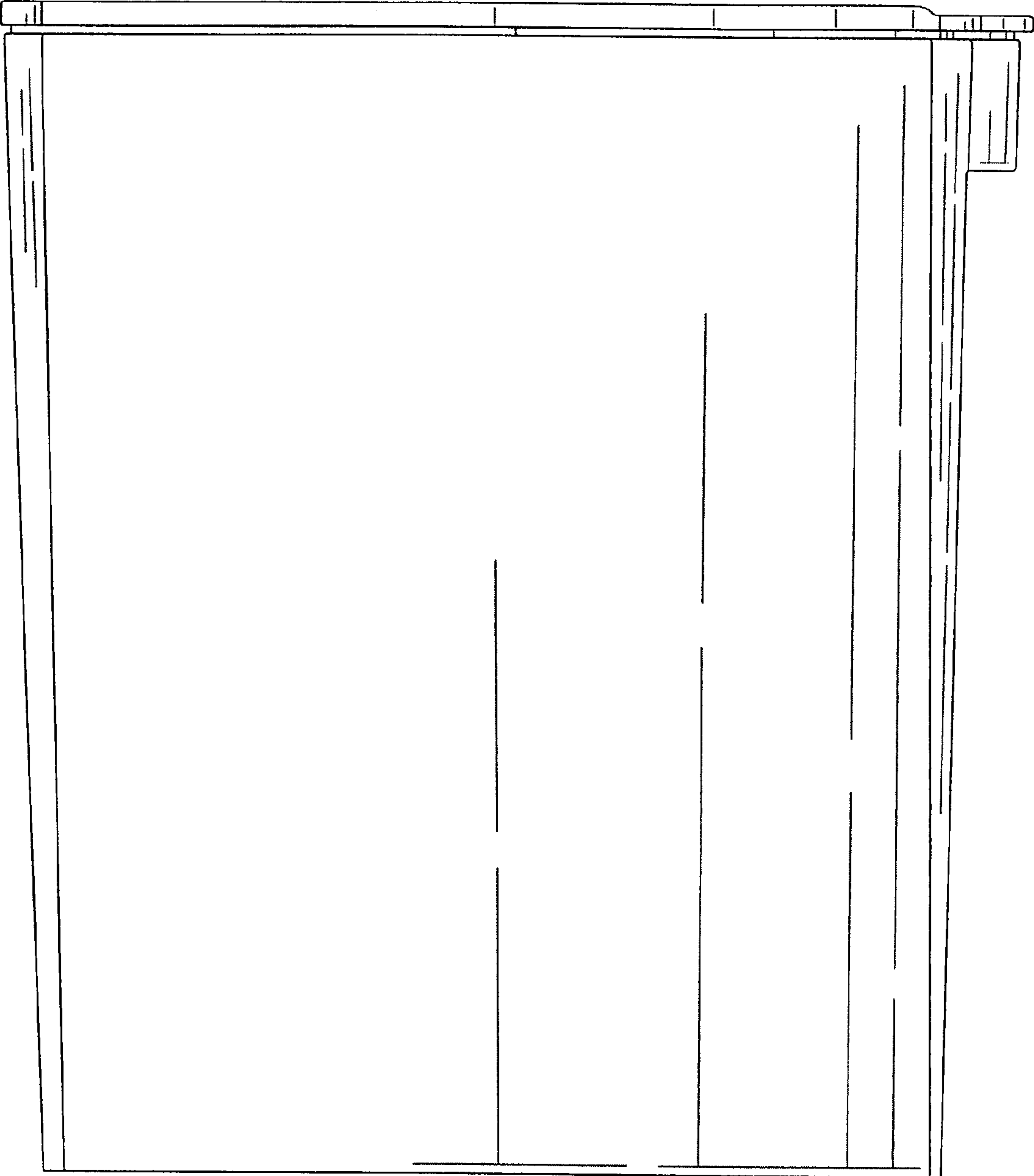

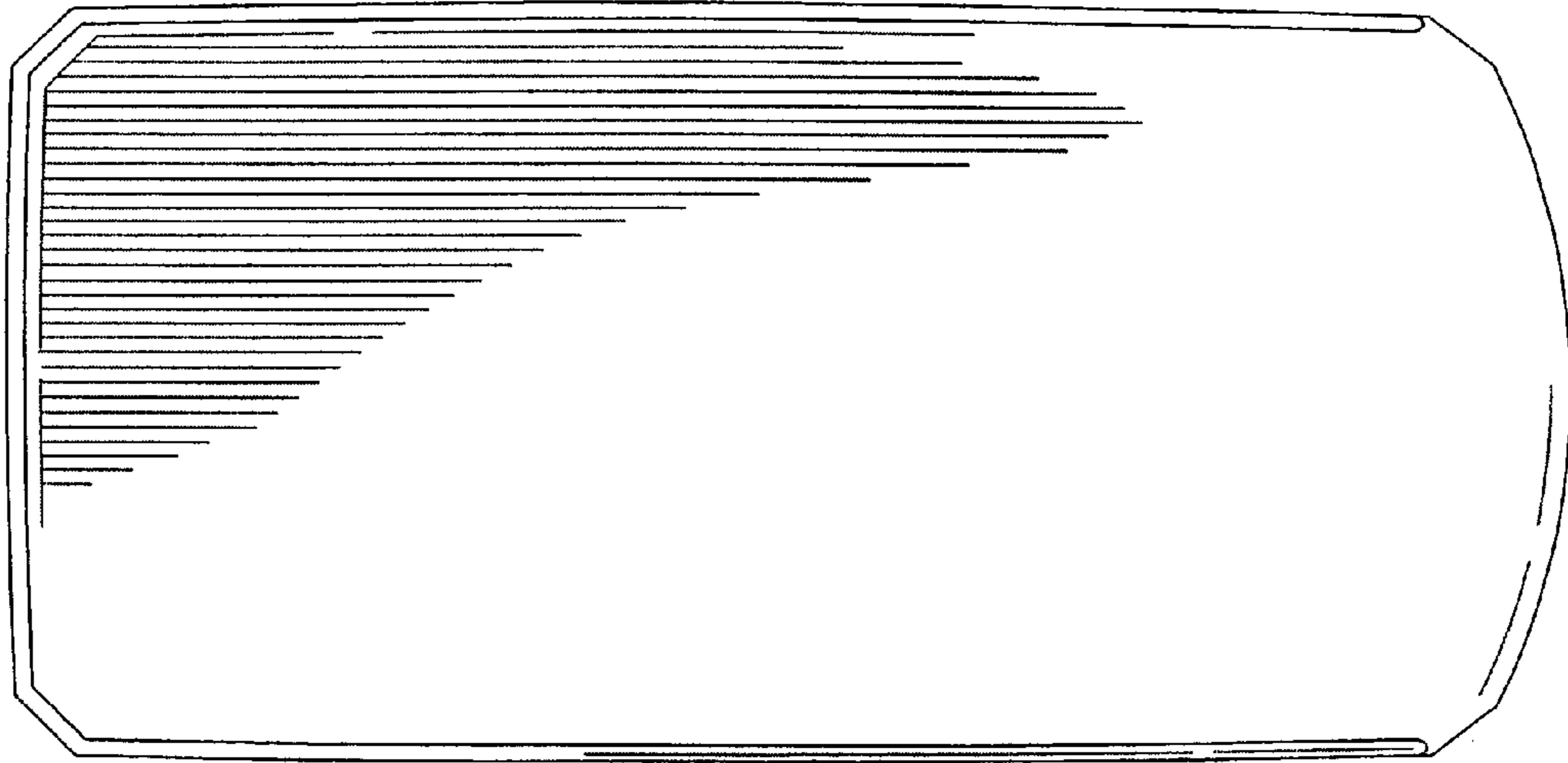

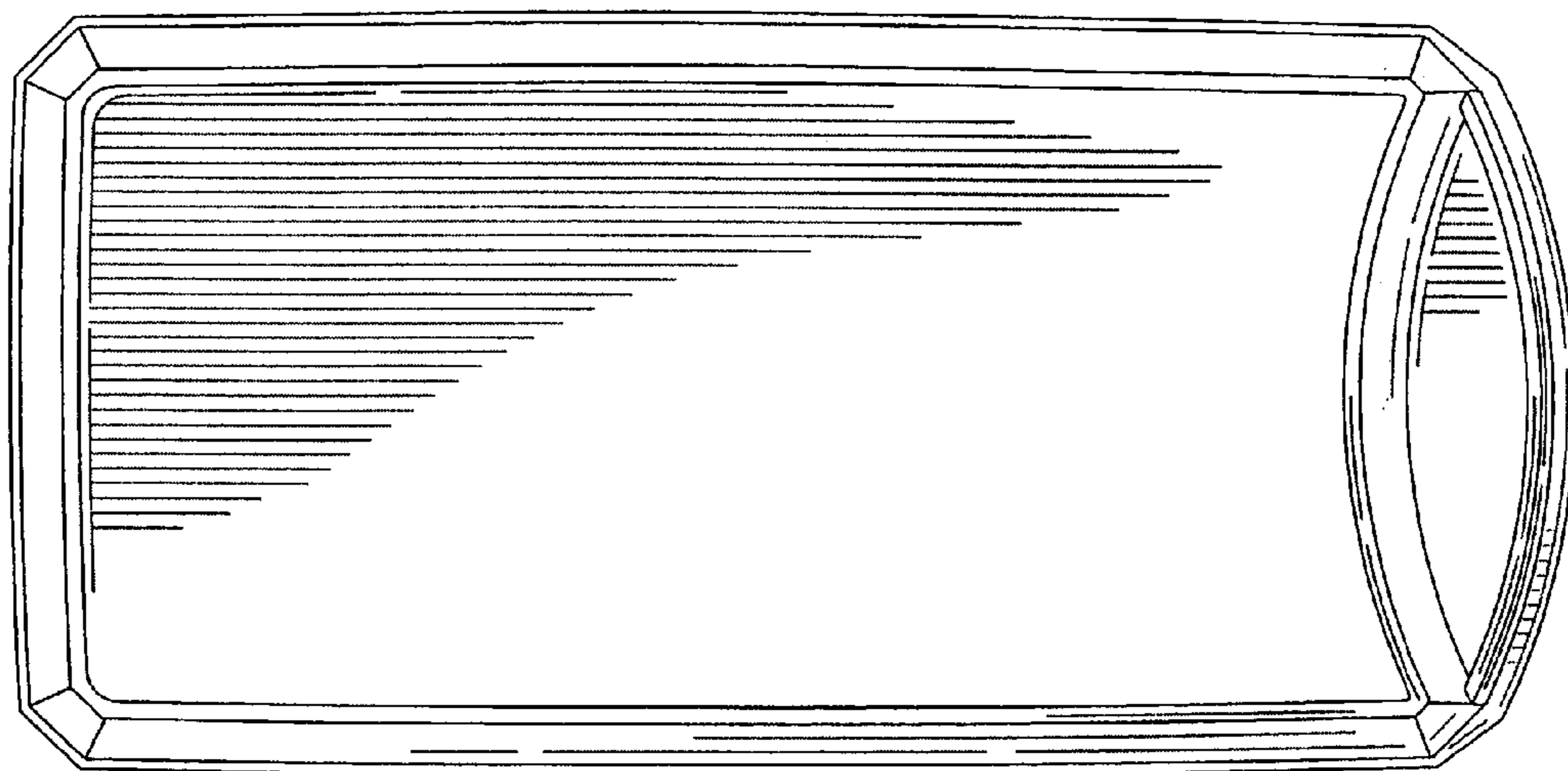
