FIG. 8 is a front elevational view of the alternative embodiment of FIG. 7.

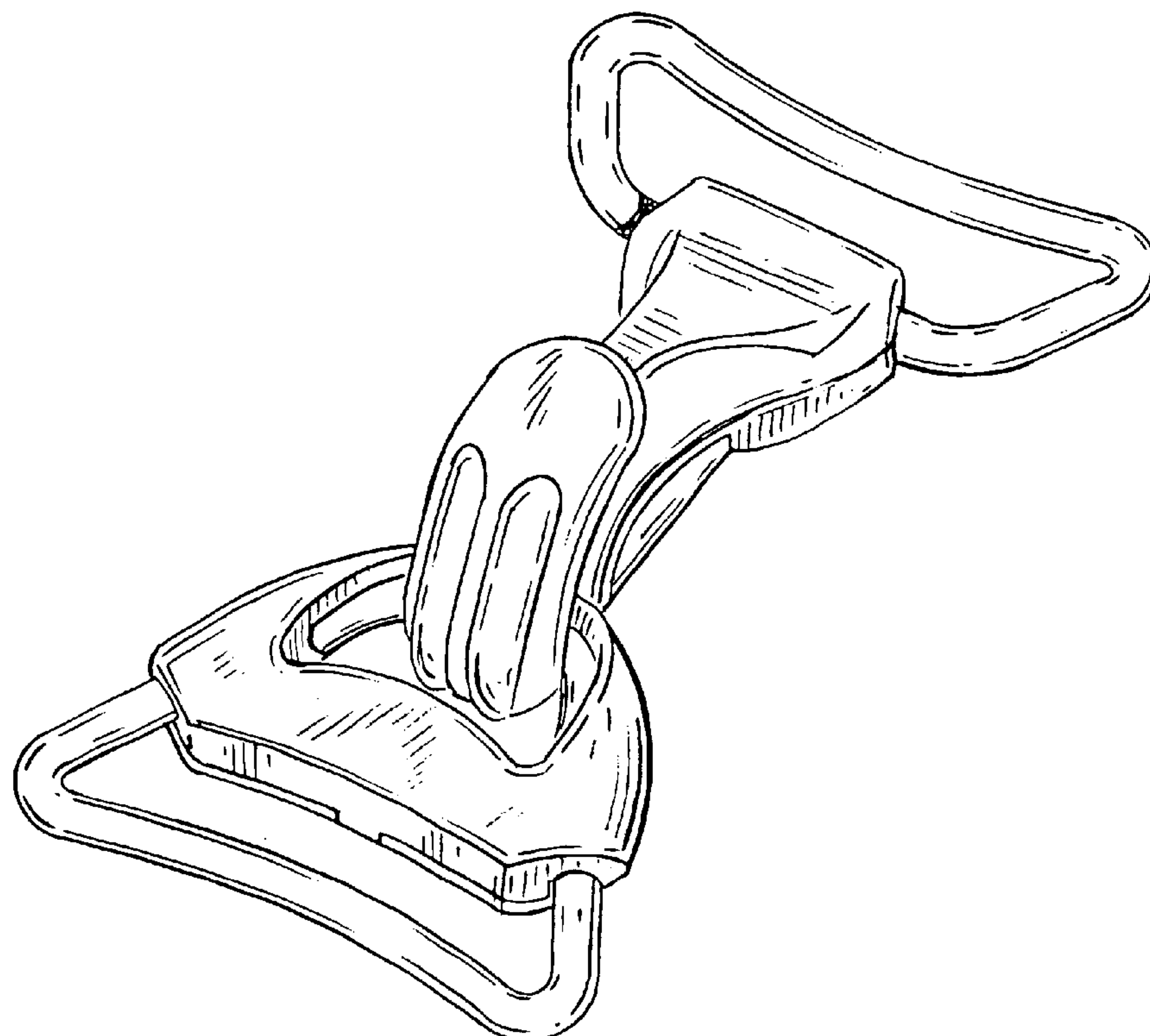

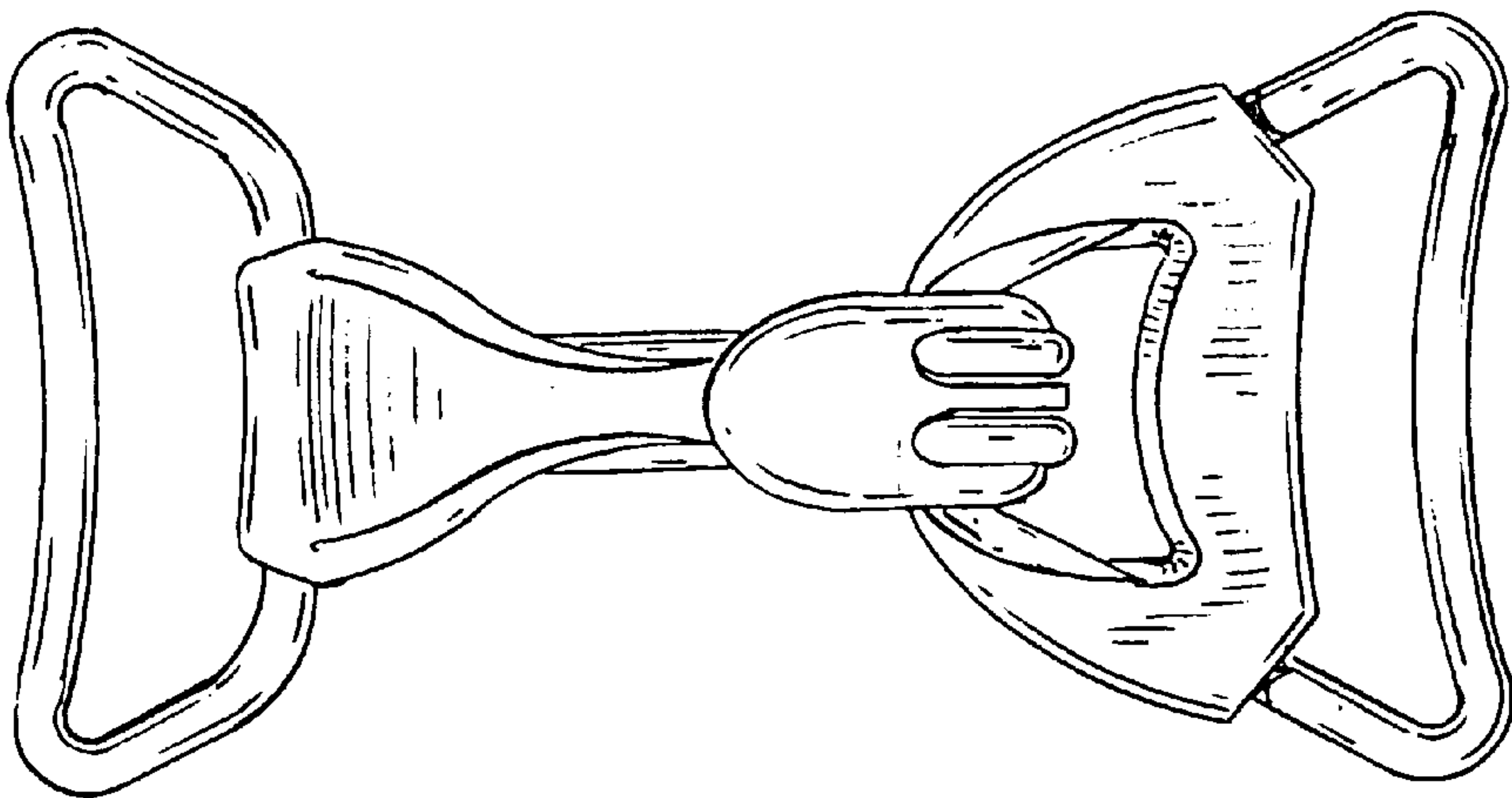
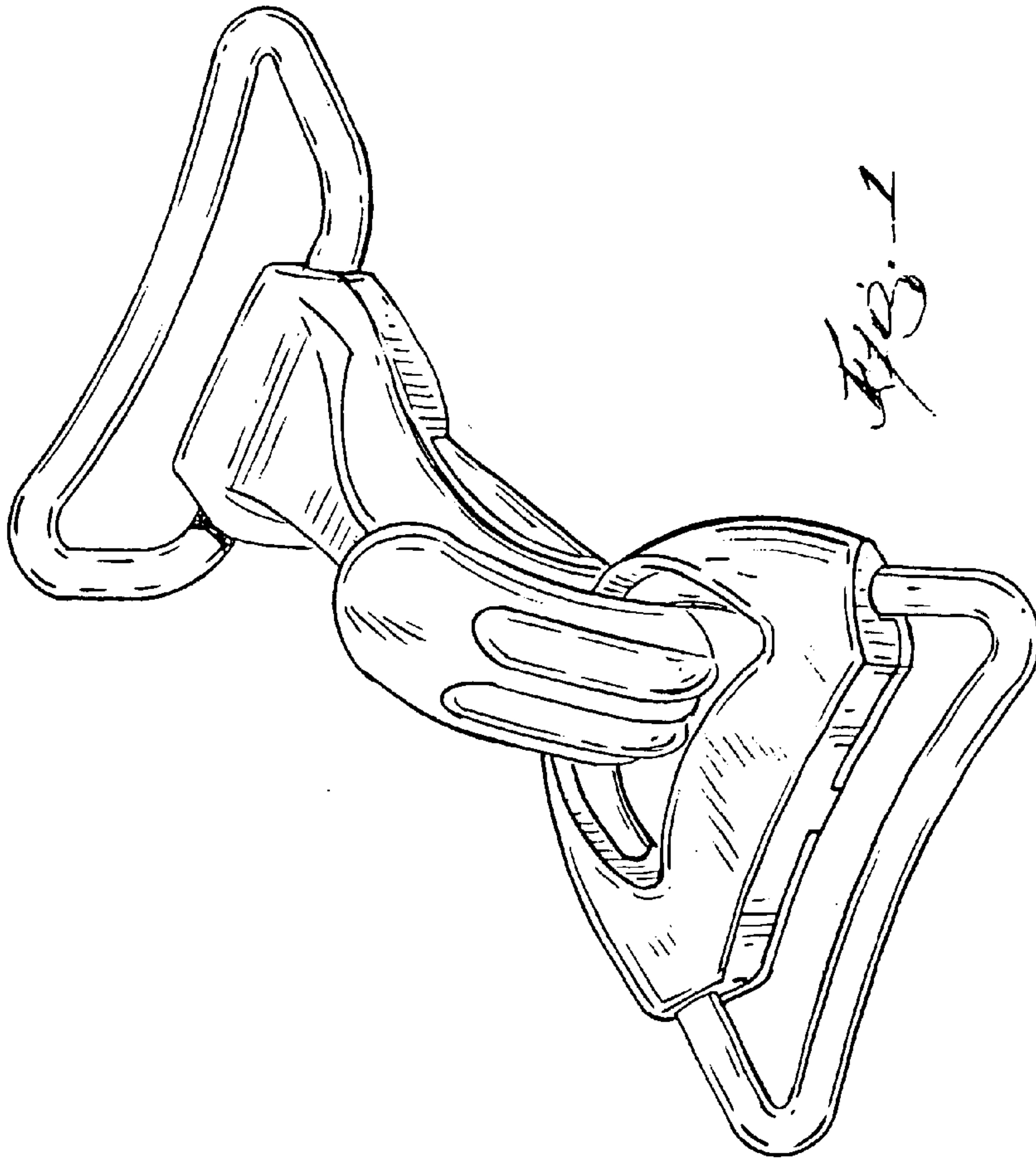

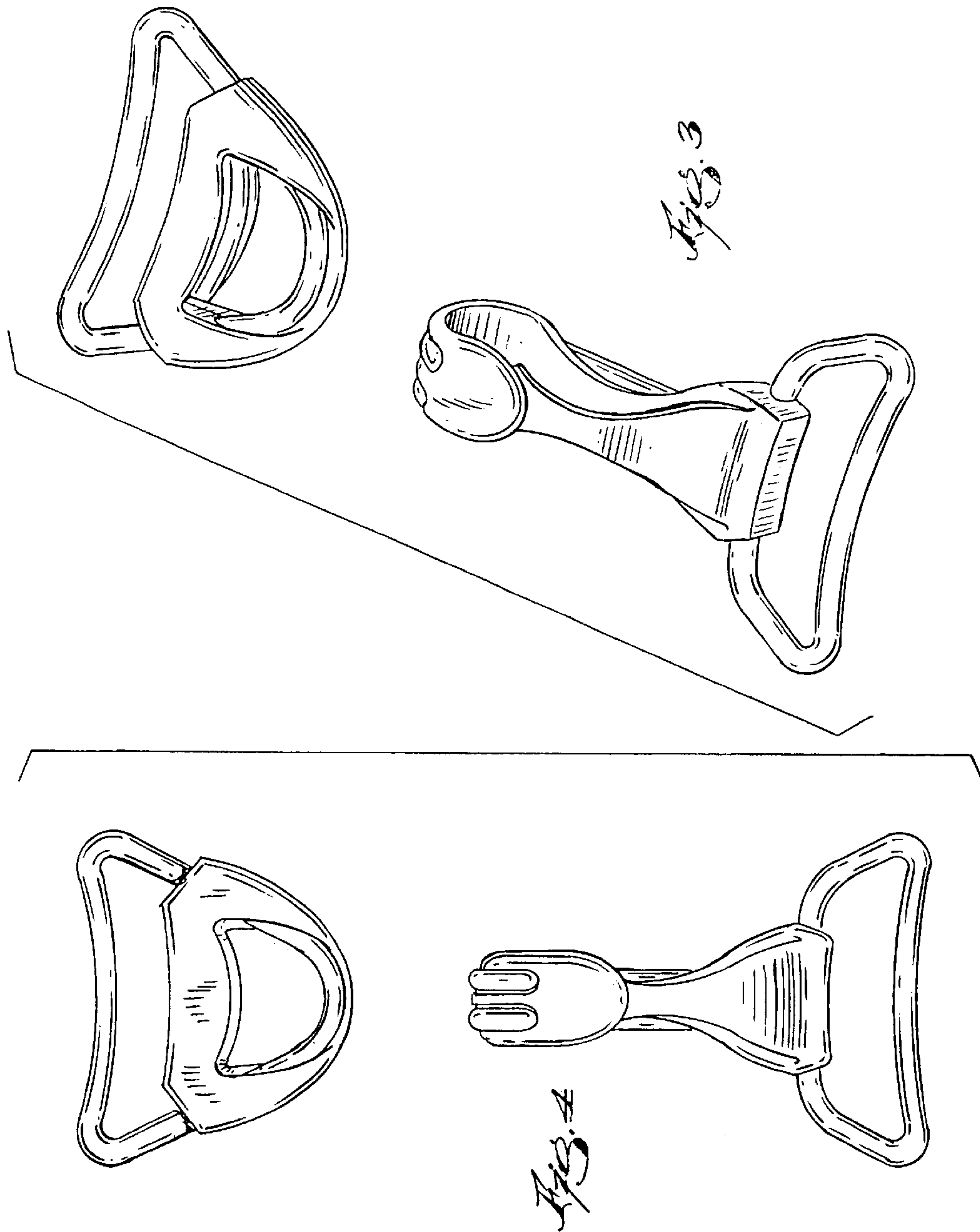

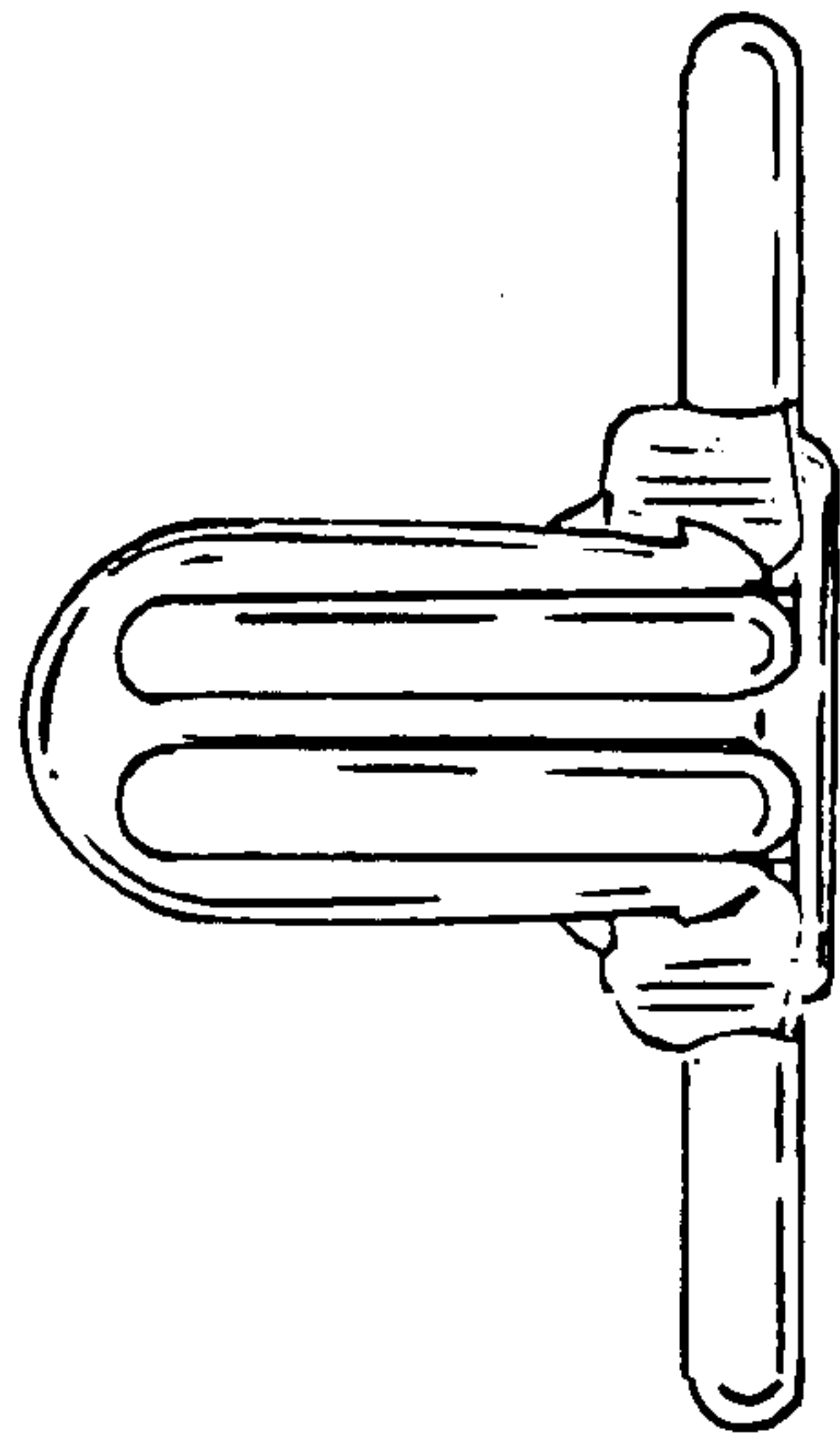

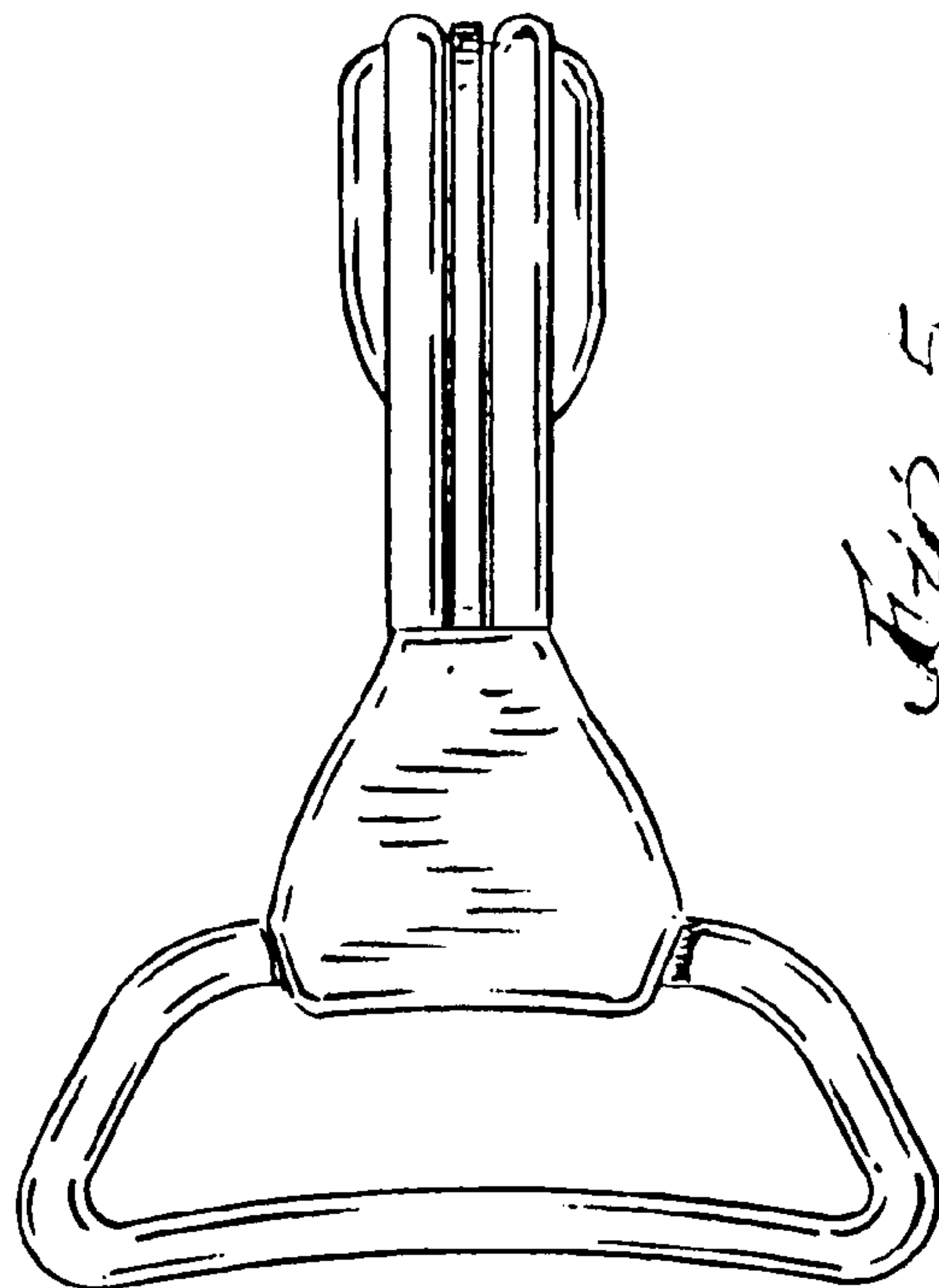

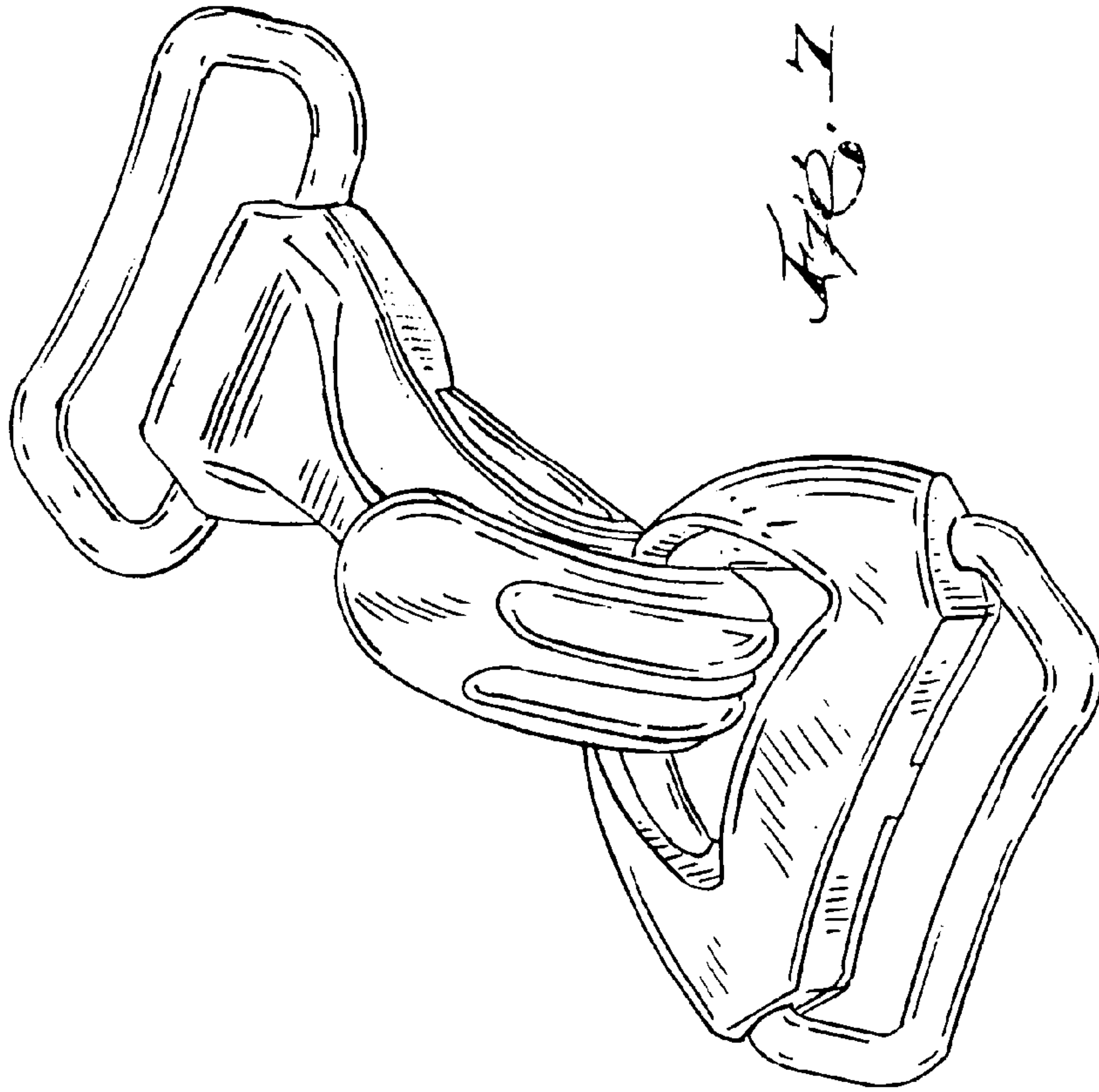

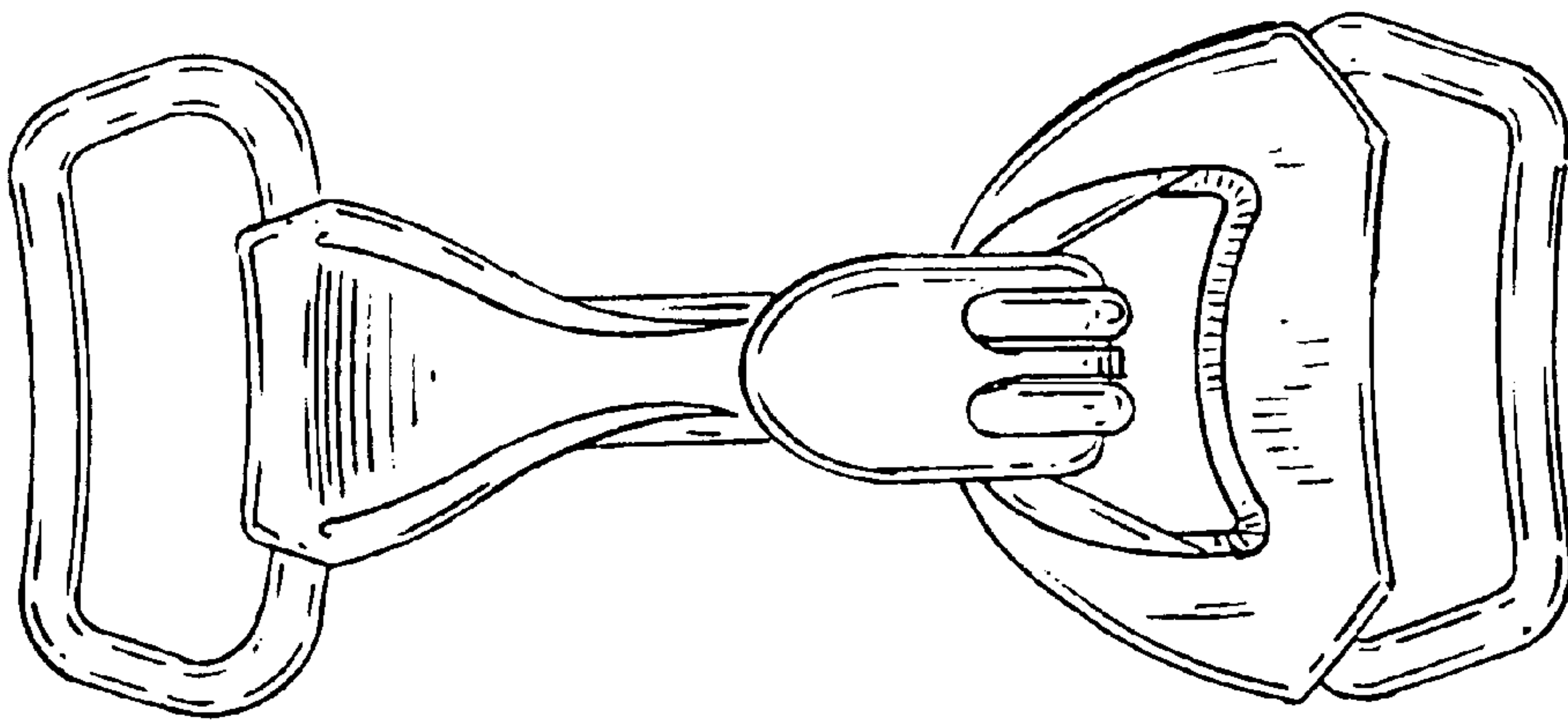
