FIG. 2 is a front view of our new design;

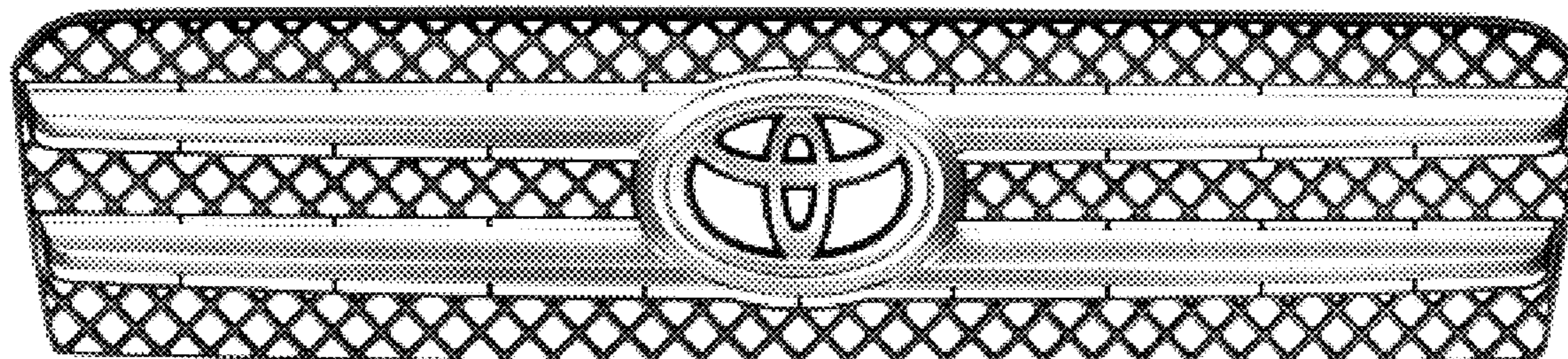
FIG. 3 is a rear view of our new design;

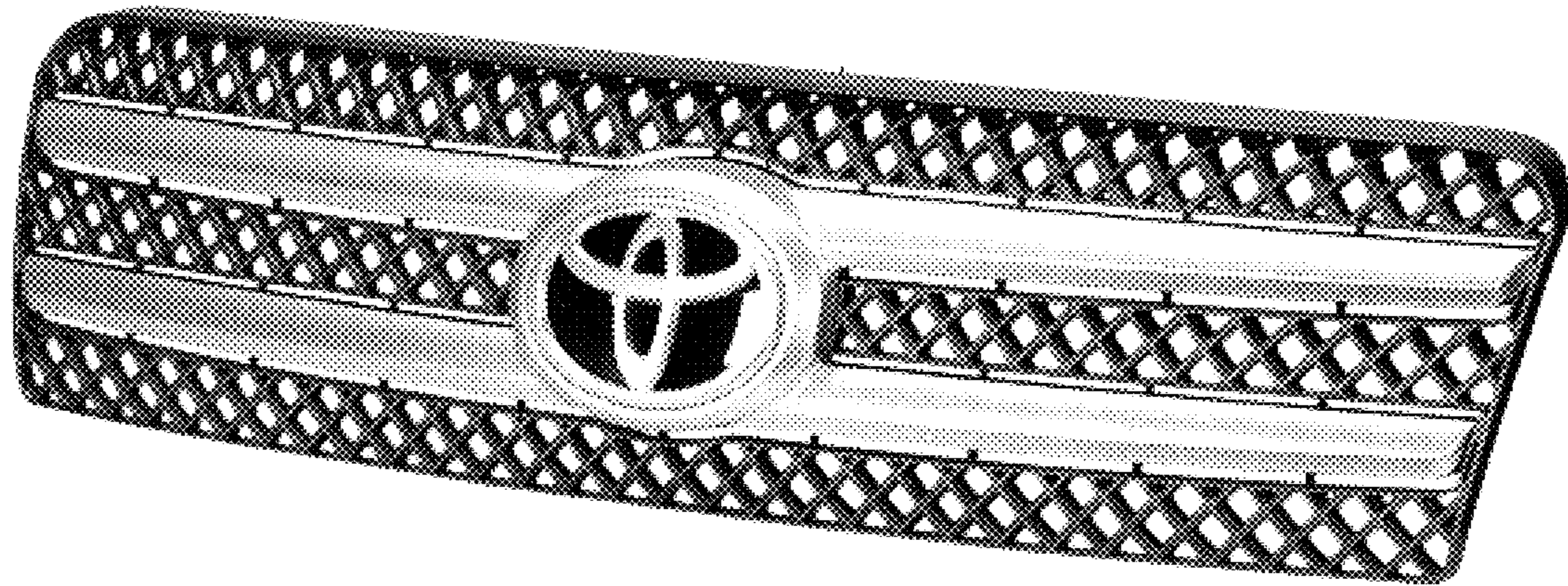

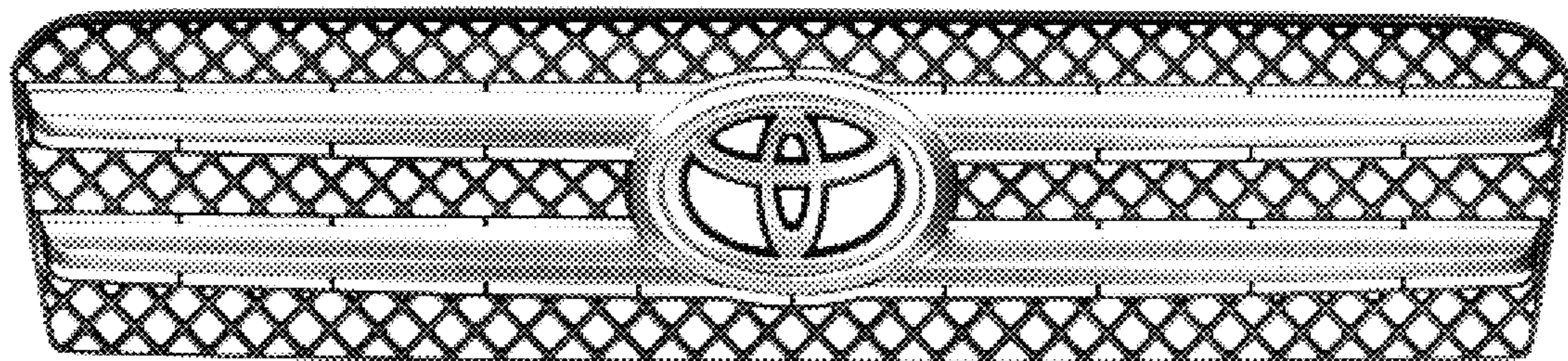

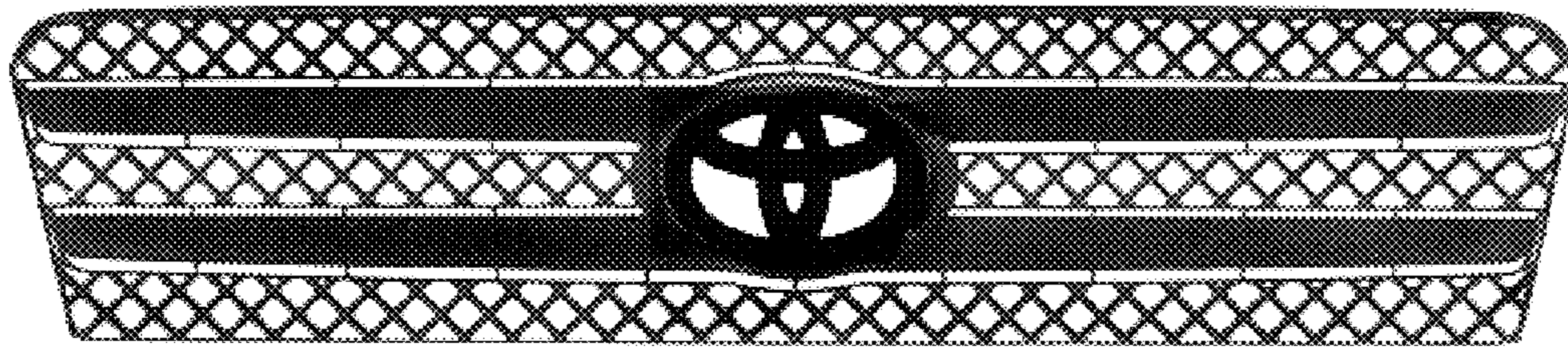

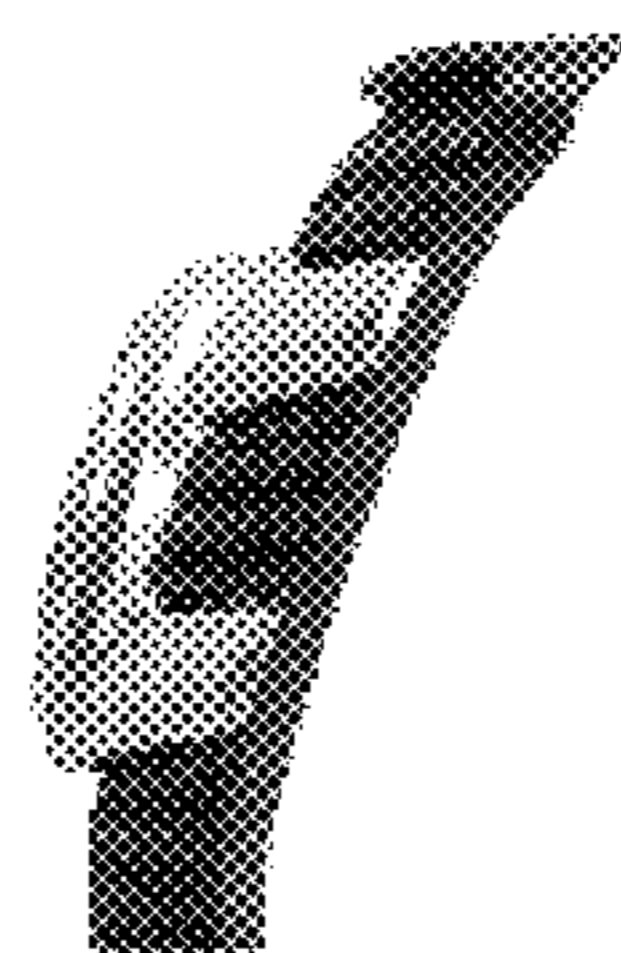
