FIG. 1 is a front elevation view of an insert for piezoelectric devices;

FIG. 3 is a rear elevation view of the invention illustrated in FIG. 1;

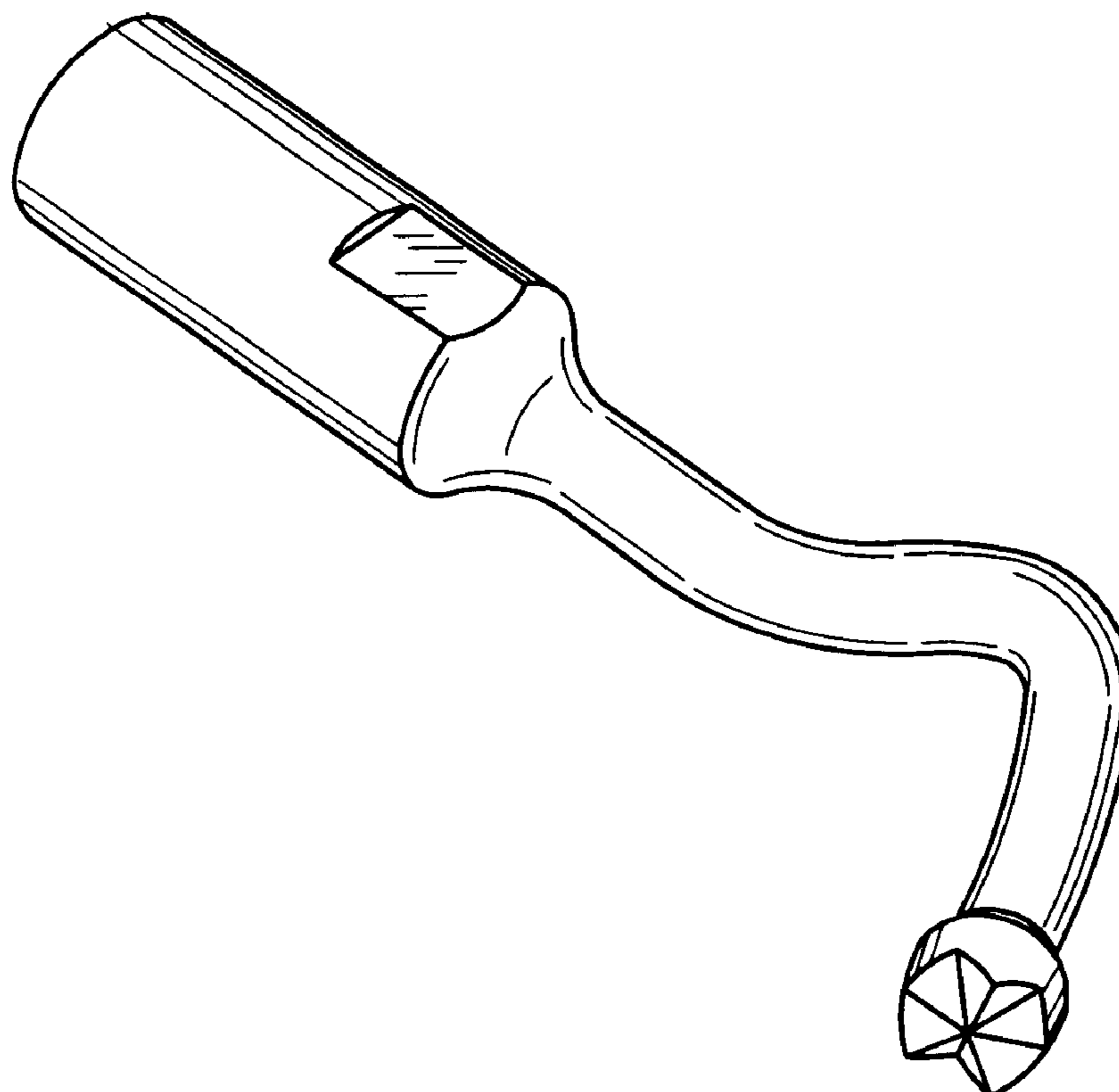
FIG. 4 is a right elevation view of the invention illustrated in FIG. 1;

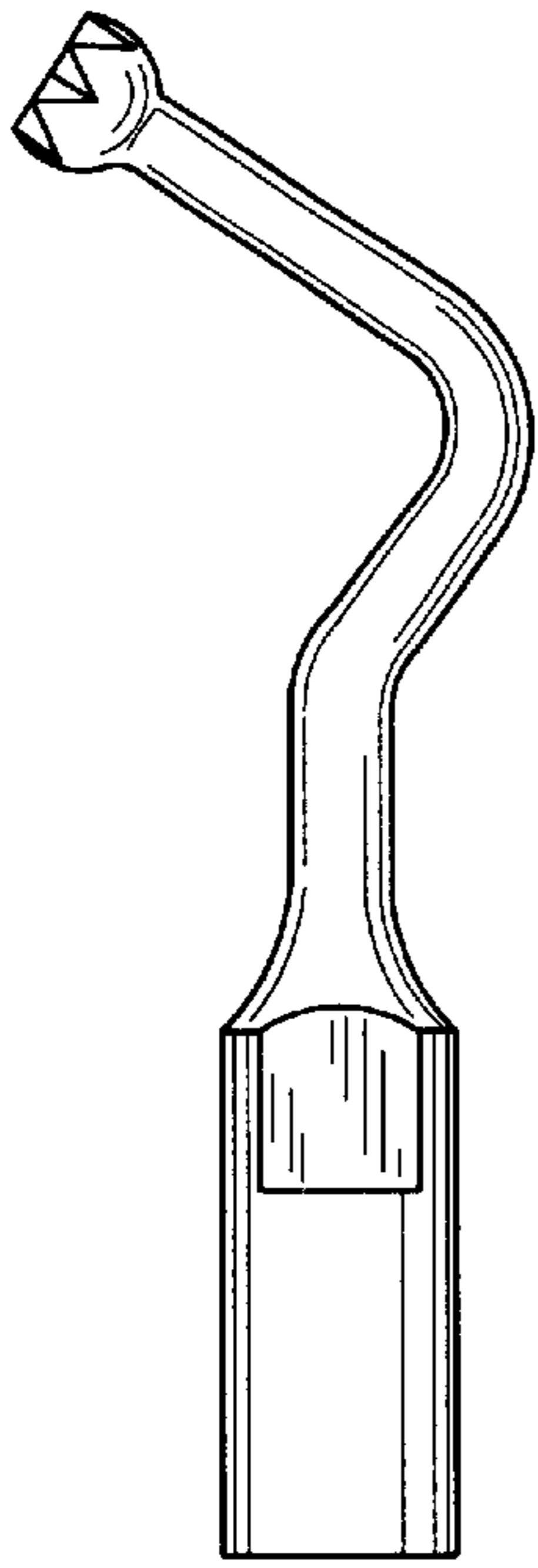

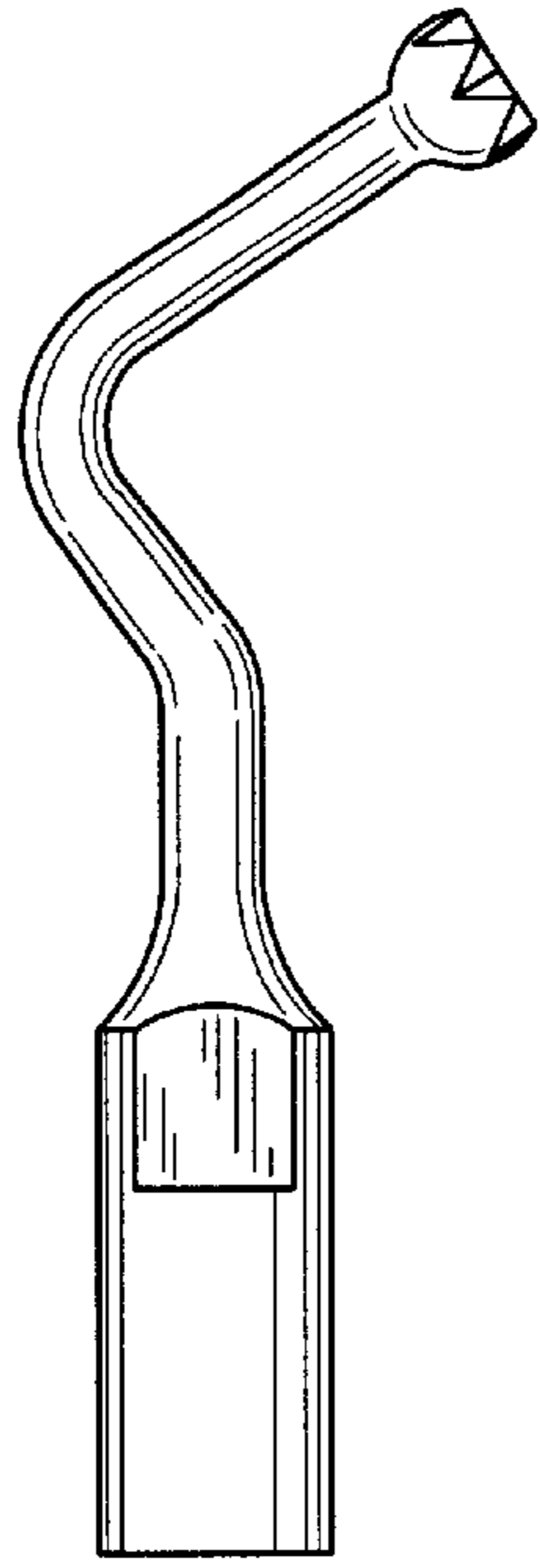

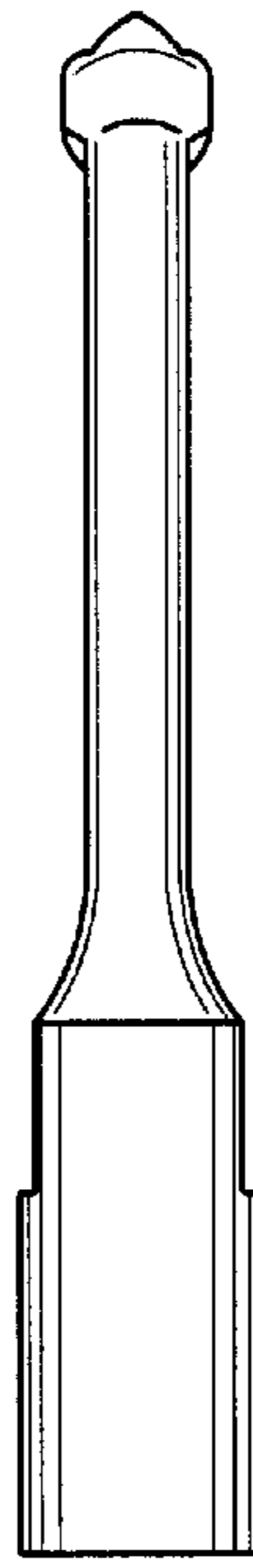

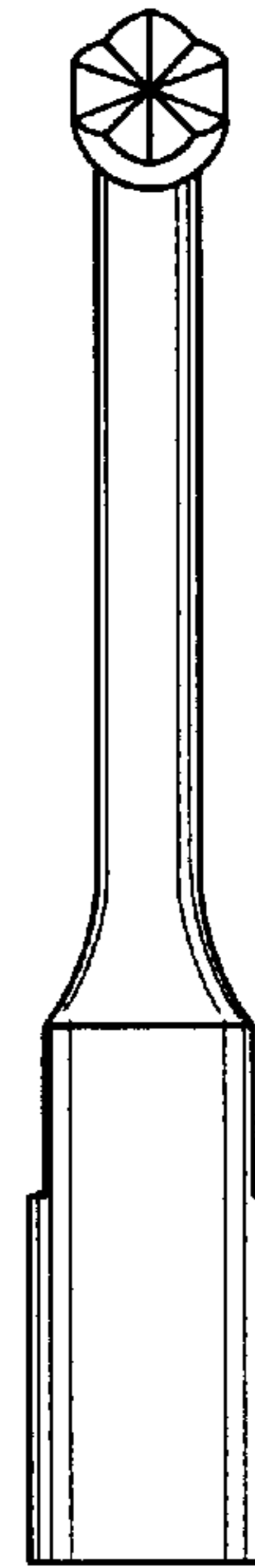

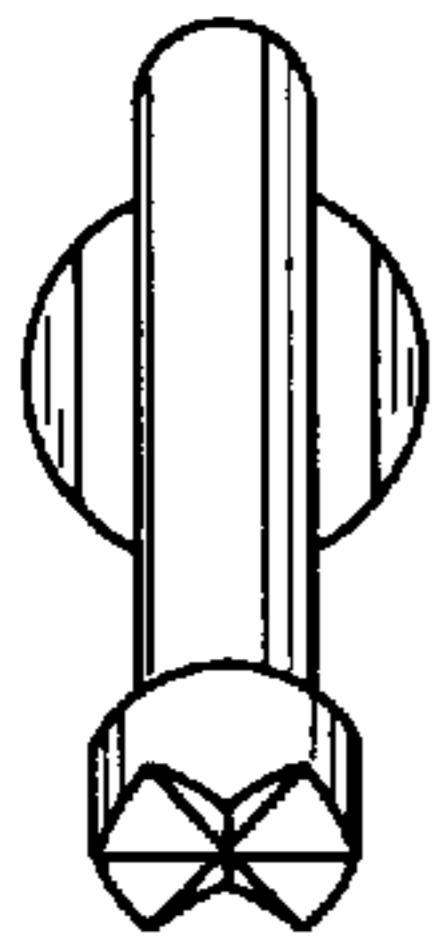

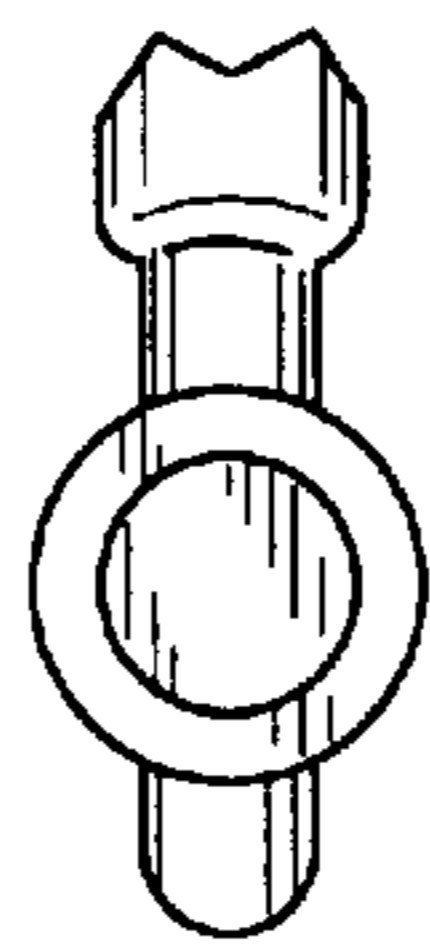

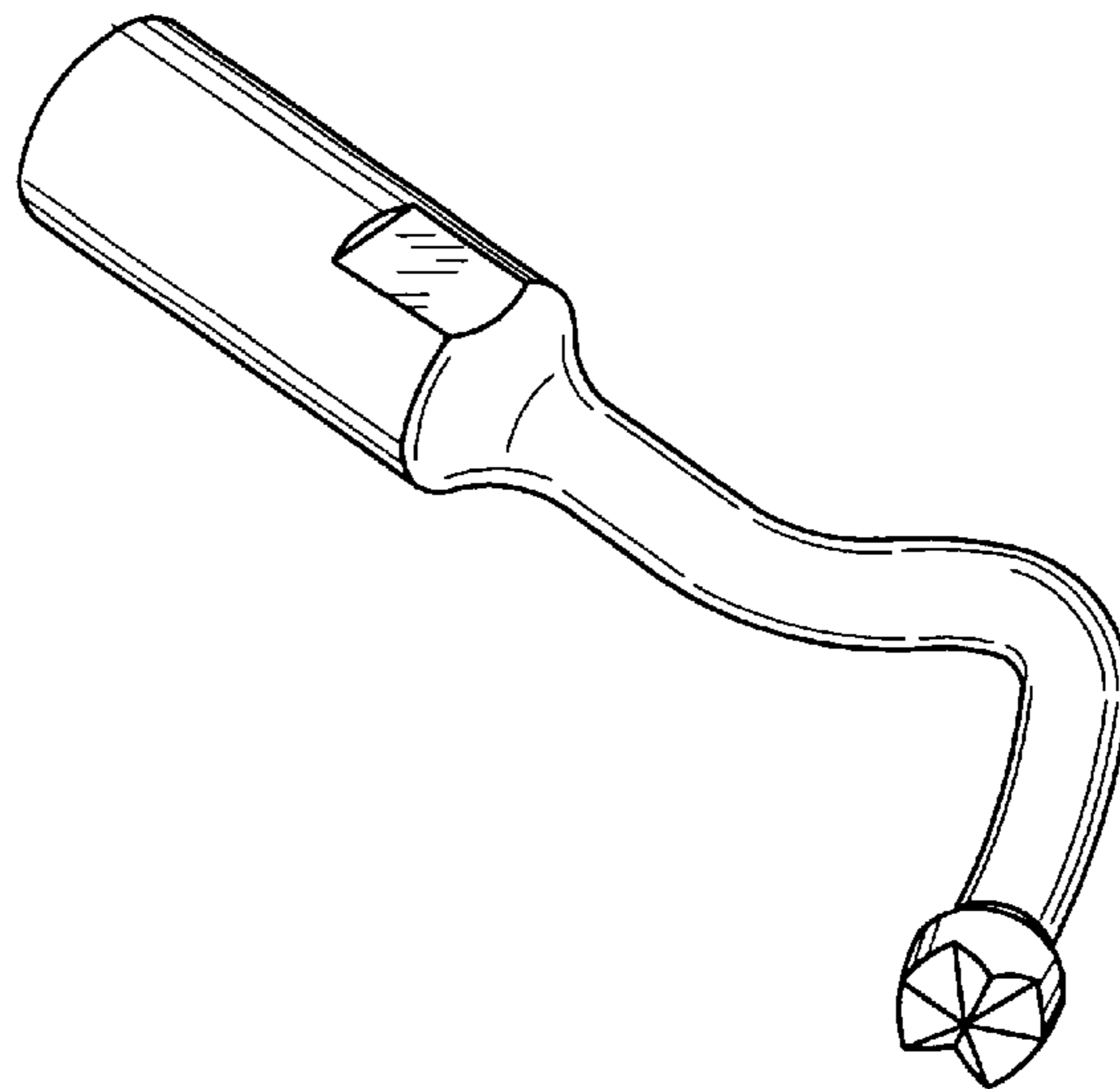
