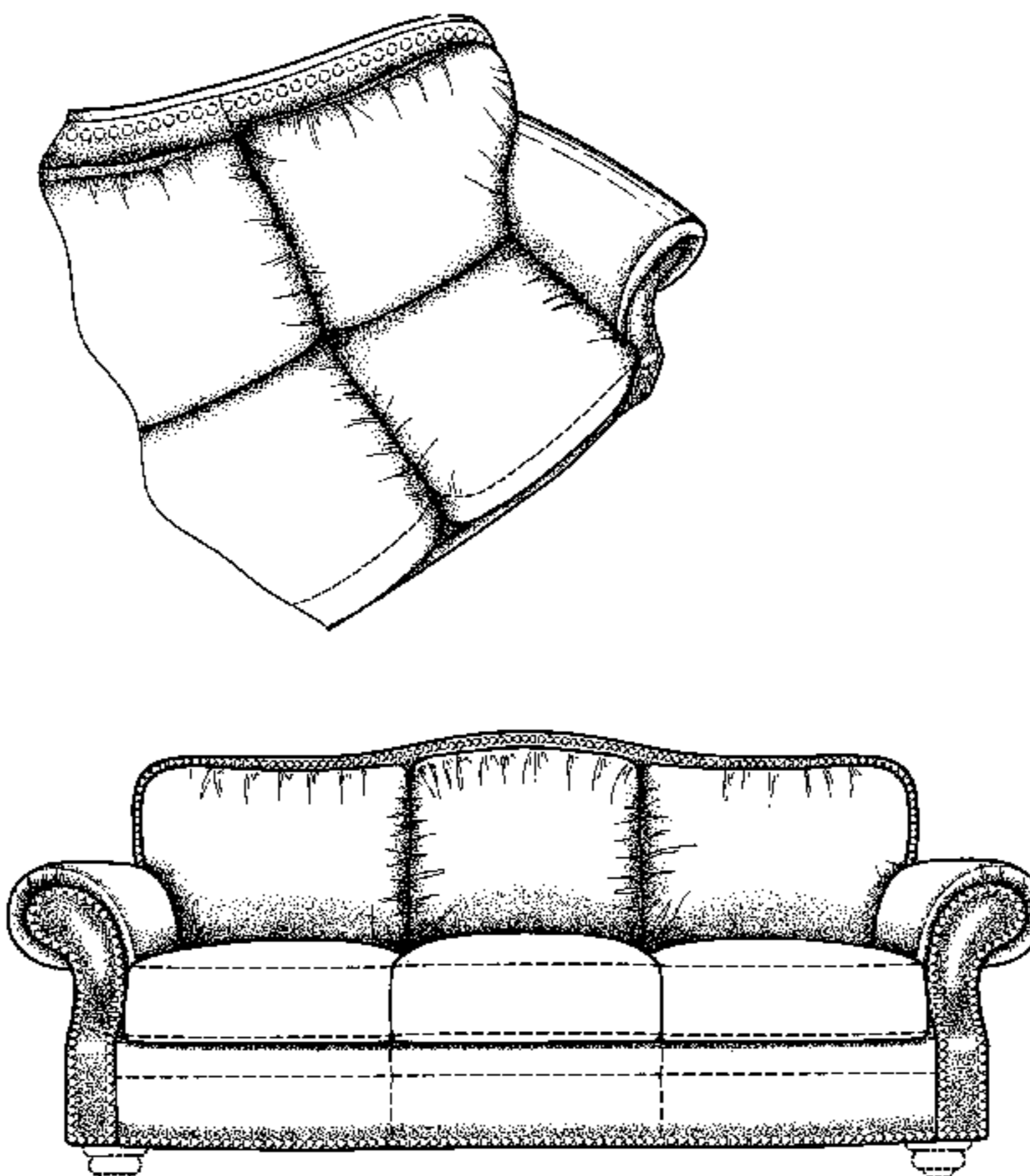
(57) **CLAIM**

The ornamental design for a sofa, as shown and described.

**DESCRIPTION**

FIG. 1 is a partial front perspective view of a sofa showing my new design;  
 FIG. 2 is a whole front perspective view of the sofa of FIG. 1;  
 FIG. 3 is a left side elevation view of FIG. 2 with the right side elevation view being a mirror image thereof; and,  
 FIG. 4 is a rear elevation view of FIG. 2.

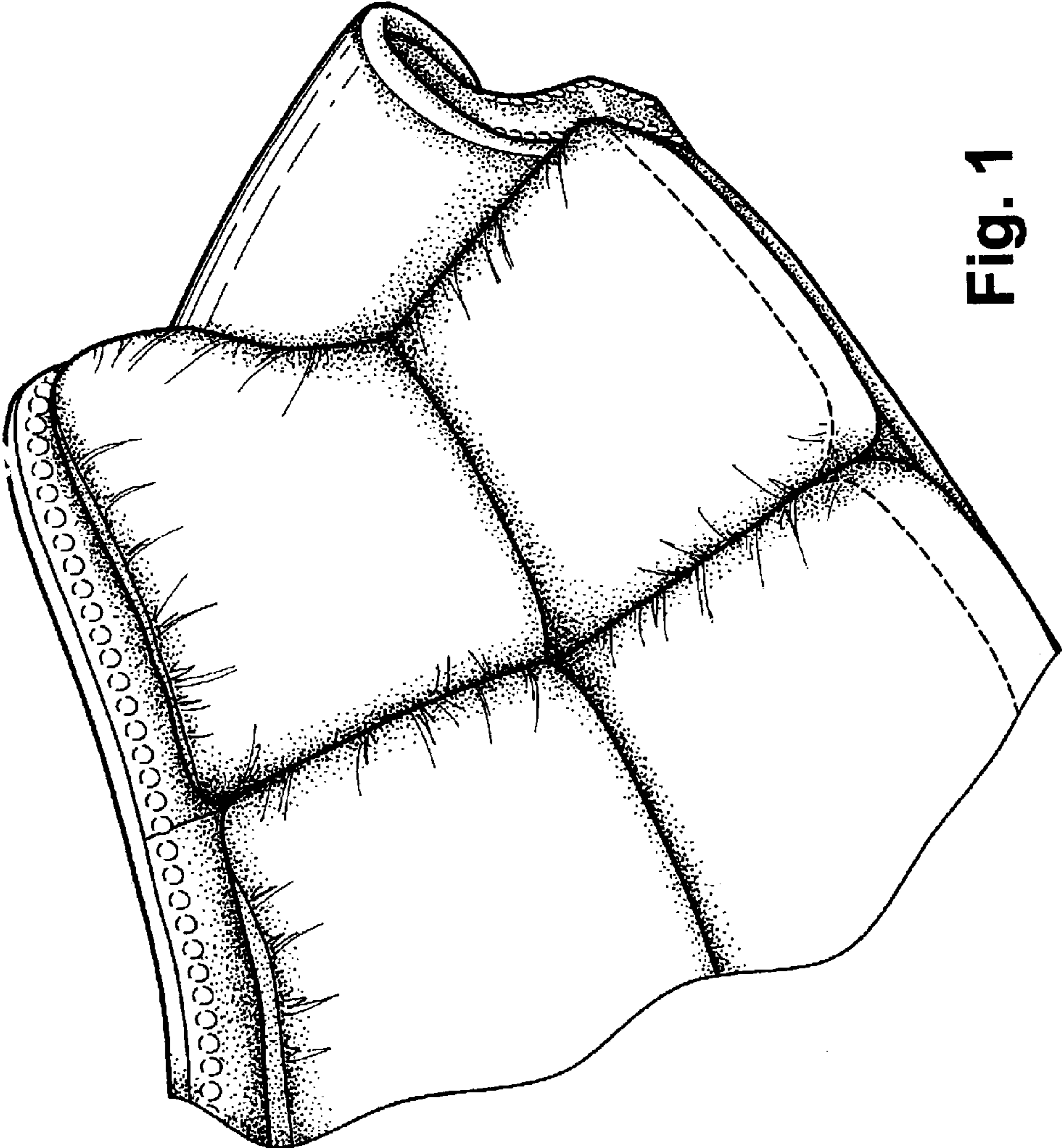

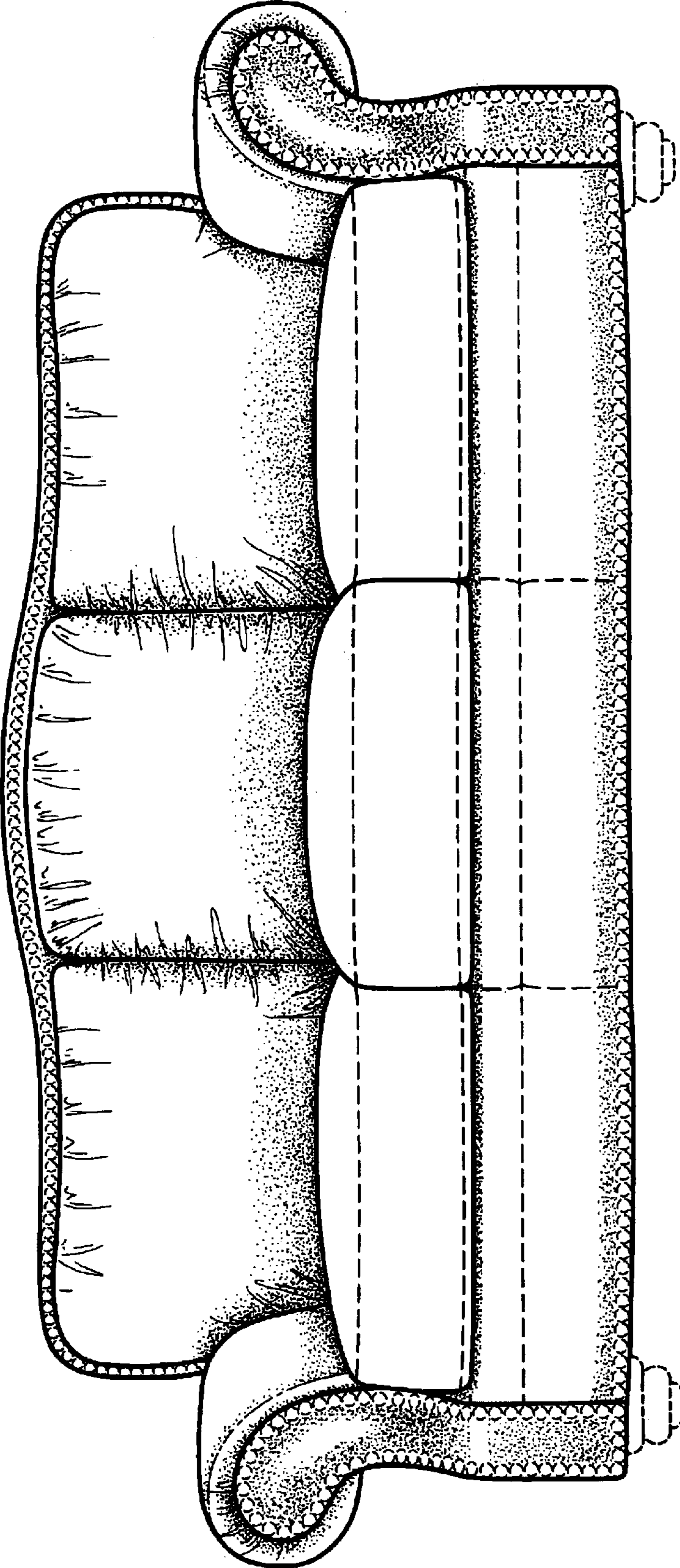

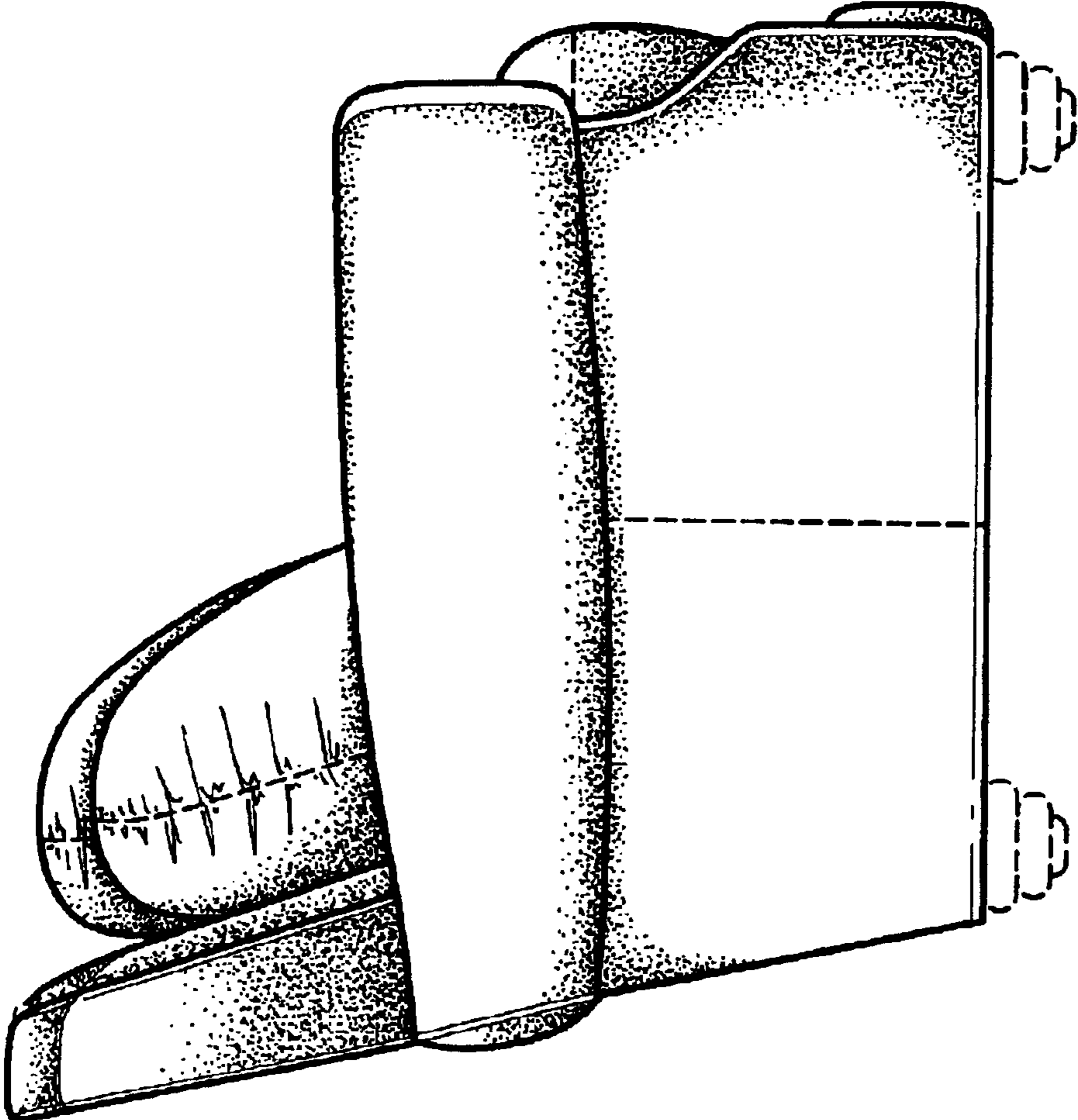

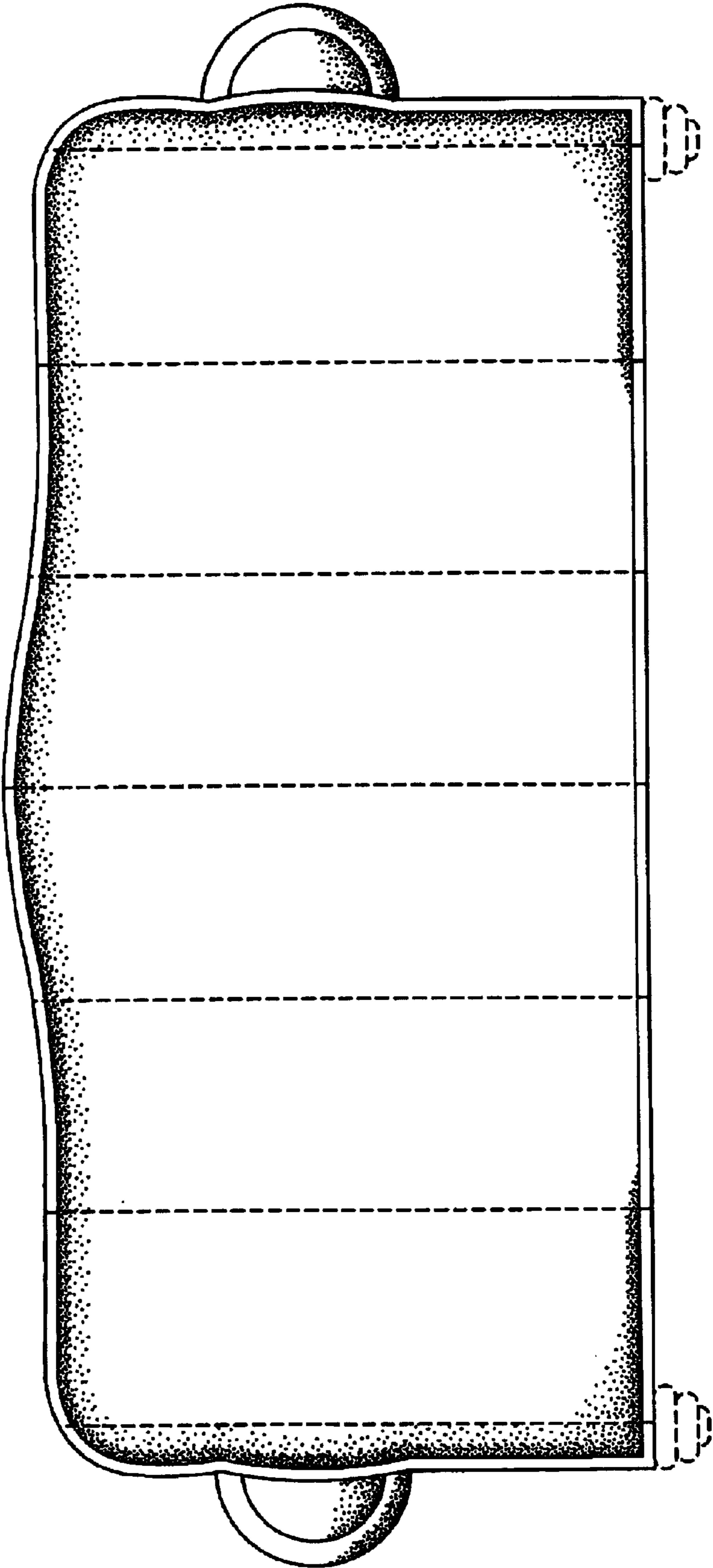
