(57) **CLAIM**

The ornamental design for a dresser, as shown and described.

**DESCRIPTION**

FIG. 1 is a left front perspective view of a first embodiment of a dresser showing my new design; FIG. 2 is a front elevational view thereof; and, FIG. 3 is a side elevational view, the opposite side being a mirror image thereof.

The views of the dresser not shown form no part of the claimed design. The broken lines depicting hardware represent environmental elements only and form no part of the claimed design.

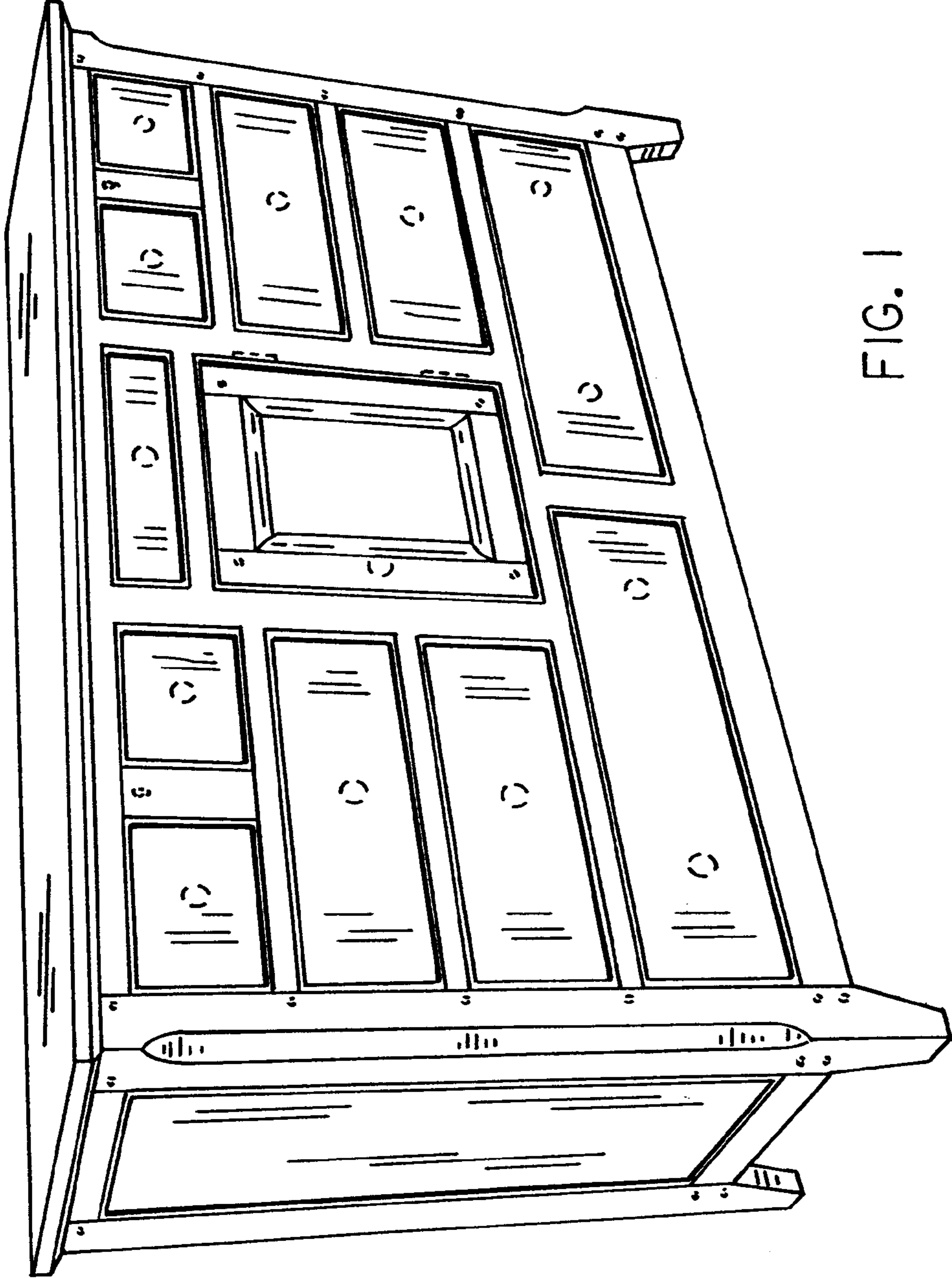

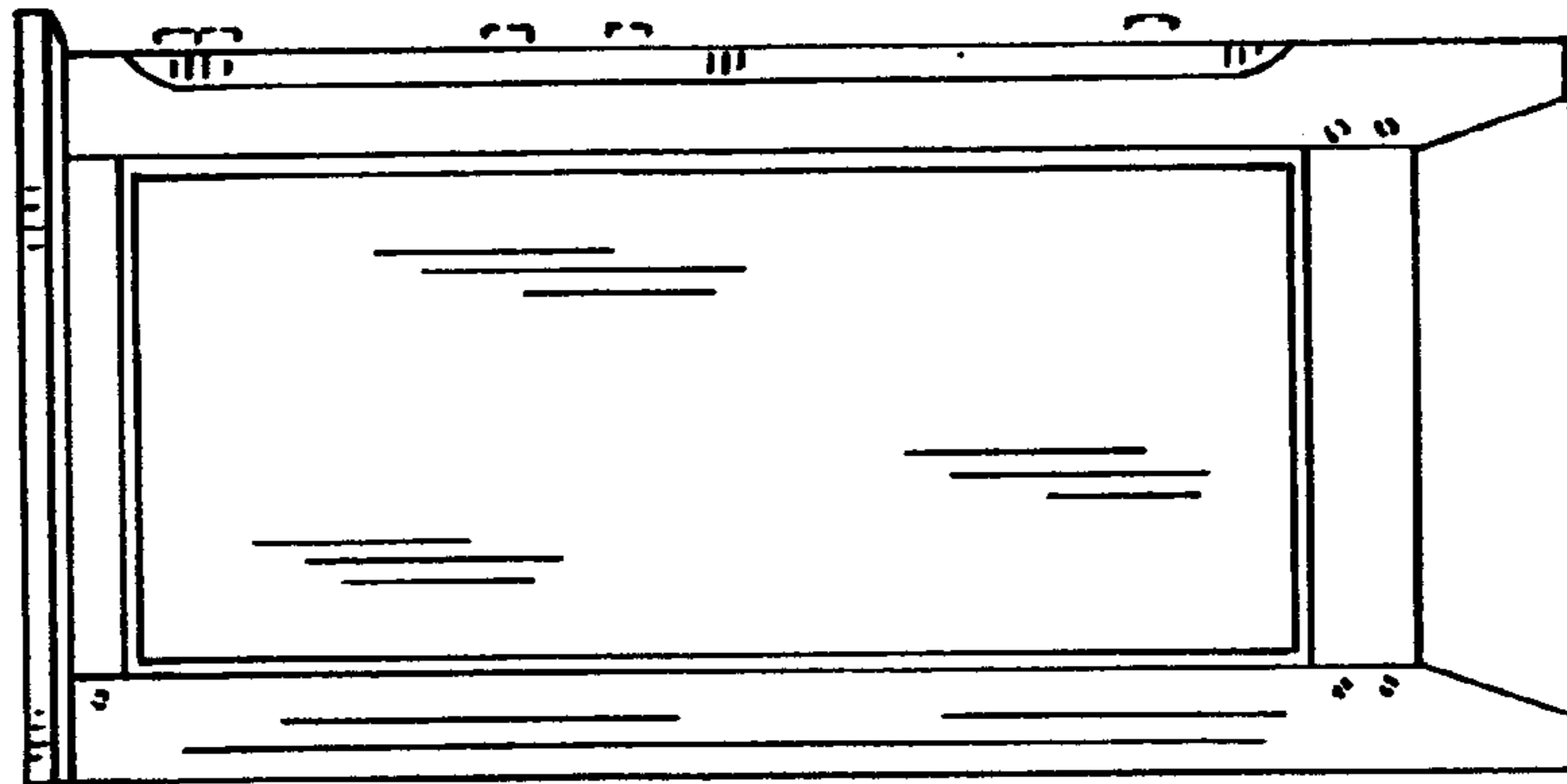

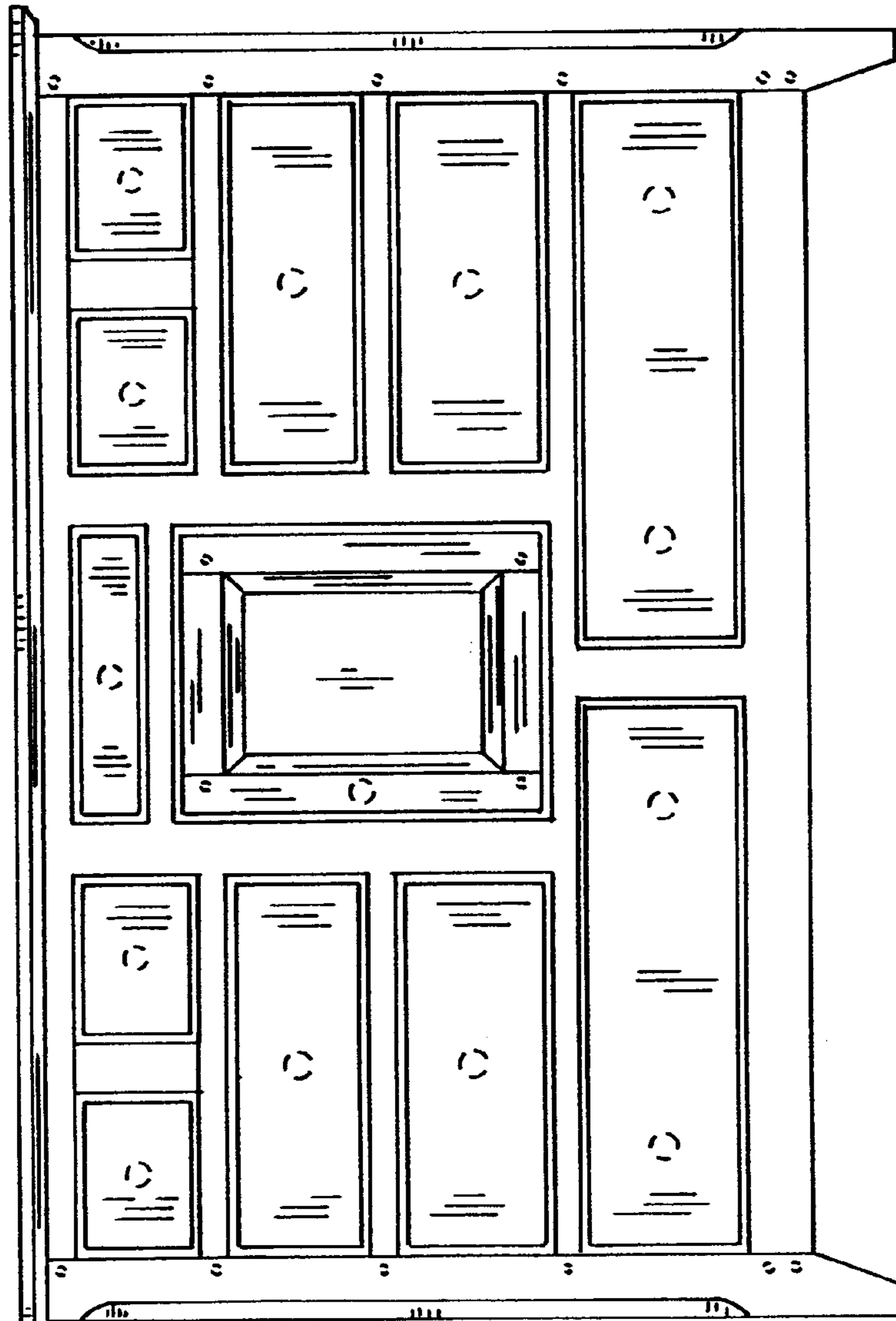
