FIG. 3 is a left side view of the same;

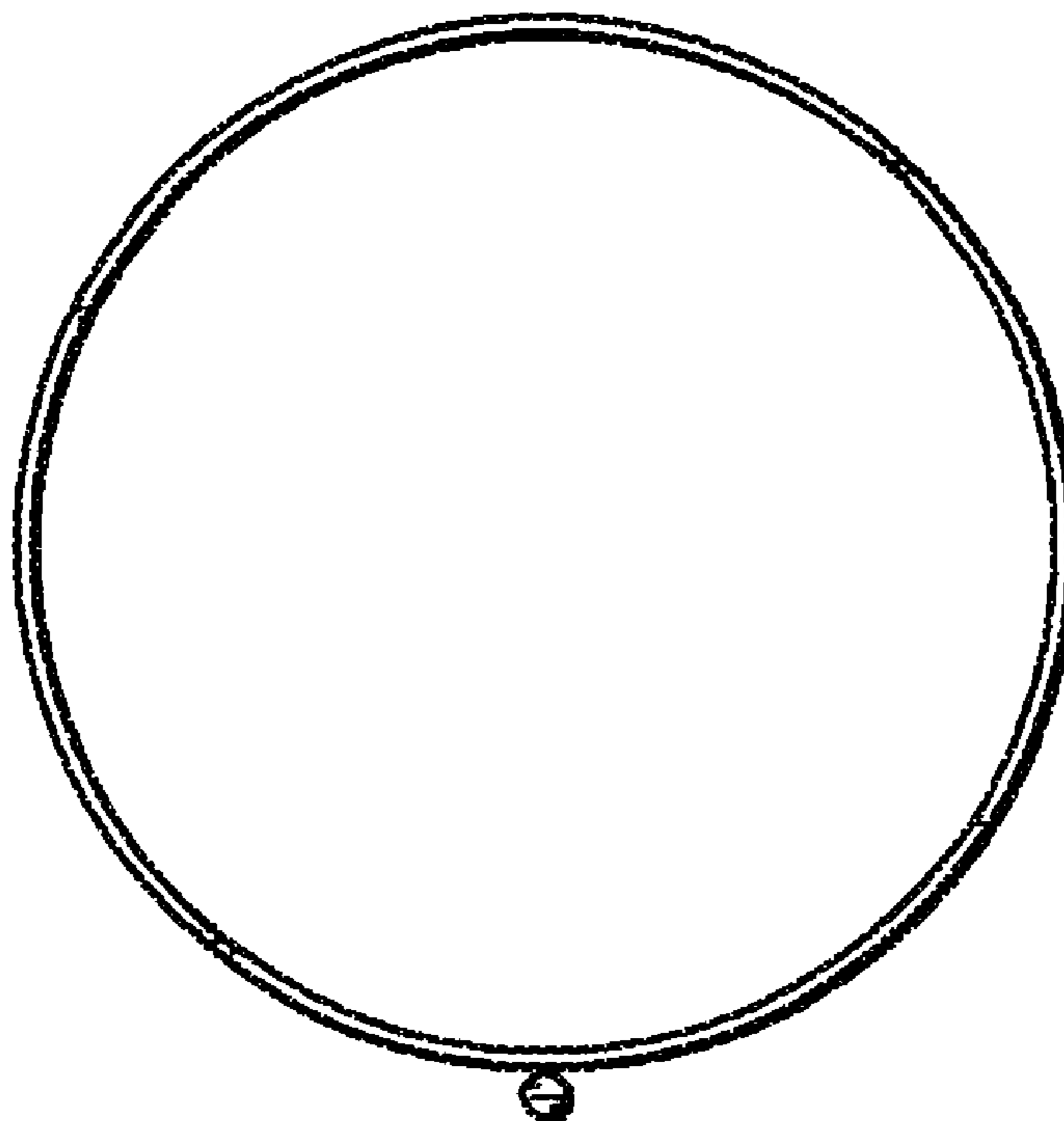
FIG. 4 is a right side view of the same;

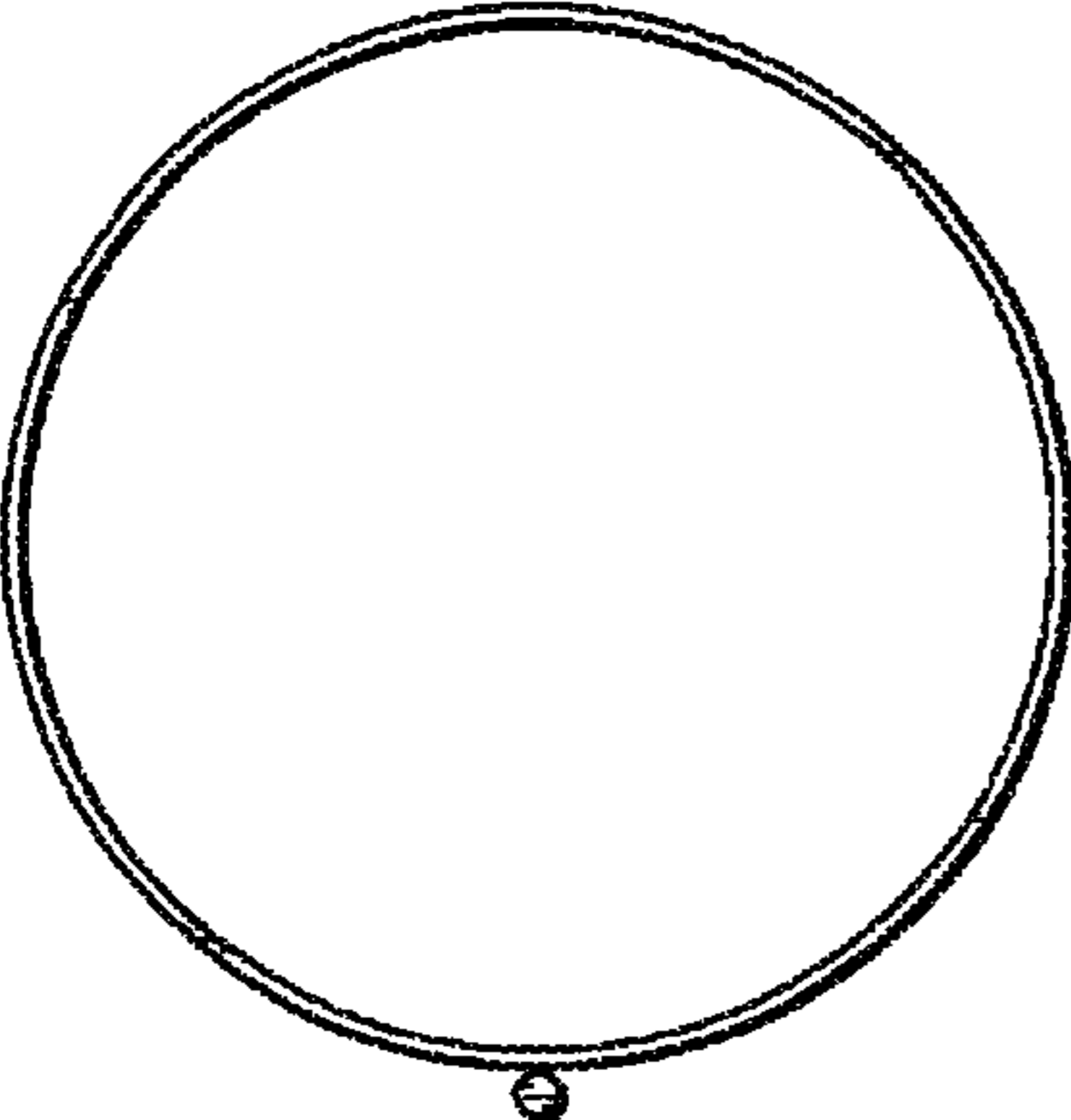
FIG. 5 is a front view of the same;

FIG. 6 is a back view of the same; and,

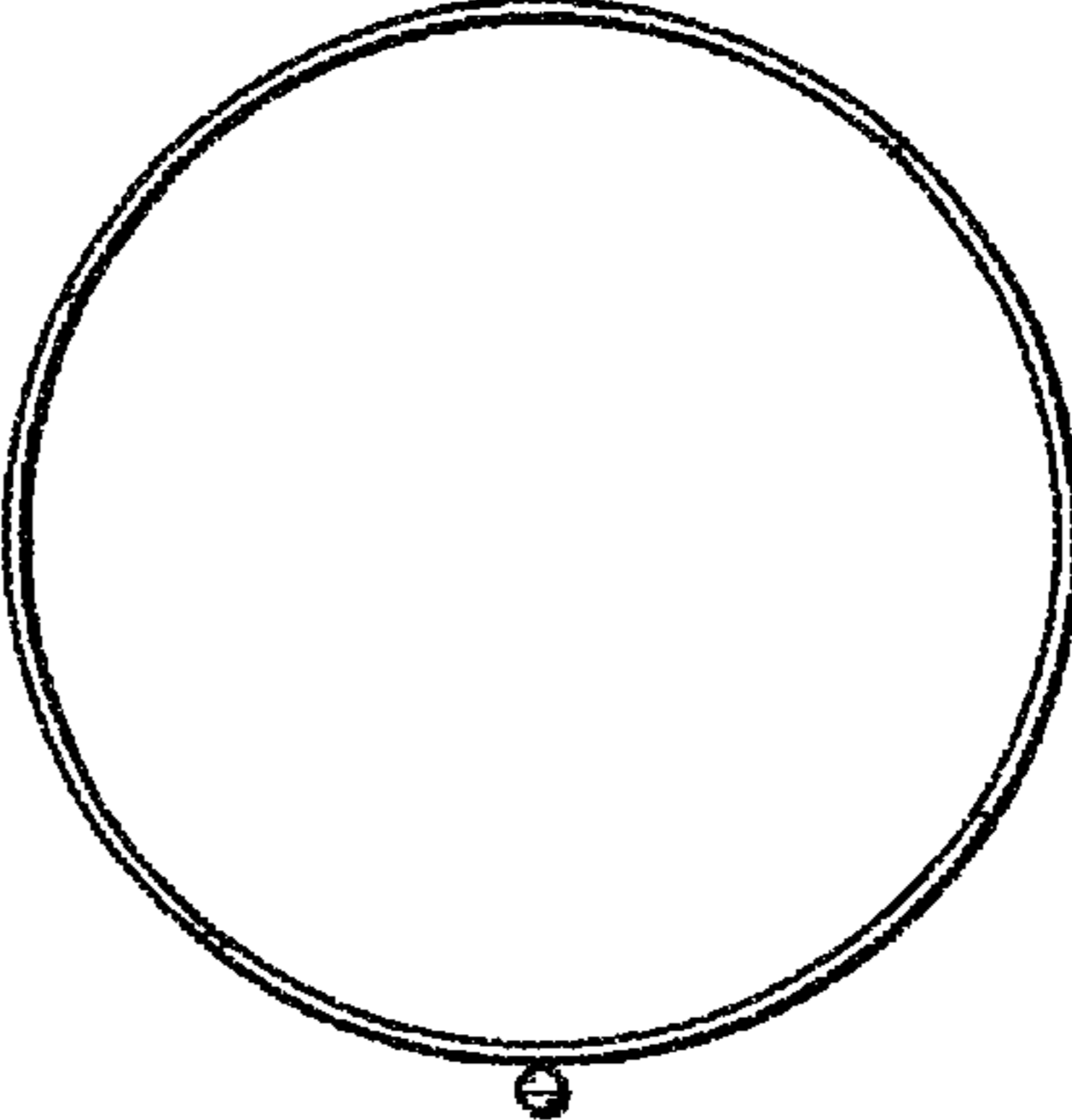
FIG. 7 is a perspective view of the same.

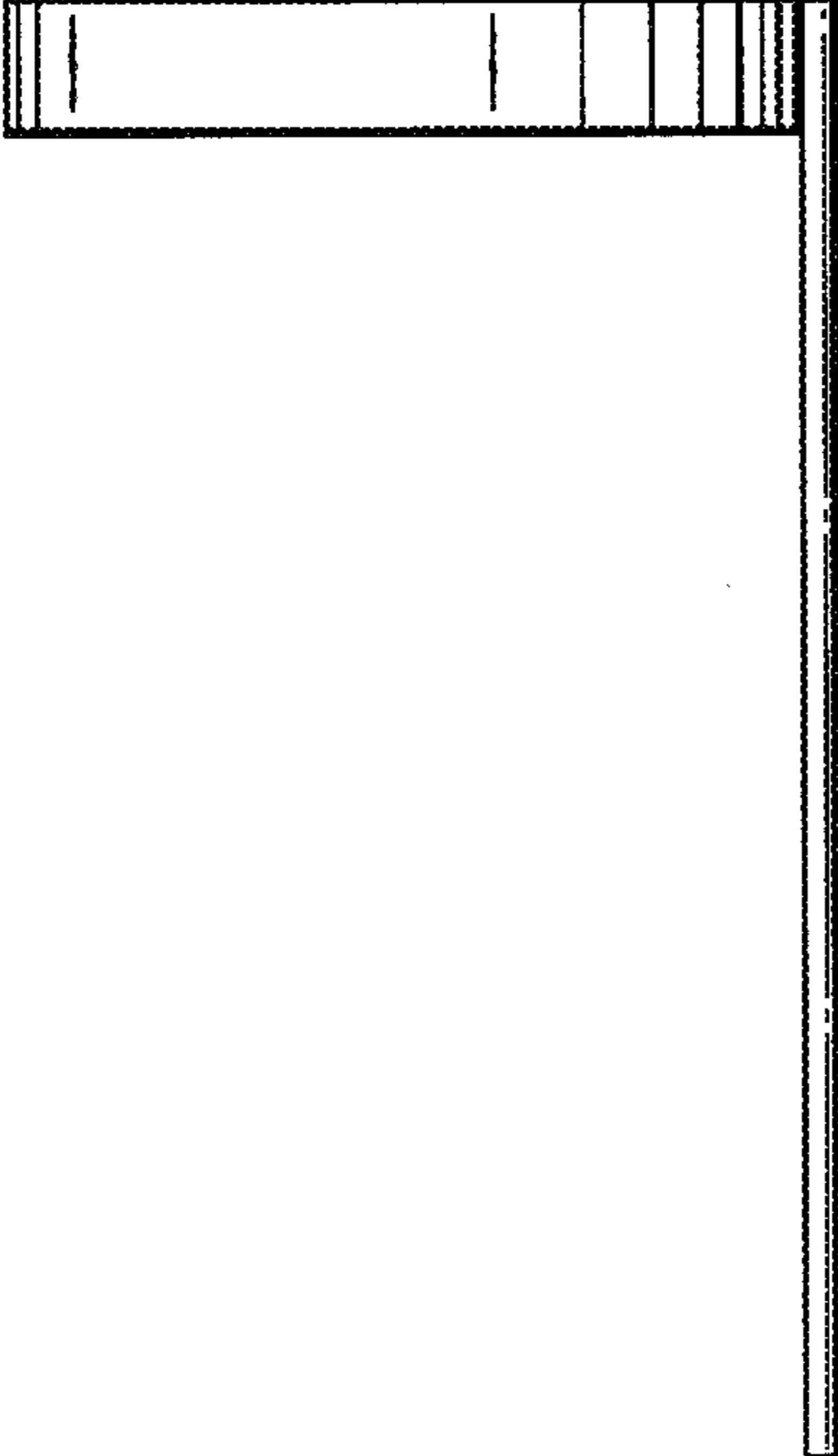




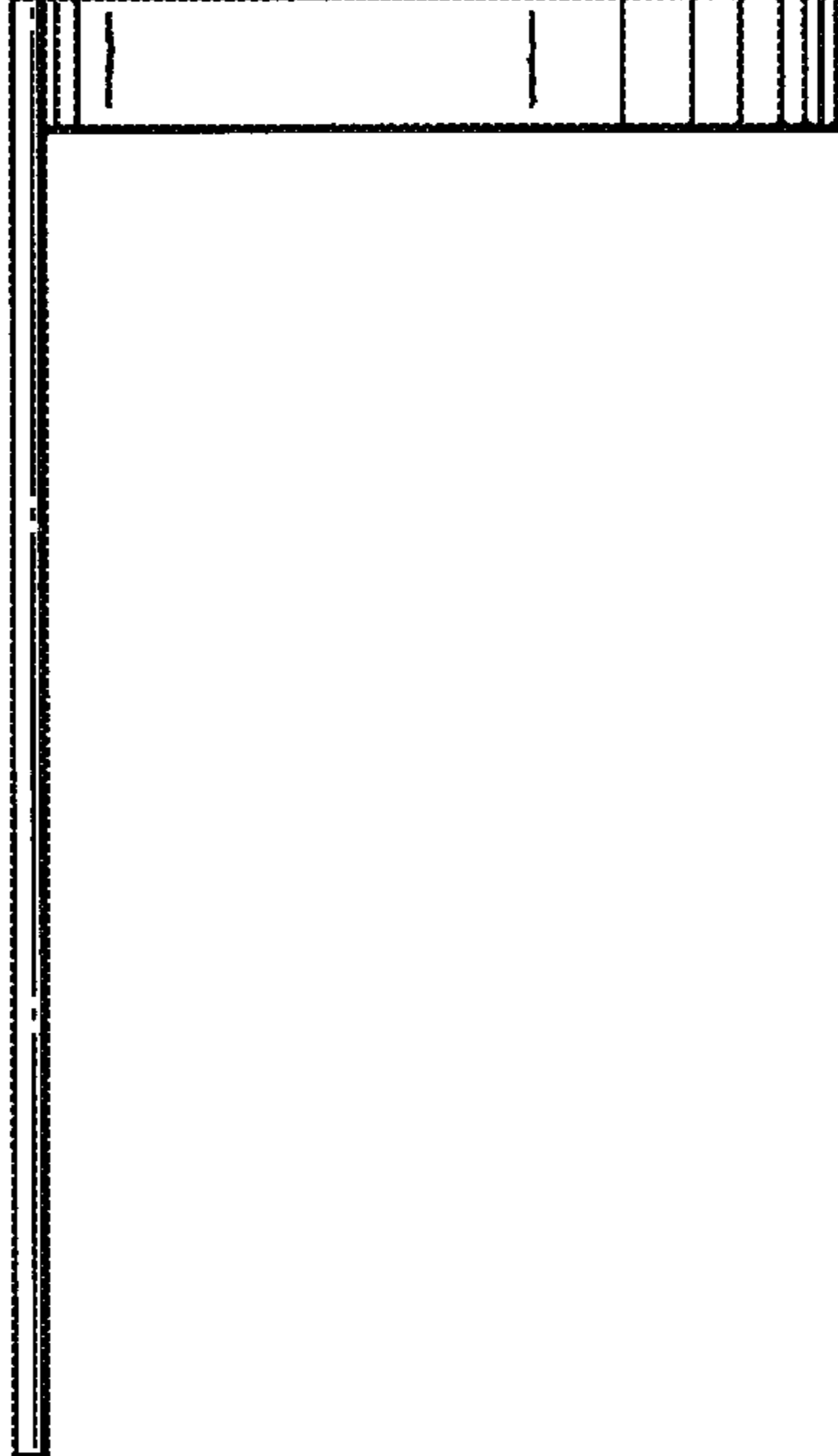

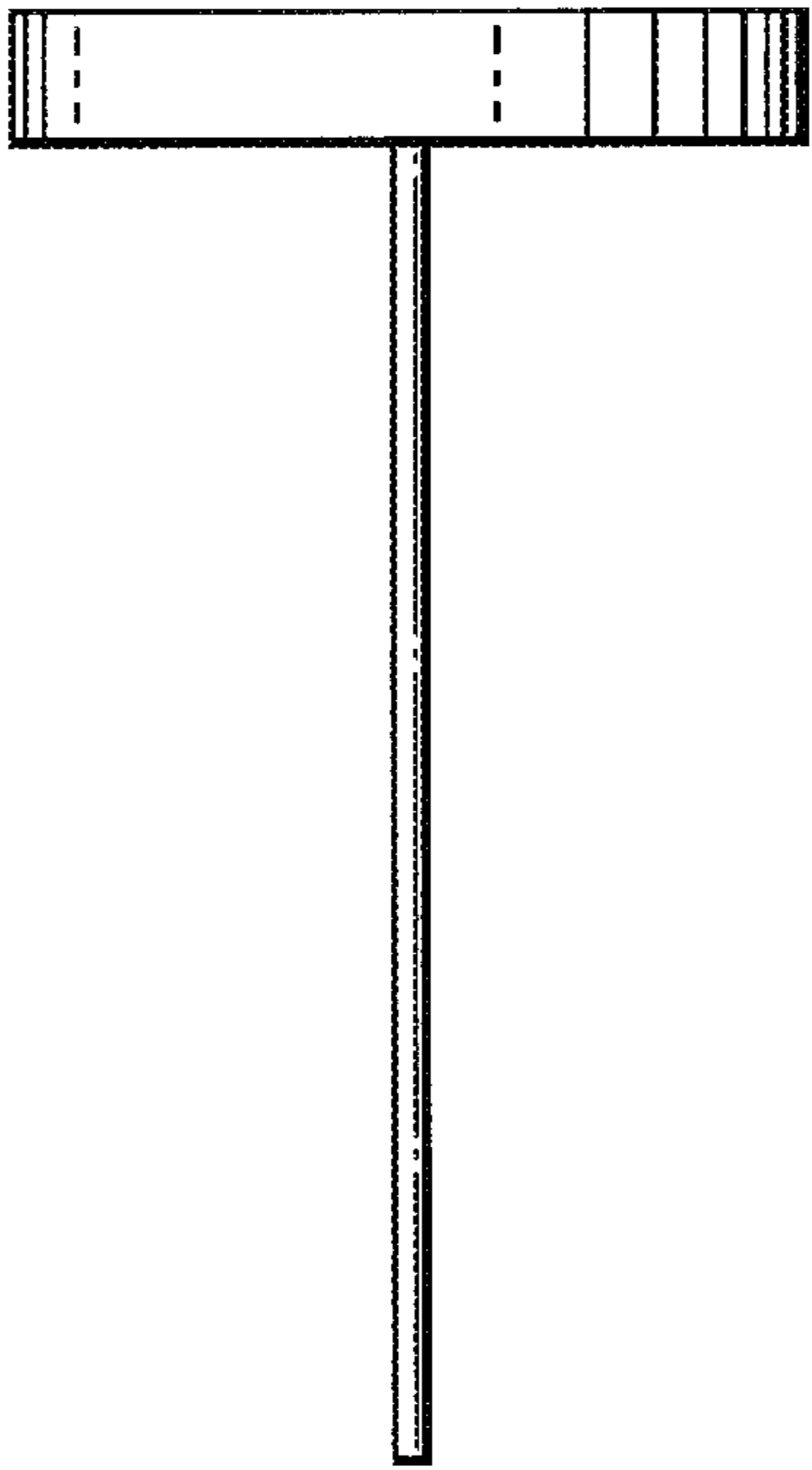

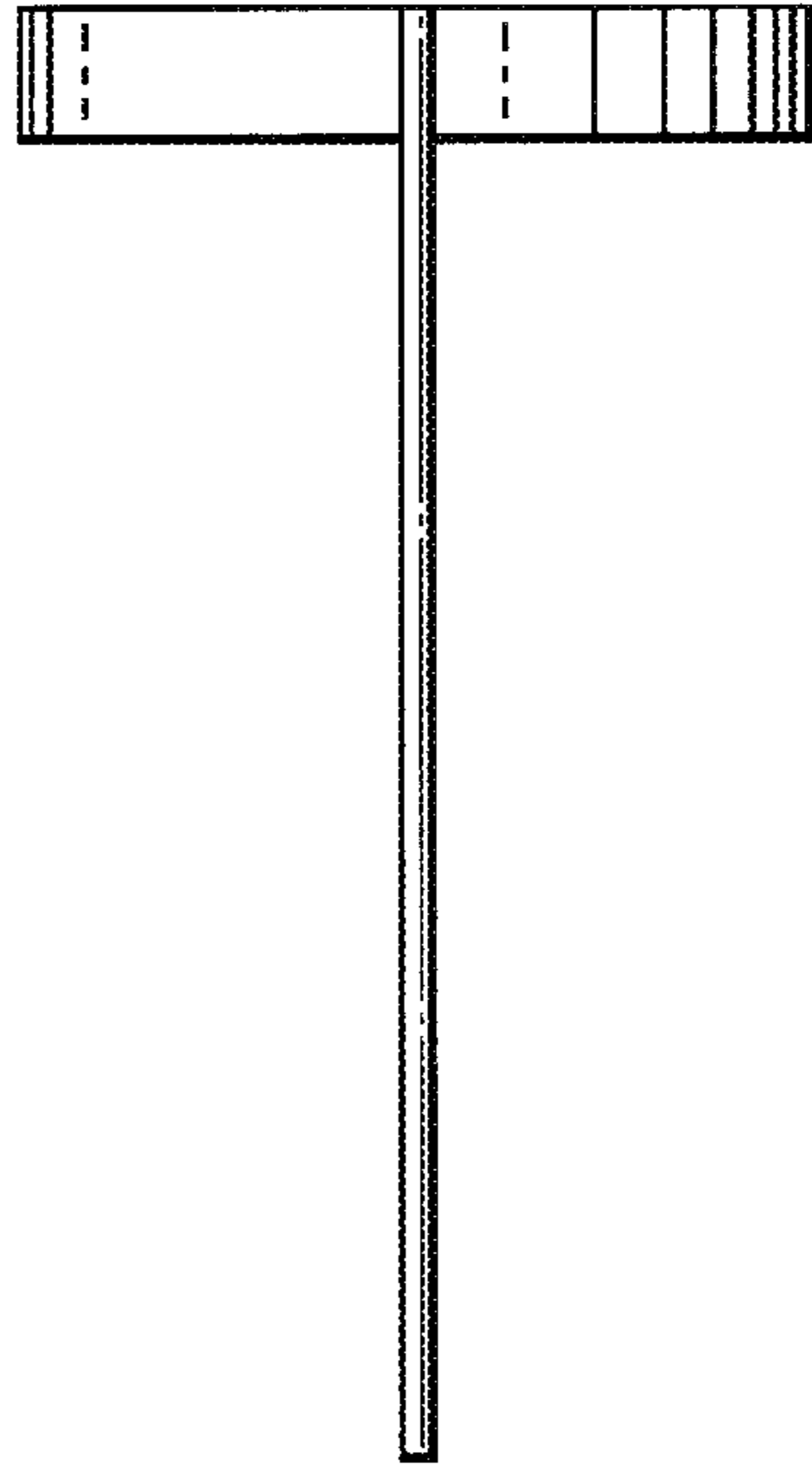

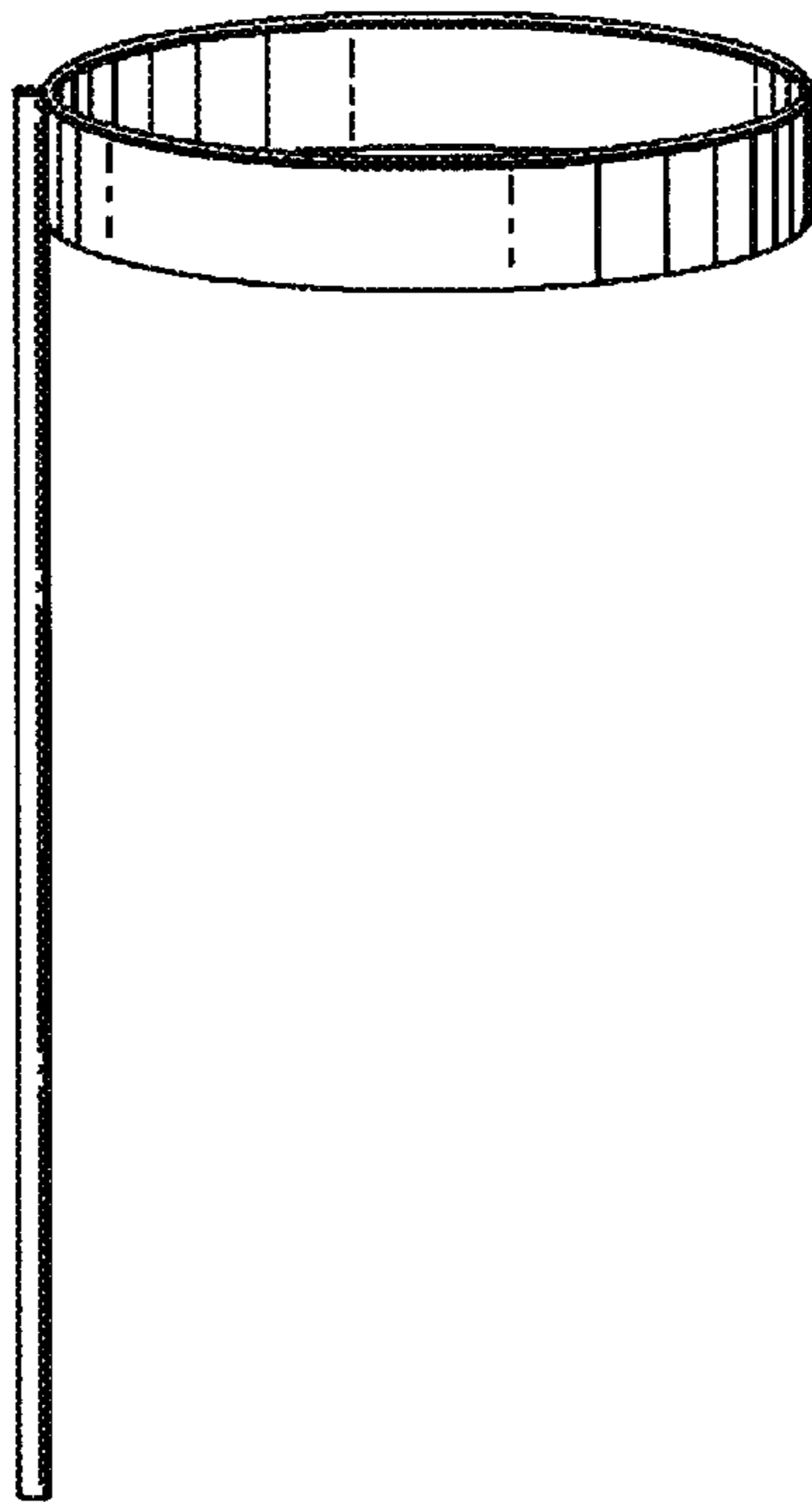
