DESCRIPTION

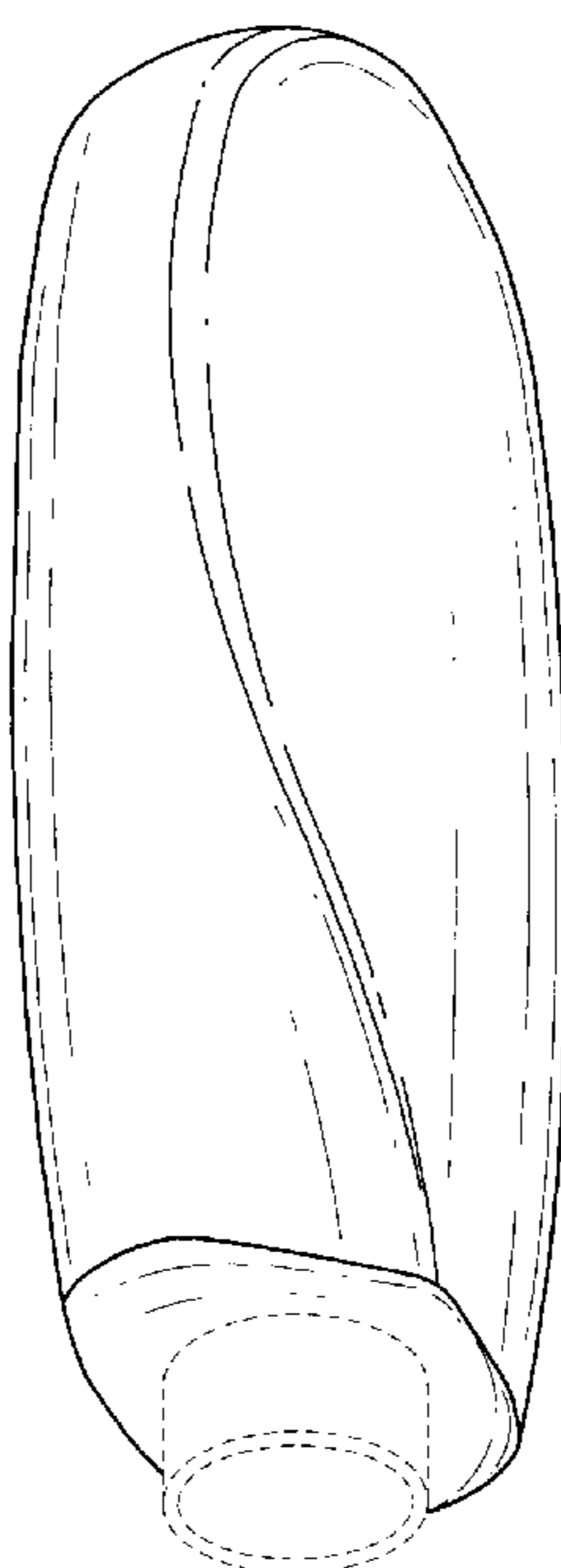
FIG. 1 is a perspective view of an inverted bottle showing our new design;

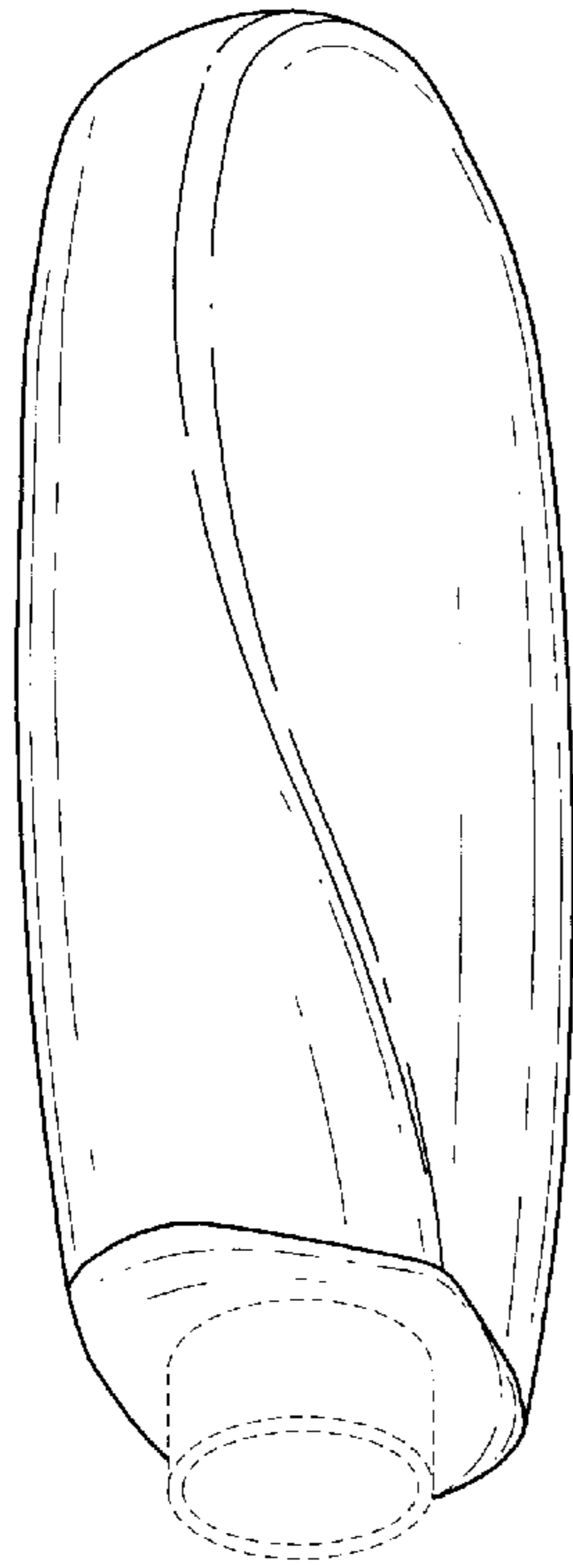

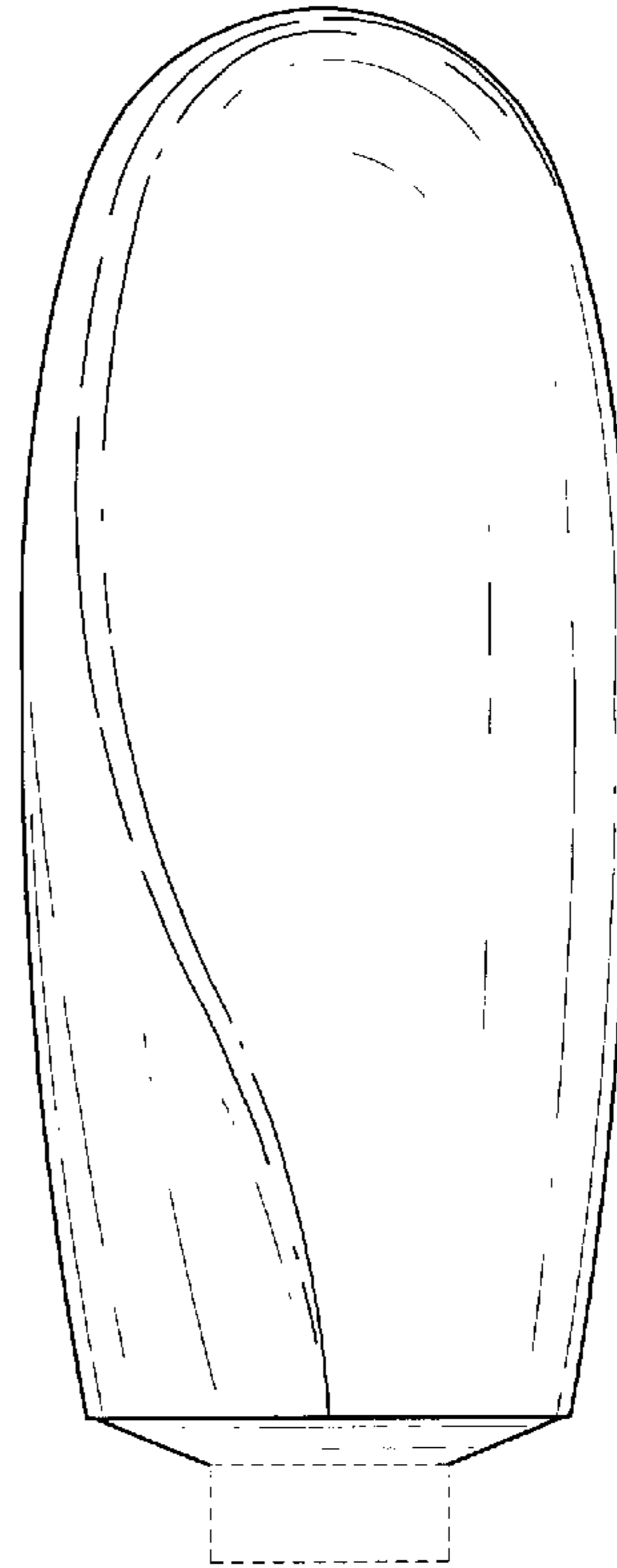

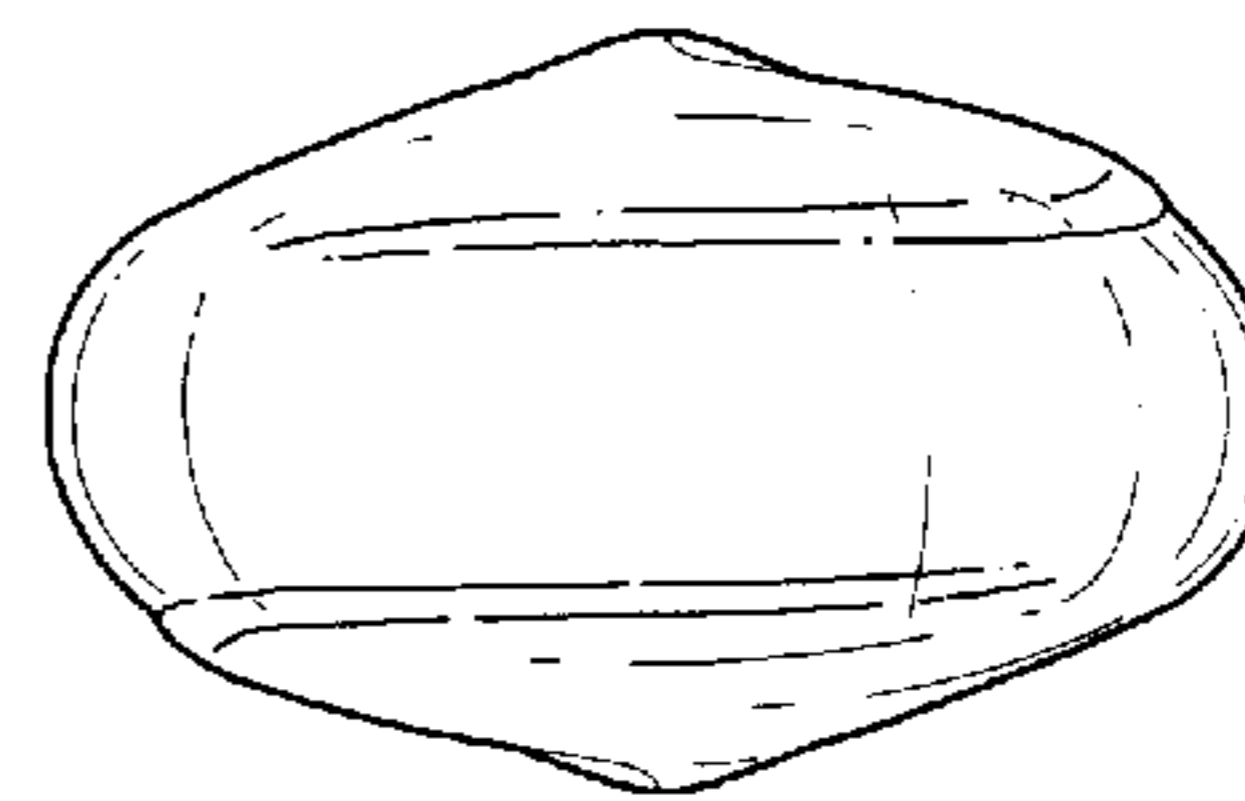

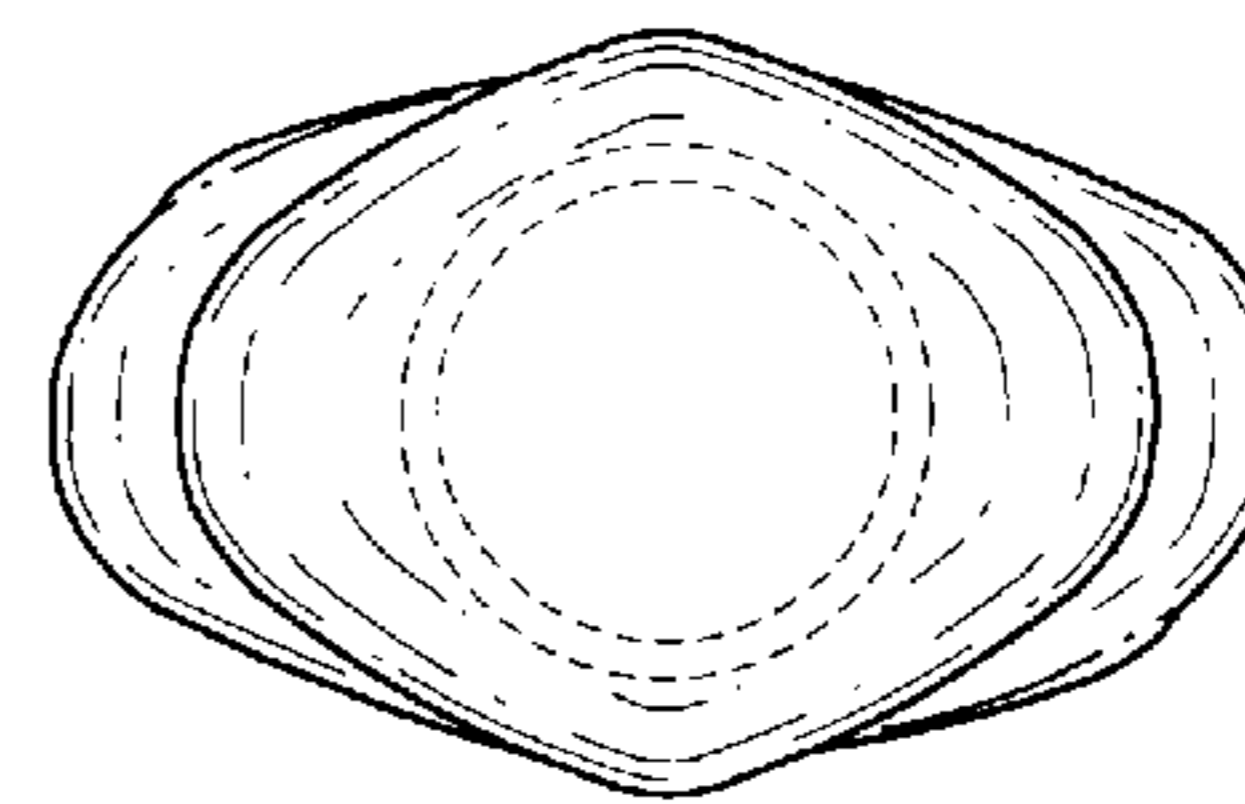
