FIG. 3 is a left side view of the bottle of FIG. 1;

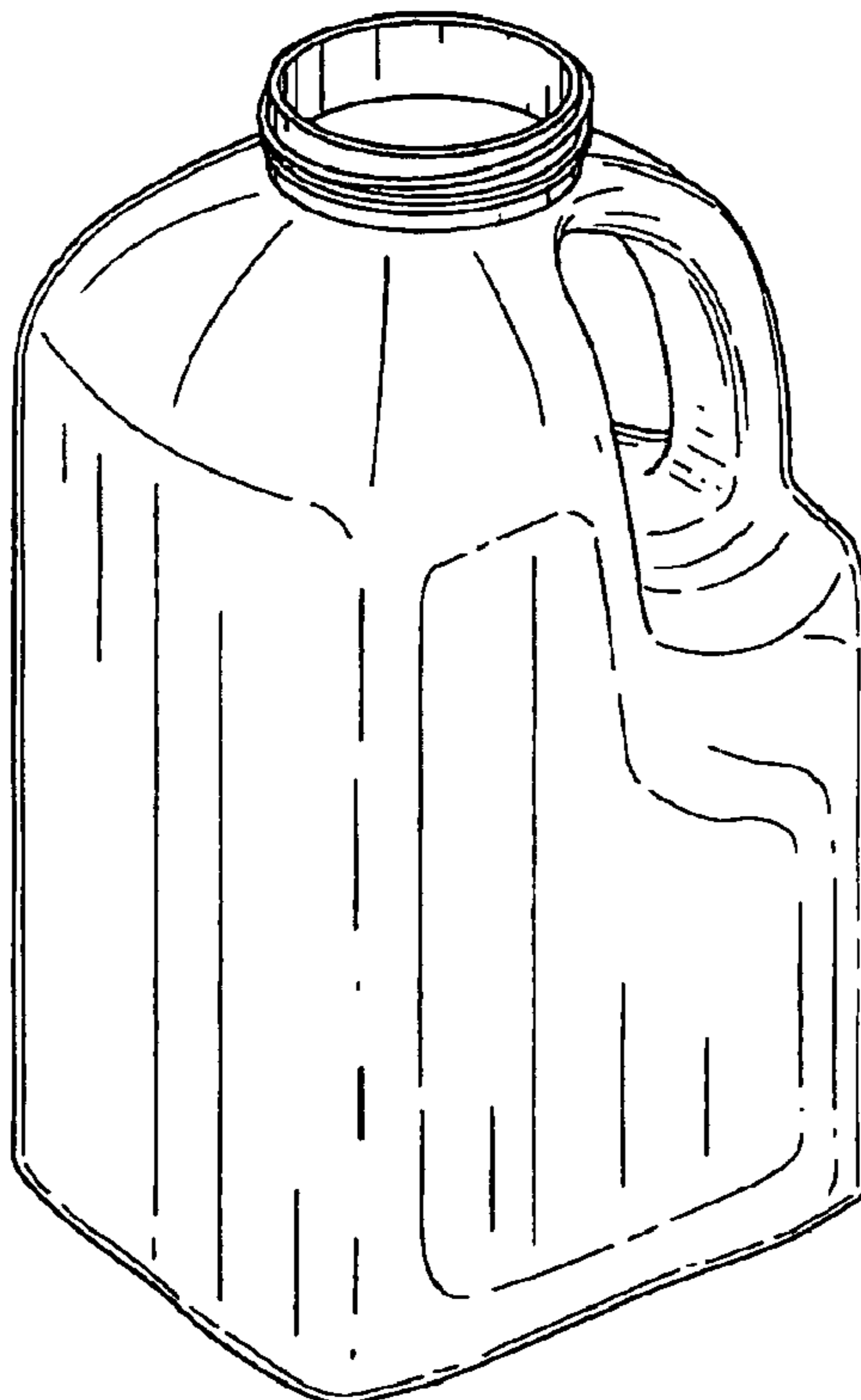
FIG. 4 is a back view of the bottle of FIG. 1;

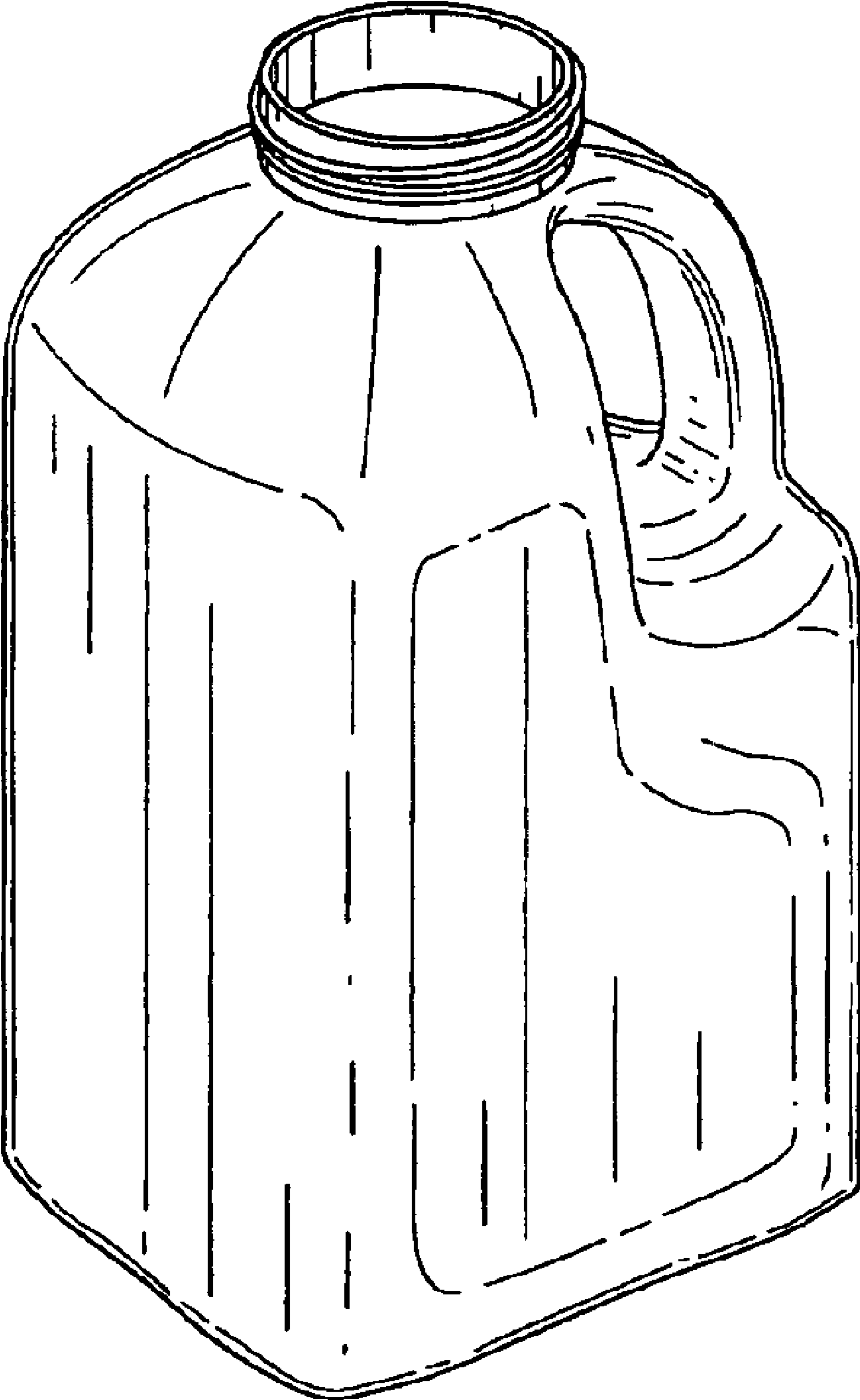

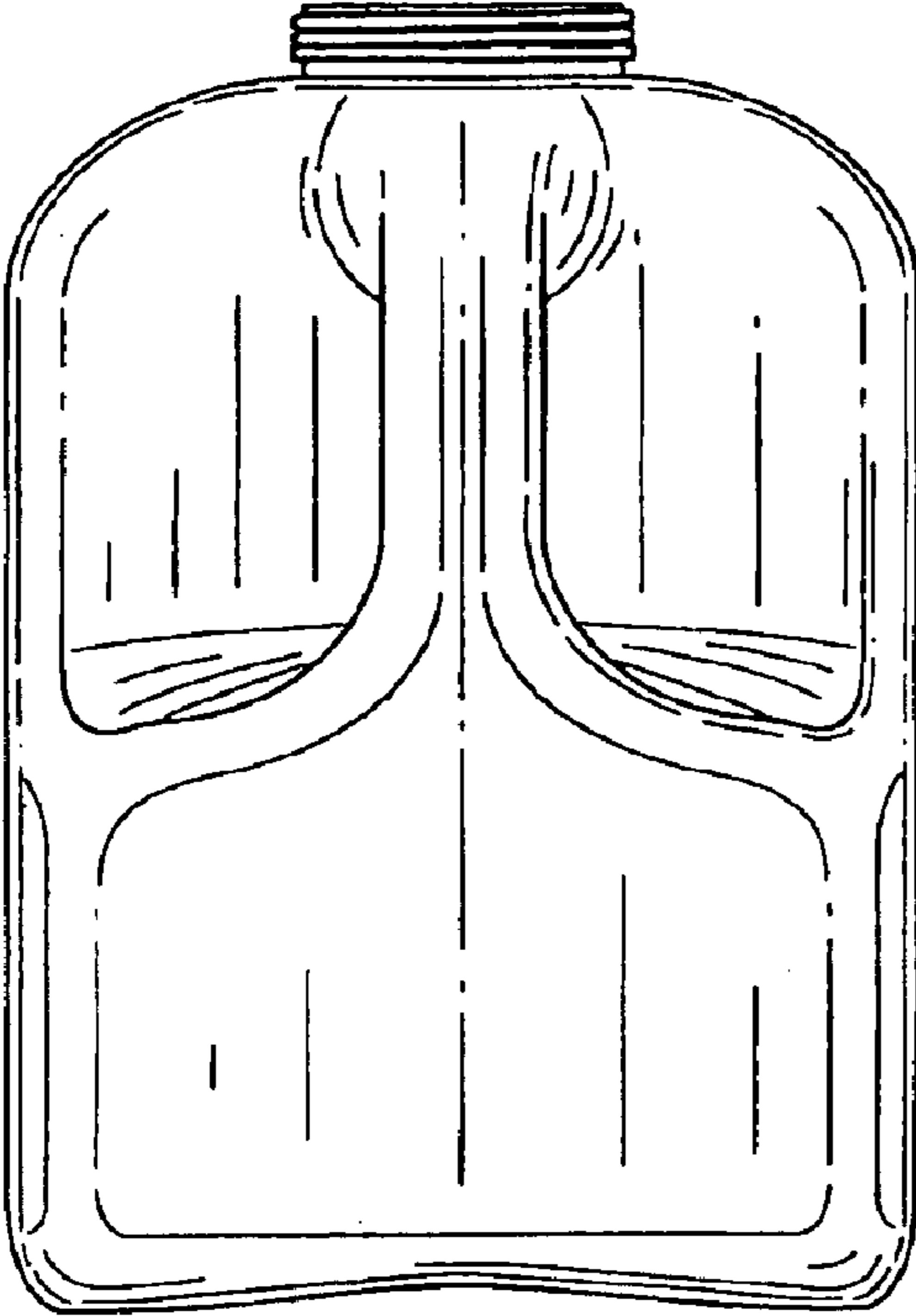

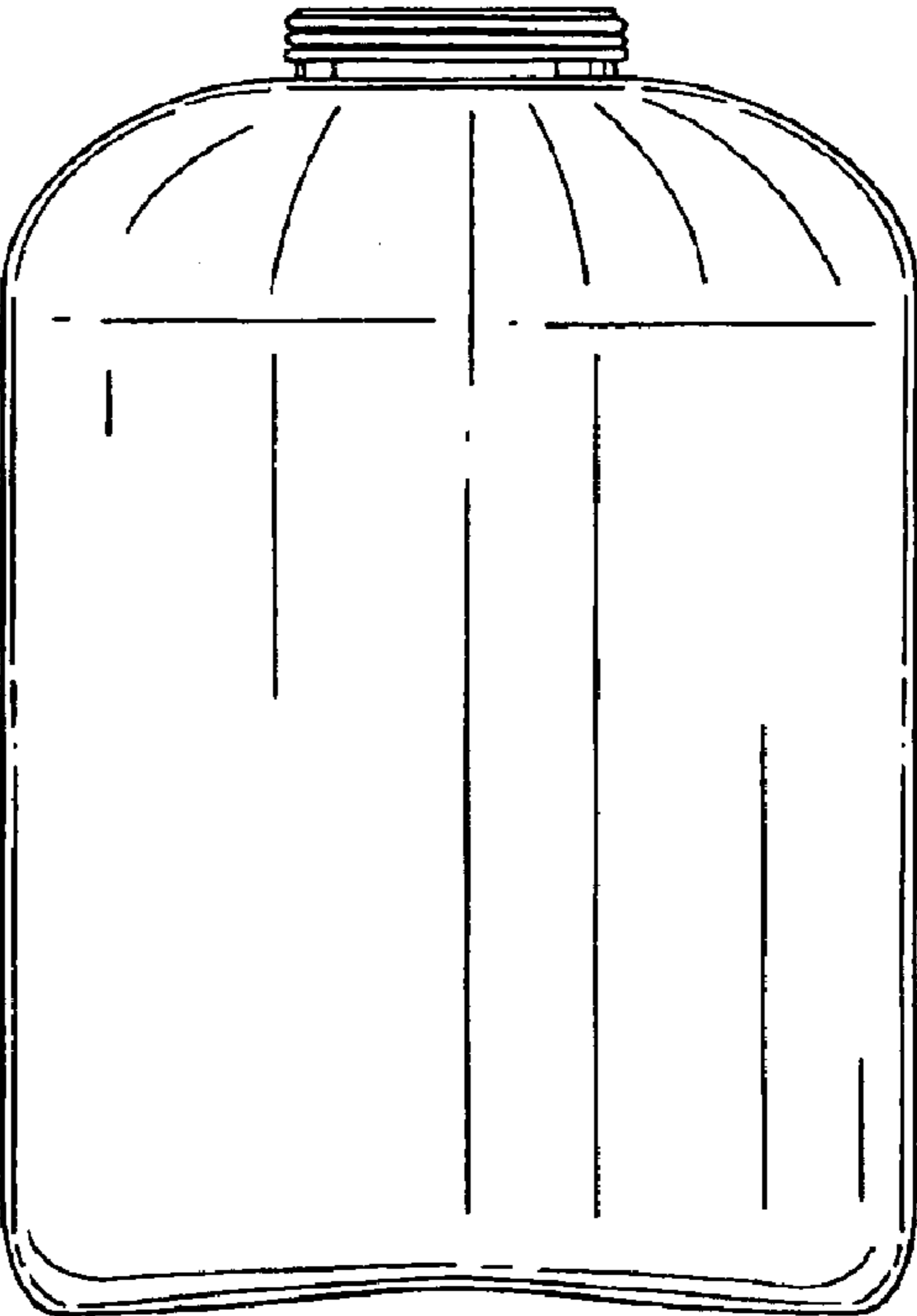

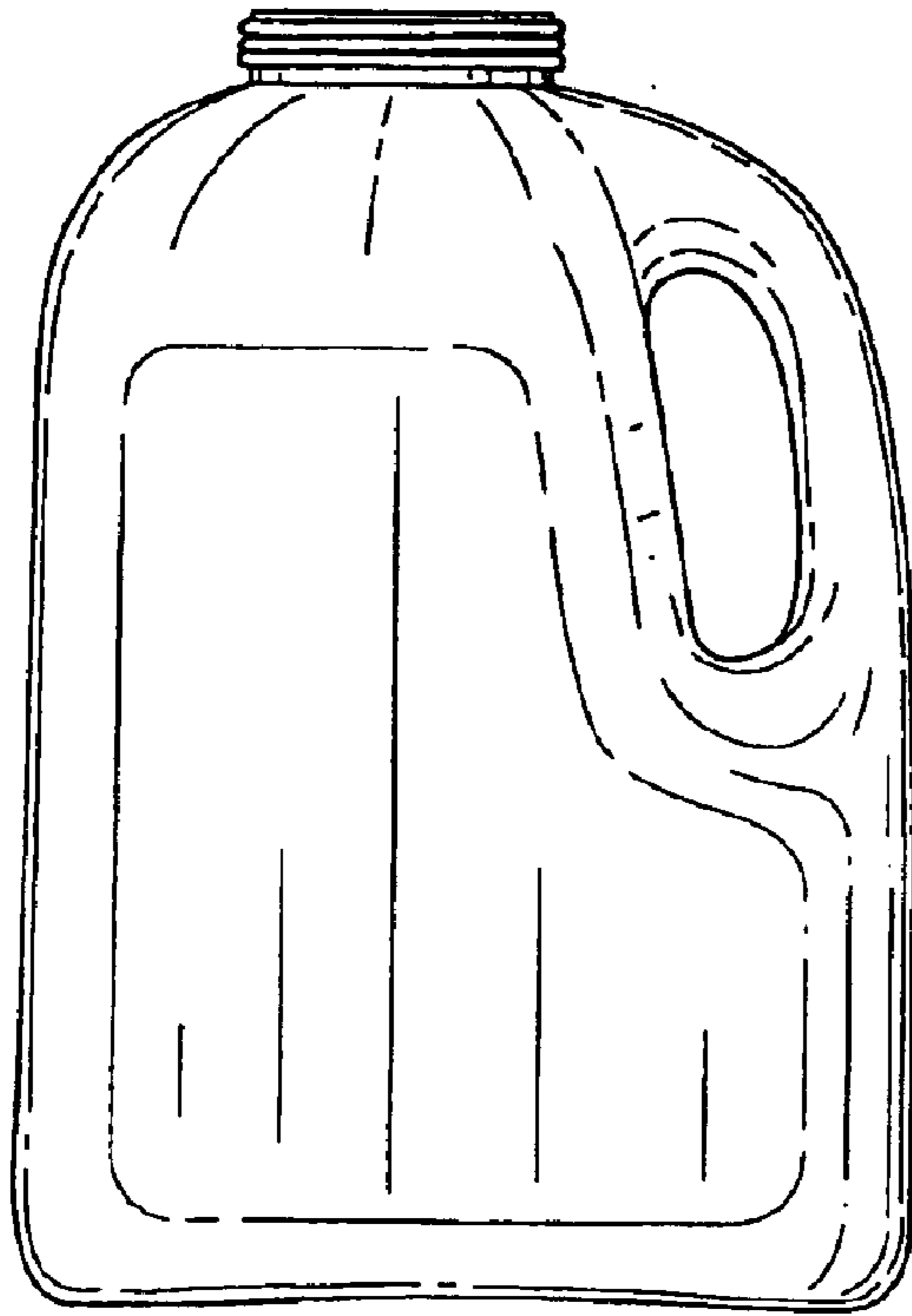

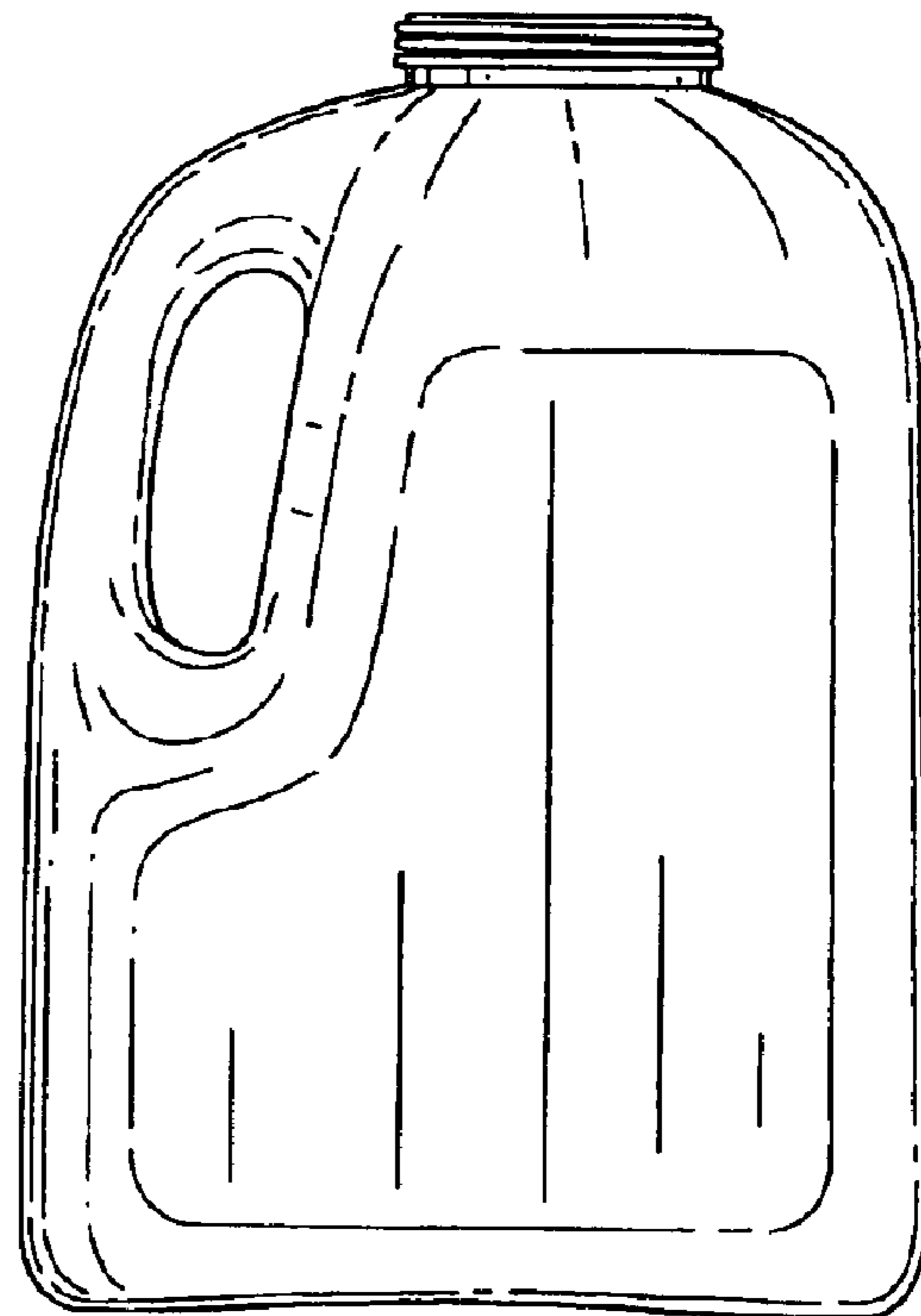

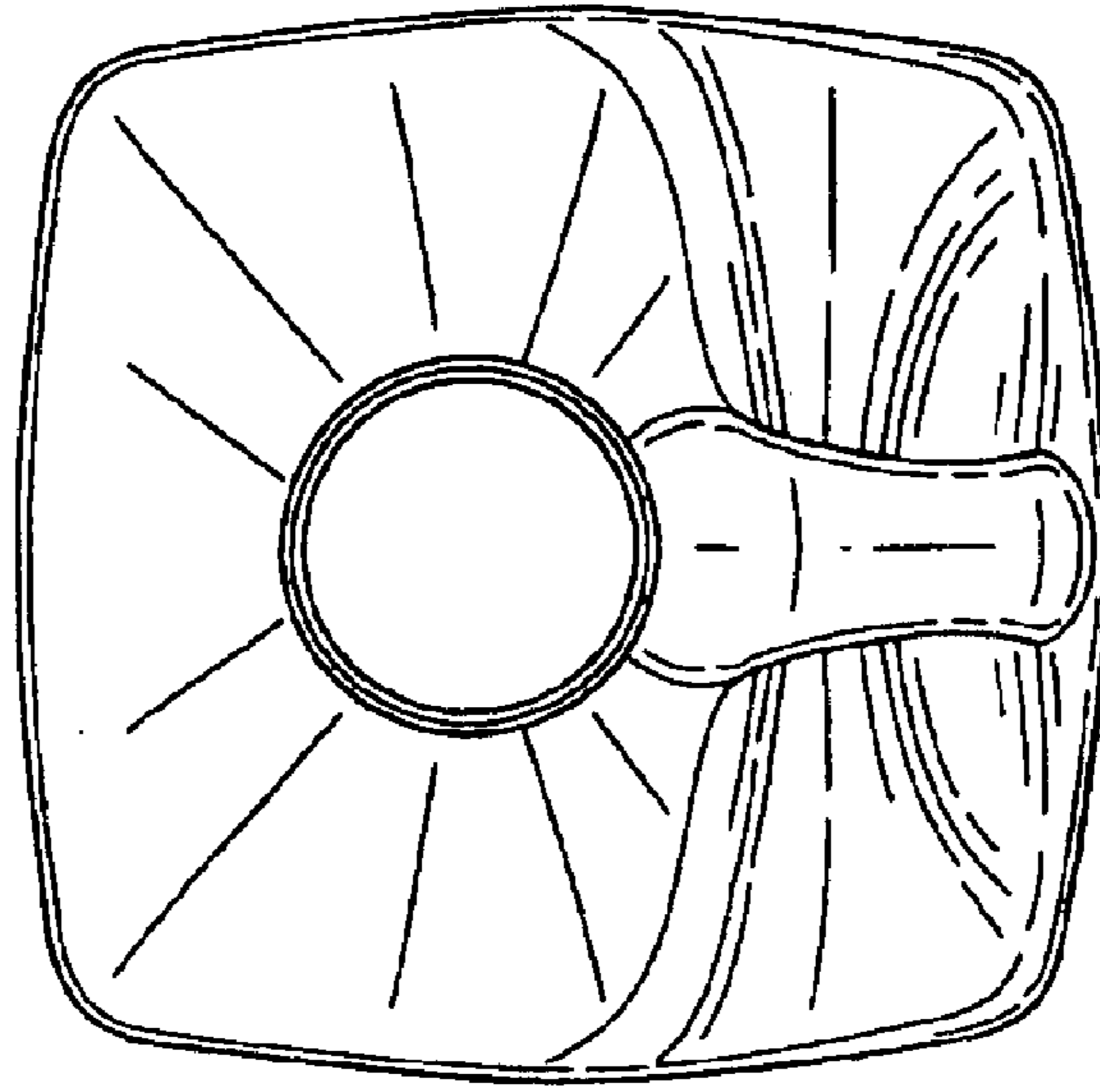

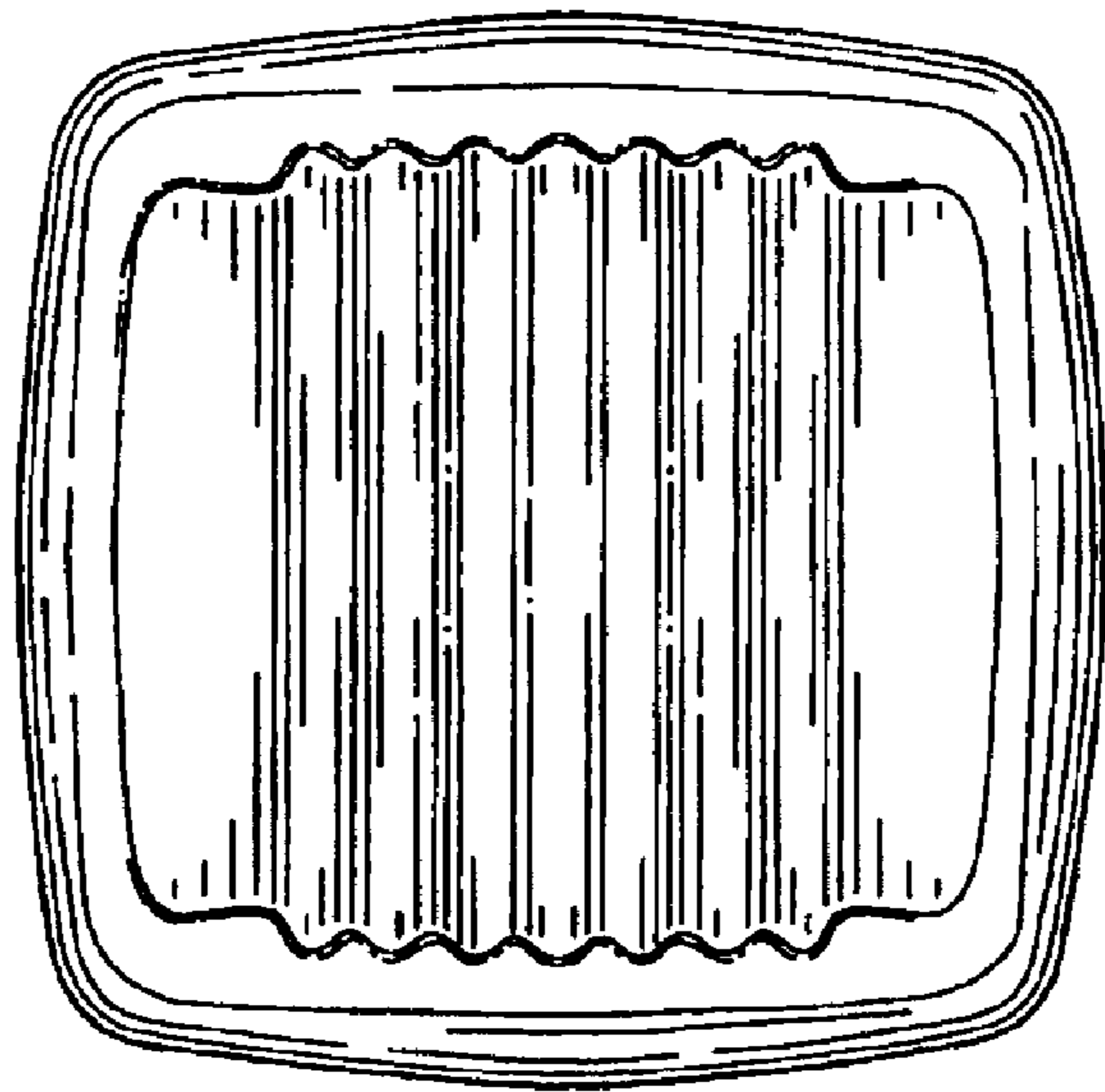
