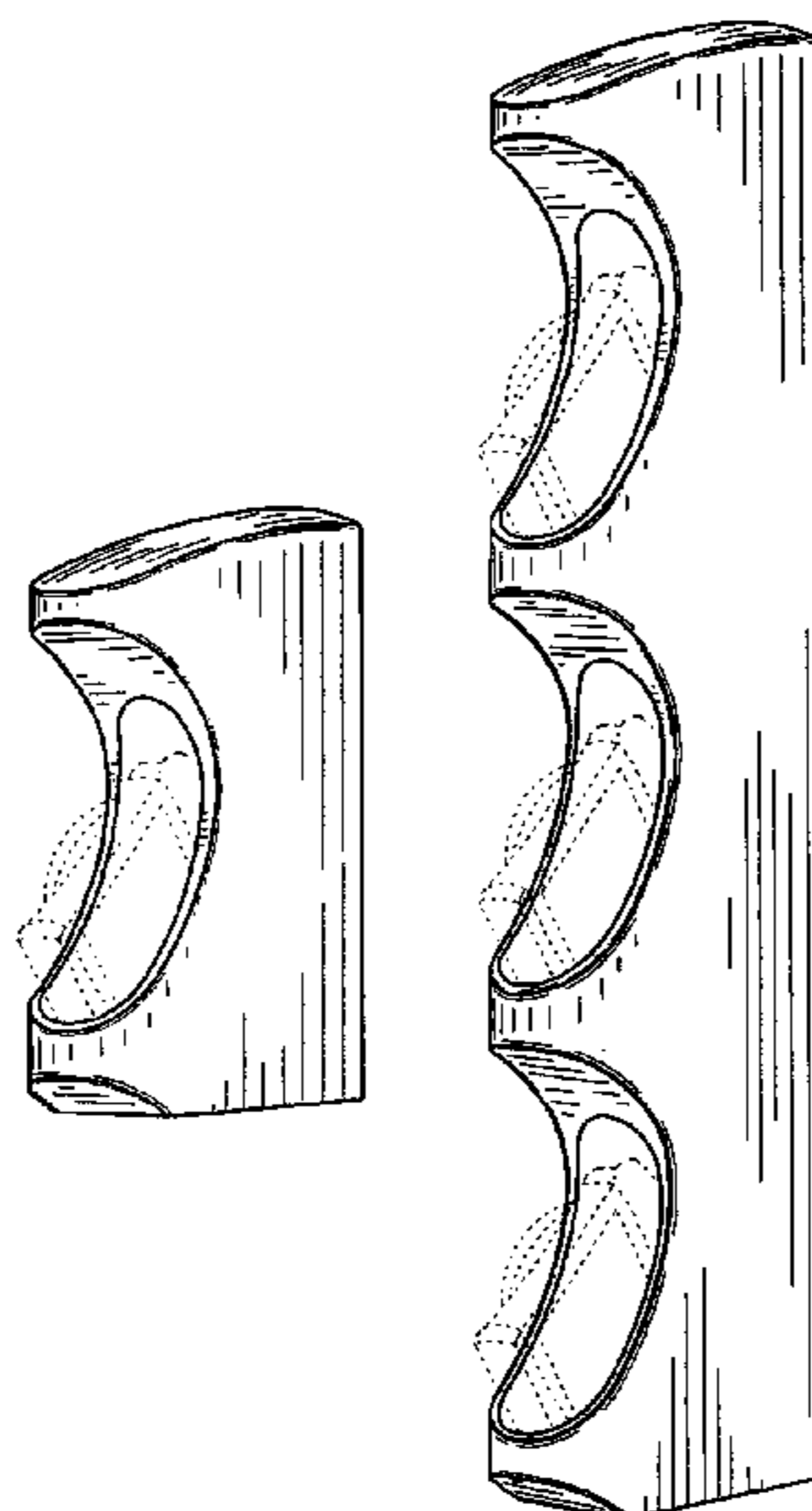
(57) **CLAIM**

The ornamental design for charging cradle, as shown and described.

**DESCRIPTION**

FIG. 1 is perspective view of the top, front and right side of a charging cradle showing our new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a back view thereof;  
FIG. 4 is a right side view thereof, the left side view being a mirror image;  
FIG. 5 is a top view thereof;  
FIG. 6 is a bottom view thereof;  
FIG. 7 is a perspective view of a second embodiment of our new design;  
FIG. 8 is a front view thereof;  
FIG. 9 is a back view thereof;  
FIG. 10 is a right side view thereof, the left side view being a mirror image;  
FIG. 11 is a top view thereof;  
FIG. 12 is a bottom view thereof;  
FIG. 13 is a perspective view of a third embodiment of our new design;  
FIG. 14 is a perspective view of a fourth embodiment of our new design;  
FIG. 15 is a front view thereof;  
FIG. 16 is a back view thereof;  
FIG. 17 is a right side view thereof, the left side being a mirror image;  
FIG. 18 is a top view thereof; and,  
FIG. 19 is a bottom view thereof.

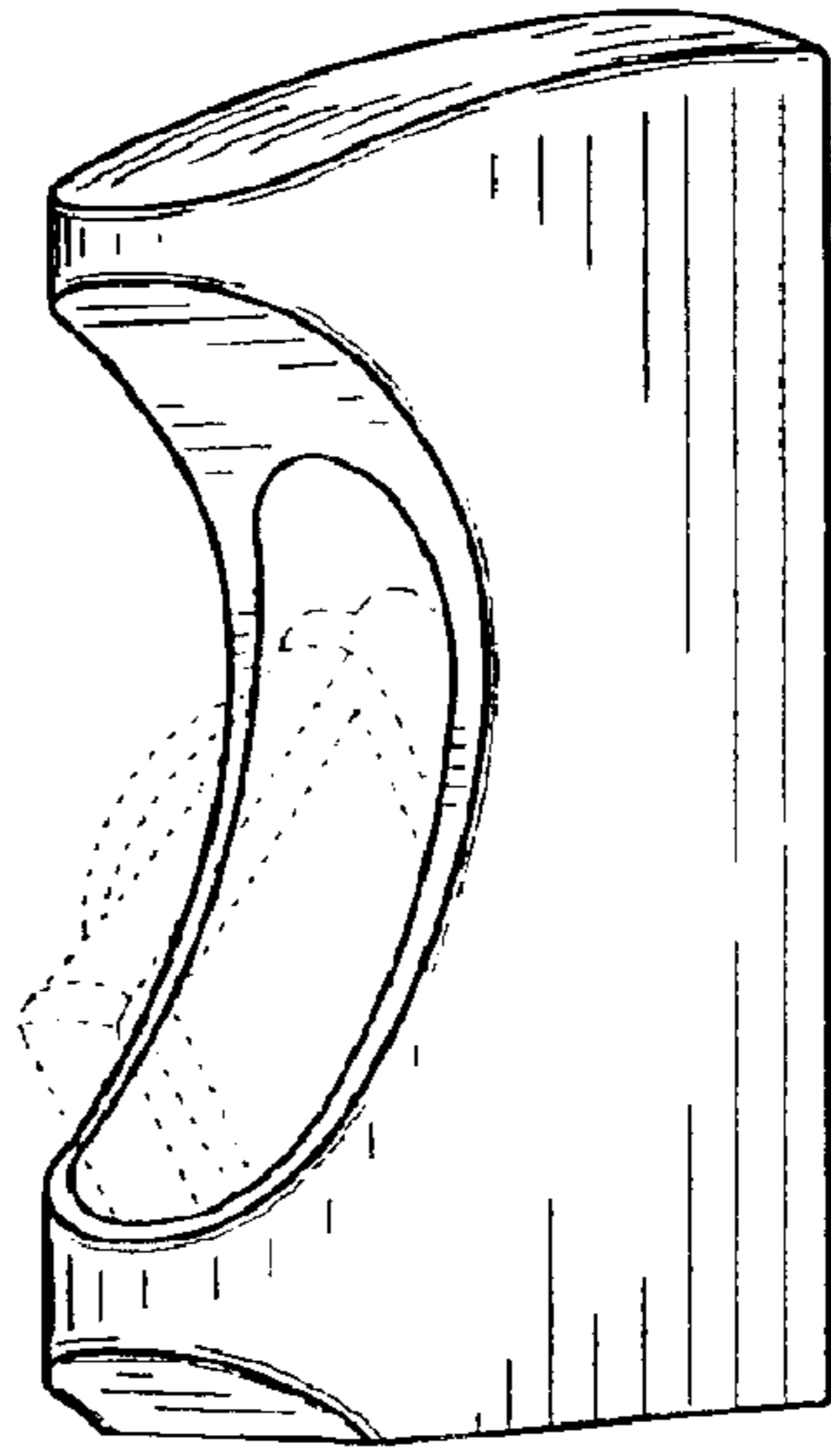

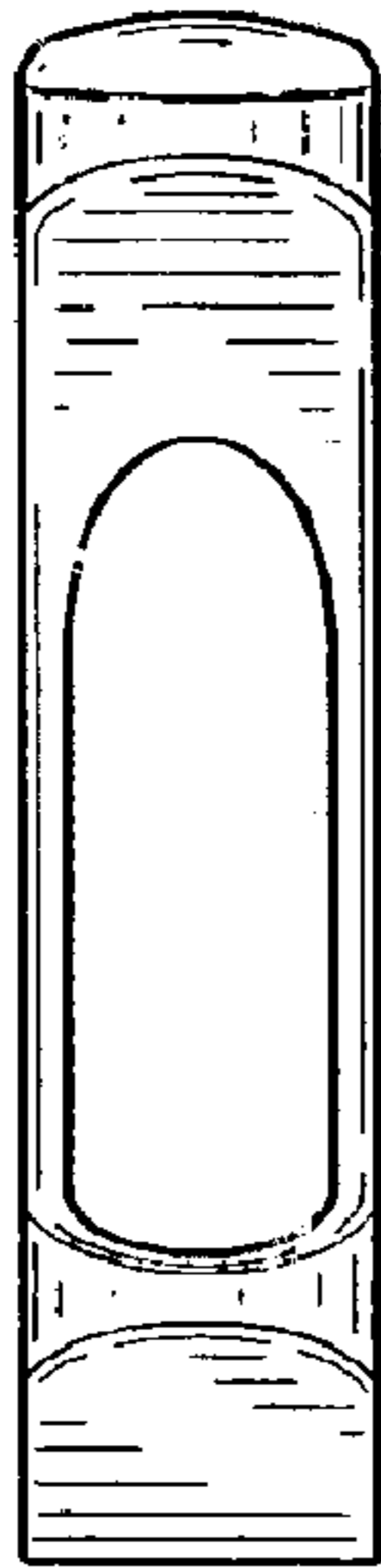

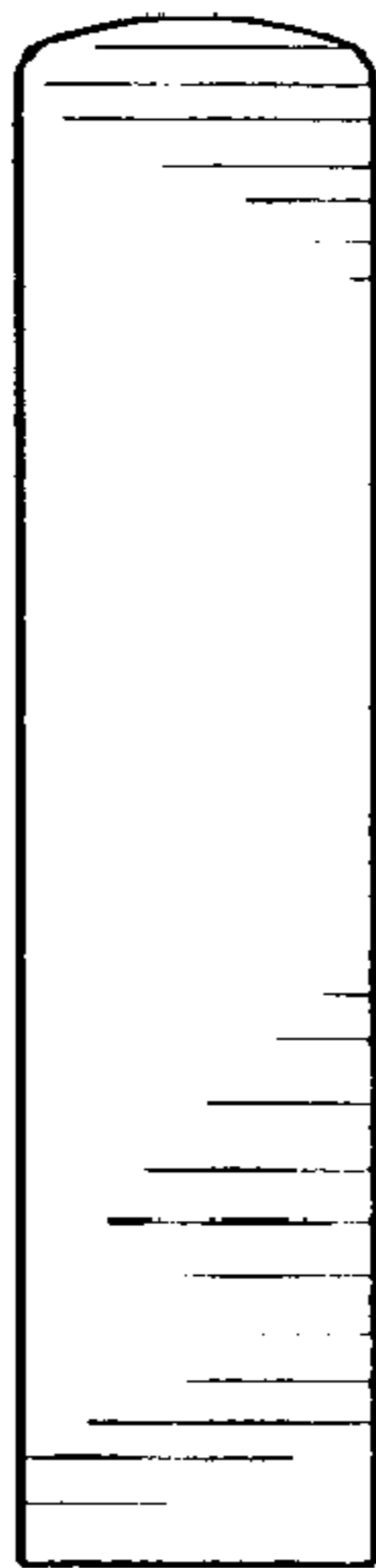

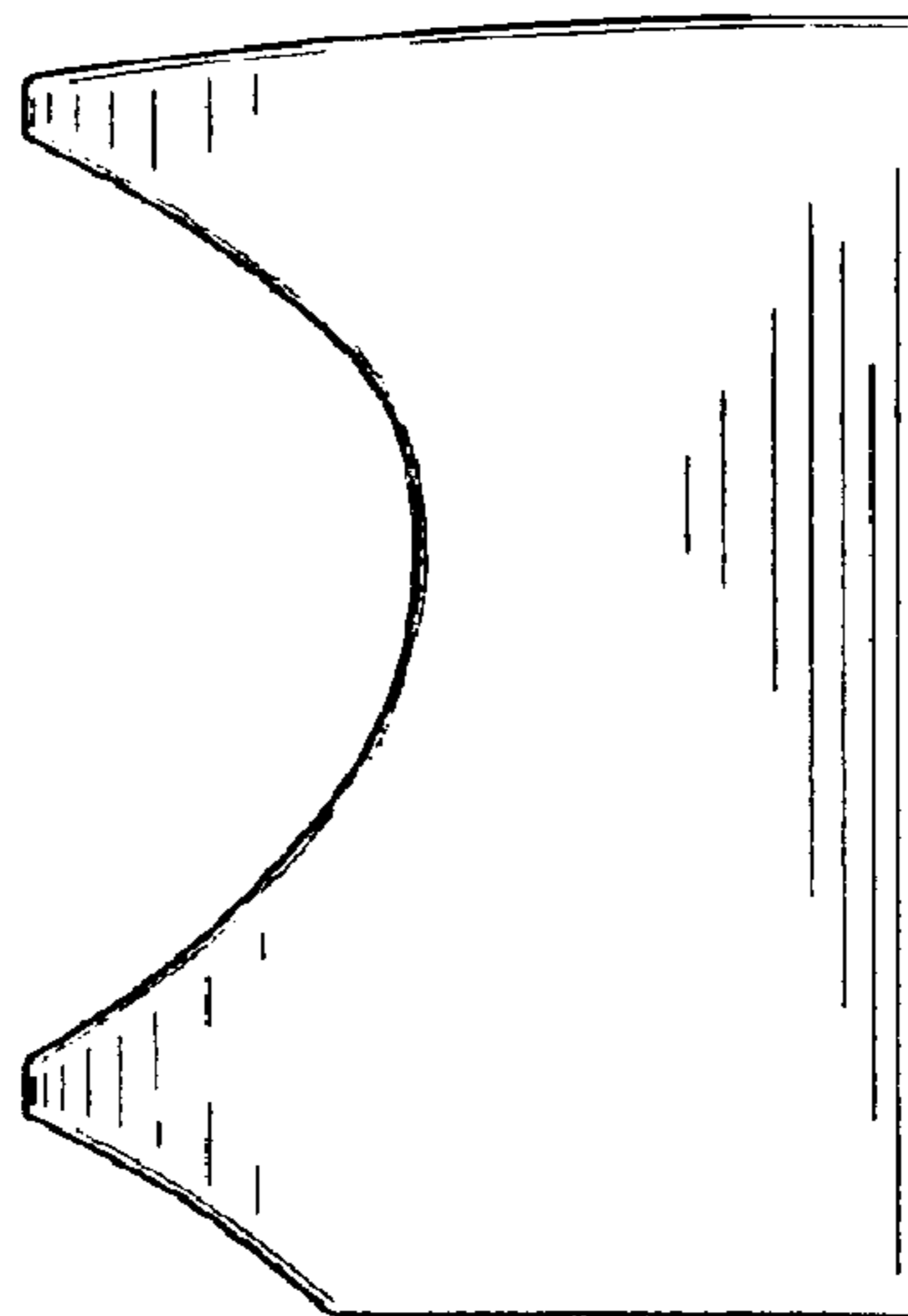

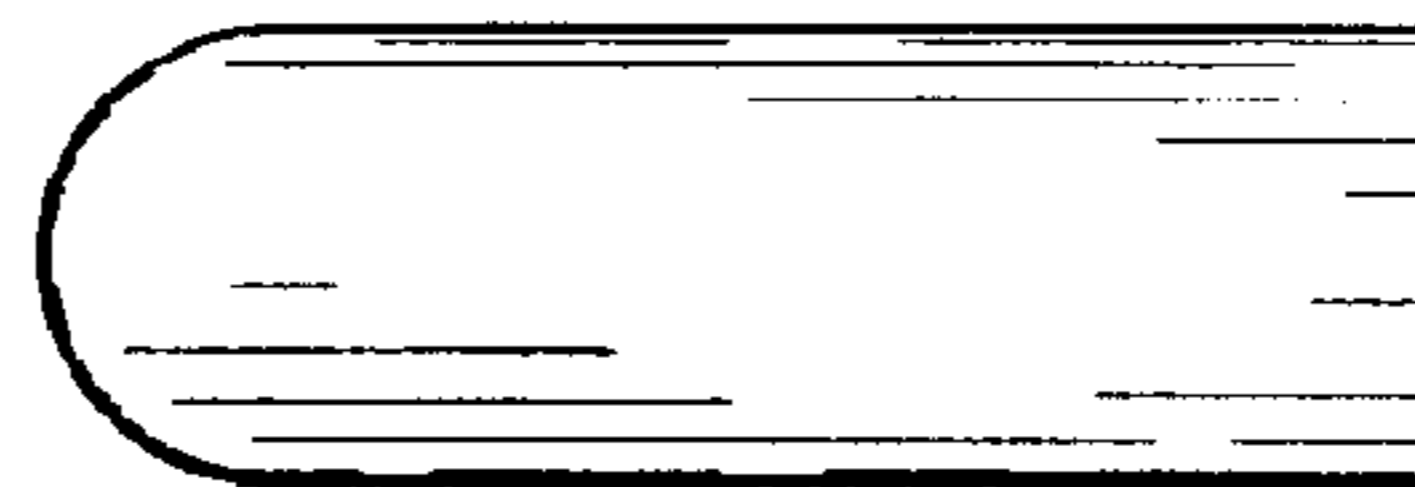

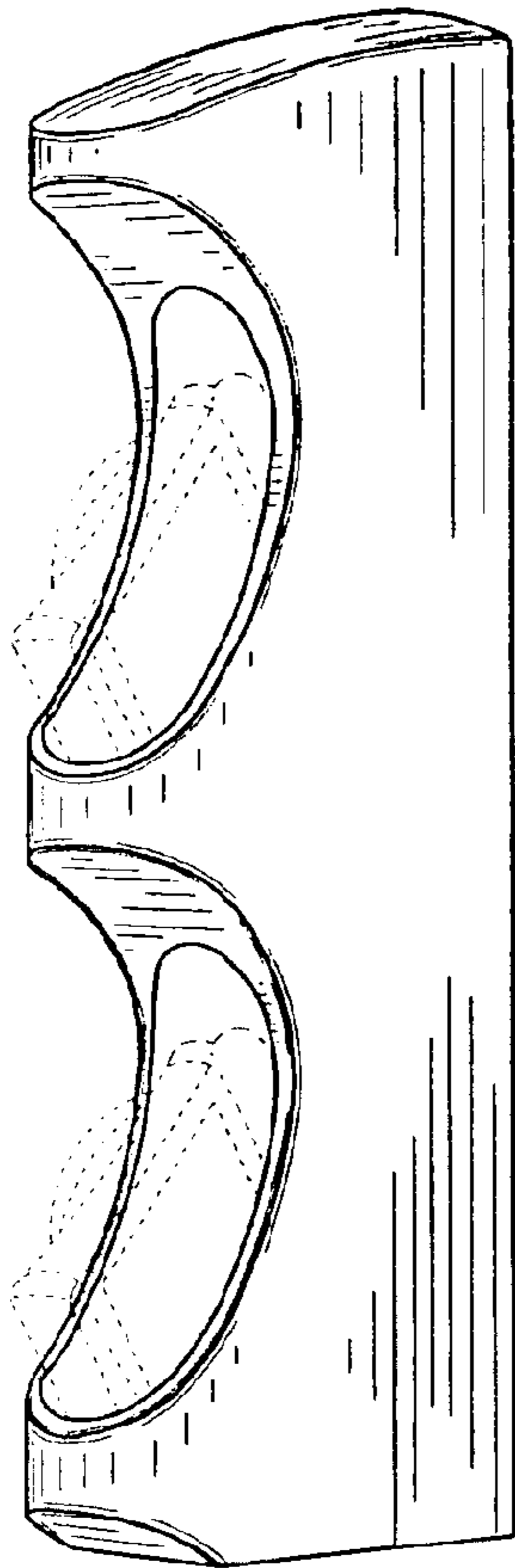

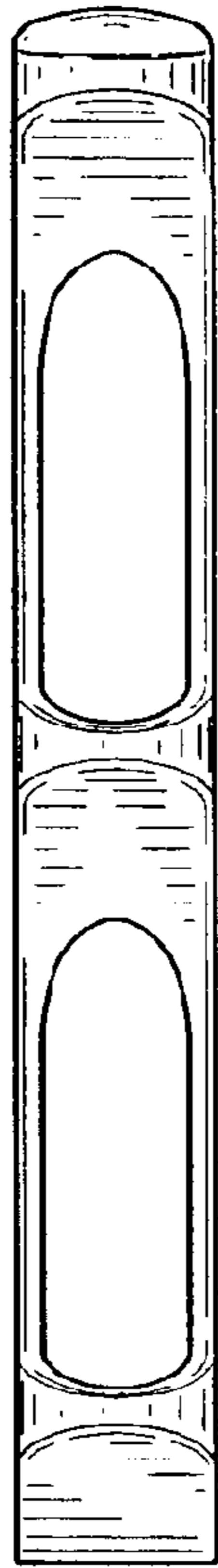

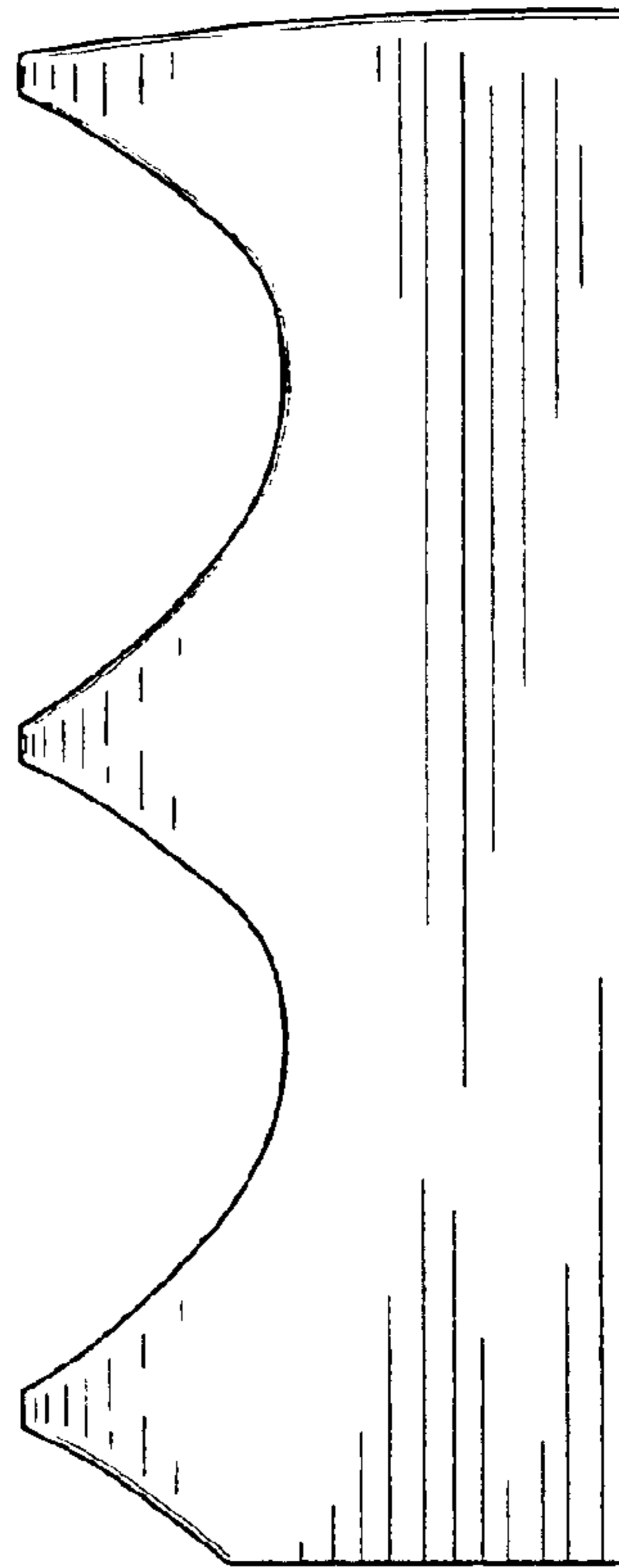

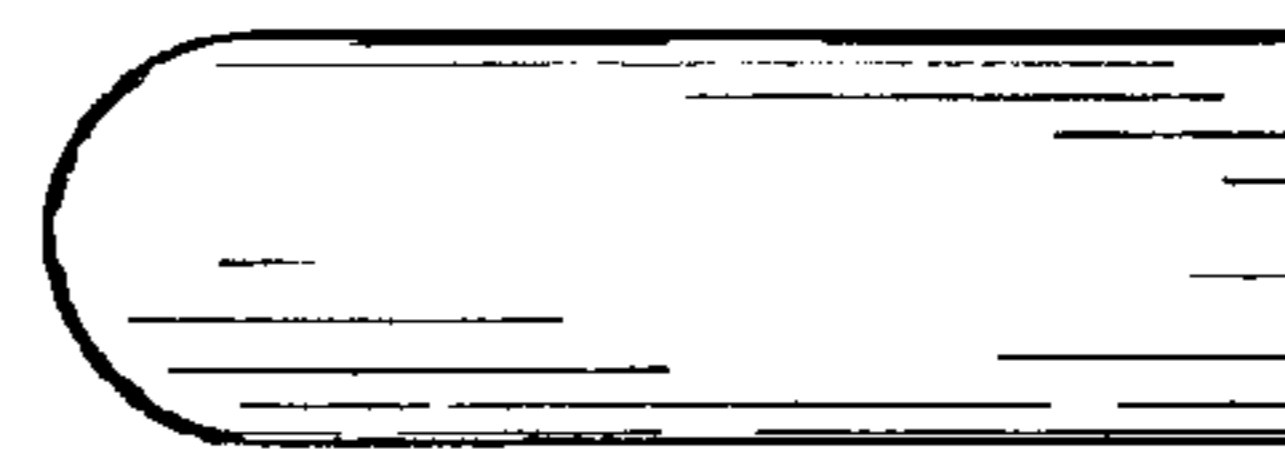

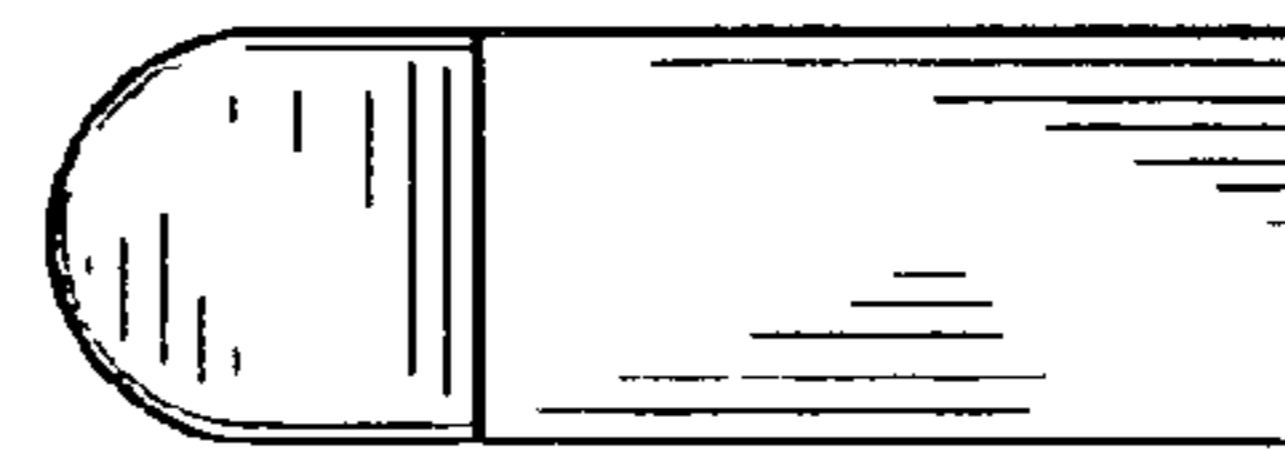

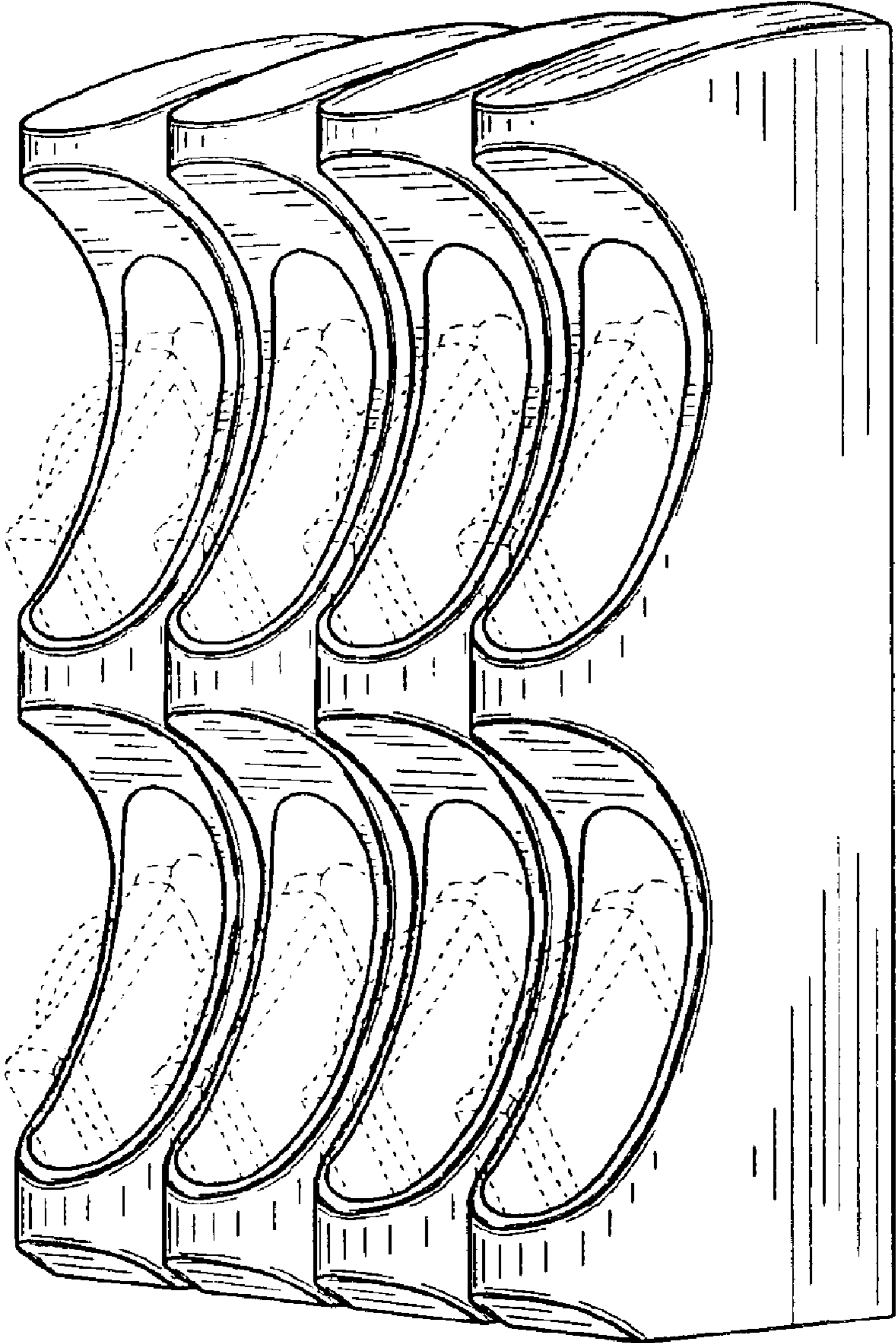

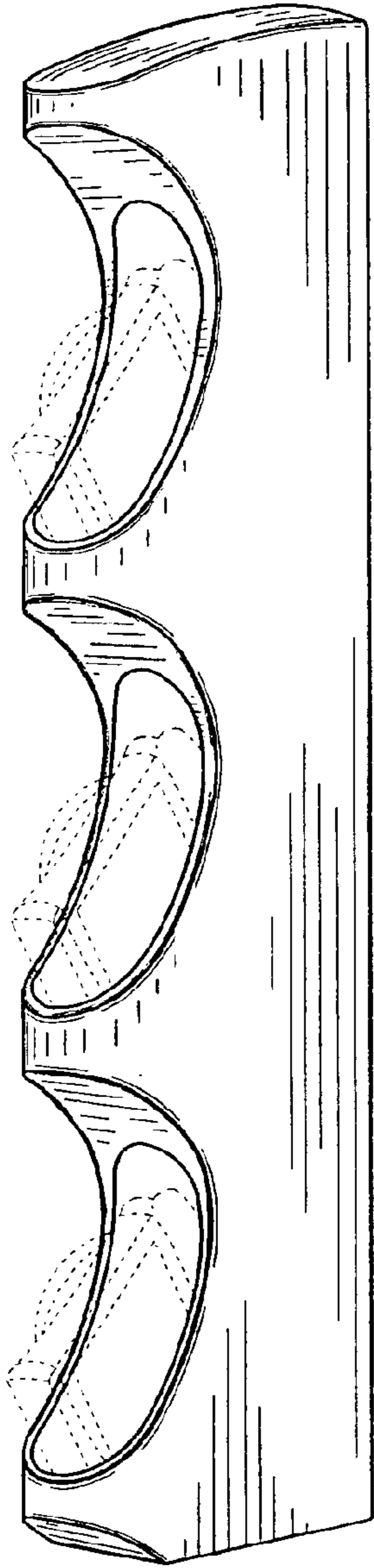

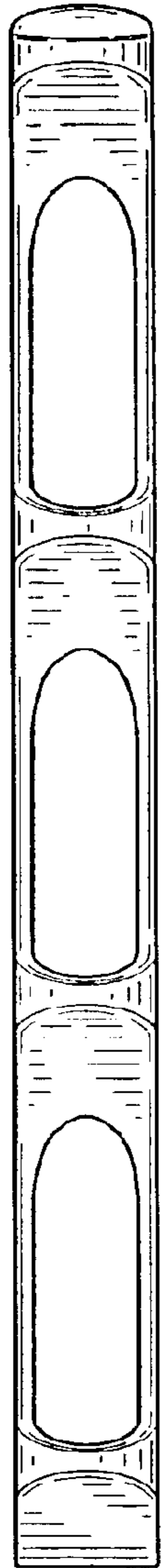

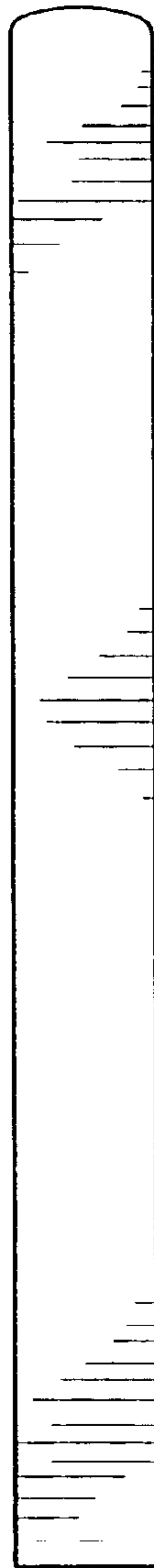

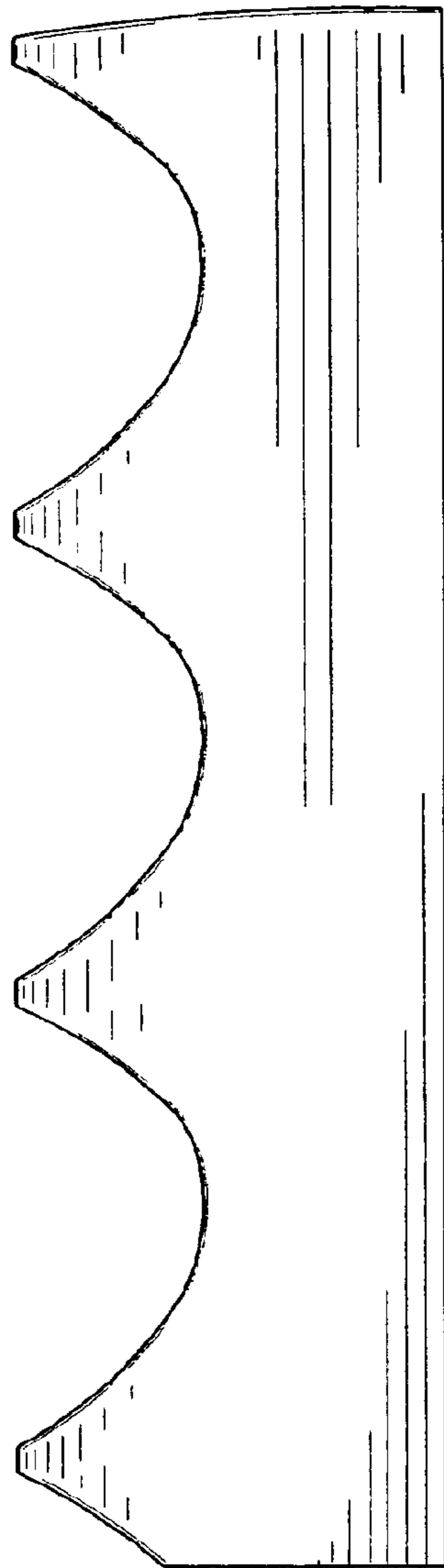

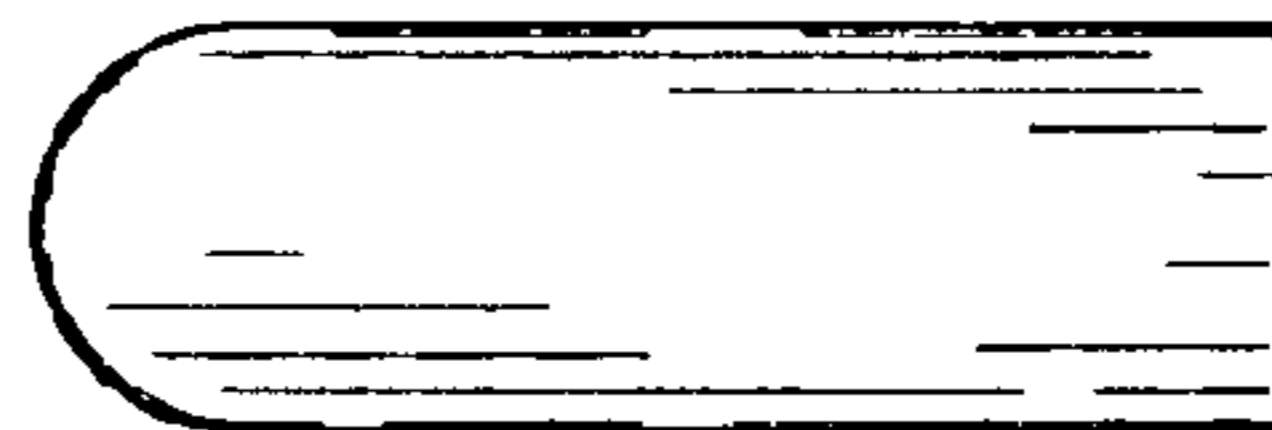
