(57) **CLAIM**

The ornamental design for a “Highlighter,” as shown and described.

FIG. 1 is a perspective view showing my new design for a “Highlighter”;

FIG. 2 is a front view of the “Highlighter” as shown in FIG. 1;

FIG. 3 is a rear view of the “Highlighter” as shown in FIG. 1;

FIG. 4 is a top view of the “Highlighter” as shown in FIG. 1;

FIG. 5 is a right side view of the “Highlighter” as shown in FIG. 1, the left side view being a mirror image of the right side view;

FIG. 6 is a bottom view of the “Highlighter” as shown in FIG. 1;

FIG. 7 is an exploded right side view of the “Highlighter” as shown in FIG. 1, the left side view being a mirror image of the right side view;

FIG. 8 is an exploded right side view of the “Highlighter” as shown in FIG. 1, except wherein the writing tip of the “Highlighter” is shown in a reverse orientation, the left side view being a mirror image of the right side view;

FIG. 9 is a right side view of a second embodiment of the “Highlighter” as shown in FIG. 1, the left side view being a mirror image of the right side view;

FIG. 10 is a right side view of the “Highlighter” as shown in FIG. 9, except wherein the writing tip of the “Highlighter” is shown in a reverse orientation, the left side view being a mirror image of the right side view;

FIG. 11 is a left upside down side view of the “Highlighter” as shown in FIG. 10;

FIG. 12 is a bottom view of the “Highlighter” as shown in FIG. 10;

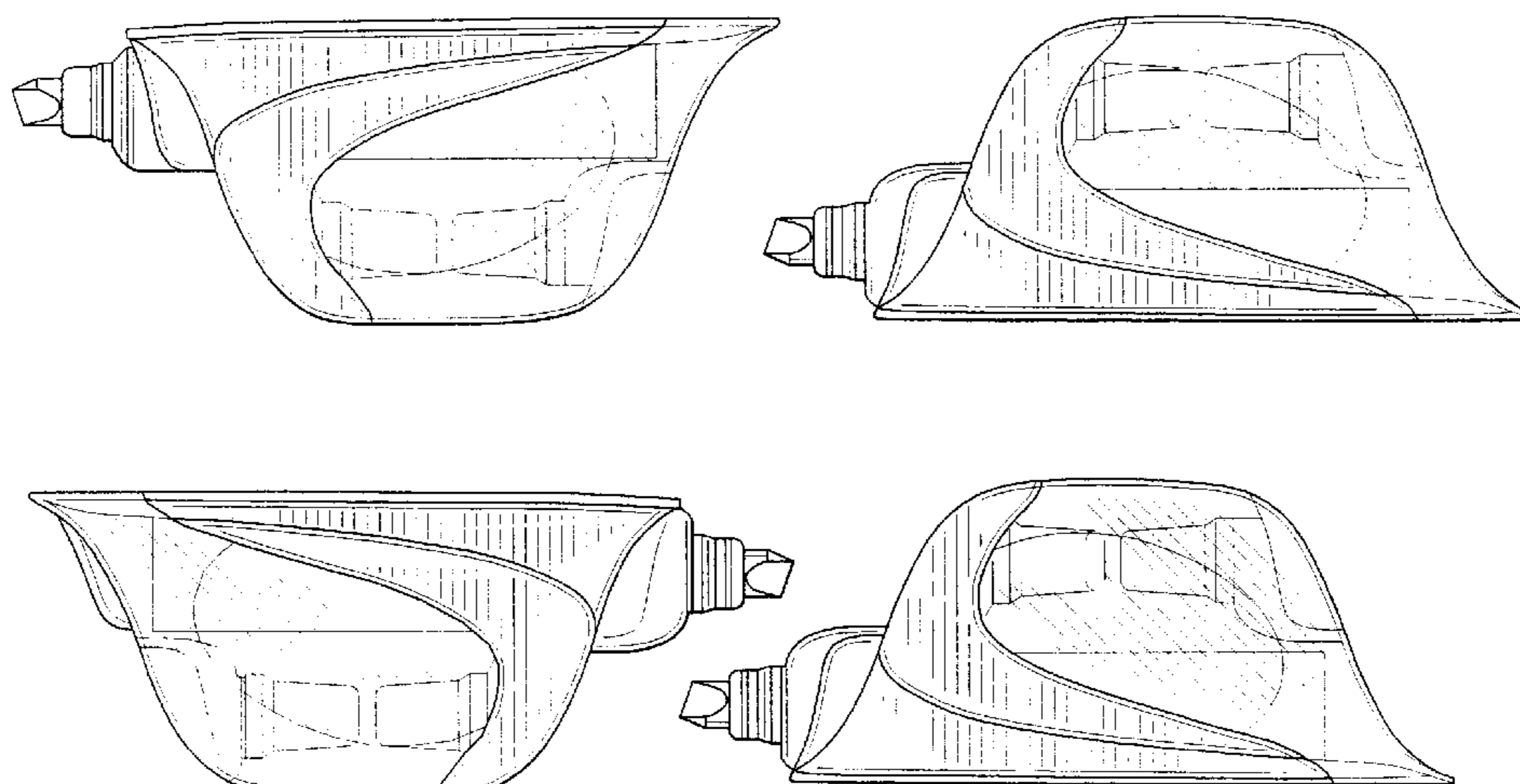
FIG. 13 is an exploded right side view of the “Highlighter” as shown in FIG. 10;

FIG. 14 is an exploded top view of the “Highlighter” as shown in FIG. 10;

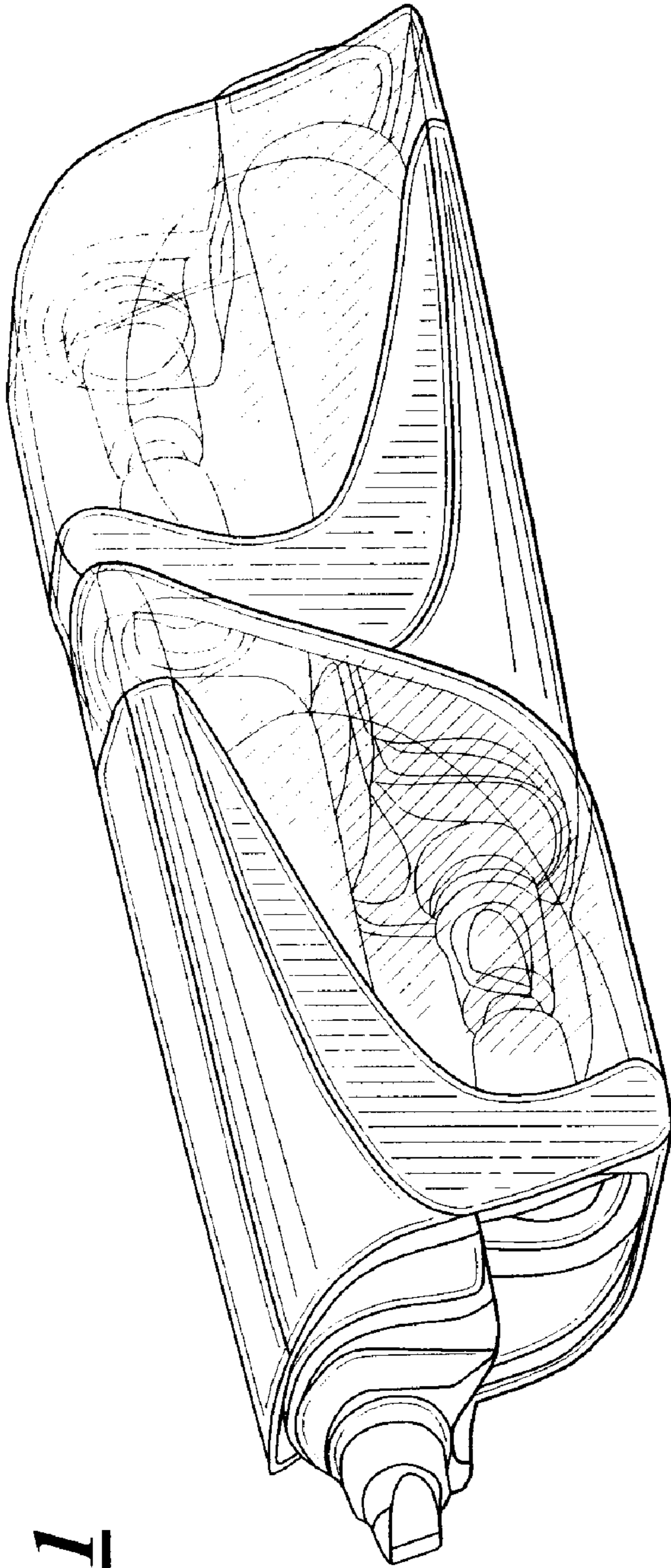

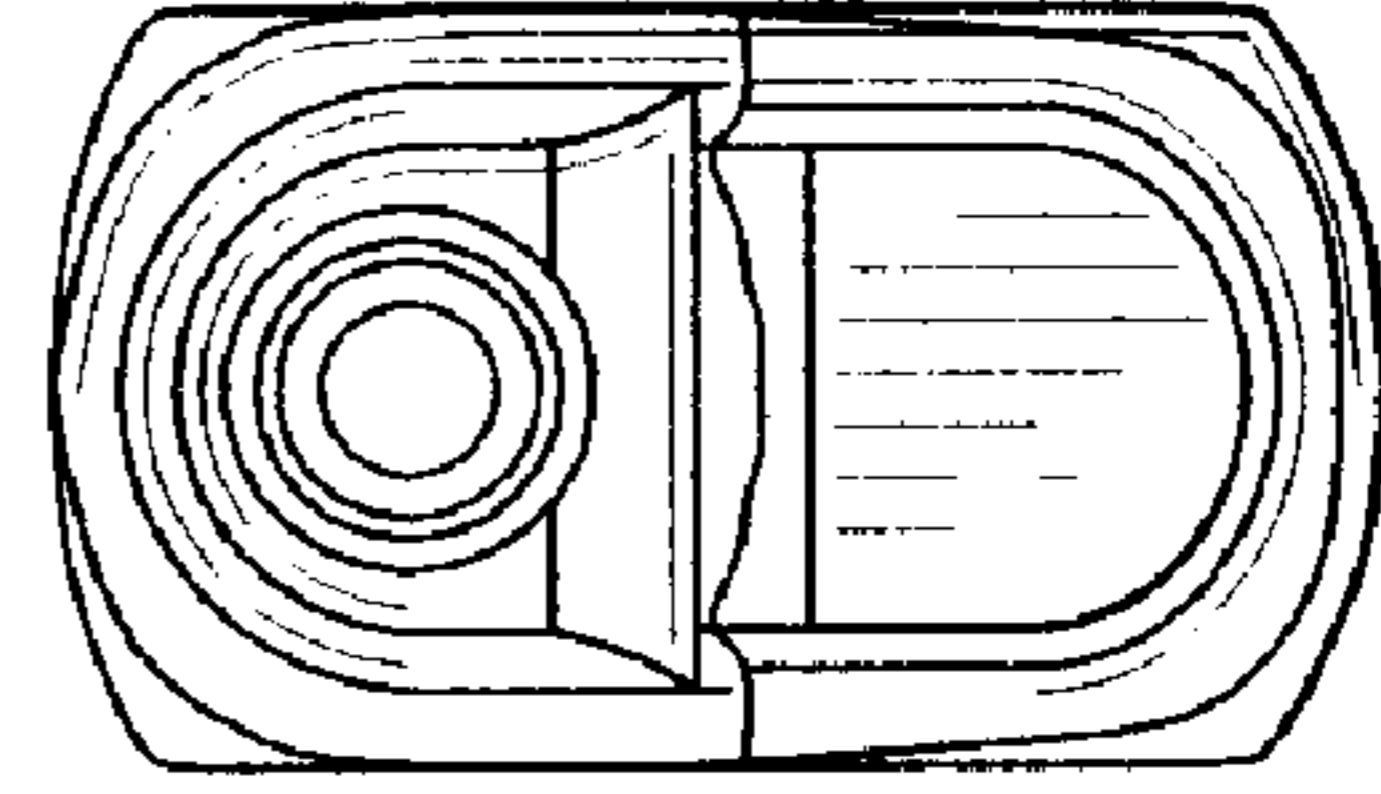

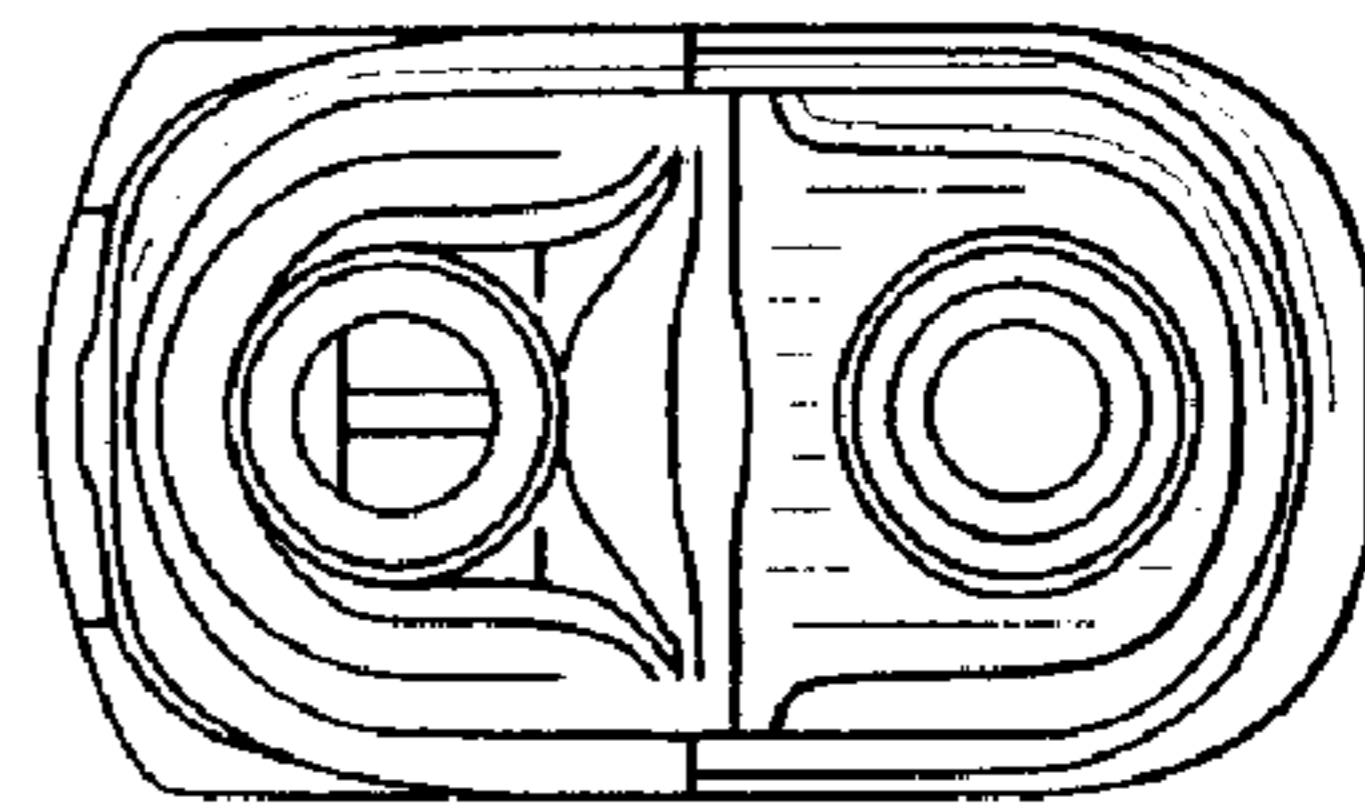

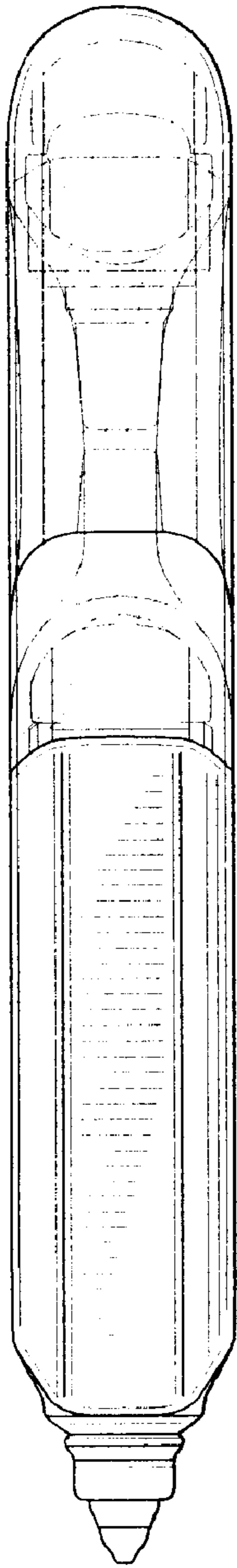

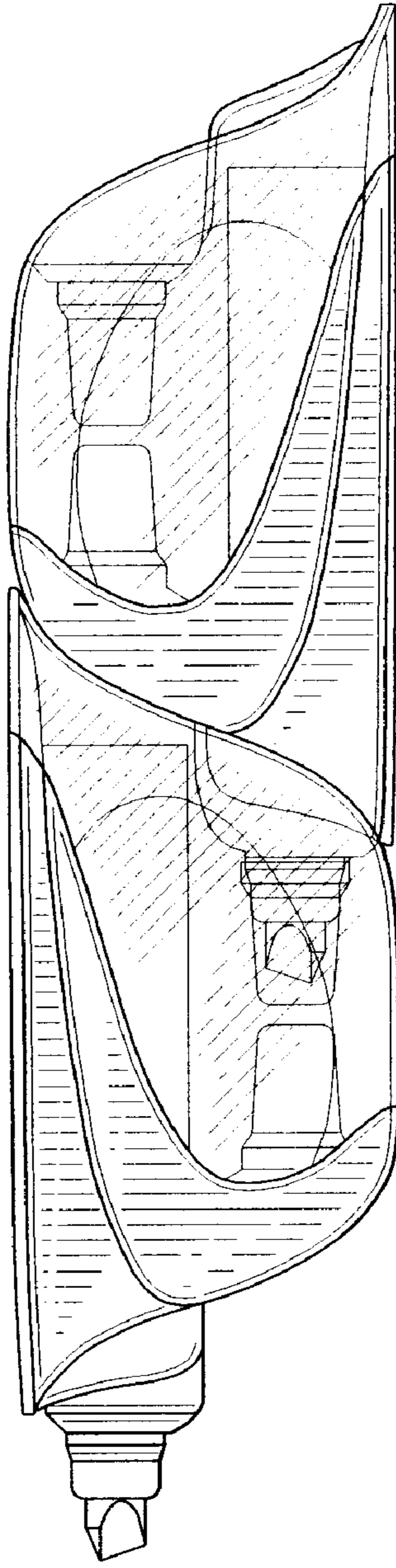

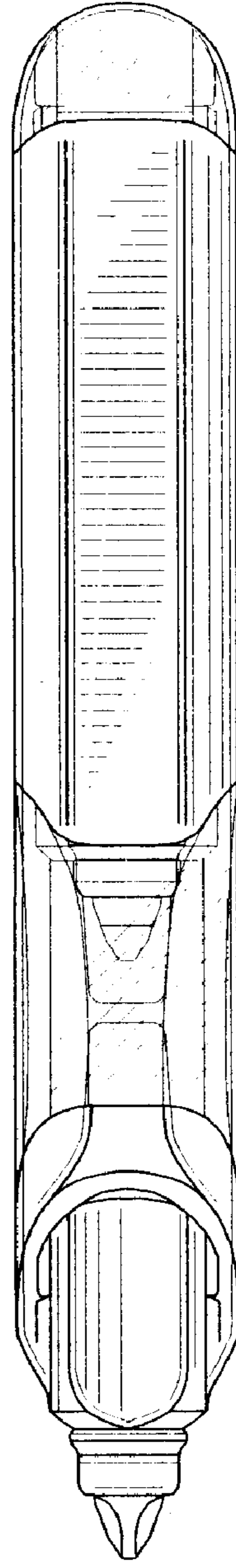

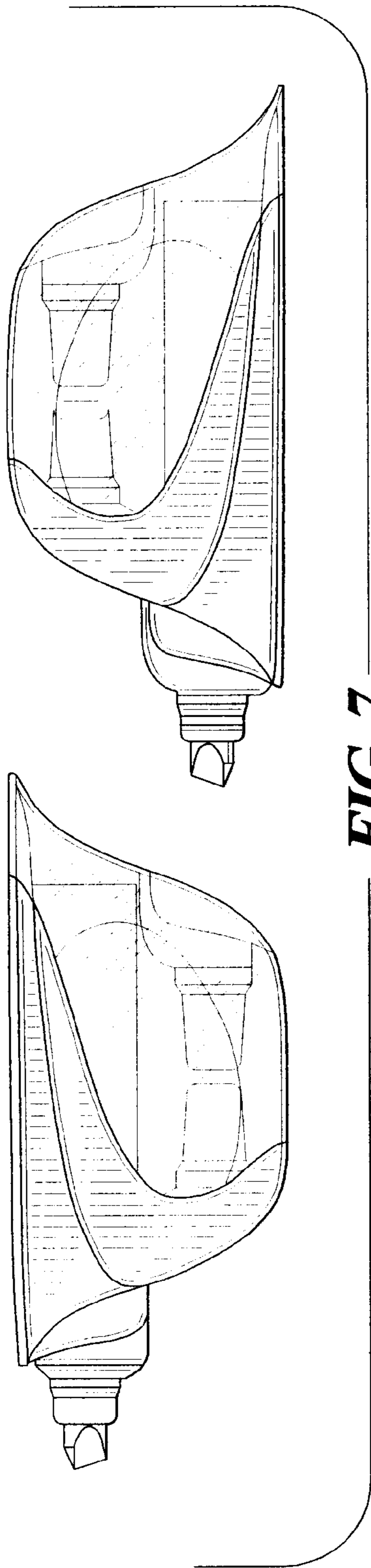

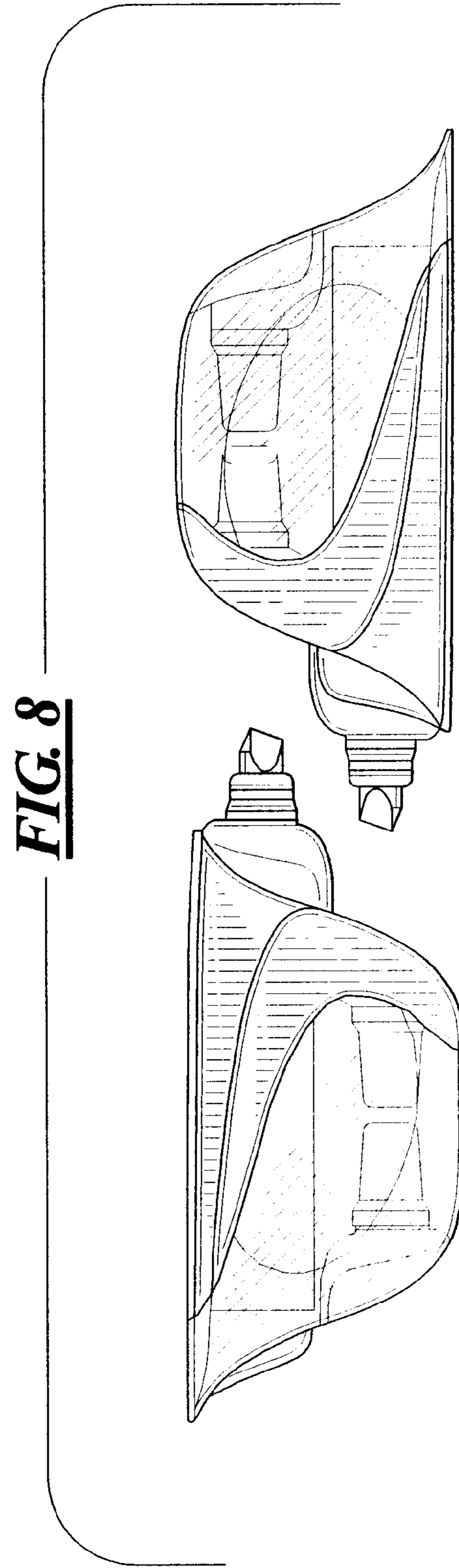

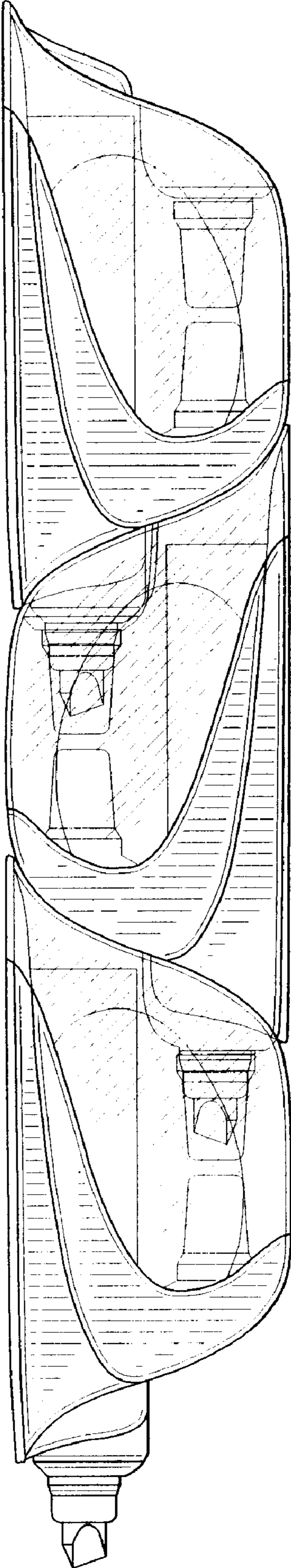

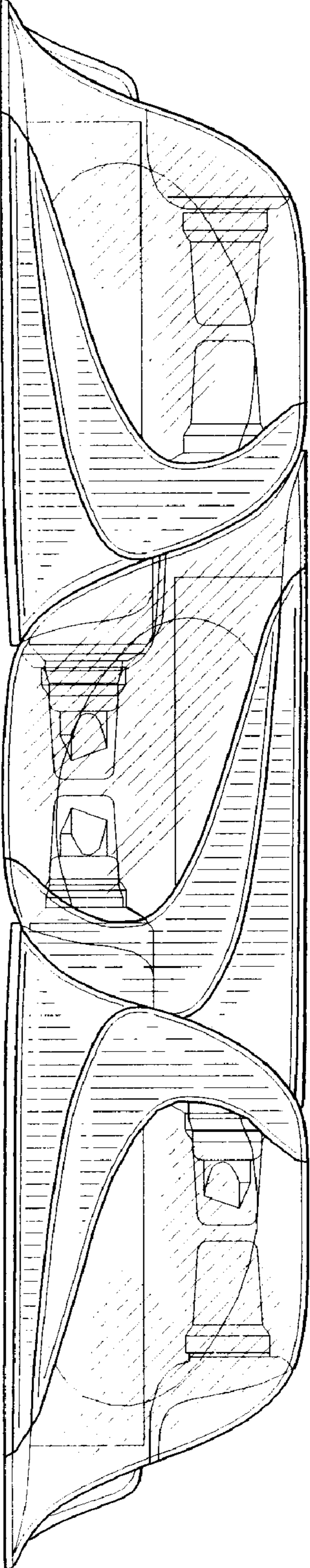

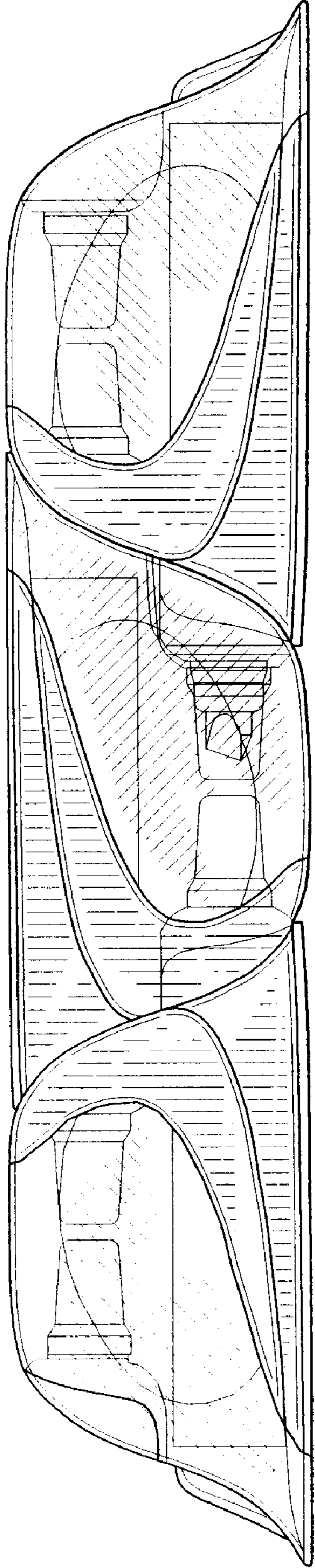
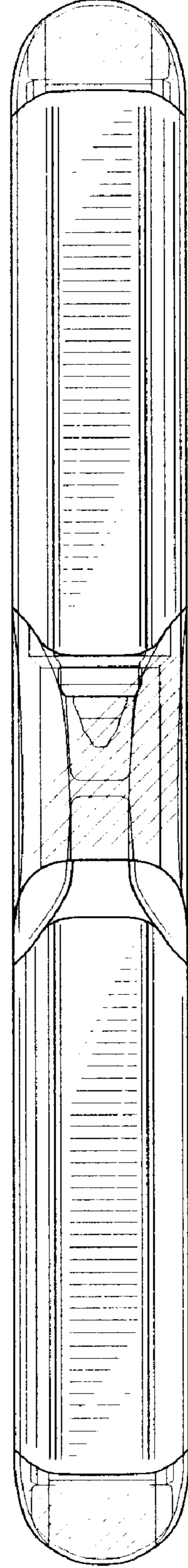

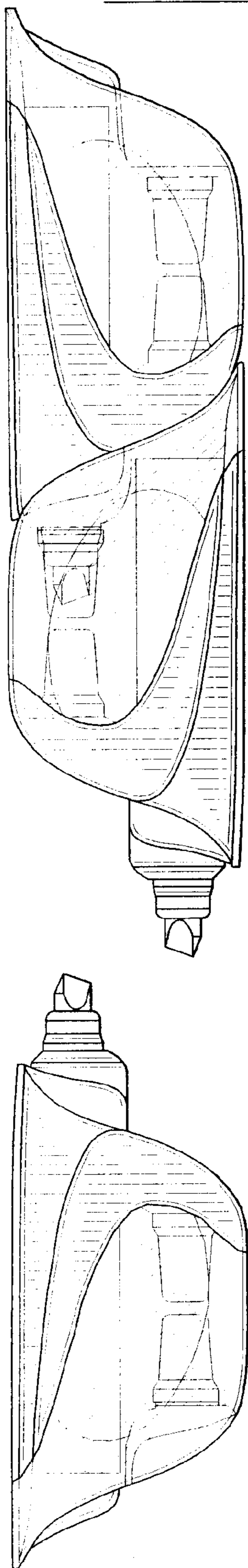
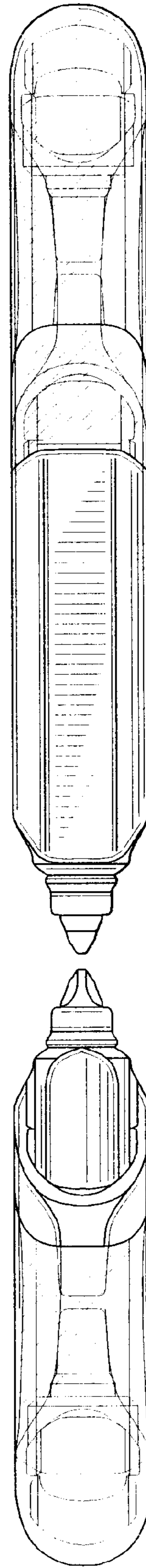

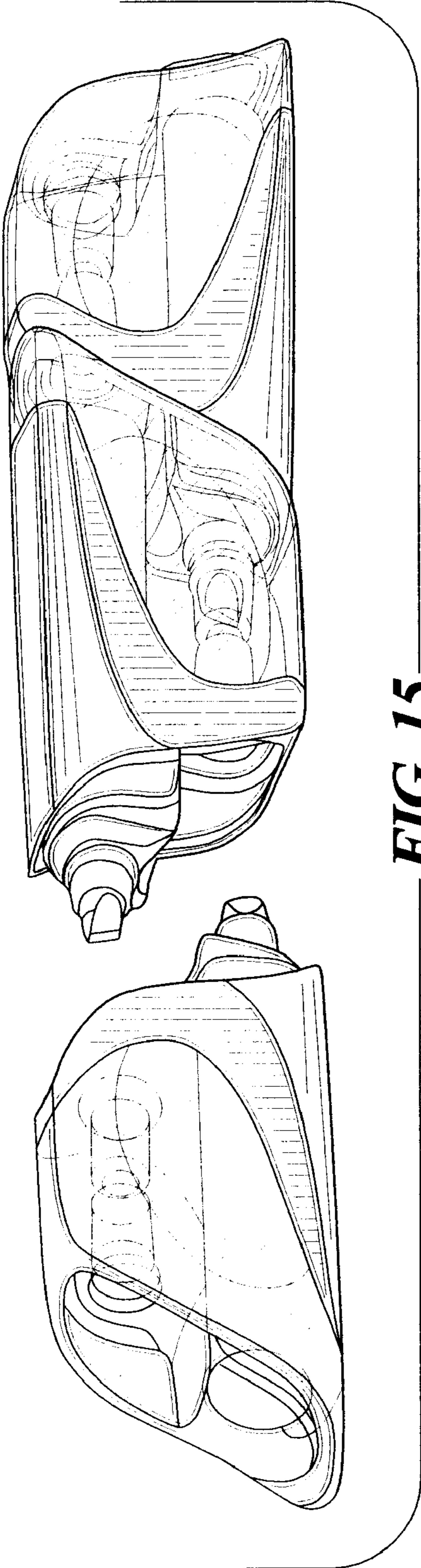

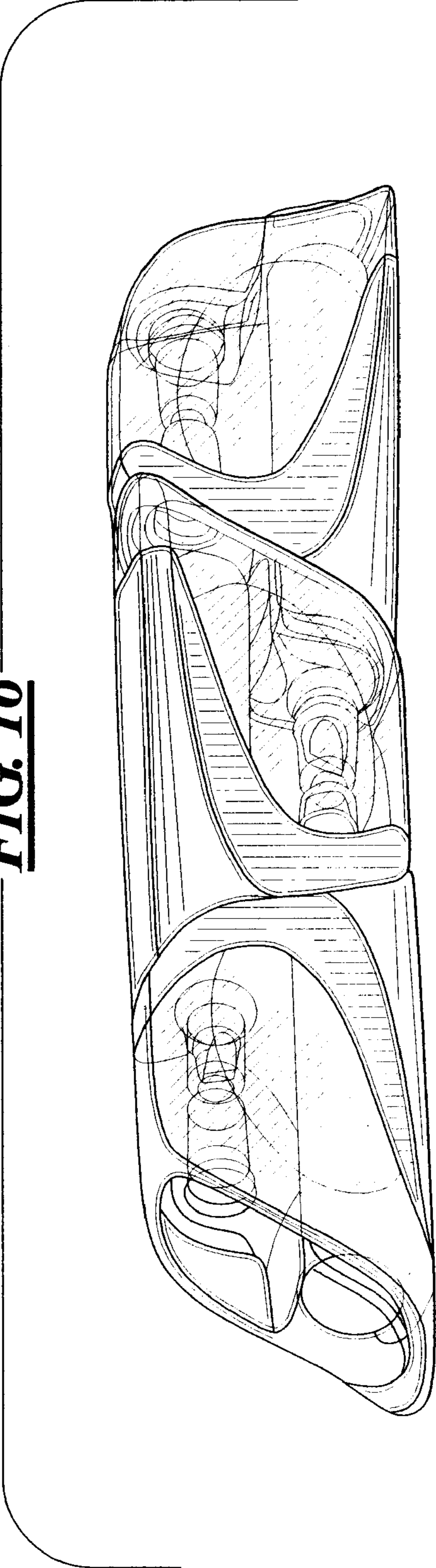
