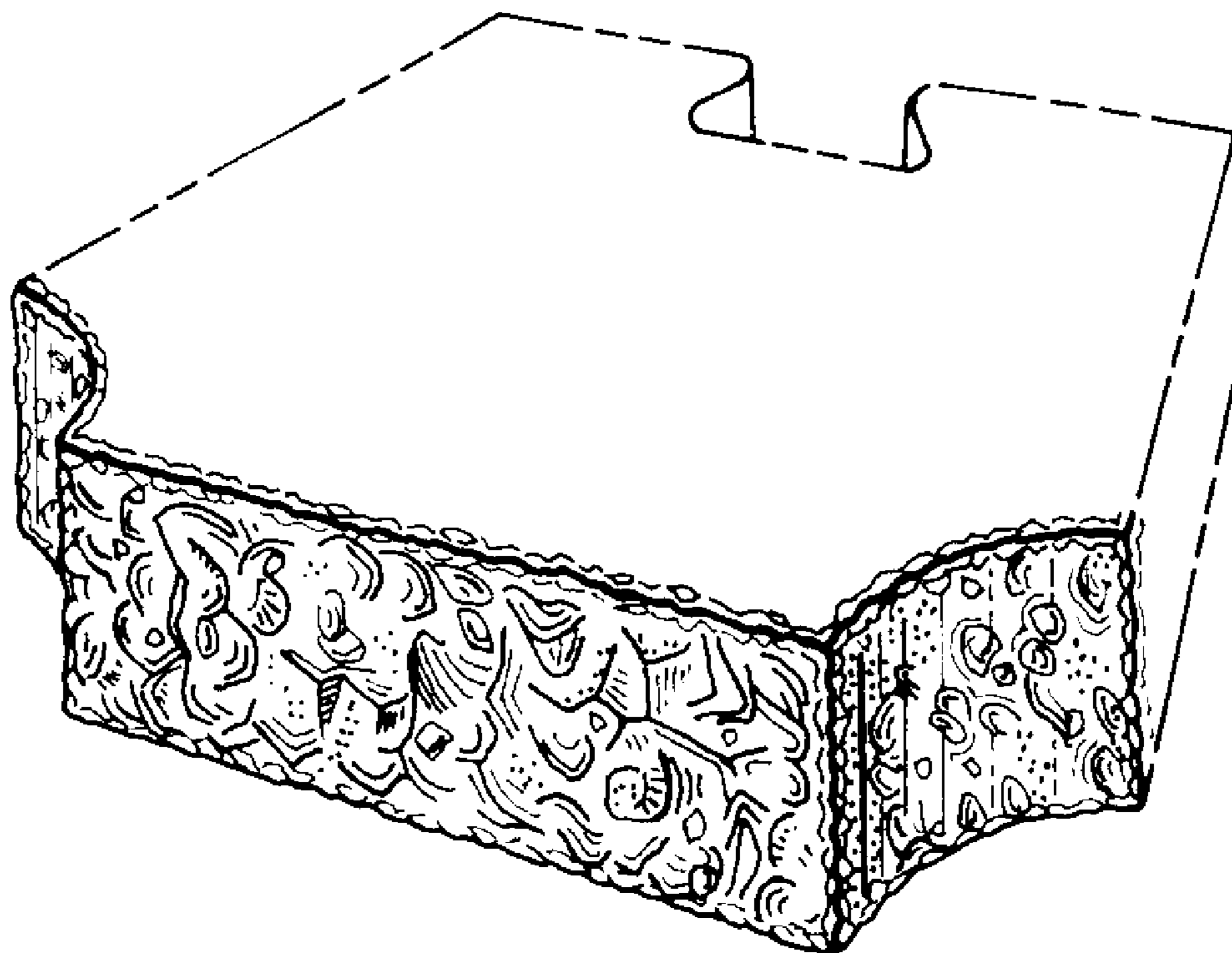
(57) **CLAIM**

The ornamental design for a retaining wall and block face, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a block showing my new design;

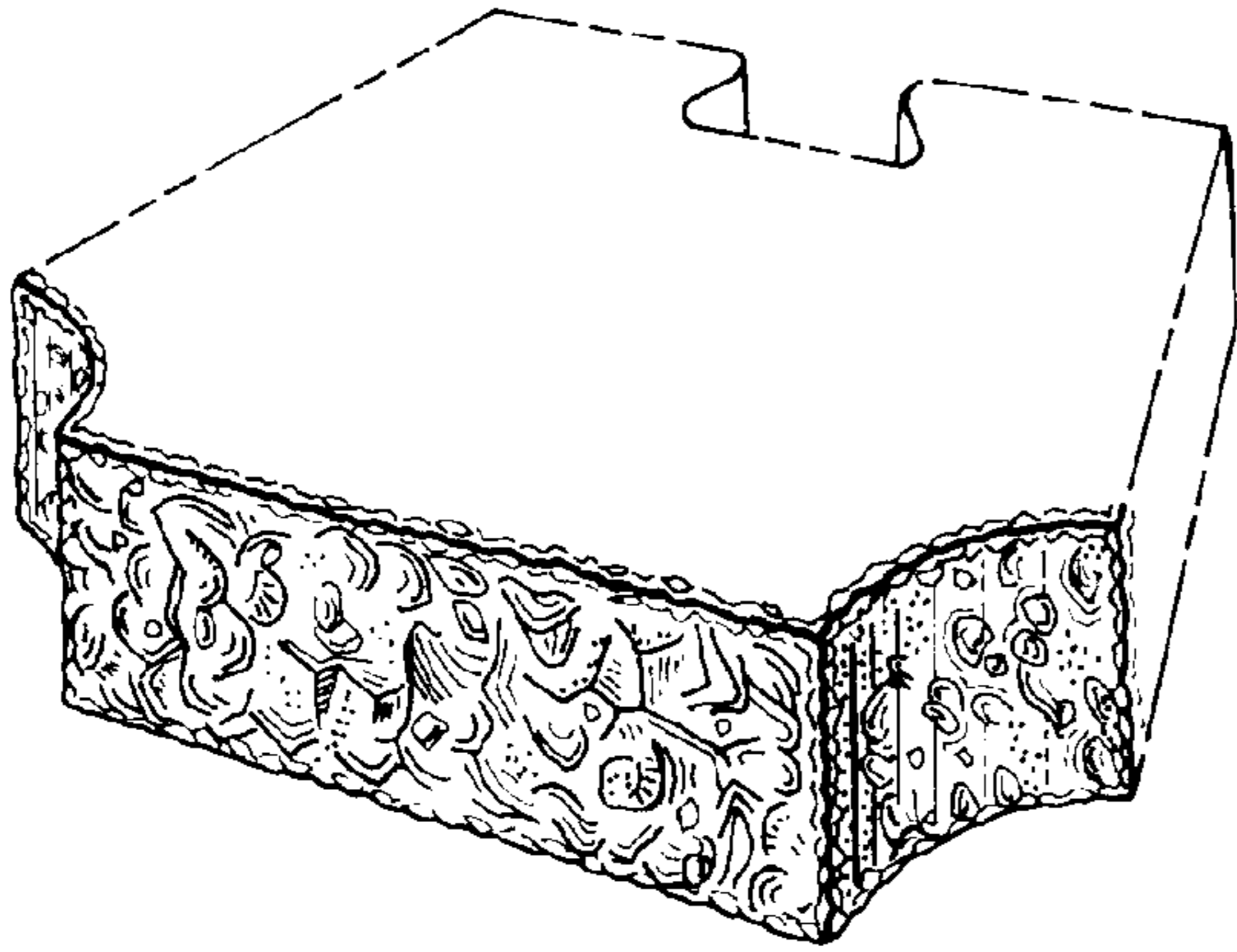

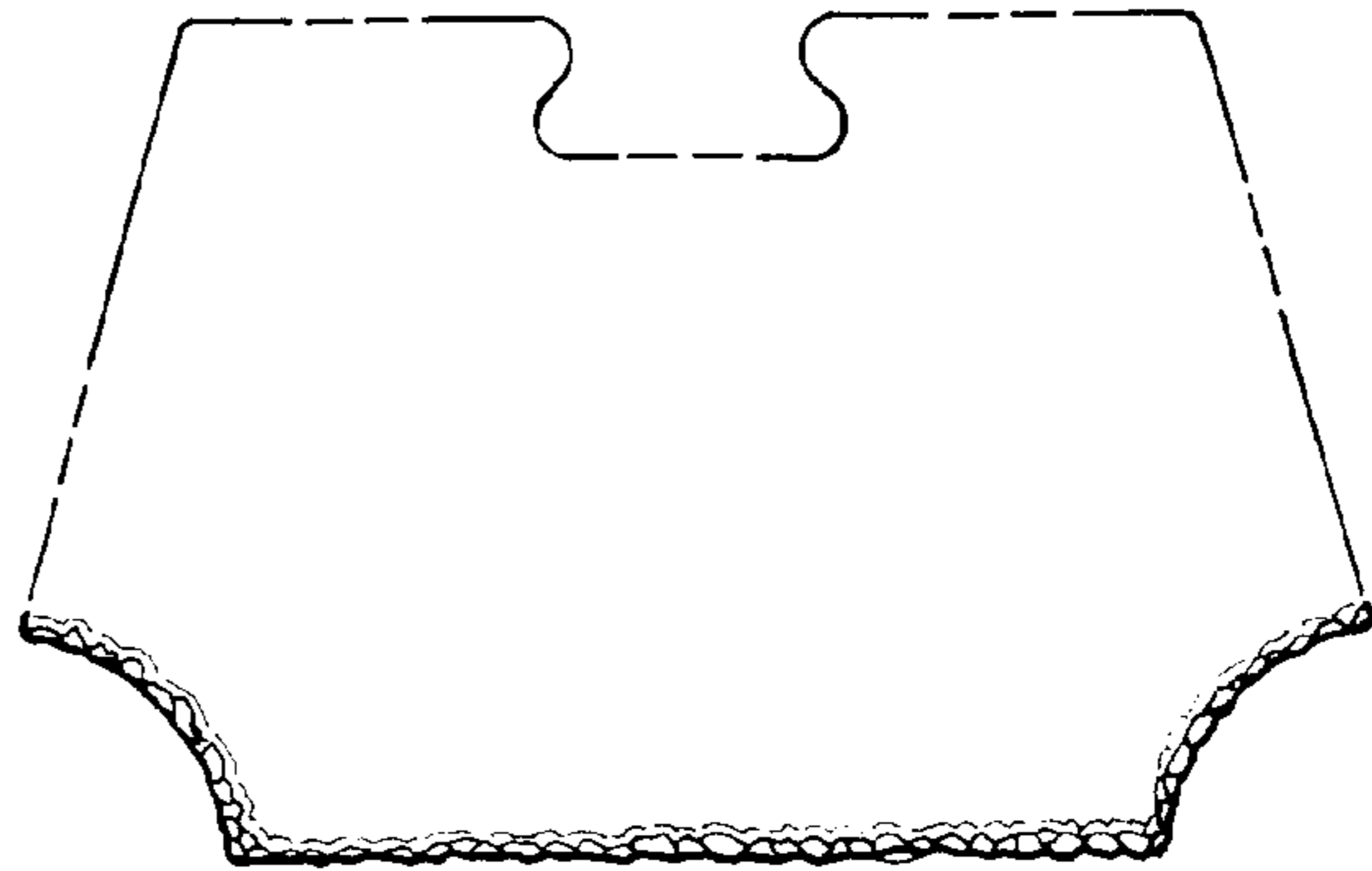

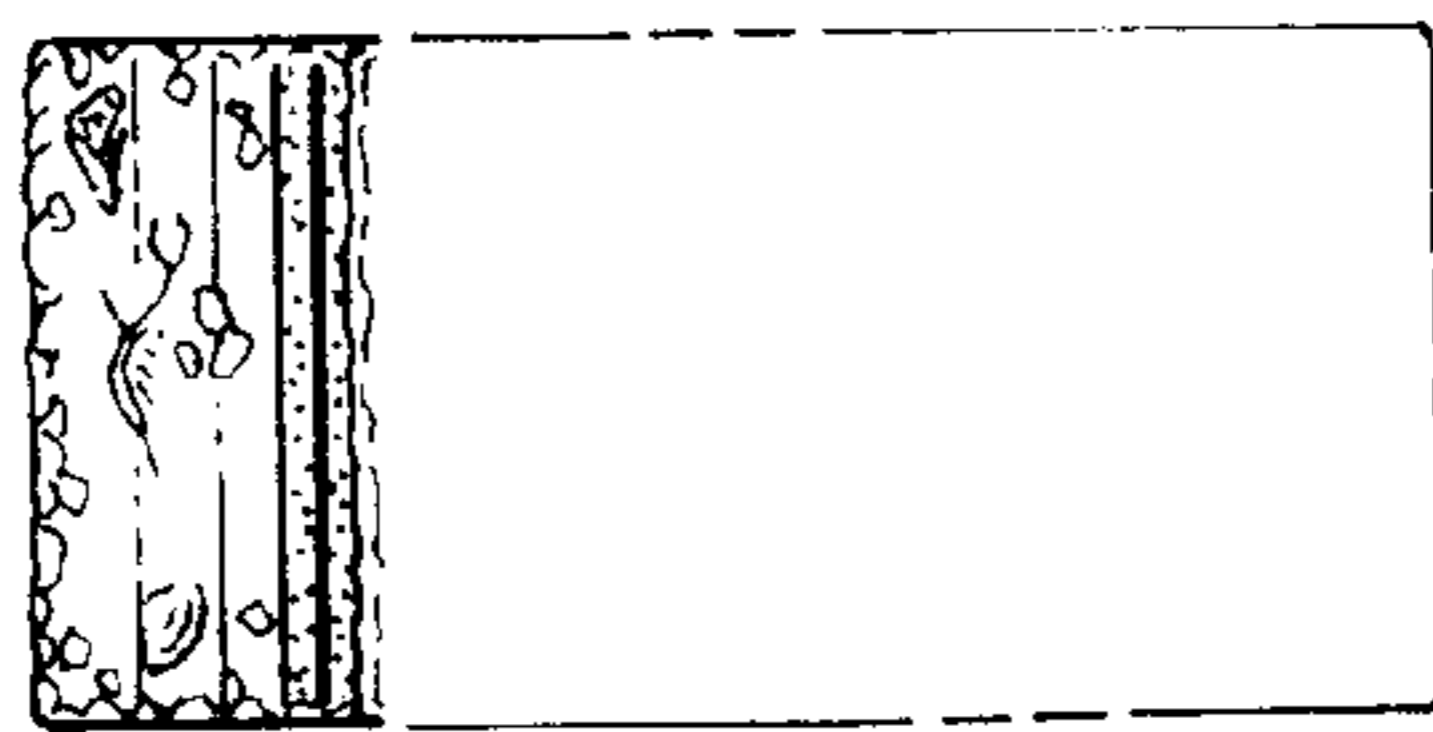

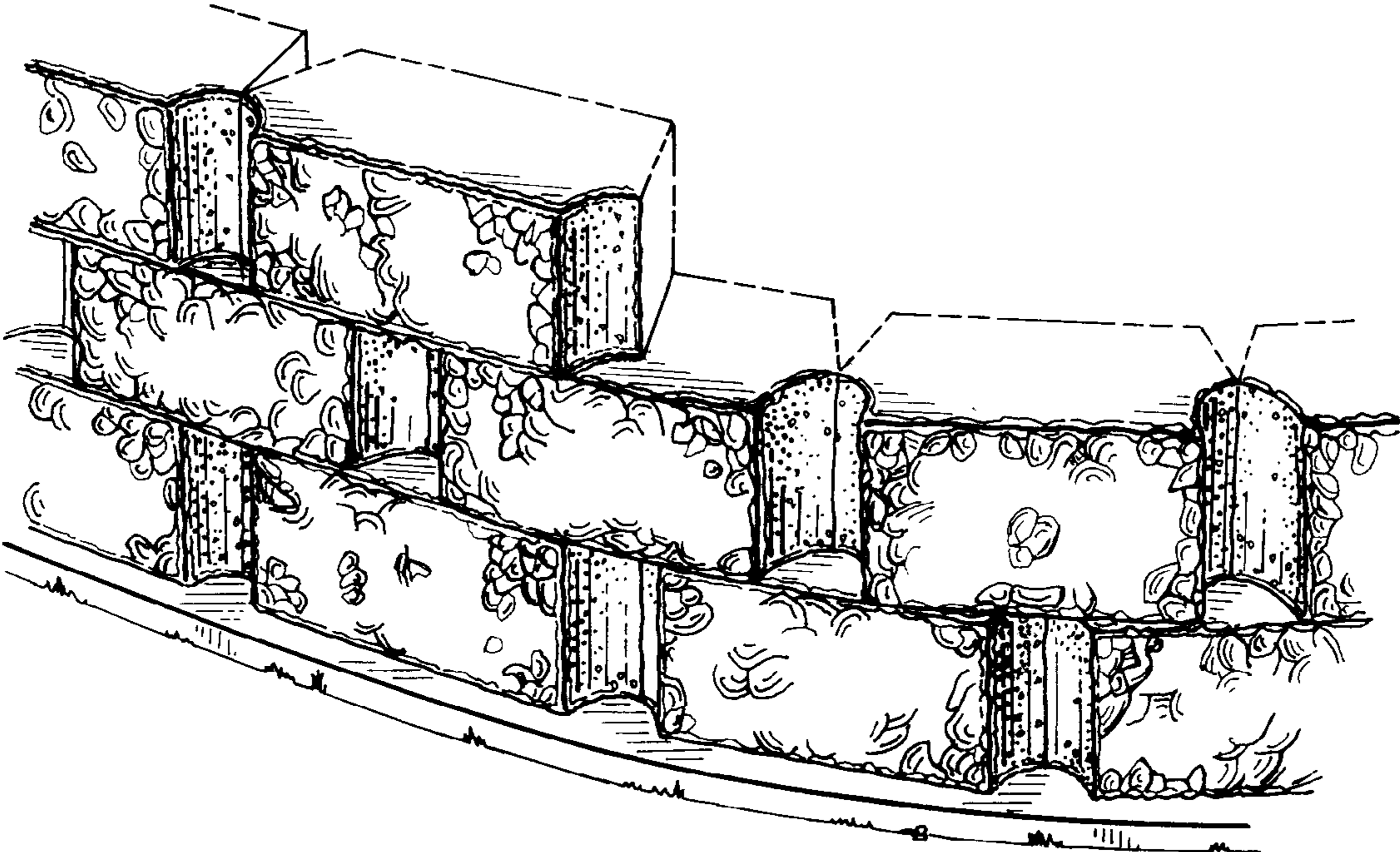
