(57) **CLAIM**

The ornamental design for hair styling comb, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a left side elevation view of the hair styling comb of the present invention;

FIG. 2 is a right side elevation view (inverted) of the hair styling comb of the present invention;

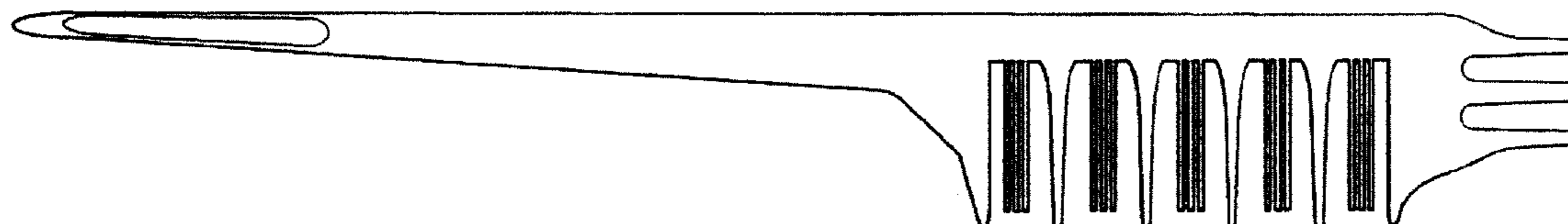
FIG. 3 is a top plan view of the hair styling comb;

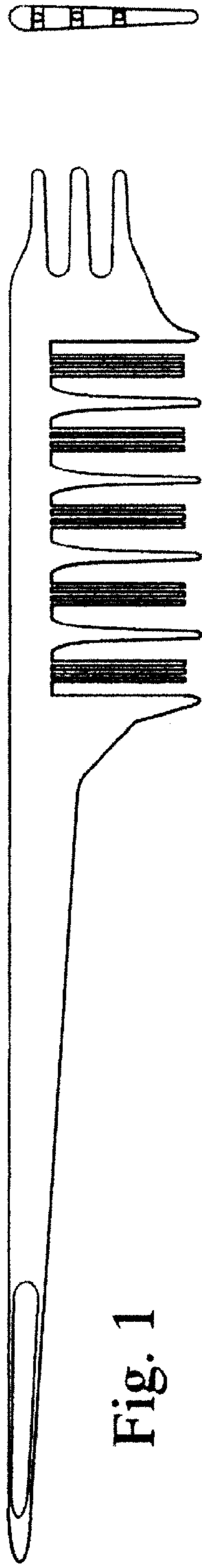

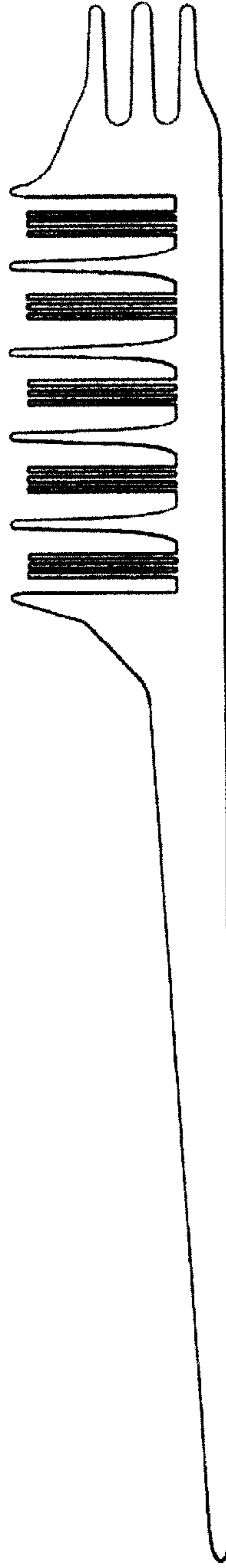
