FIG. 4 is a rear view of the pocketed sweatshirt of FIG. 1;

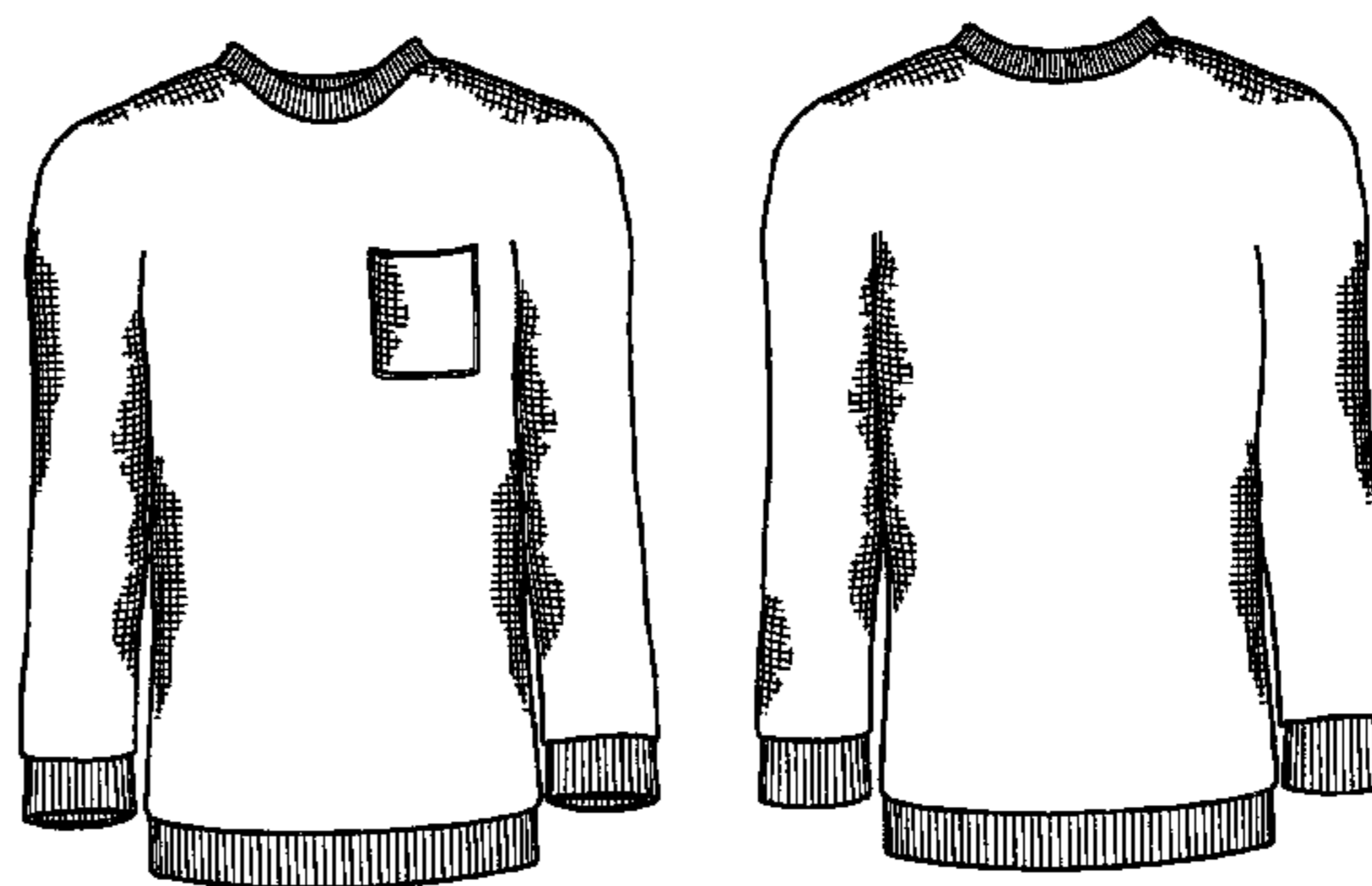
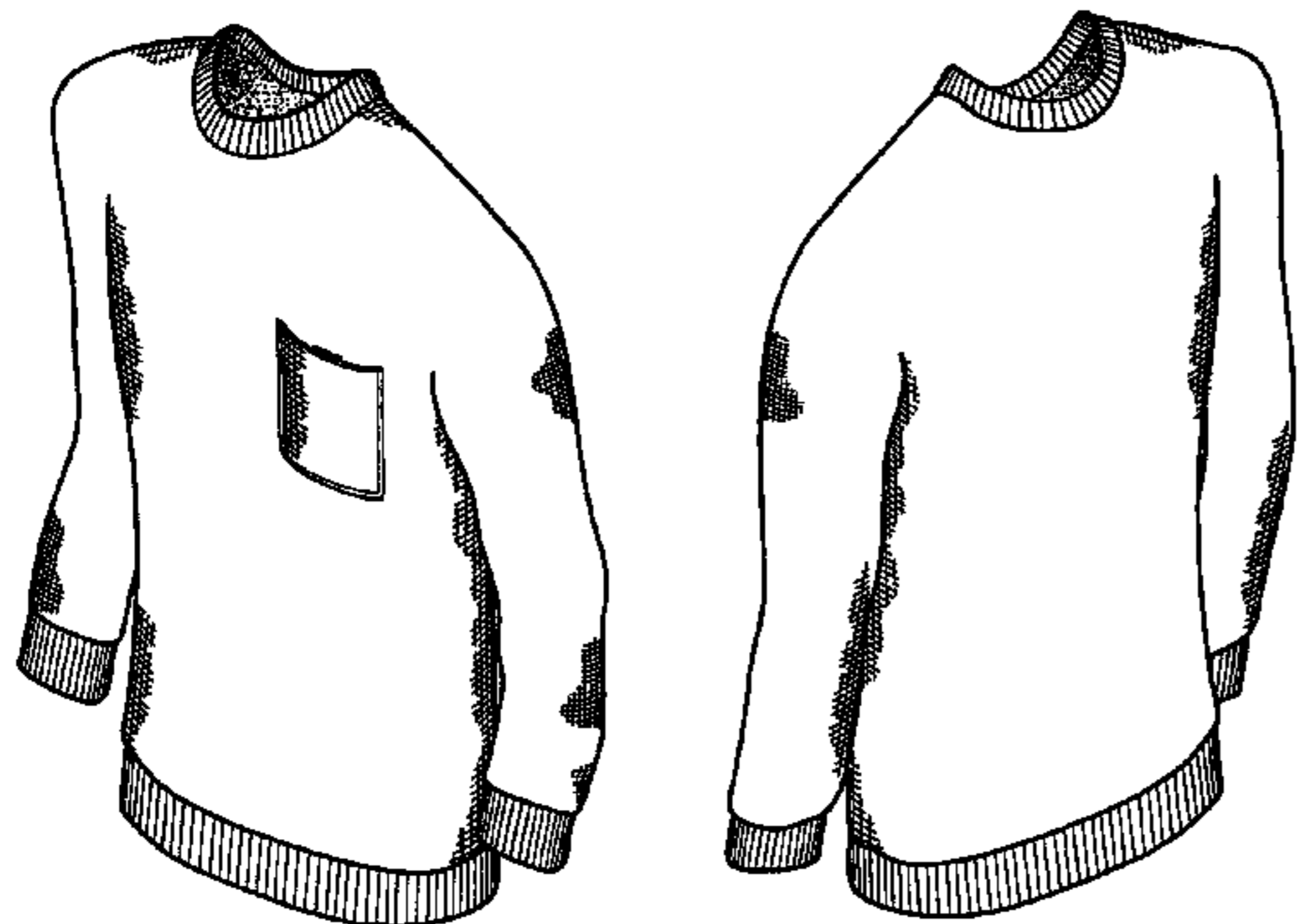
FIG. 5 is a left side view of the pocketed sweatshirt of FIG. 1;

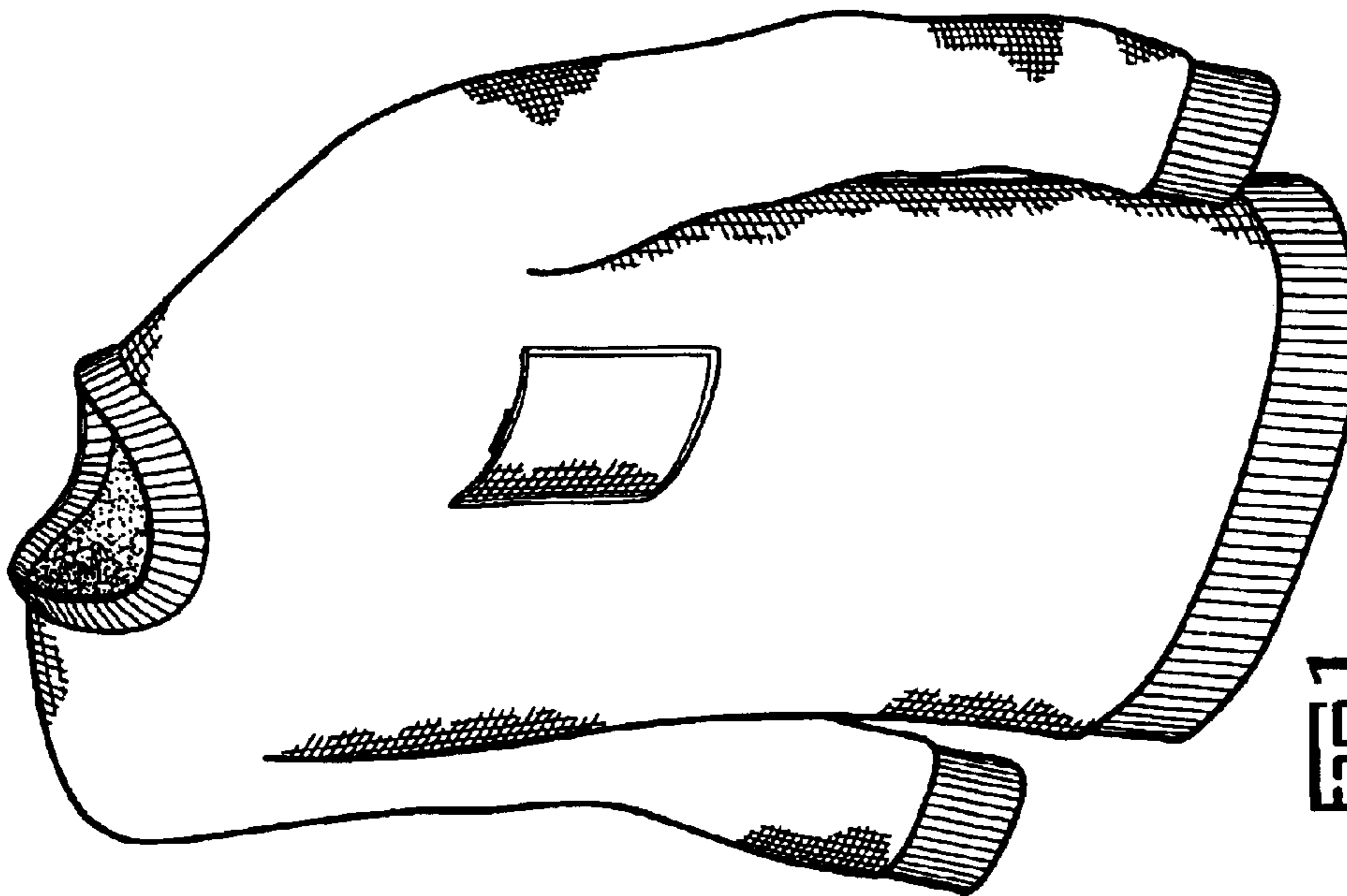
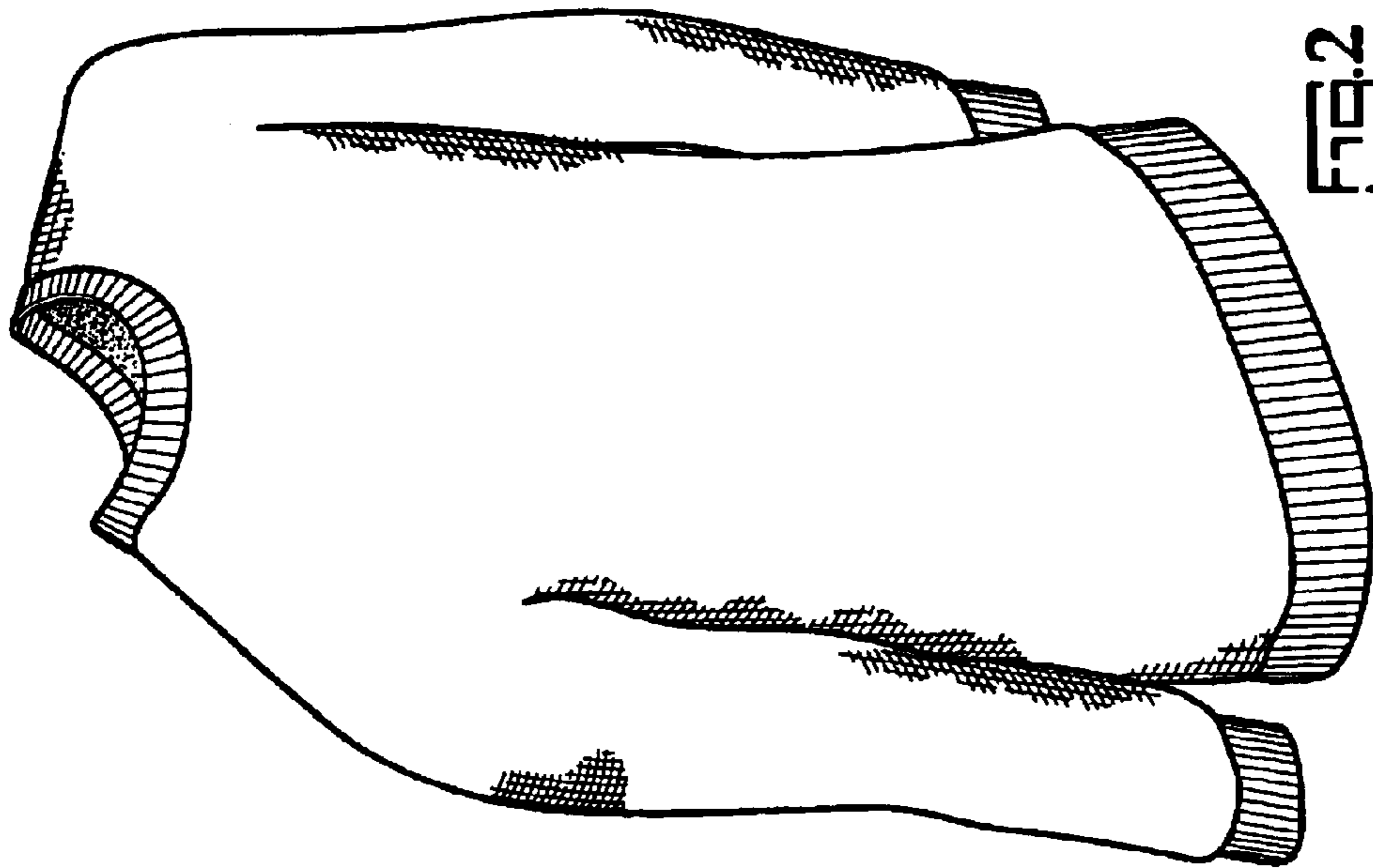
FIG. 6 is a right side view of the pocketed sweatshirt of FIG. 1;

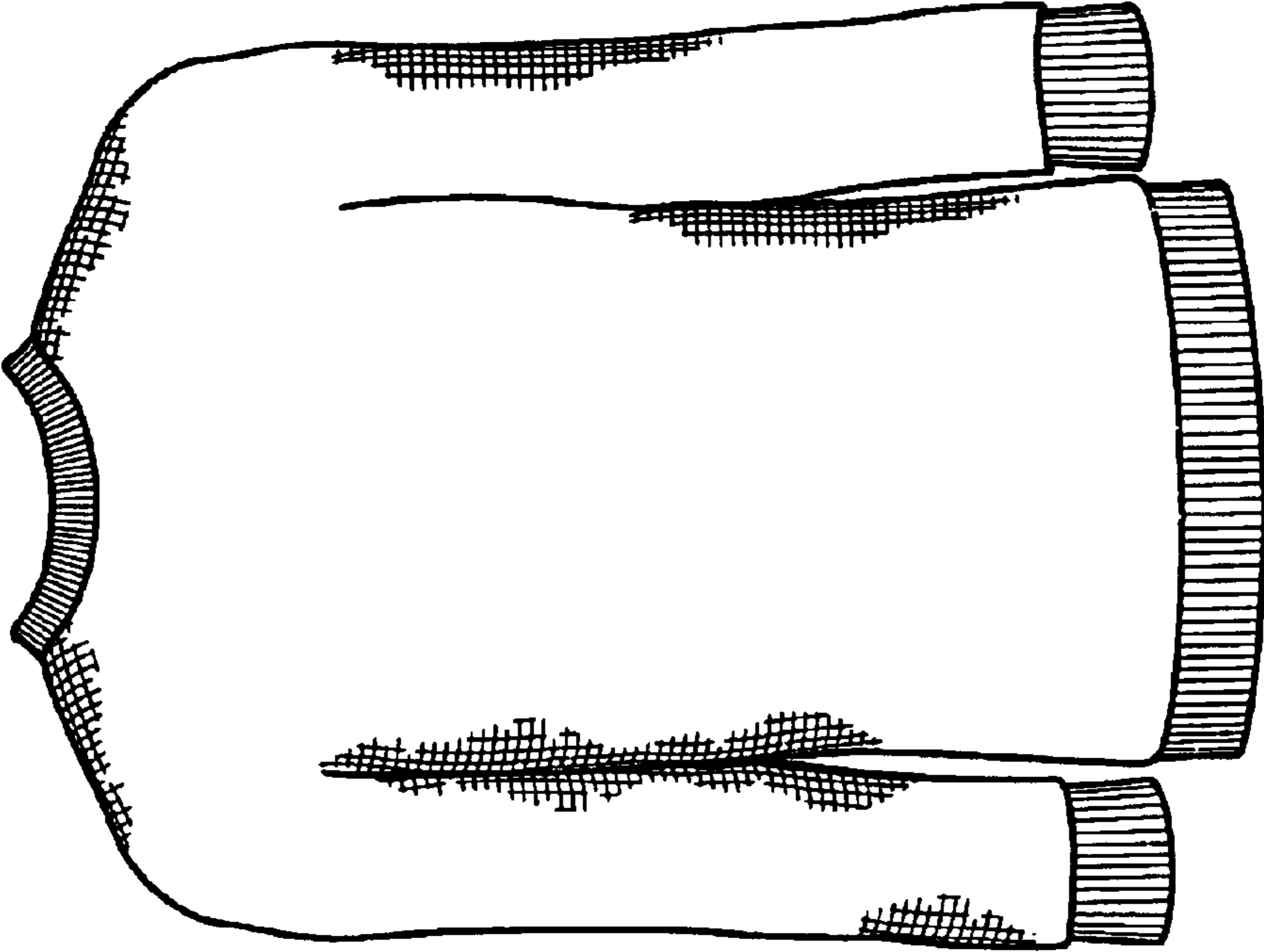

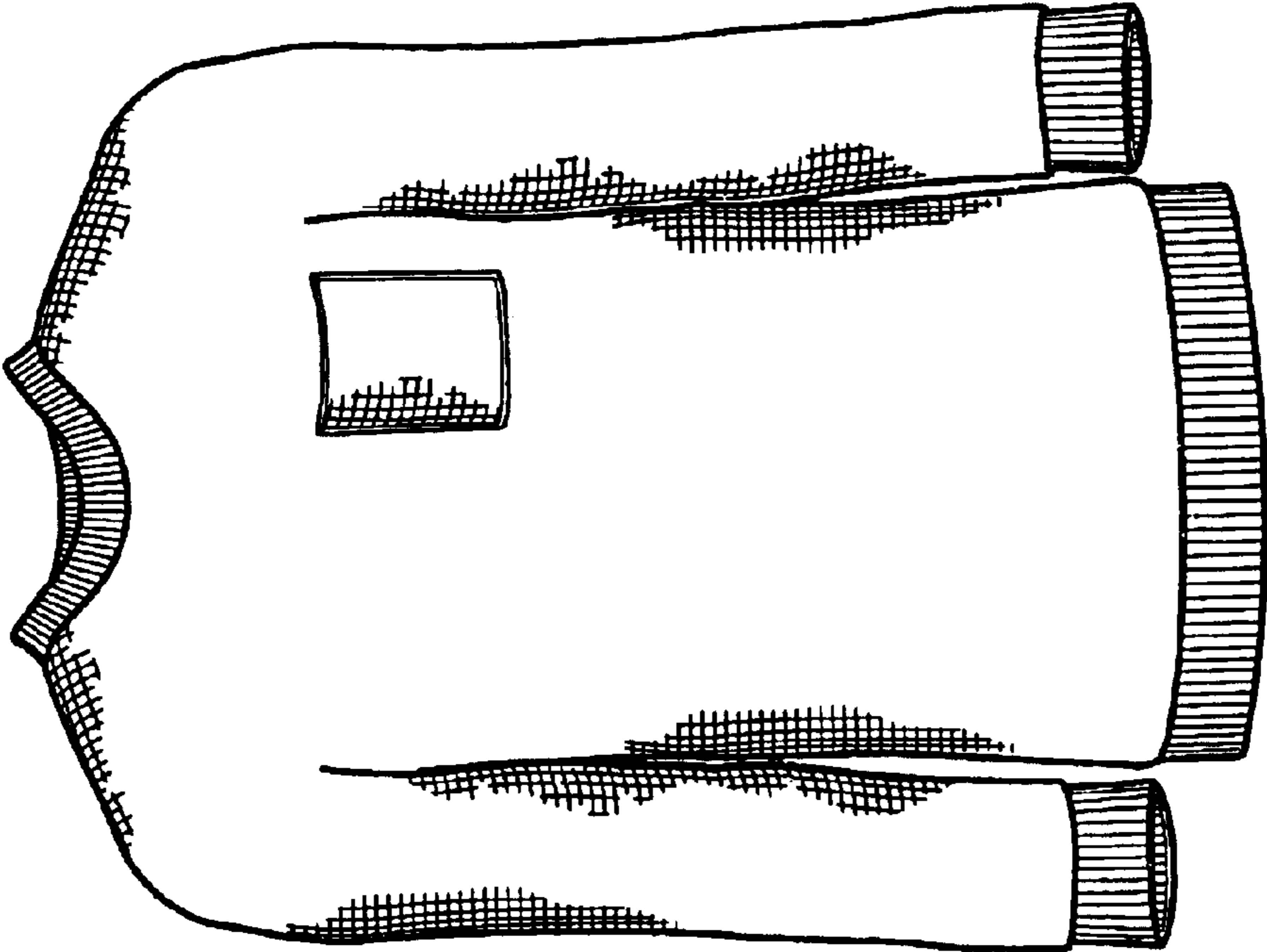

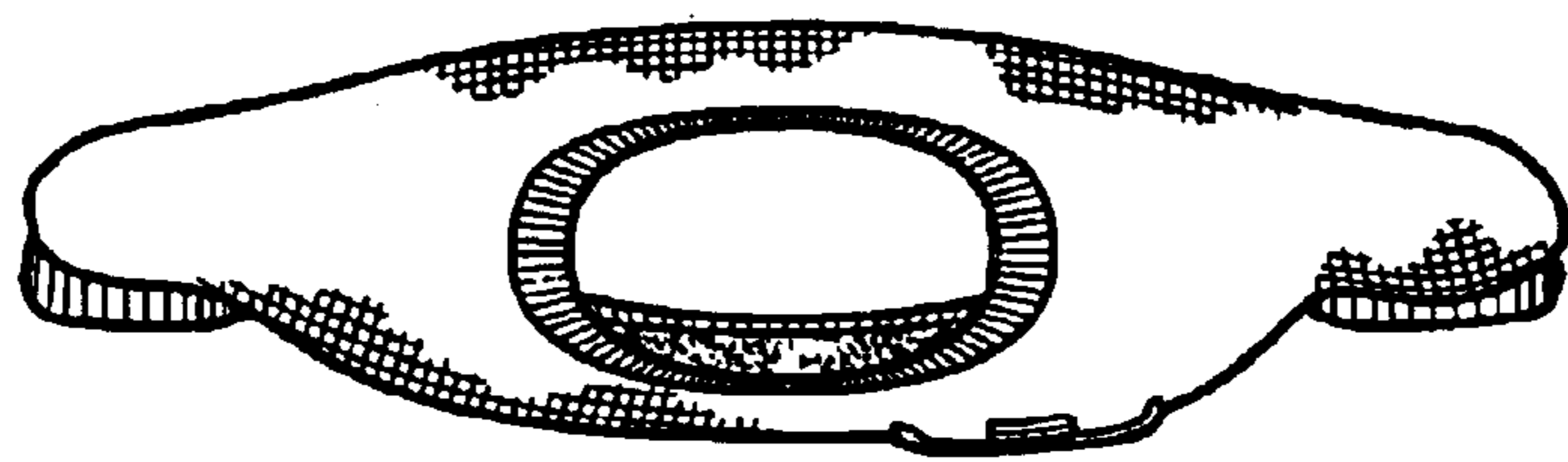
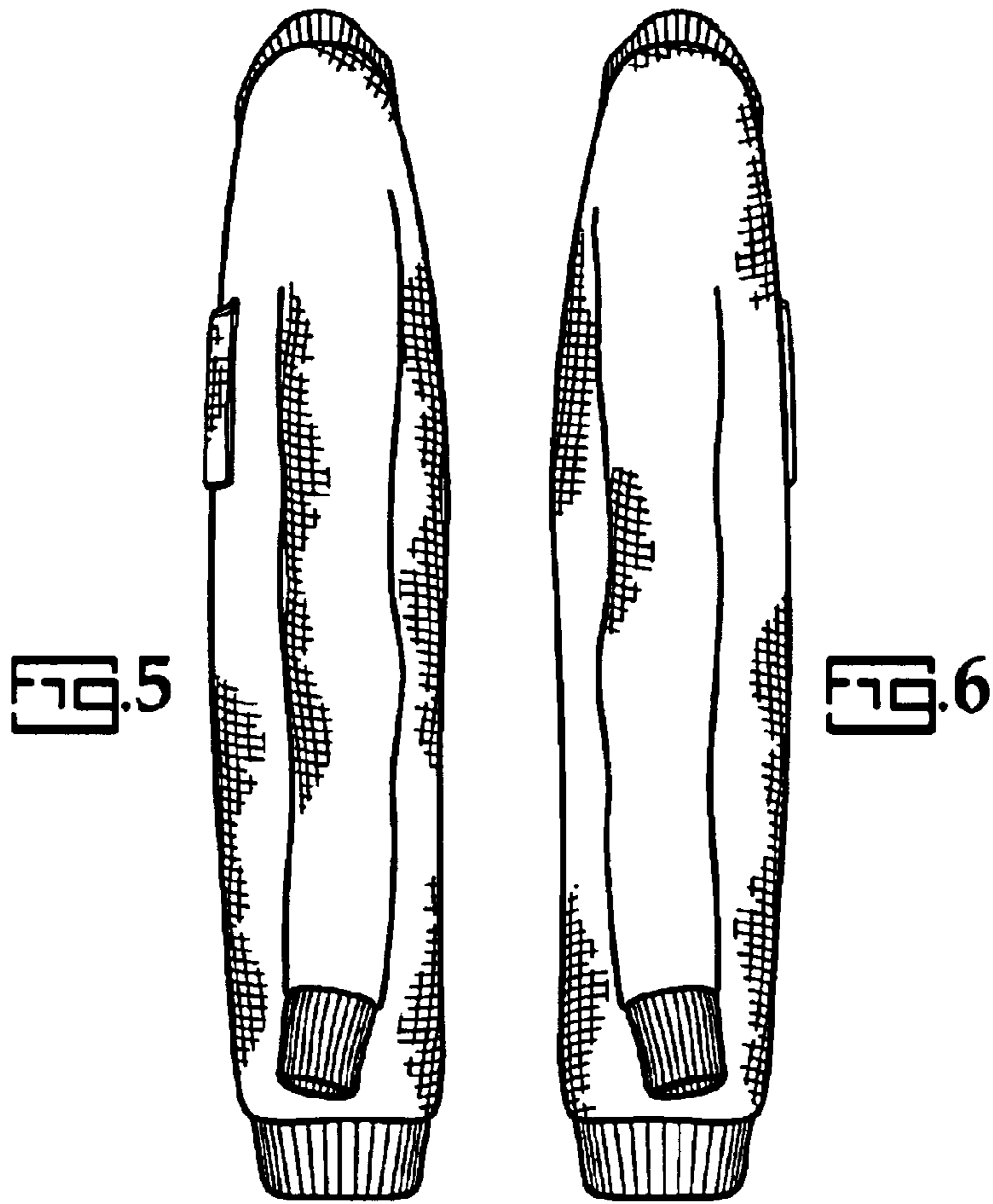

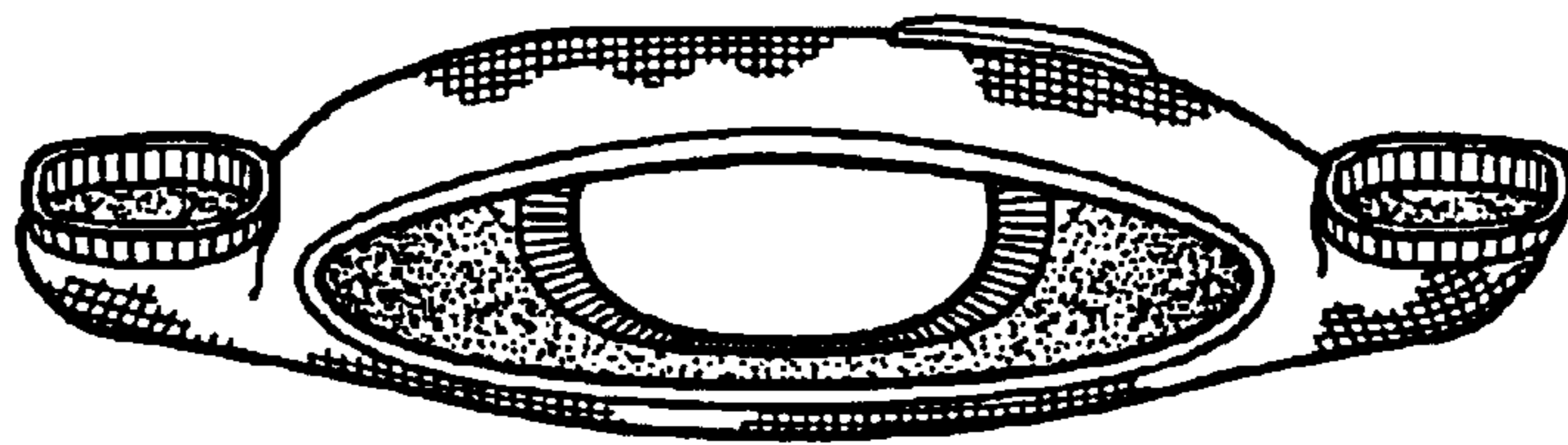
