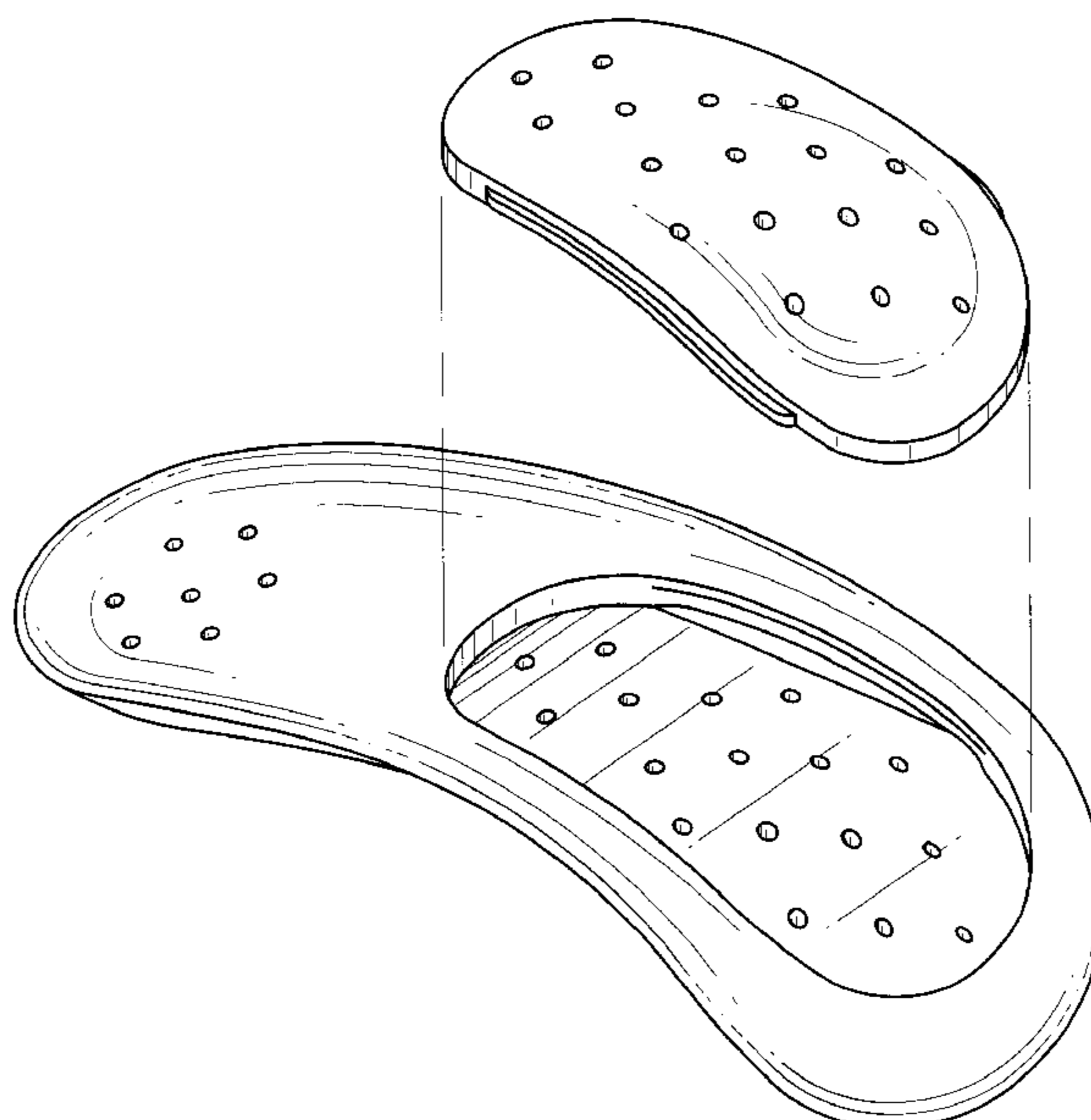
(57) **CLAIM**

I claim the ornamental design for the orthotic with insert, as shown and described.

DESCRIPTION

FIG. 1 is an exploded perspective view of an orthotic with insert showing my new design in accordance with a preferred embodiment;
FIG. 2 is a left side elevational view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a front view thereof; and,
FIG. 7 is a rear view thereof.

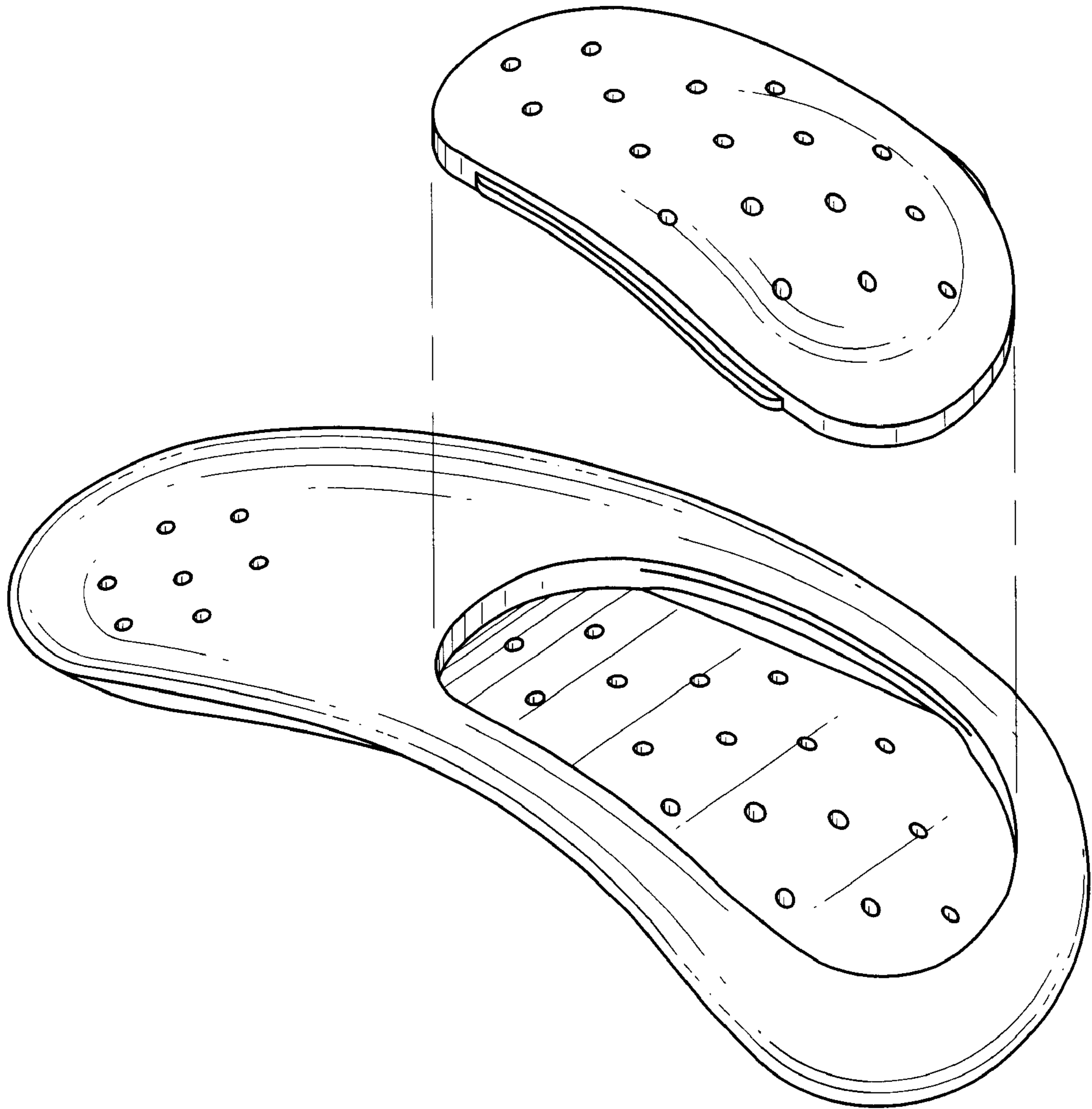

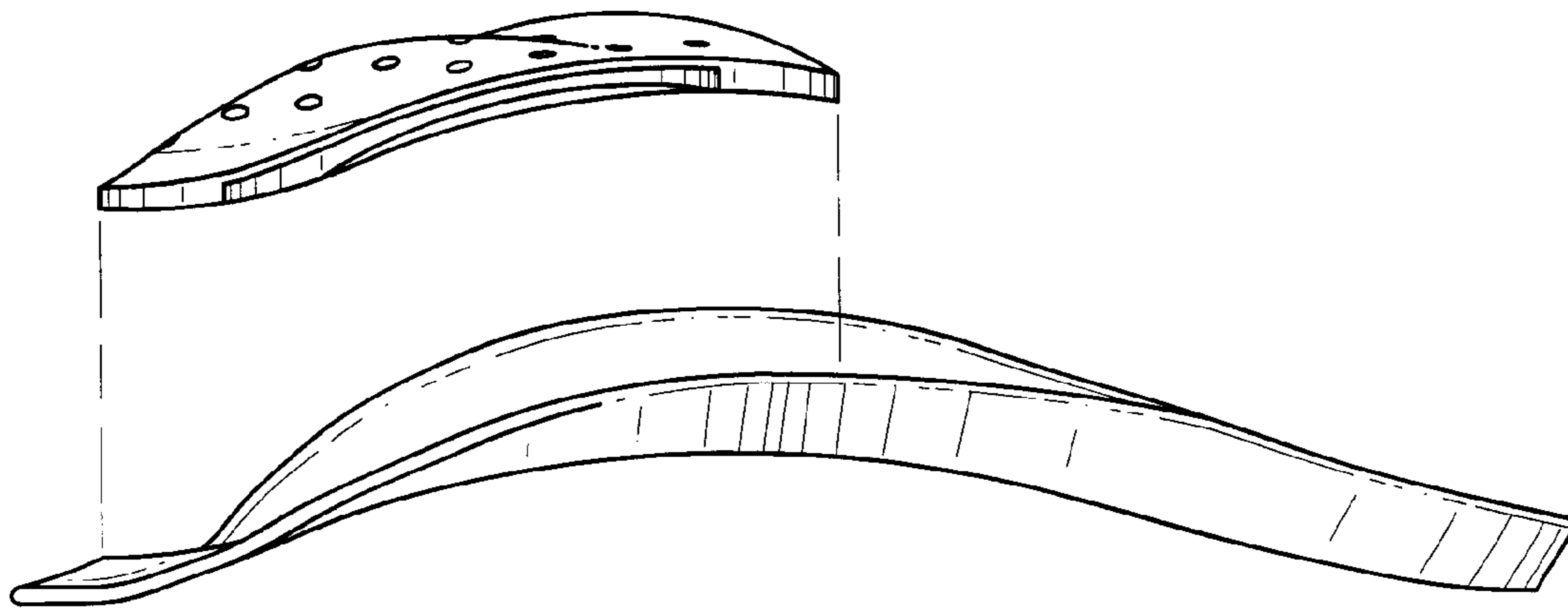

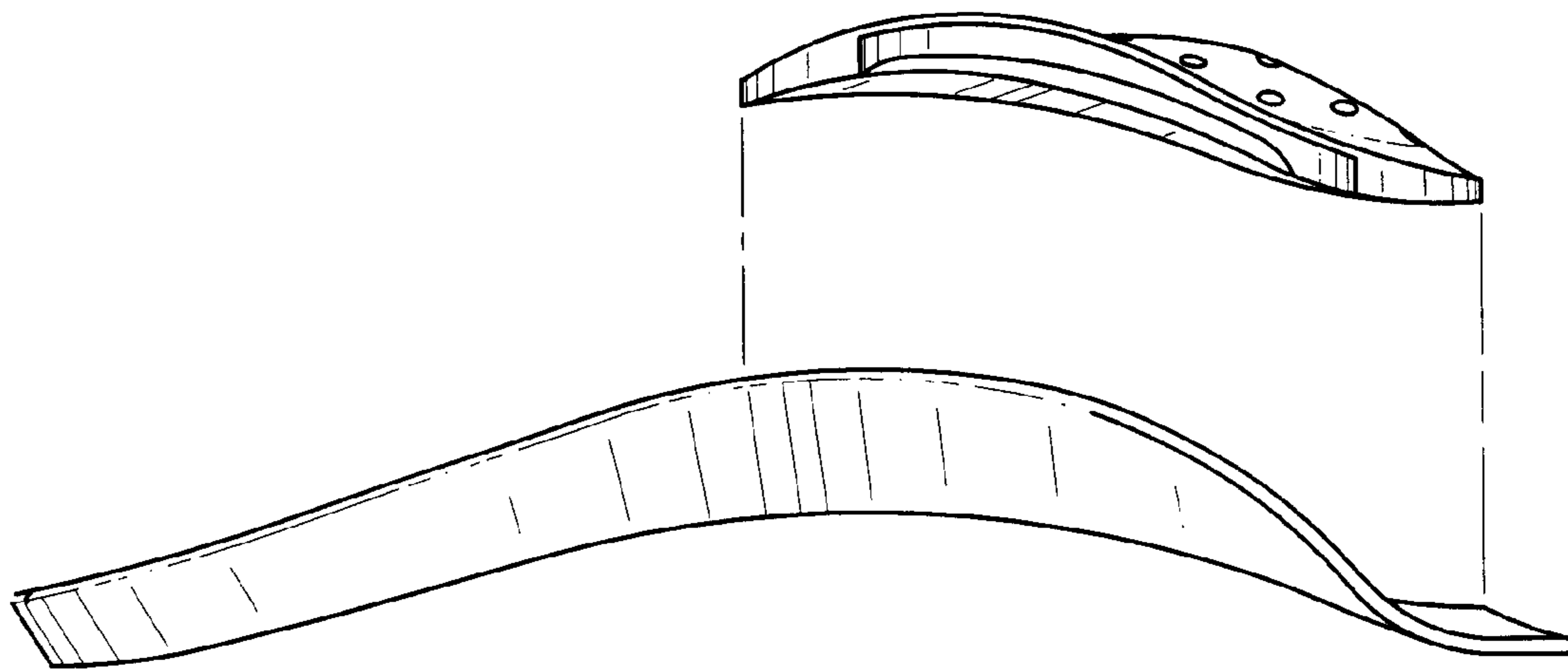

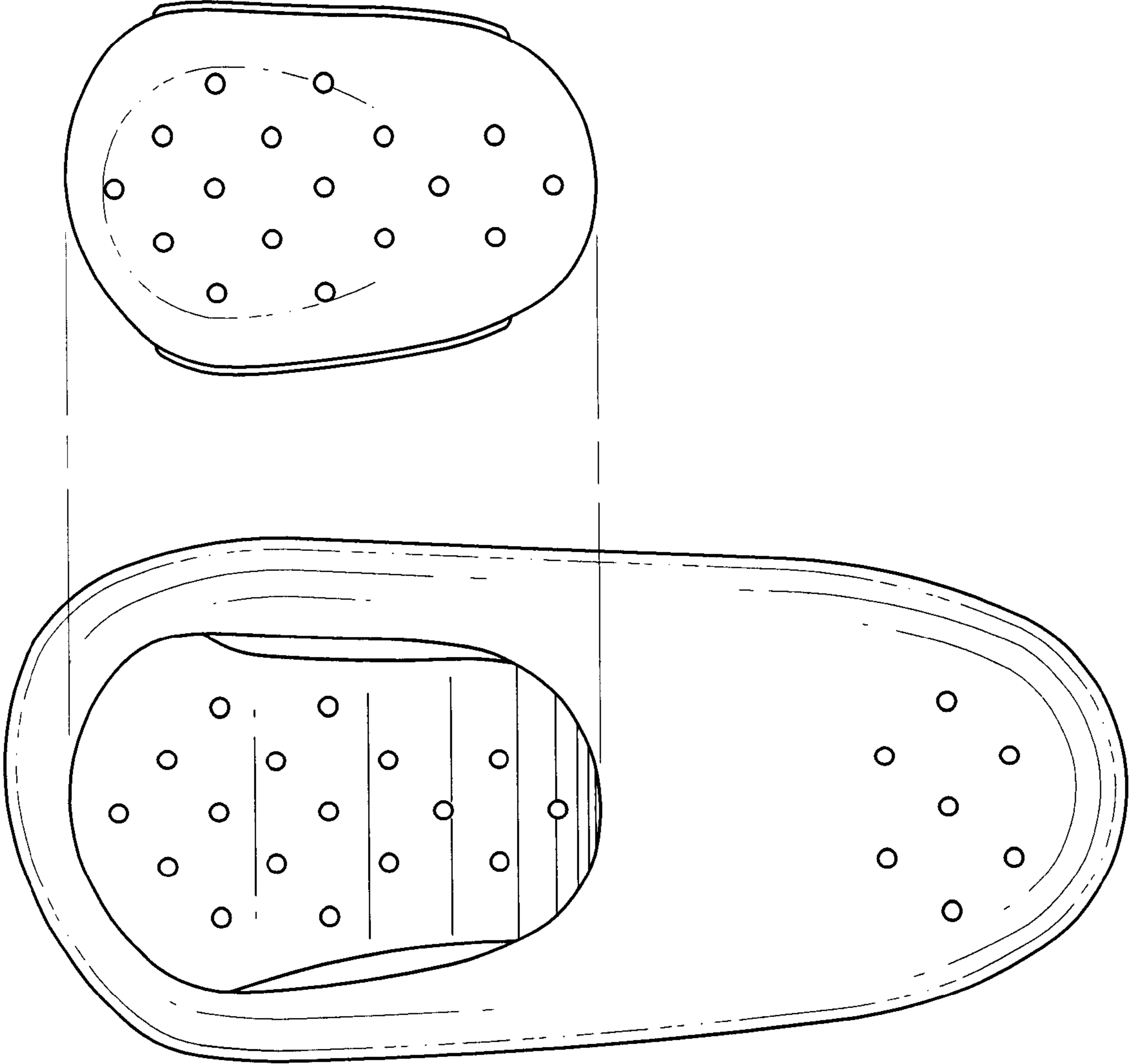

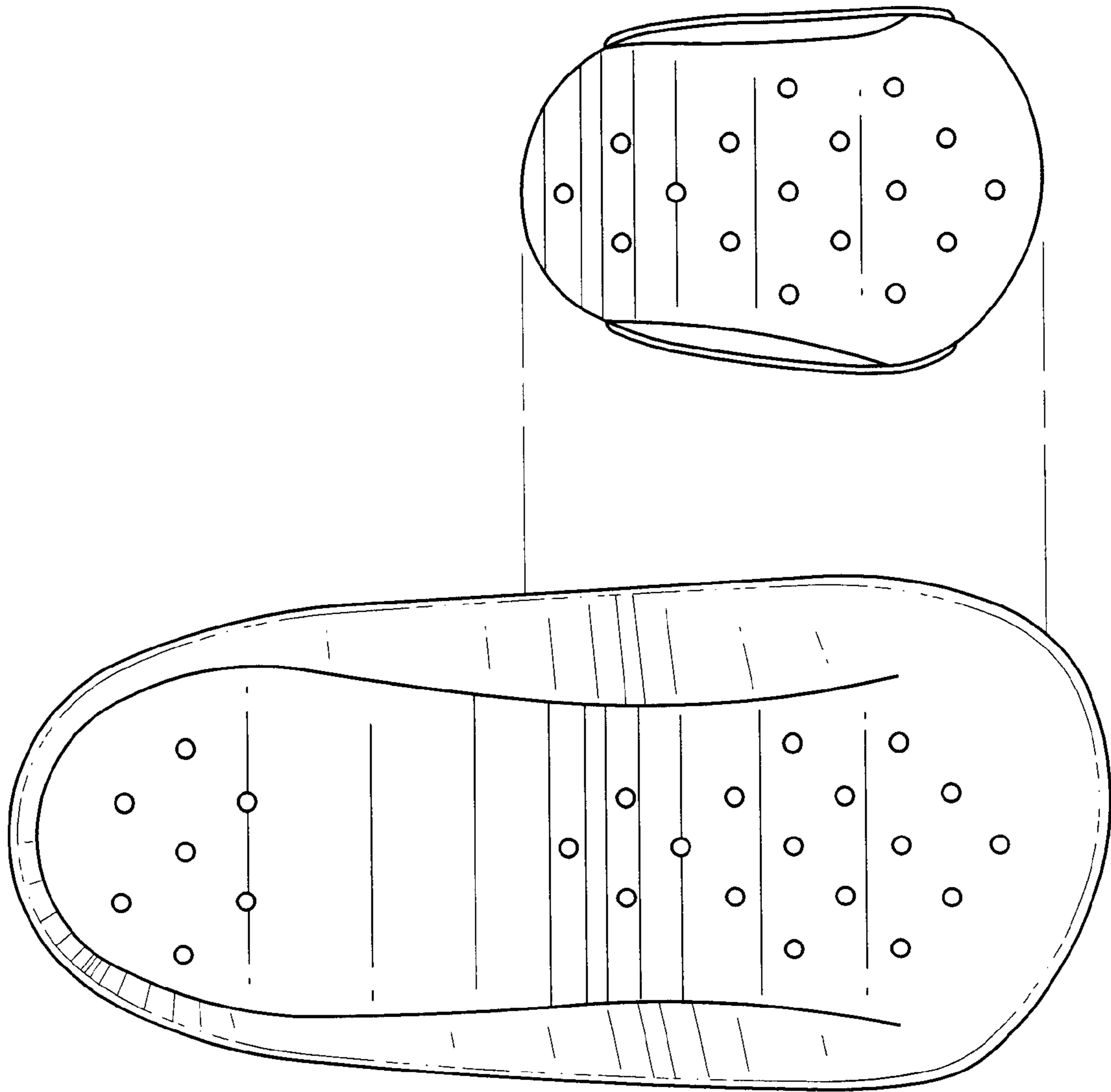

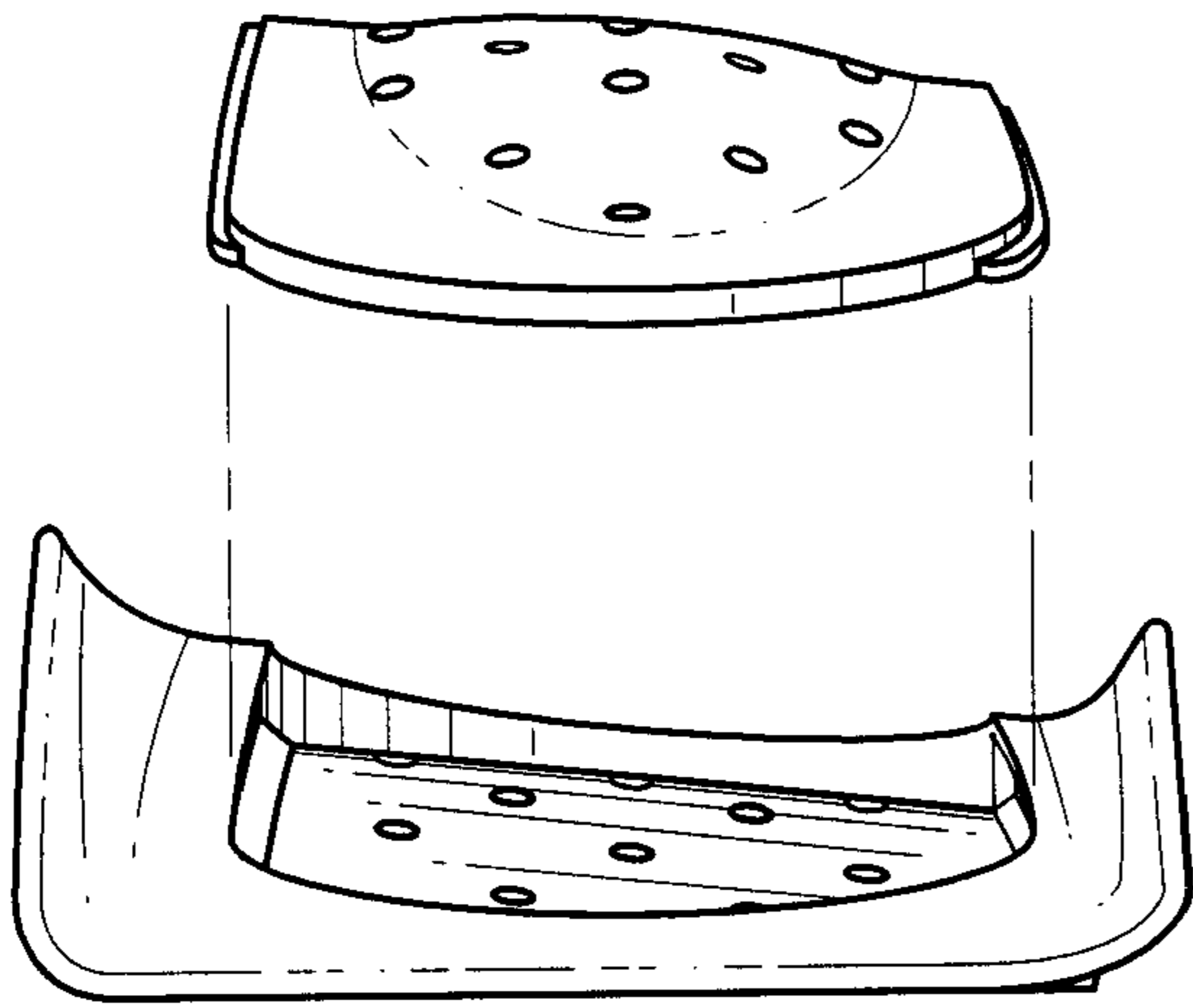

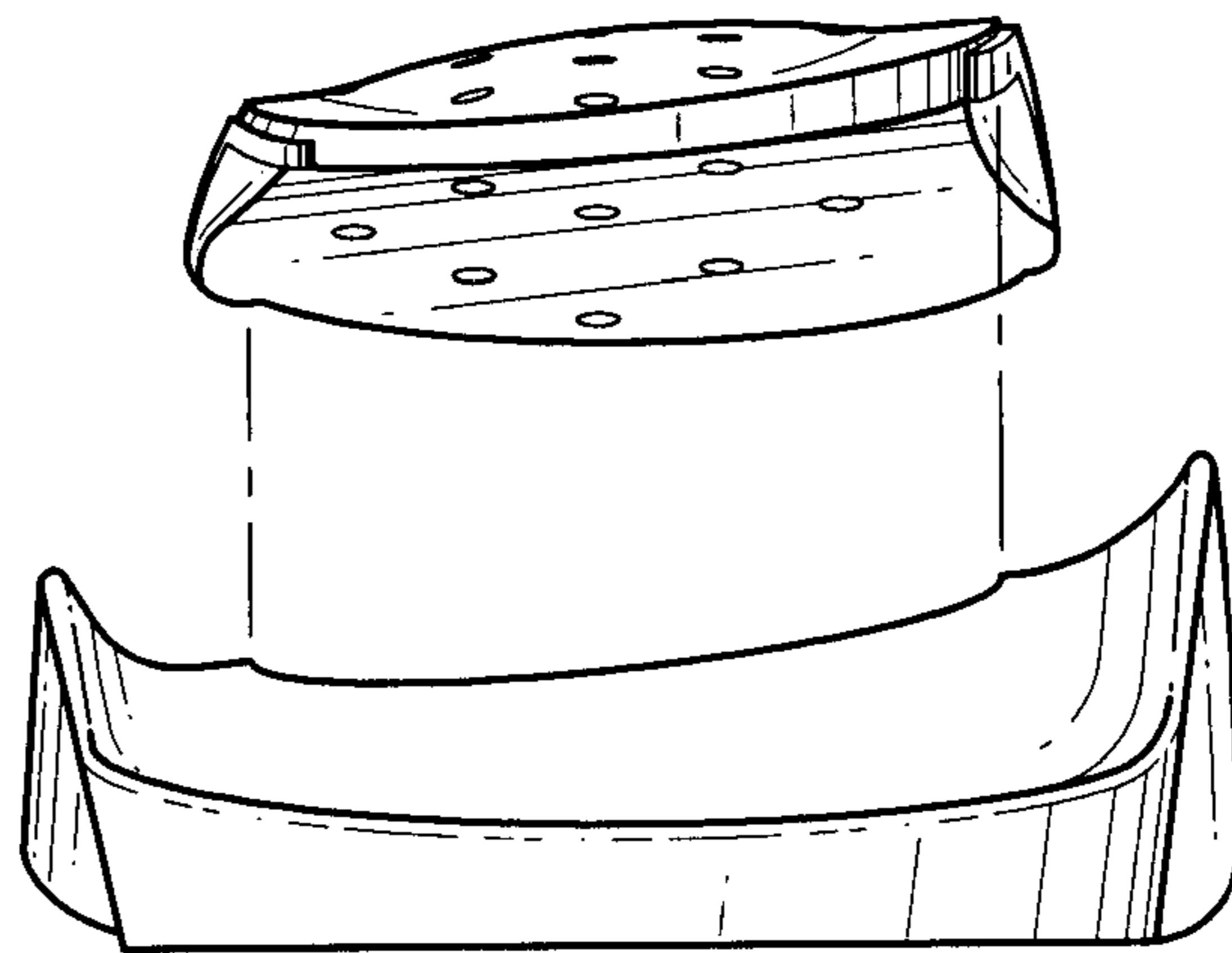
