(57) **CLAIM**

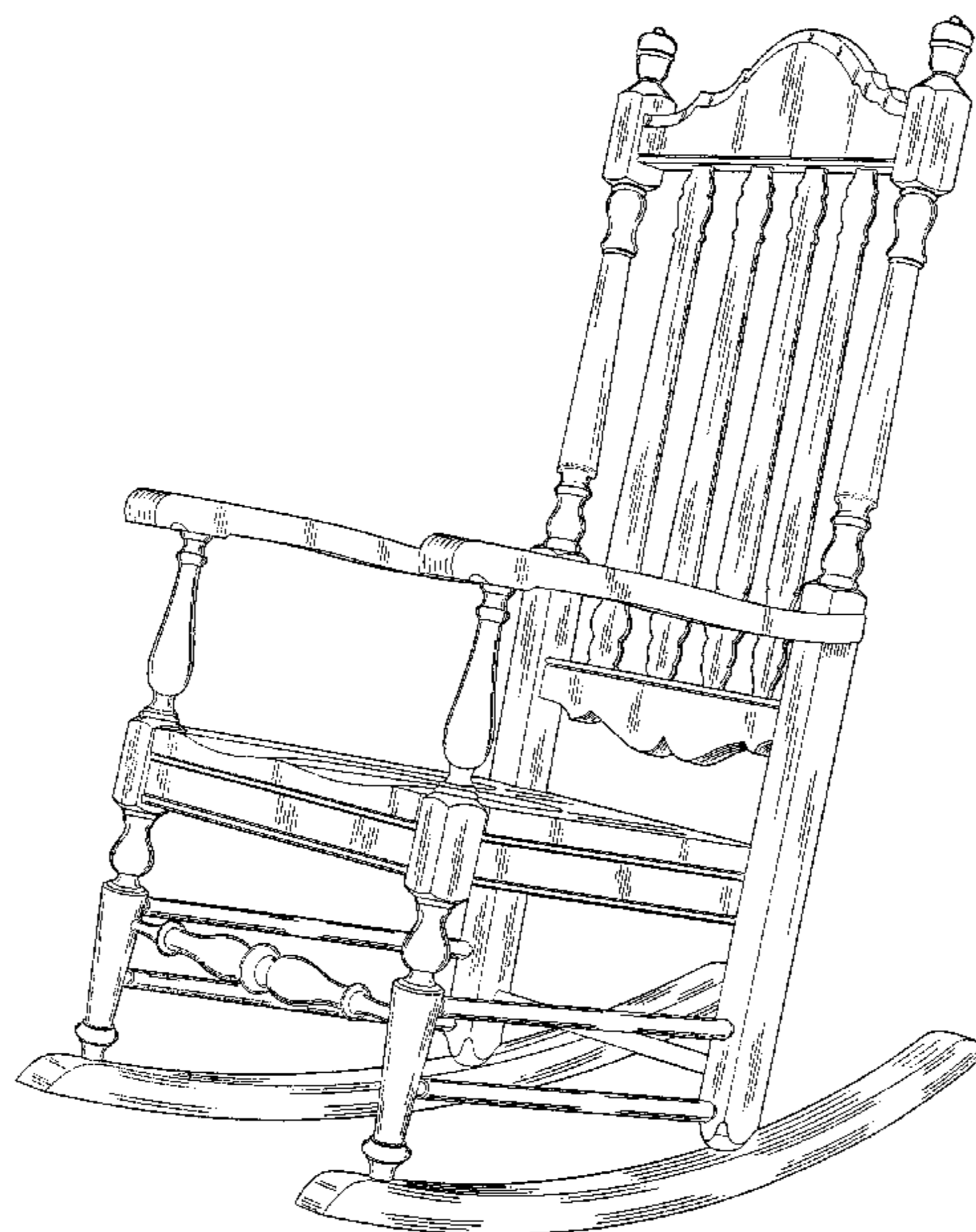
The ornamental design for a rocking chair, as shown and described.

FIG. 1 is a perspective view of a rocking chair showing our new design;
FIG. 2 is a front elevational view thereof;

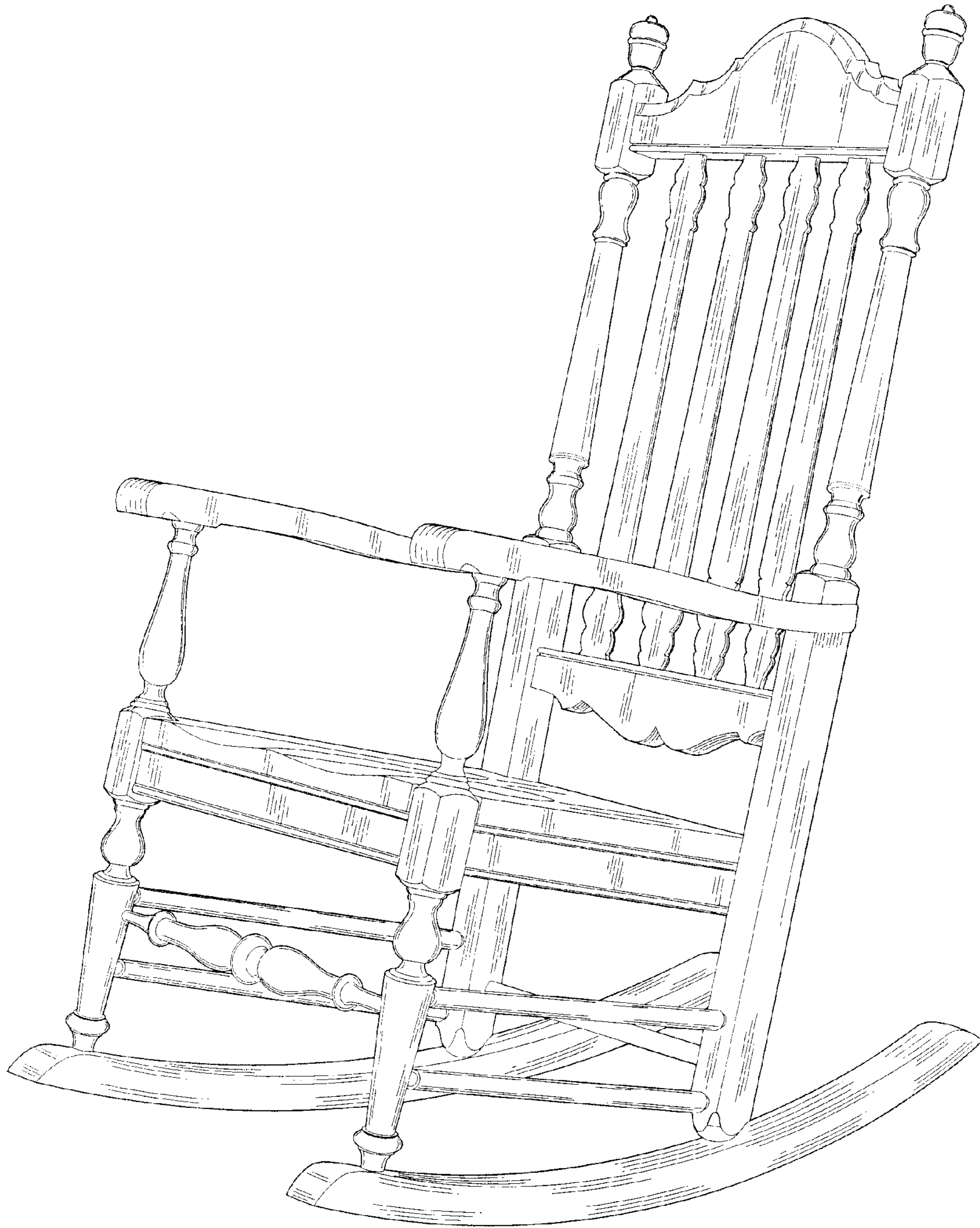

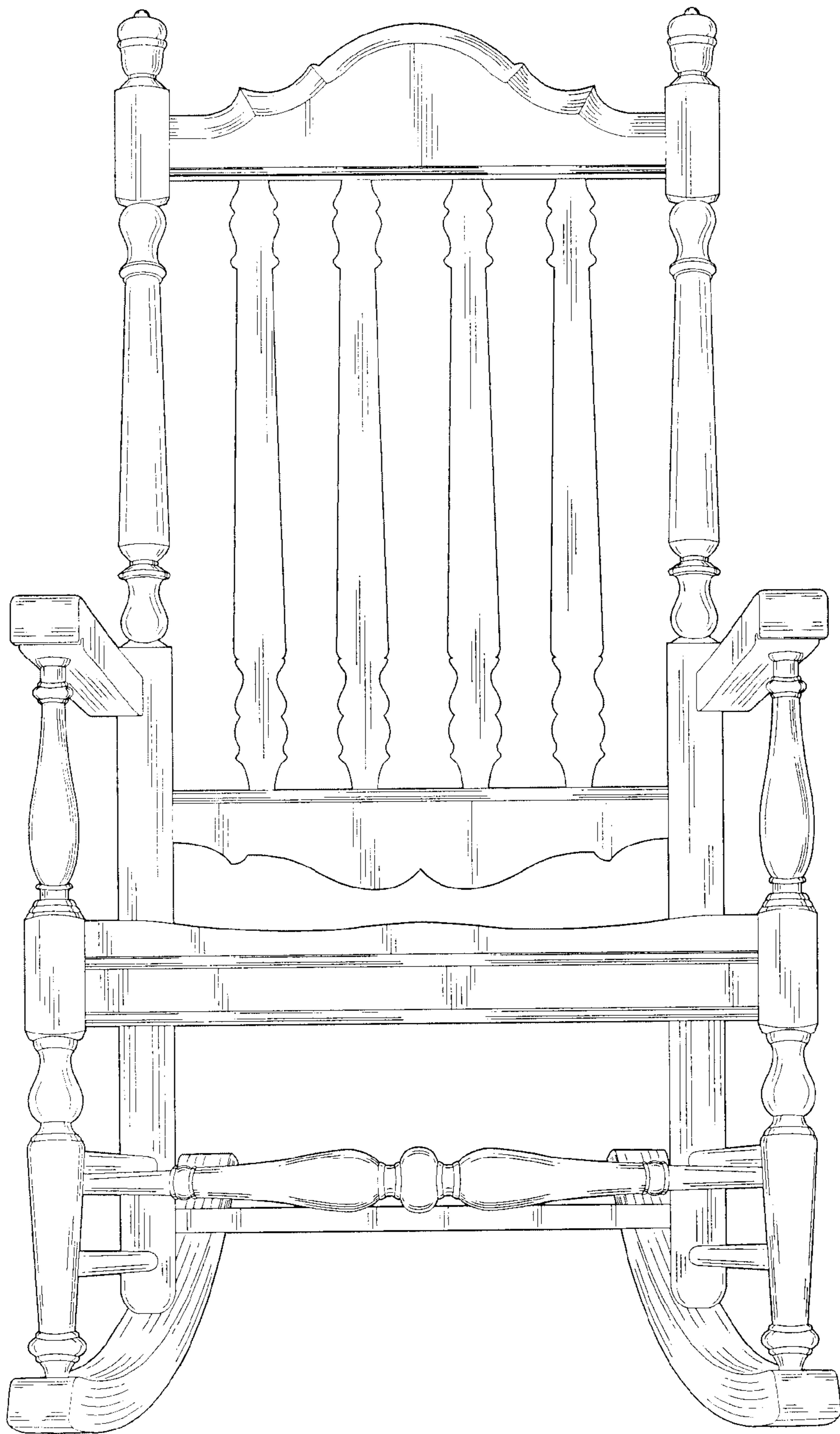

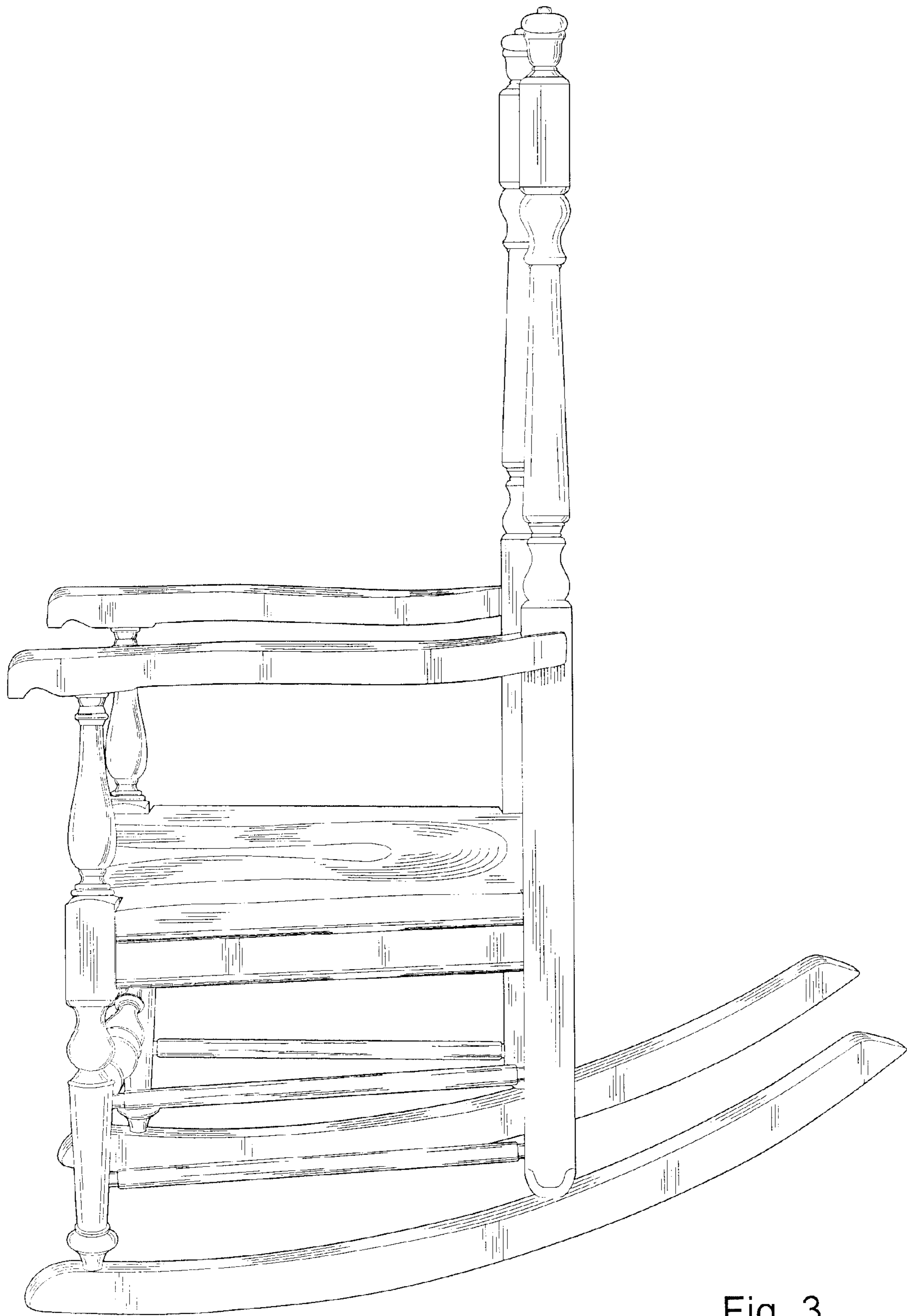

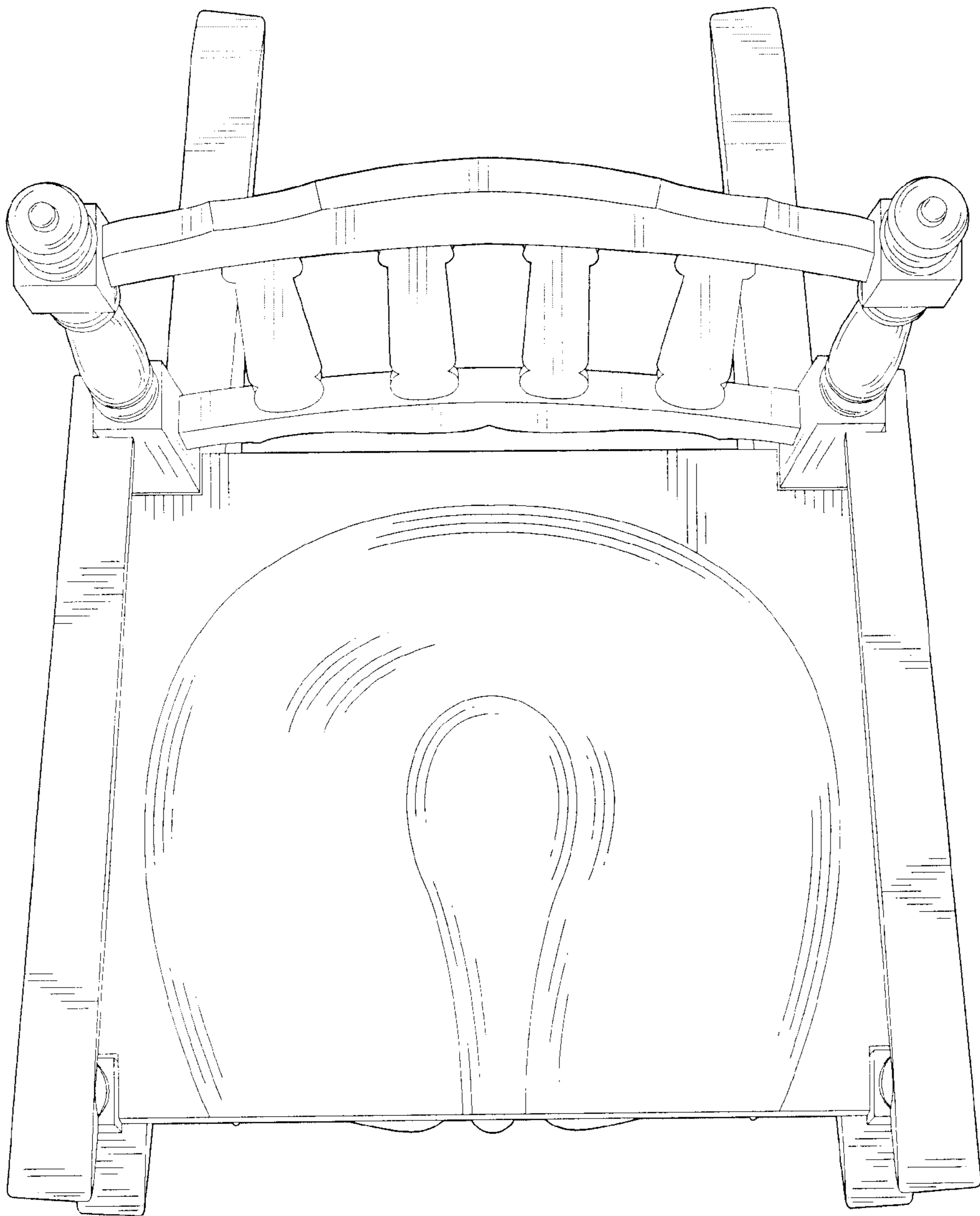
