bottle;

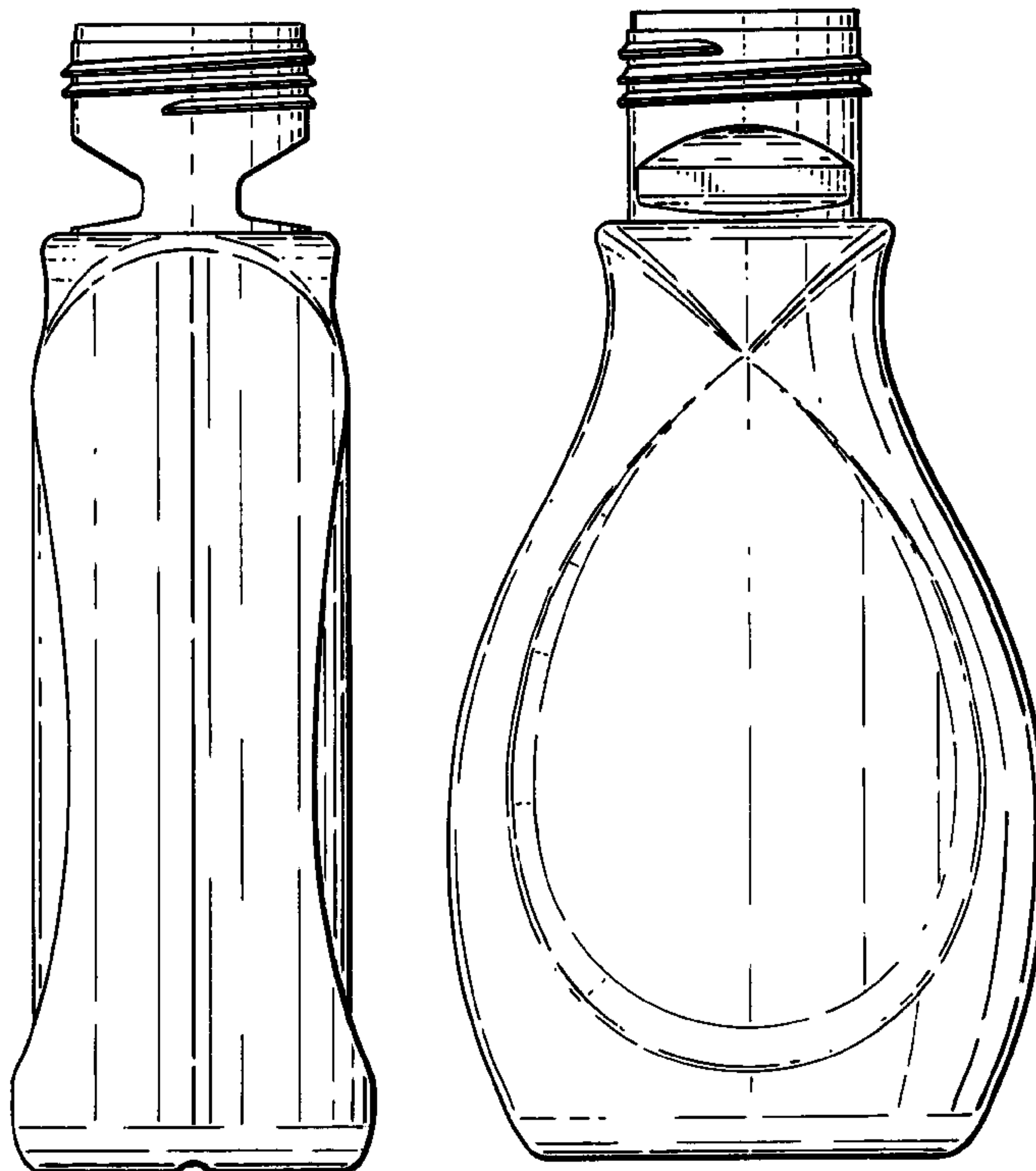
FIG. 2 is a right side elevational view of the bottle;

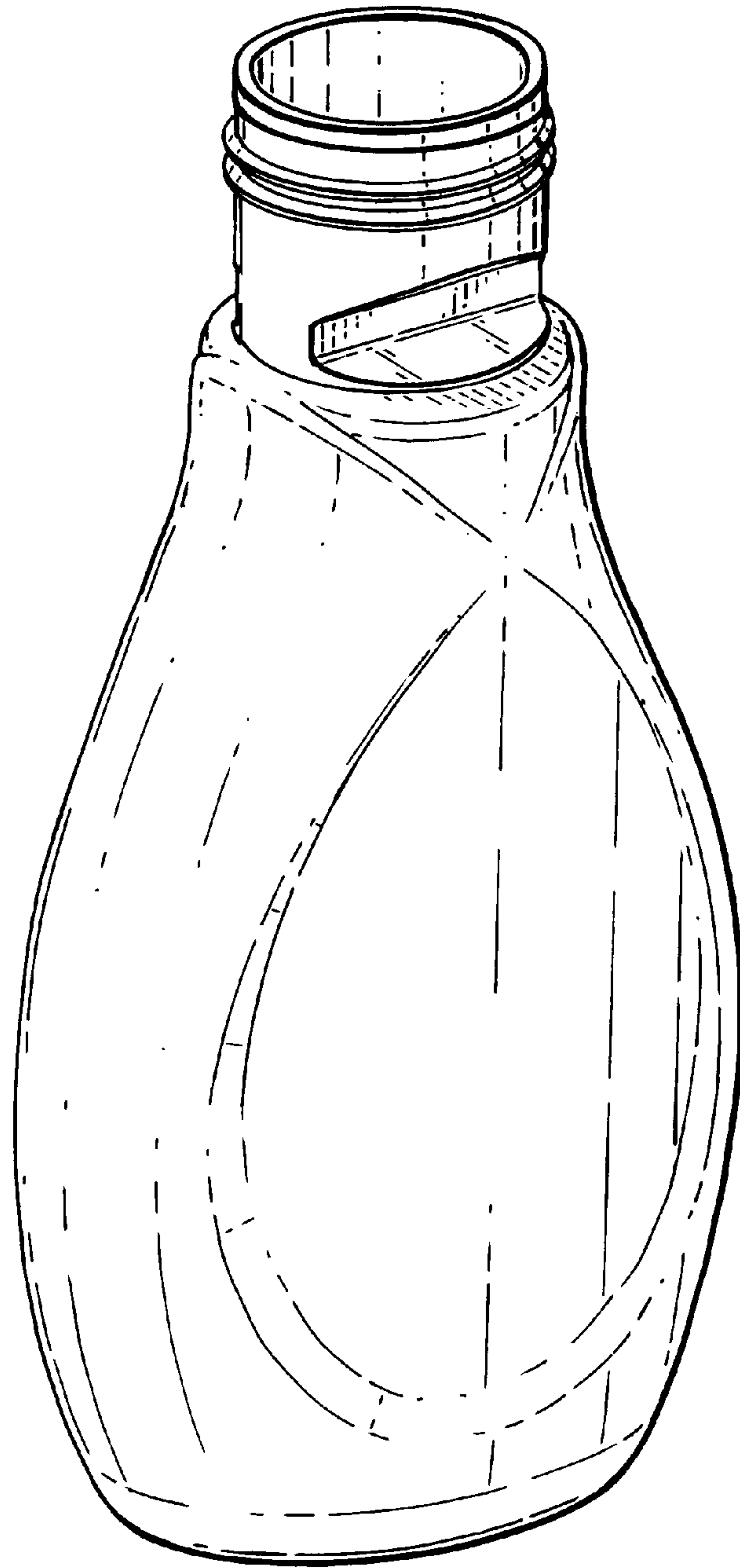

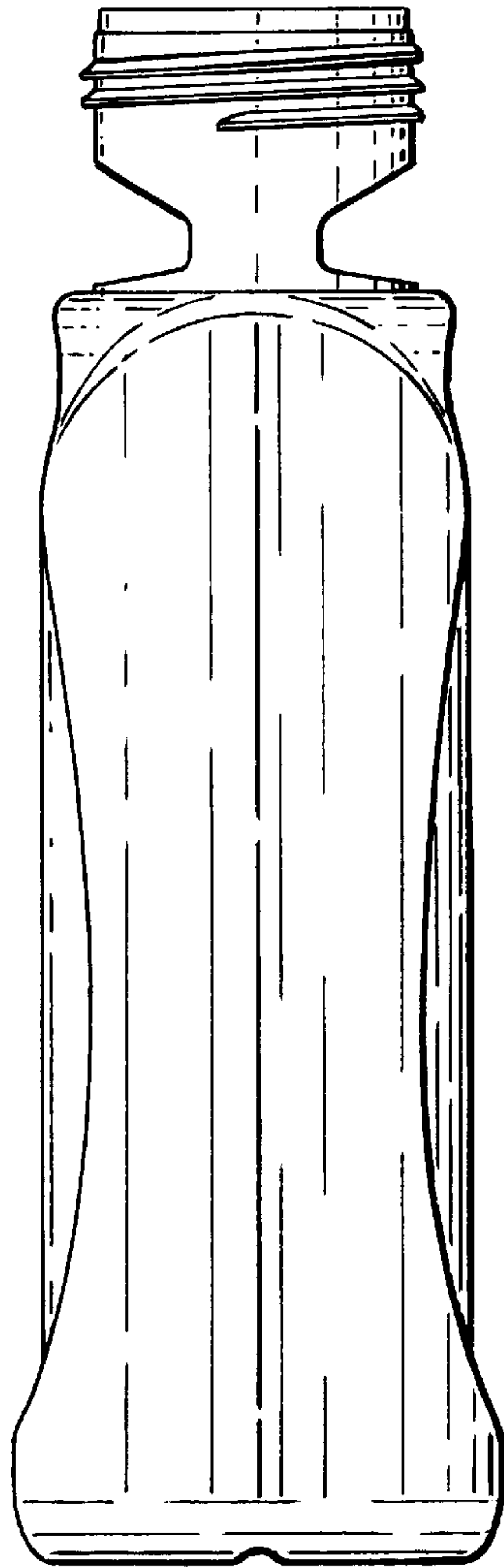

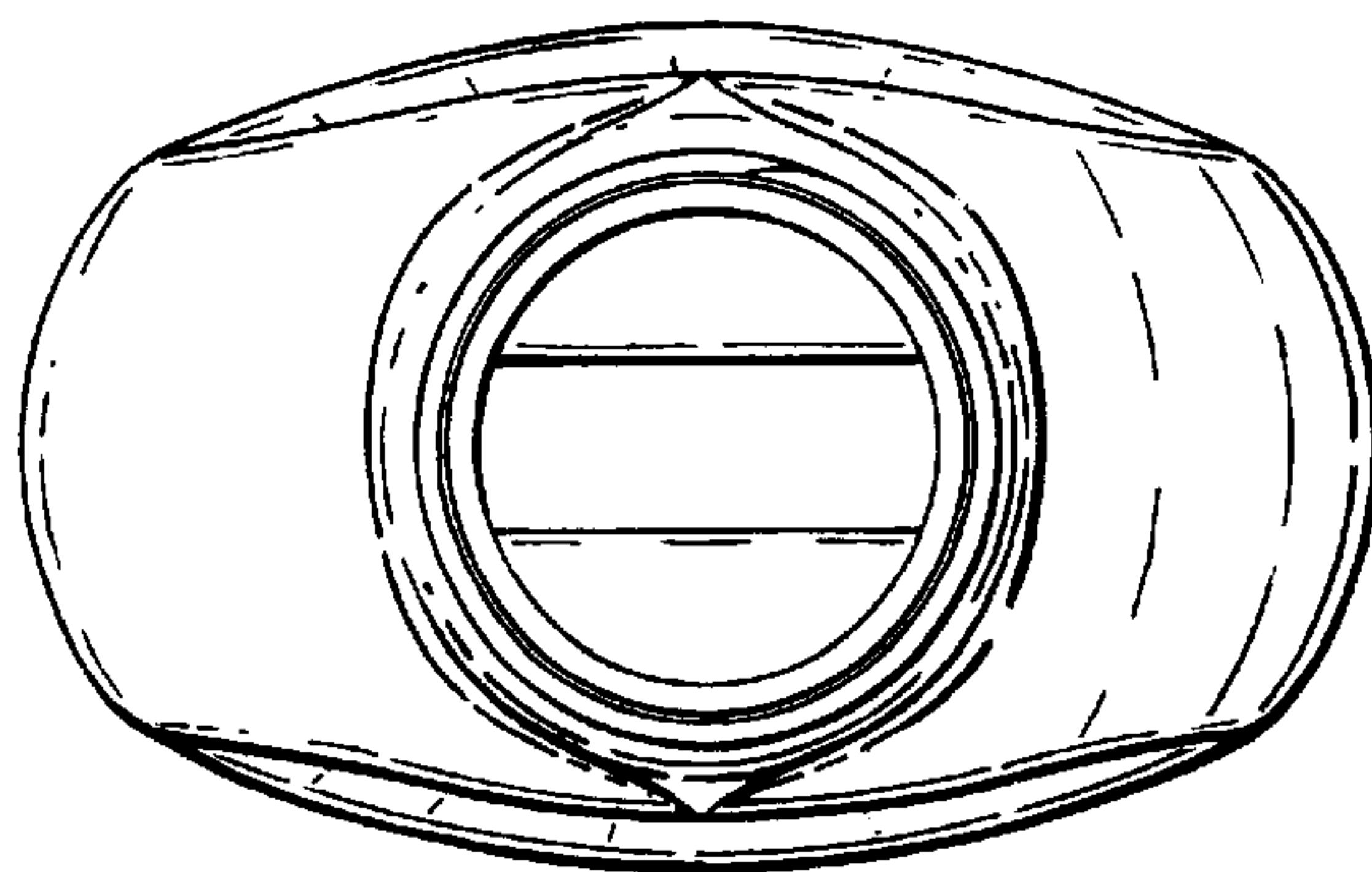

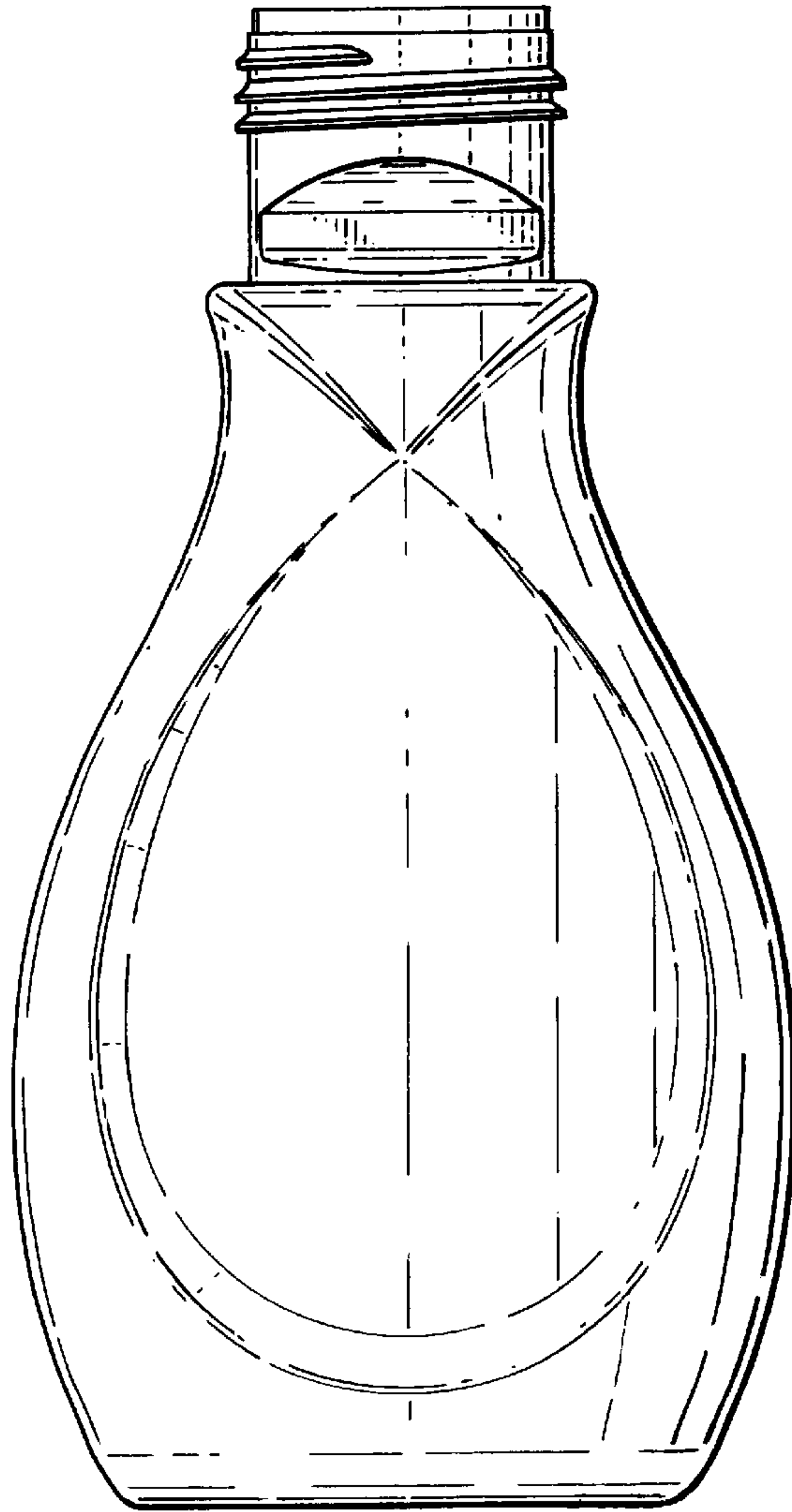

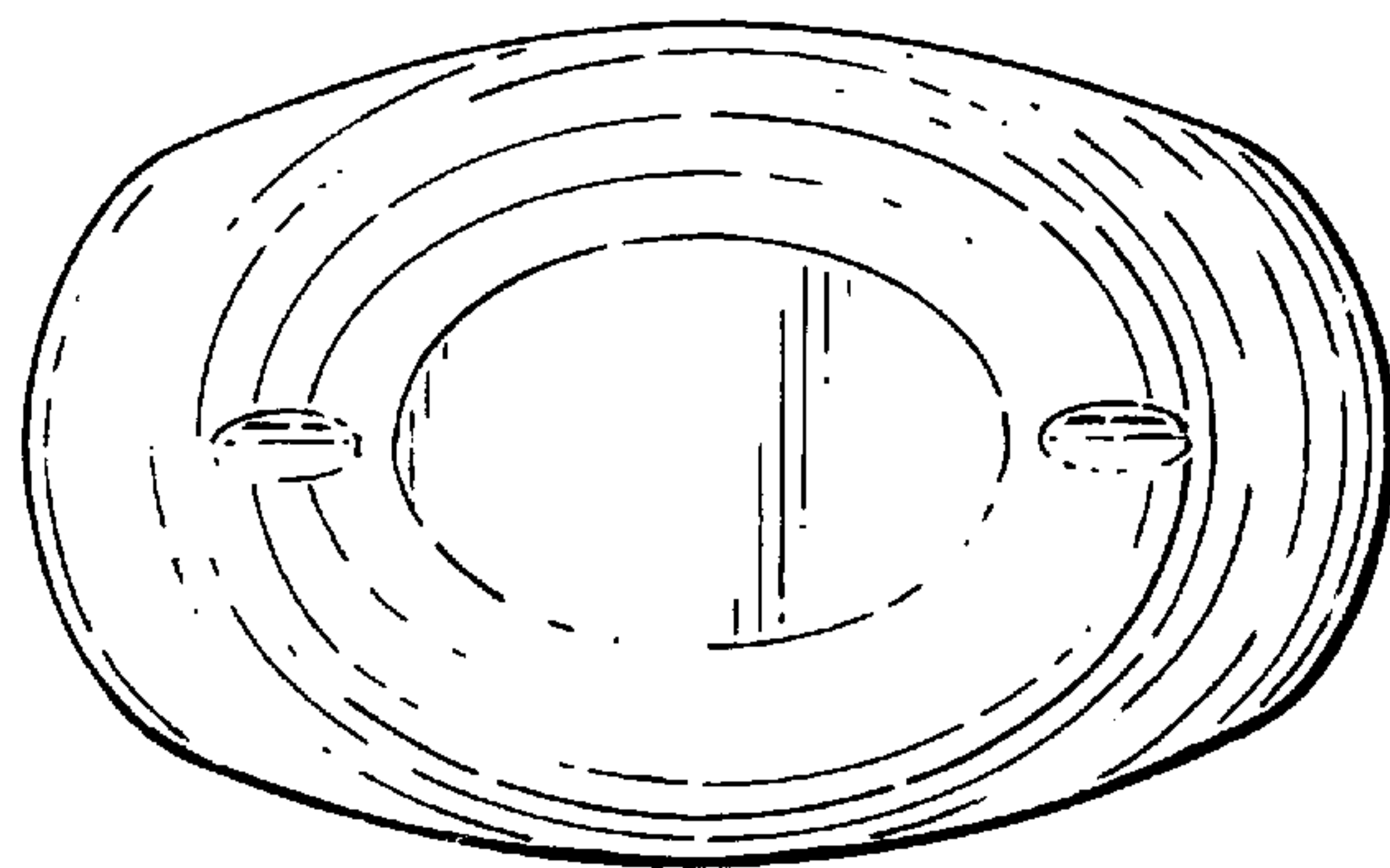
