(57) **CLAIM**

We claim the ornamental design for panels of a garment, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of our new design for panels of a garment;

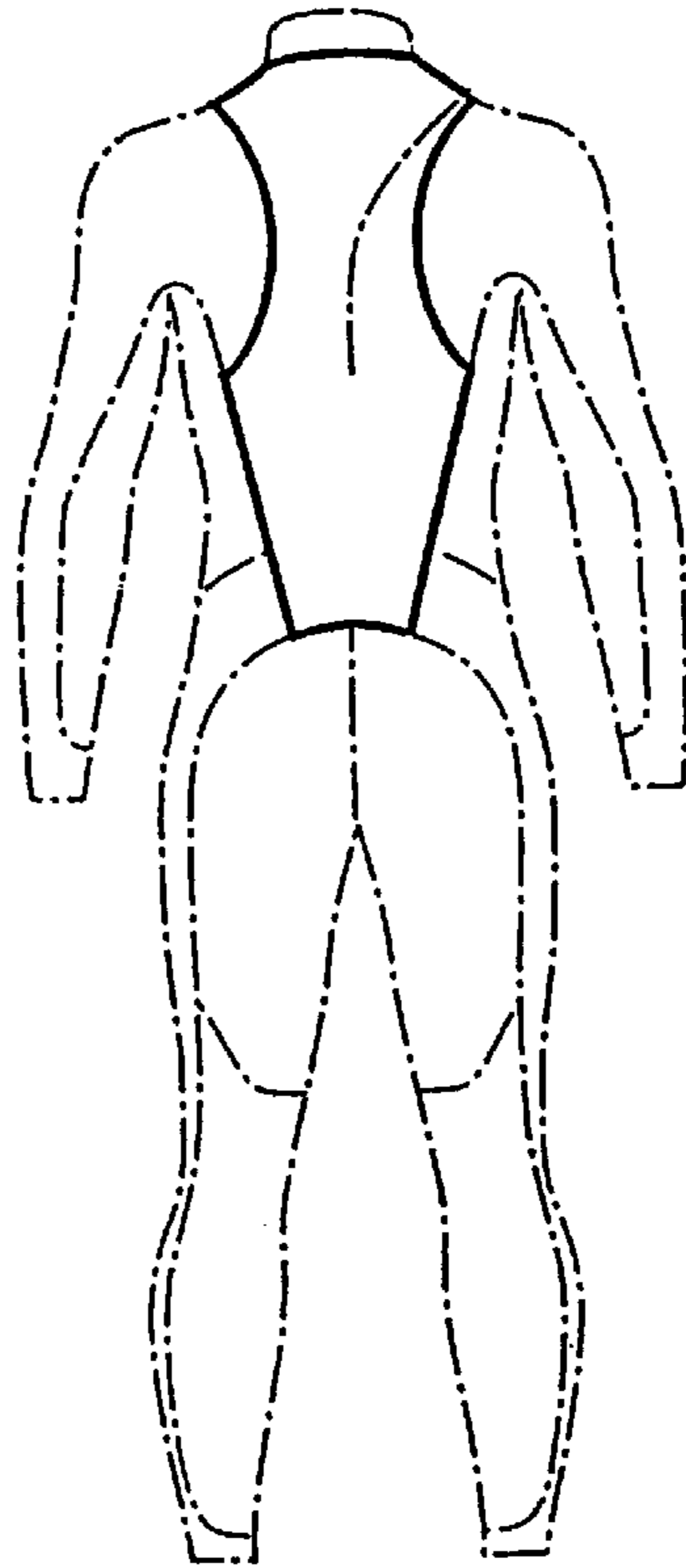
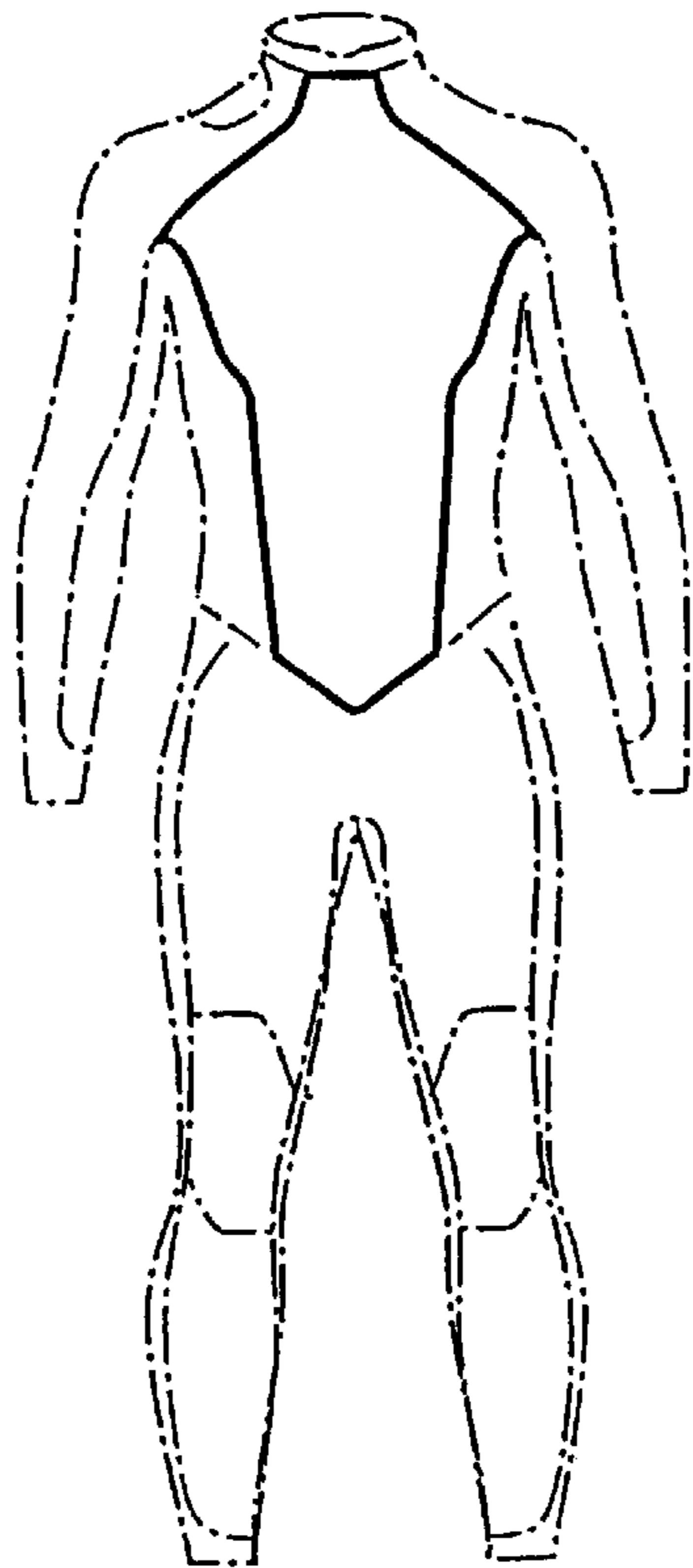
FIG. 2 is a rear view thereof; and,

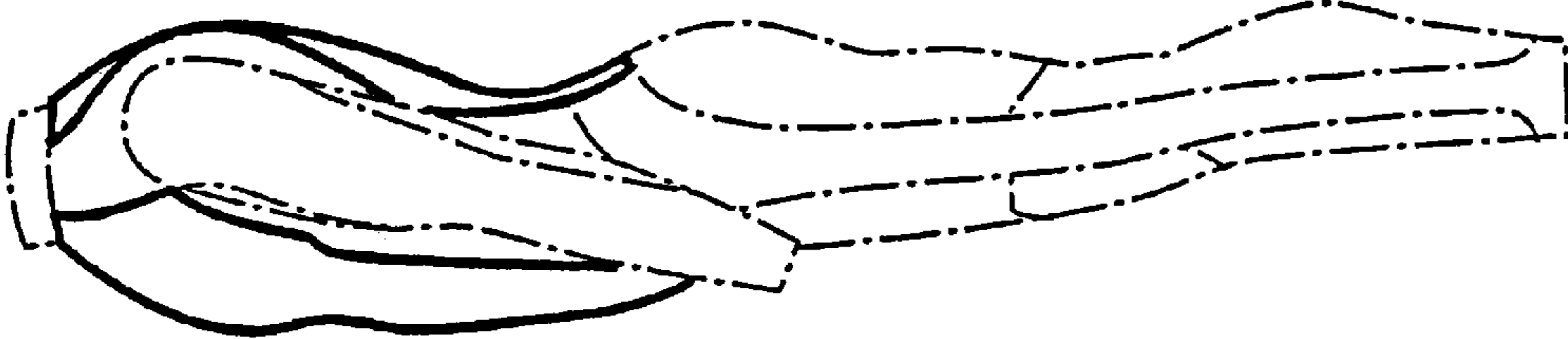

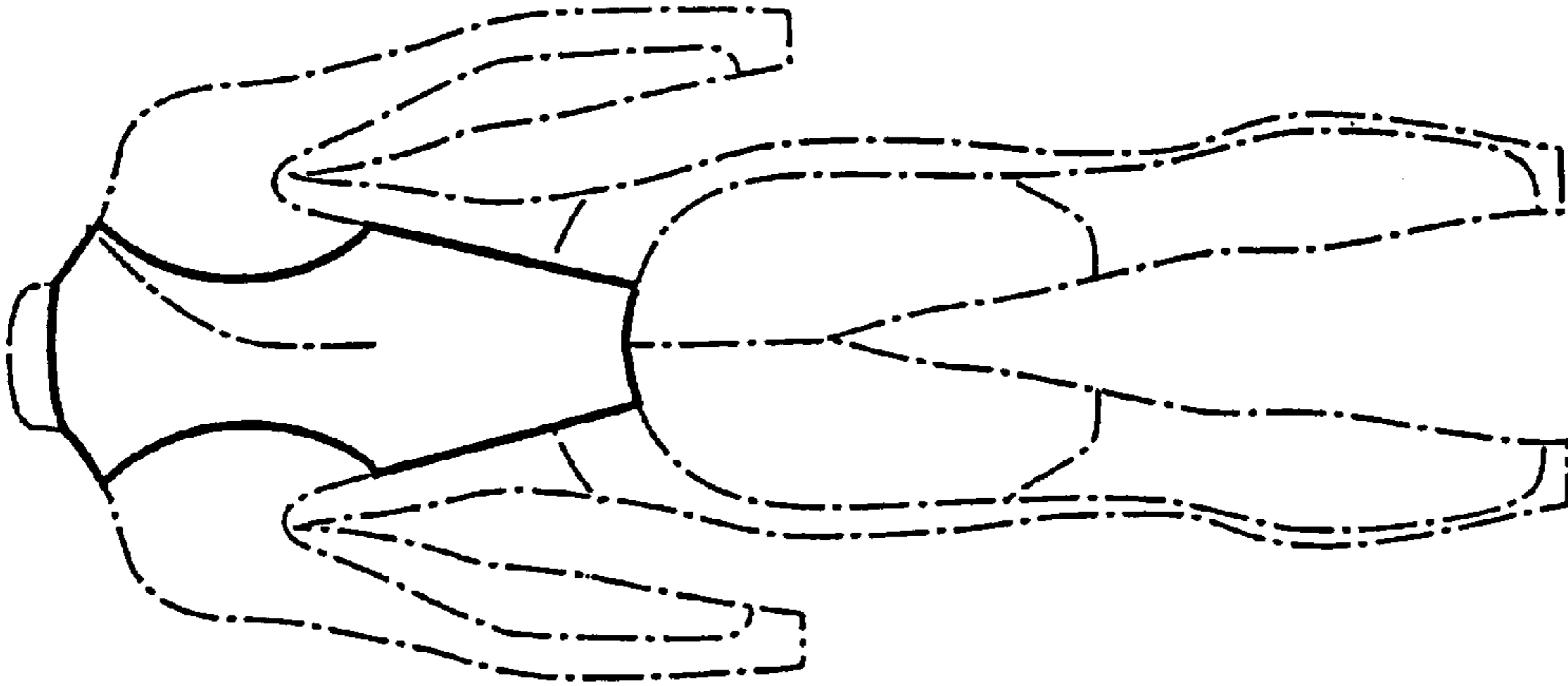

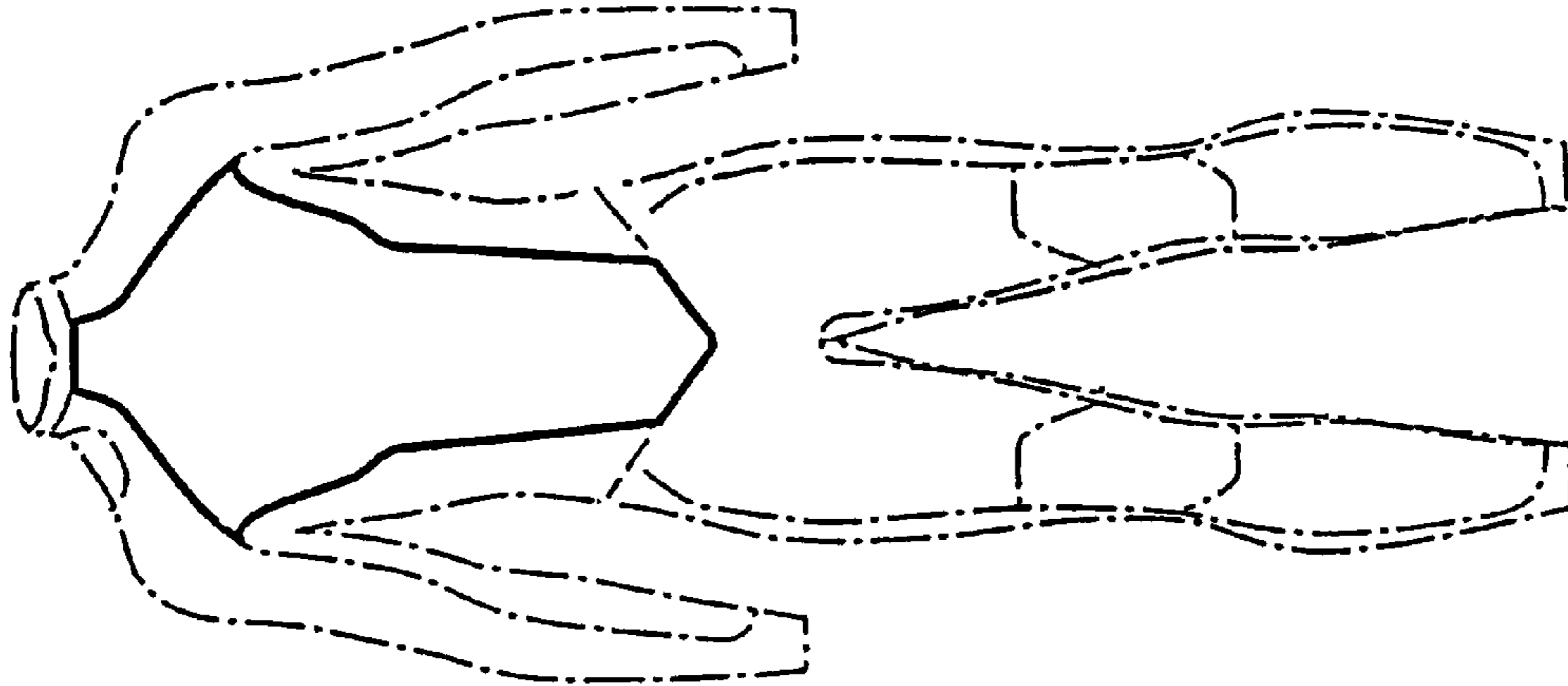
