(57) **CLAIM**

The ornamental design for a portion of a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a portion of a shoe upper showing my new design with the flaps being shown in a first position;

FIG. 2 is a rear perspective view thereof;

FIG. 3 is a first side elevational view thereof;

FIG. 4 is a second side elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a front elevational view thereof;

FIG. 7 is a front perspective view of the portion of a shoe upper of FIGS. 1-6 with the flaps being shown in a second position;

FIG. 8 is a rear perspective view thereof;

FIG. 9 is a first side elevational view thereof;

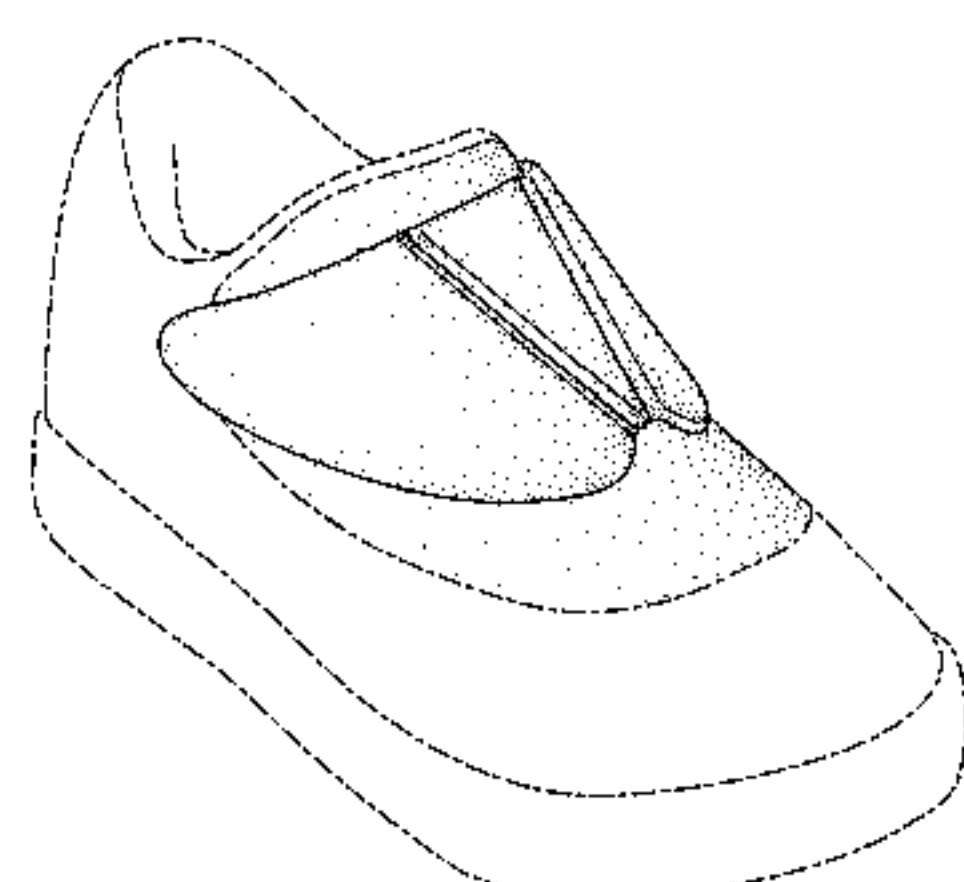
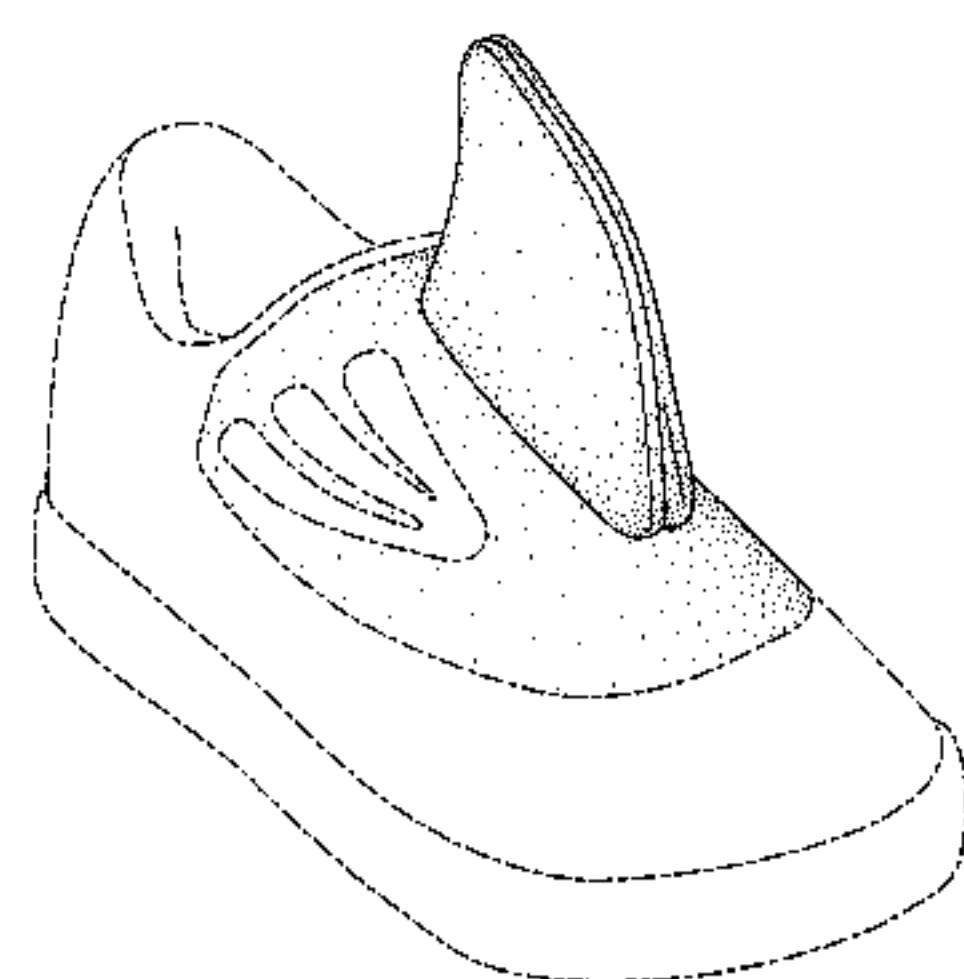
FIG. 10 is a second side elevational view thereof;

FIG. 12 is a front elevational view thereof.

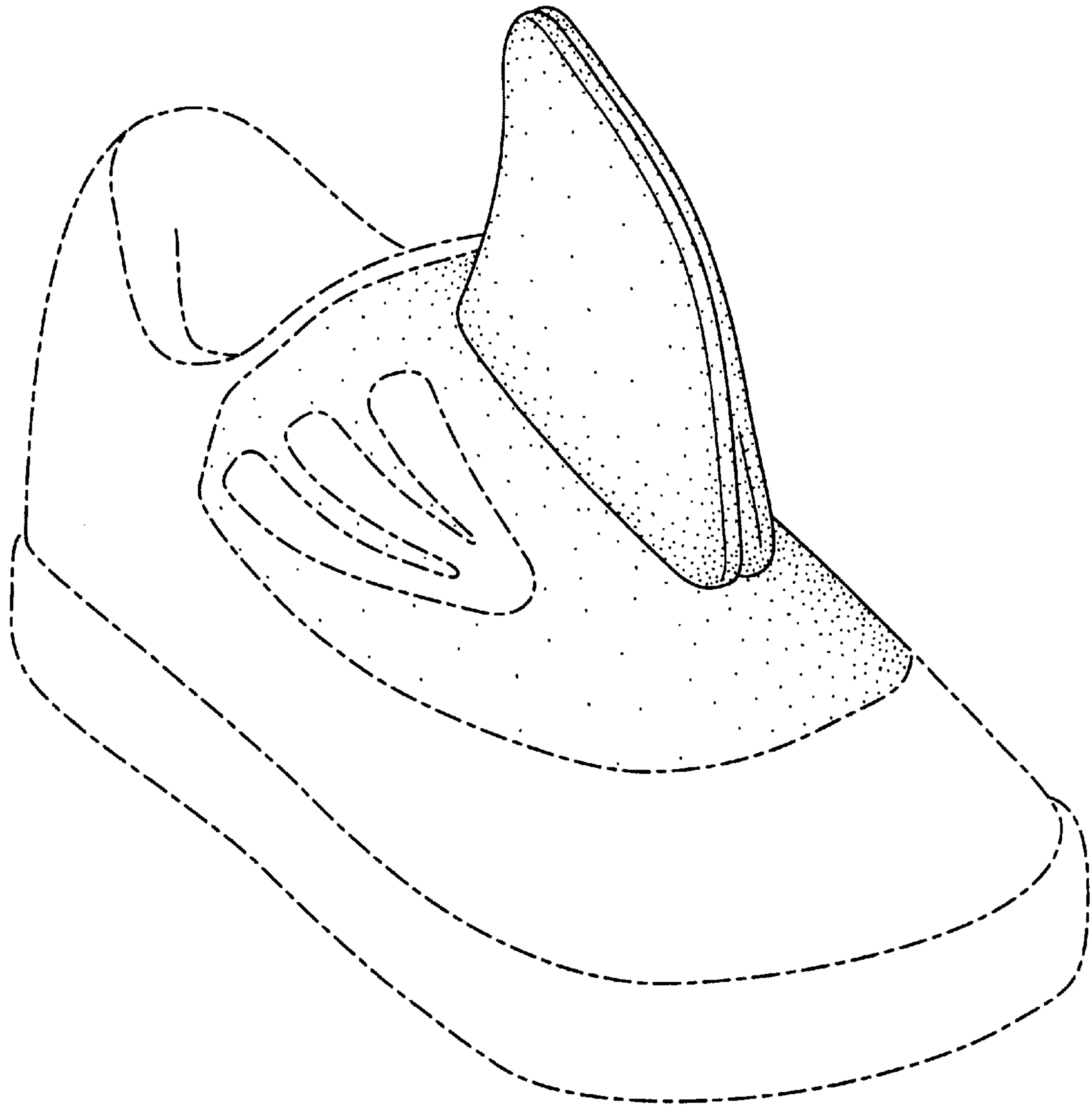

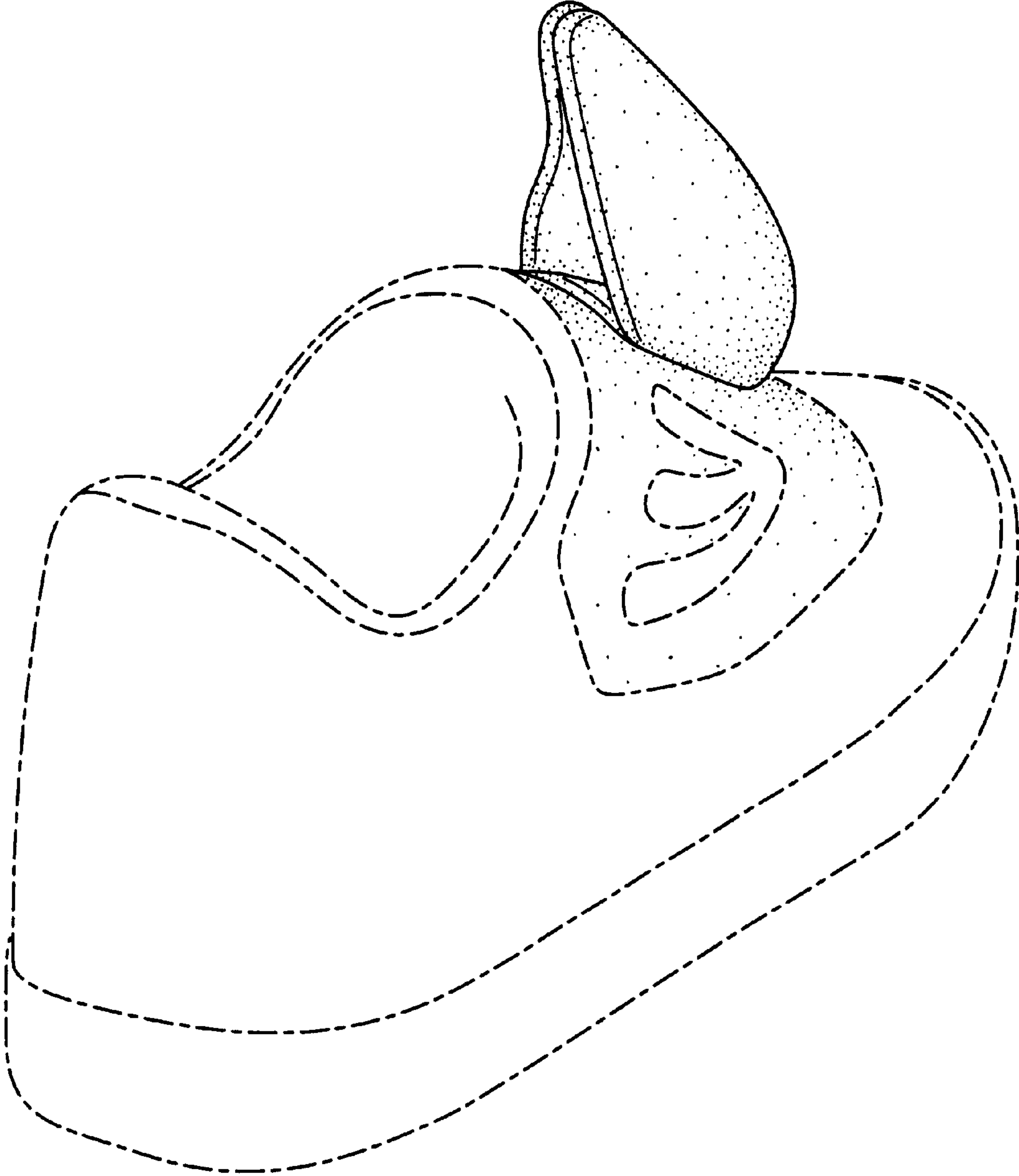

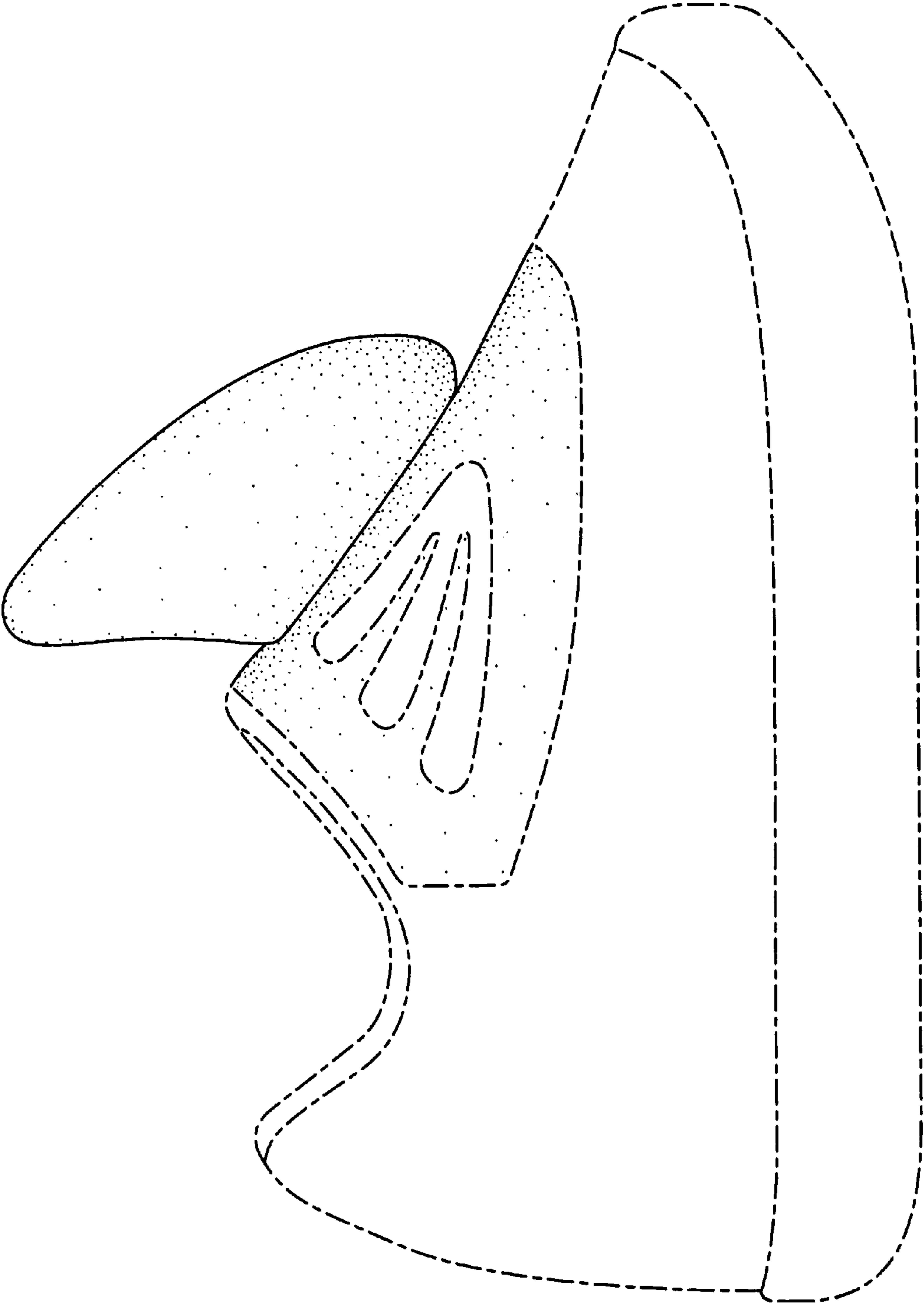

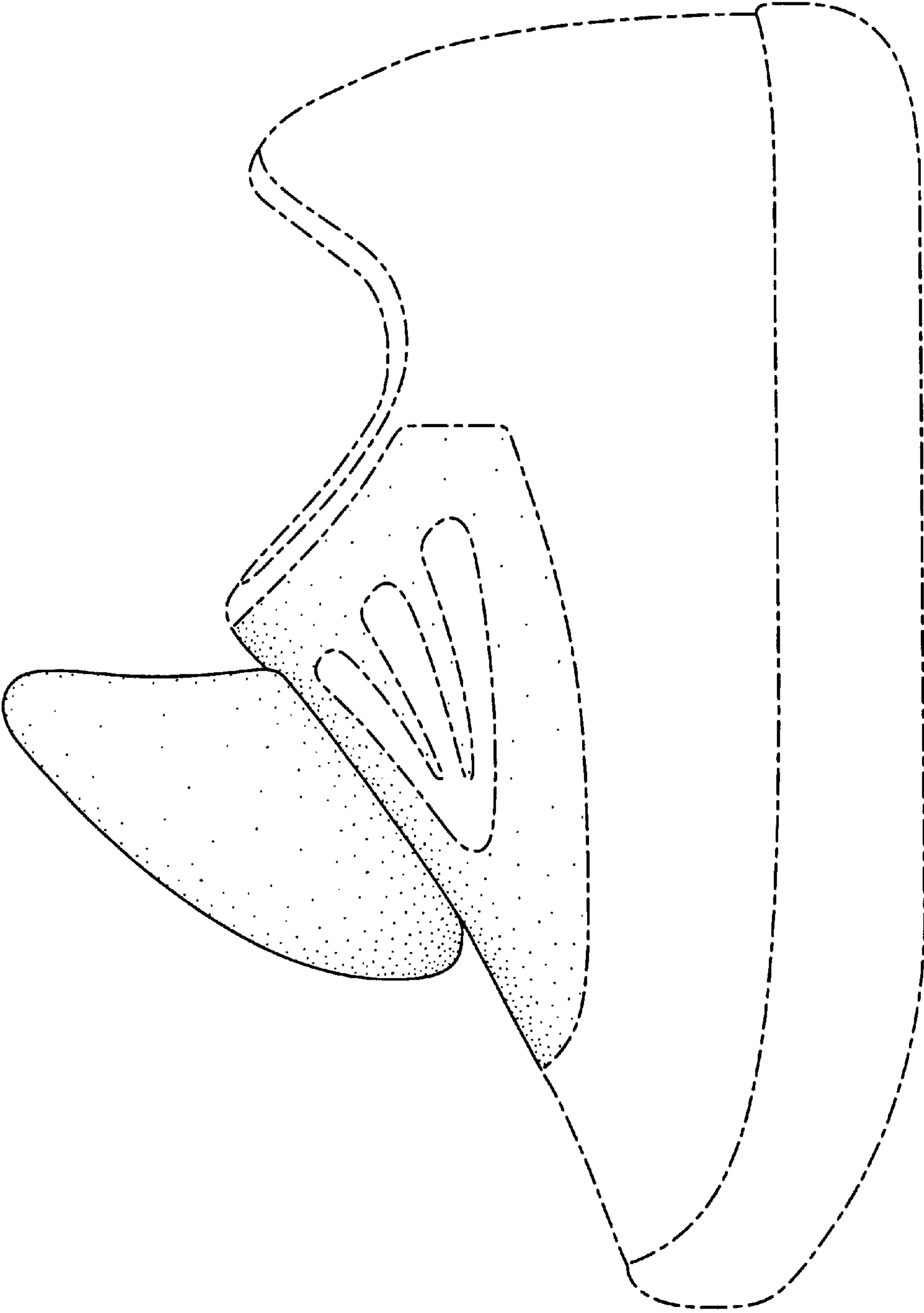

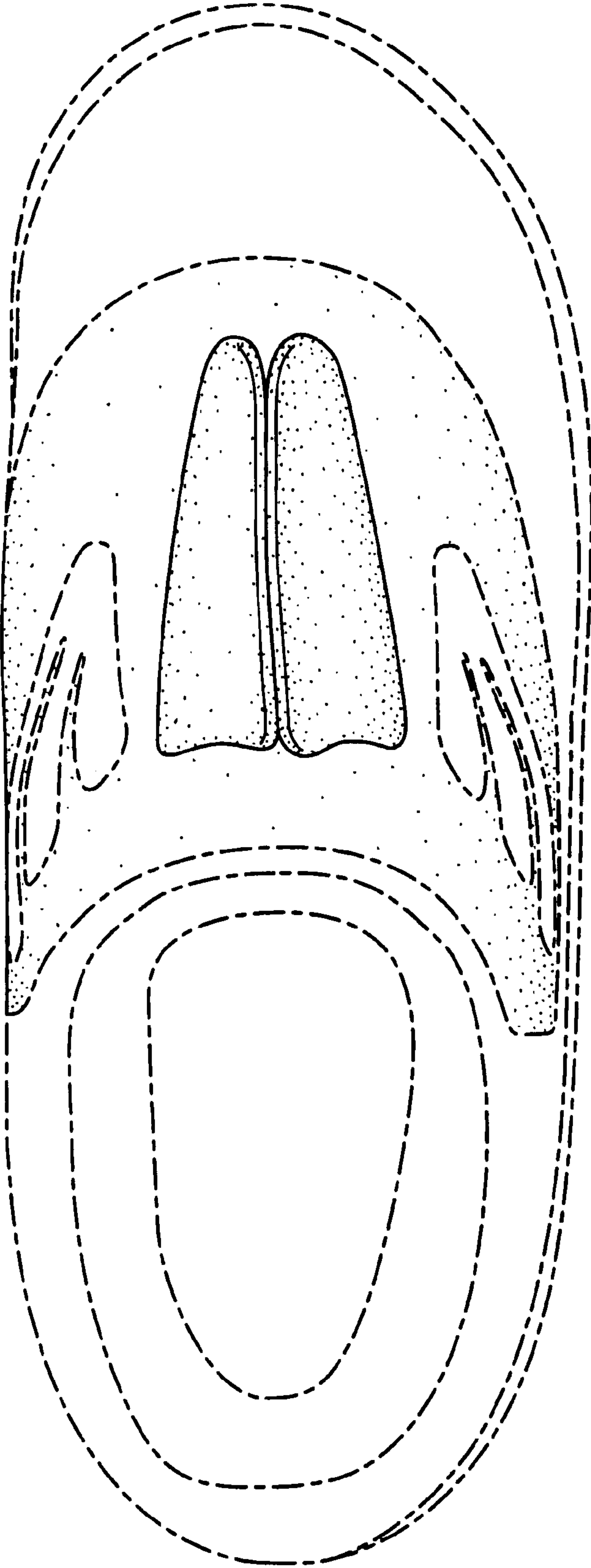

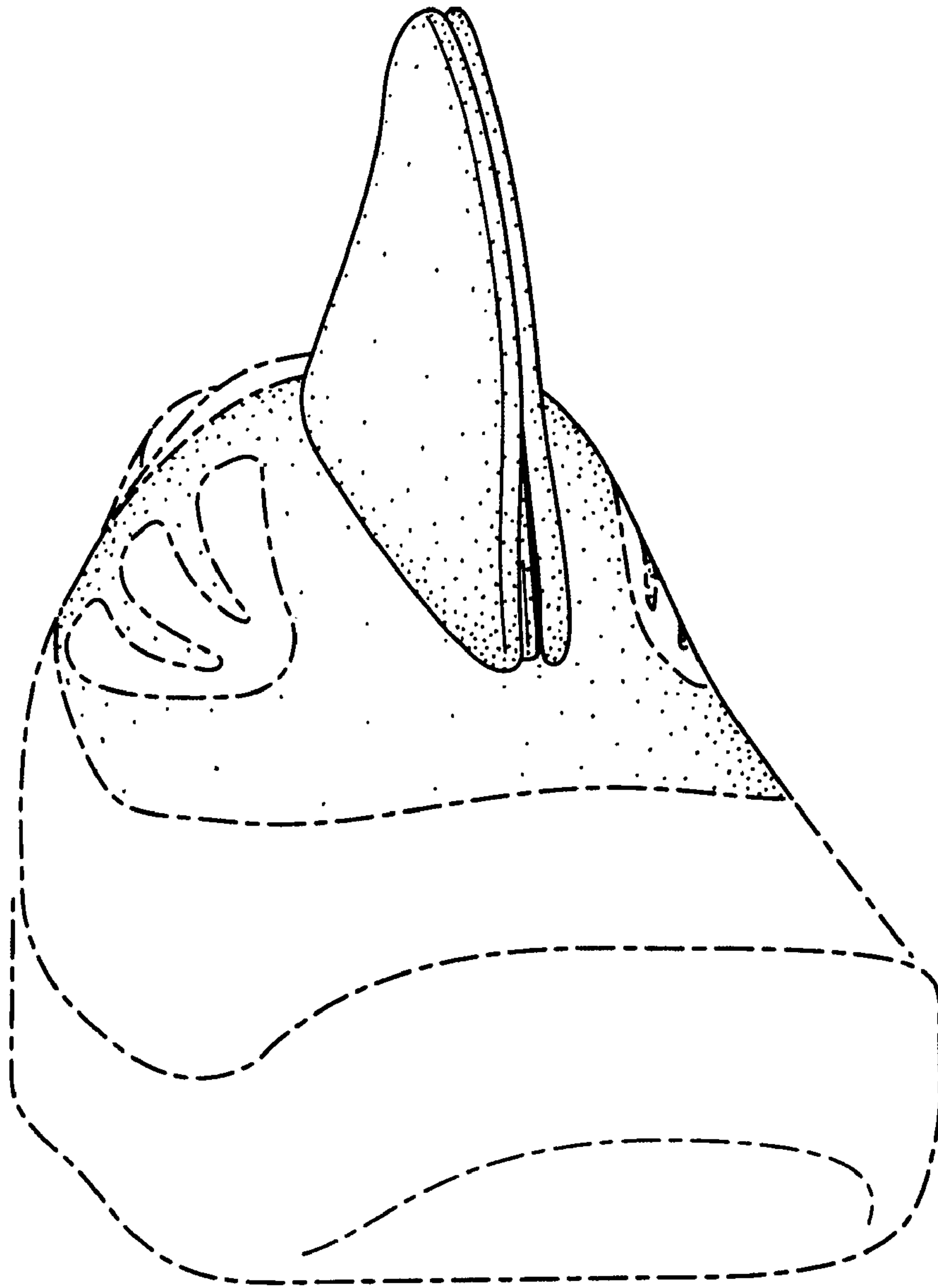

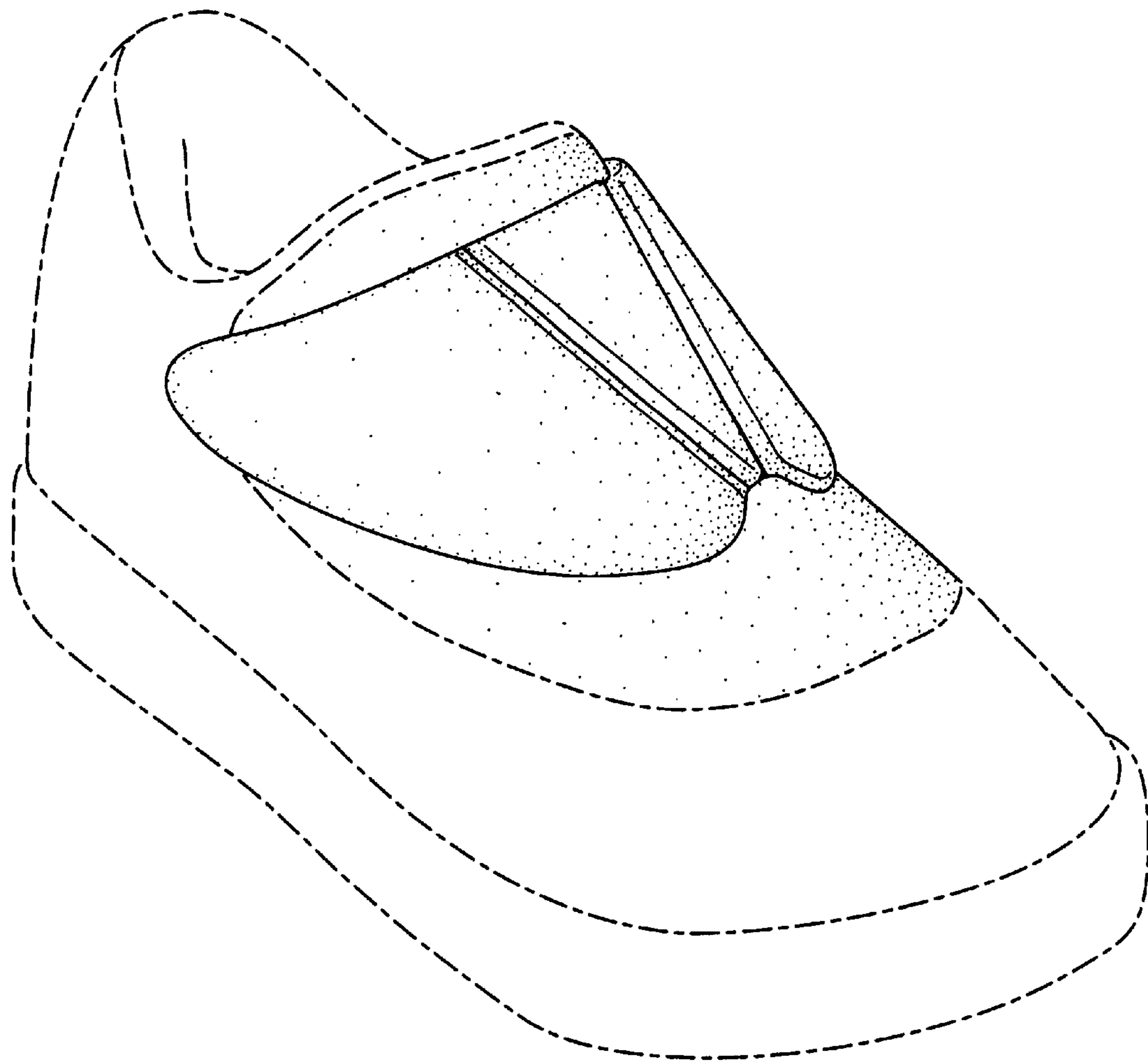

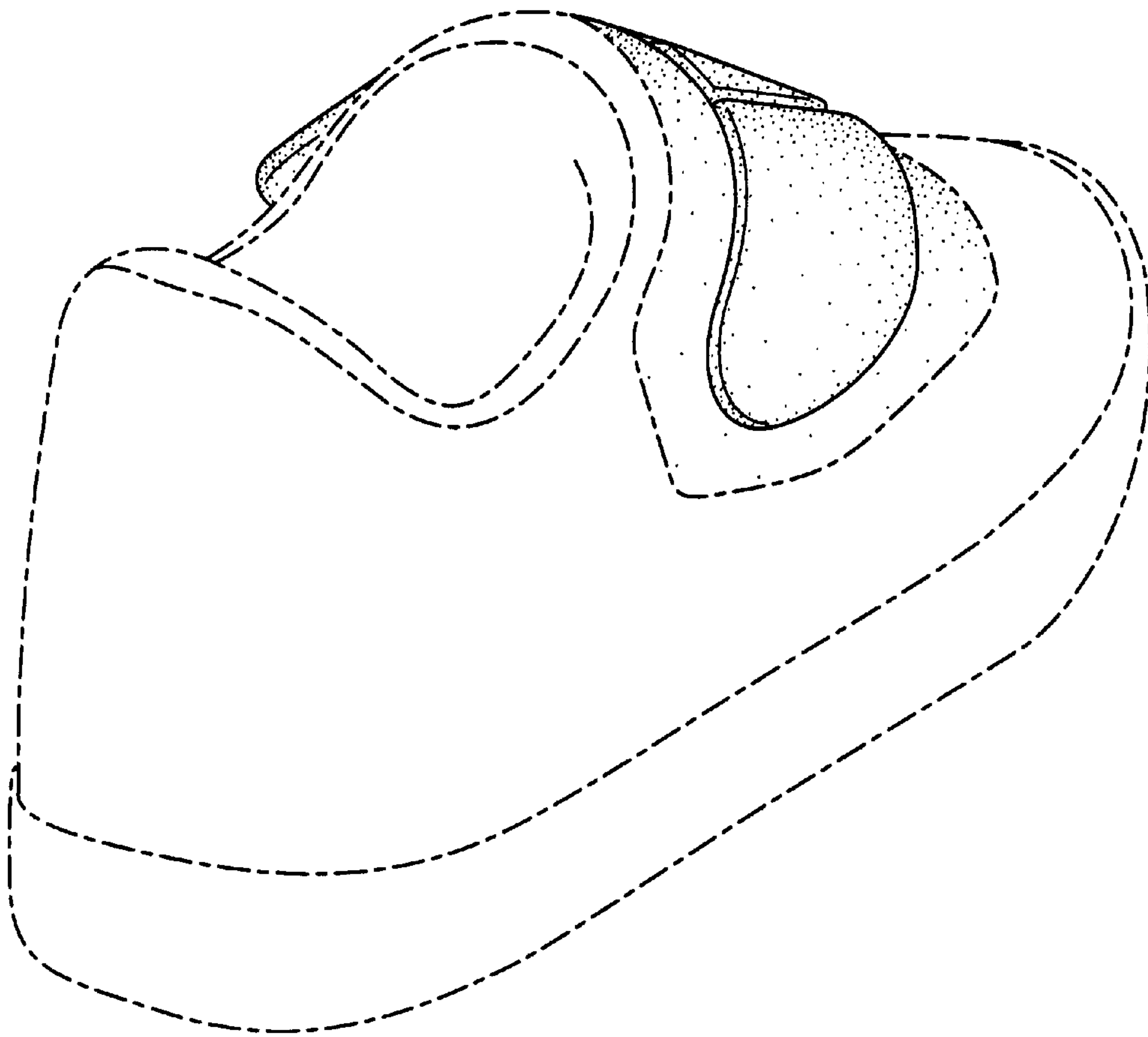

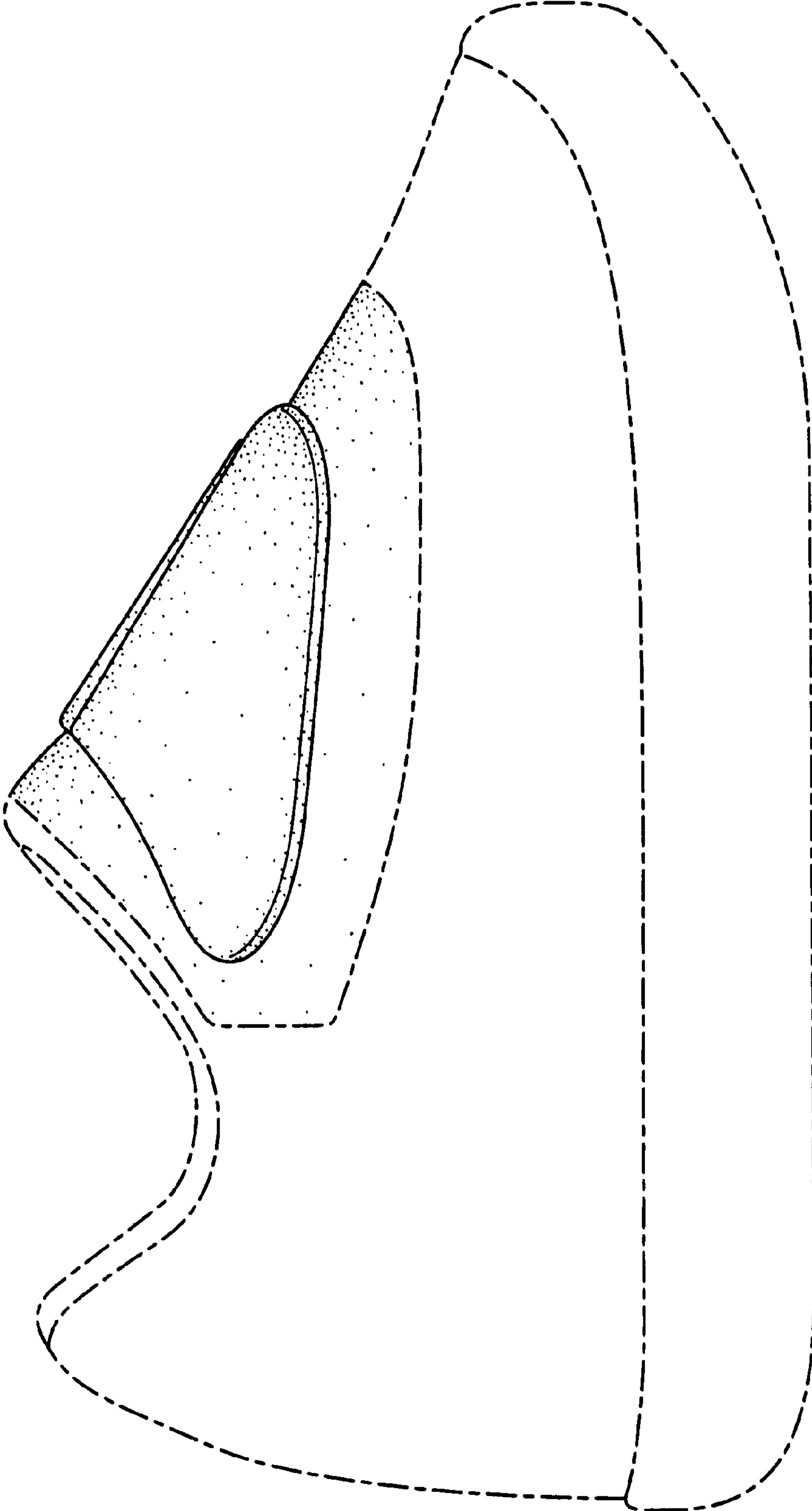

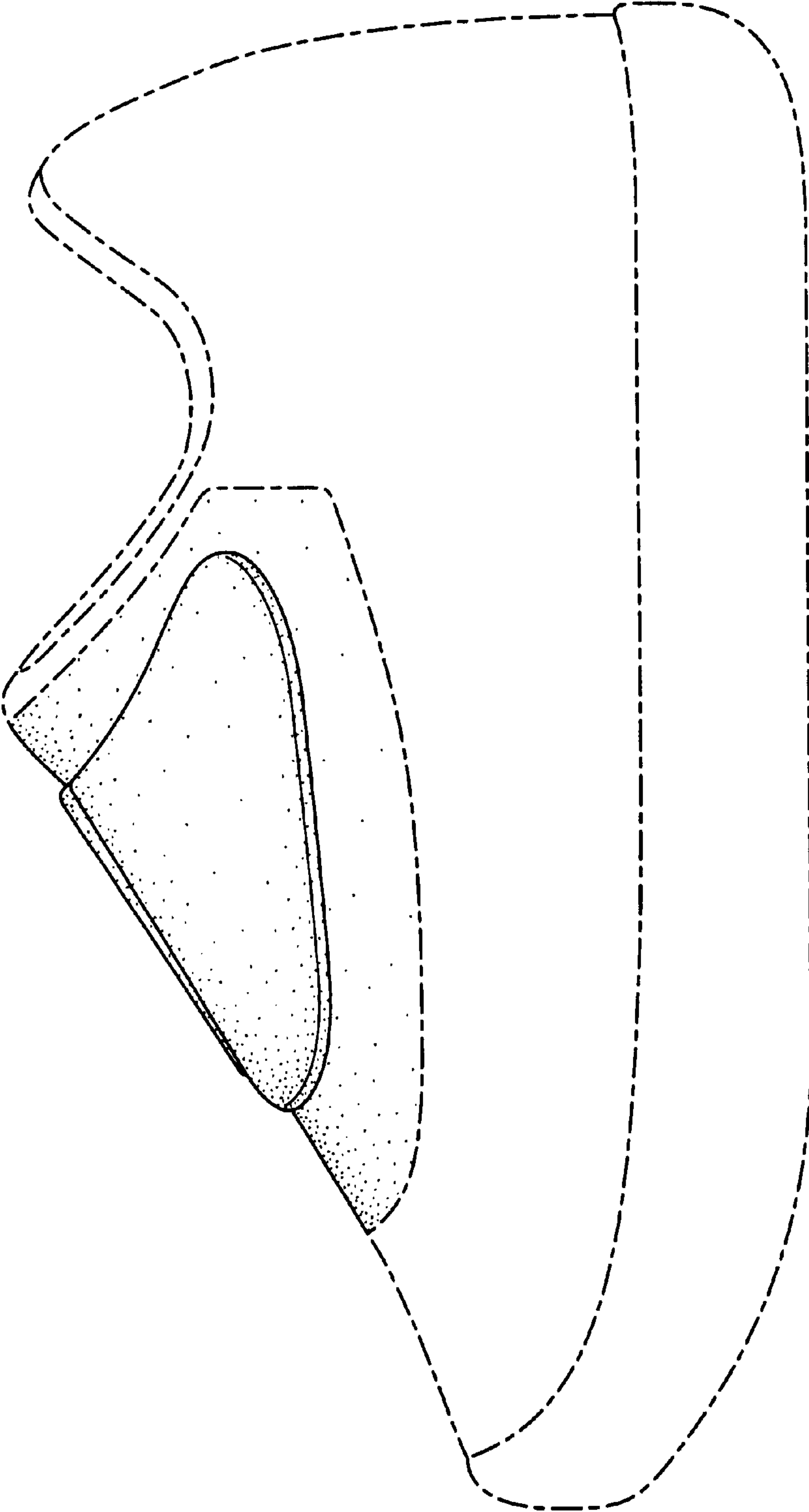

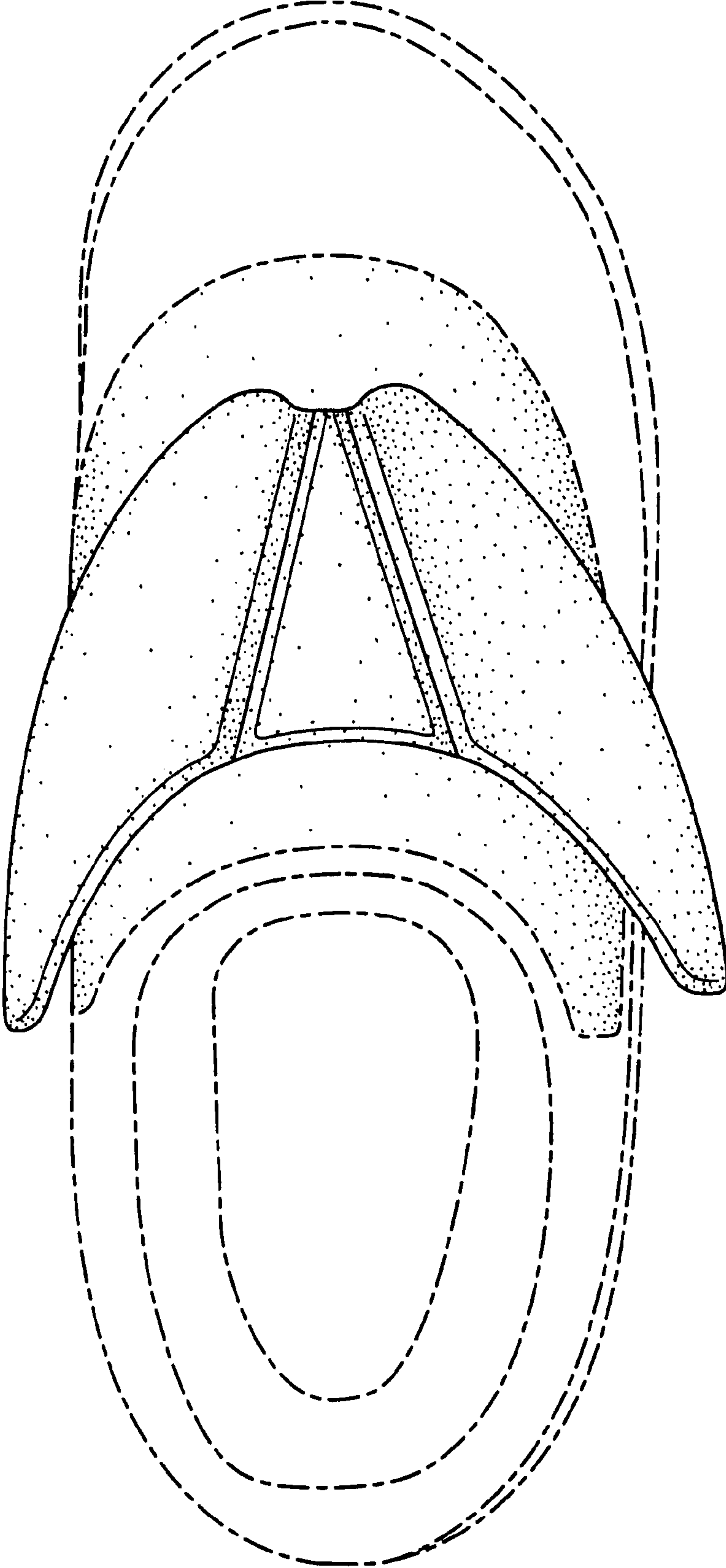

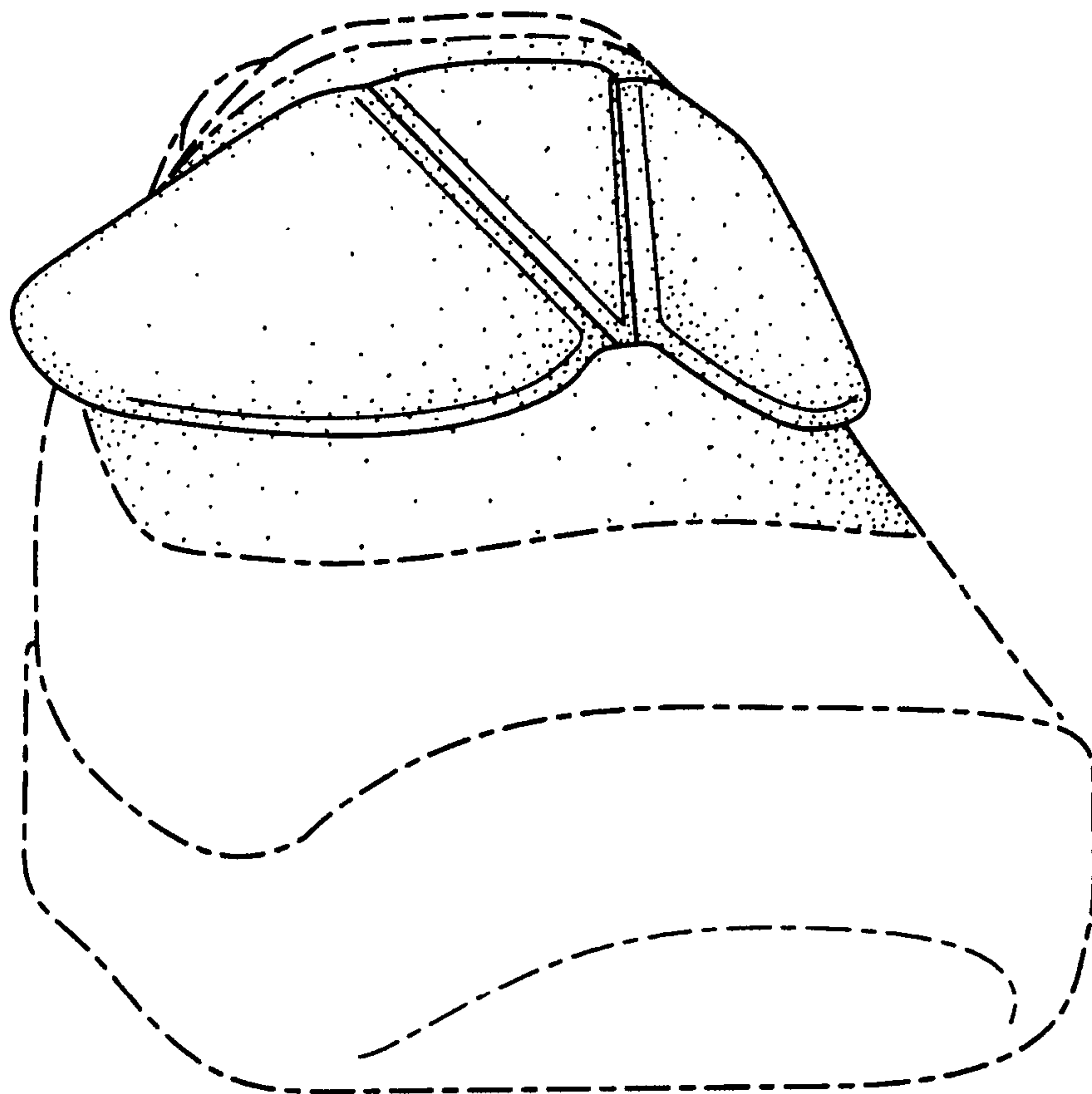
