DESCRIPTION

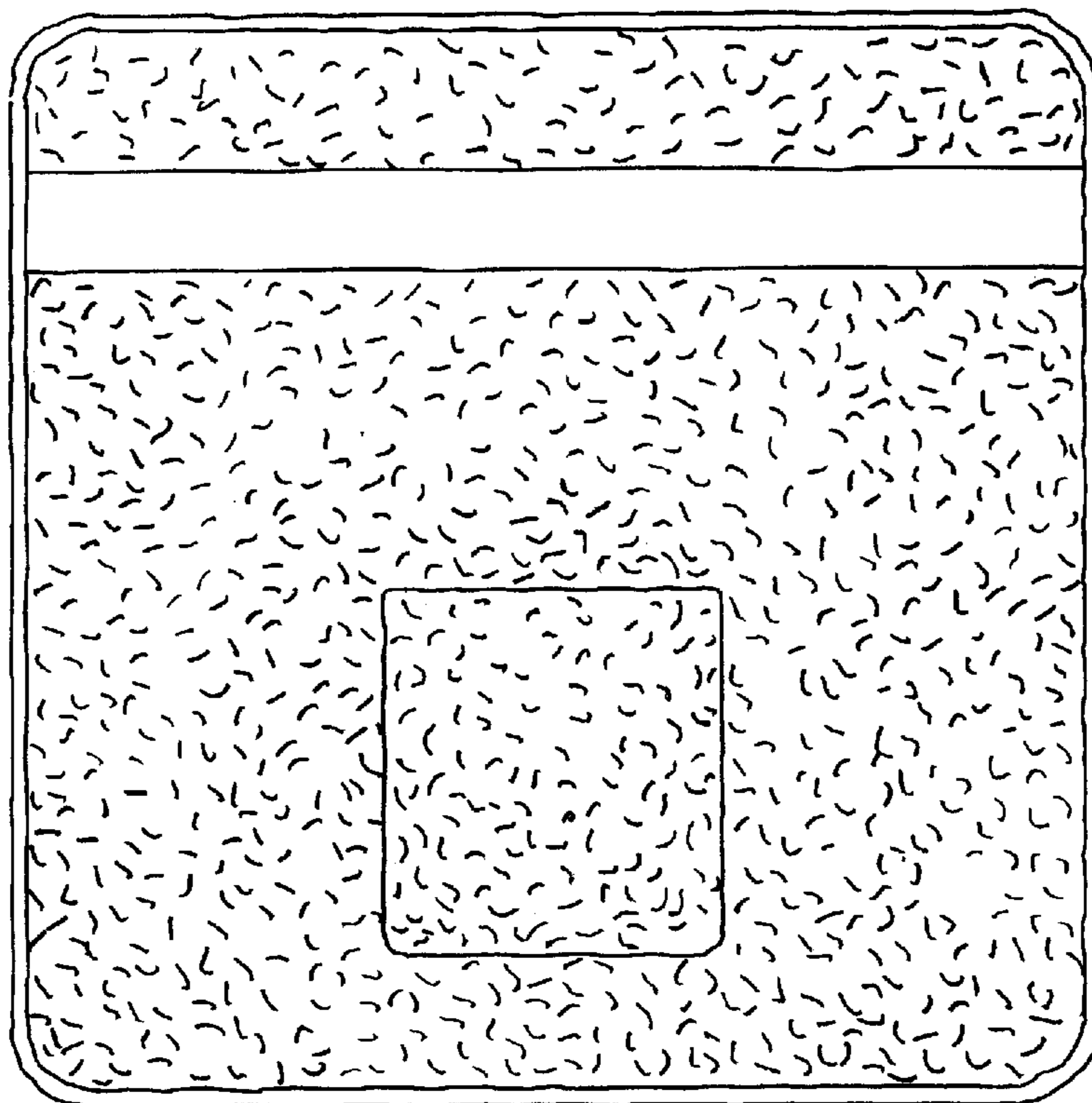
FIG. 1 is a front elevational view of a towel with a soap pocket, showing the design with a bar of soap shown in phantom line;
 FIG. 2 is view taken from the top of FIG. 1;
 FIG. 3 is a side elevational view of the towel with a soap pocket showing the design; and,
 FIG. 4 is a view of the design taken from the bottom of FIG. 1.
 The broken lines showing a bar of a soap in FIGS. 1 and 3 are for illustrative purposes only and do not form part of the claimed design.

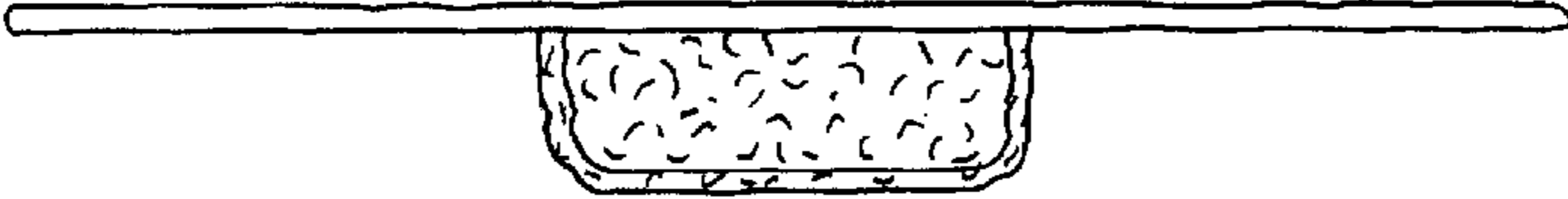

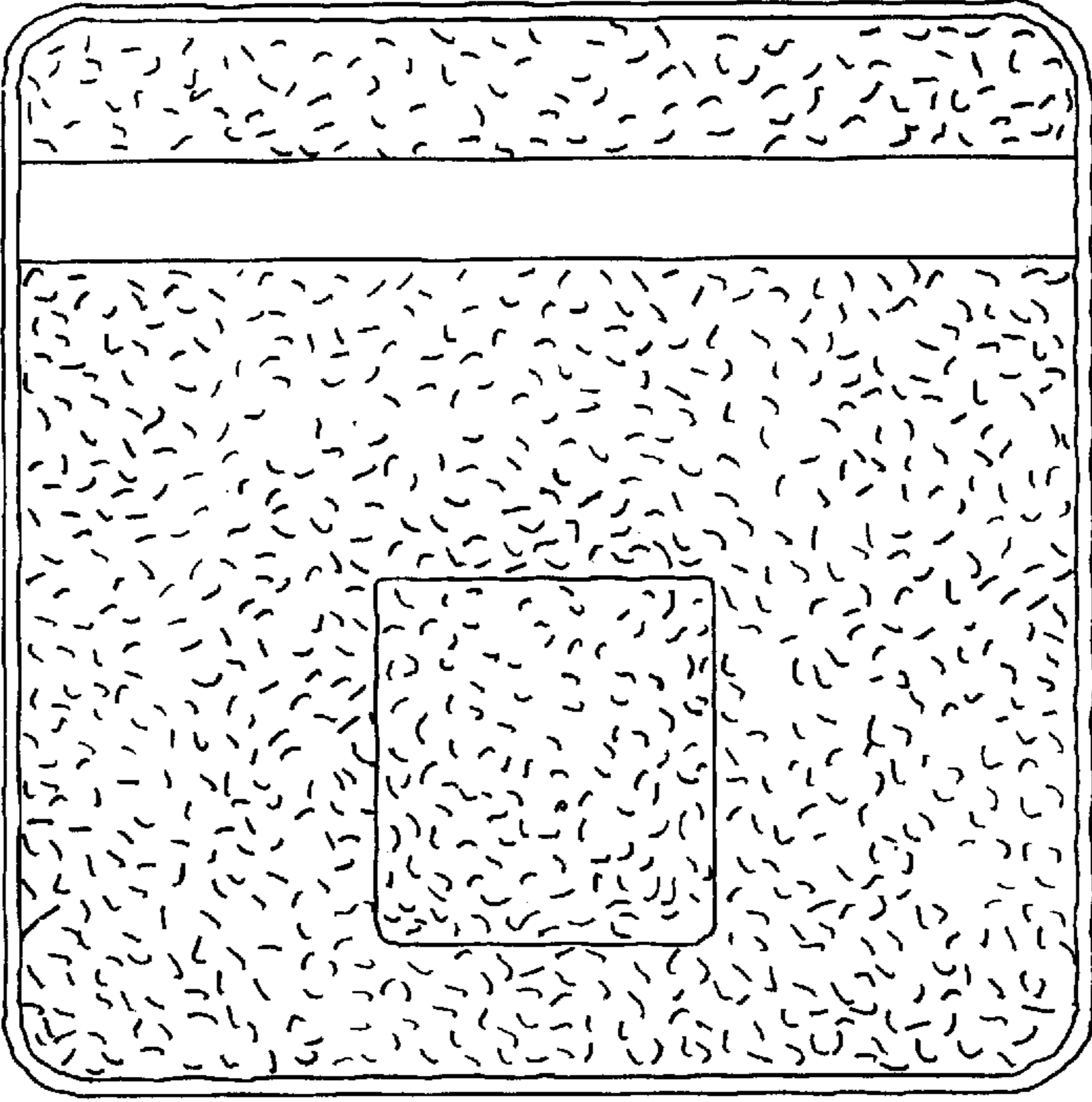

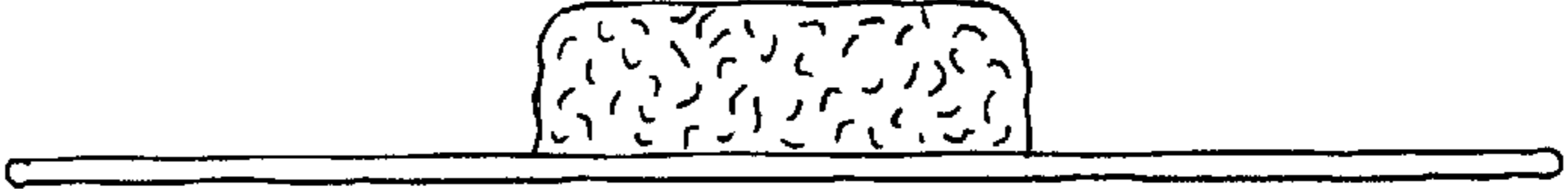
