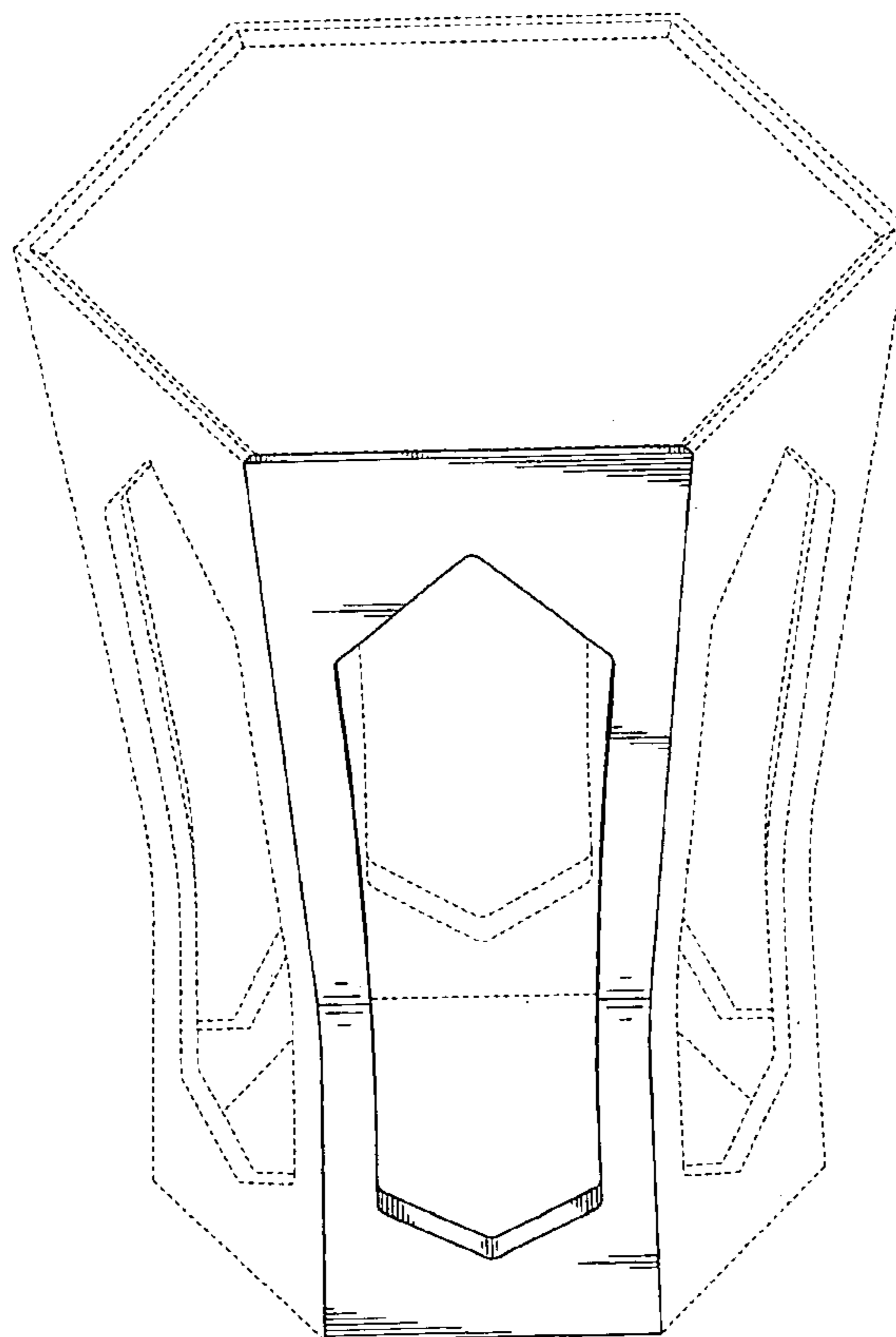
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a table in accordance with the new design;
FIG. 2 is a top view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a front view of an alternative embodiment of said new design showing two portions broken away for indeterminable height;
FIG. 6 is a perspective view of an alternative embodiment of said new design; and,

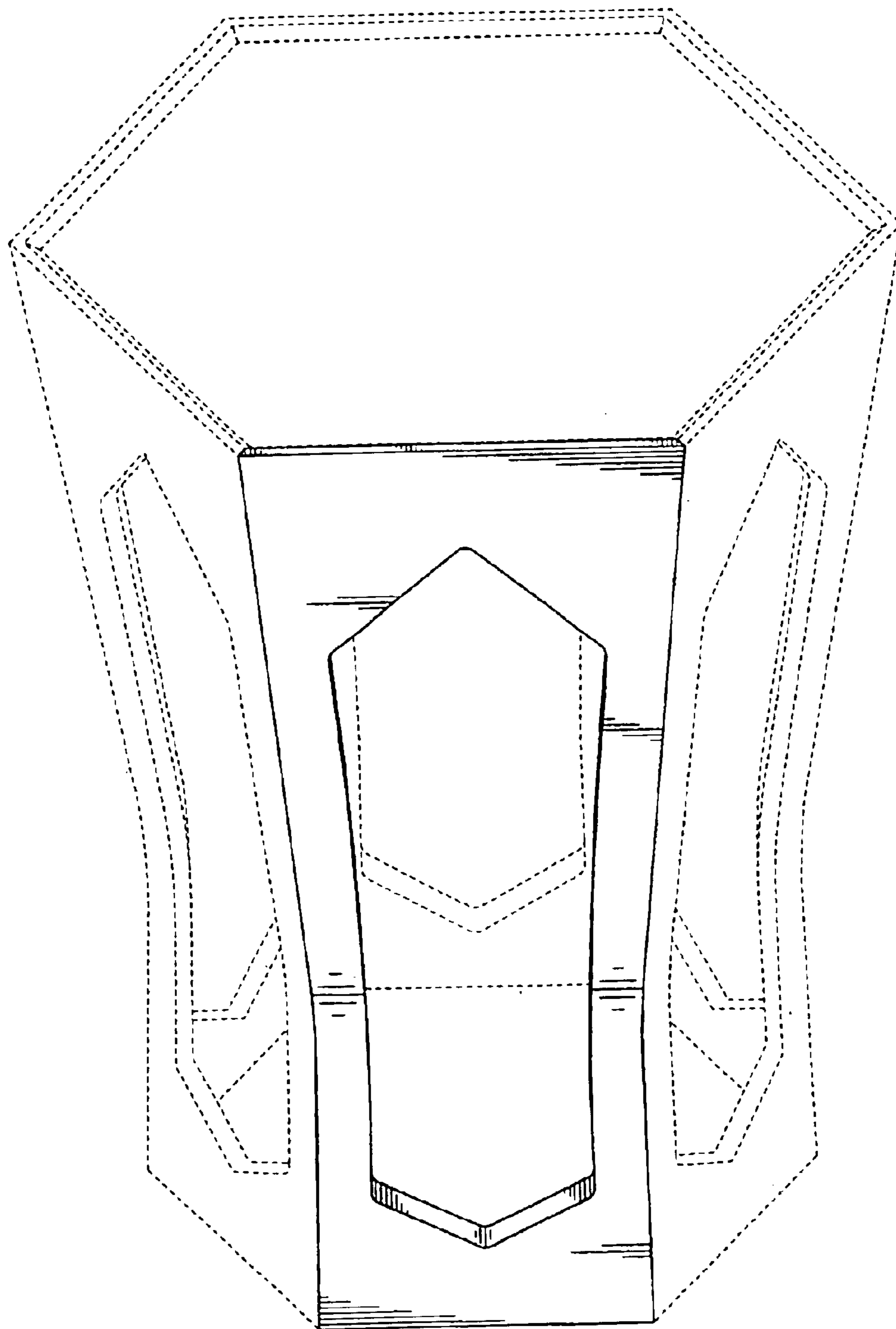

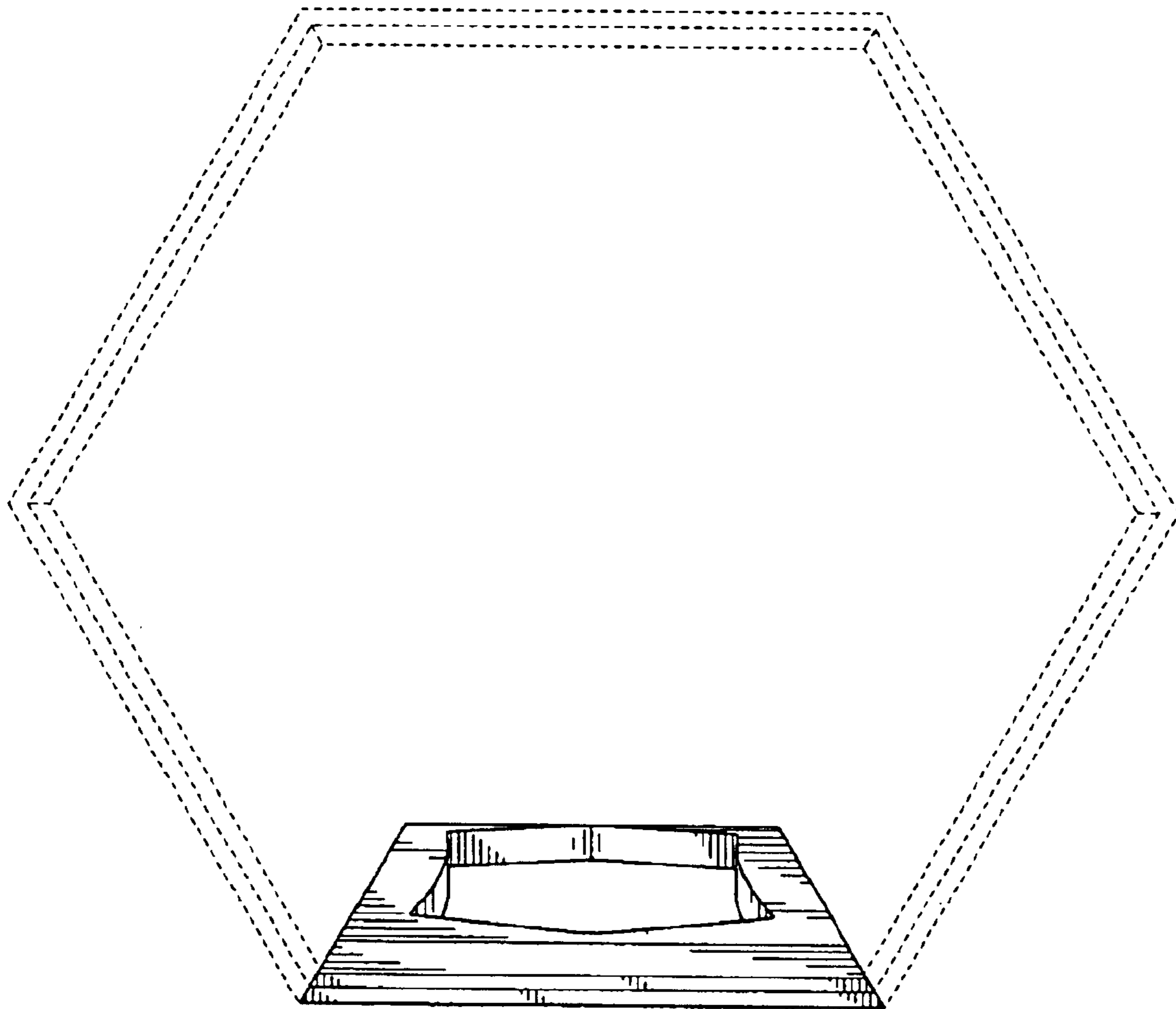

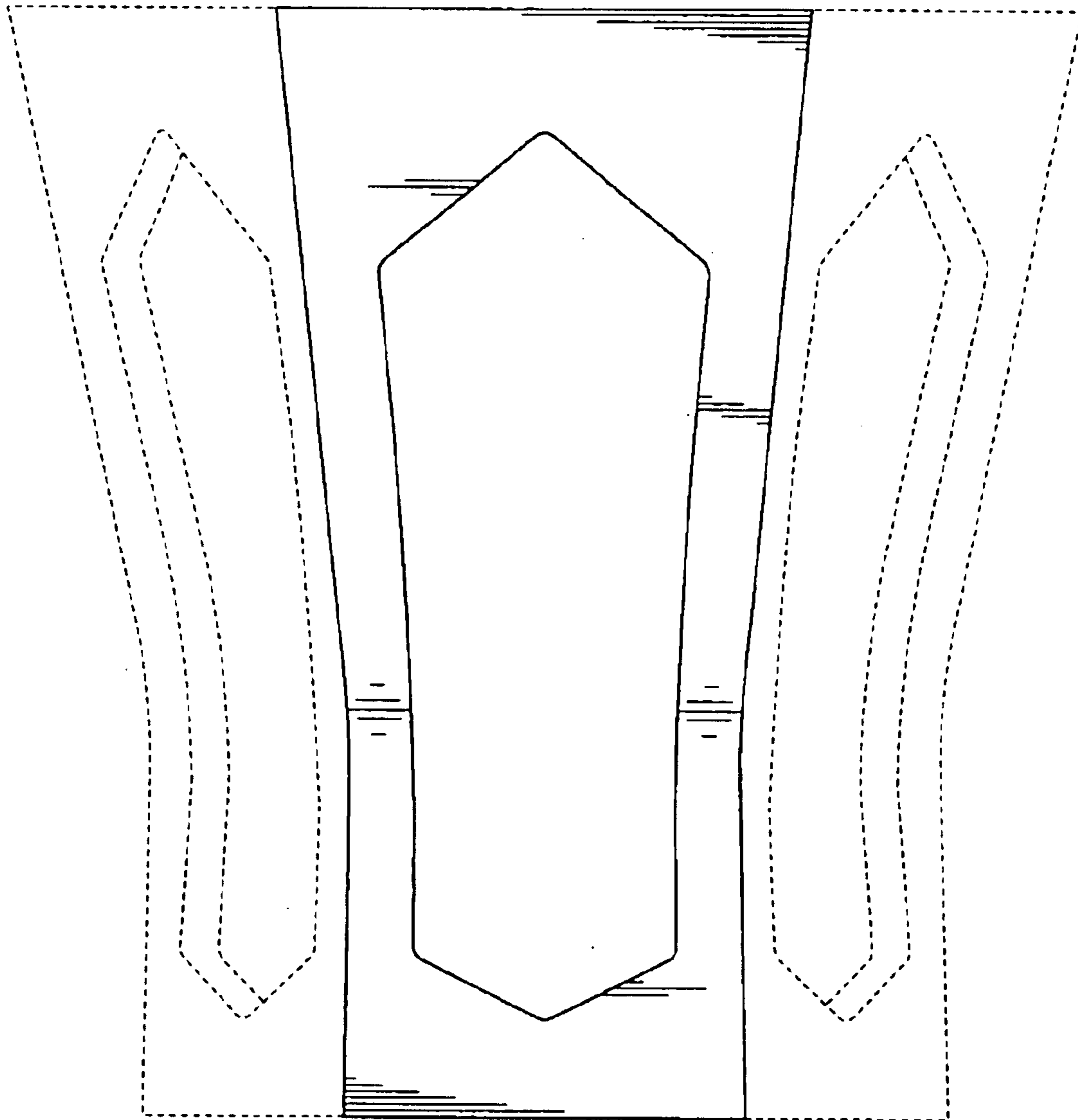

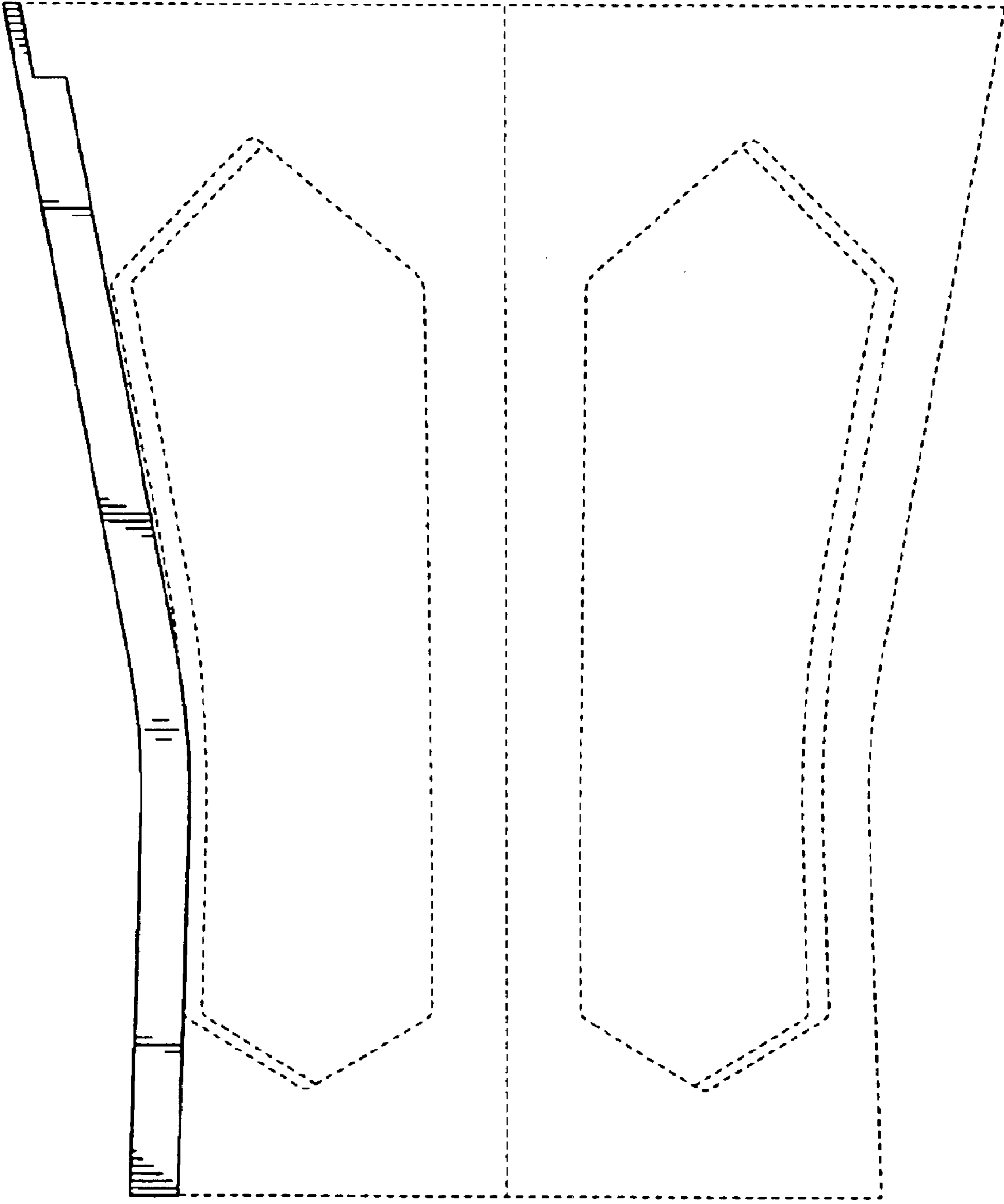

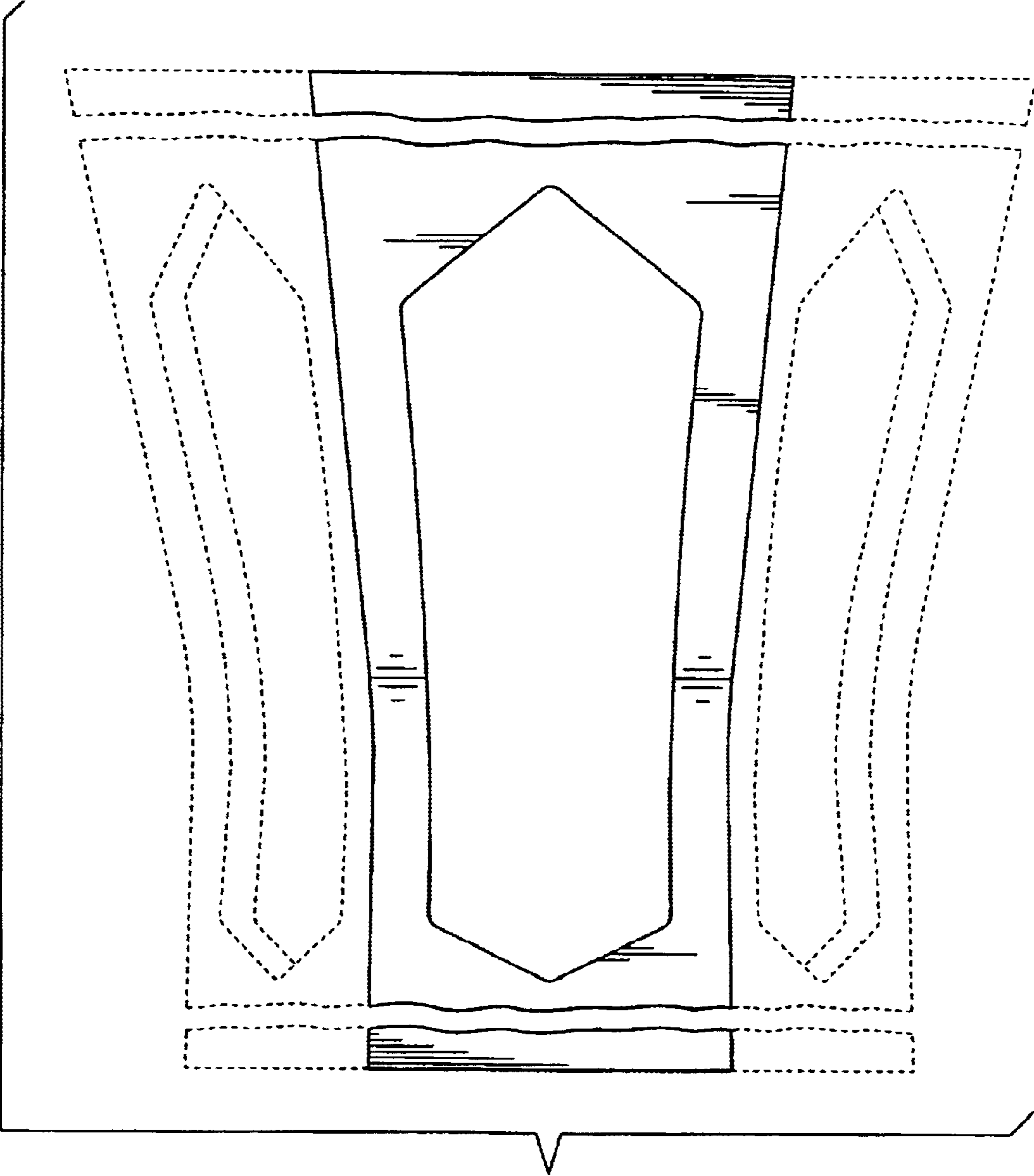

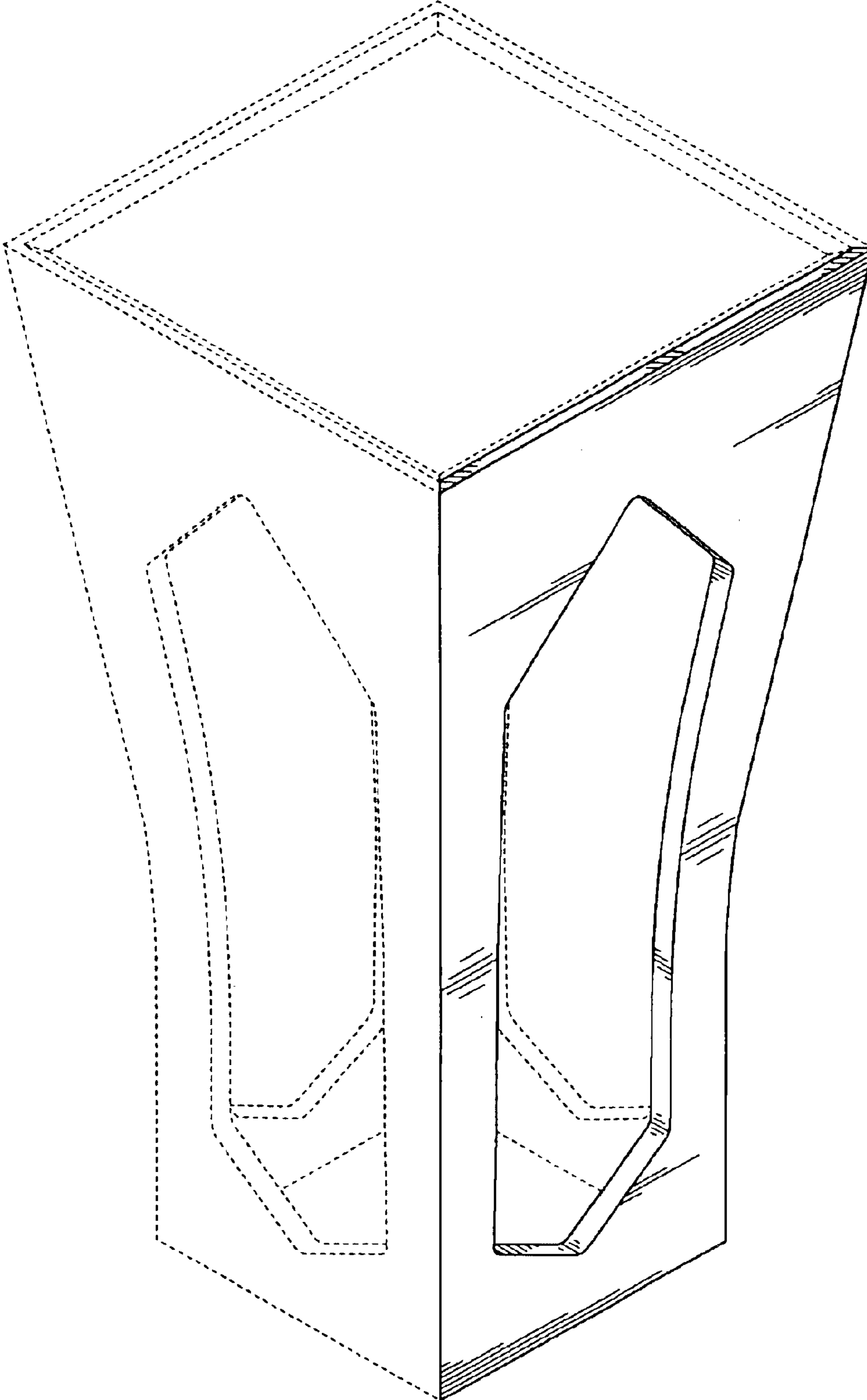

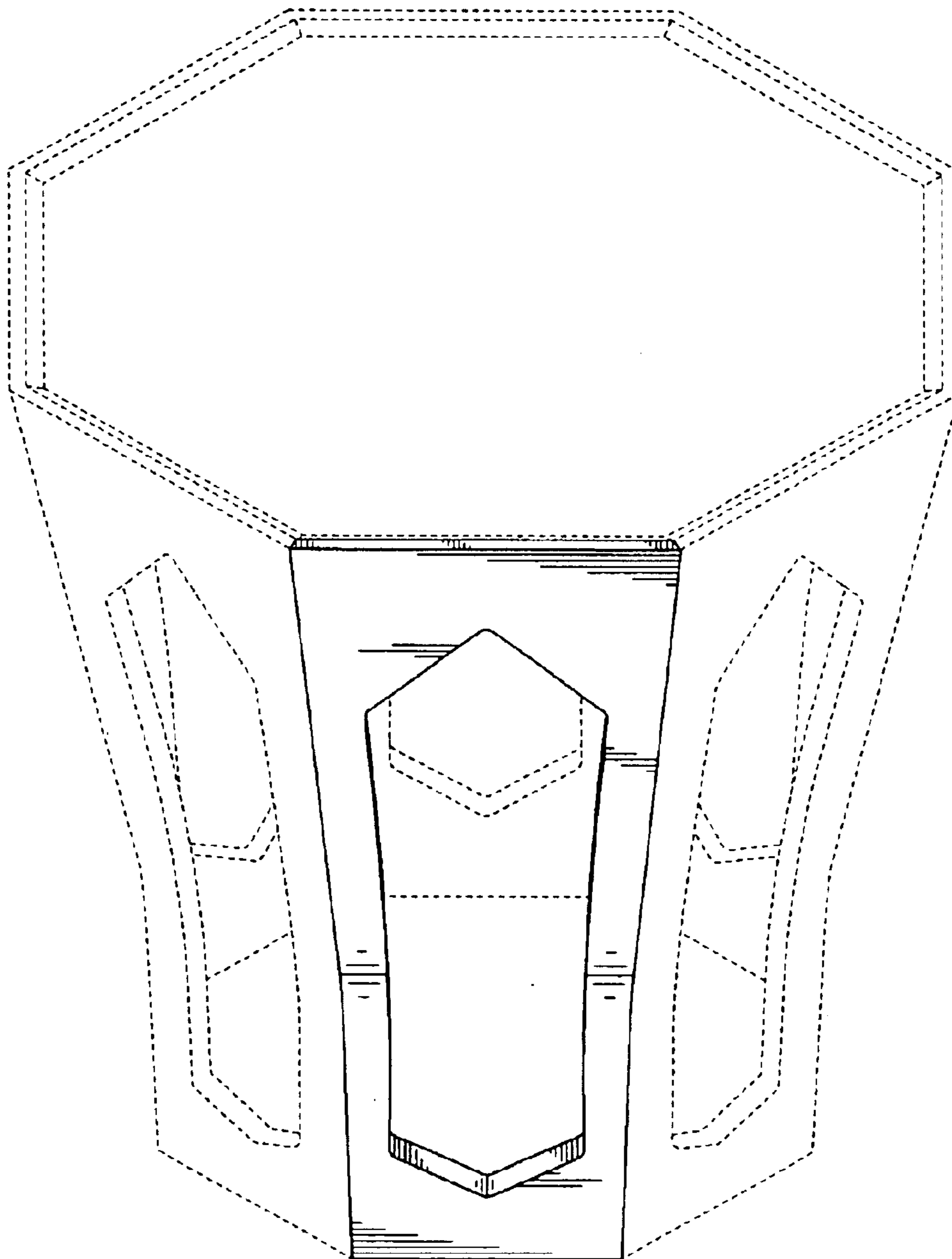
