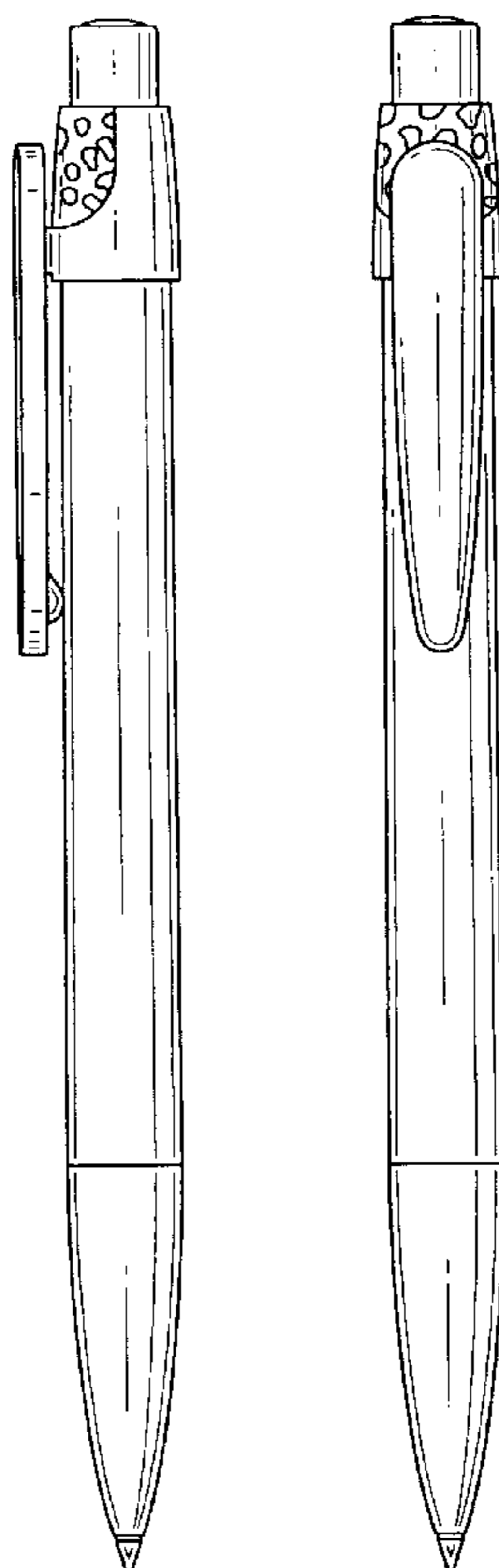
(57) **CLAIM**

The ornamental design for the writing utensil, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of a writing utensil with a textured pattern near the button portion, the left side elevational view being a mirror image thereof; FIG. 2 is a front elevational view of the writing utensil with a textured pattern near the button portion; and, FIG. 3 is a rear elevational view of the writing utensil.

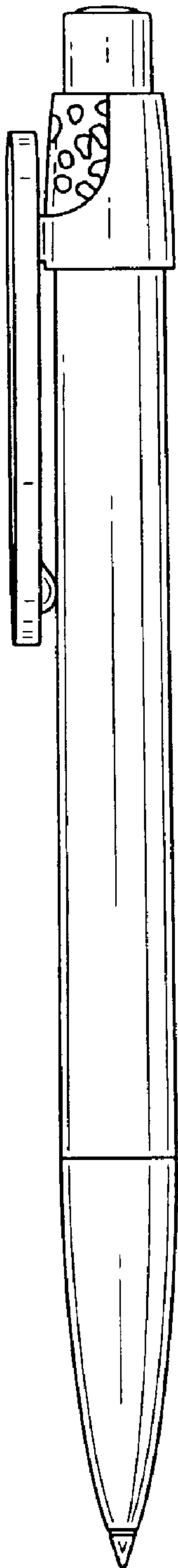
