The ornamental design for an ergonomic trigger for trigger sprayer, as shown and described.

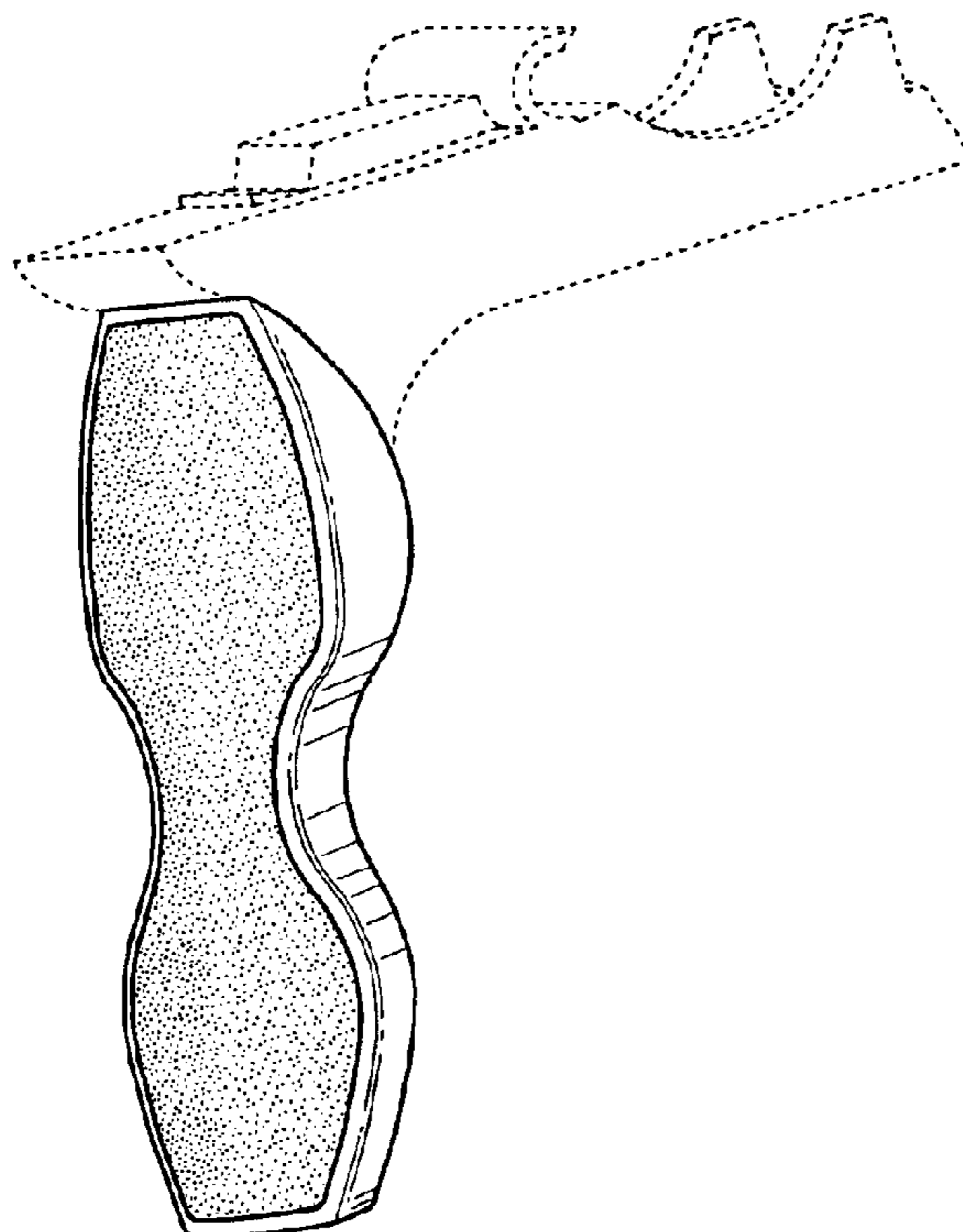
DESCRIPTION

The application relates to an ergonomic trigger for use with a trigger sprayer.

FIG. 1 is a perspective view of an ergonomic trigger for a trigger sprayer showing my new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

The broken lines showing the arm of the sprayer in the drawings are environmental only and form no part of the claimed design.

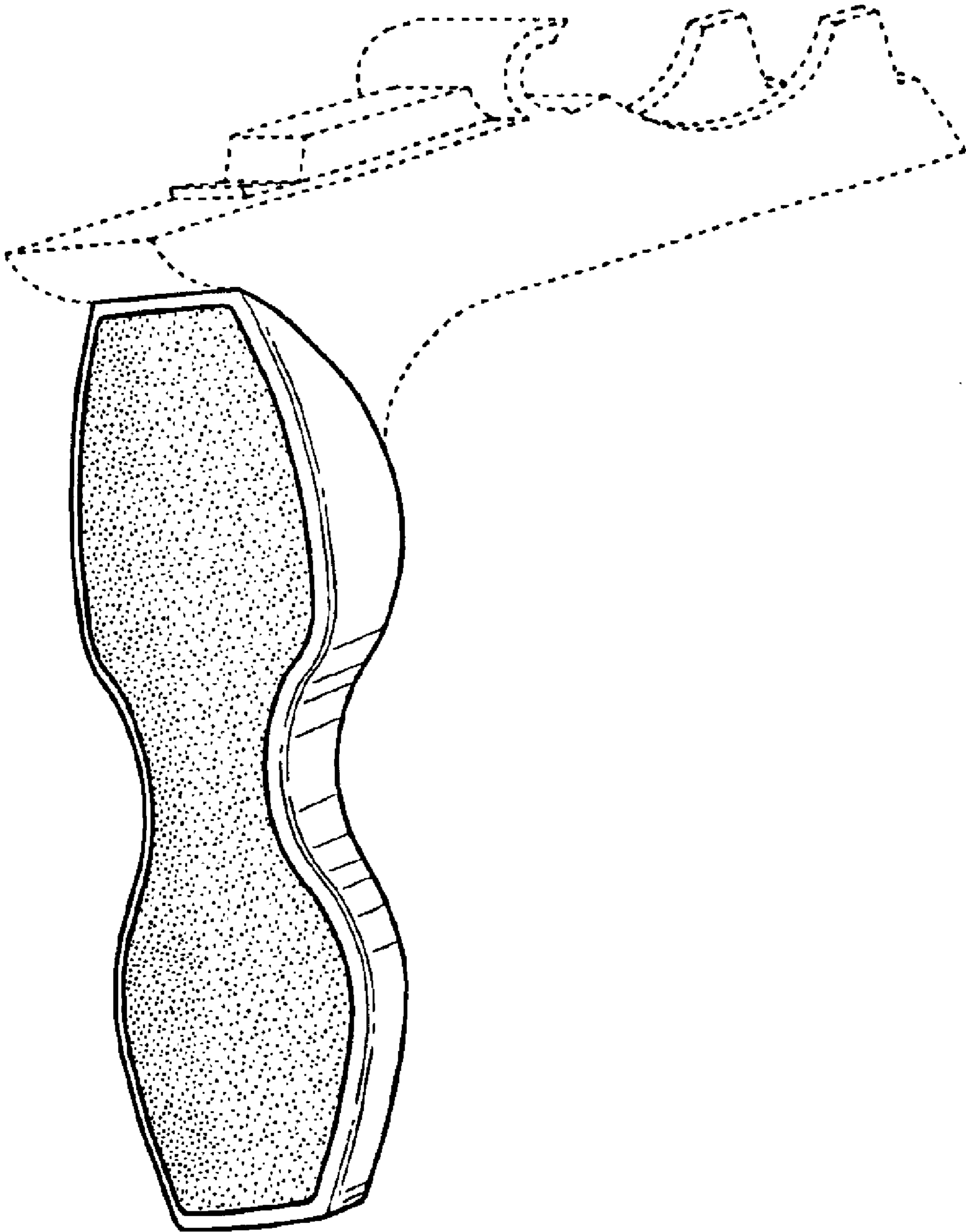

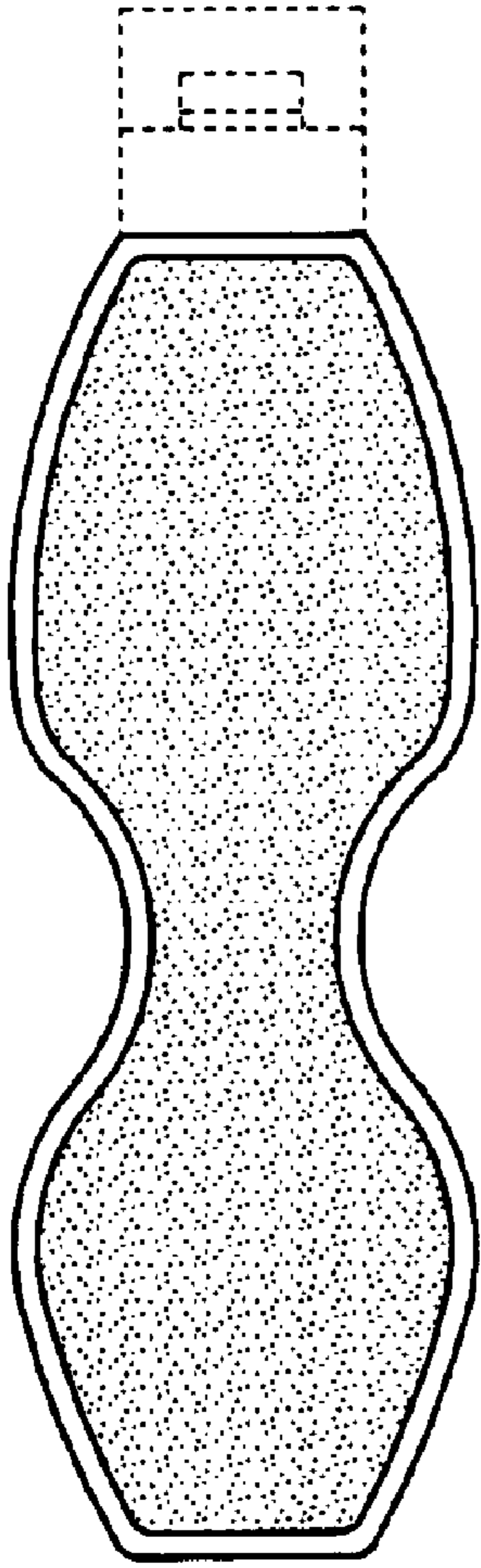

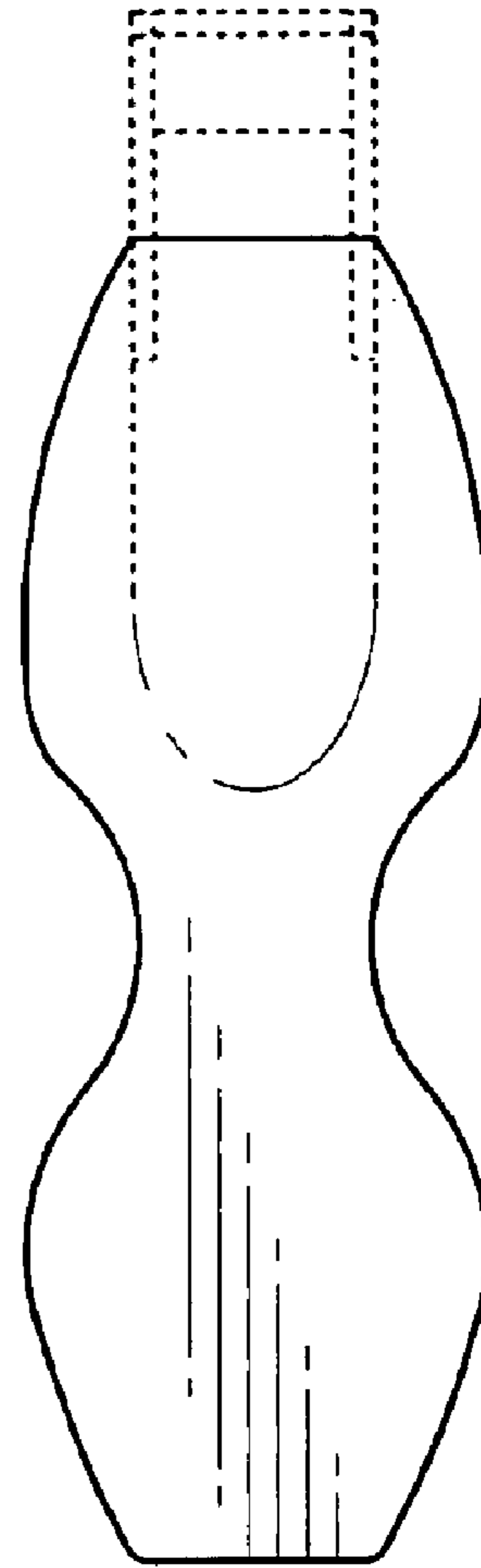

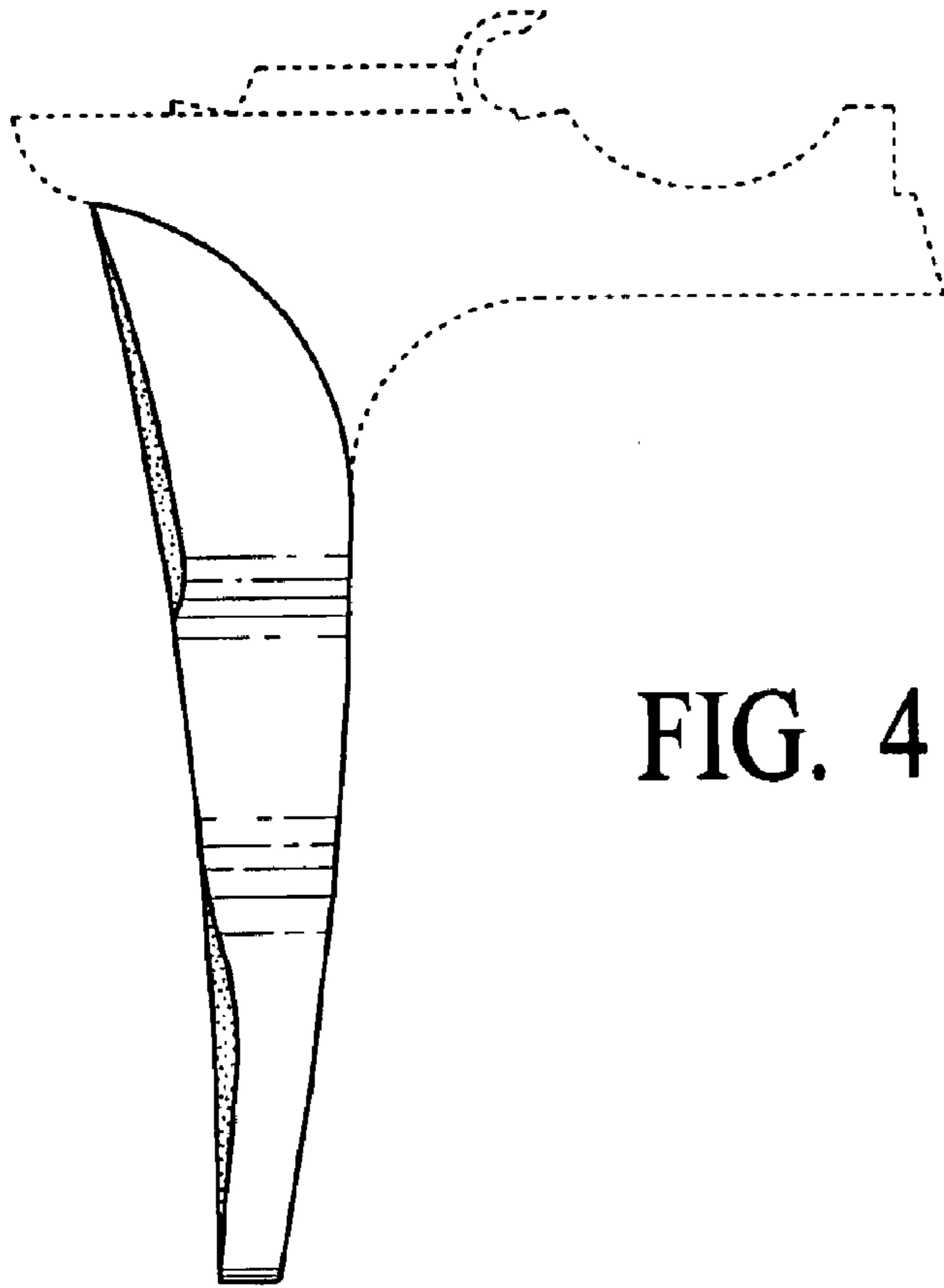

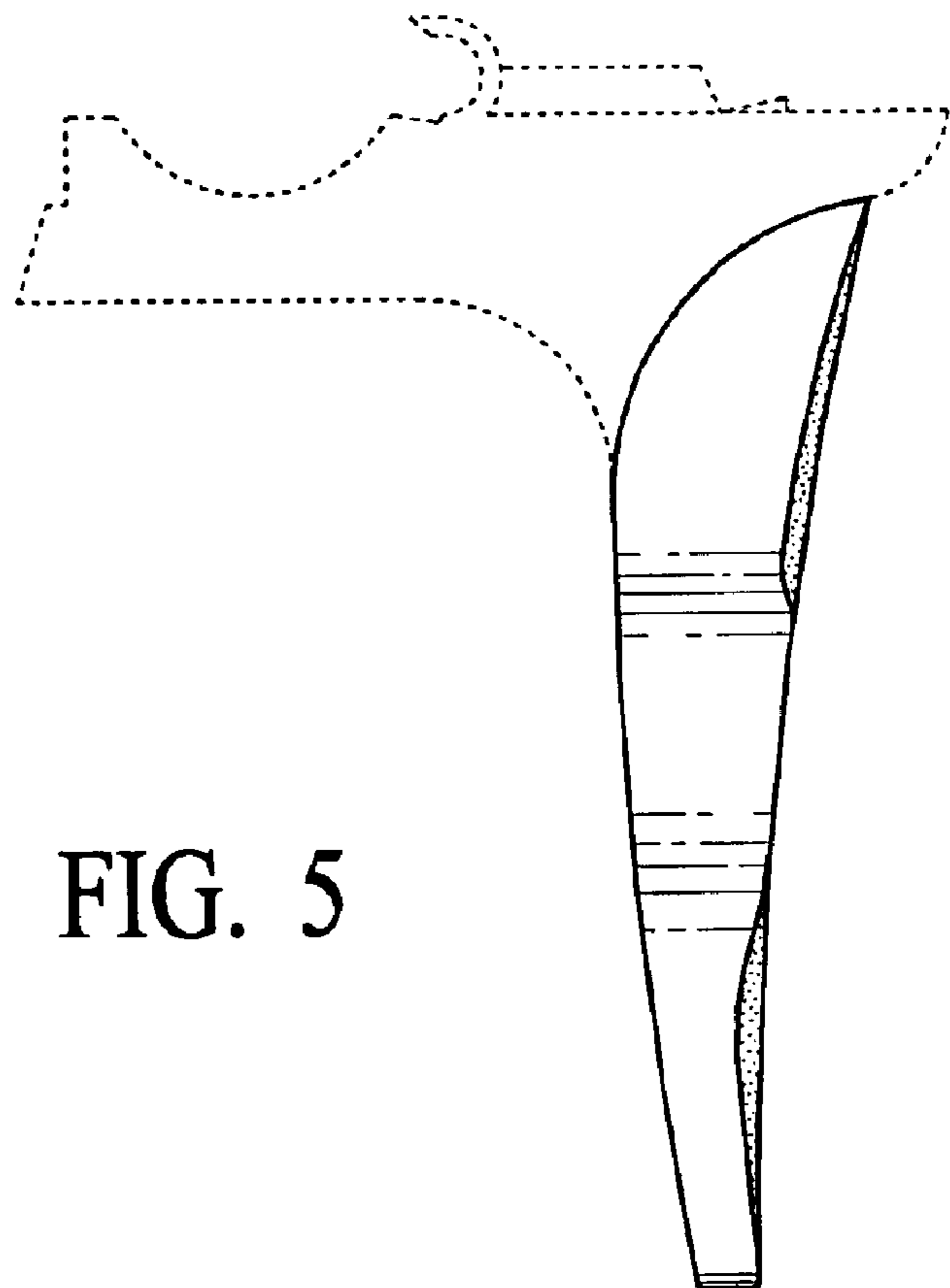

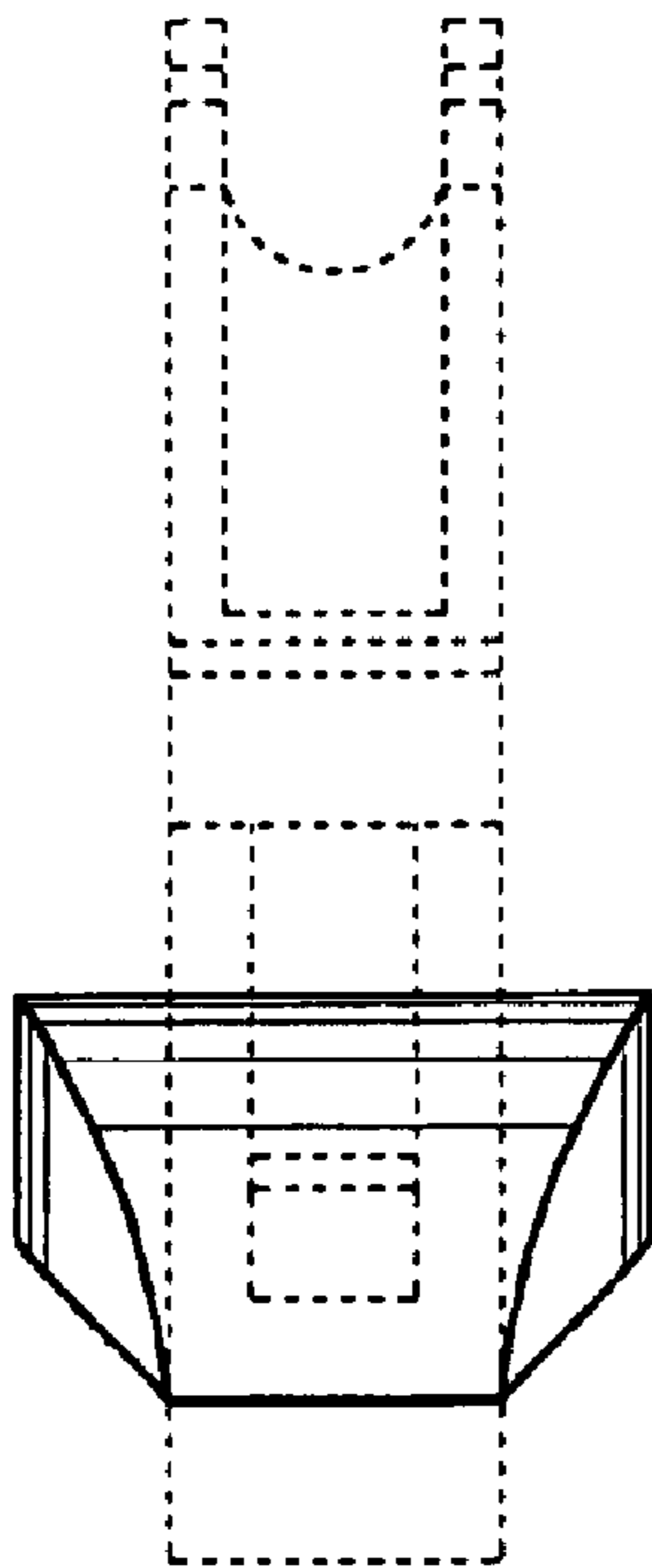

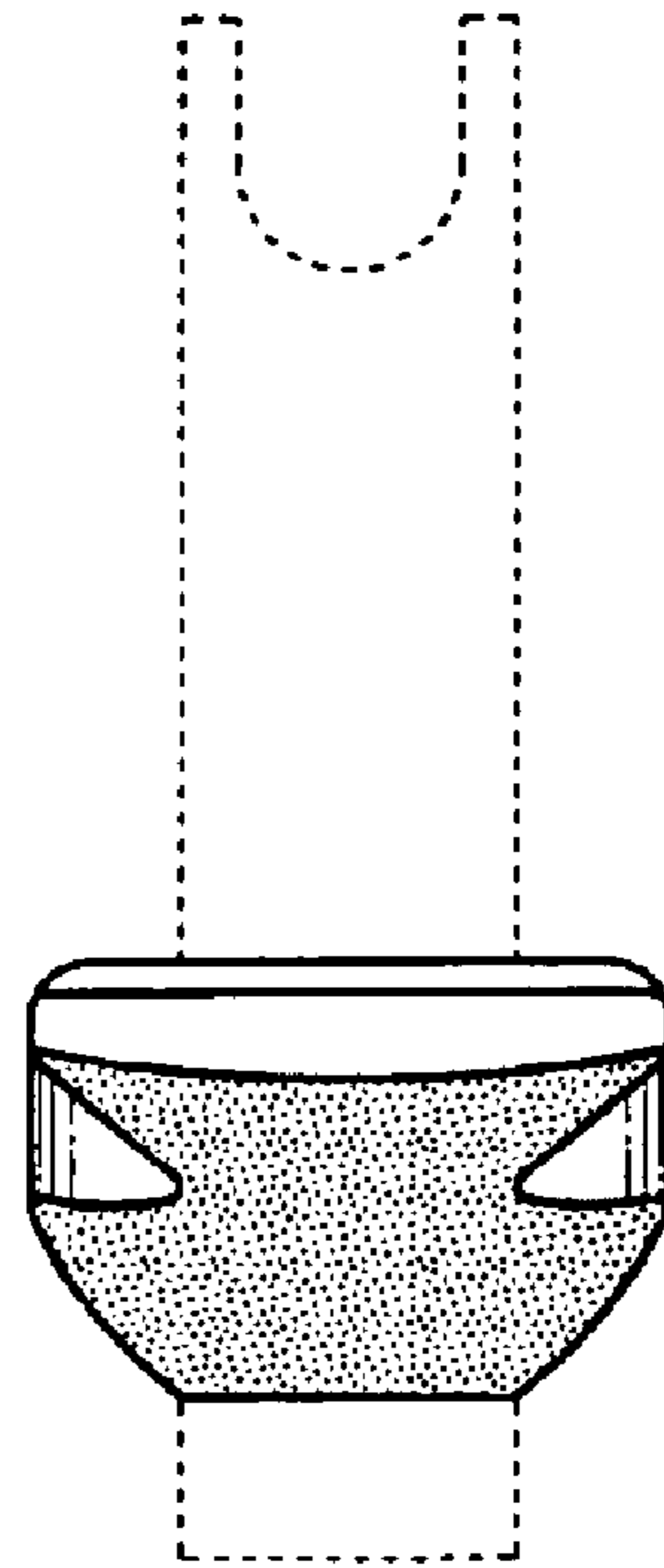
