(57) **CLAIM**

The ornamental design for a child's bowl with lid and cutlery, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view as seen from the upper right front side of a child's bowl with lid and cutlery showing my new design;

FIG. 2 is a perspective view as seen from the upper left front side thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a right side elevational view thereof, with the left side elevational view being a mirror image thereof;

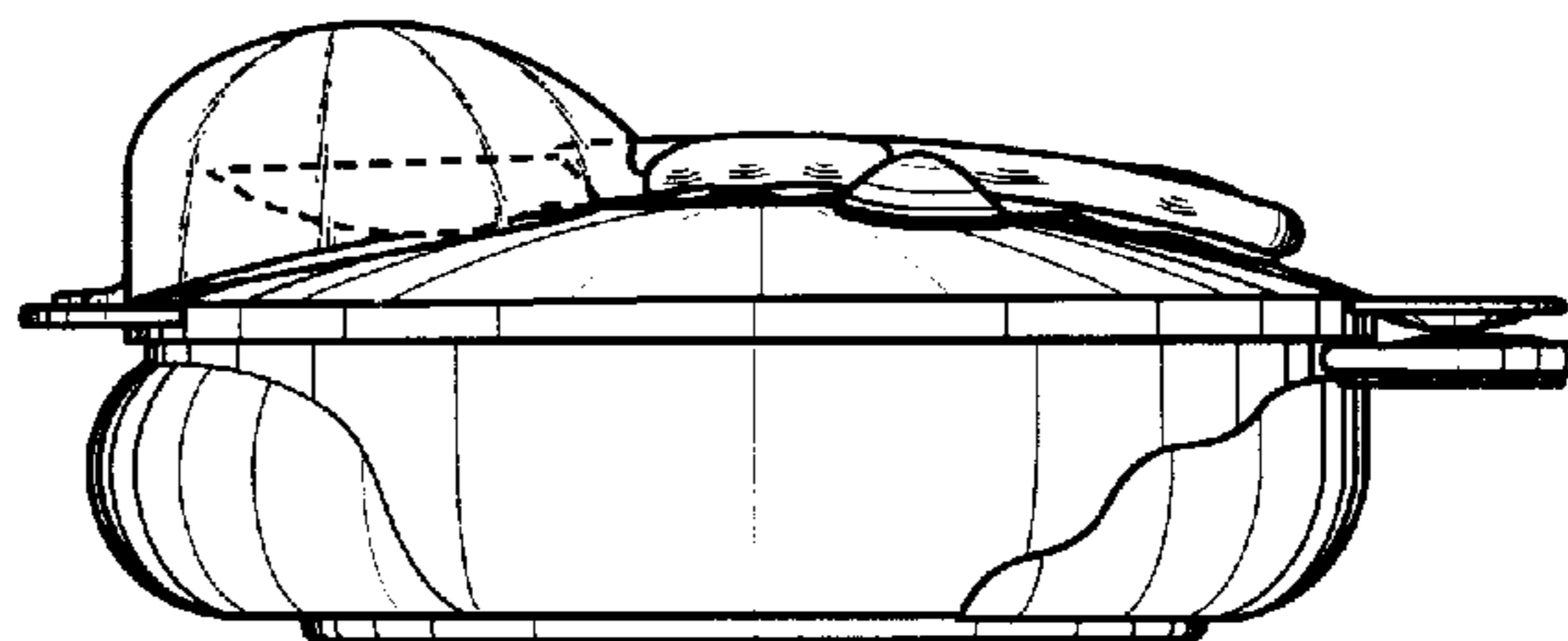
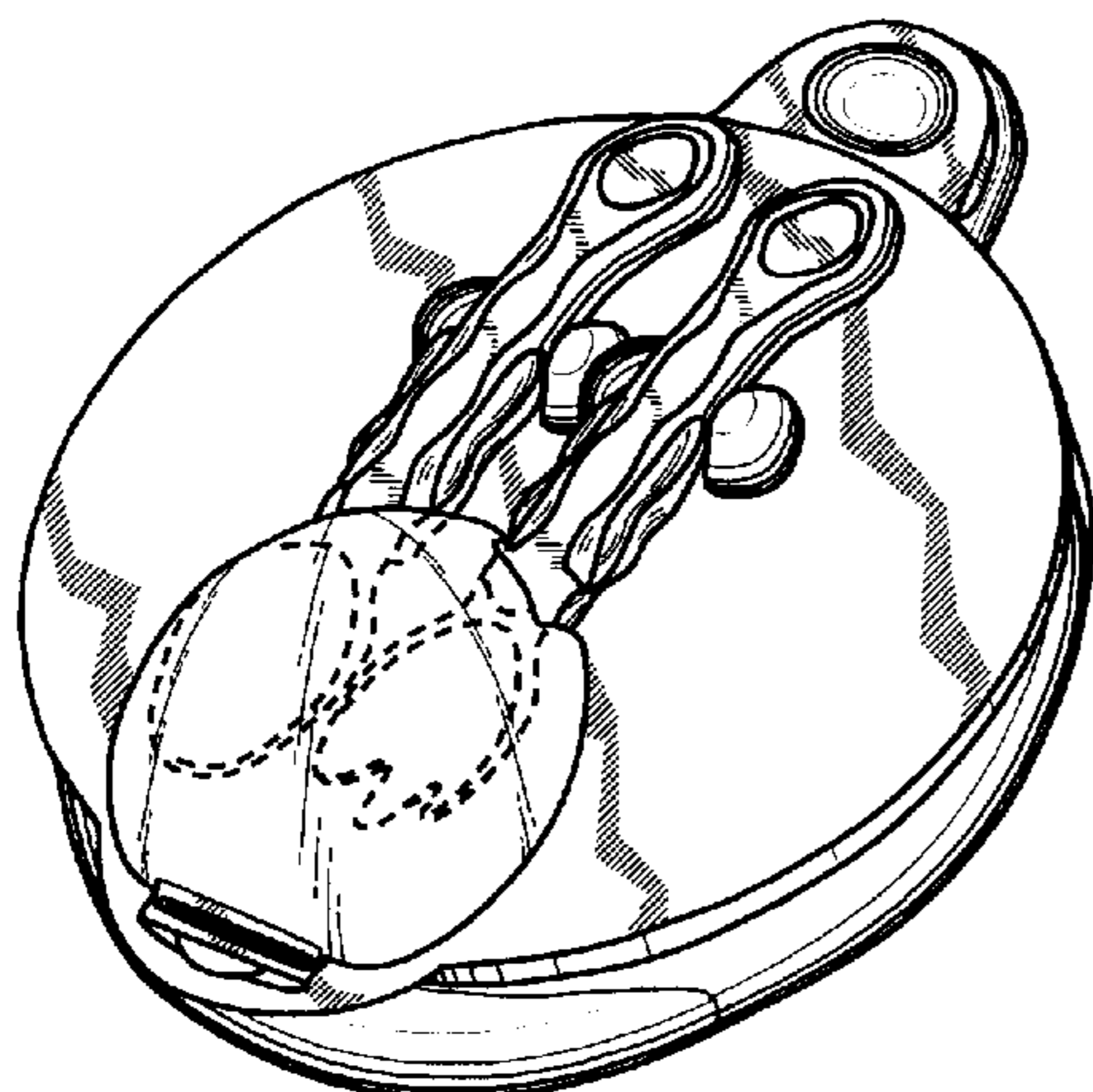
FIG. 5 is an upper end elevational view thereof;

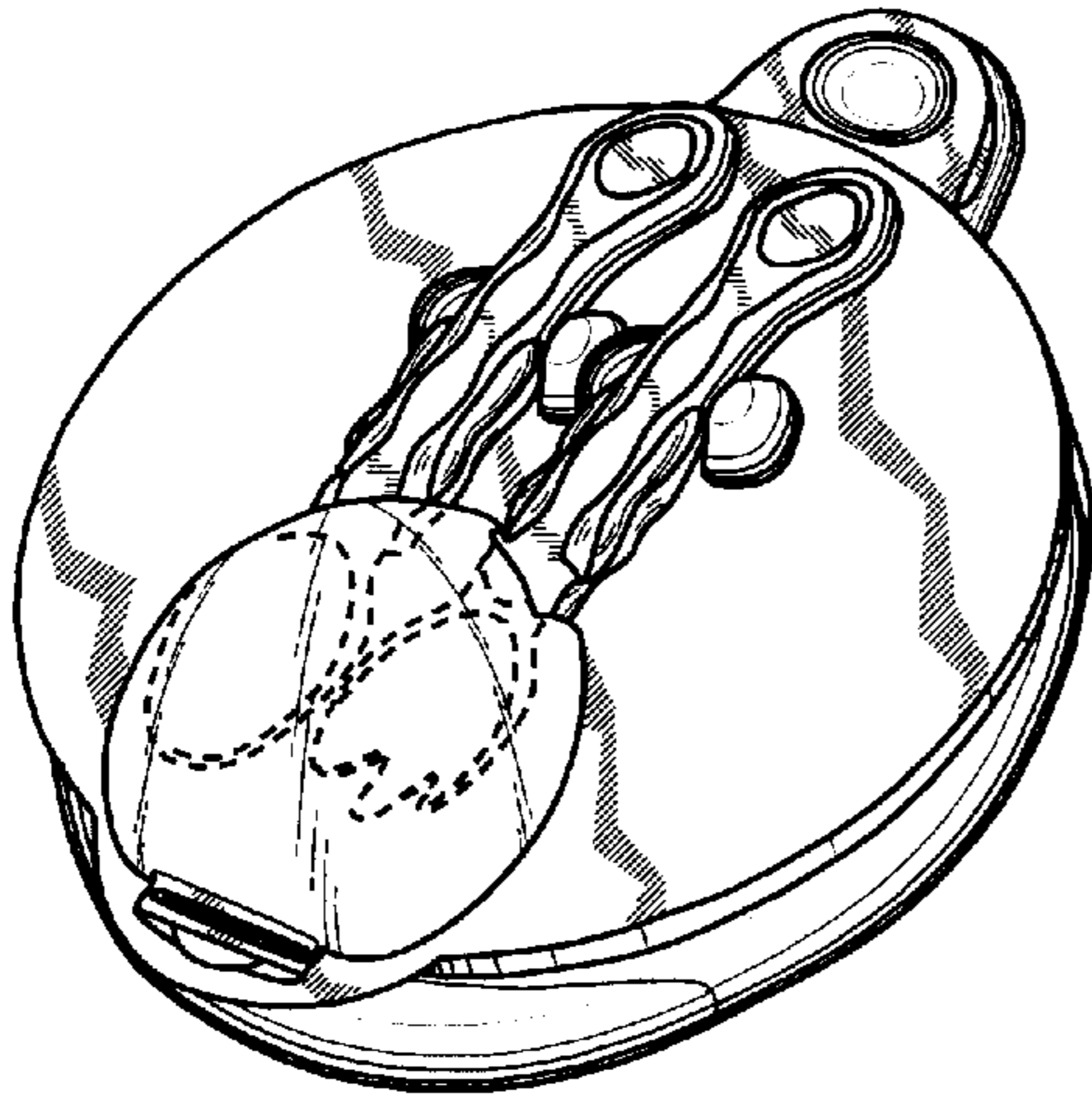

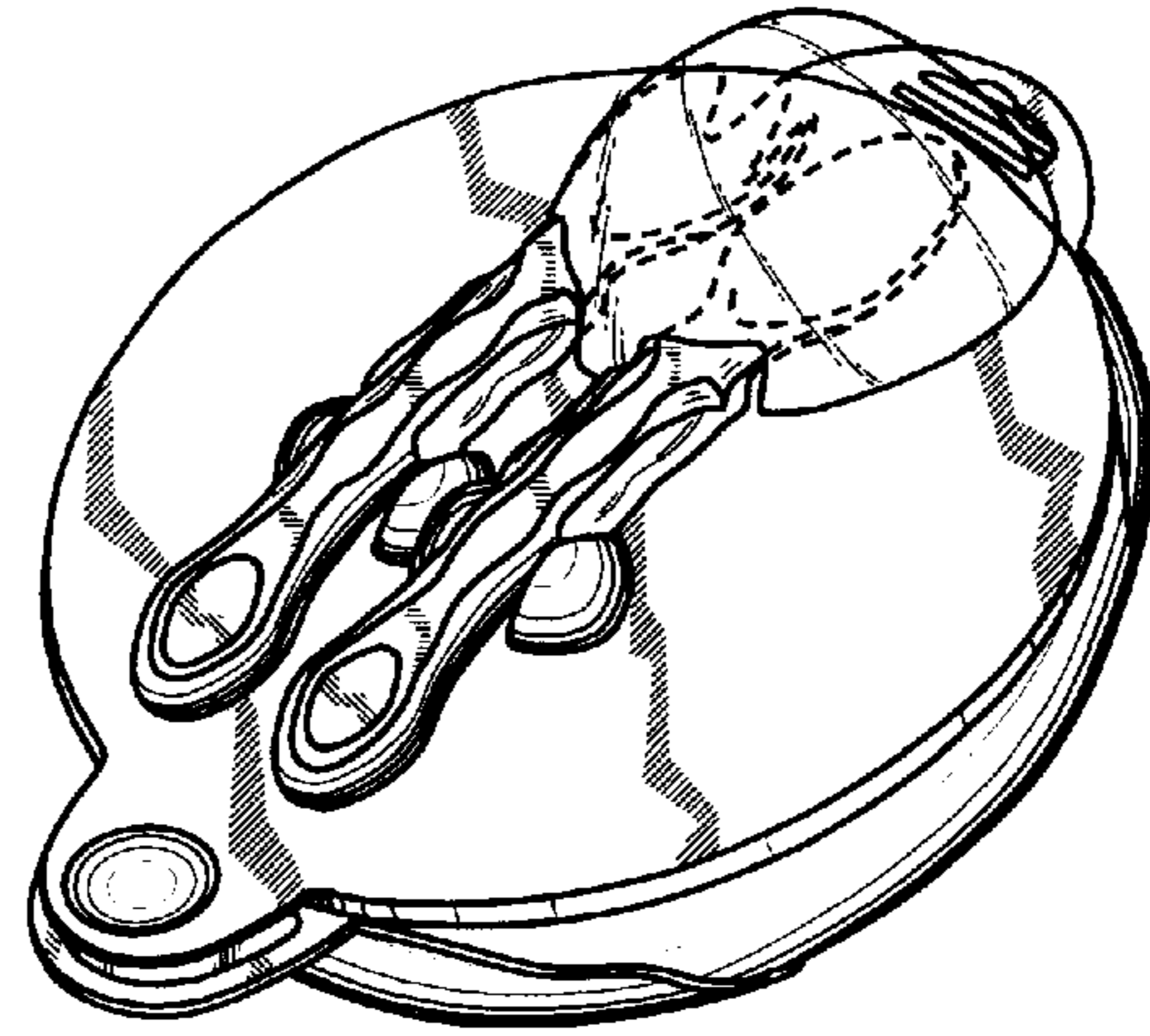

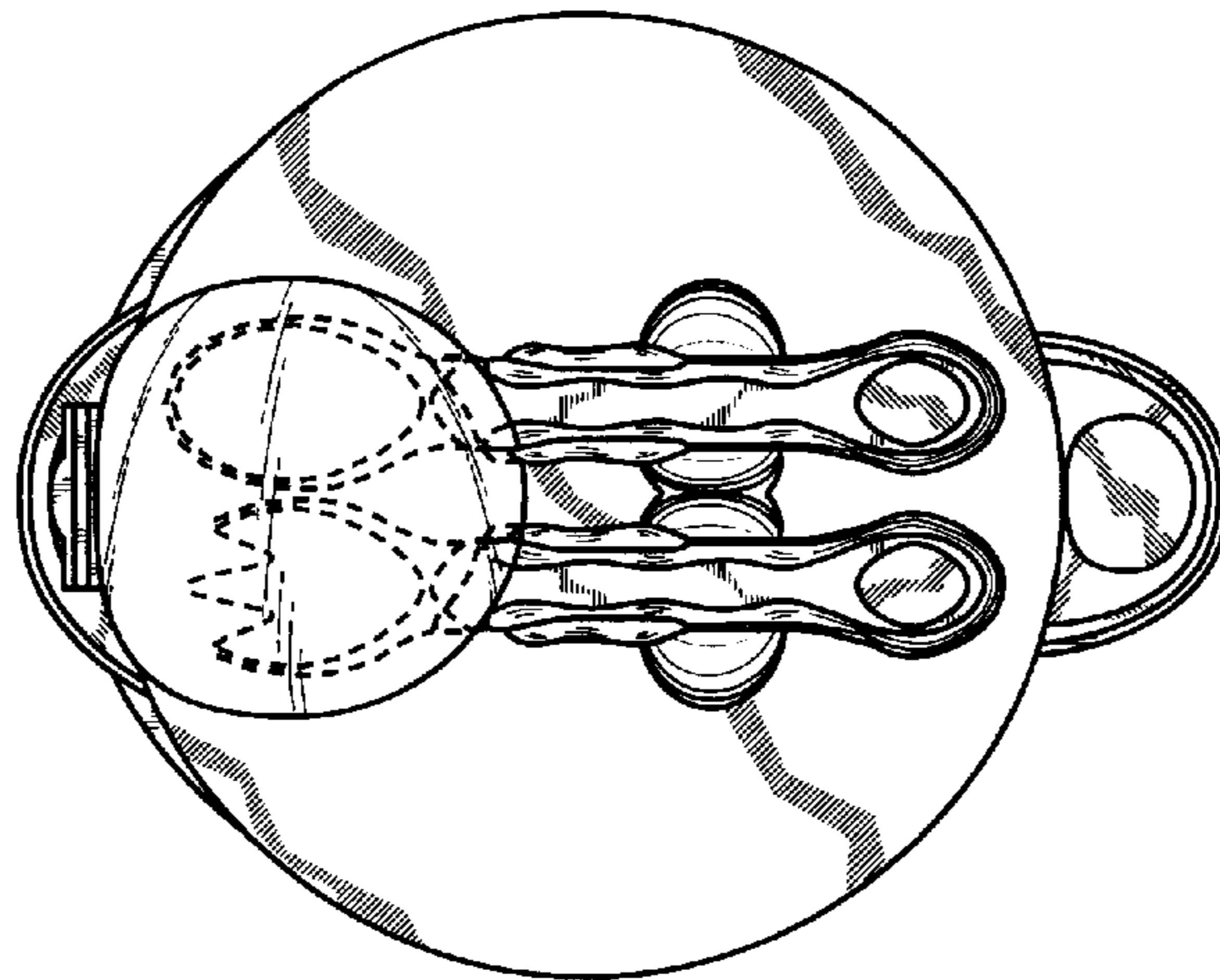

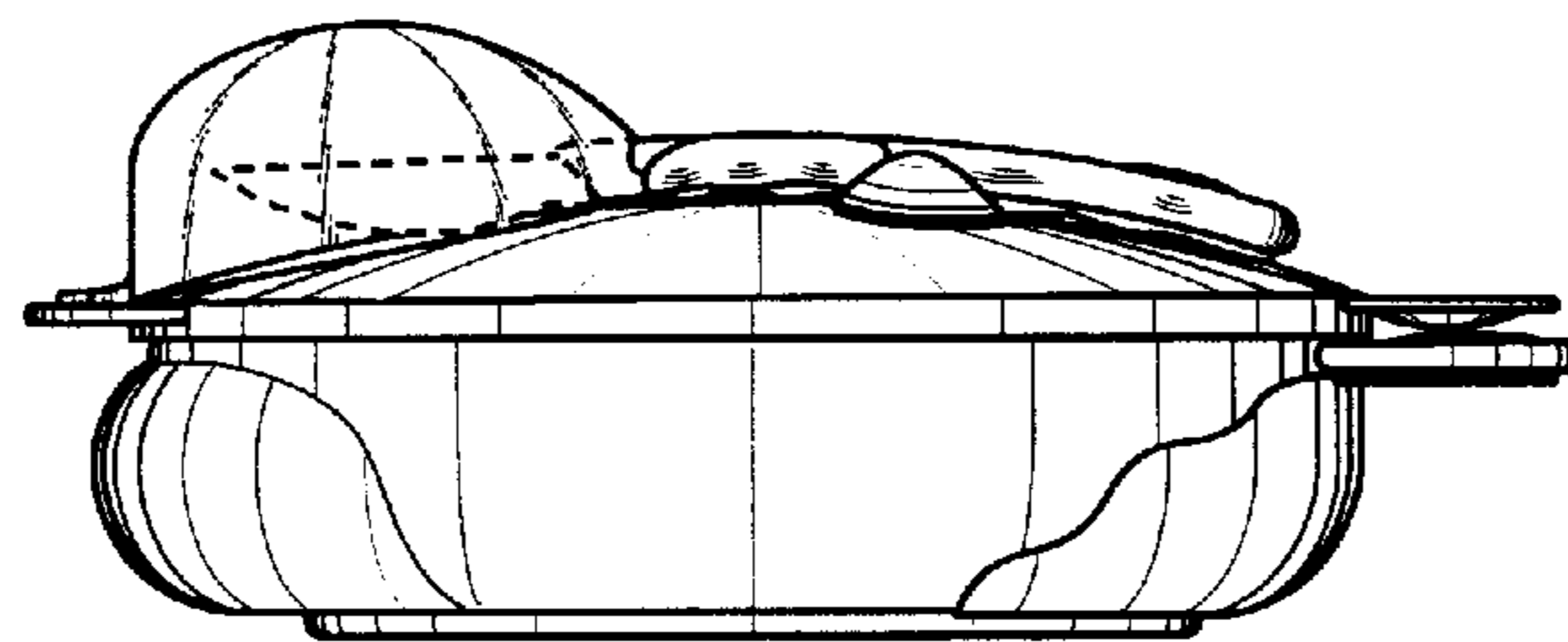

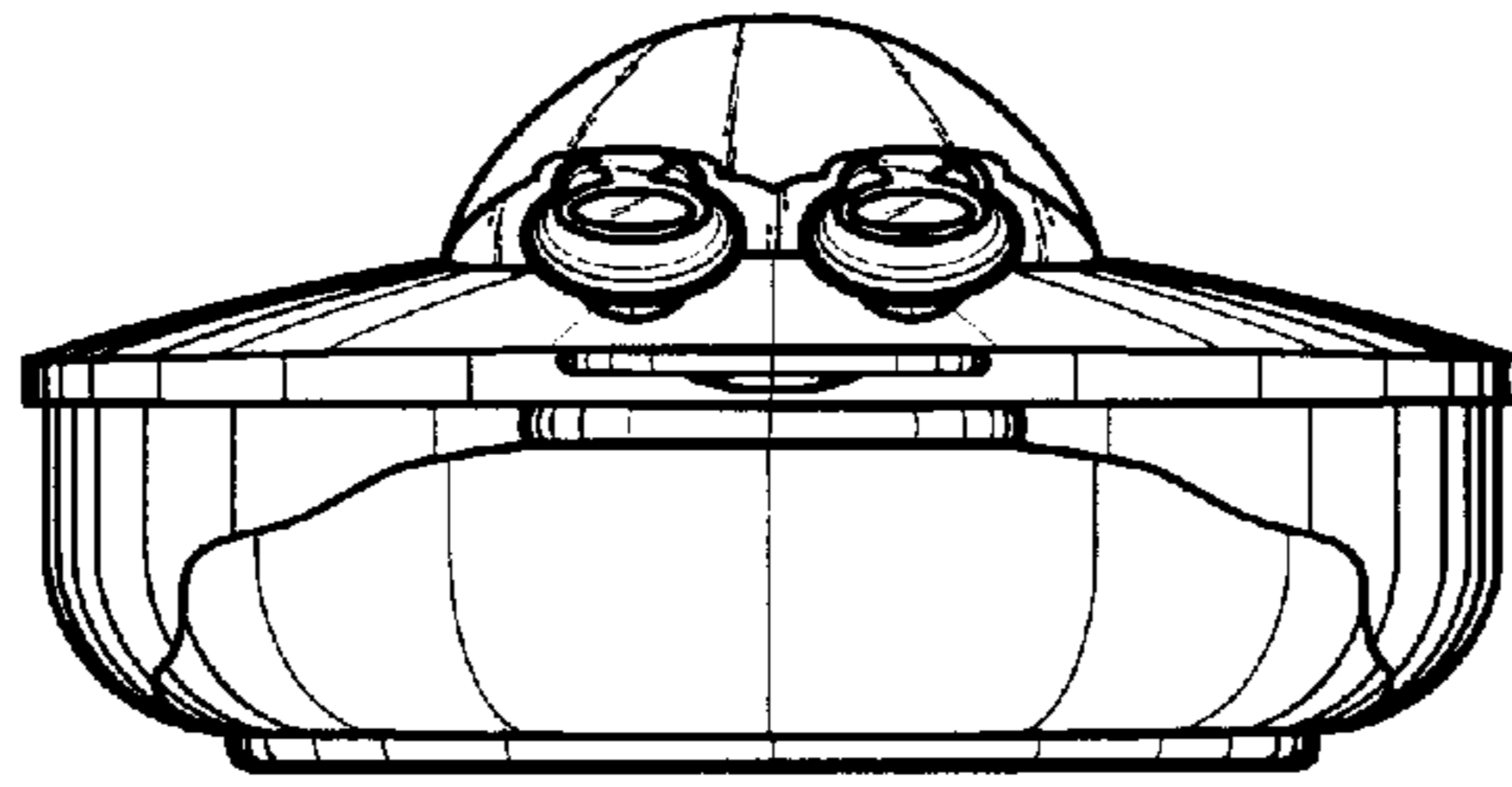

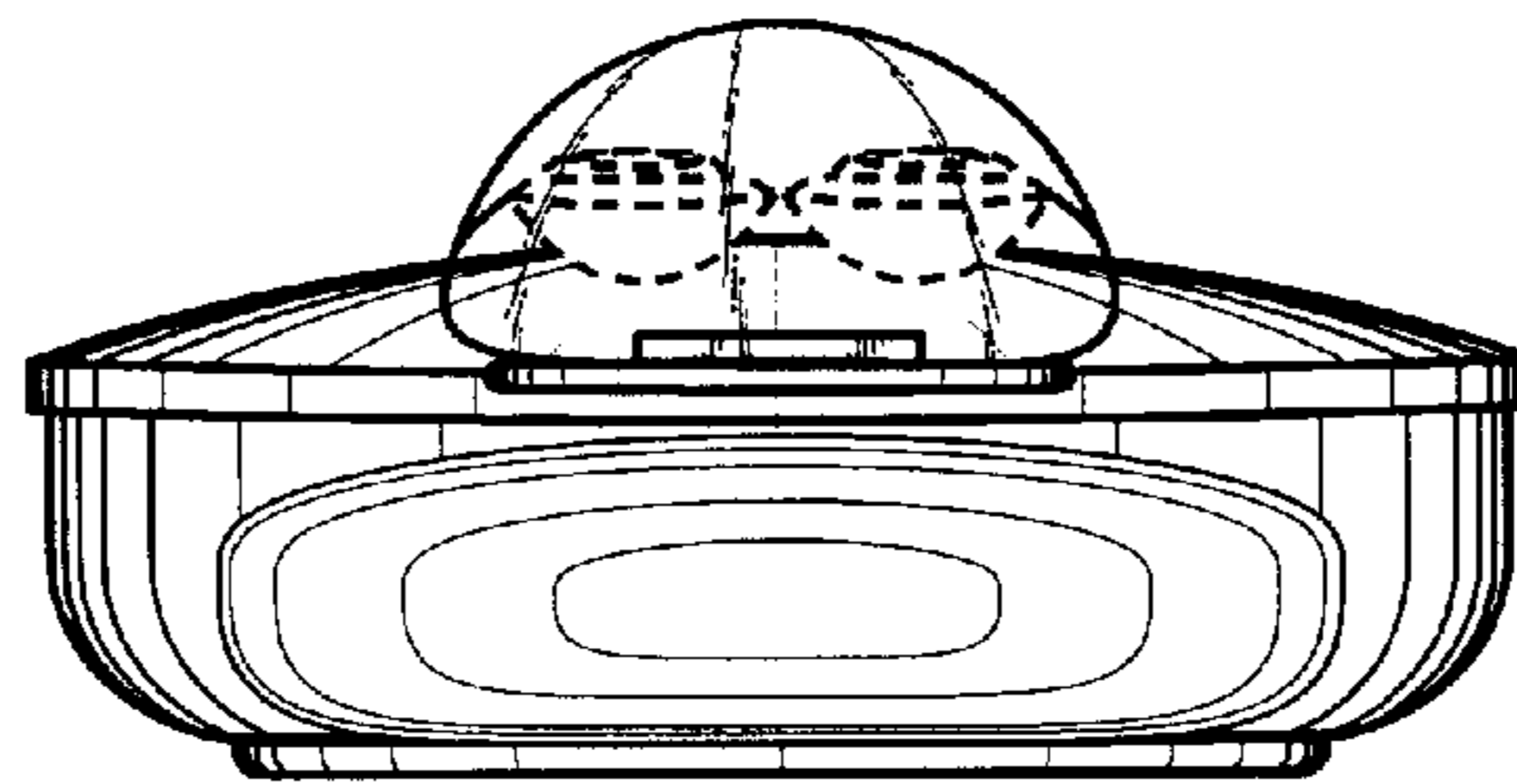

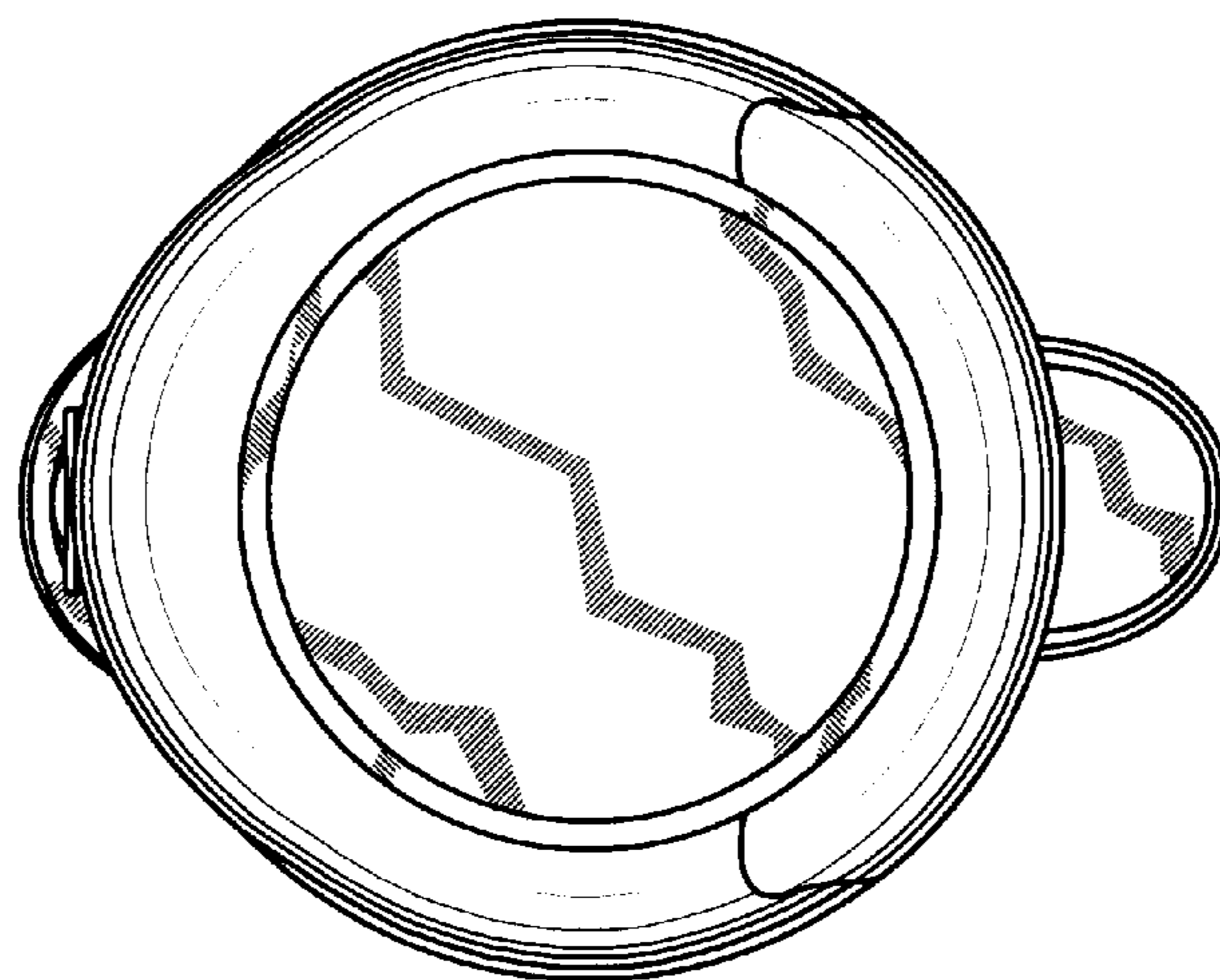
