FIG. 4 is a bottom plan view of an eating utensil;

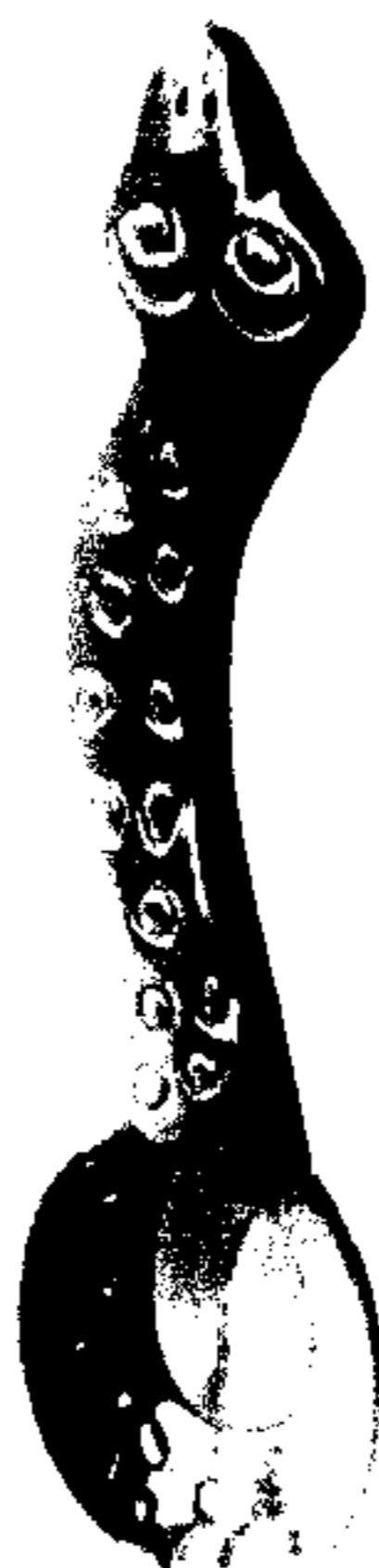
FIG. 5 is a left side elevation view of an eating utensil;

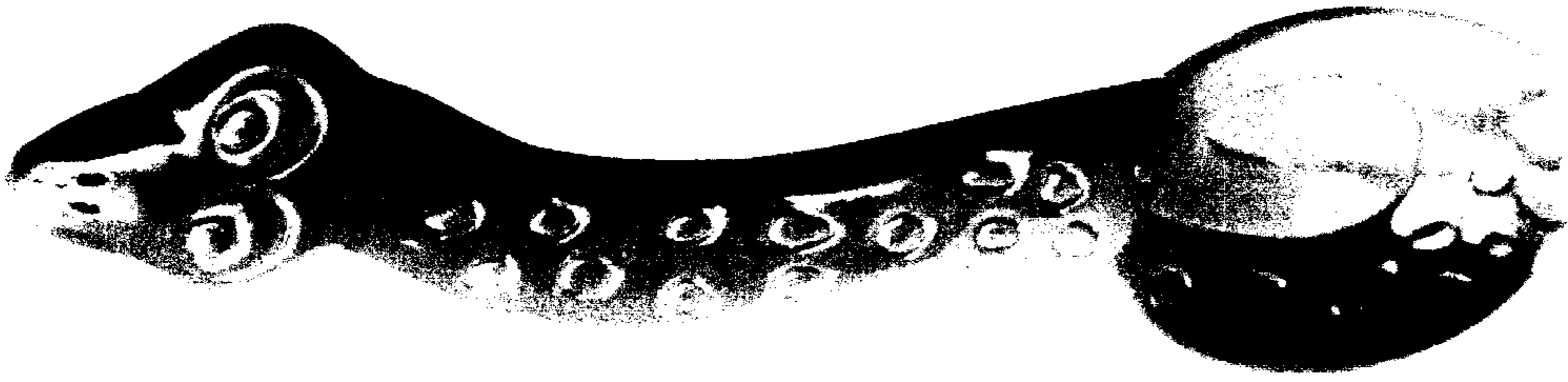

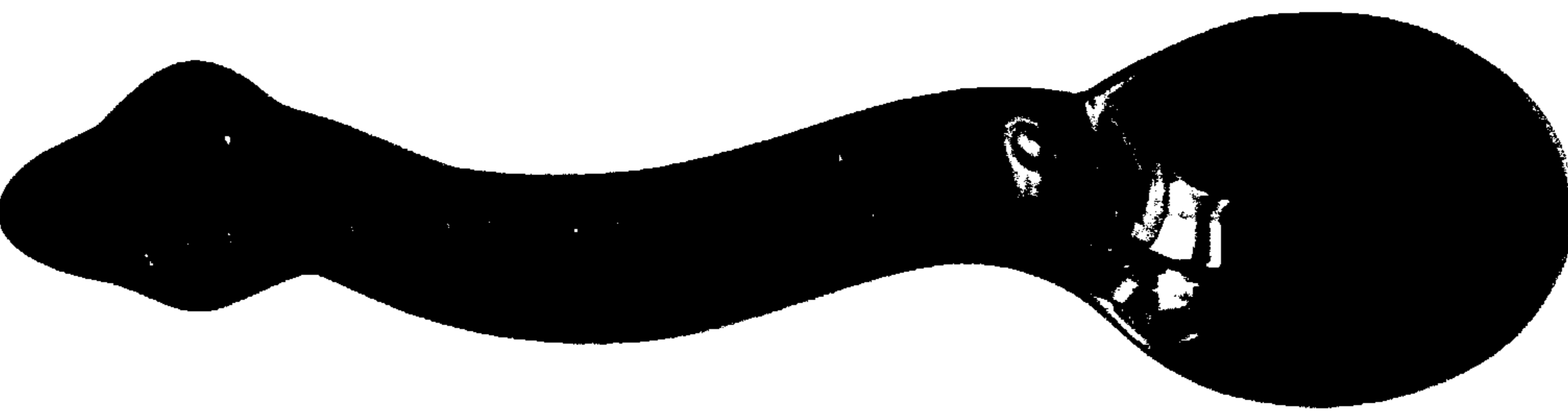

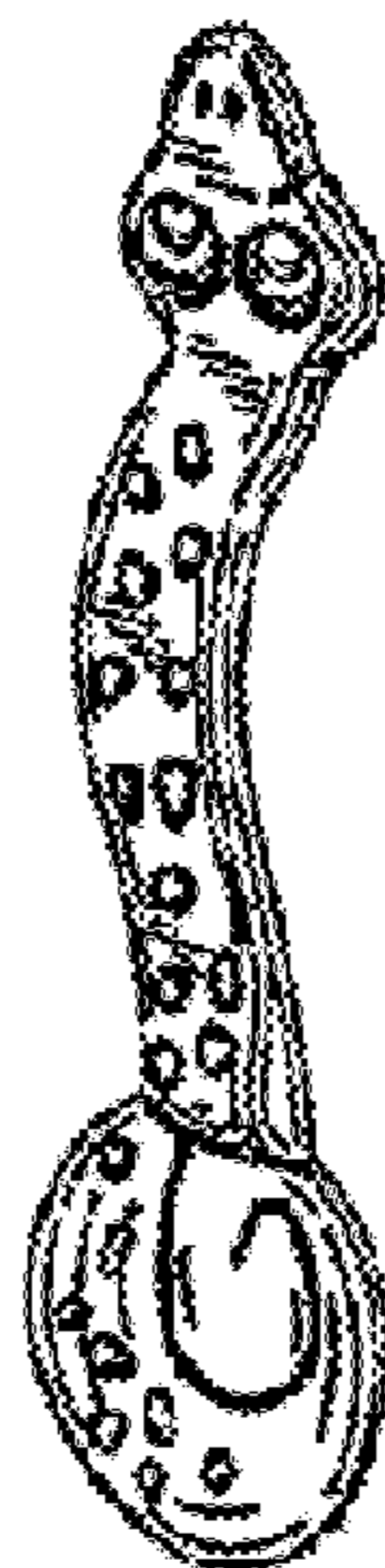

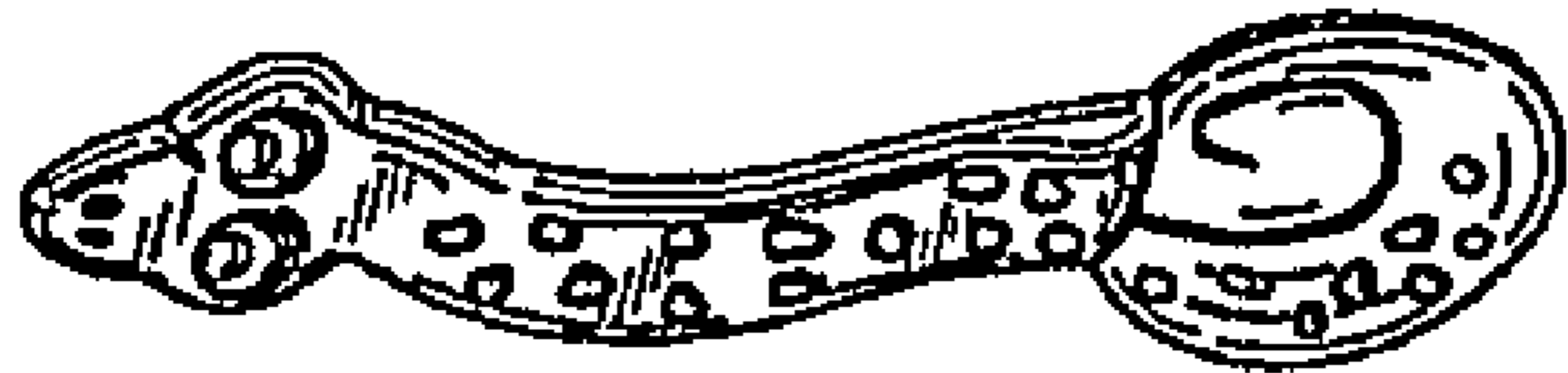

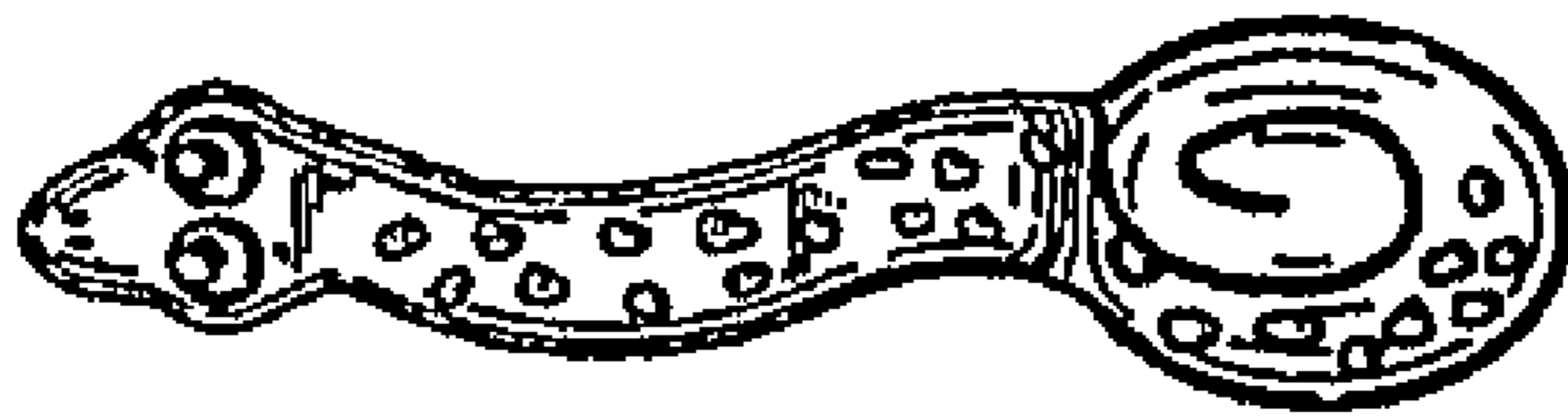

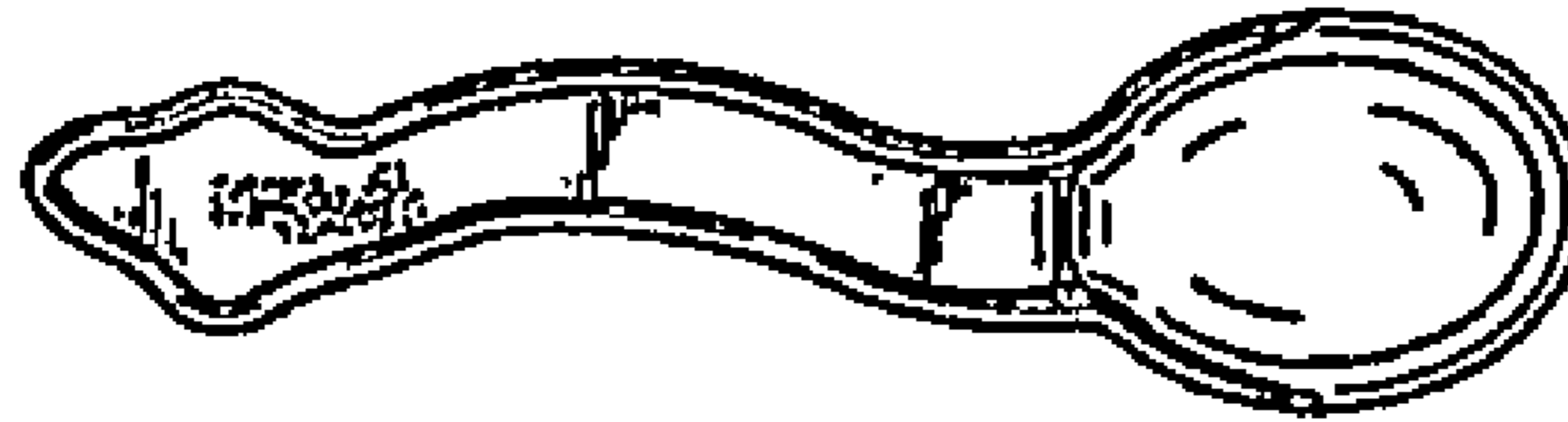

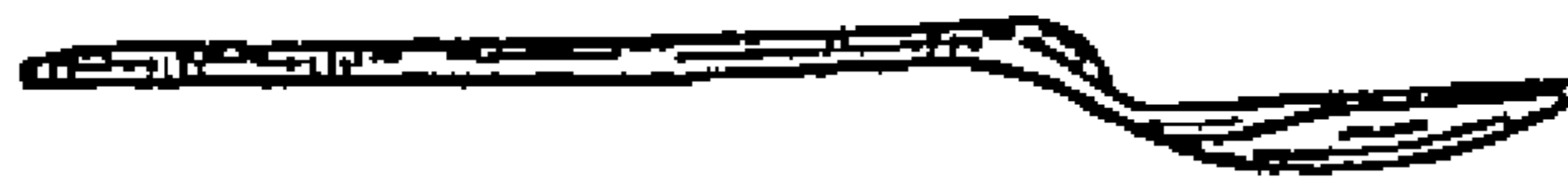
