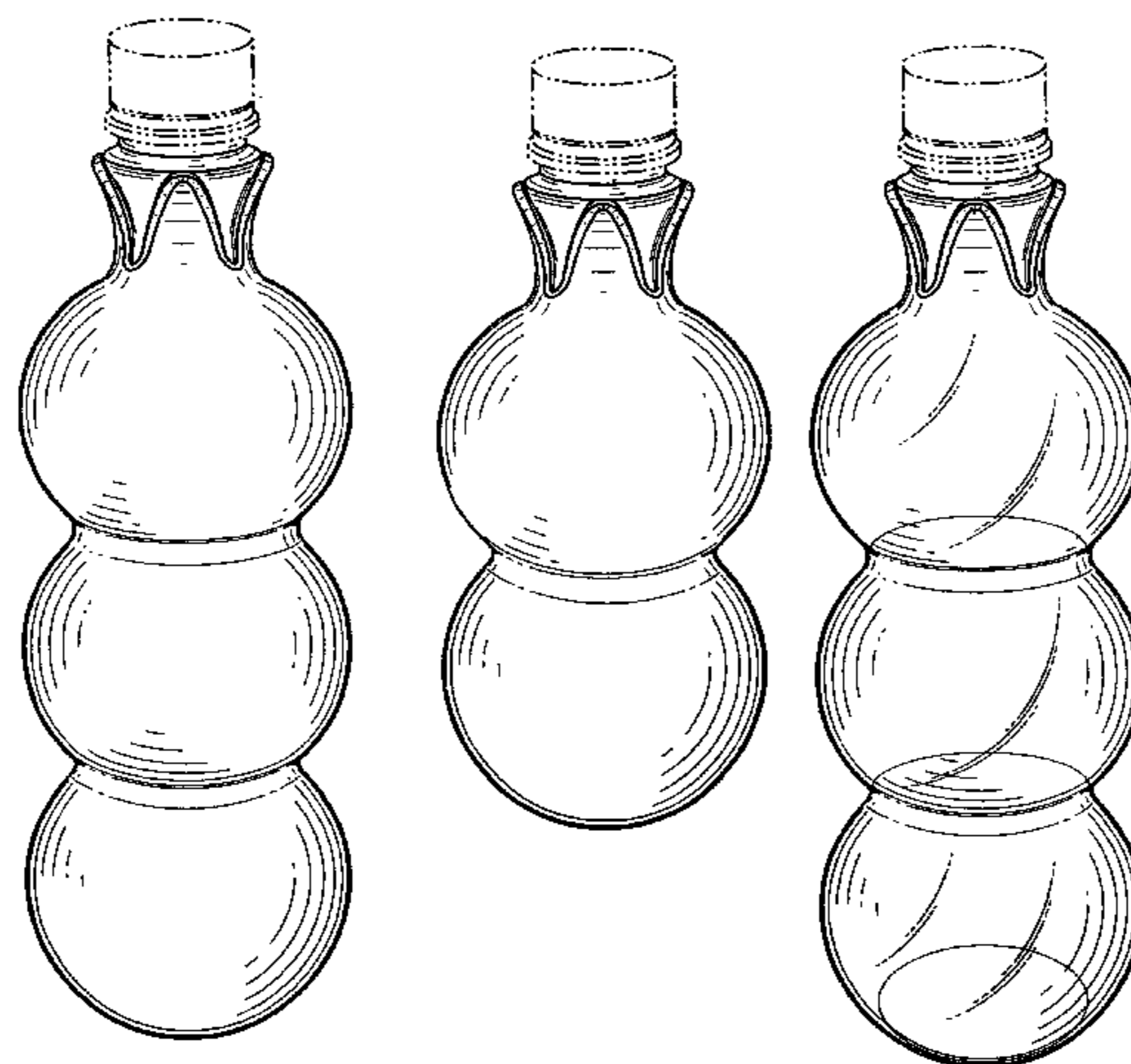
(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a bottle embodying my new design, the bottle being opaque;  
 FIG. 2 is a top plan view of the bottle of FIG. 1;  
 FIG. 3 is a side elevational view of the bottle of FIG. 1;  
 FIG. 4 is a perspective view of a second embodiment of the bottle embodying my new design, the bottle being opaque;  
 FIG. 5 is a top plan view of the bottle of FIG. 4;  
 FIG. 6 is a side elevational view of the bottle of FIG. 4;  
 FIG. 7 is a perspective view of a third embodiment of the bottle embodying my new design, the bottle being transparent;  
 FIG. 8 is a top plan view of the bottle of FIG. 7;  
 FIG. 9 is a side elevational view of the bottle of FIG. 7;  
 FIG. 10 is a perspective view of a fourth embodiment of the bottle embodying my new design, the bottle being transparent;  
 FIG. 11 is a top plan view of the bottle of FIG. 10; and,  
 FIG. 12 is a side elevational view of the bottle of FIG. 10.  
 The broken line showing in FIGS. 1-12 is for environmental purposes only and forms no part of the claimed design.

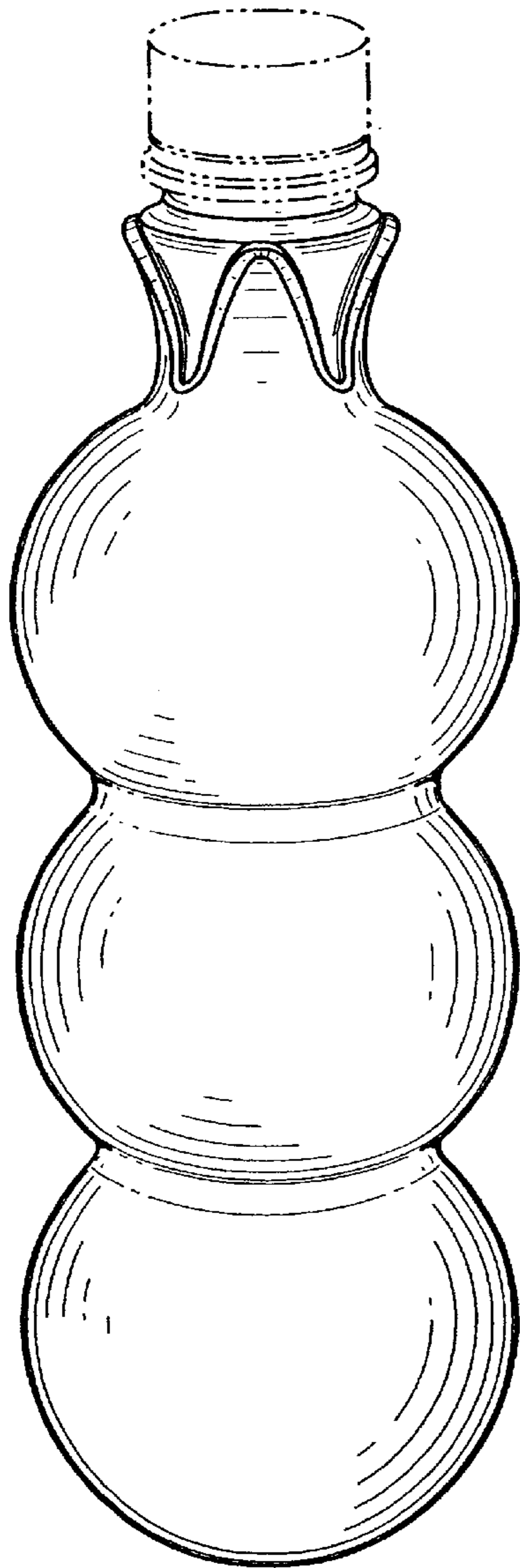

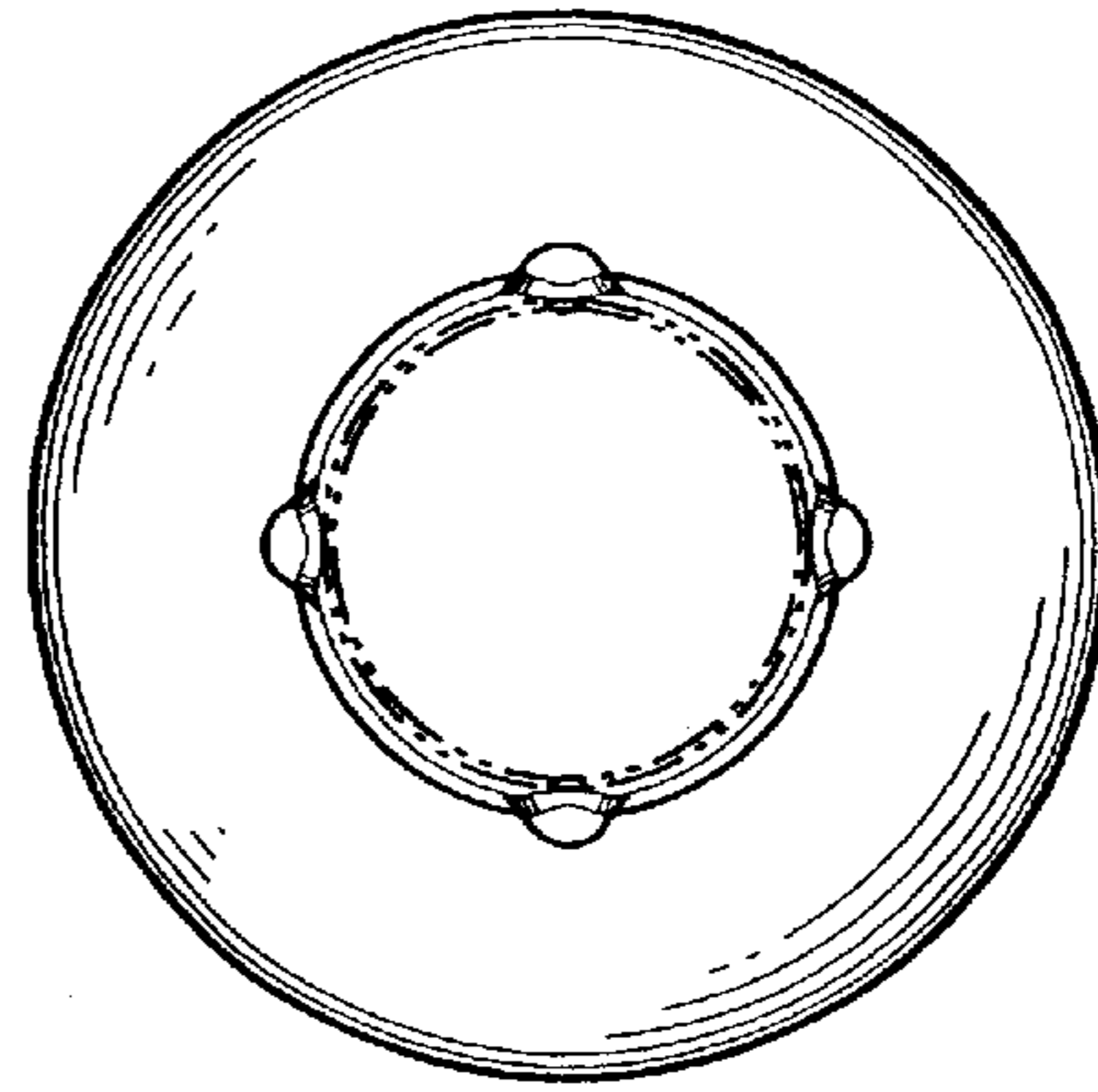

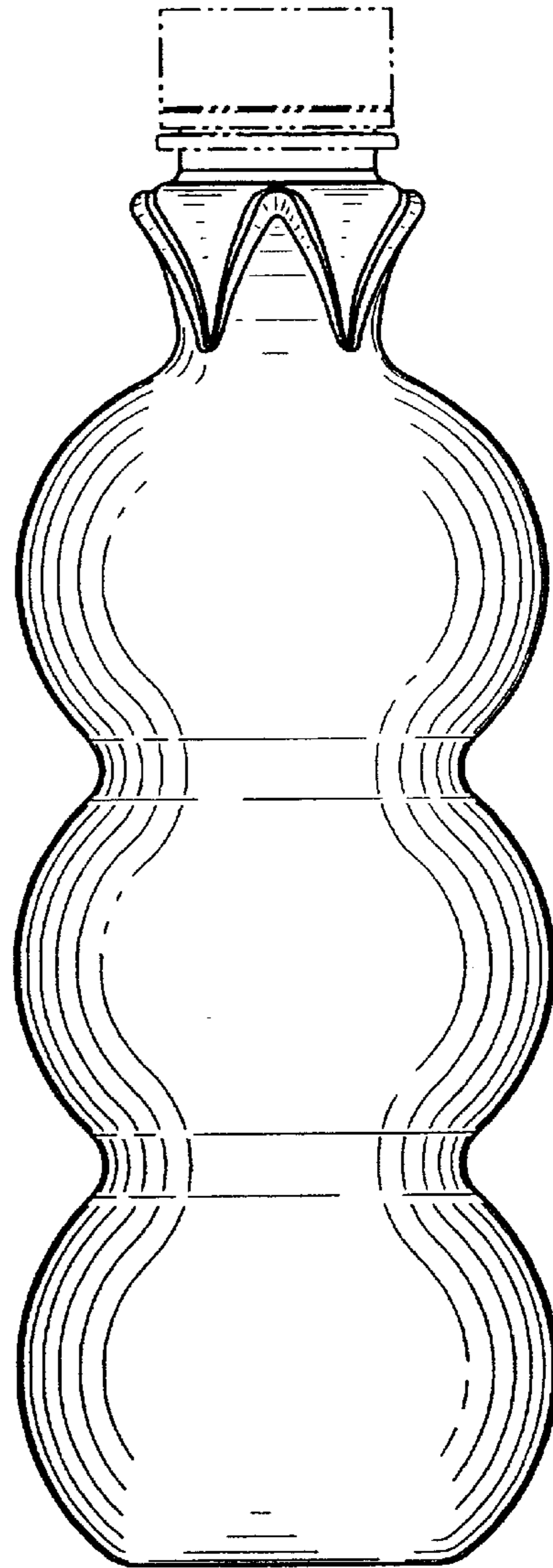

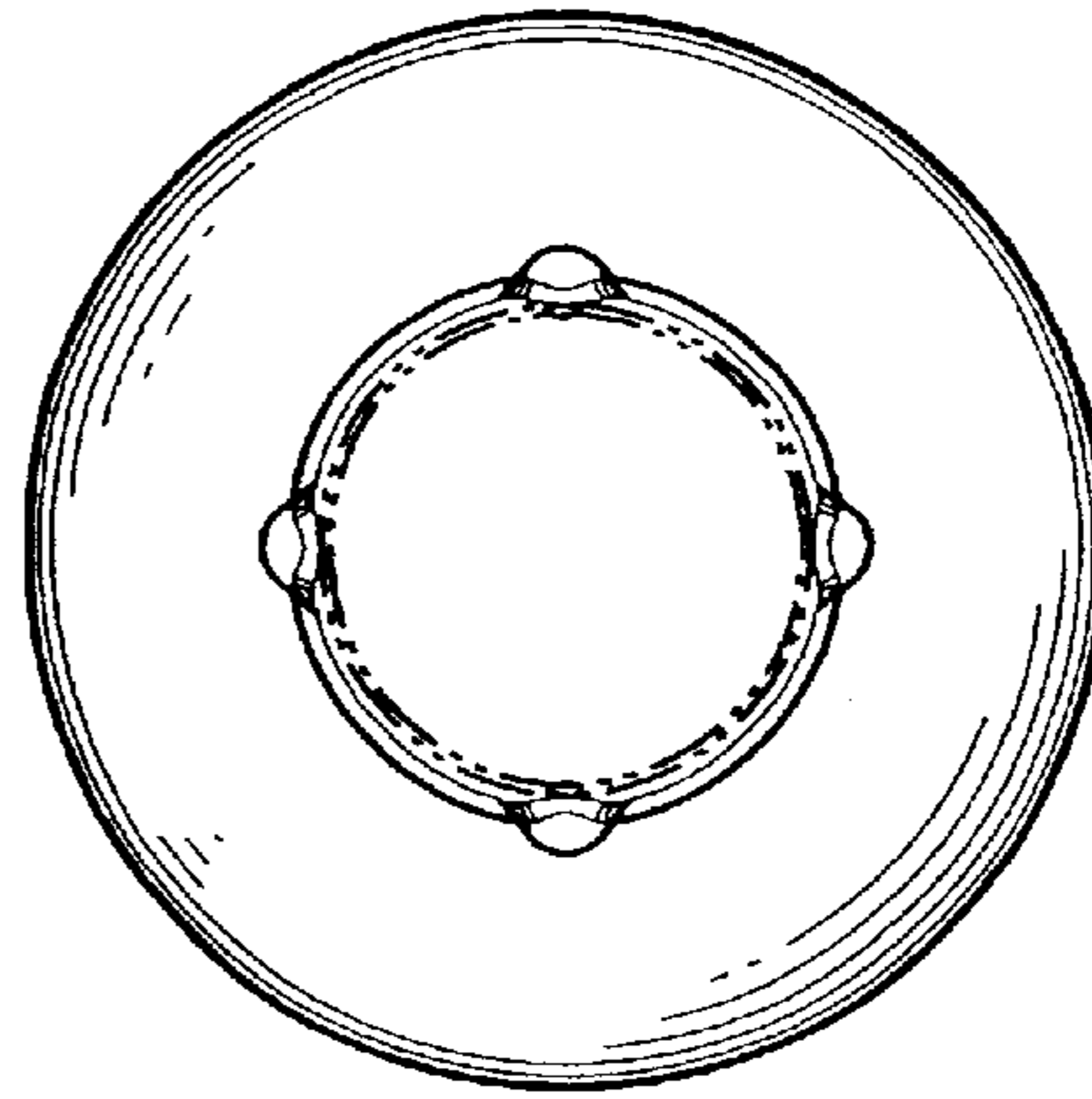

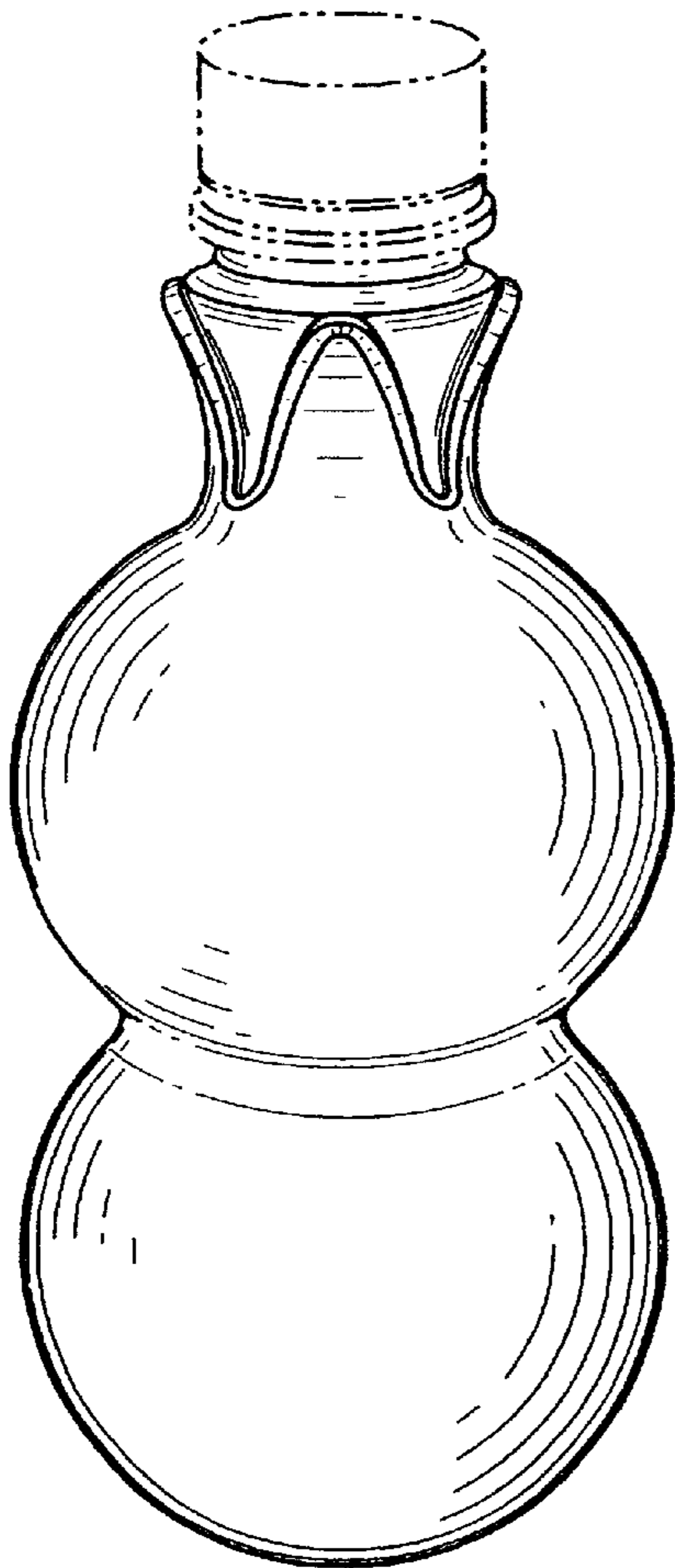

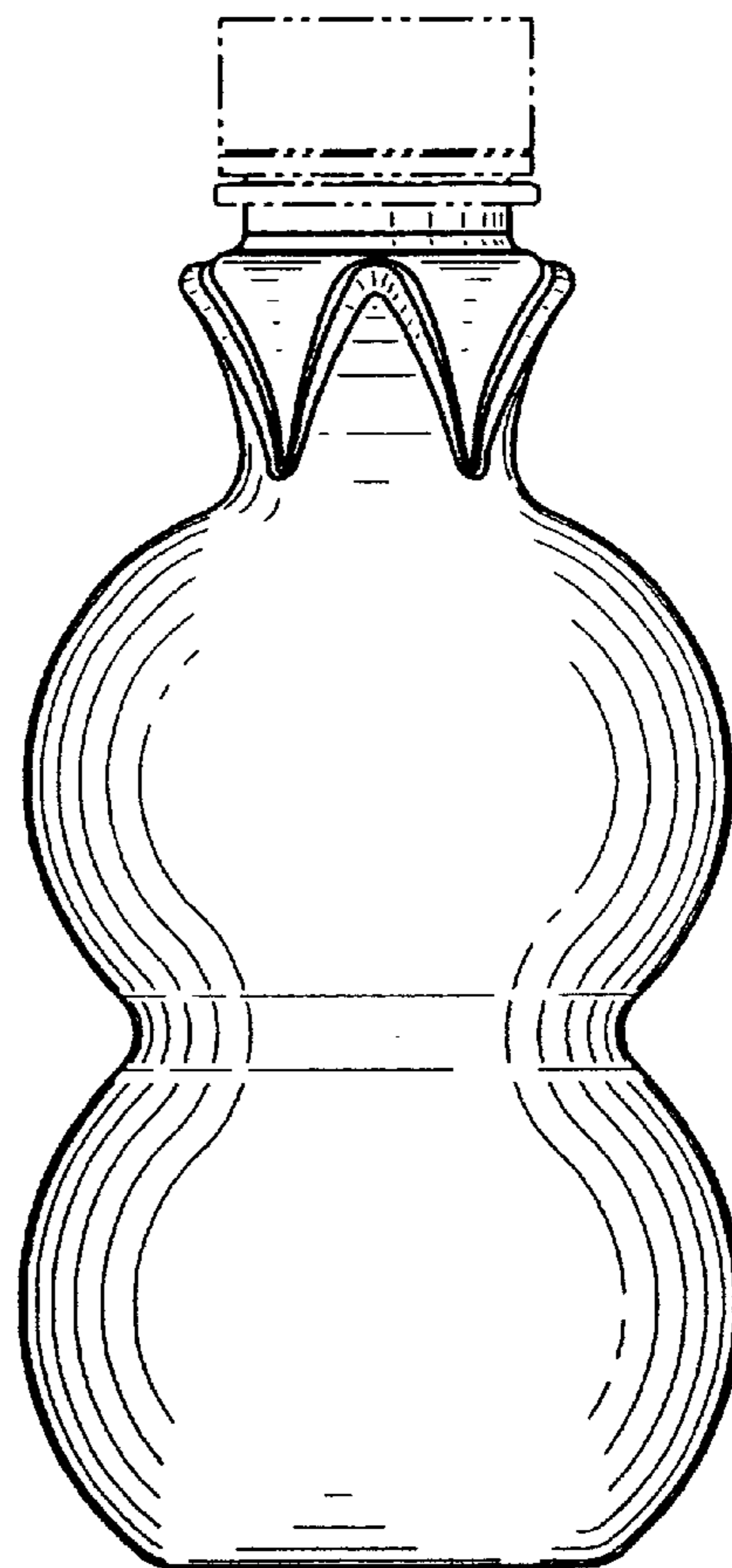

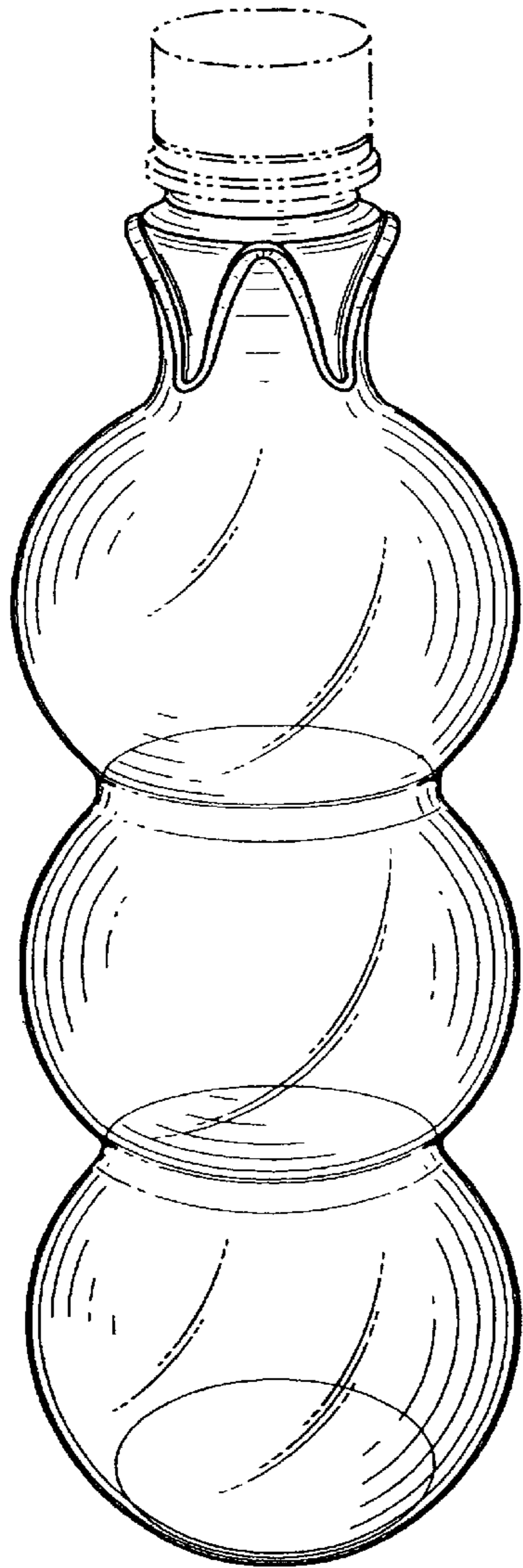

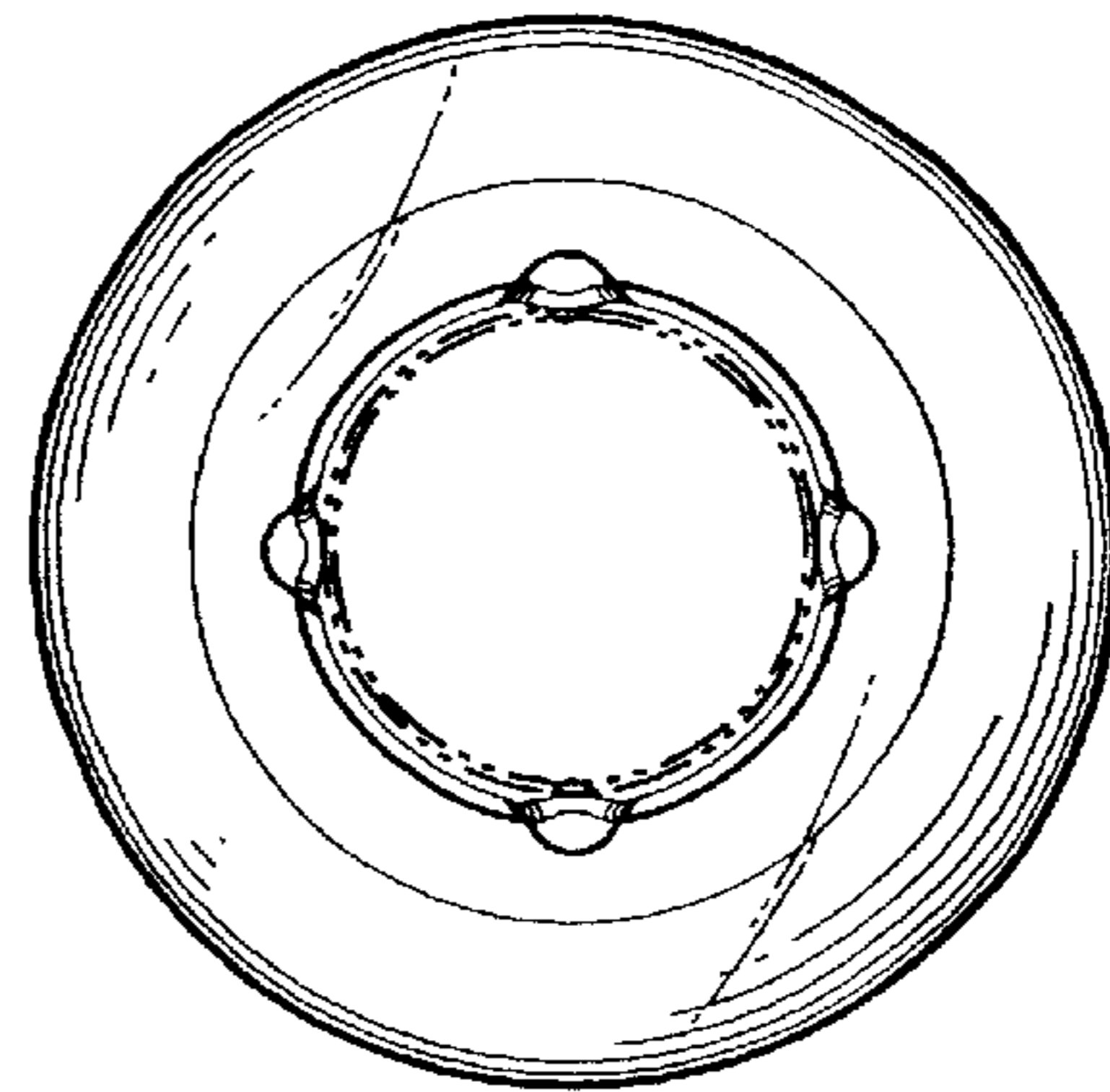

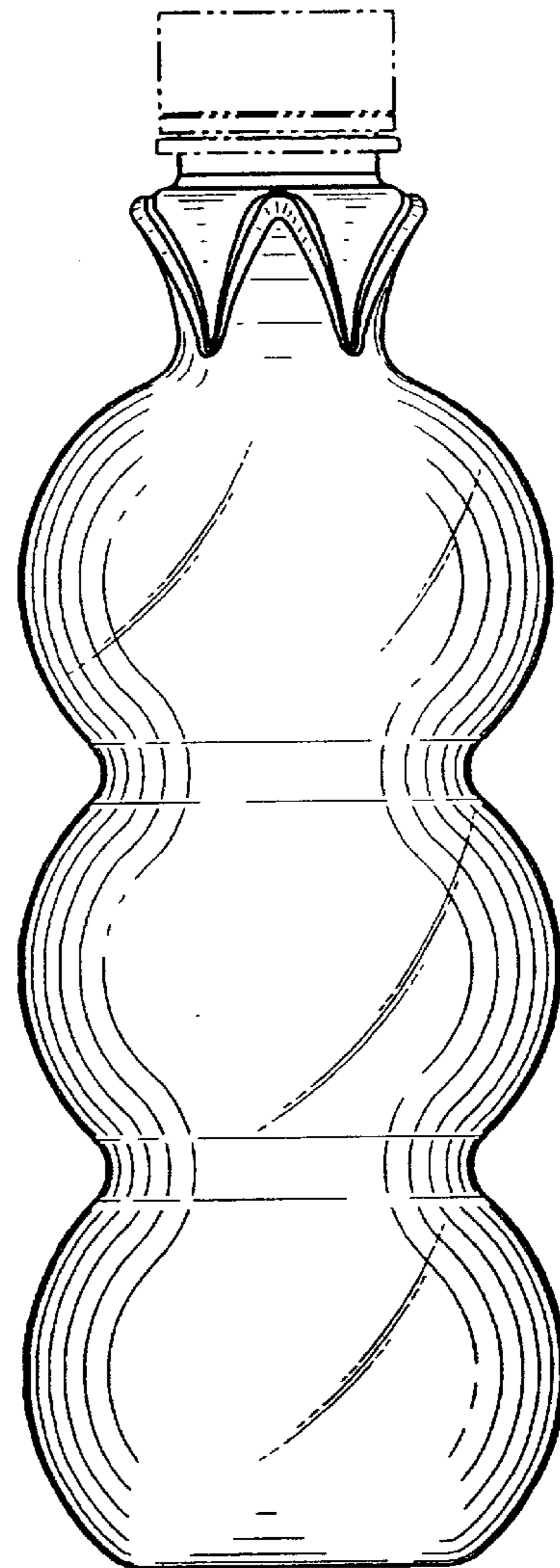

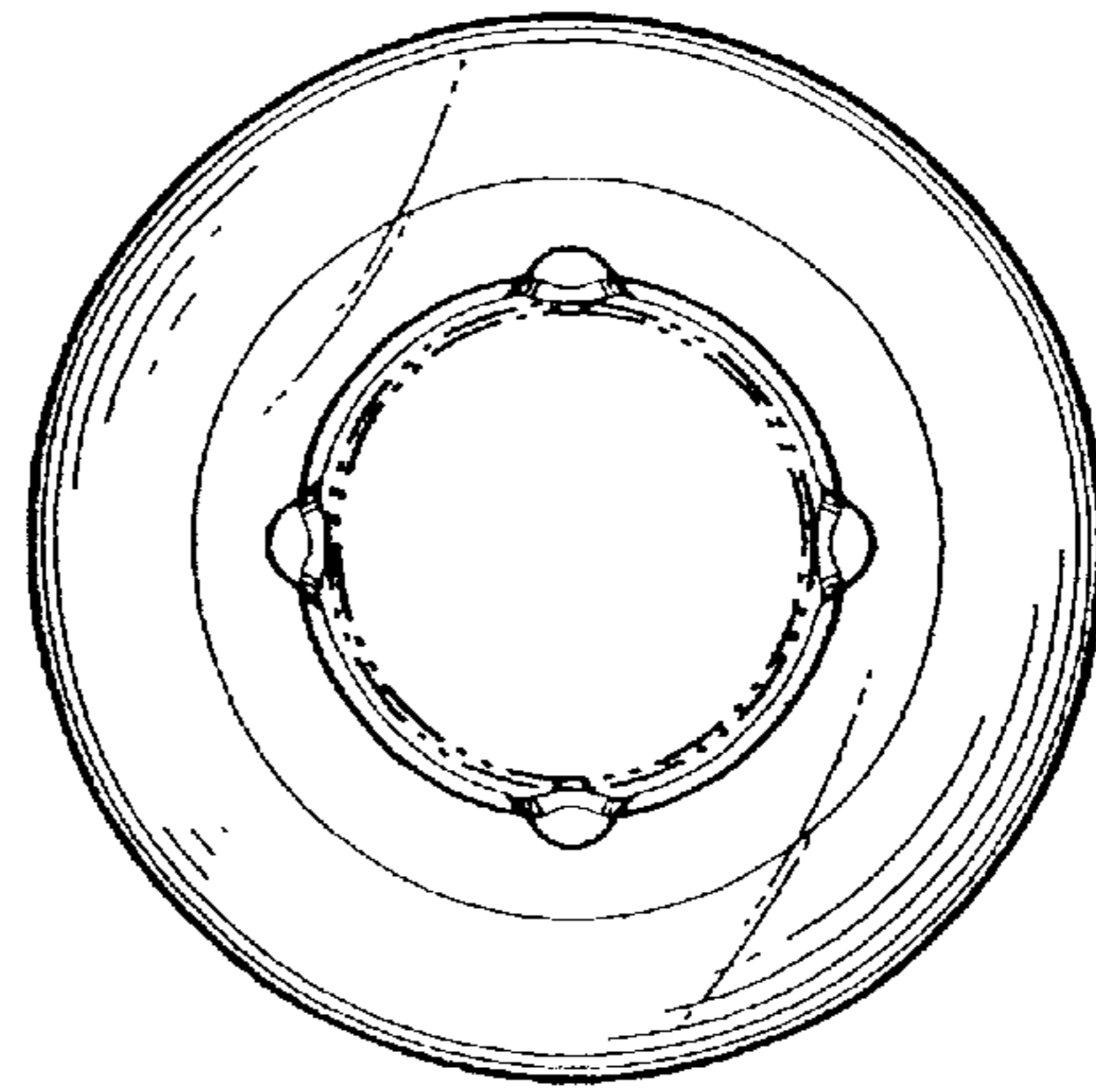

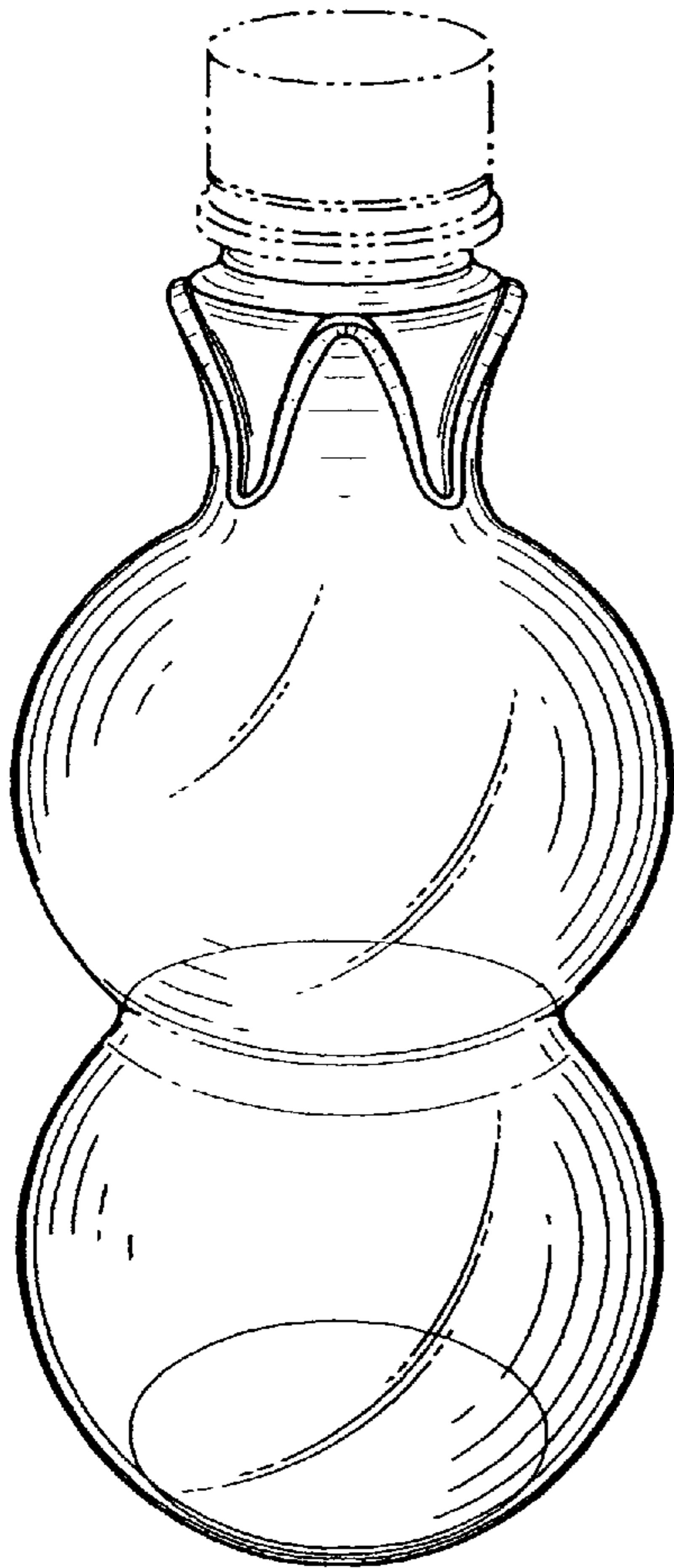

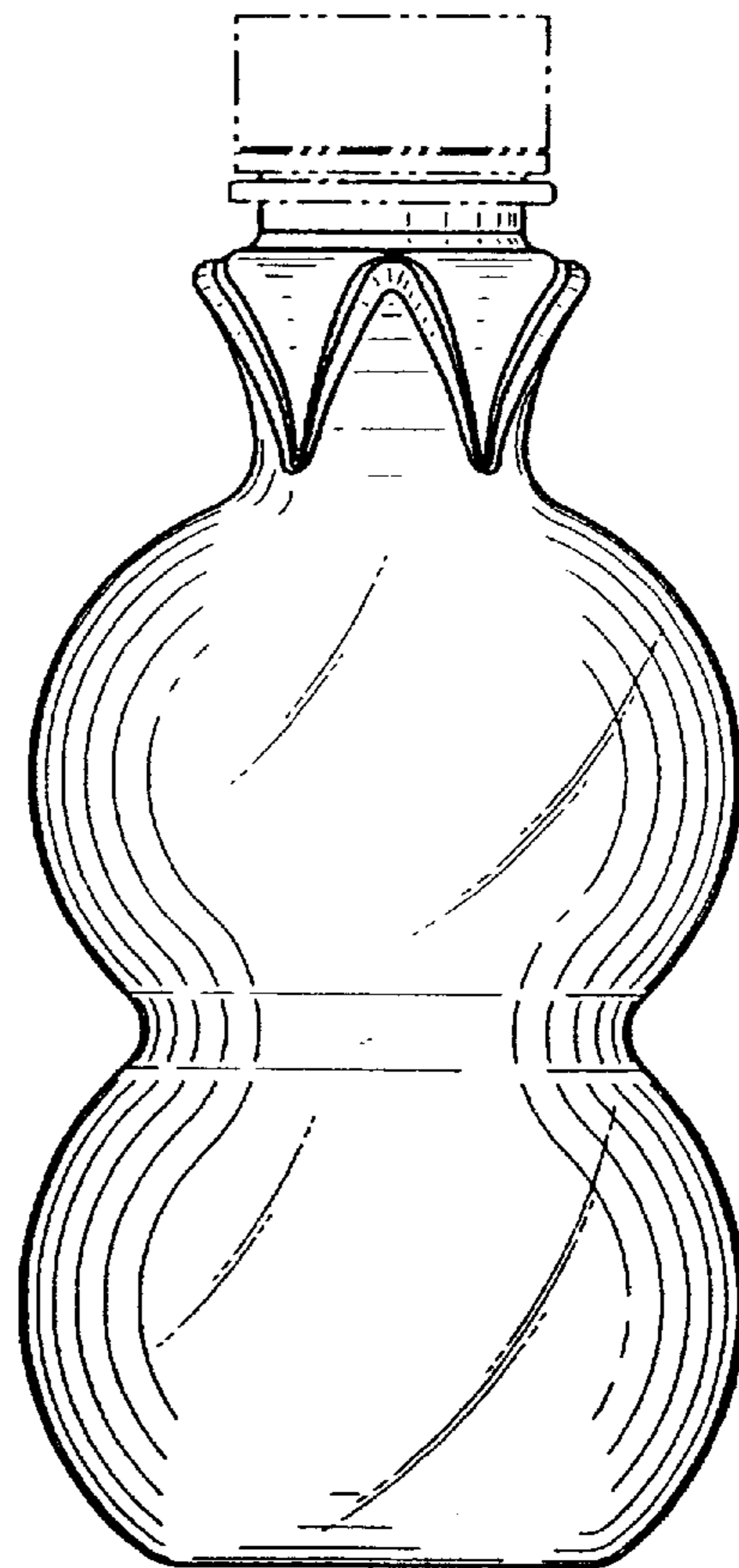
