The ornamental design for a motion detector head, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a motion detector head showing my new design;

FIG. 2 is a right elevational view of the motion detector head of FIG. 1; the left elevational view is a mirror image;

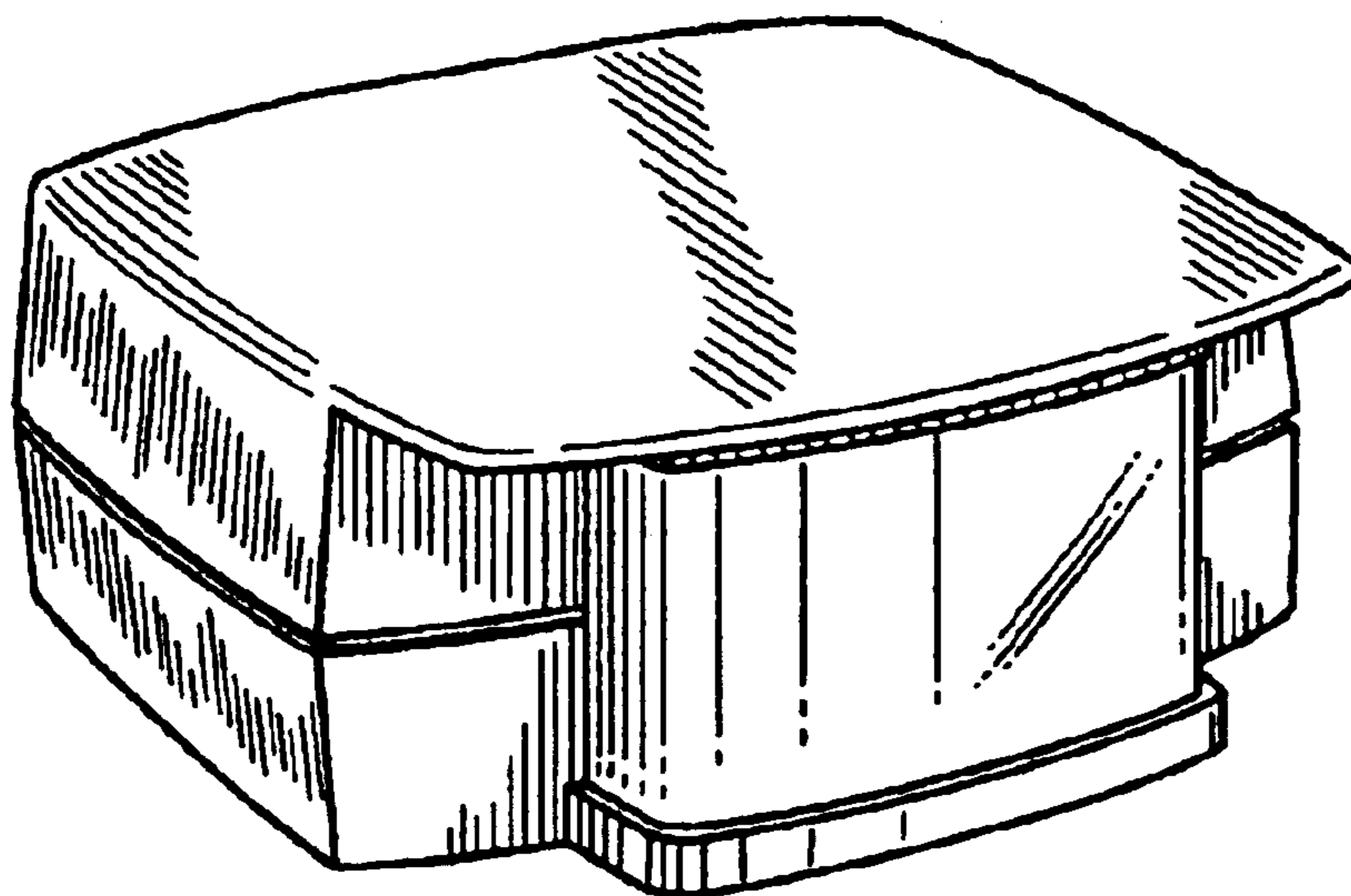
FIG. 3 is a top plan view thereof;

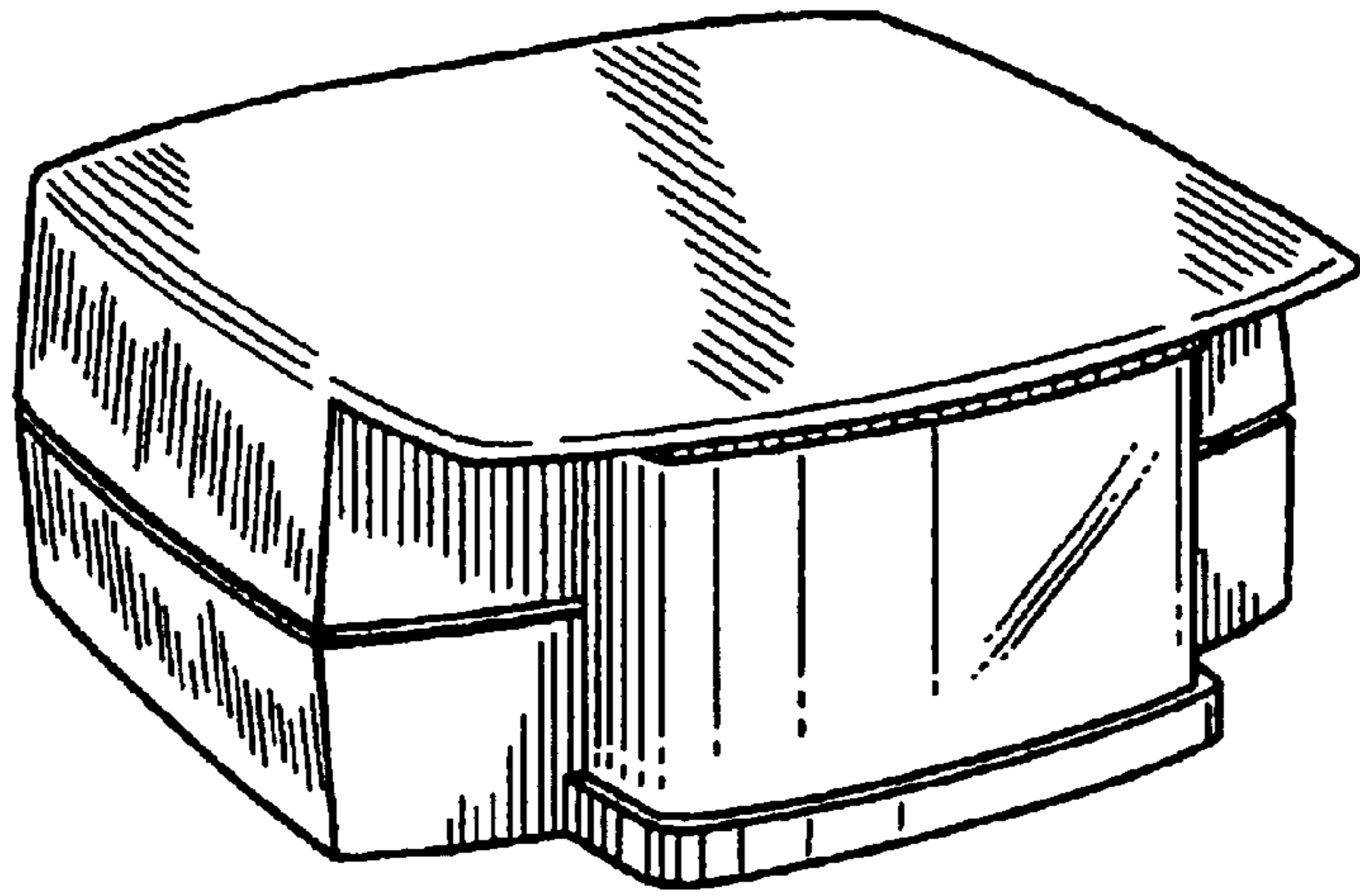

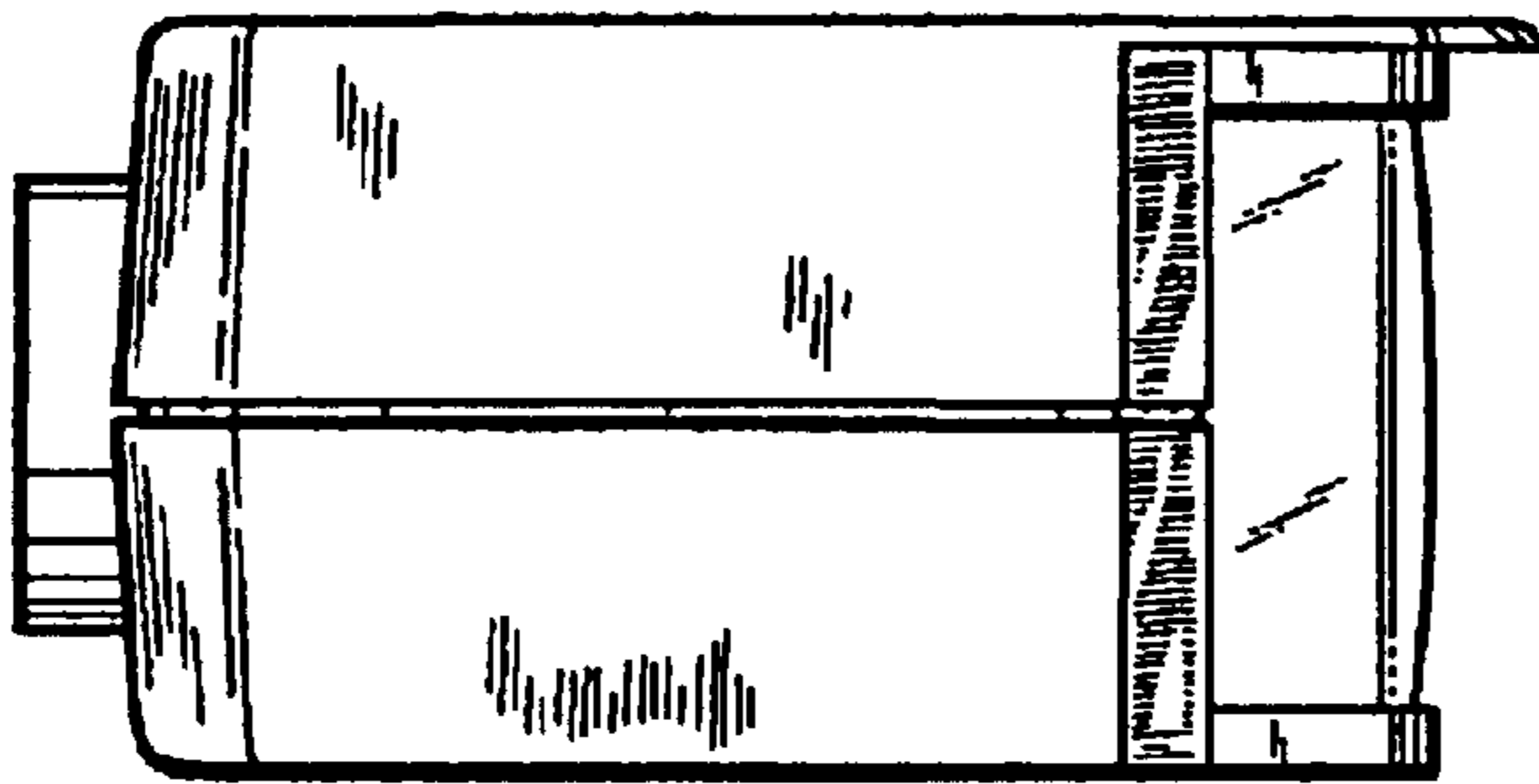

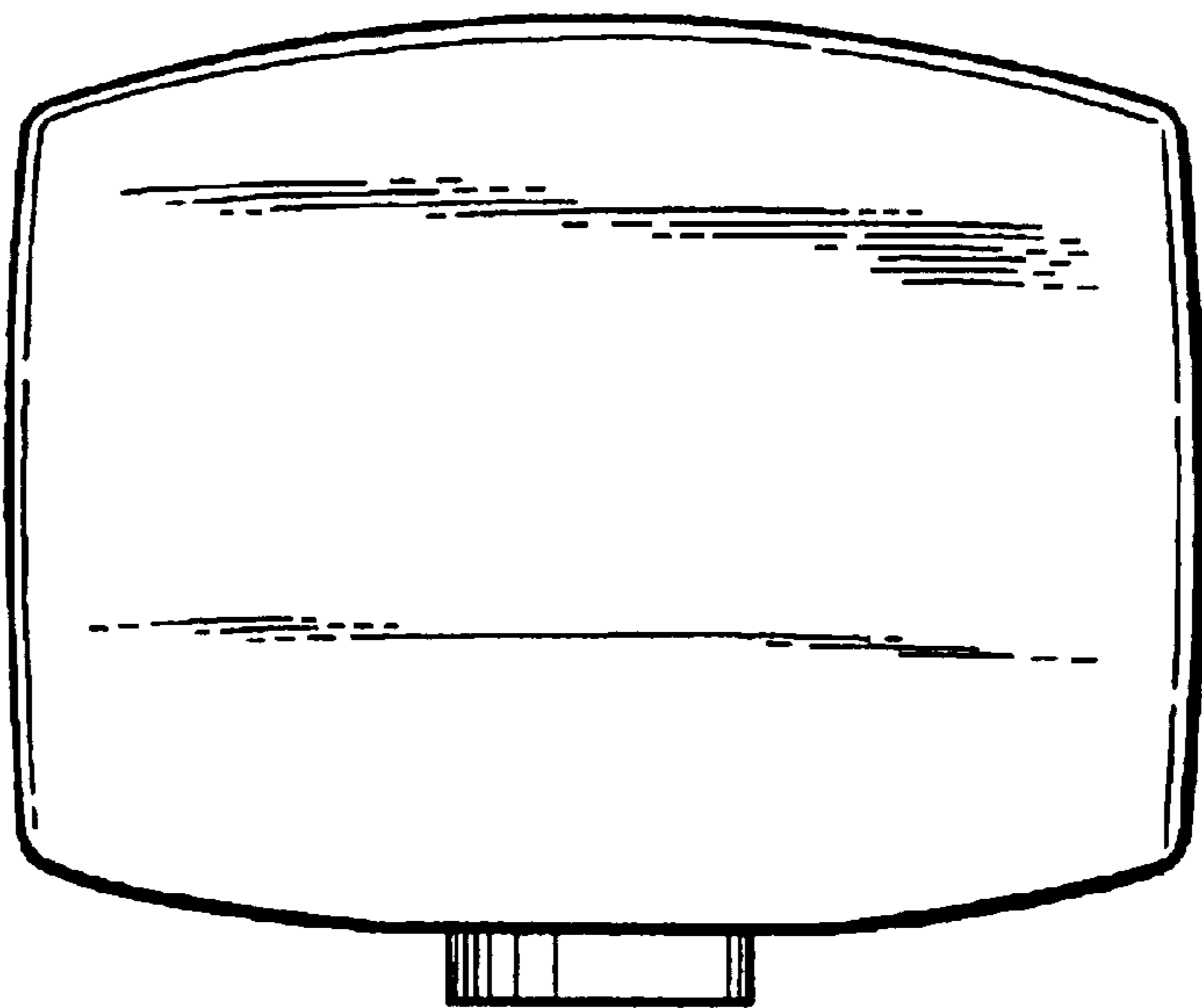

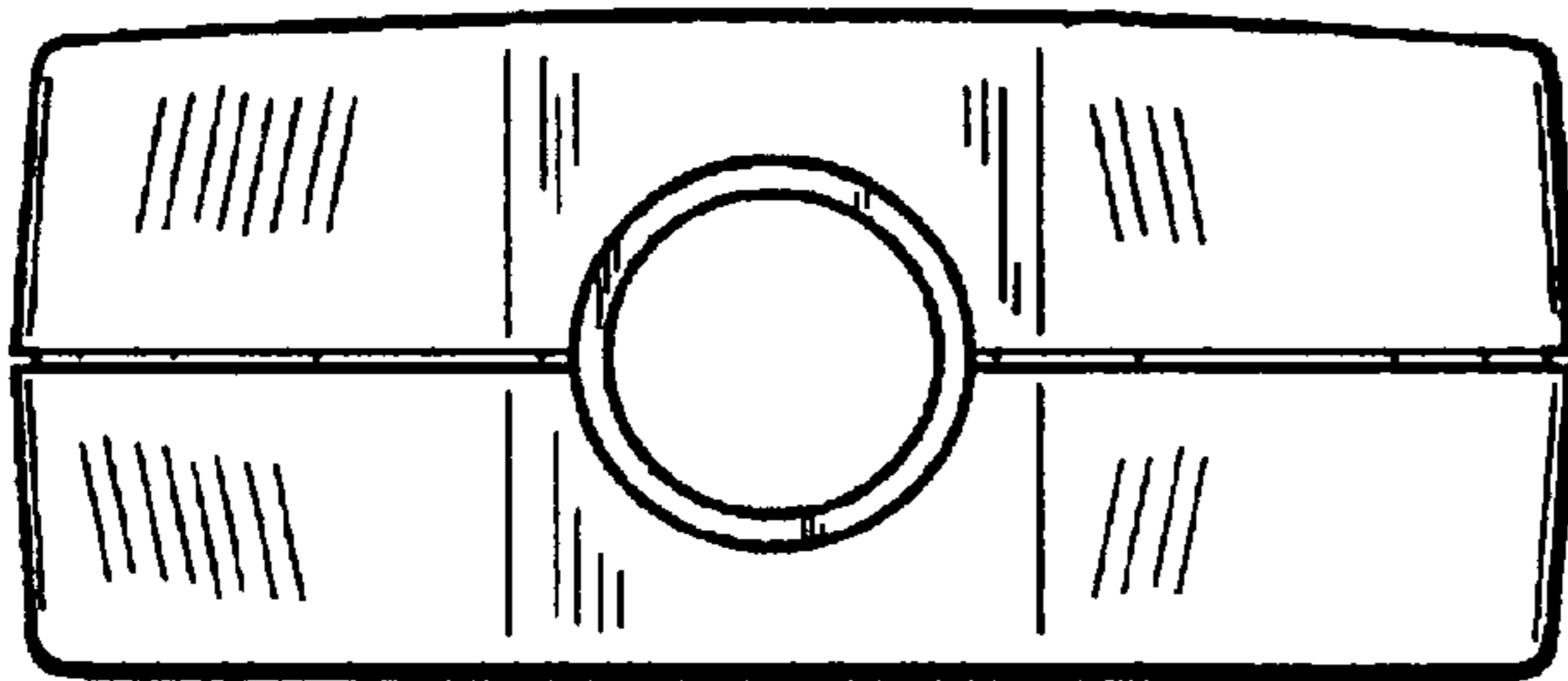
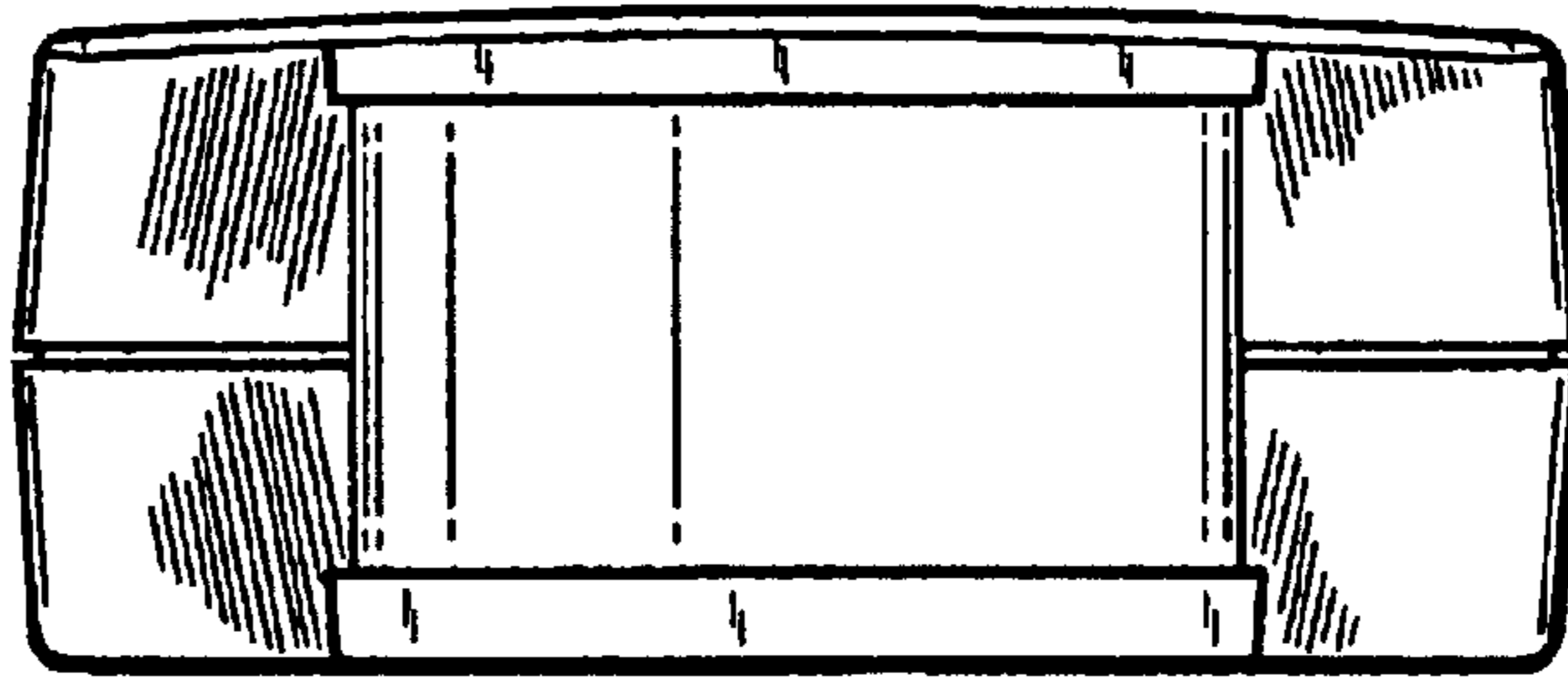
