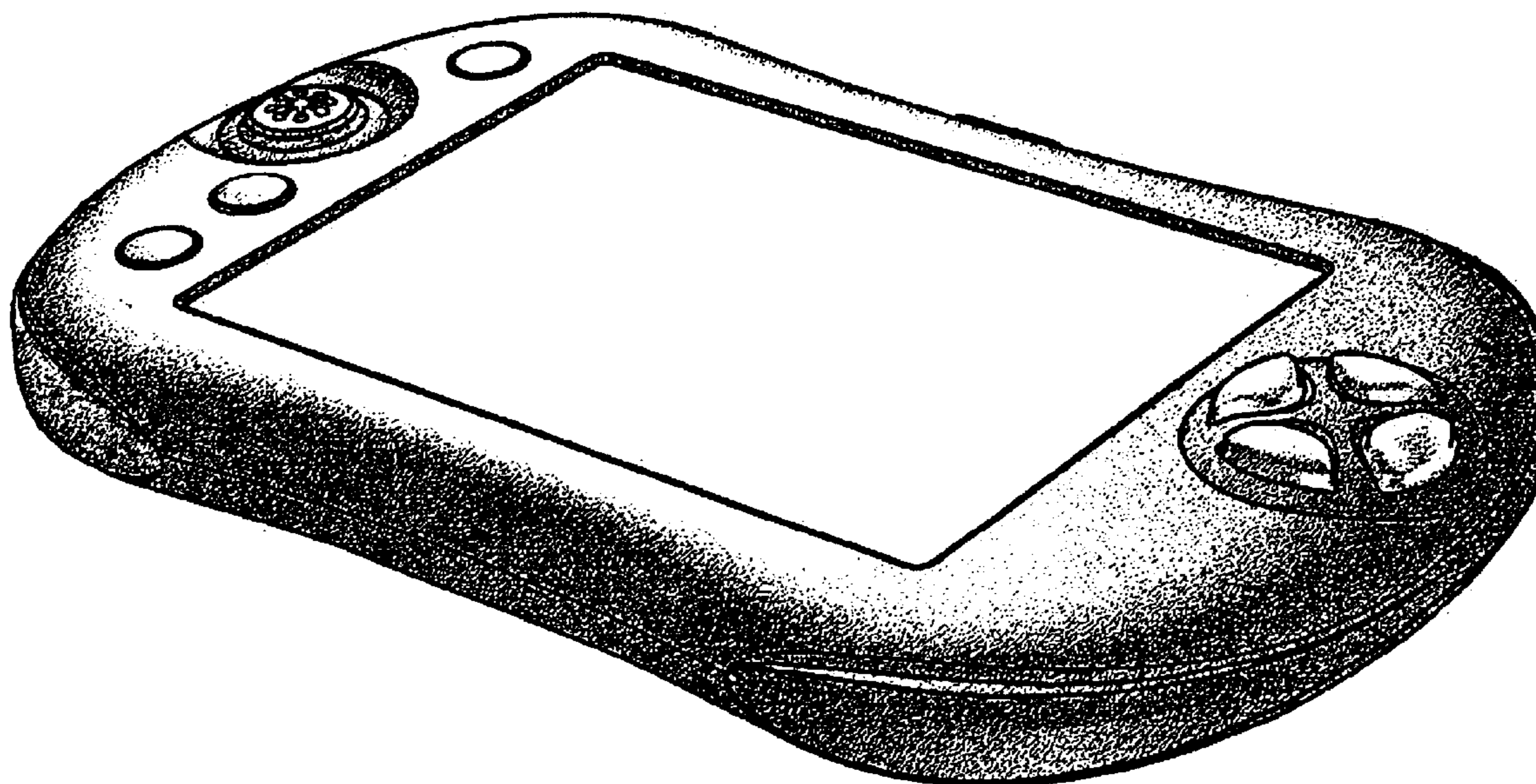
FIG. 1 is a front view of a handheld computing device;

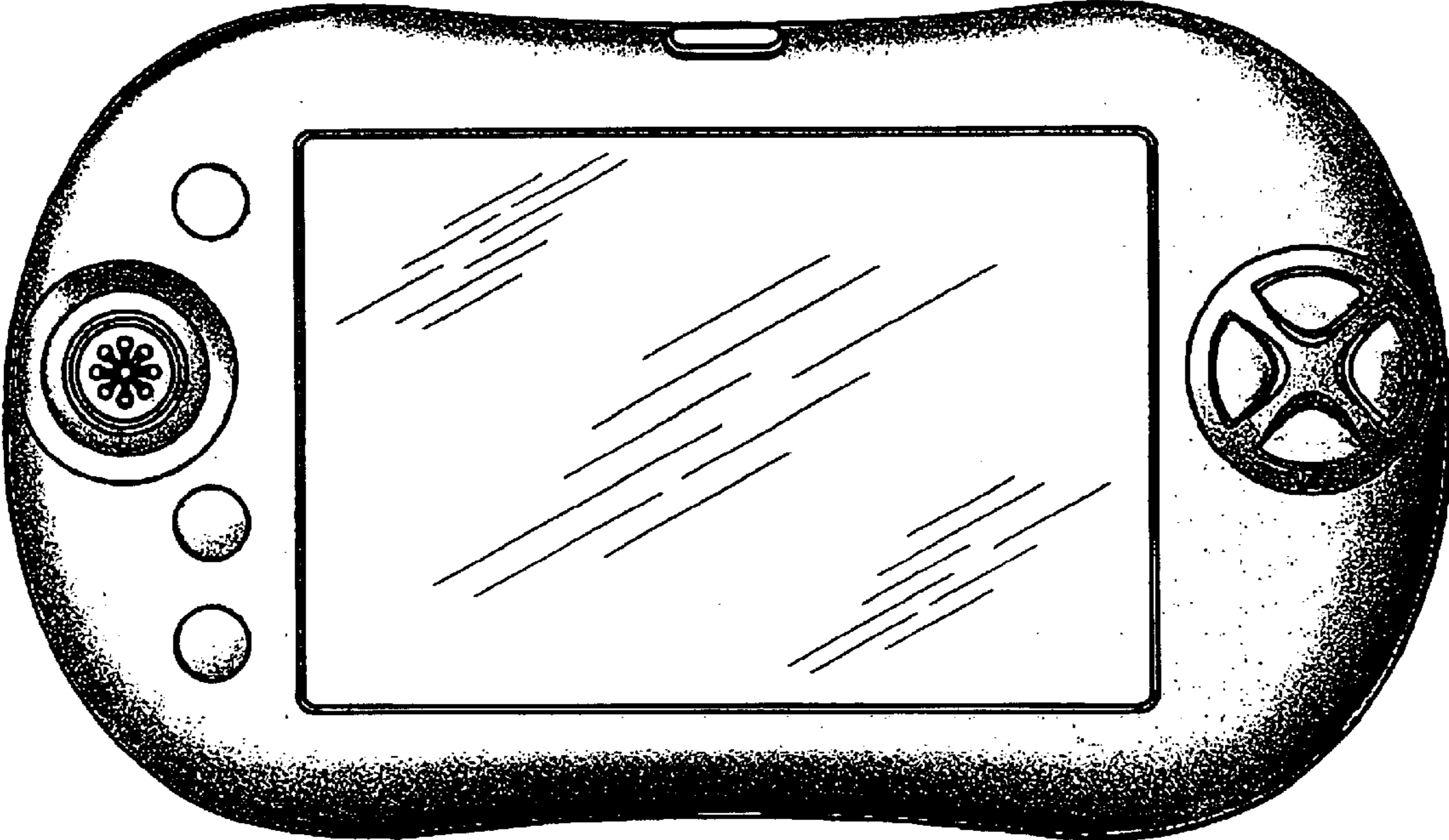

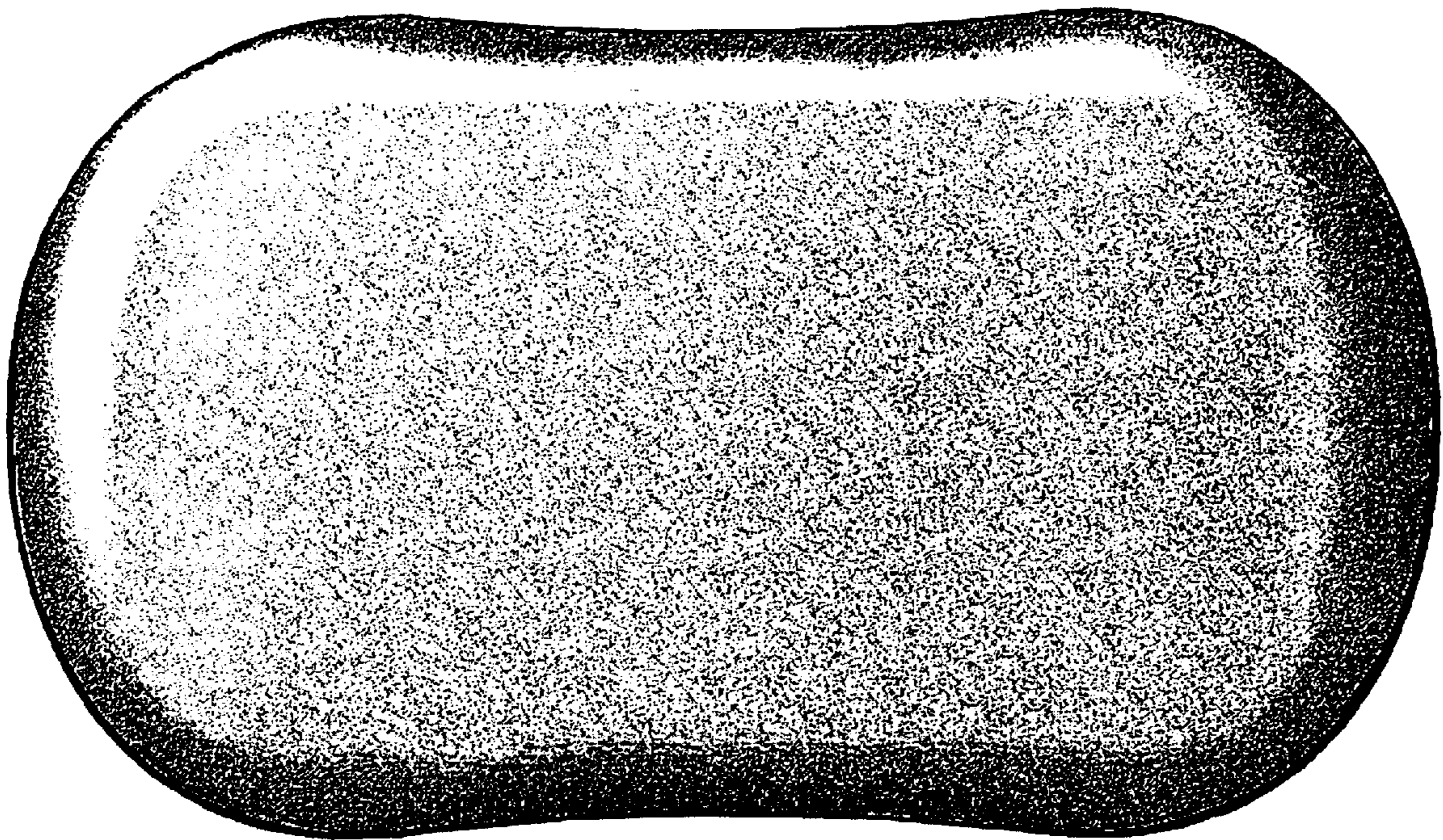

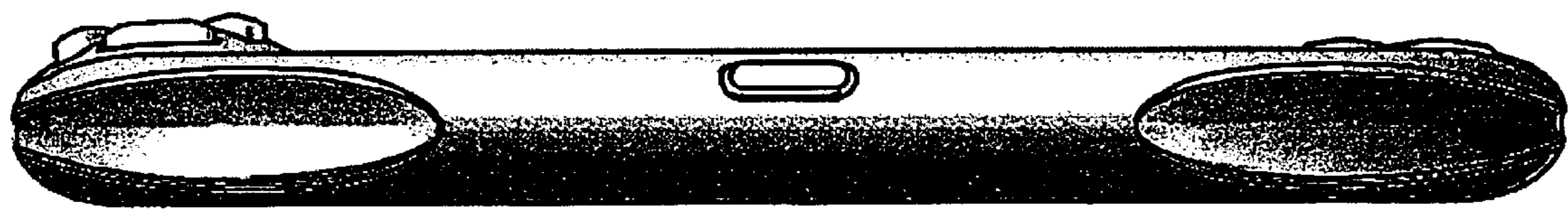

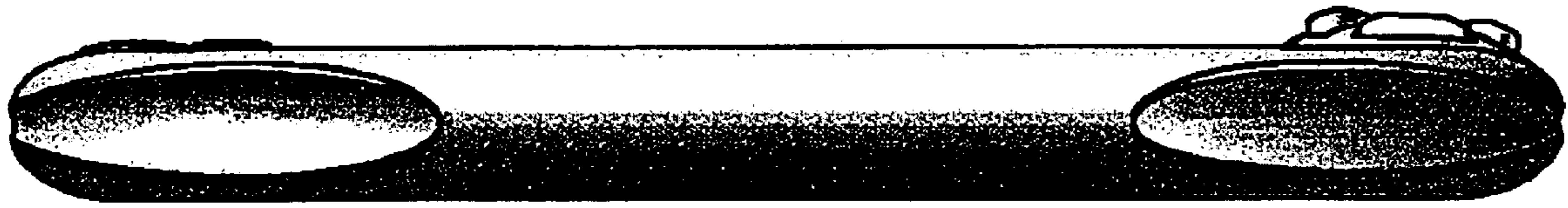

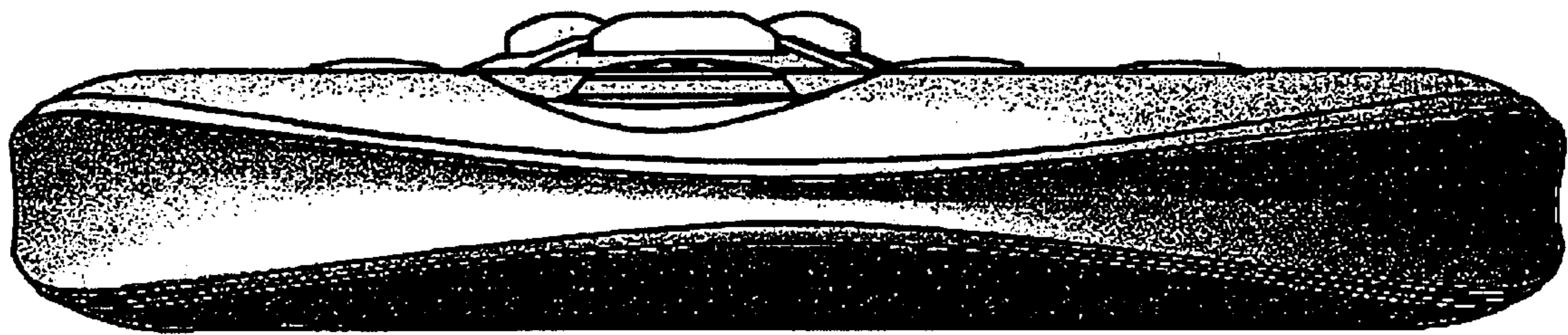

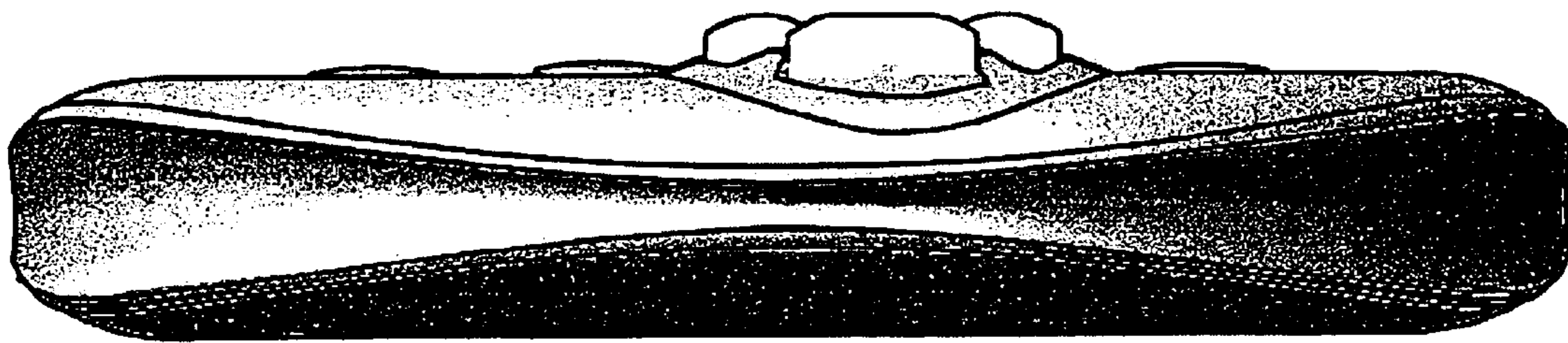

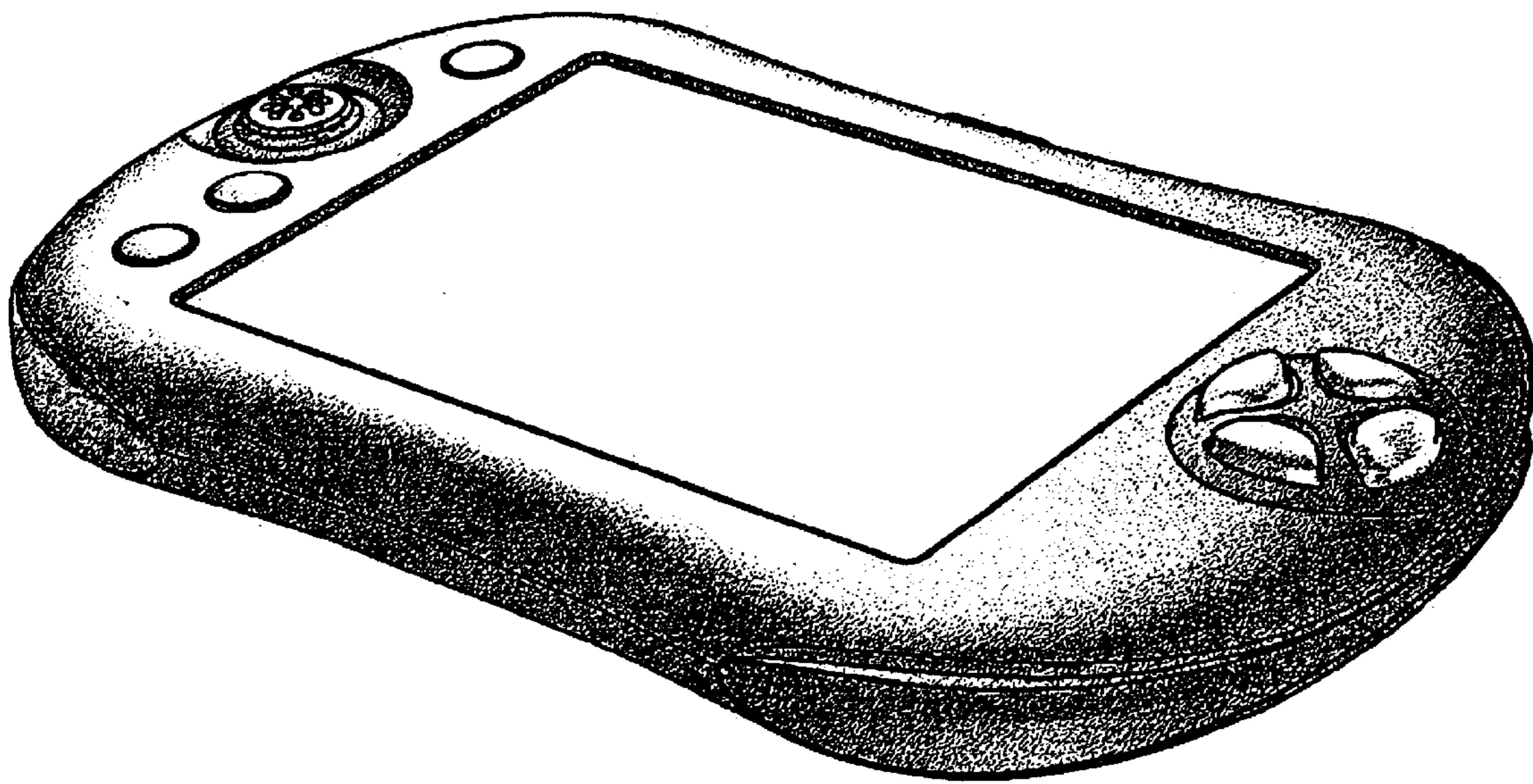
