(57) **CLAIM**

I claim the ornamental design for a window binder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a window binder shown in a partially opened condition and illustrating my new design. The bands on the rim of the binder represent the visual appearance of the texture of the trim material that extends about the rim.

FIG. 2 is a front elevational view thereof shown with the window binder in a closed condition;

FIG. 3 is a top plan view thereof;

FIG. 4 is bottom plan view thereof;

FIG. 5 is a left-side elevational view thereof;

FIG. 6 is a right-side elevational view thereof;

FIG. 7 is a rear elevational view thereof;

FIG. 8 is a plan view thereof showing the outside surfaces of both the front and the back of the window binder in an open condition; and,

FIG. 9 is an opposite plan view thereof showing both the inside of the front and back of the window binder in an open condition.

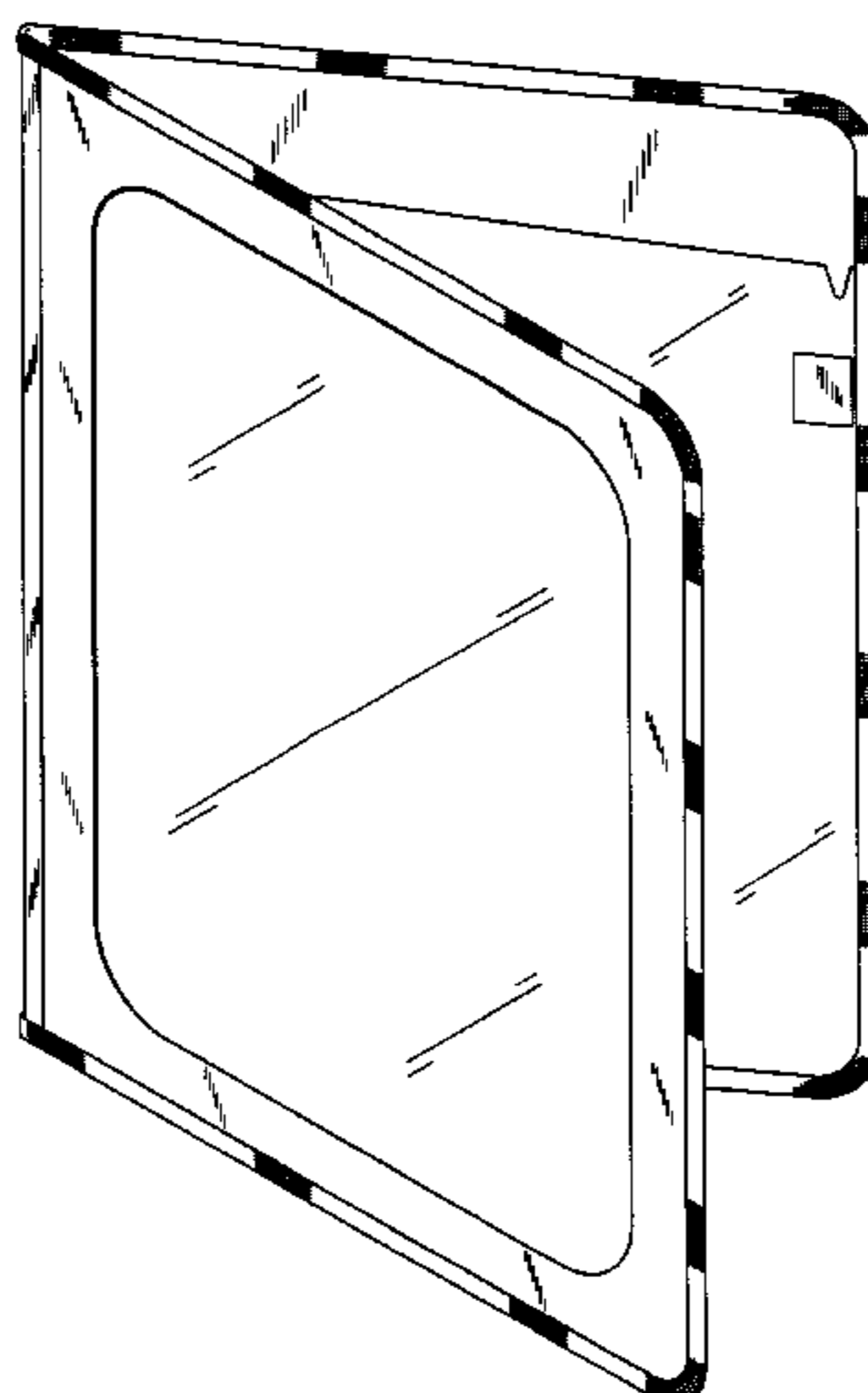

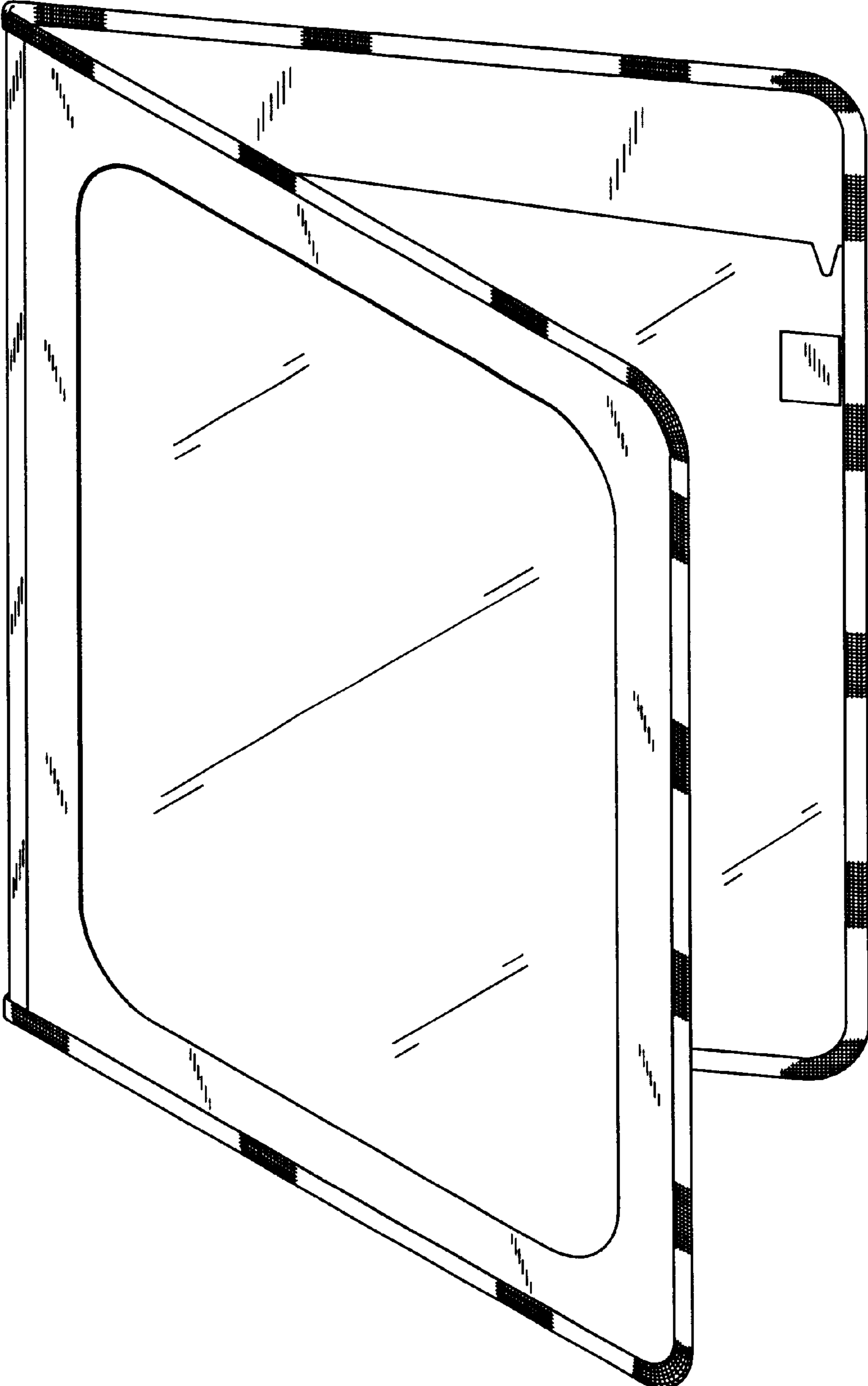

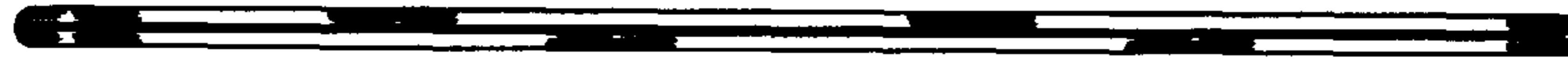

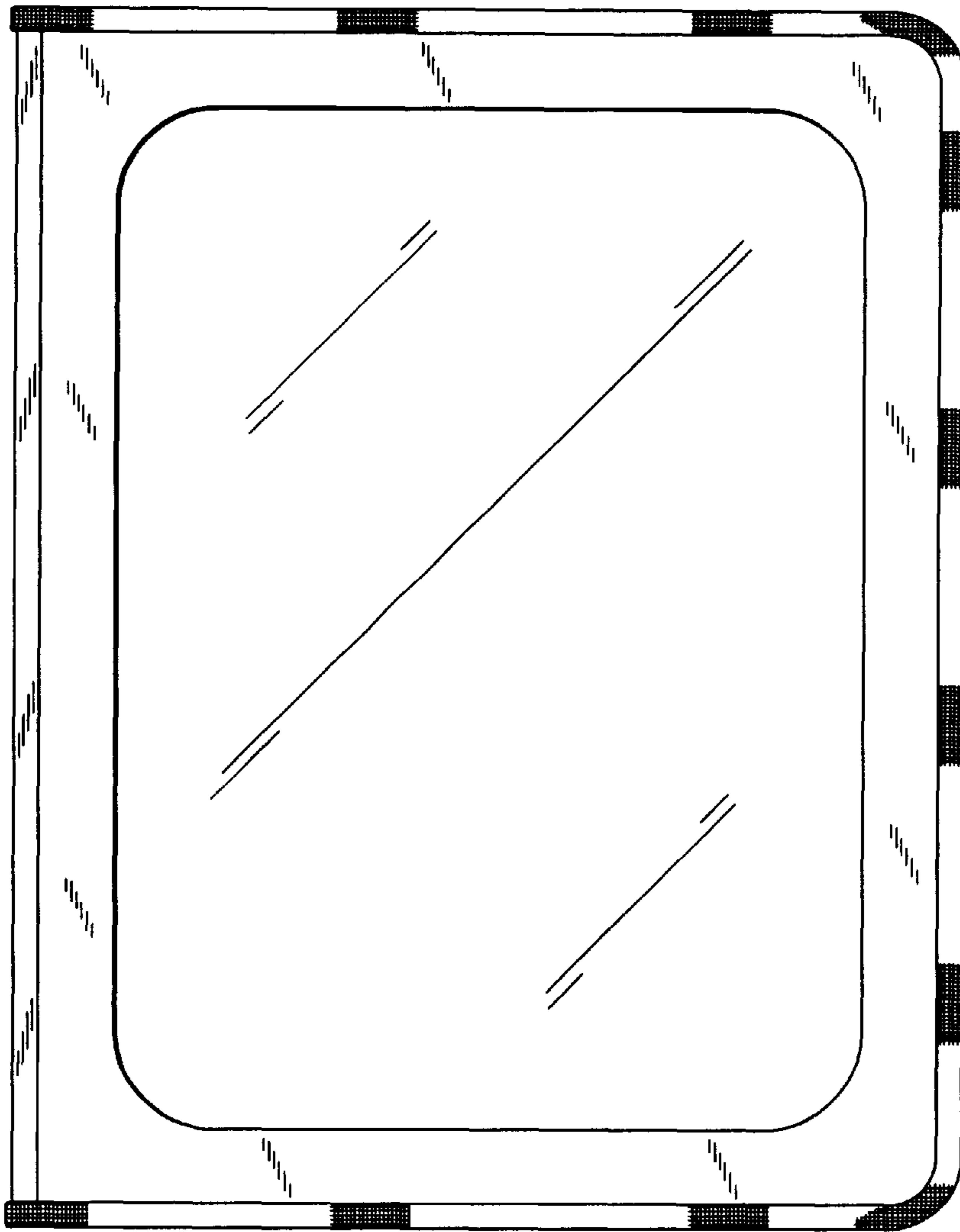

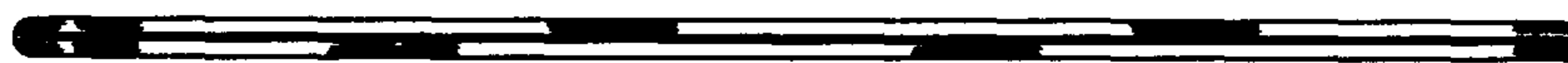

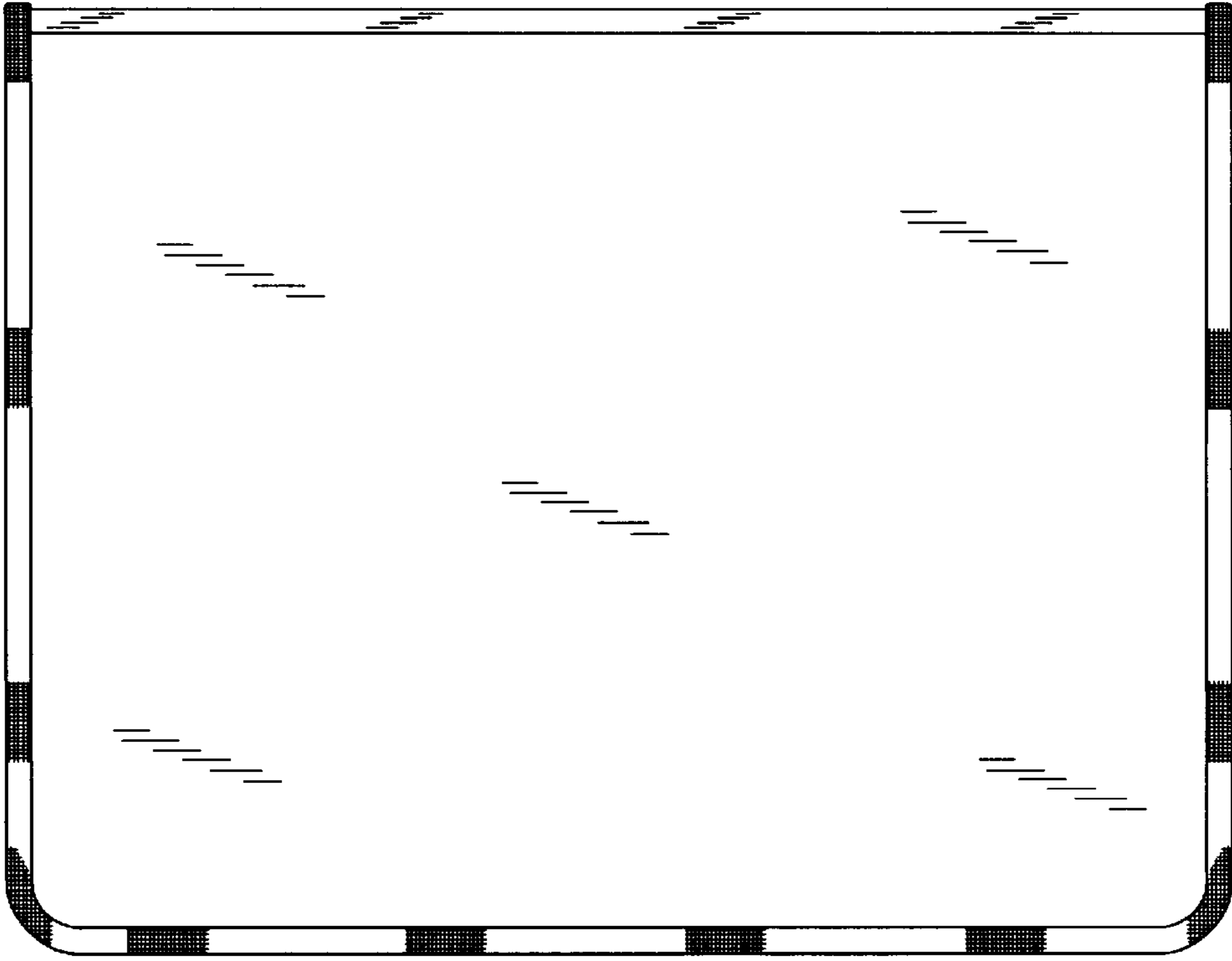

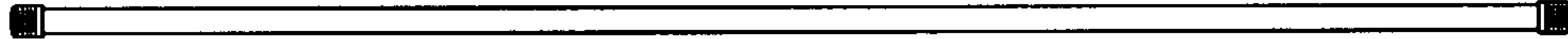

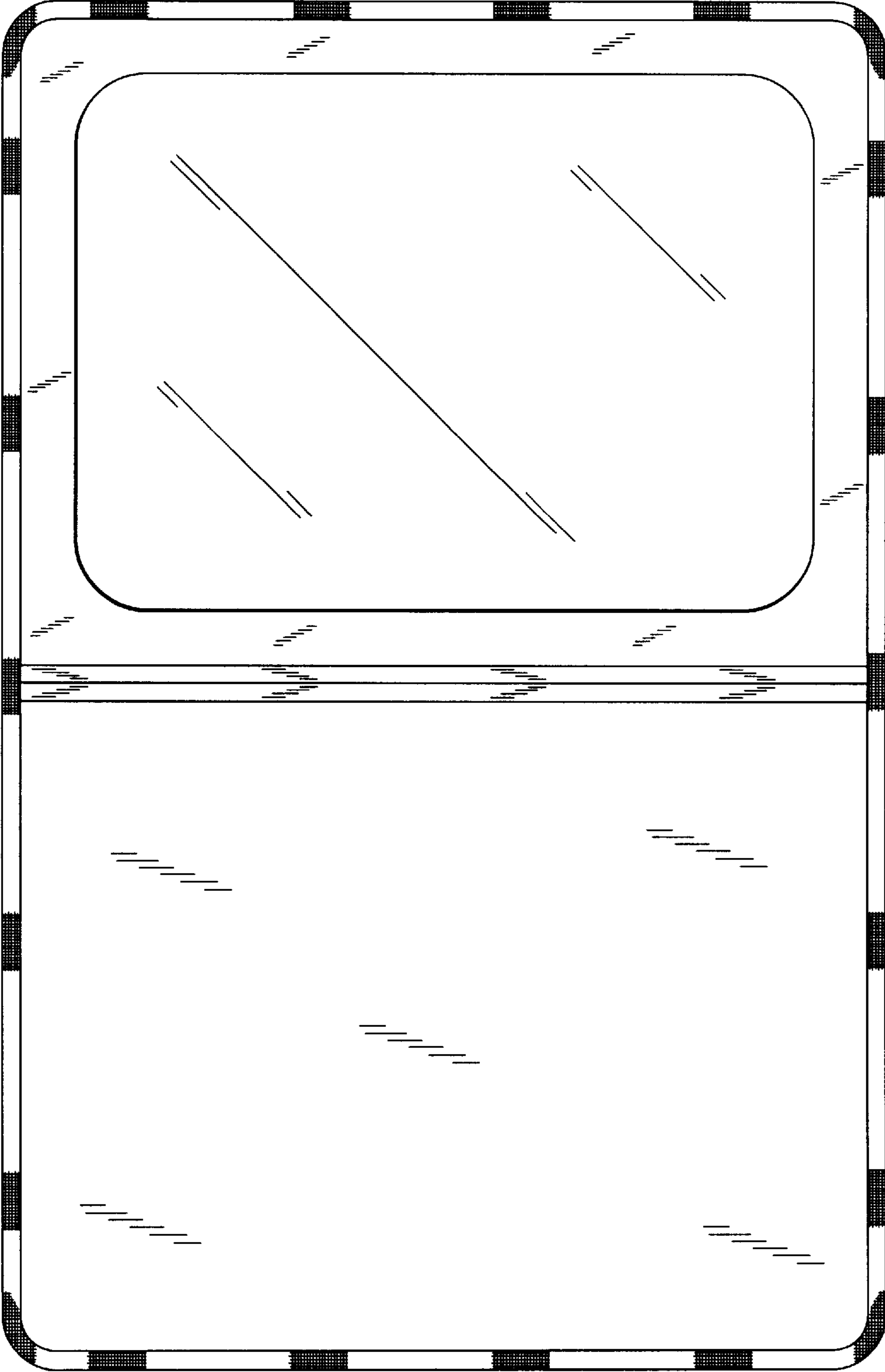
