(57) **CLAIM**

The ornamental design for a promotional assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a promotional assembly of the present invention wherein the promotional assembly of this embodiment includes an advertising portion and a coupon card portion;

FIG. 2 is a front view of the promotional assembly of FIG. 1;

FIG. 3 is a rear view of the promotional assembly of FIG. 1 showing a number of coupons in phantom;

FIG. 4 is a right side elevational view of the promotional assembly of FIG. 2;

FIG. 5 is a left side elevational view of the promotional assembly of FIG. 2;

FIG. 6 is a bottom side elevational view of the promotional assembly of FIG. 2;

FIG. 7 is a top side elevational view of the promotional assembly of FIG. 2;

FIG. 8 is a perspective view of a second embodiment of the promotional assembly of the present invention wherein the promotional assembly of this embodiment also includes an advertising portion and a coupon card portion;

FIG. 9 is a front view of the promotional assembly of FIG. 8;

FIG. 10 is a rear view of the promotional assembly of FIG. 8 showing a number of coupons in phantom;

FIG. 11 is a right side elevational view of the promotional assembly of FIG. 9;

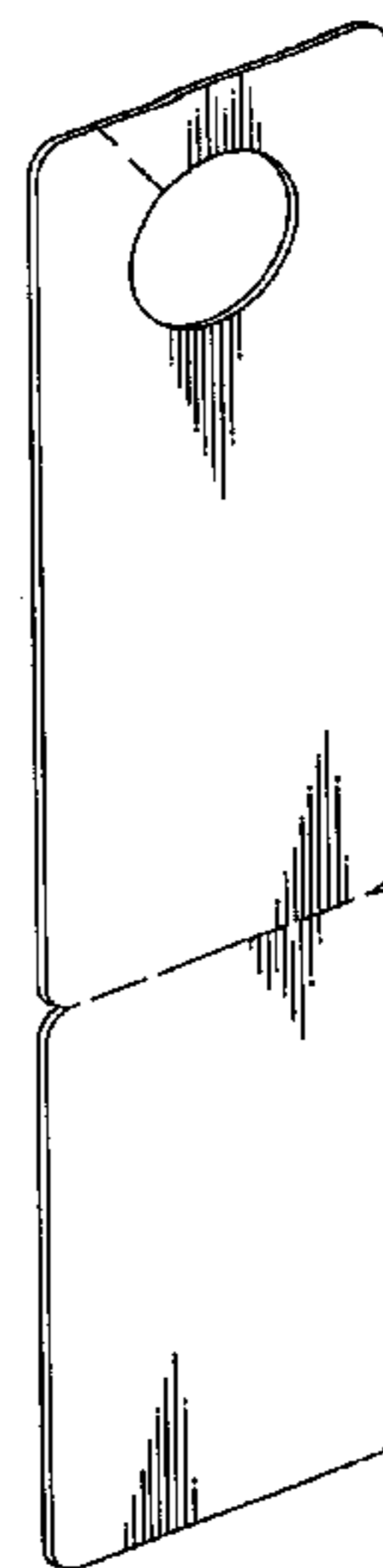
FIG. 12 is a left side elevational view of the promotional assembly of FIG. 9;

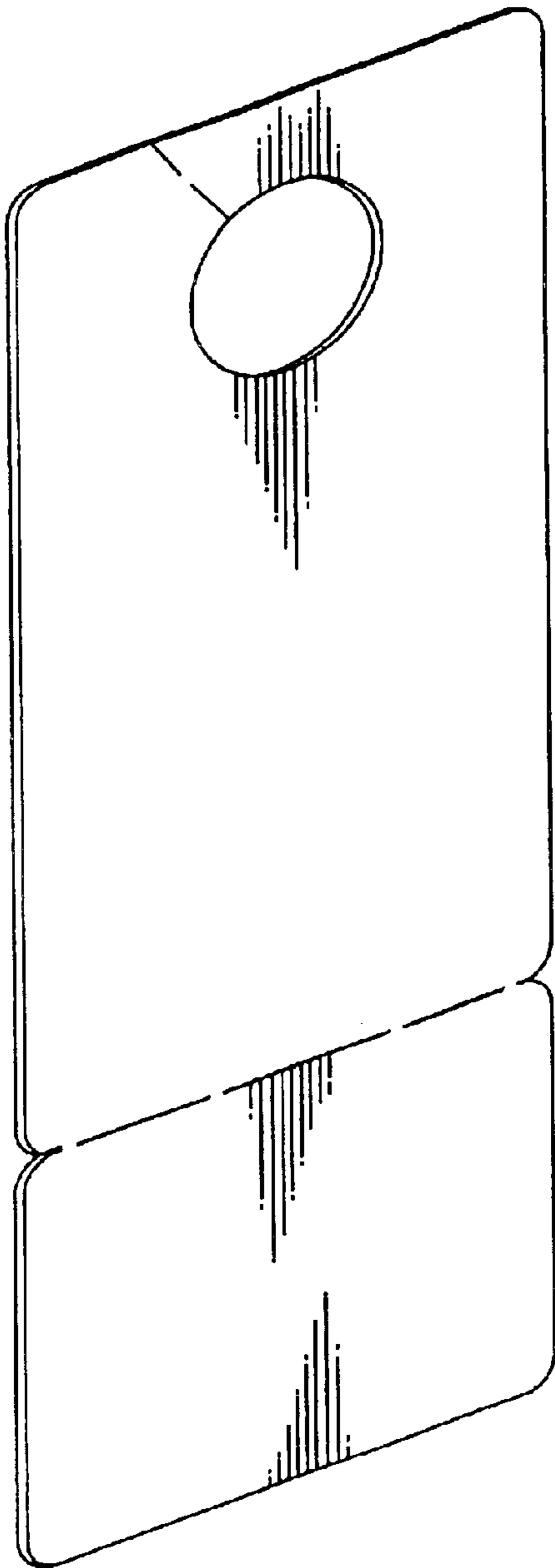

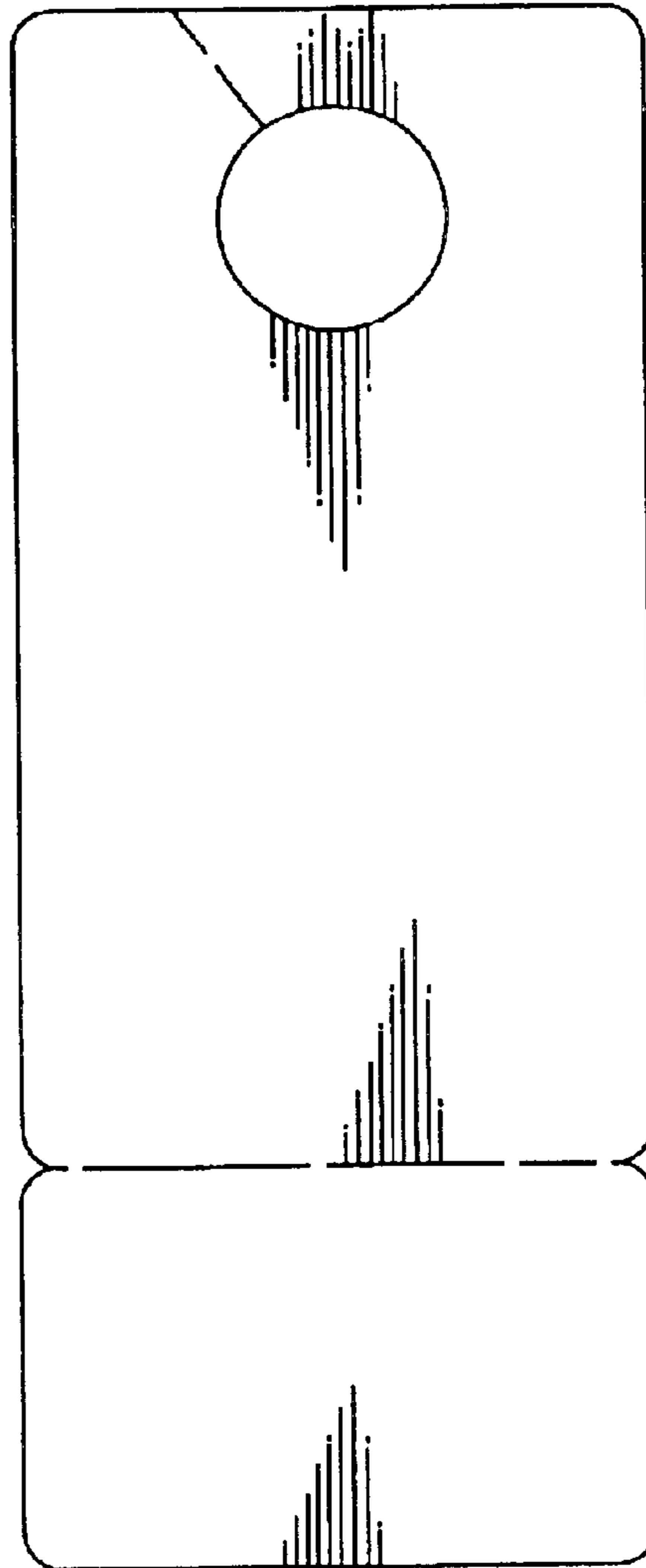

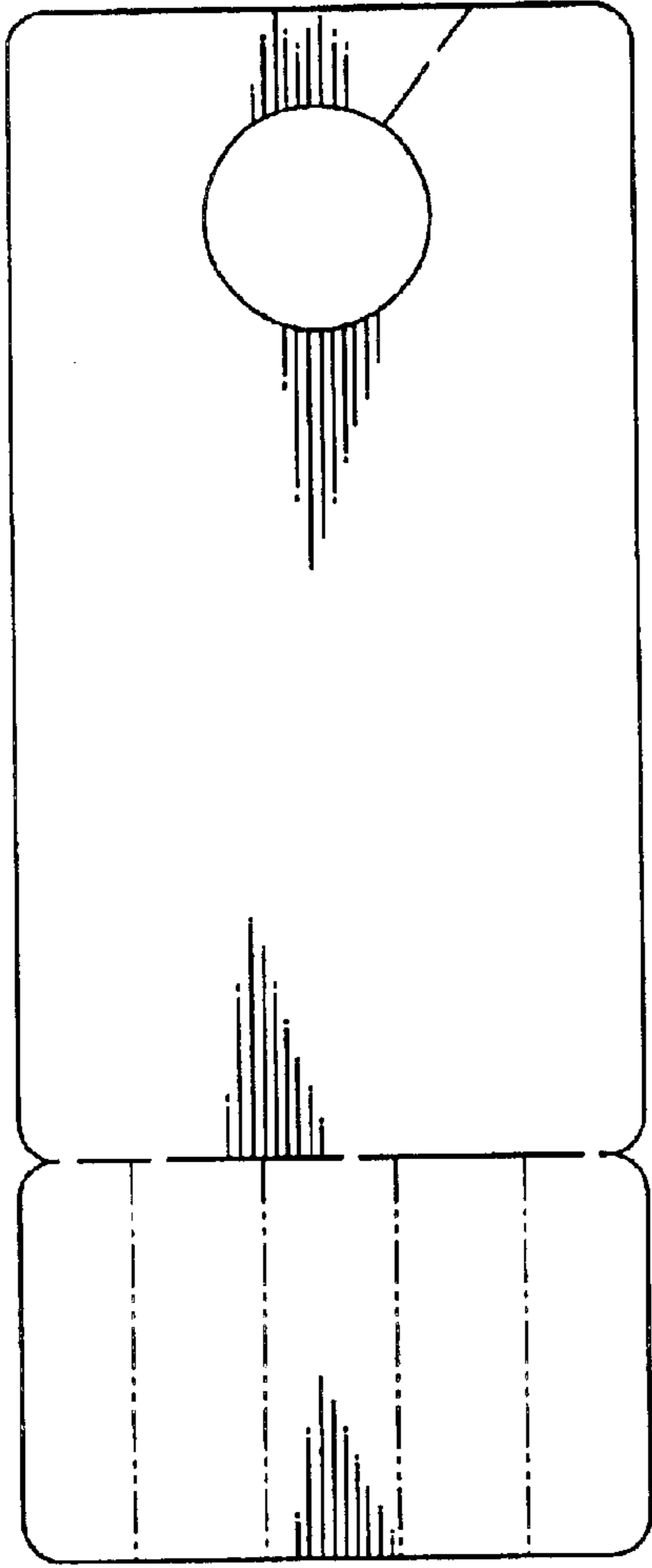

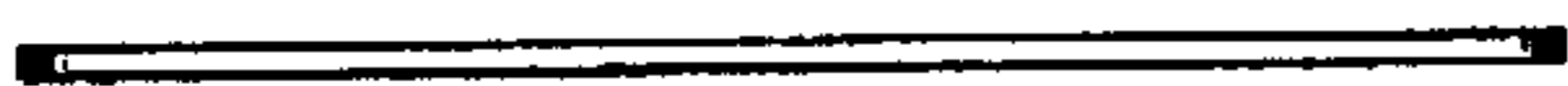

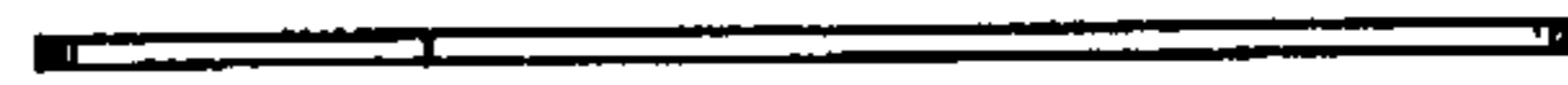
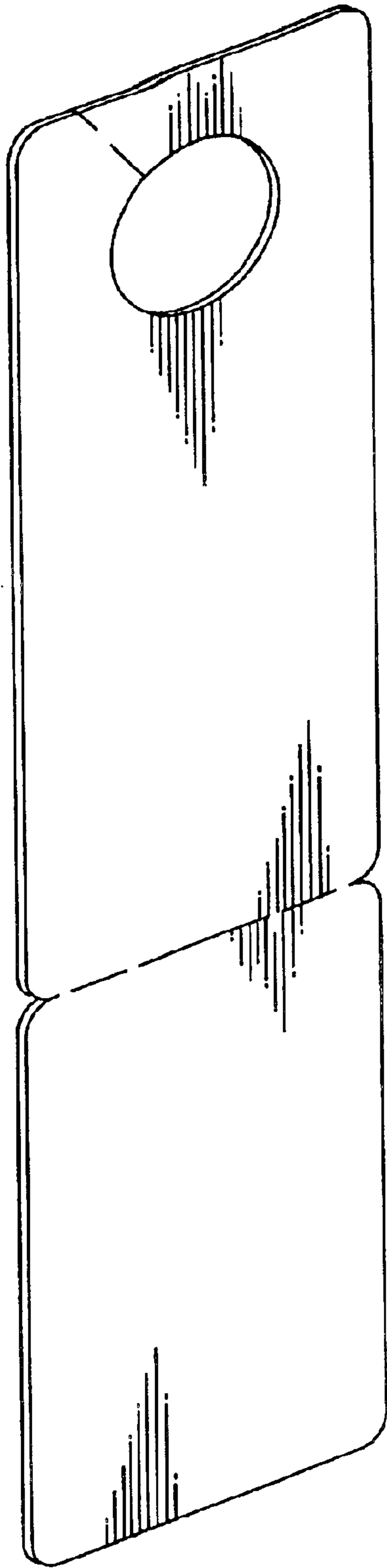
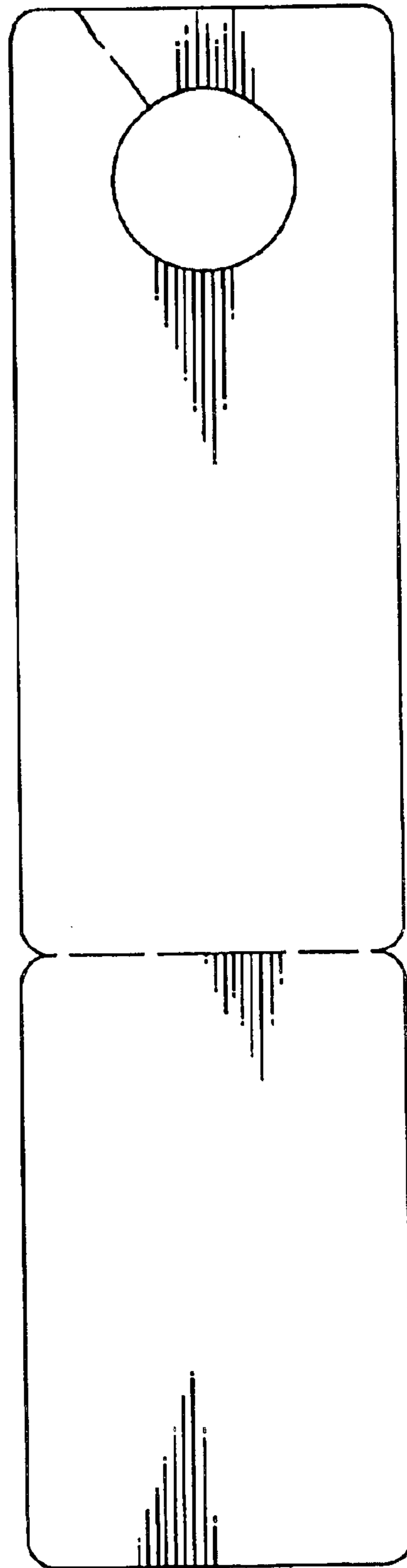

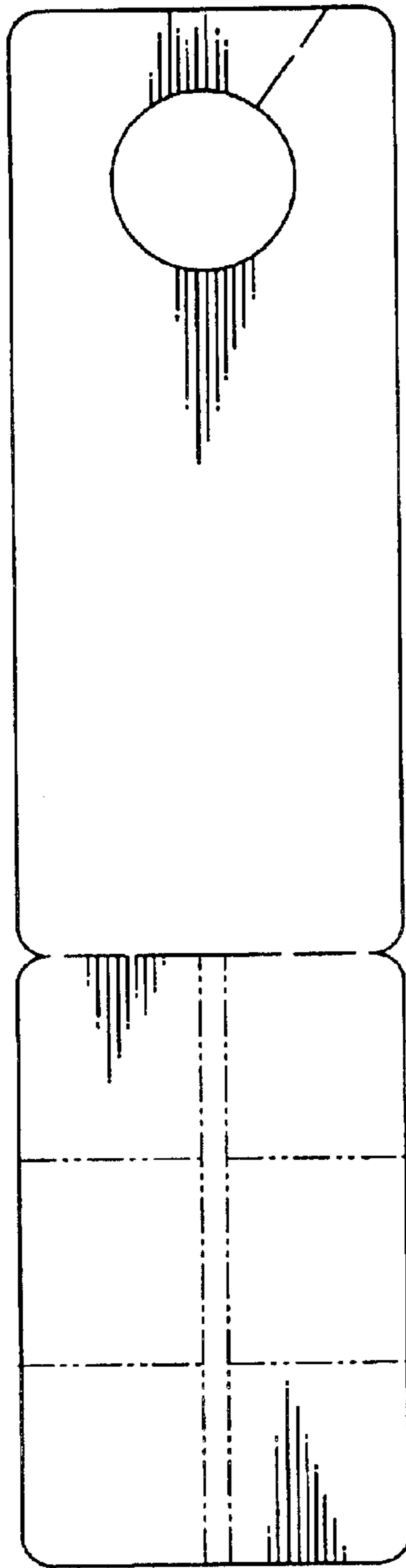

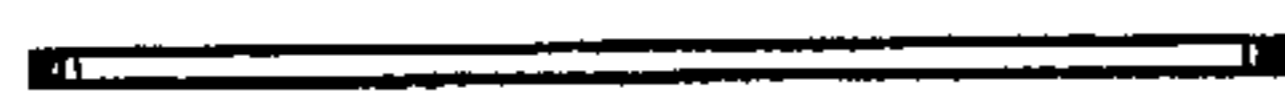

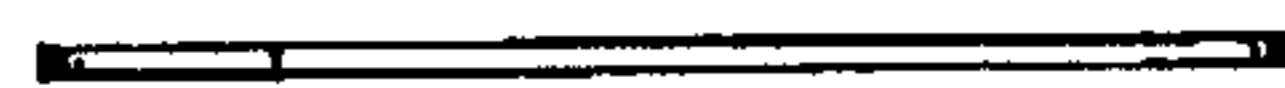
