The ornamental design for a lamp canopy, as shown.

DESCRIPTION

FIG. 1 is a top plan view of a lamp canopy according to the present design;

FIG. 2 is a front elevational view of the lamp canopy of FIG. 1;

FIG. 3 is a side elevational view of the lamp canopy of FIG. 1;

FIG. 4 is a top plan view of a lamp canopy according to a first variant of the present design;

FIG. 5 is a front elevational view of the lamp canopy of FIG. 4;

FIG. 6 is a side elevational view of the lamp canopy of FIG. 4;

FIG. 7 is a top plan view of a lamp canopy according to a second variant of the present design;

FIG. 14 is a front elevational view of the lamp canopy of FIG. 13;

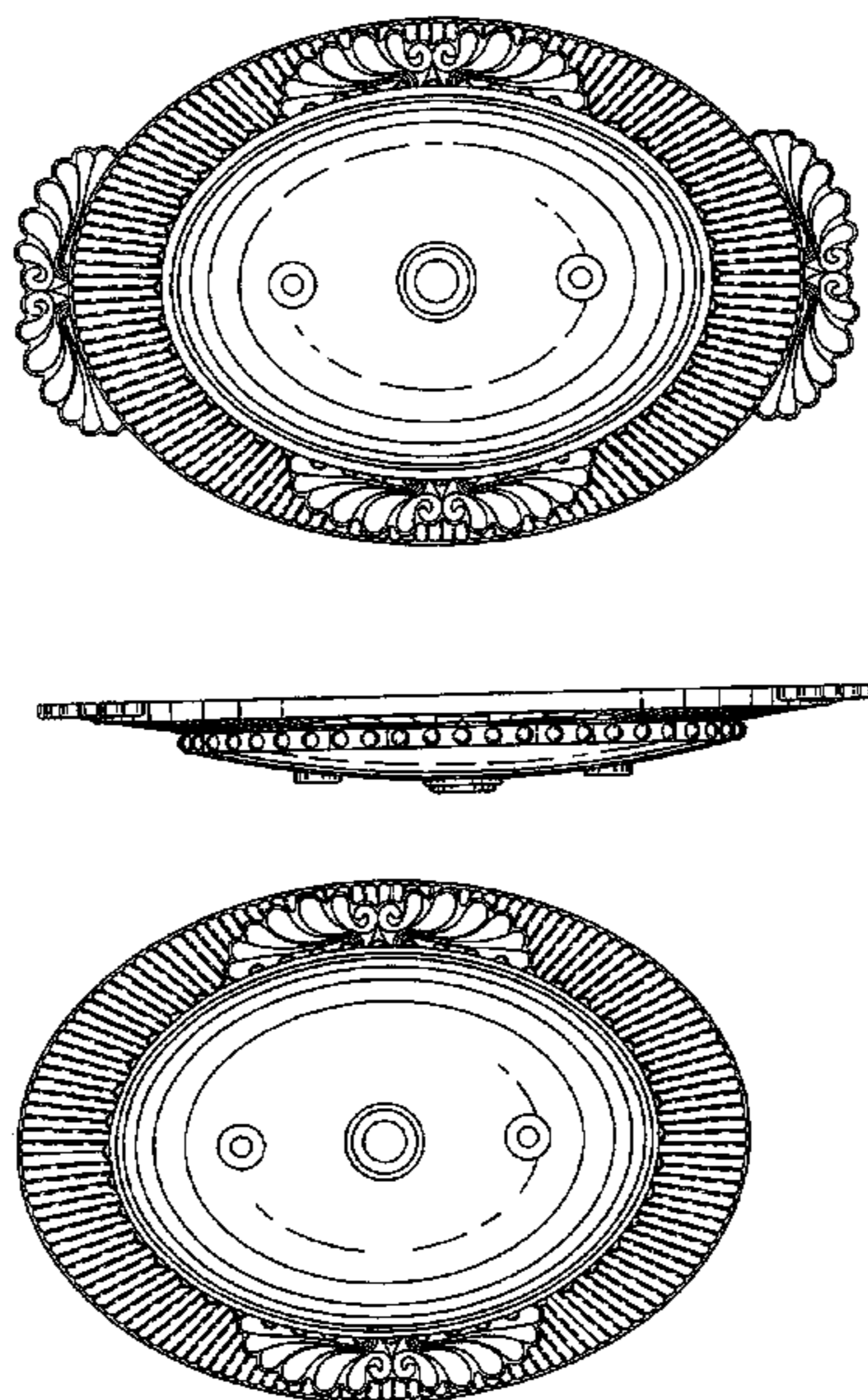
FIG. 15 is a side elevational view of the lamp canopy of FIG. 13;

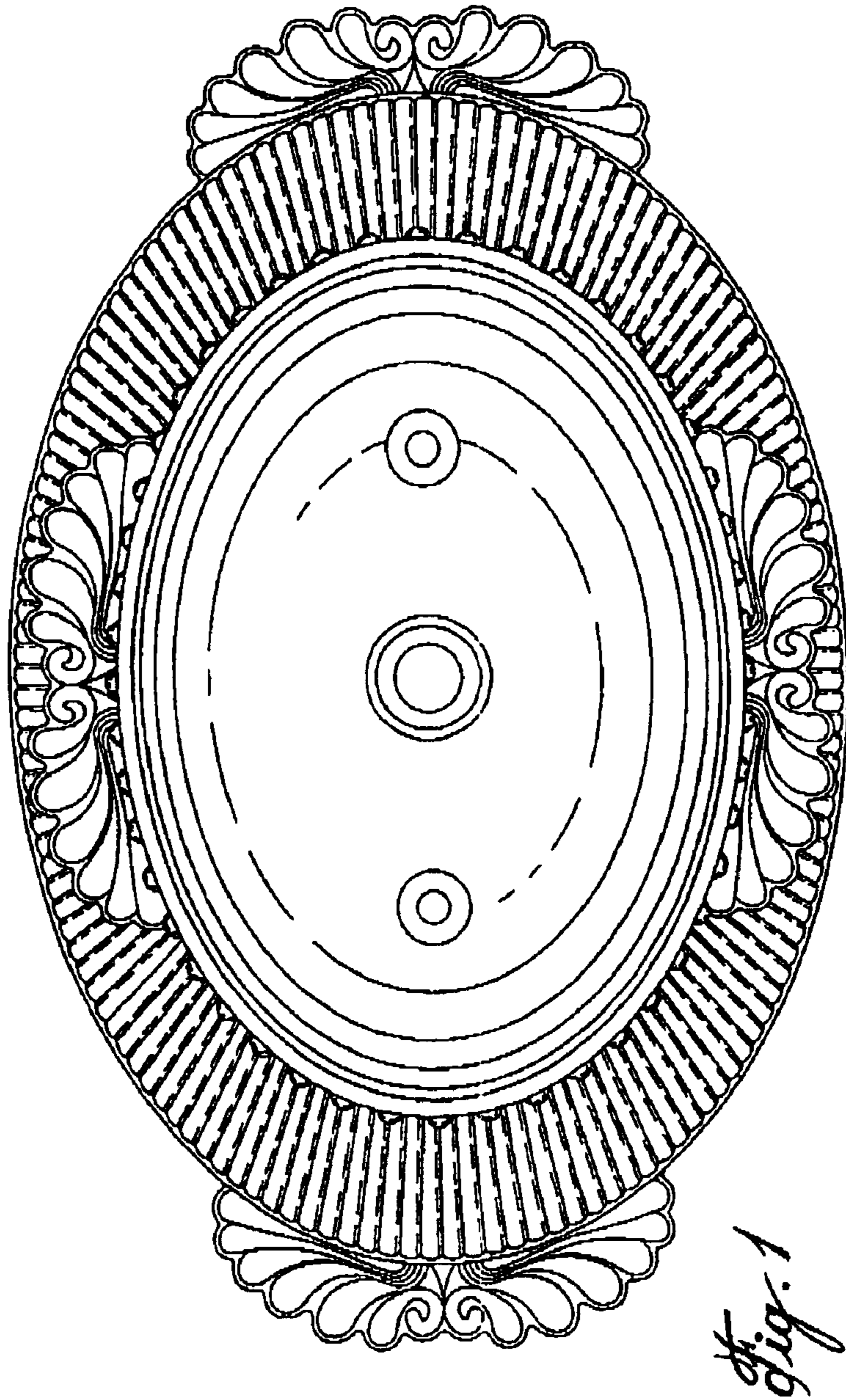
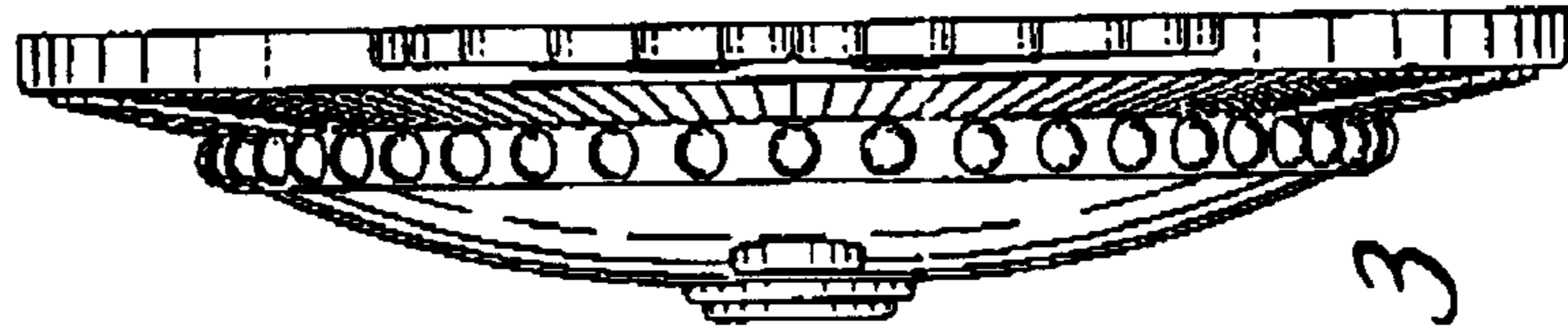
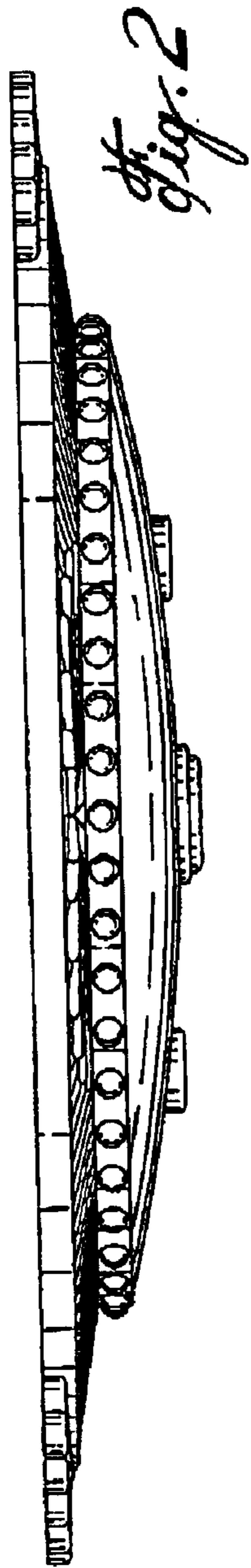
FIG. 16 is a top plan view of a lamp canopy according to a fifth variant of the present design;

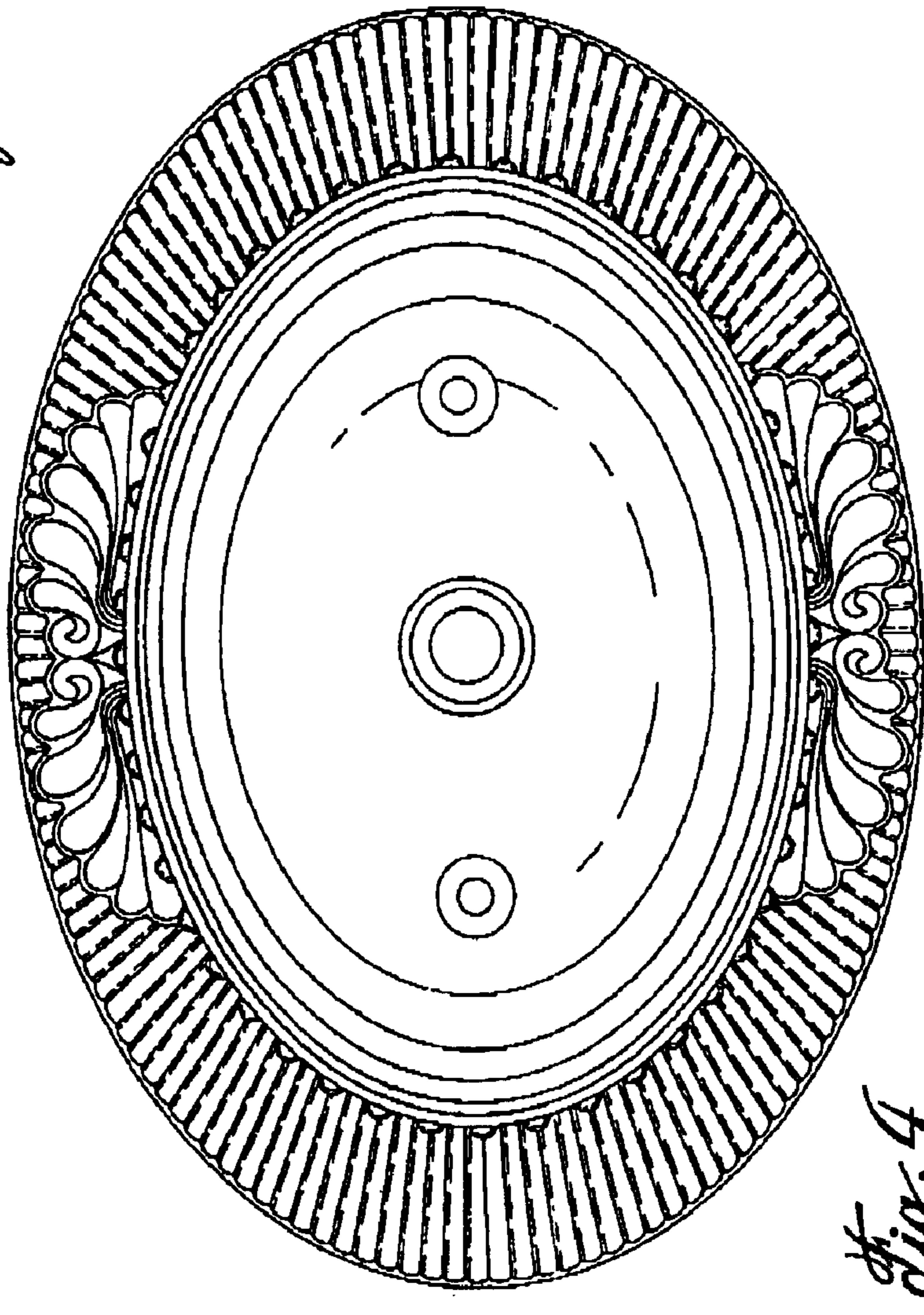
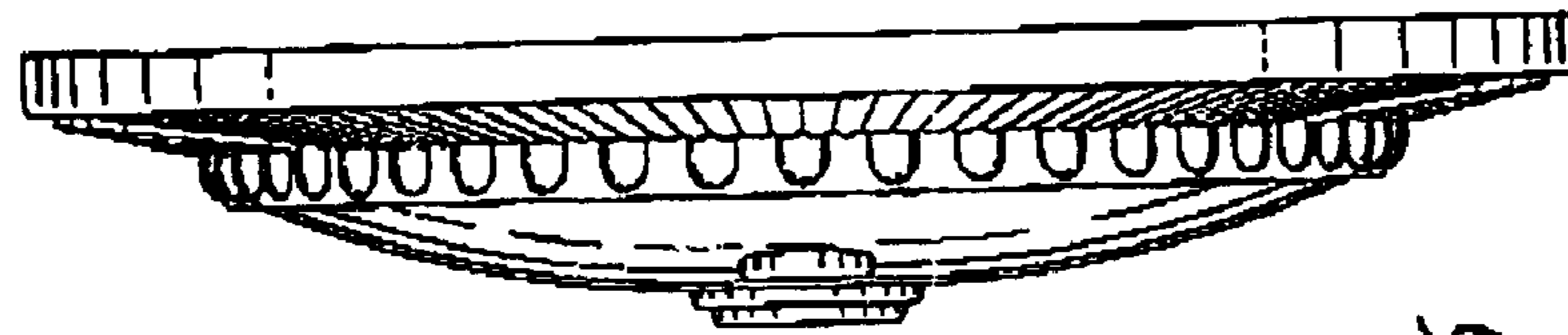
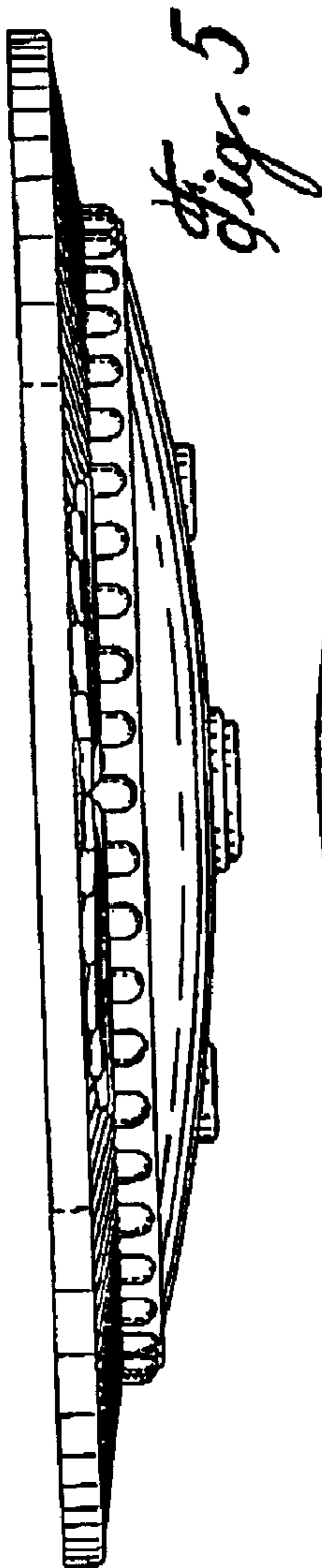
FIG. 17 is a front elevational view of the lamp canopy of FIG. 16; and,

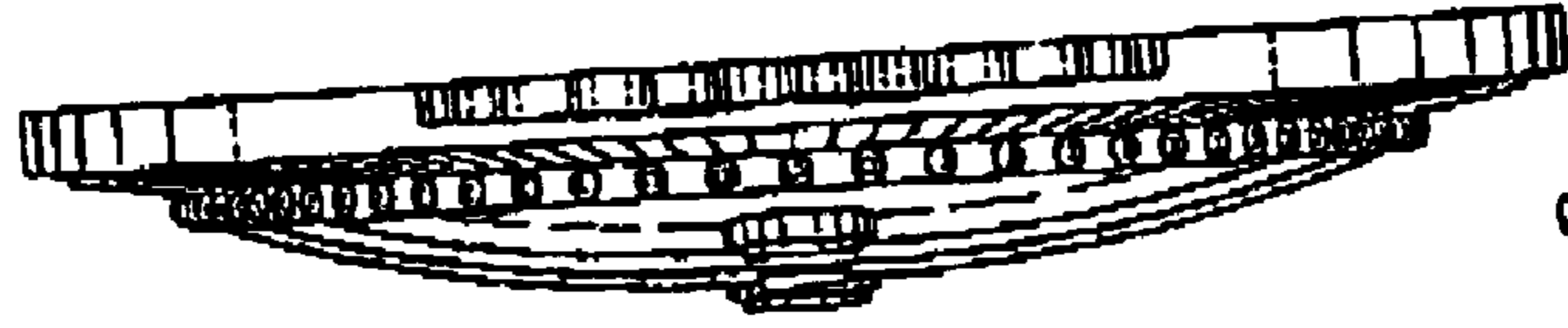

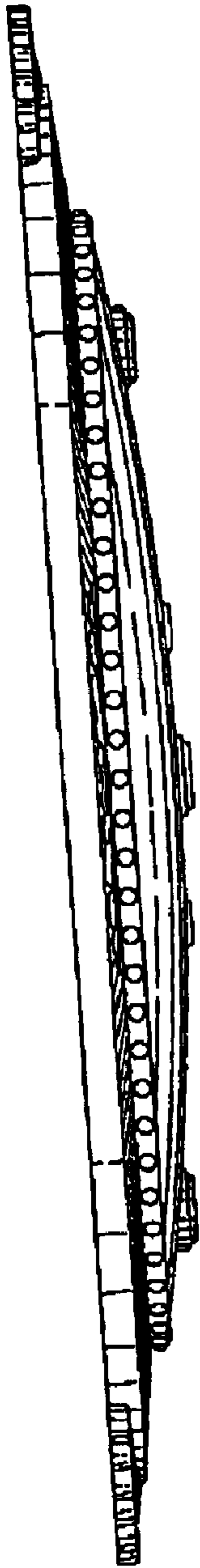

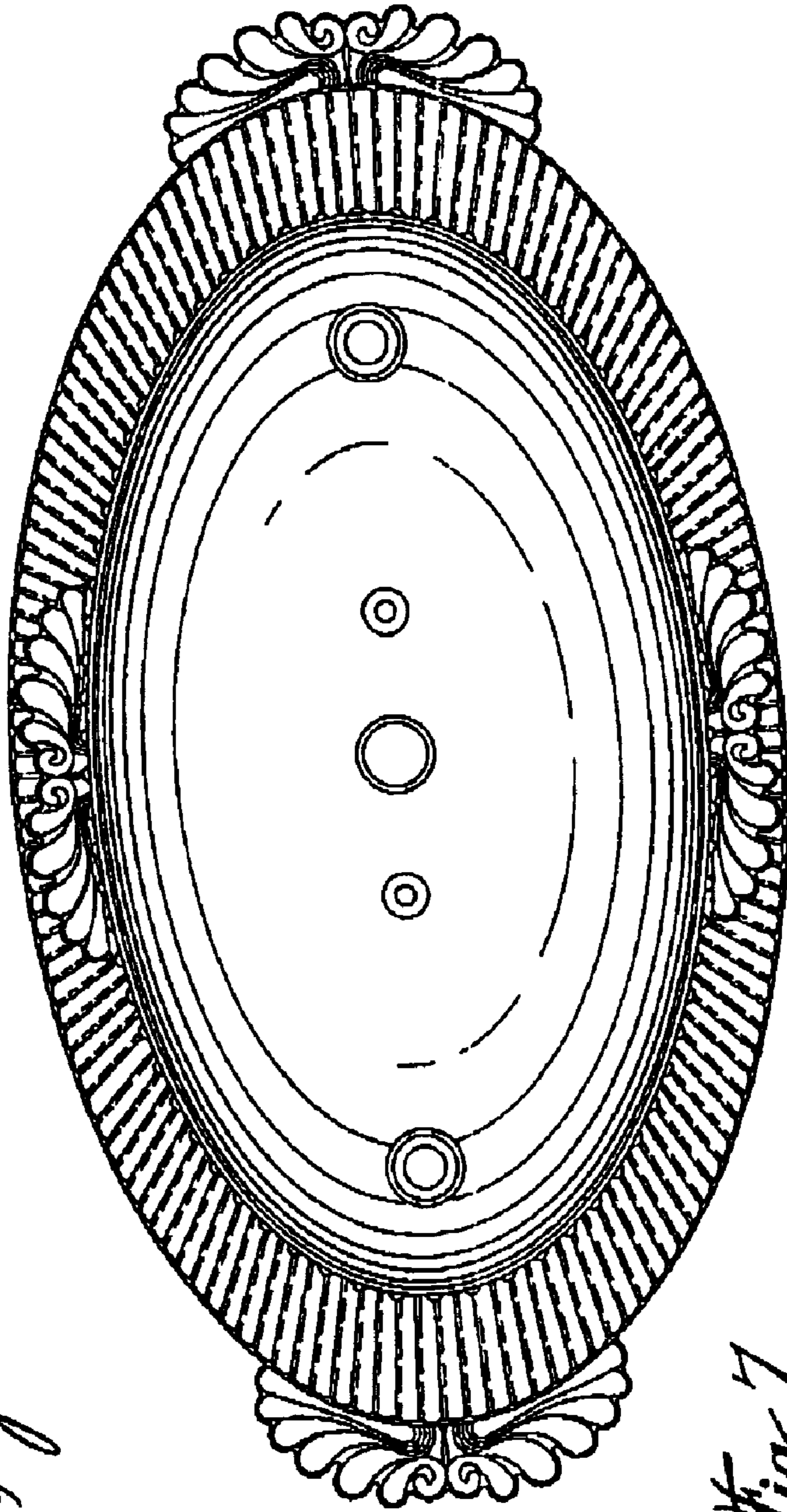

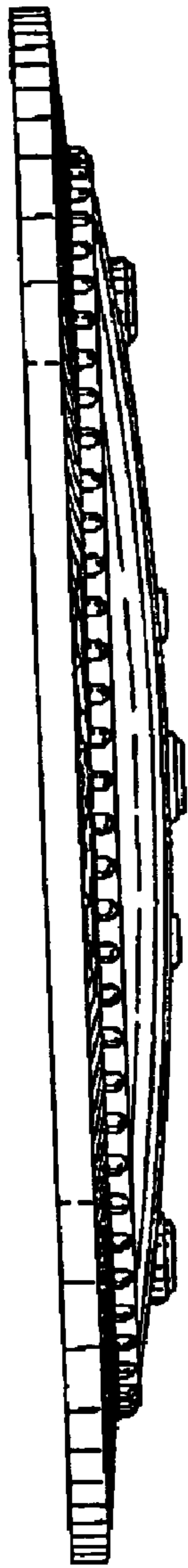

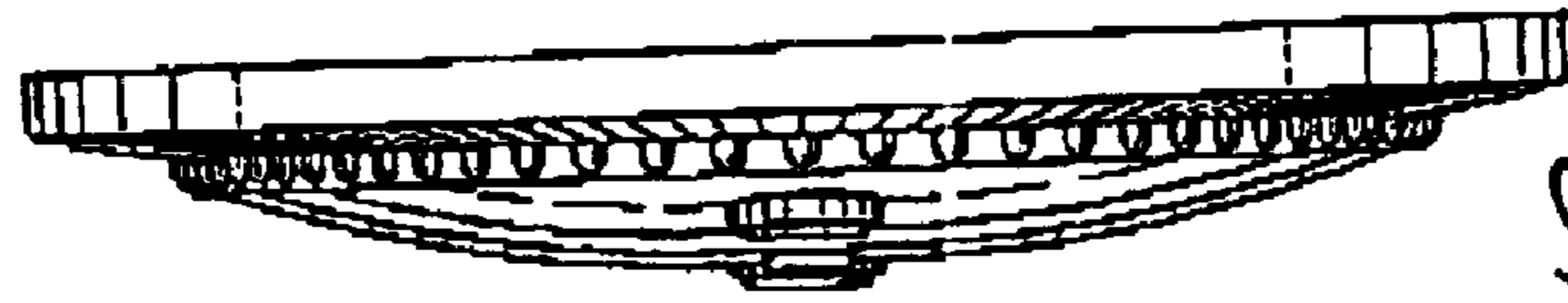

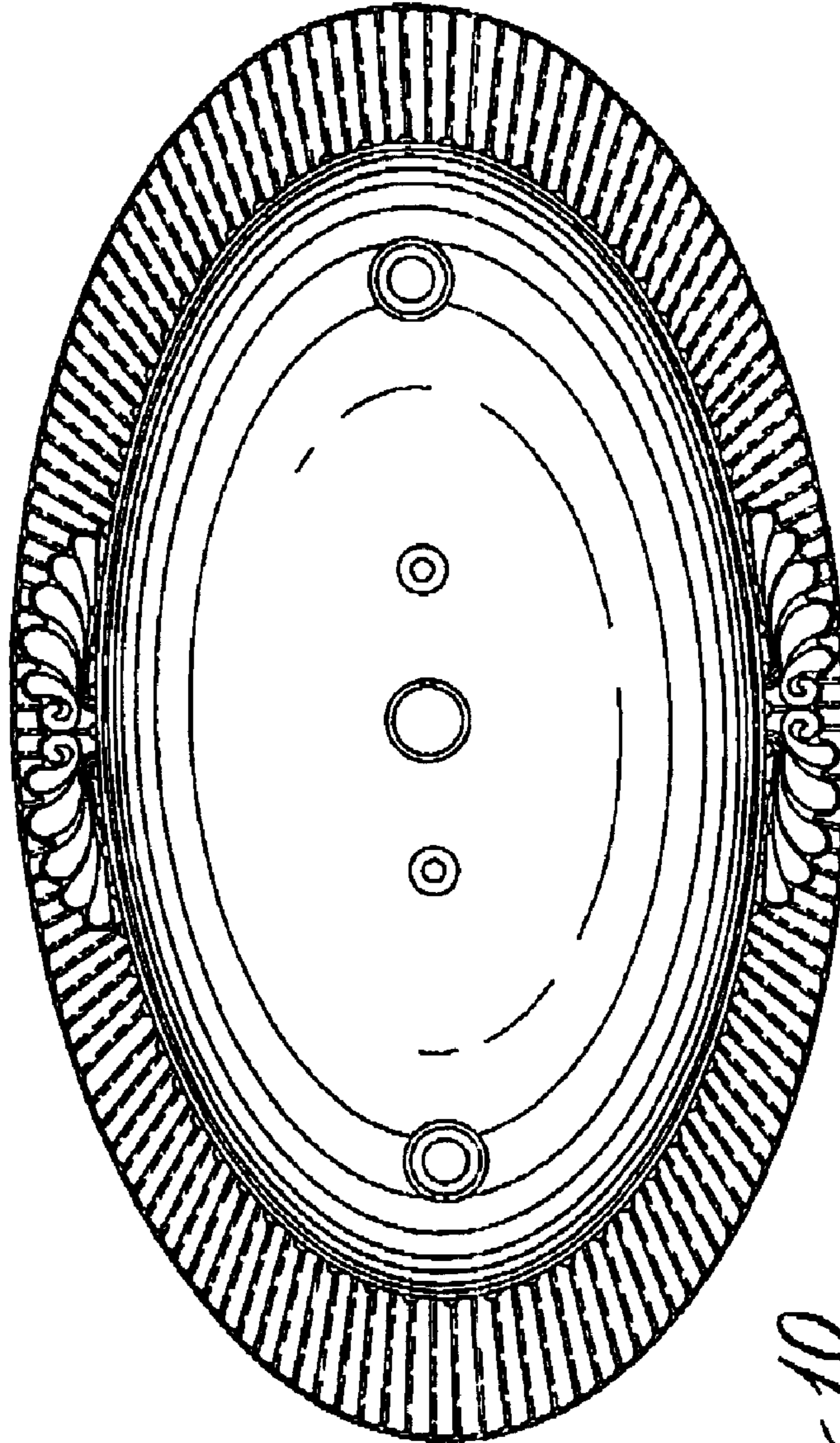

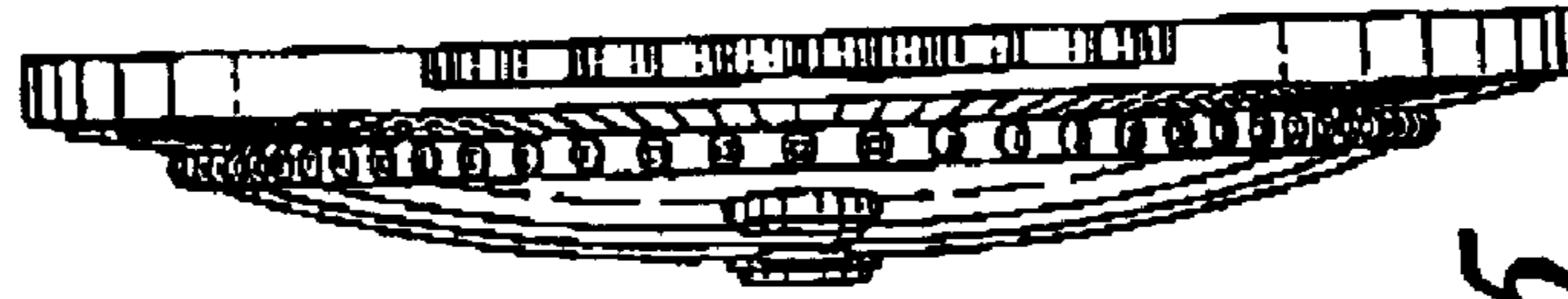

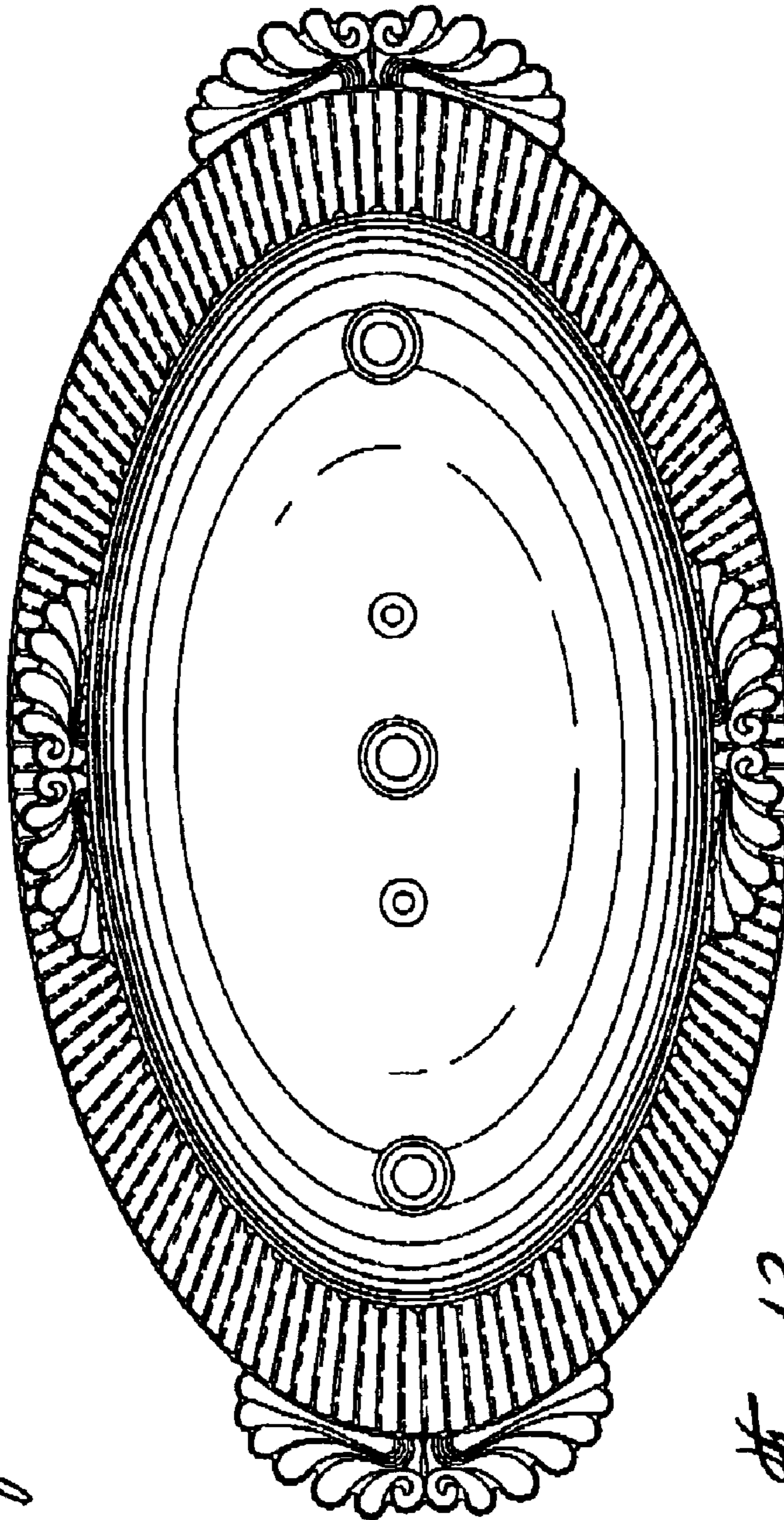

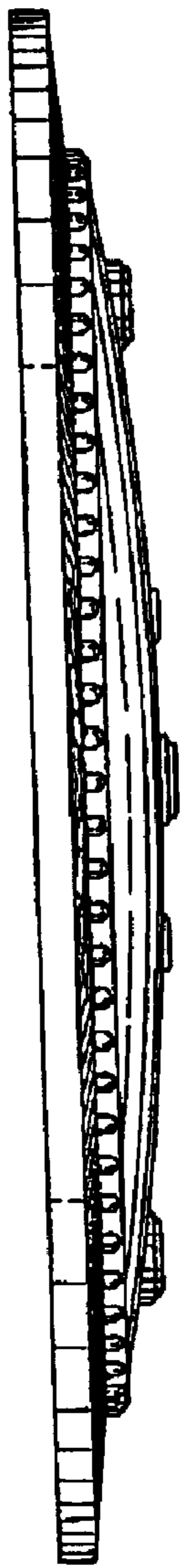

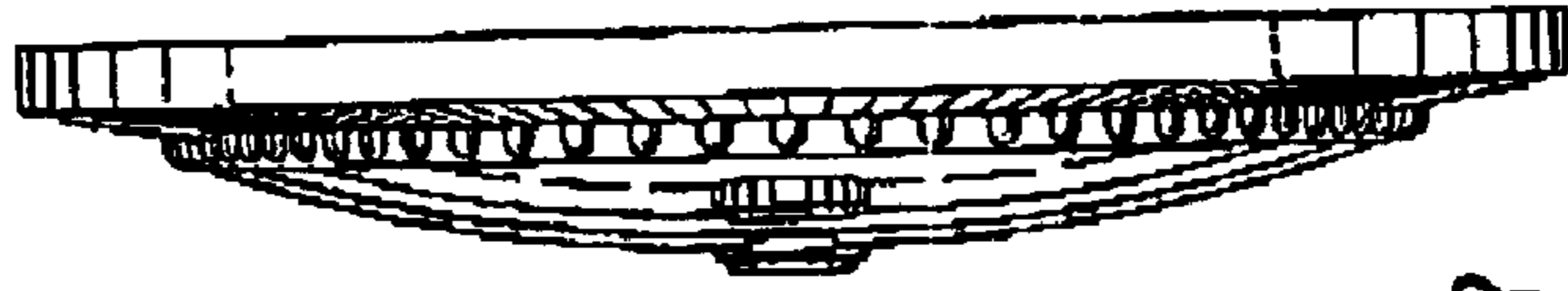

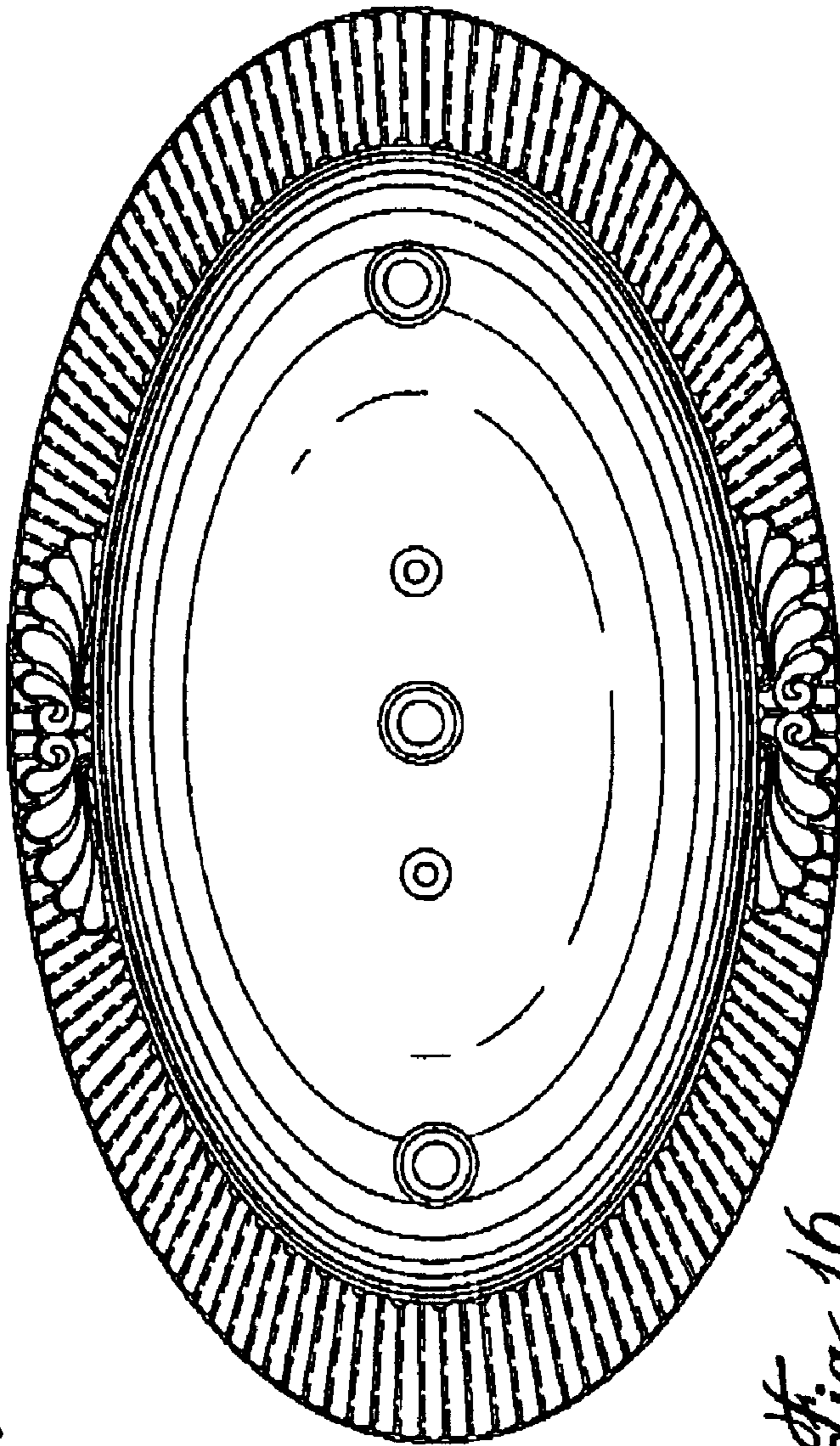
