The ornamental design for the razor handle, as shown and described.

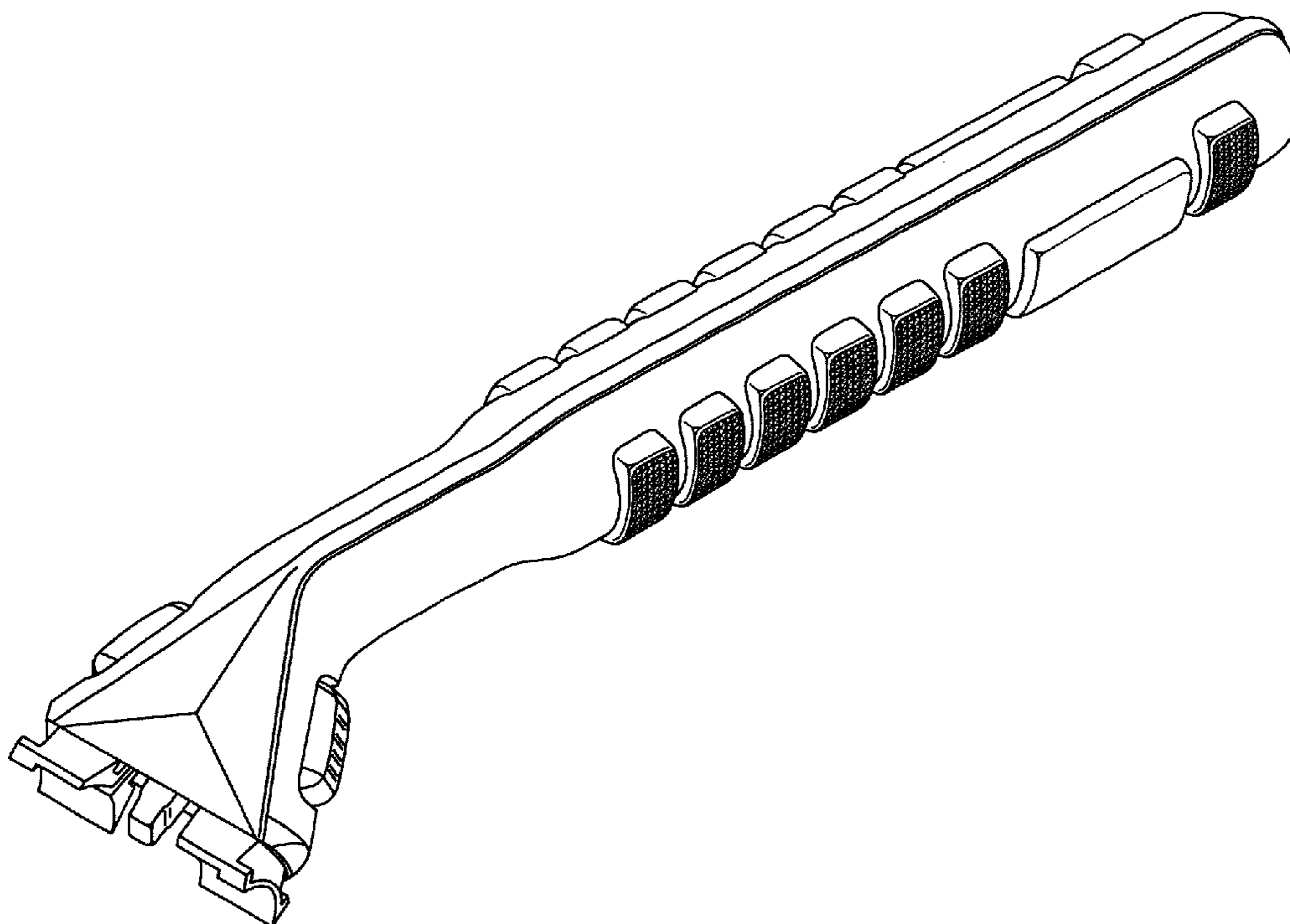
DESCRIPTION

FIG. 1 is a top perspective taken from the left side of the razor handle of the present invention;
FIG. 2 is a top plan view thereof;
FIG. 3 is a left side view thereof, the right side view being a mirror image thereof;

FIG. 5 is a front elevational view thereof; and,
FIG. 6 is a rear elevational view thereof.

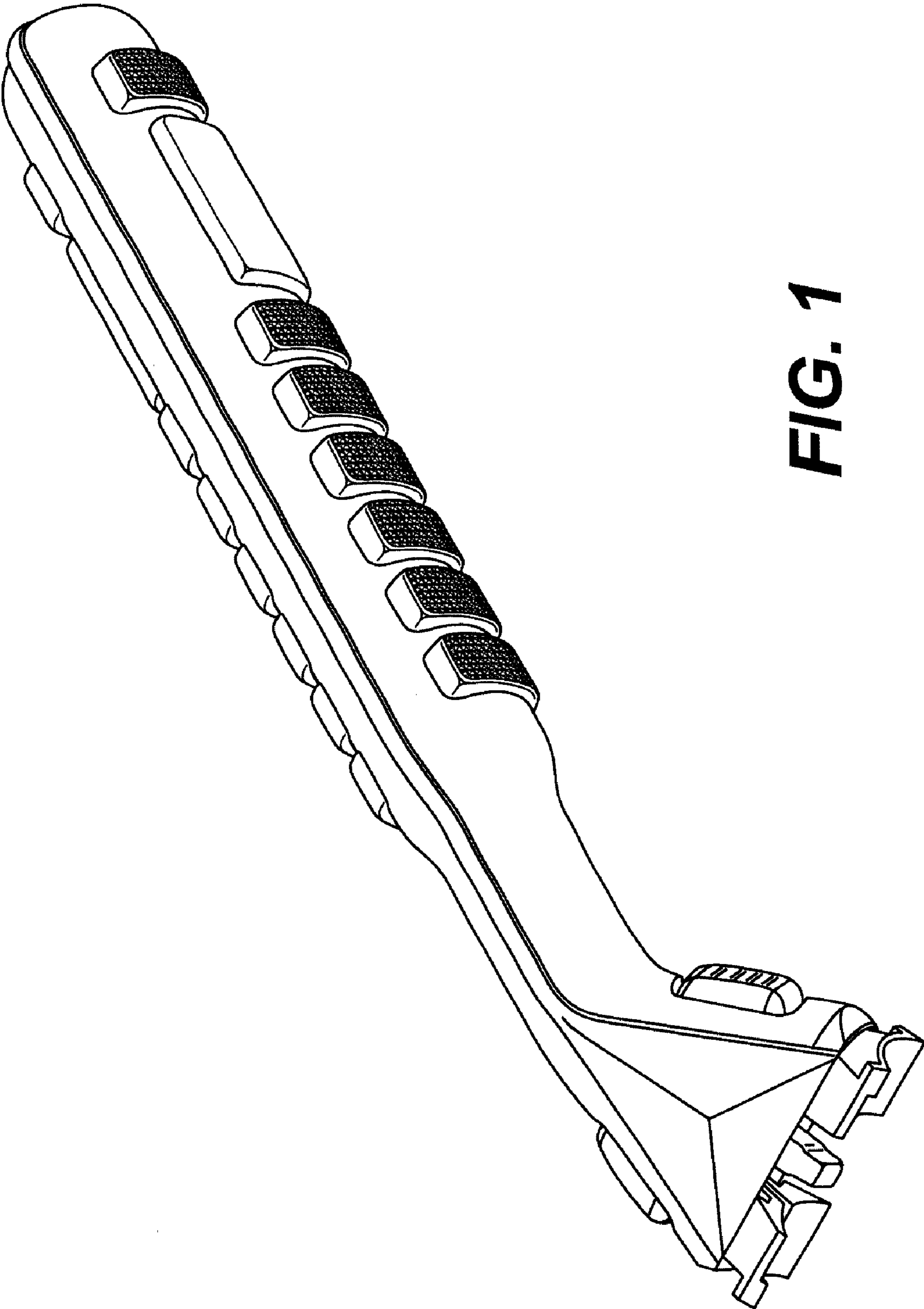

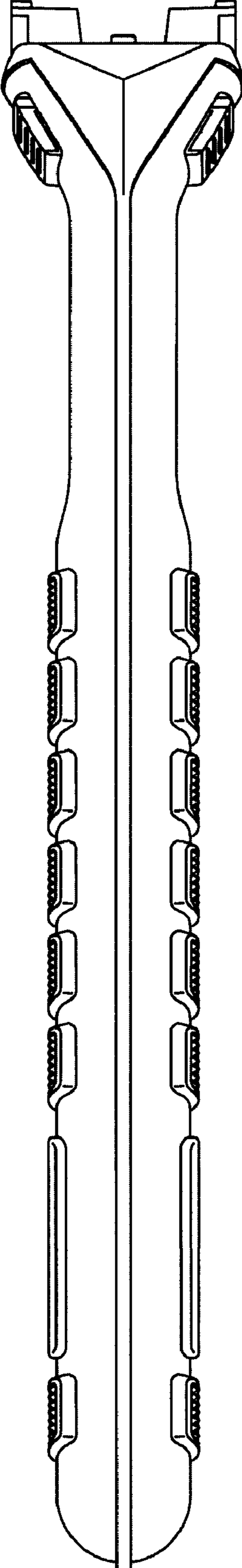

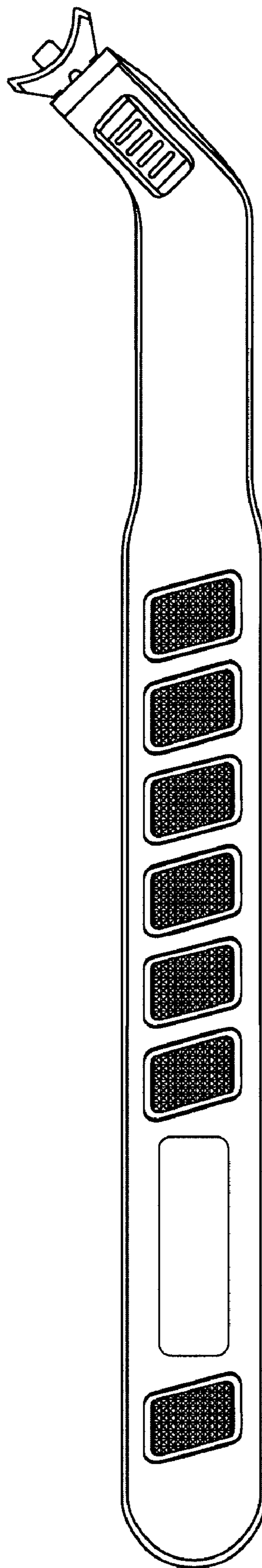

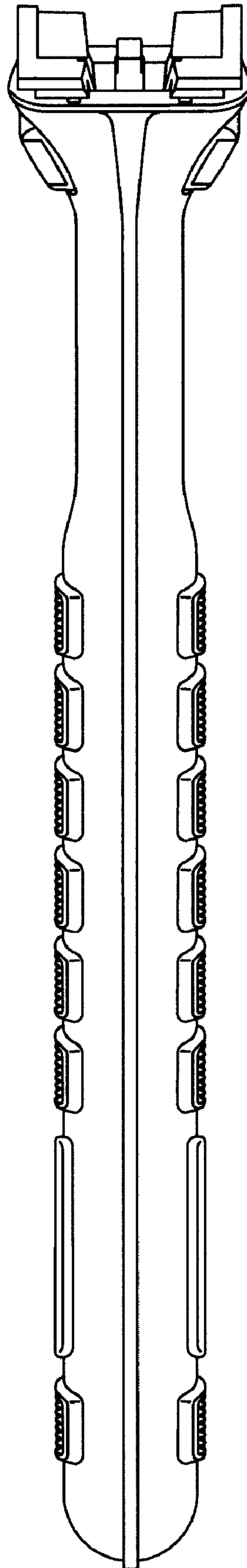

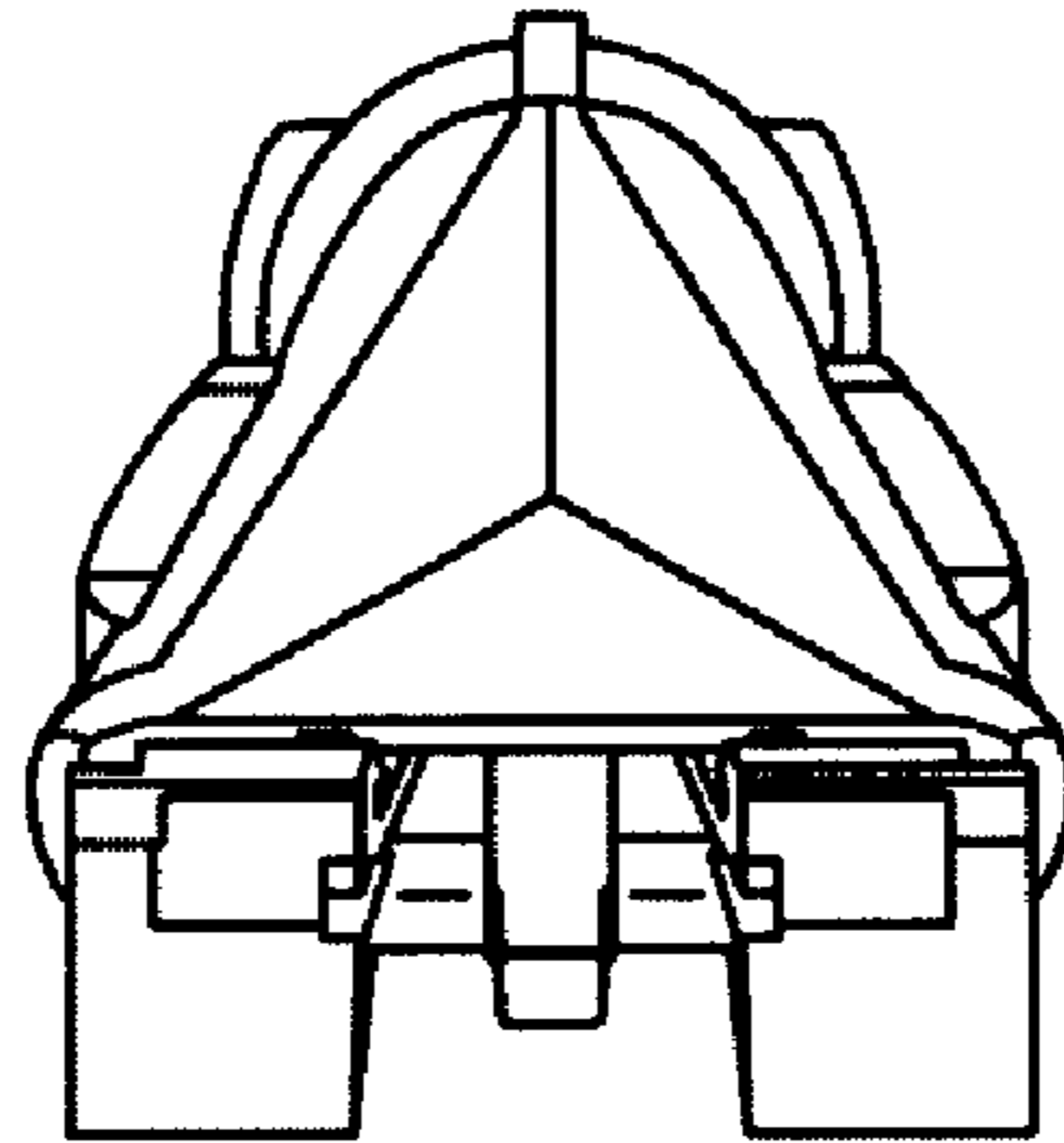
